**DESCRIPTION**

FIG. 3 is a right side elevation view thereof.

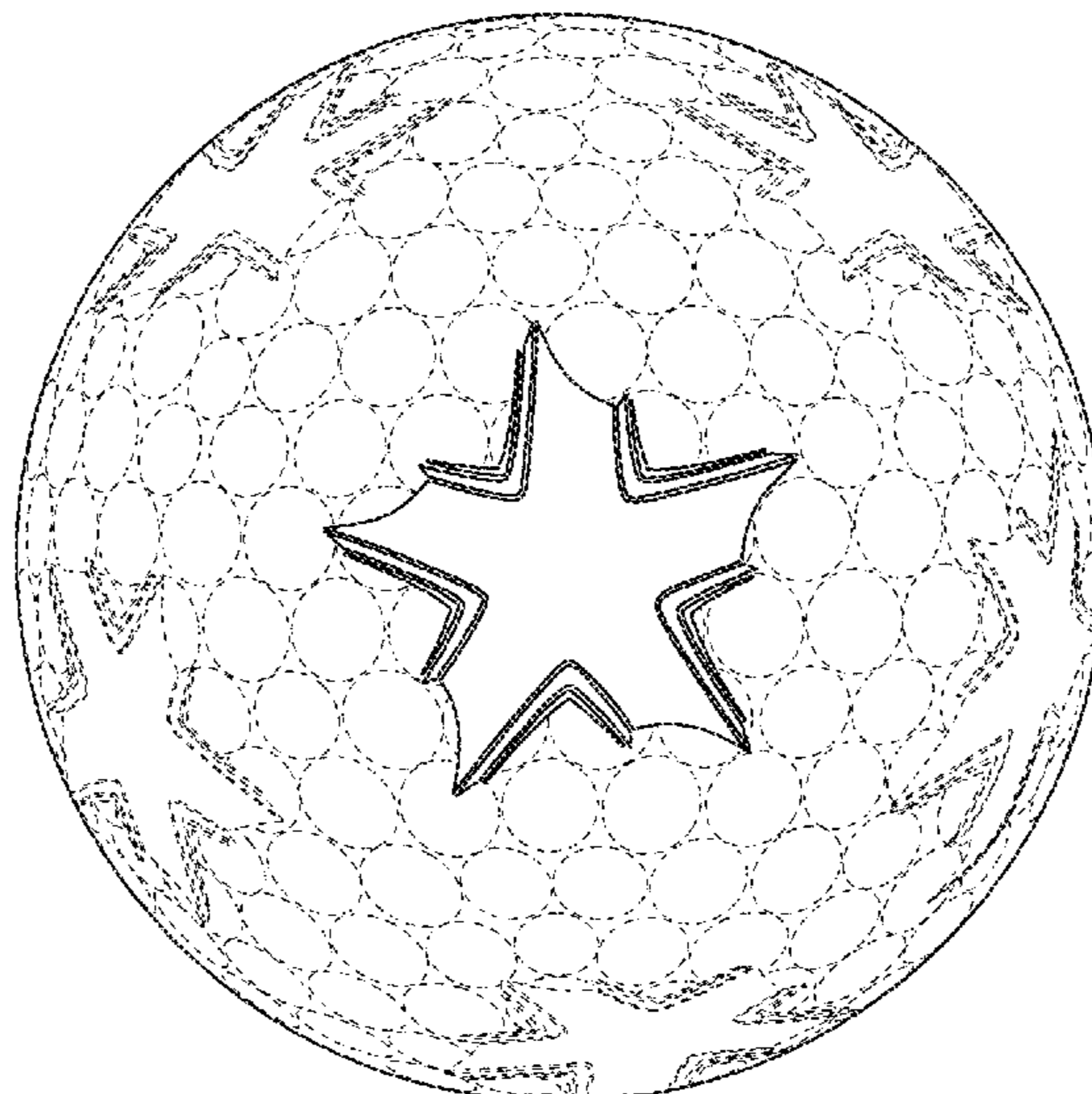
FIG. 4 is a left side elevation view thereof.

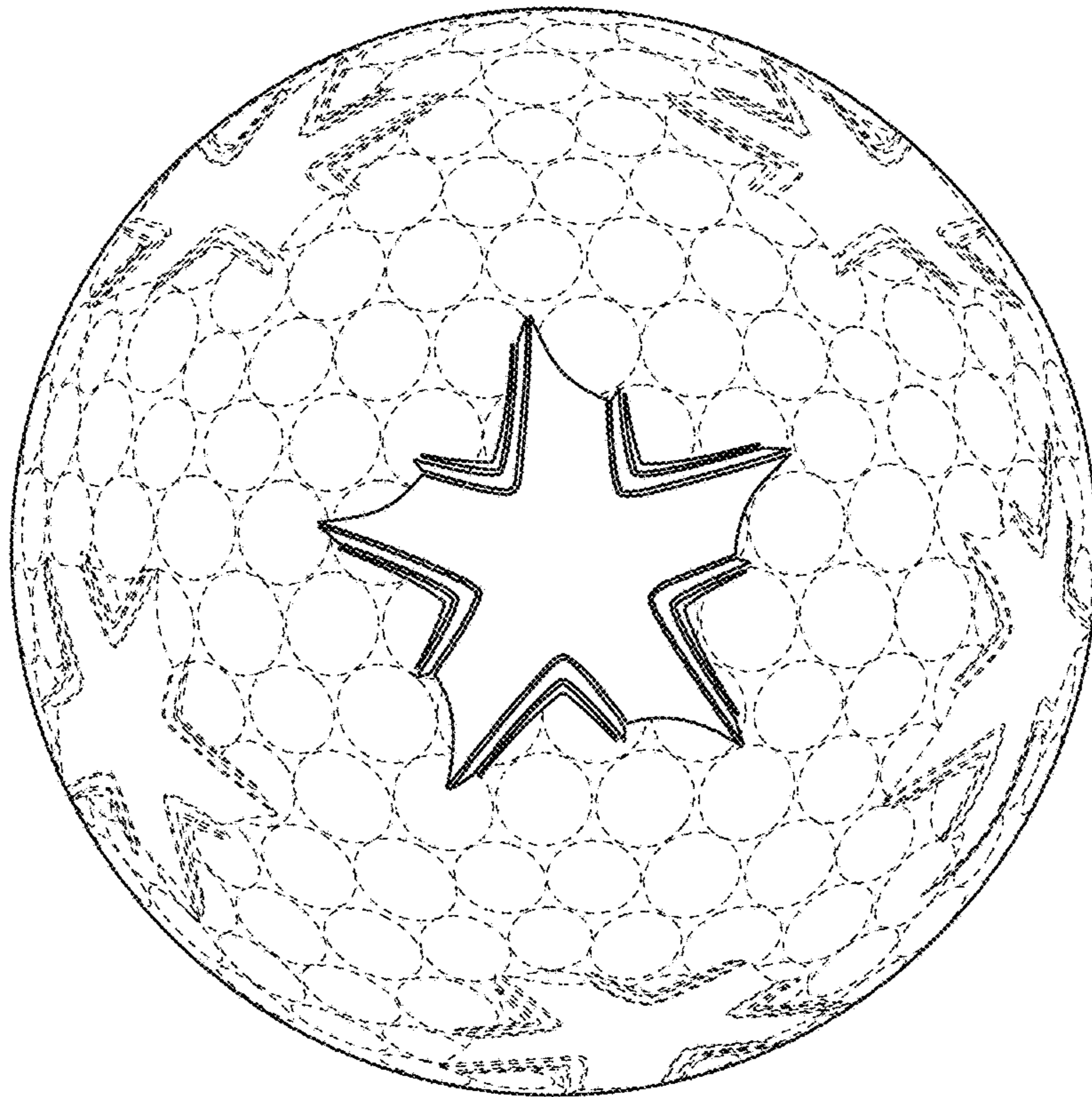

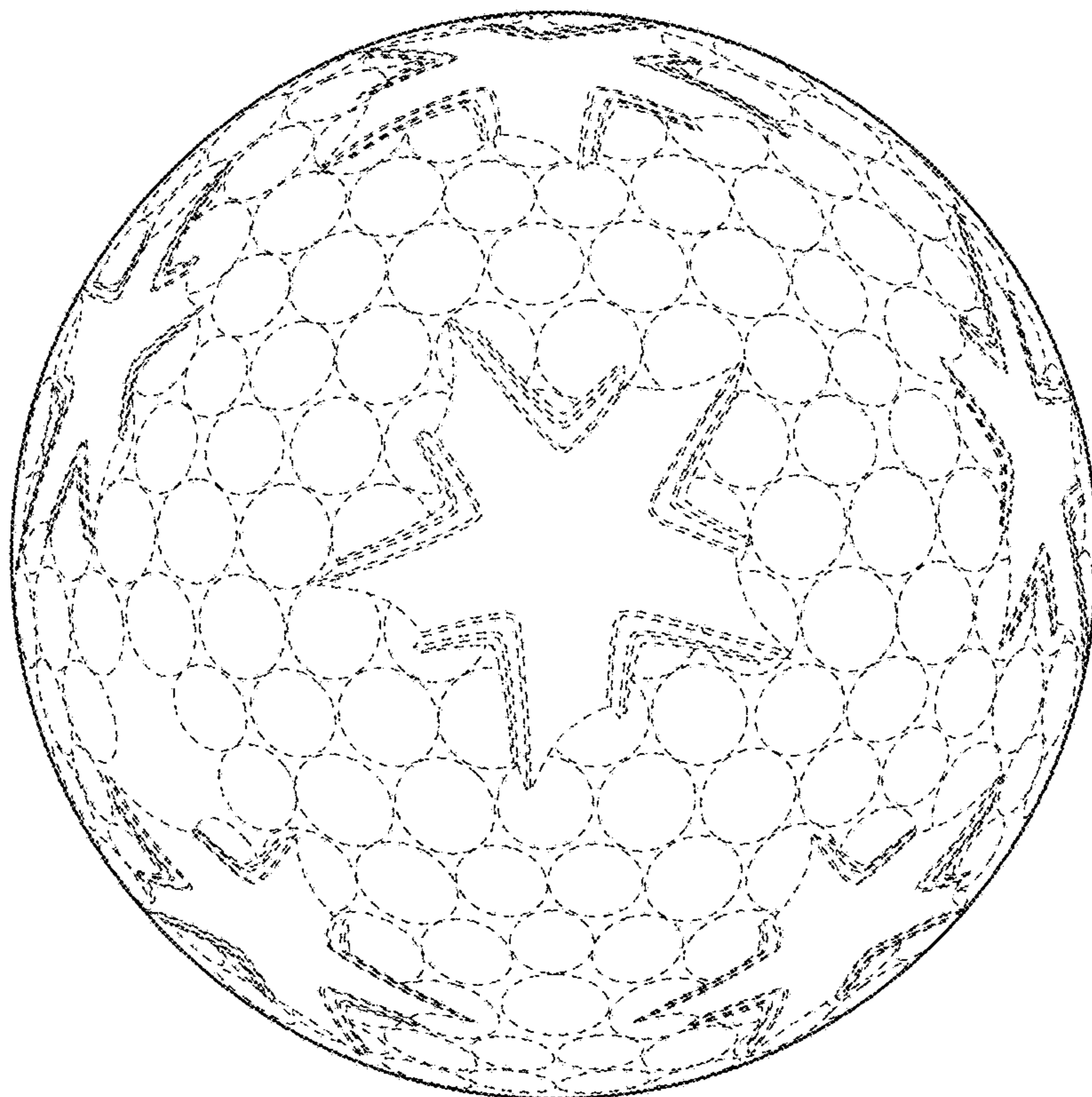

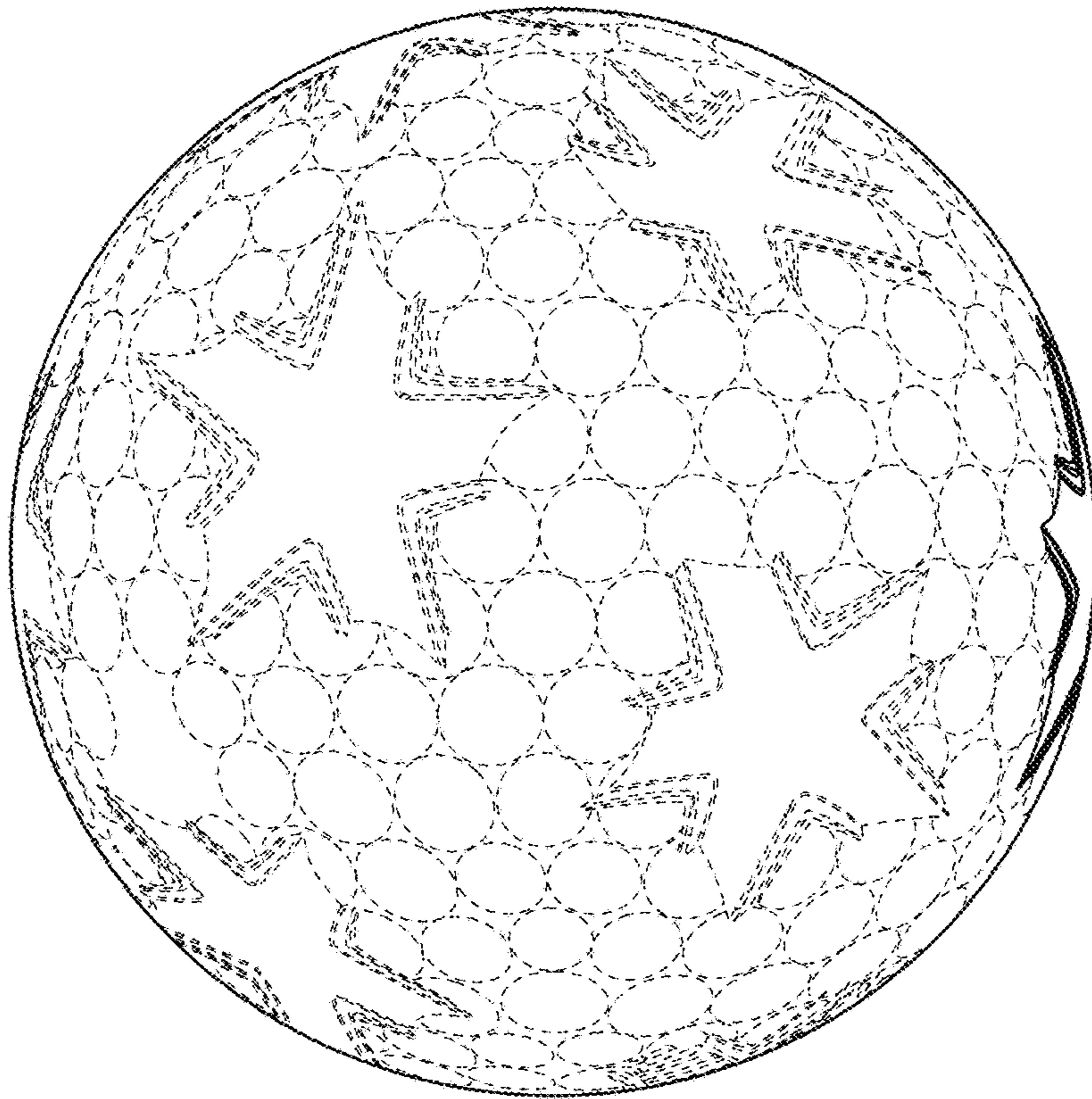

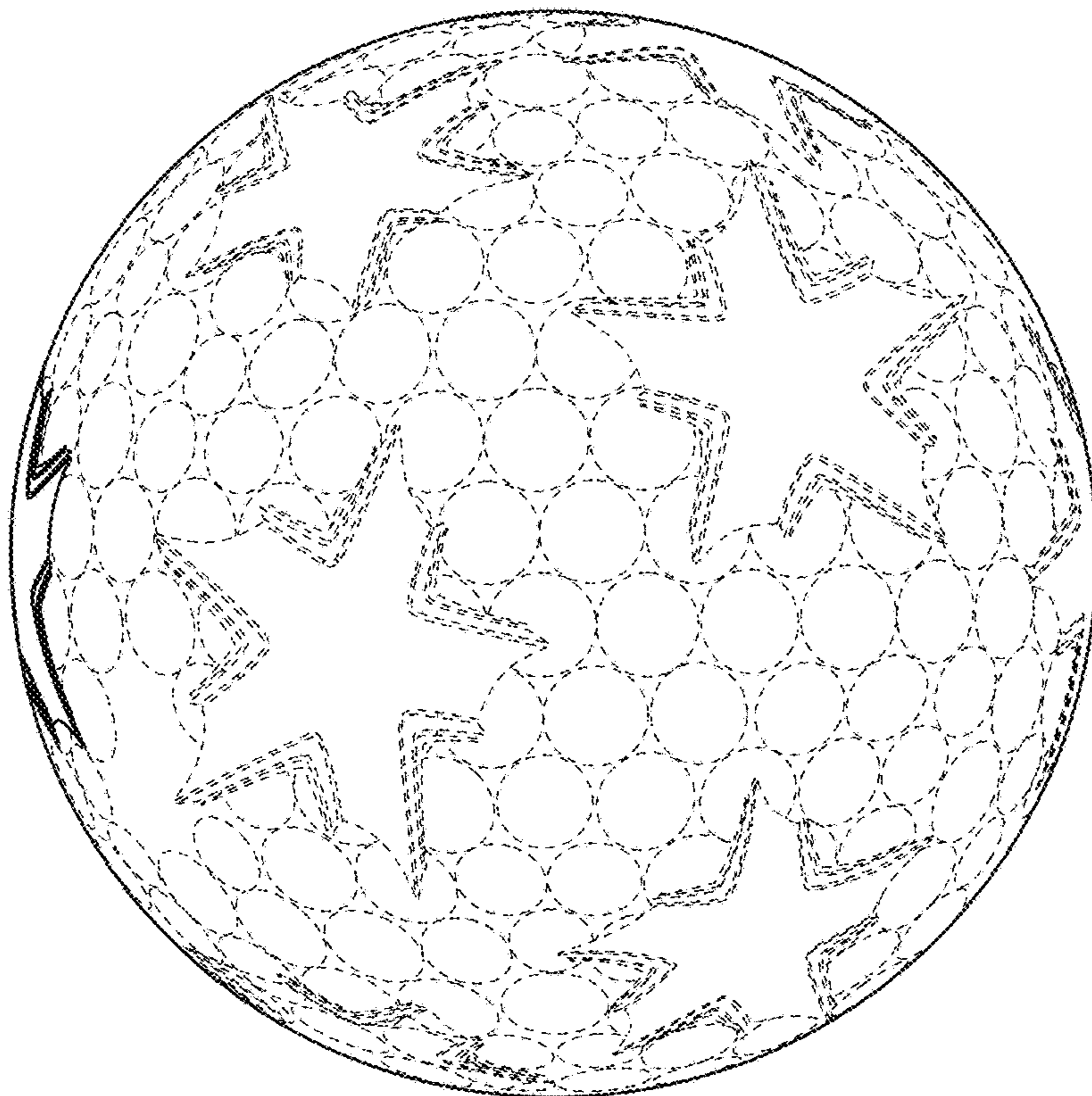

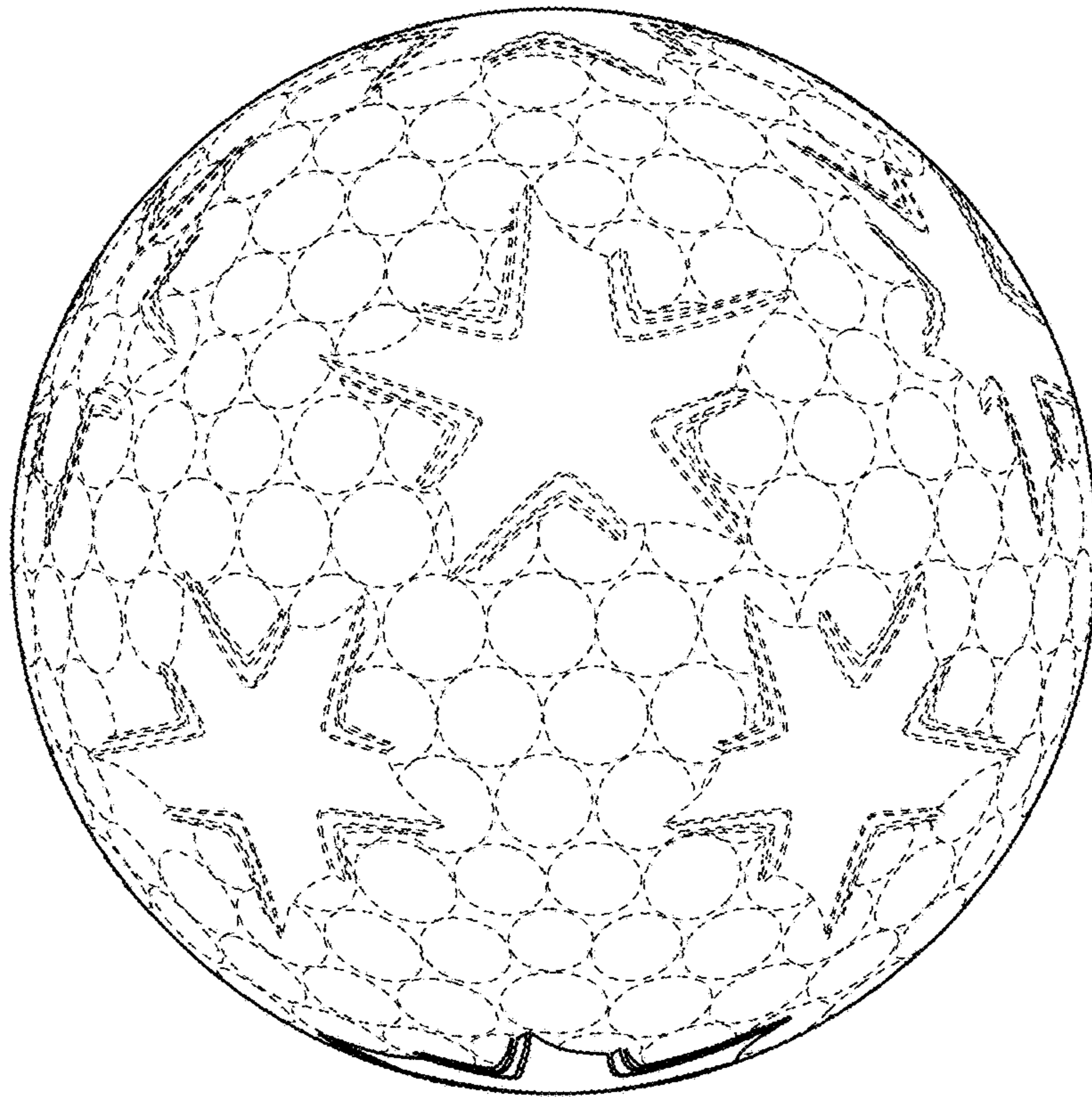

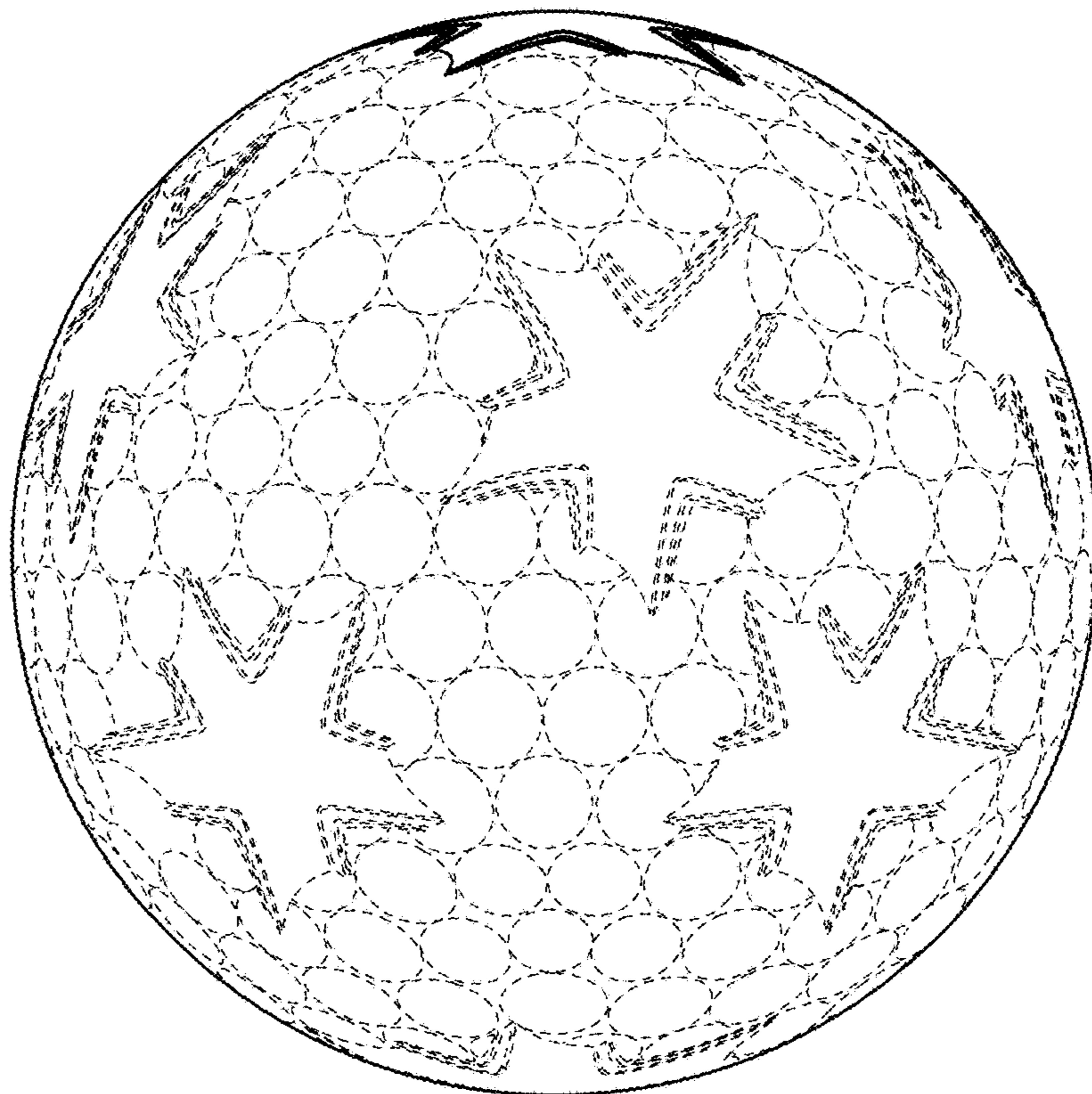
