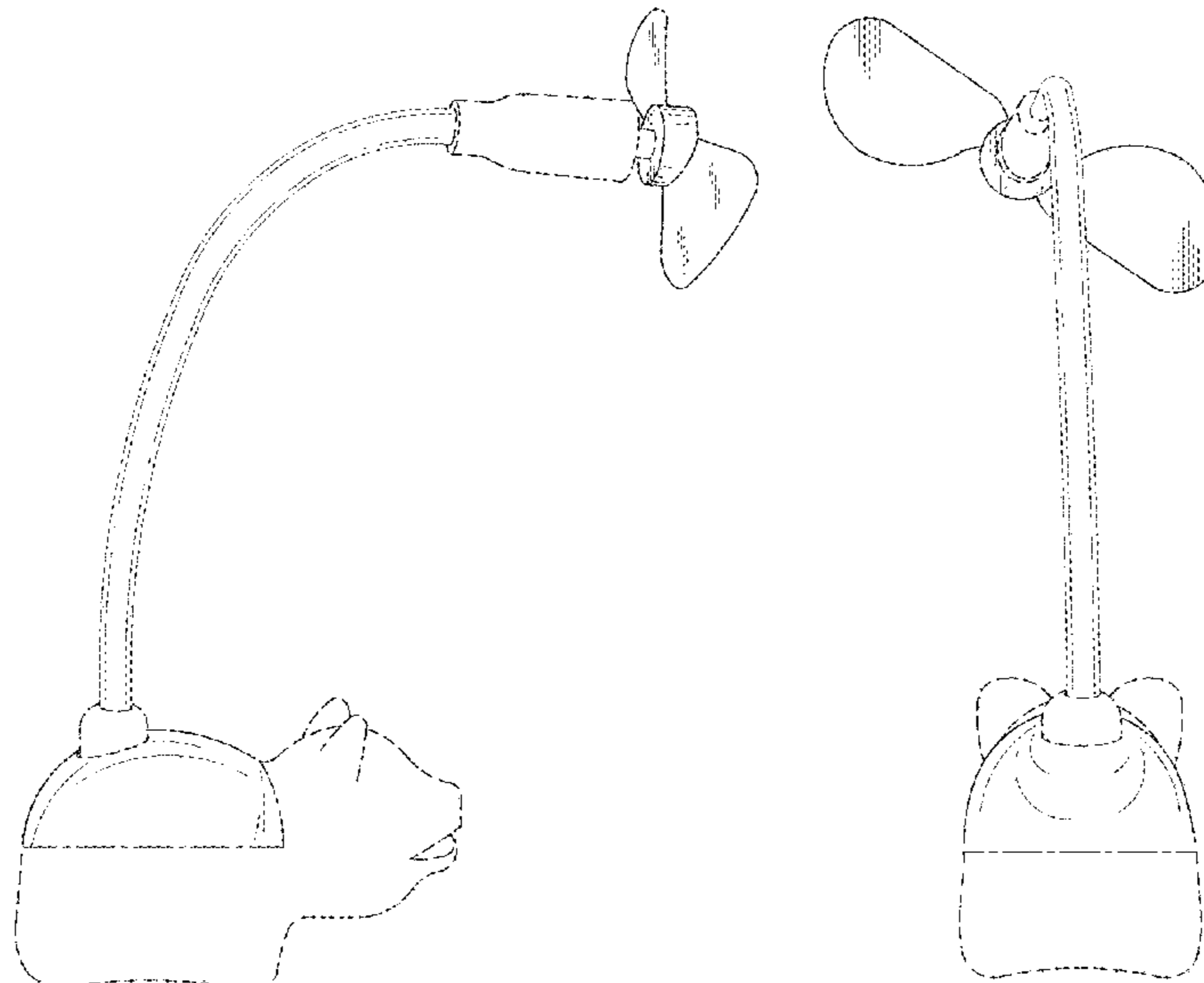
The ornamental design for a food cooling device, as shown and described.

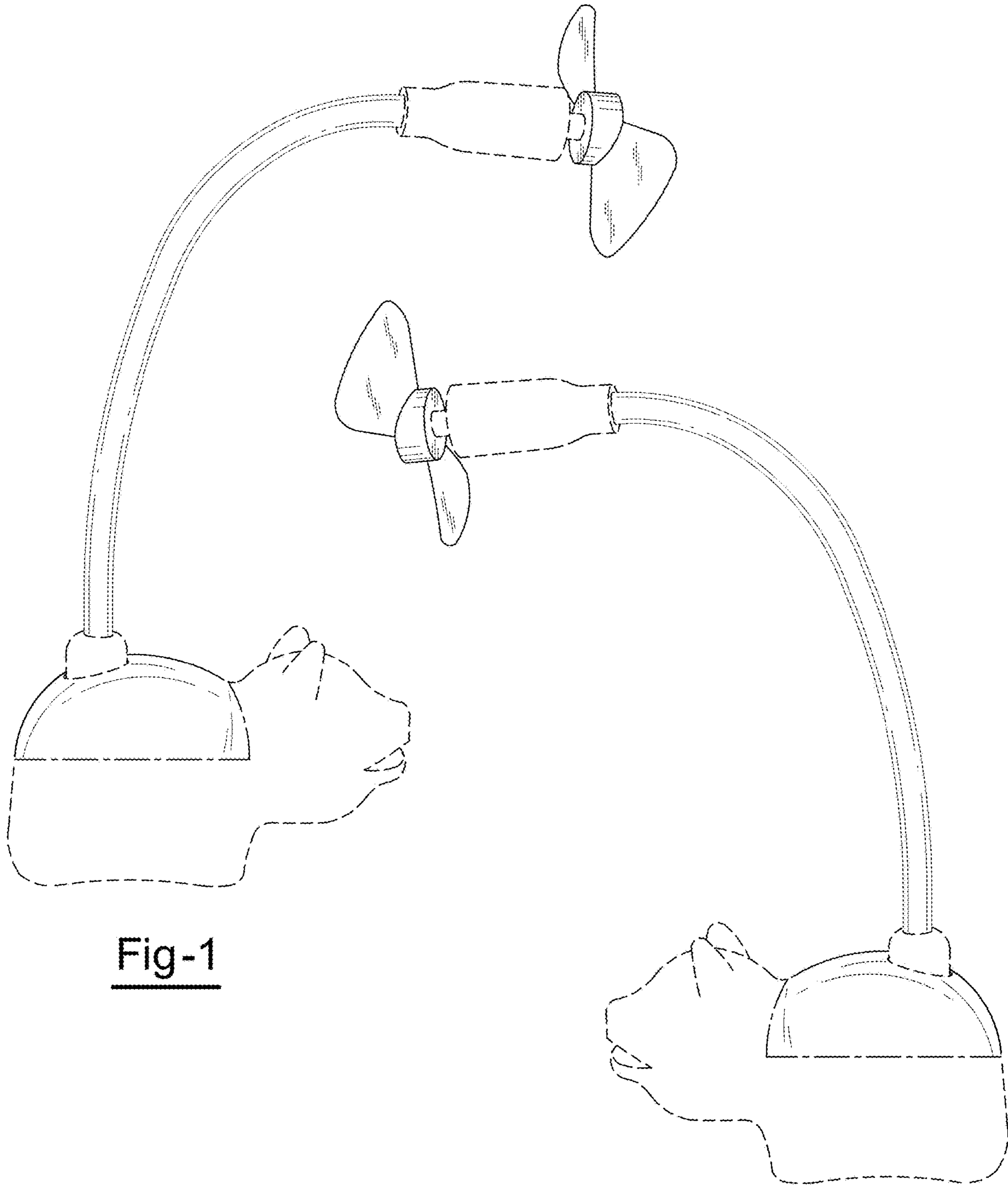

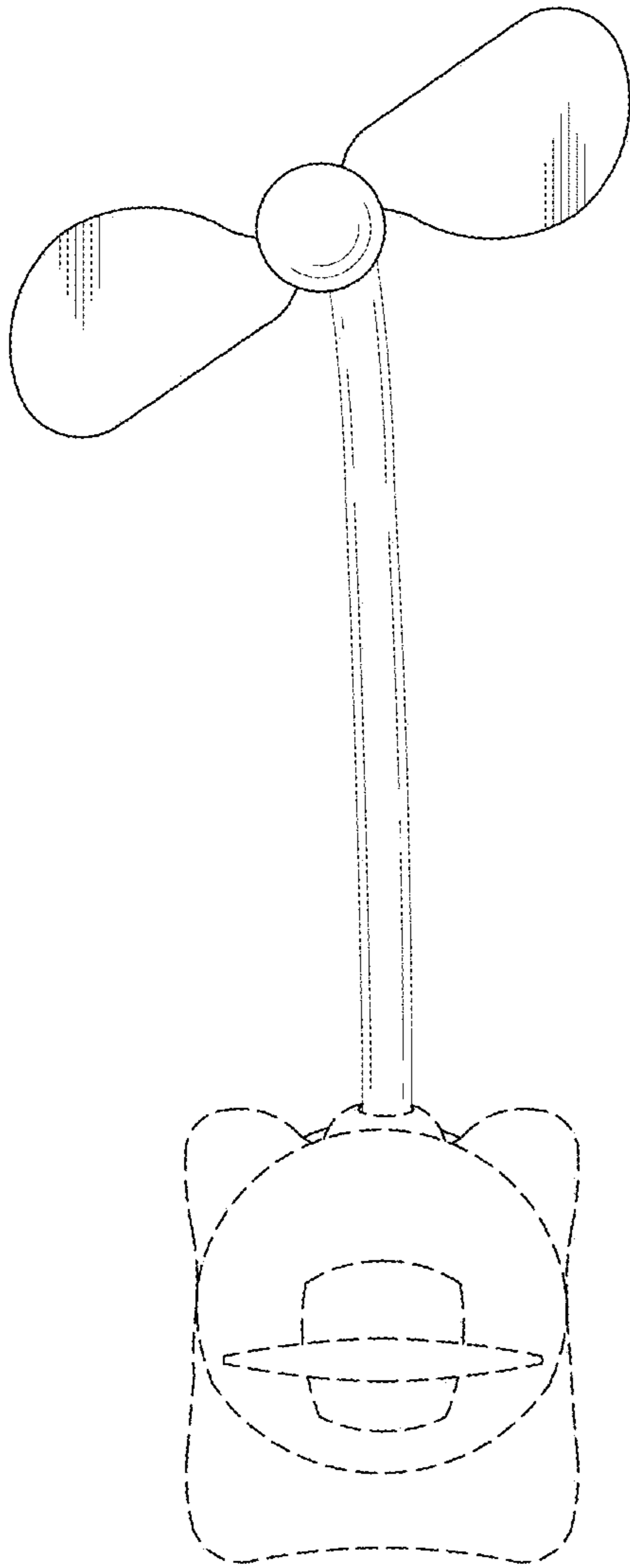

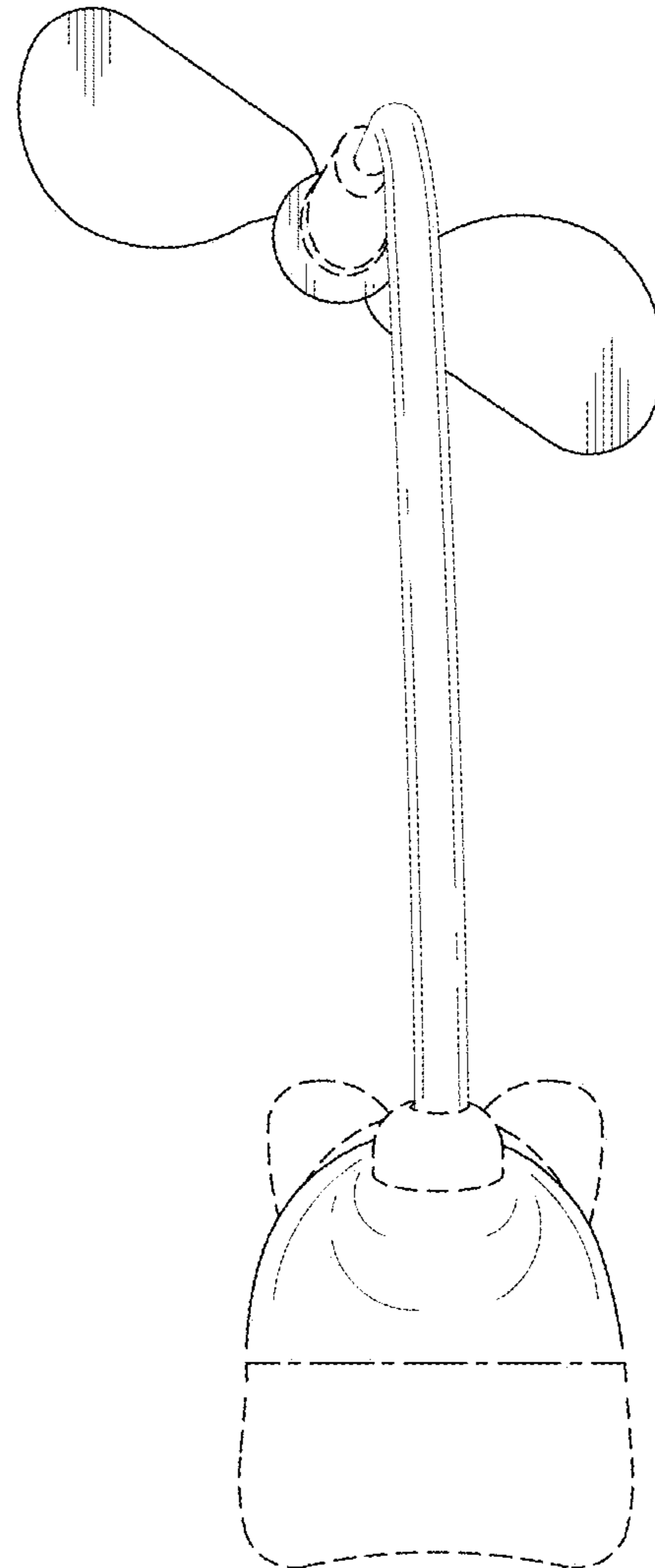

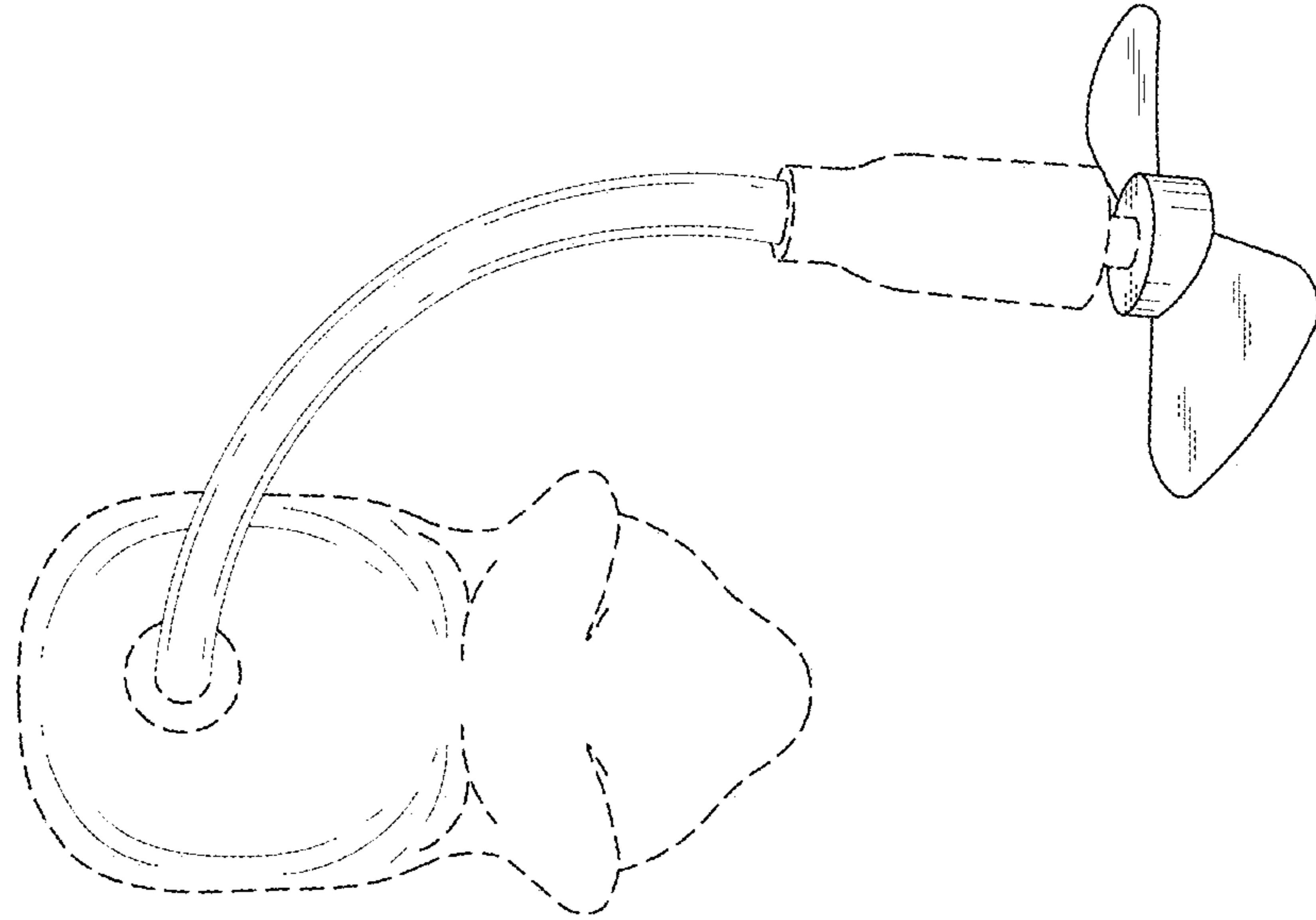

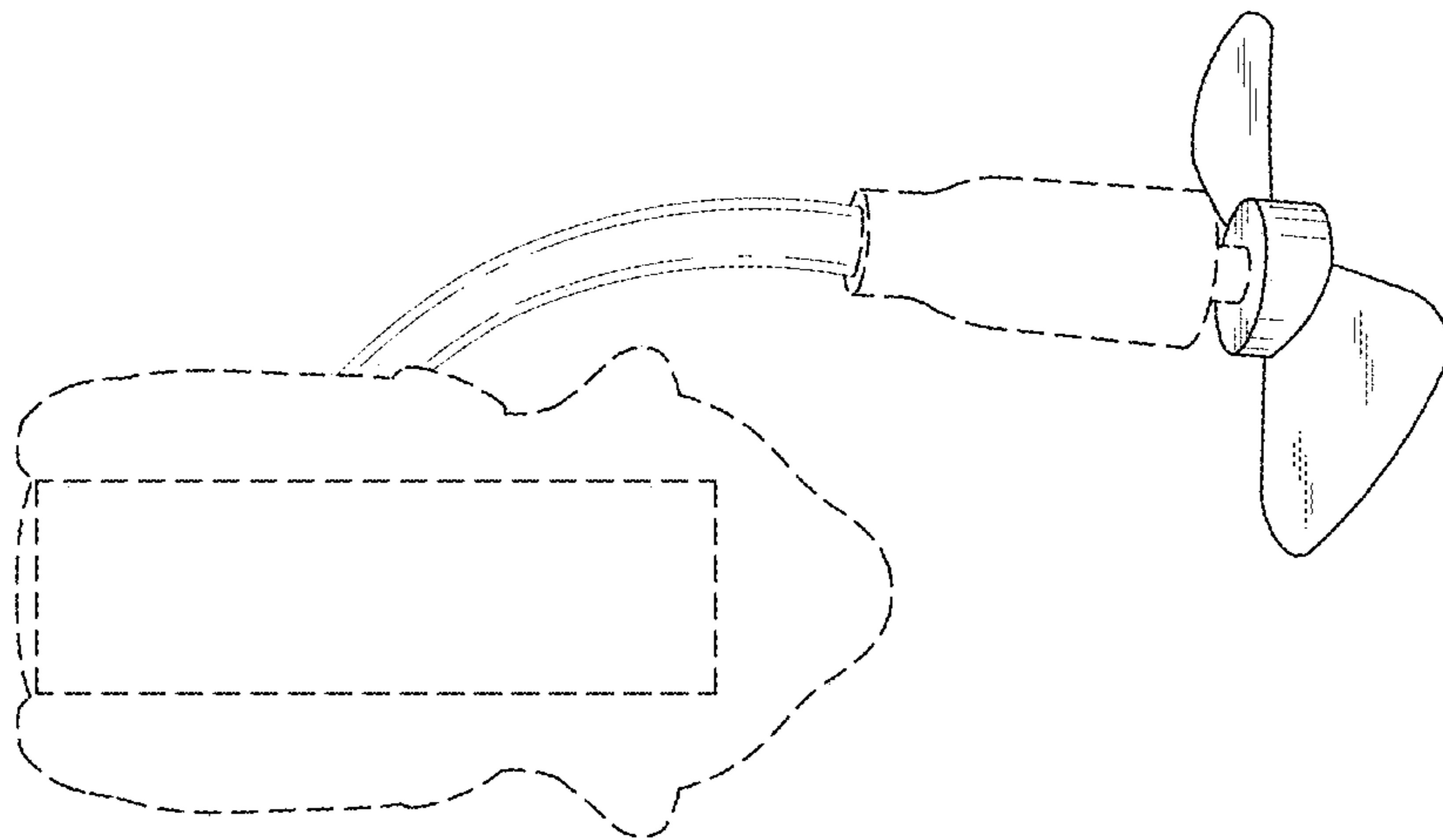
