(57) **CLAIM**

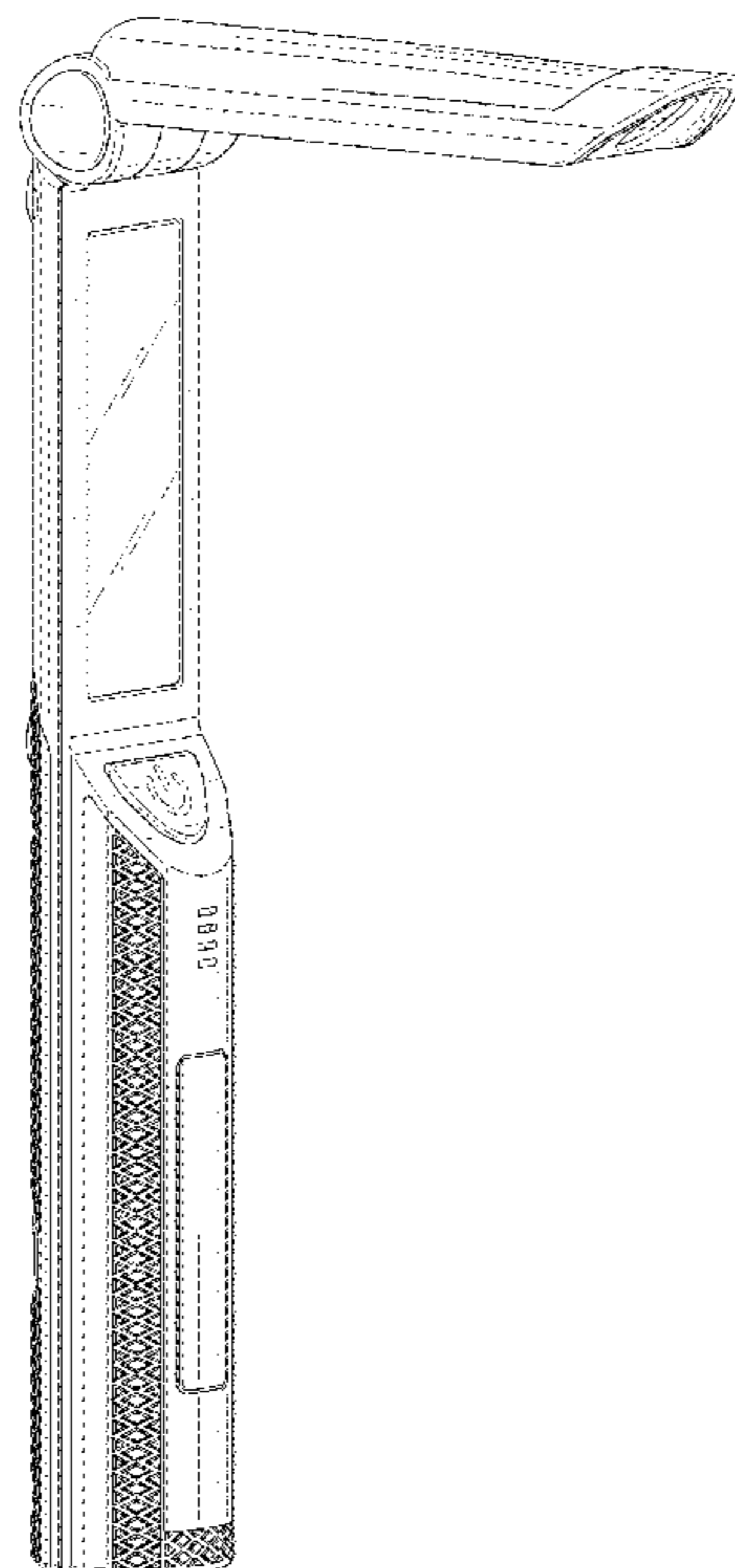
The ornamental design for a work lamp, as shown and described.

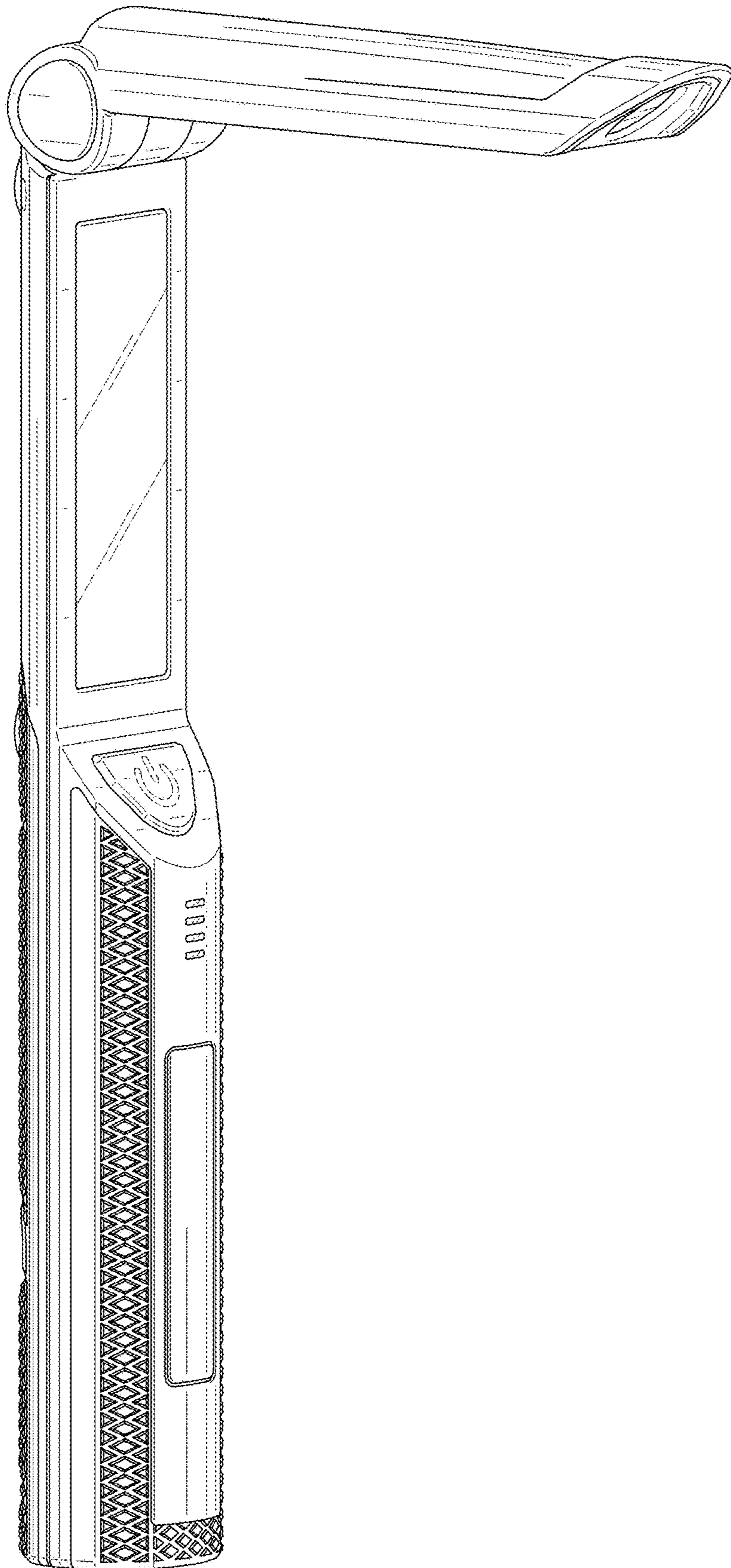

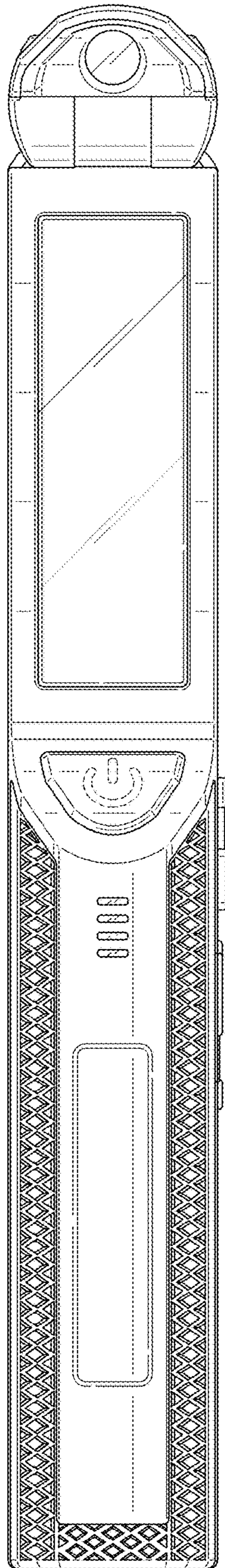

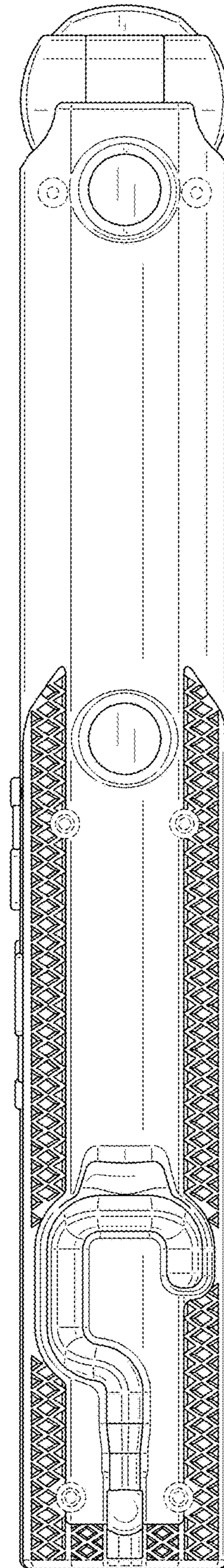

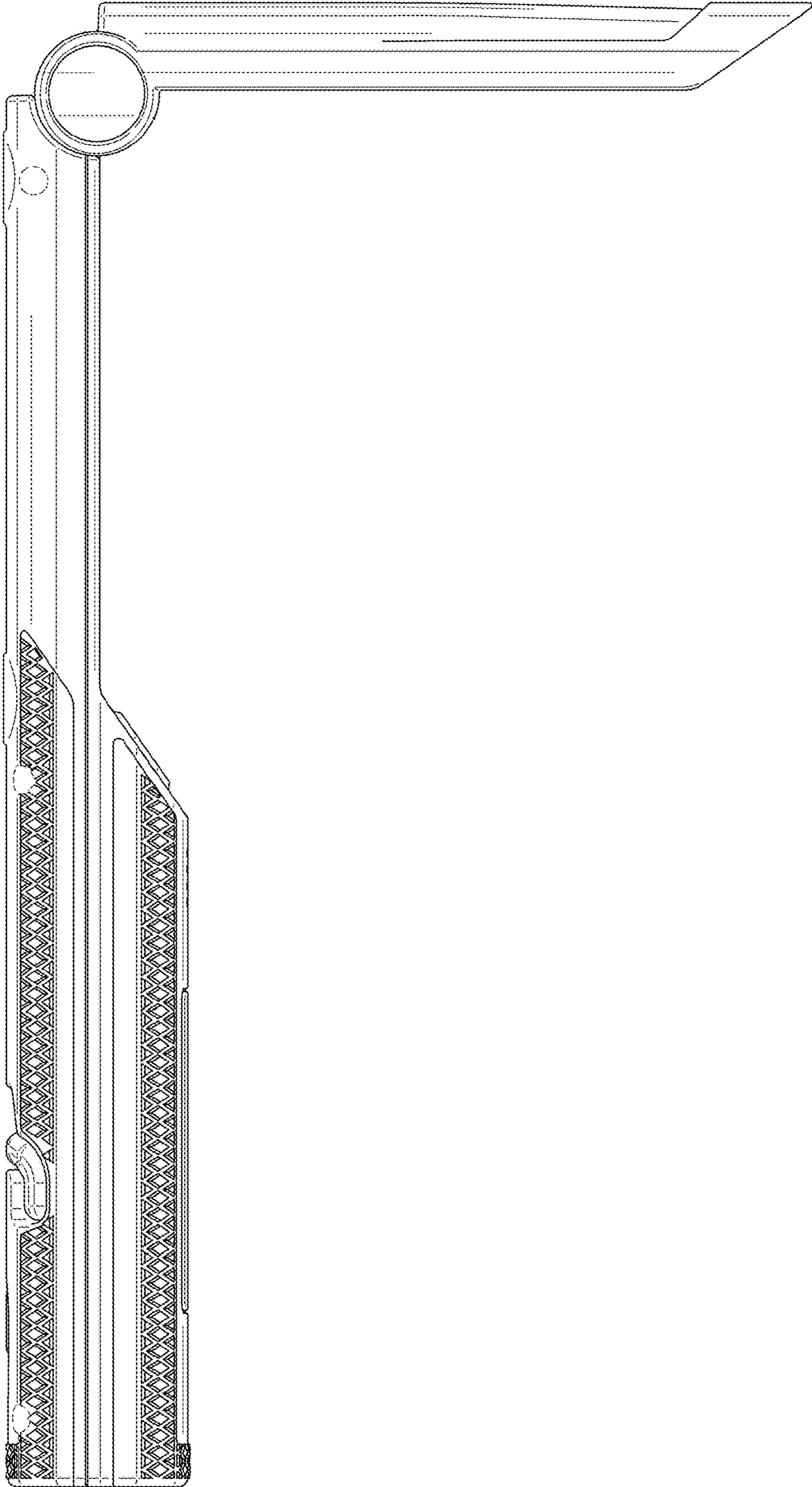

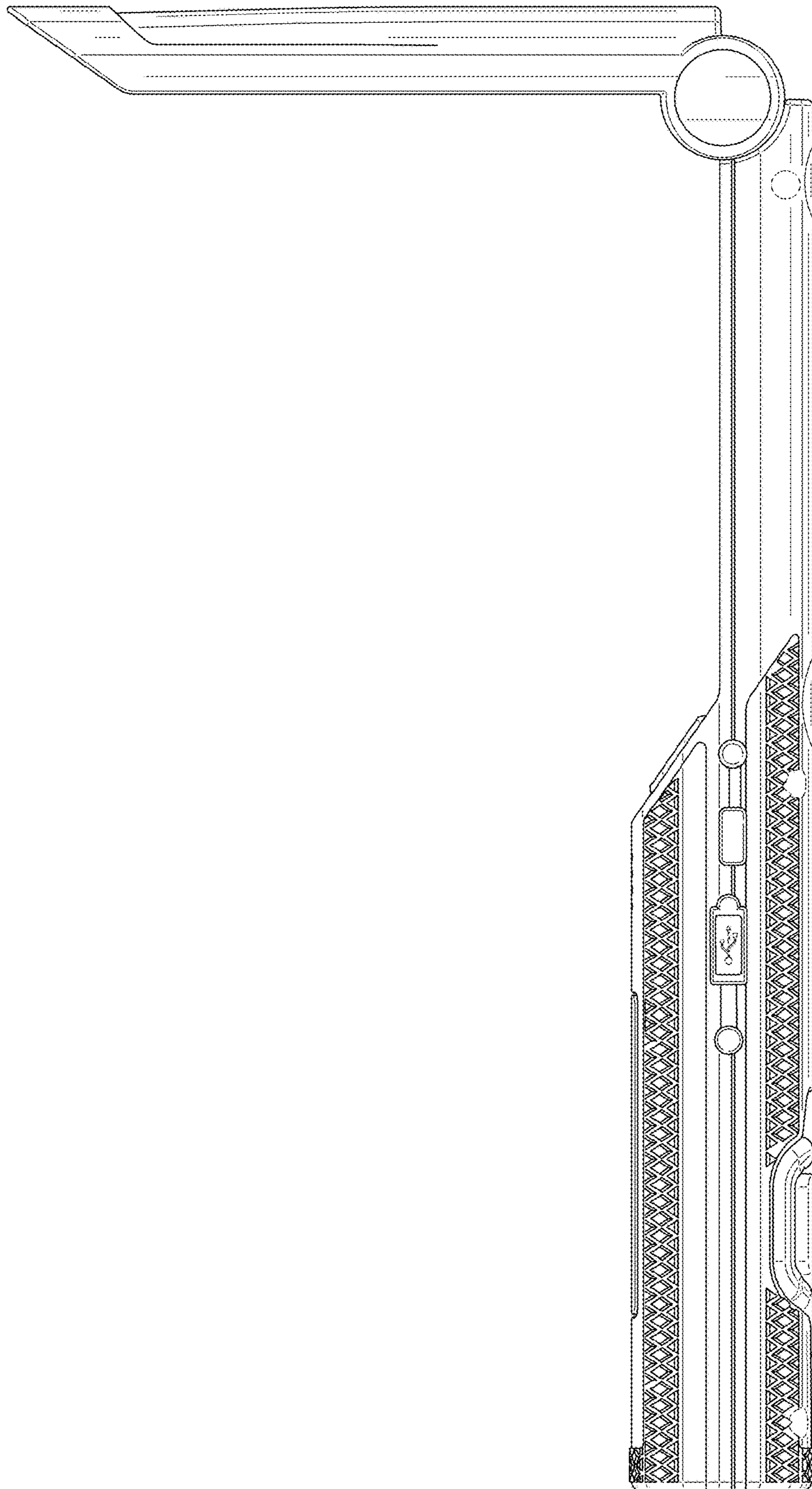

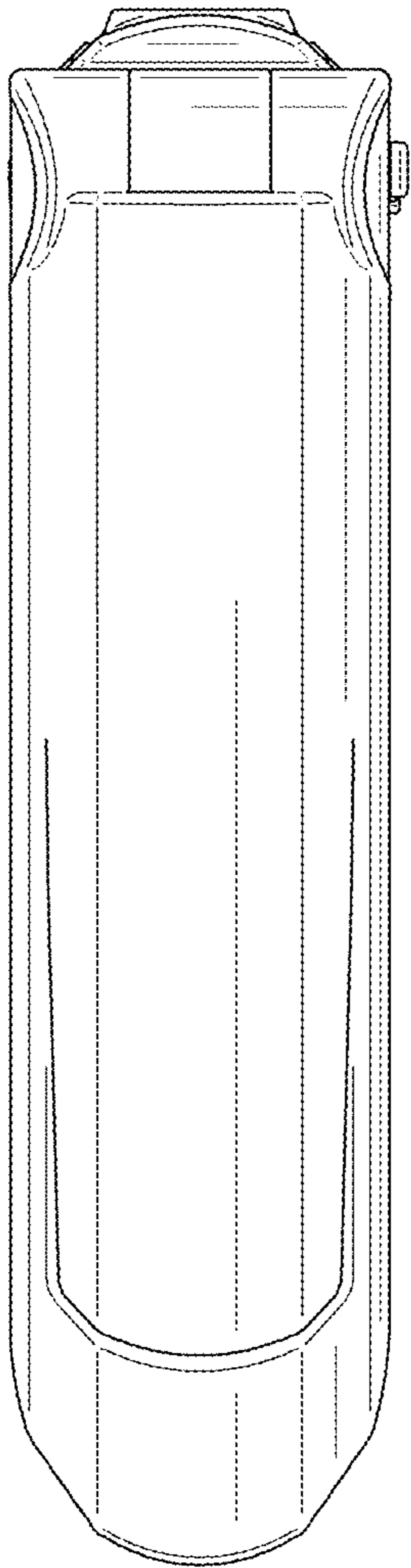

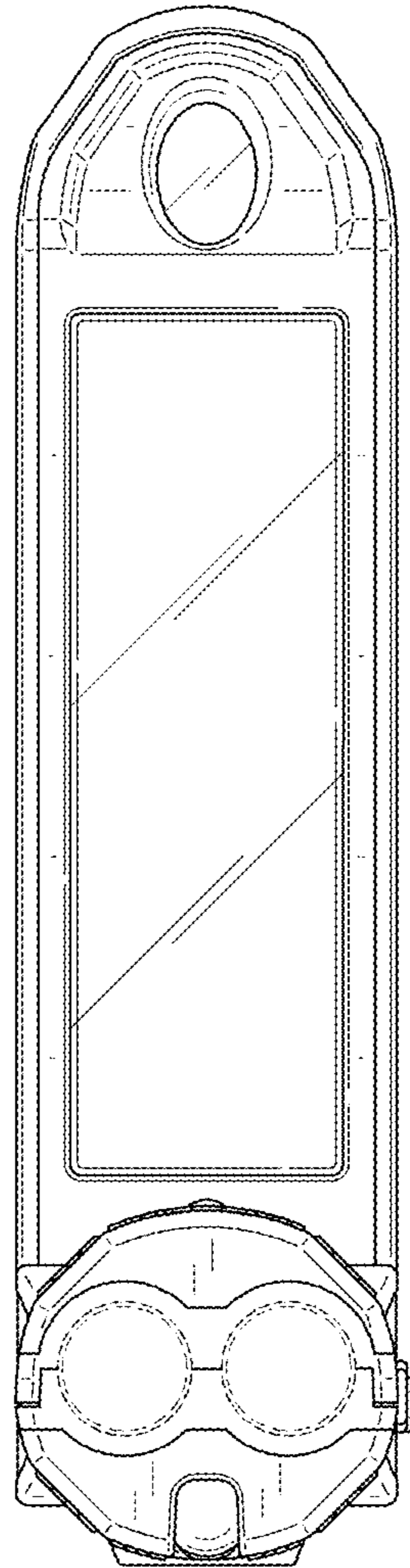

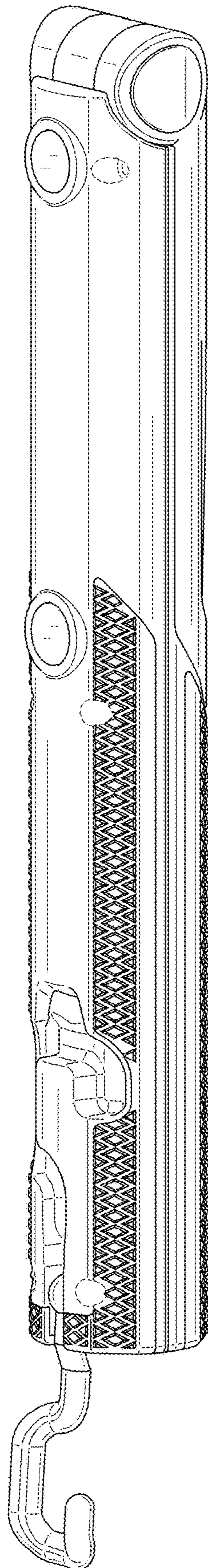

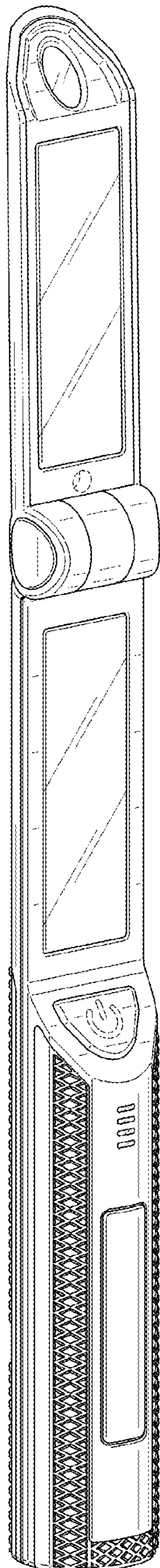
