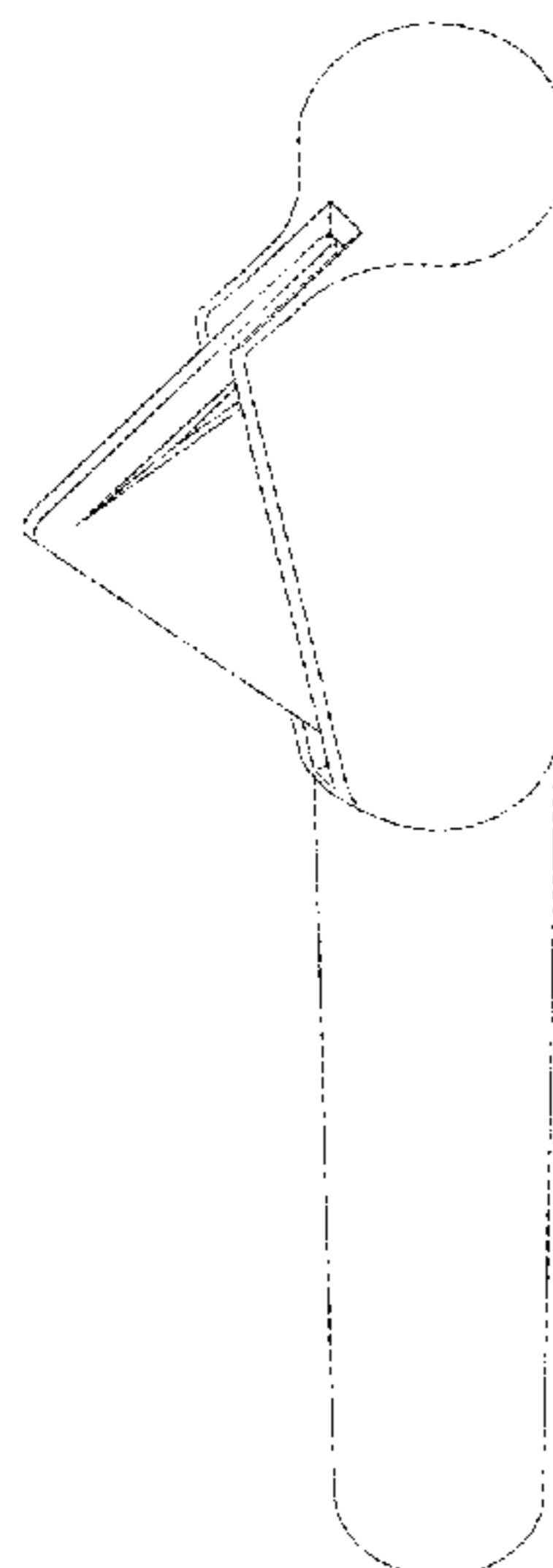

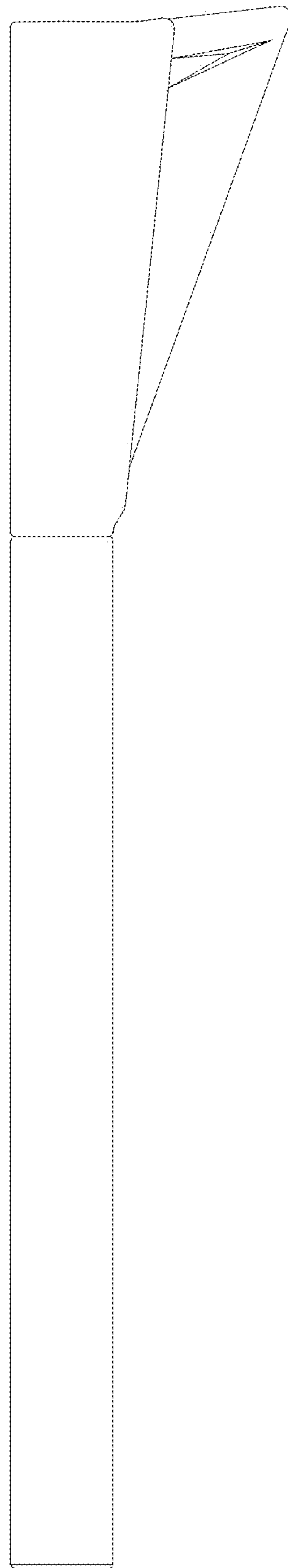

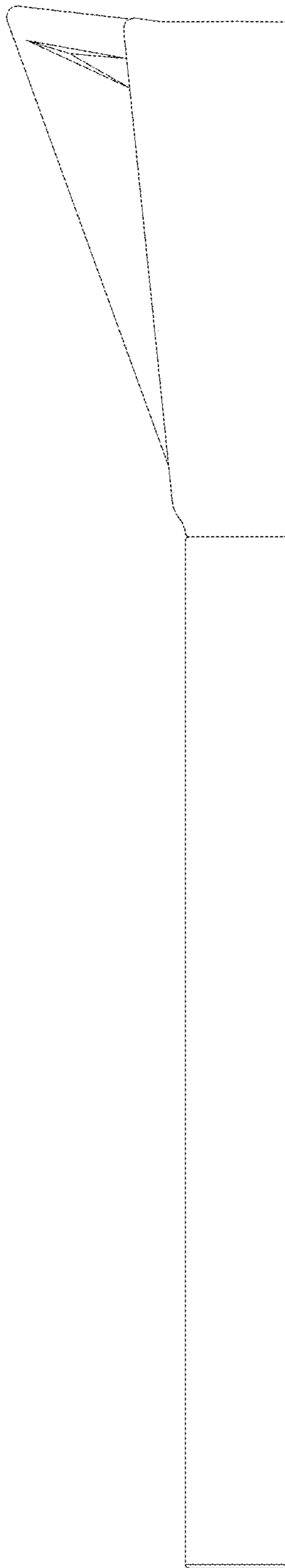
1.7 : Exploded view in perspective showing removable stencil removed from holder

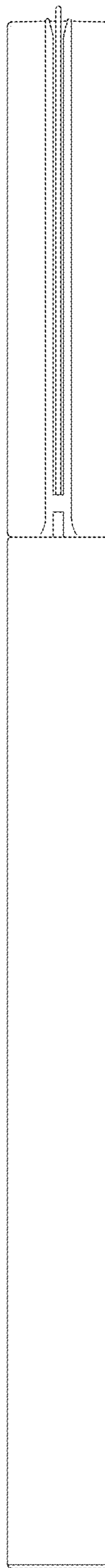

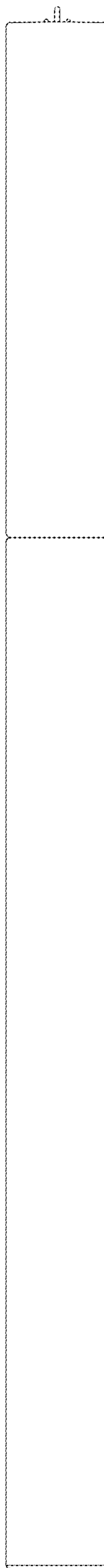


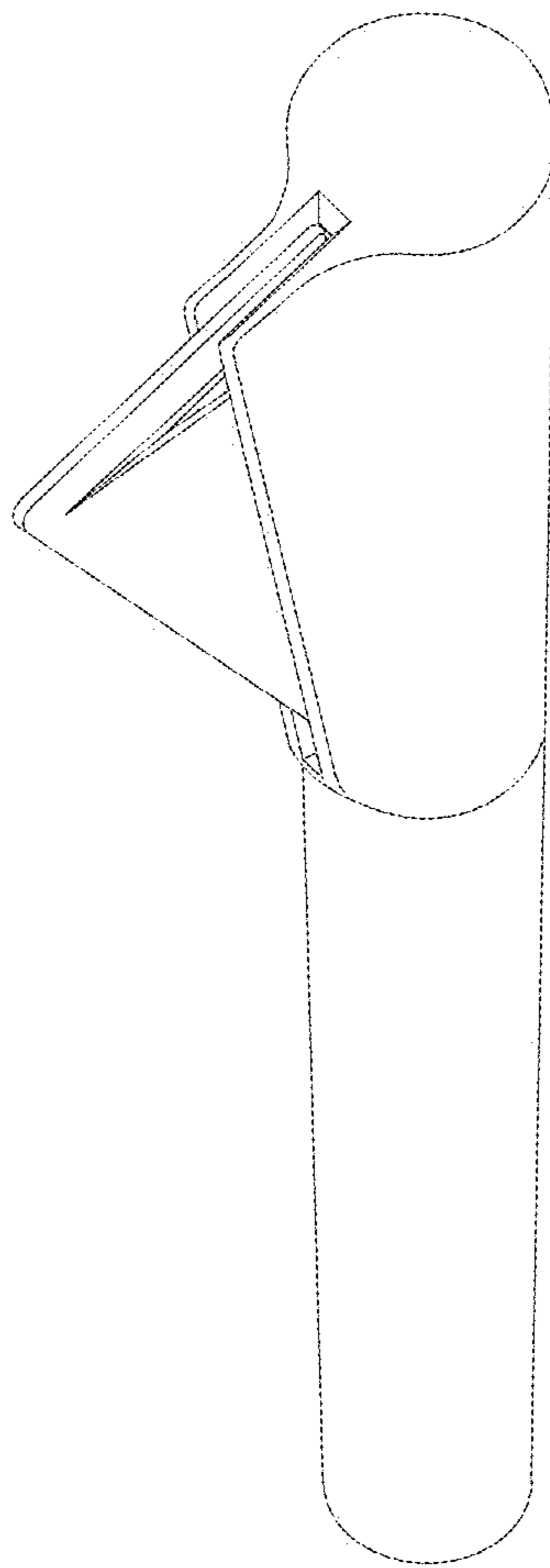

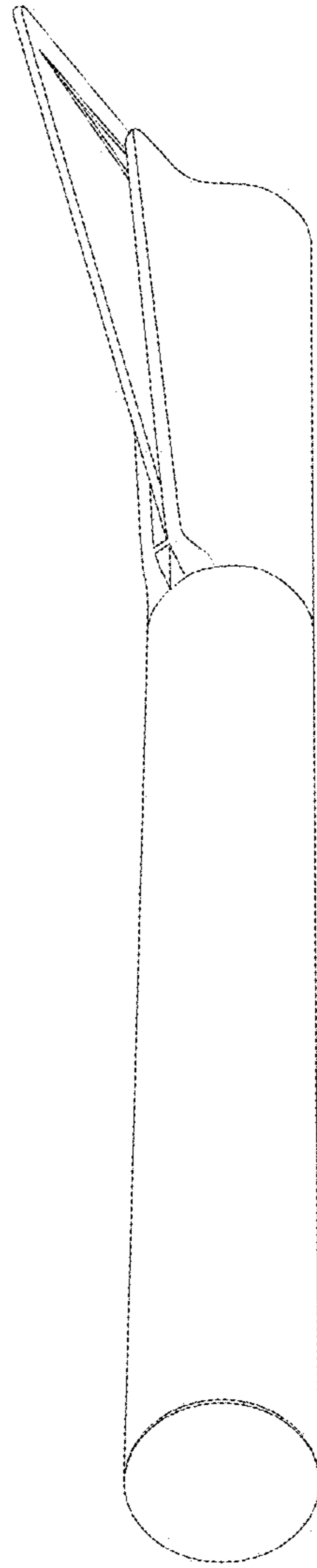
