(57) **CLAIM**

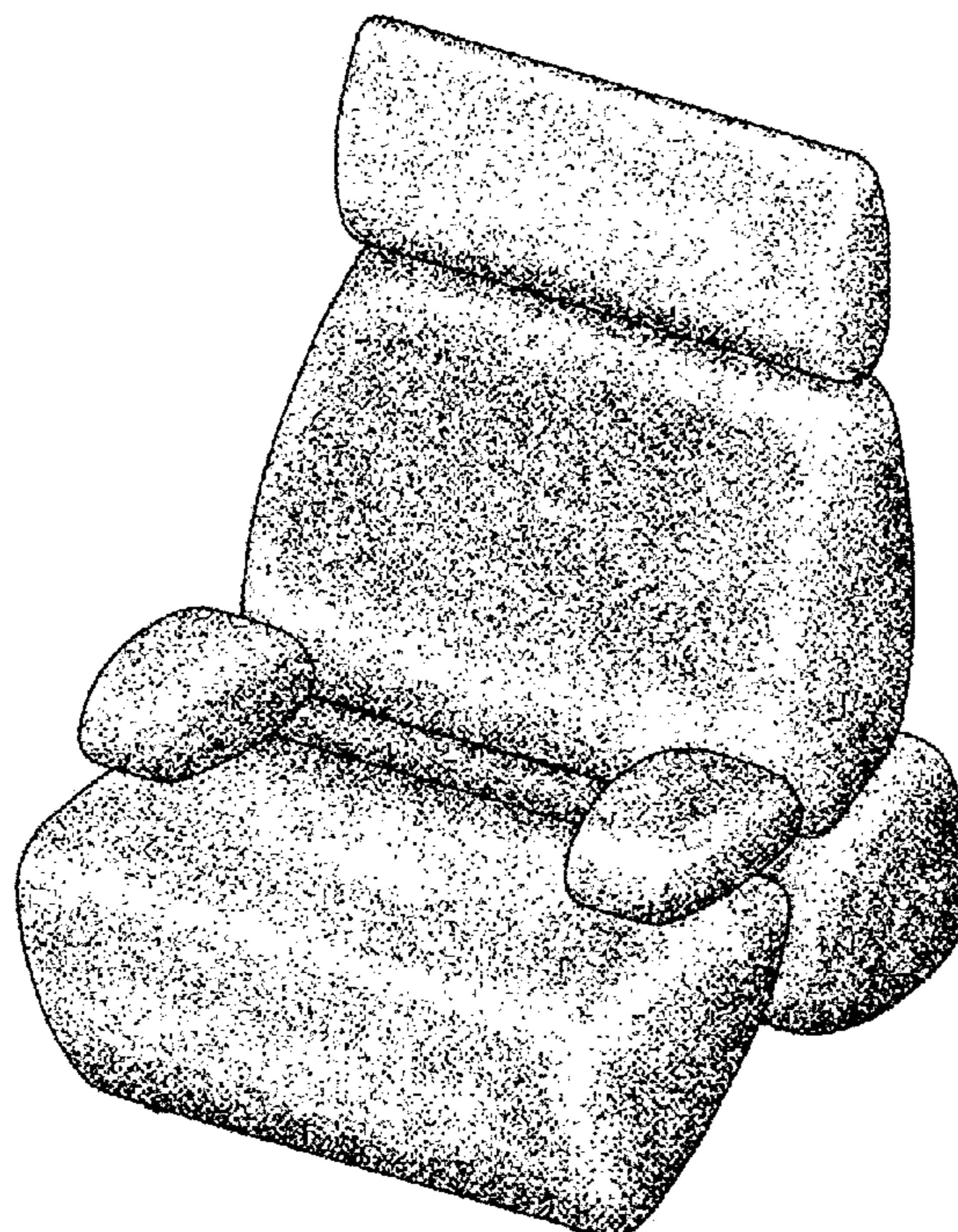
The ornamental design for a sofa, as shown and described.

DESCRIPTION

FIG. 1 is a front, top, and right side perspective view of a sofa, showing our new design;
 FIG. 2 is a rear, top, and left side perspective view thereof;

 FIG. 4 is a rear view thereof;
 FIG. 5 is a top plan view thereof;
 FIG. 6 is a bottom plan view thereof;
 FIG. 7 is a right side view thereof;
 FIG. 8 is a cross-sectional view taken along the line 8-8 in FIG. 3; and,
 FIG. 9 is a cross-sectional view taken along the line 9-9 in FIG. 7.
 The left side view is omitted because it is a mirror image of the right side view.

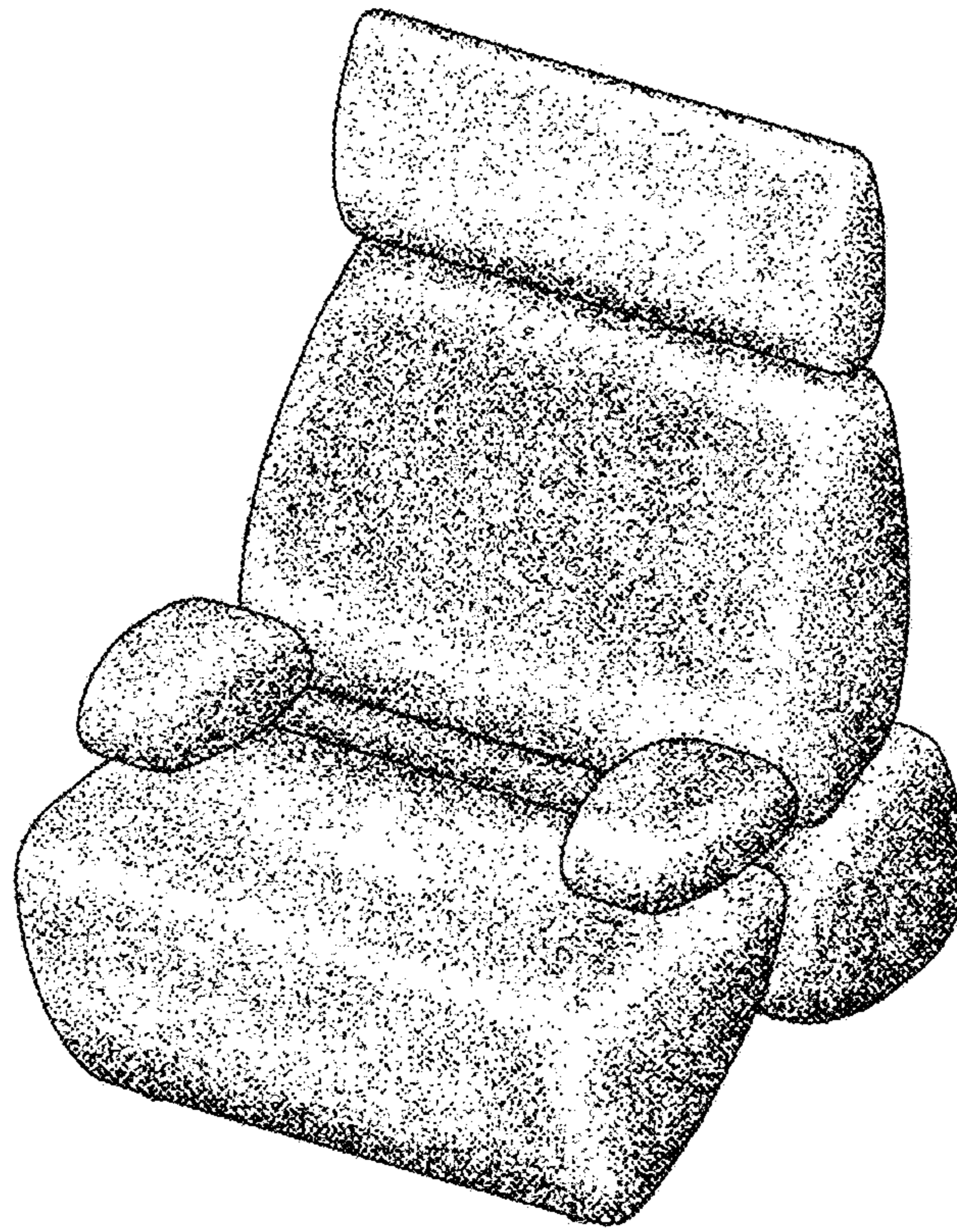

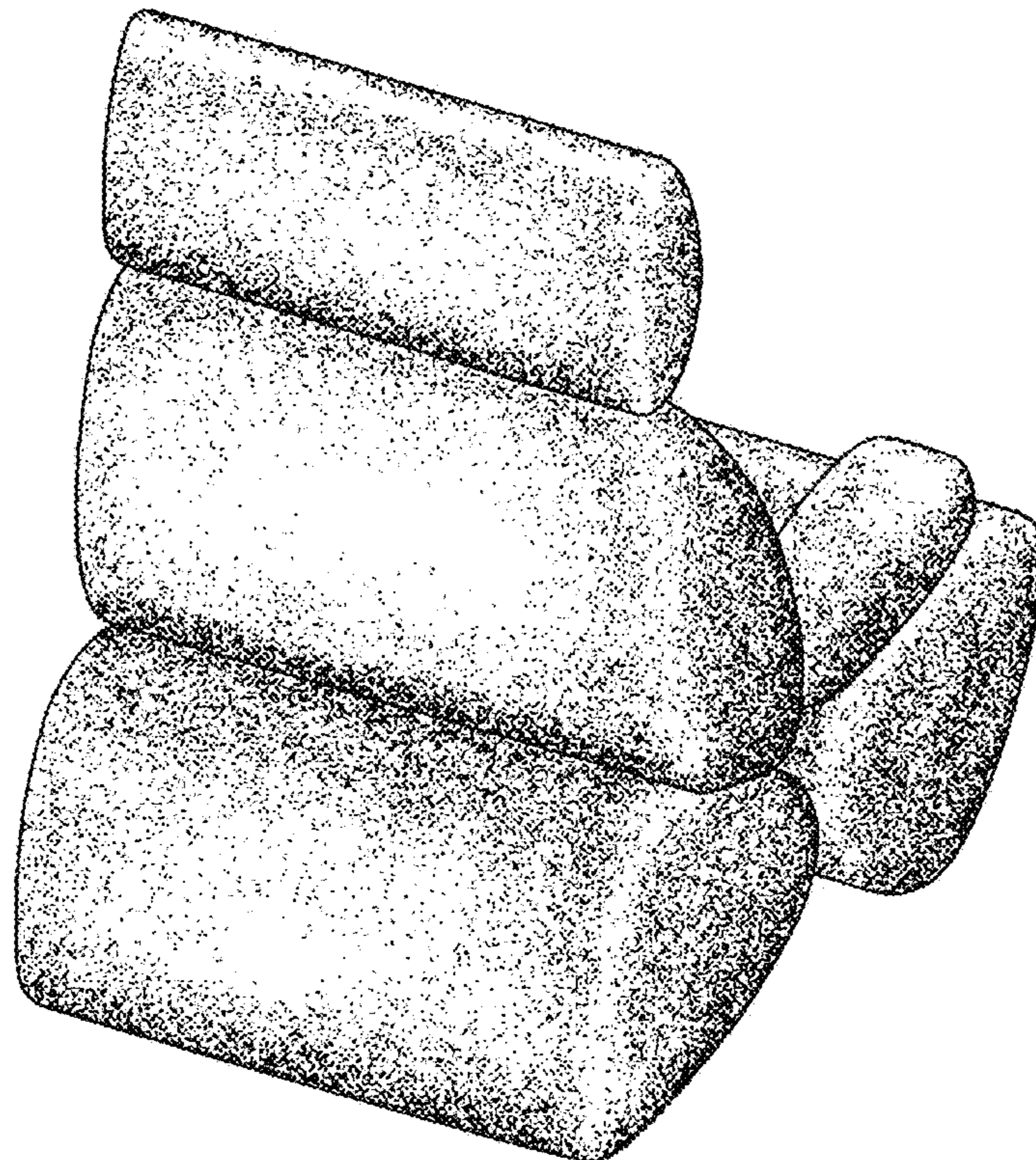

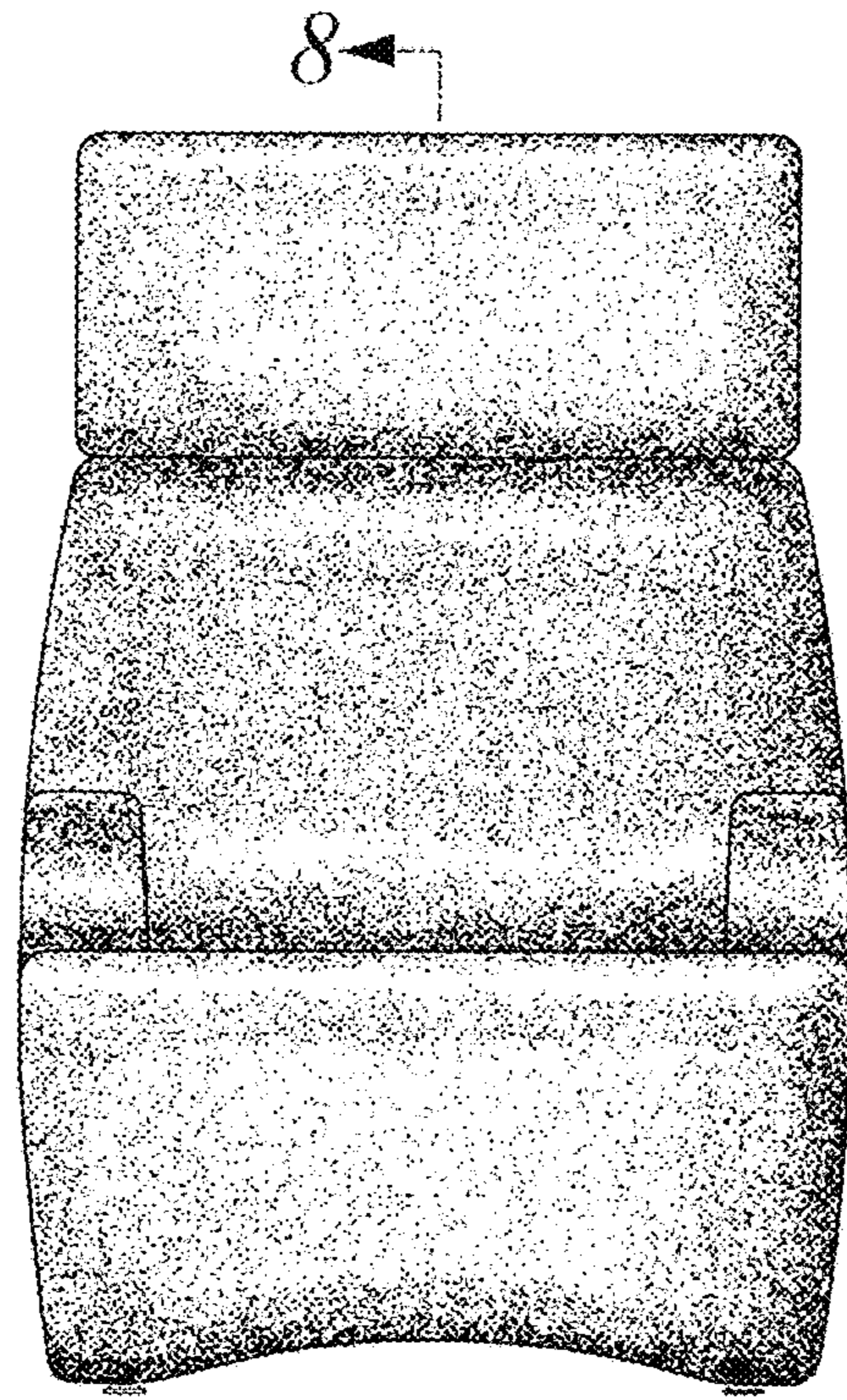

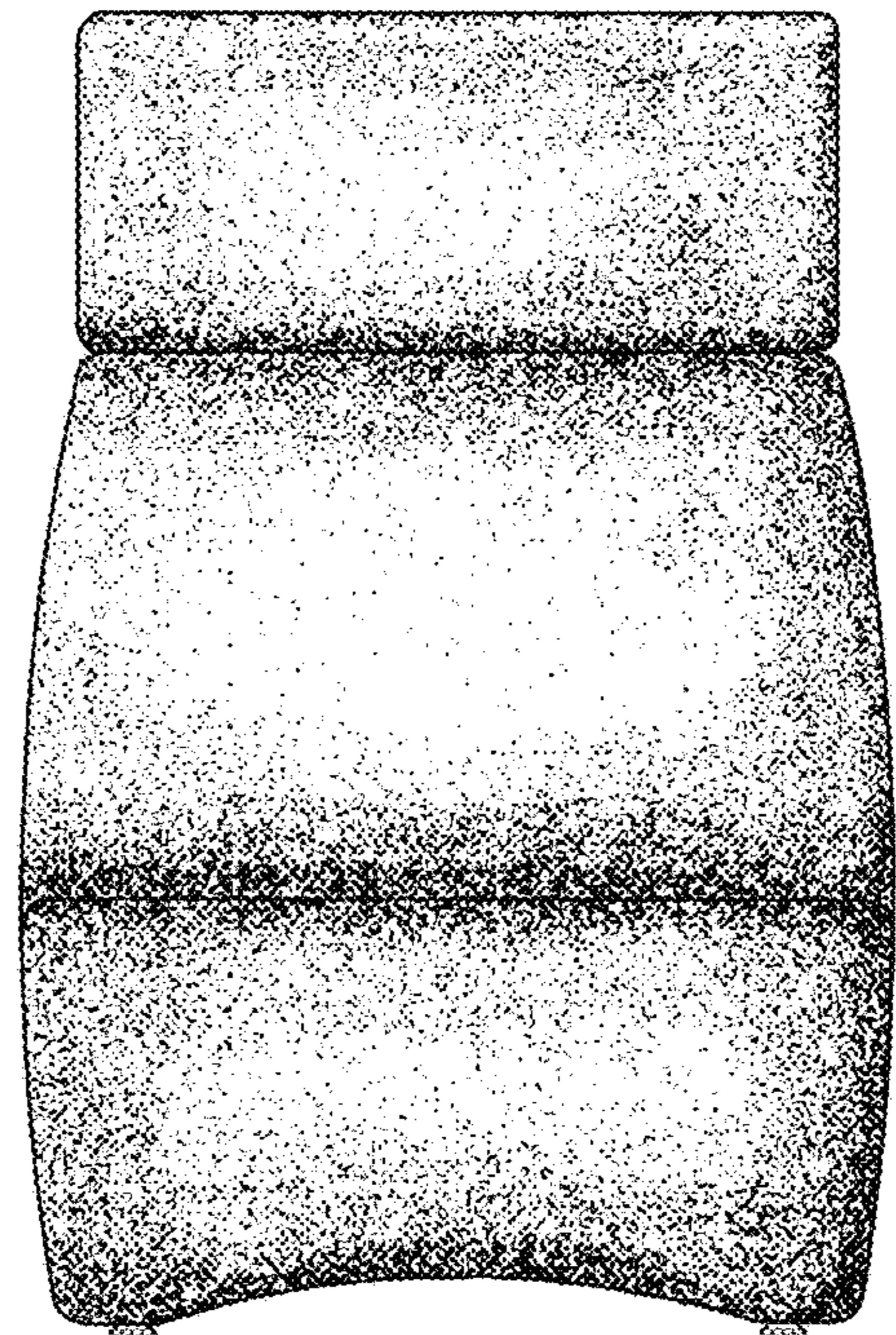

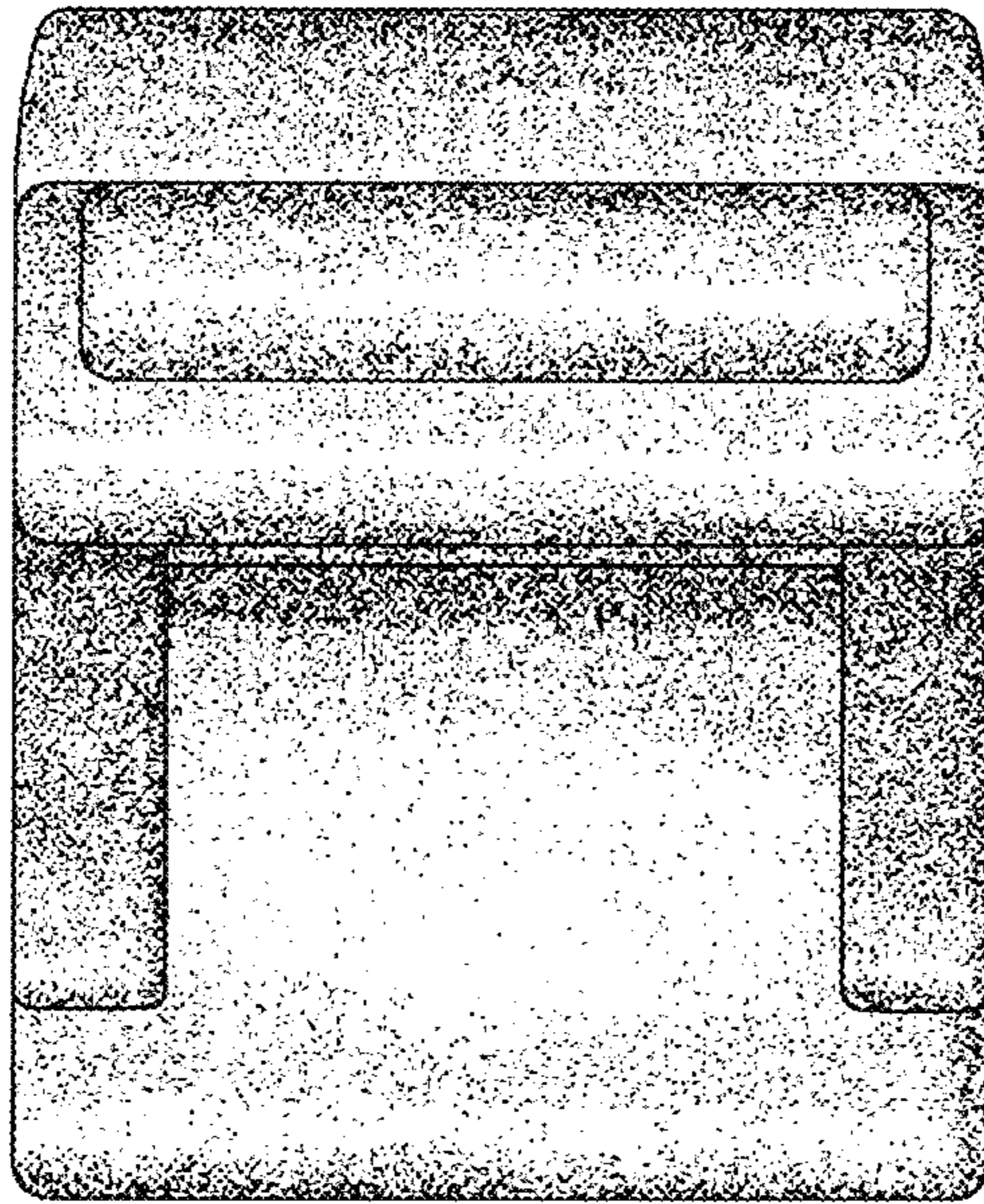

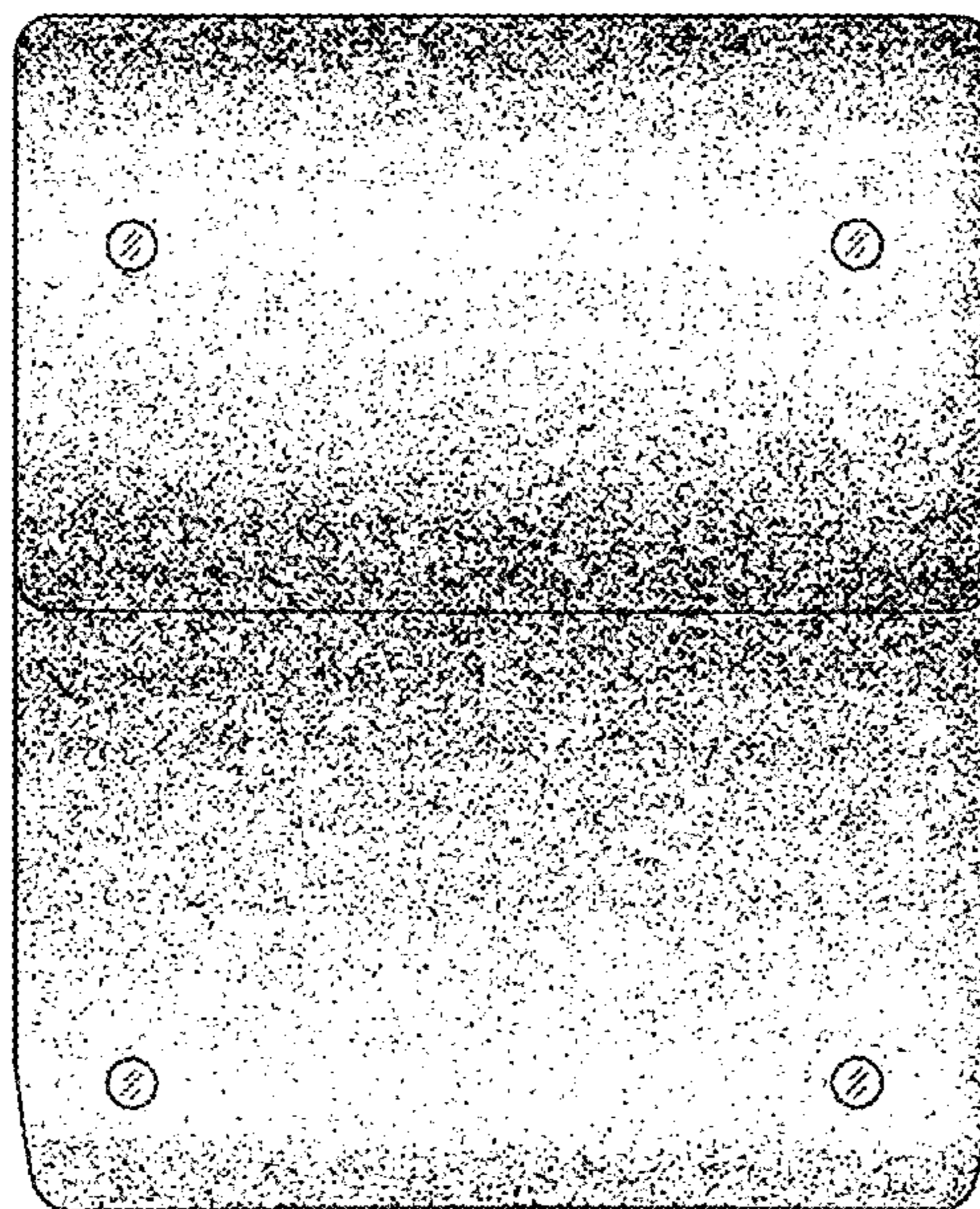

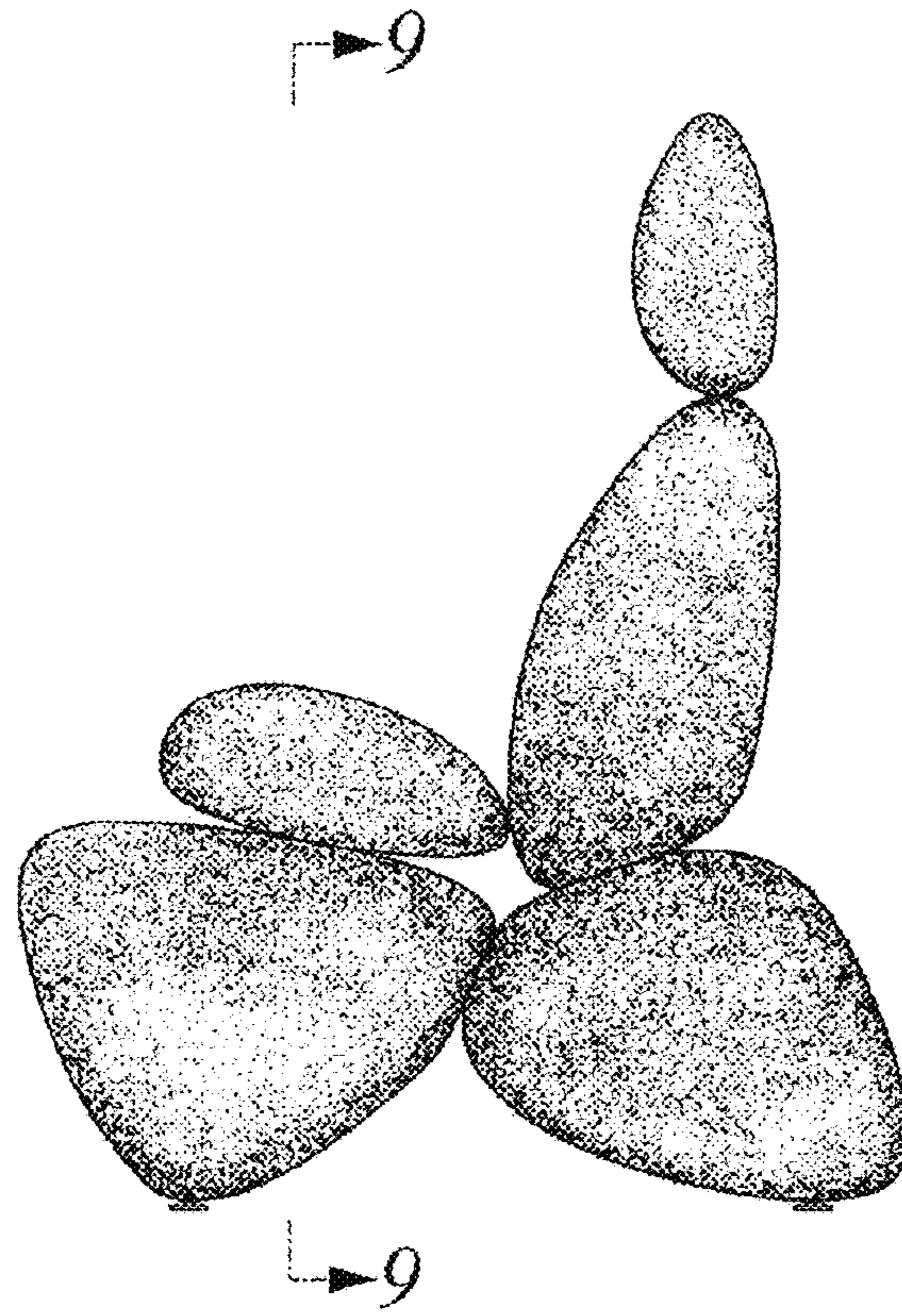

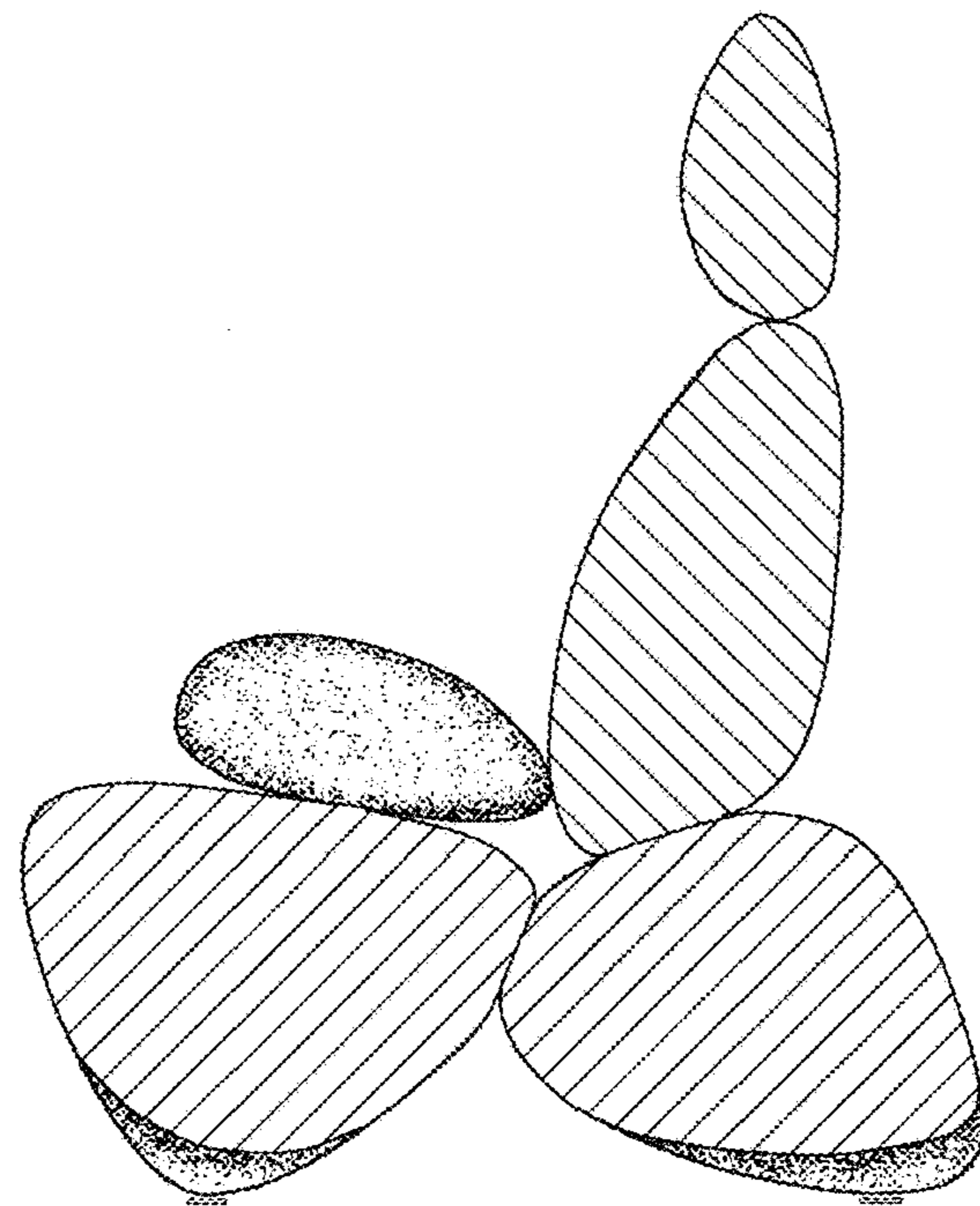

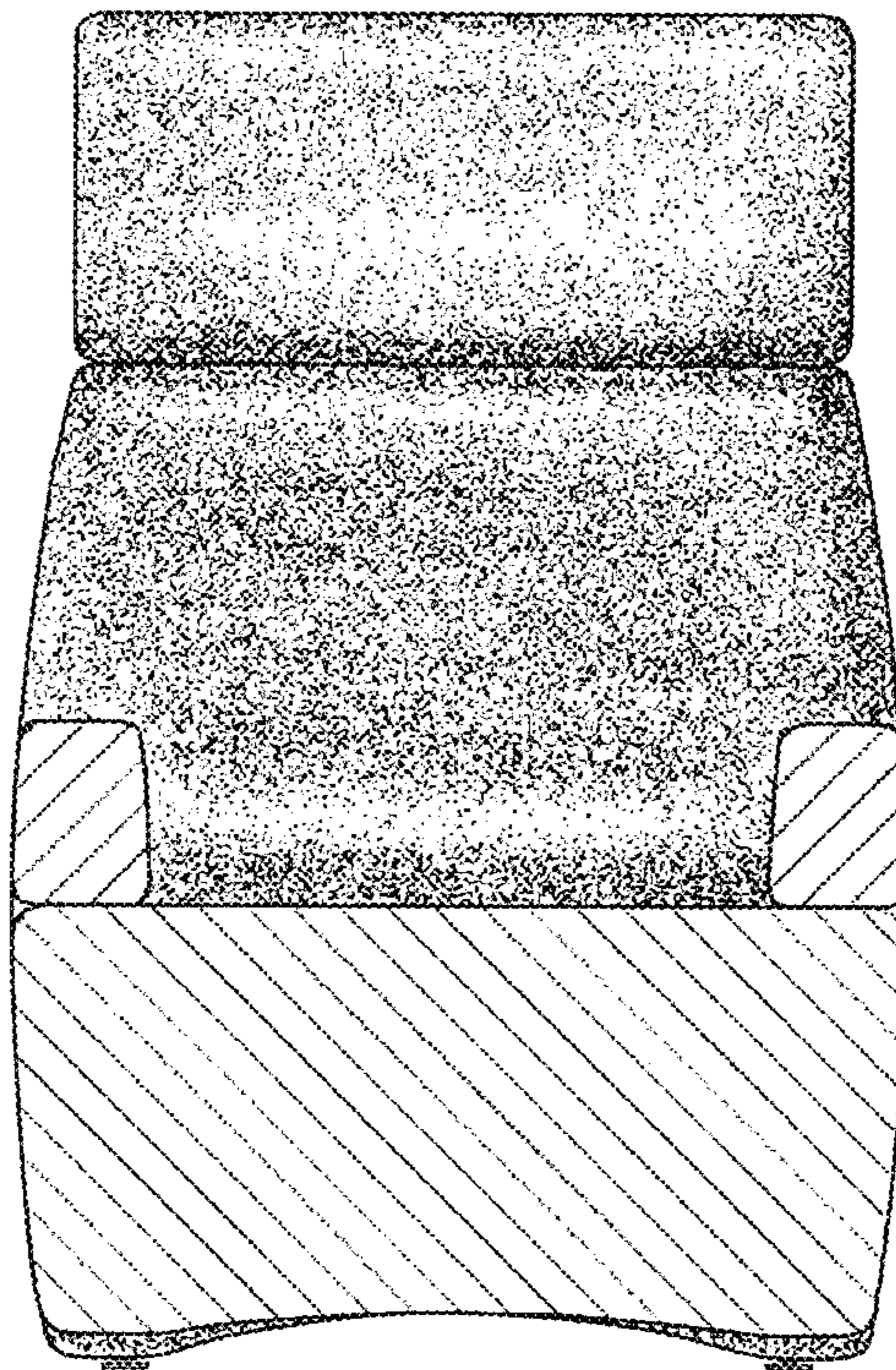
