(57) **CLAIM**

The ornamental design for a pillowcase with mesh insert, as shown and described.

DESCRIPTION

FIG. 1 is a top view of the pillowcase with mesh insert showing the new design, the bottom view of the pillowcase with mesh insert being identical to the top view.

FIG. 2 is a perspective view of the pillowcase with mesh insert shown in FIG. 1, where the pillowcase is depicted as covering a pillow.

FIG. 3 is a back, perspective view of the pillowcase with mesh insert shown in FIG. 1, where the pillowcase is depicted as covering a pillow.

FIG. 4 is a top view of the pillowcase with mesh insert shown in FIG. 1, where the pillowcase is depicted as covering a pillow.

FIG. 5 is a bottom view of the pillowcase with mesh insert shown in FIG. 1, where the pillowcase is depicted as covering a pillow.

FIG. 6 is a left, side view of the pillowcase with mesh insert shown in FIG. 1, where the pillowcase is depicted as covering a pillow.

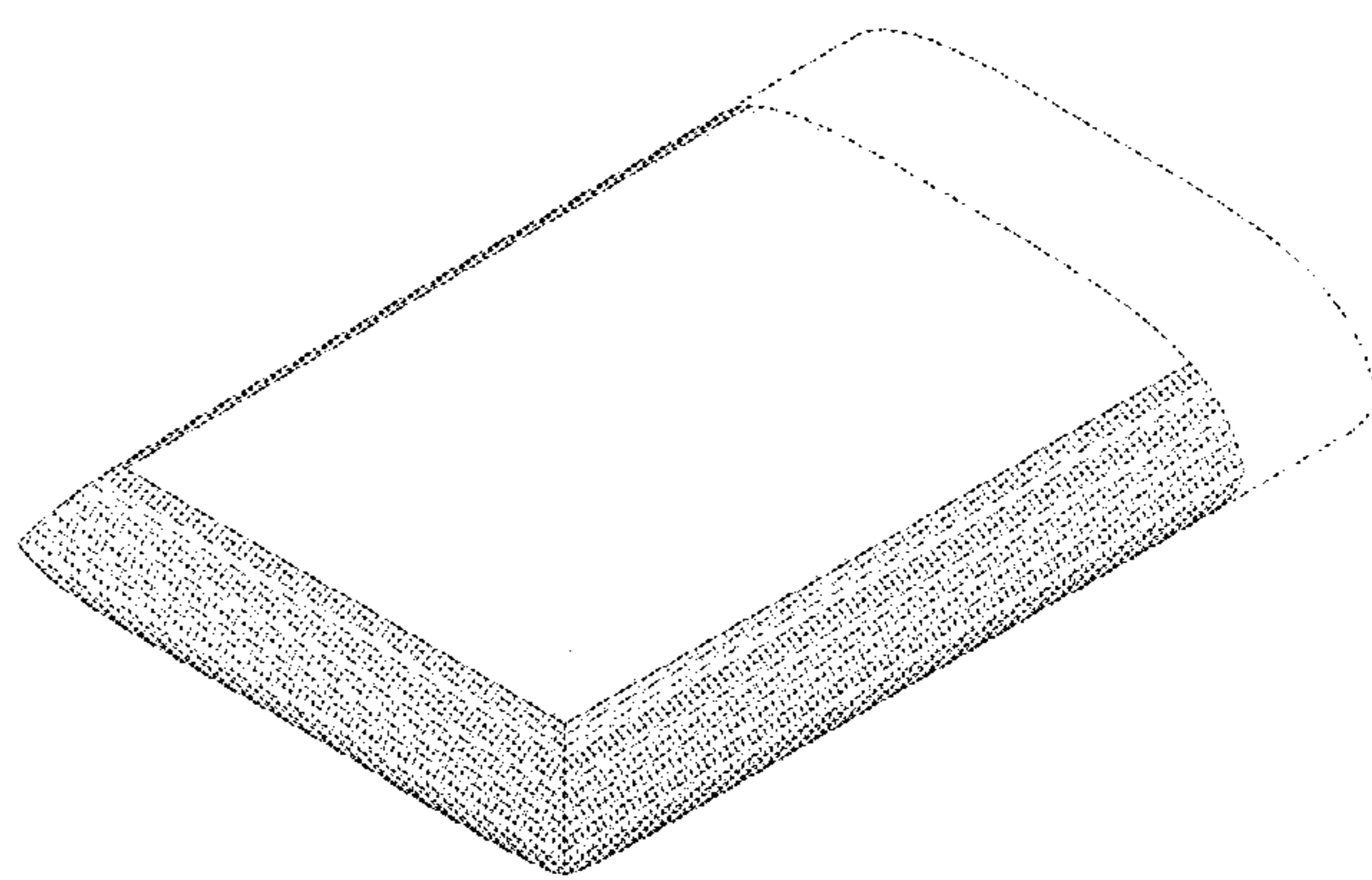
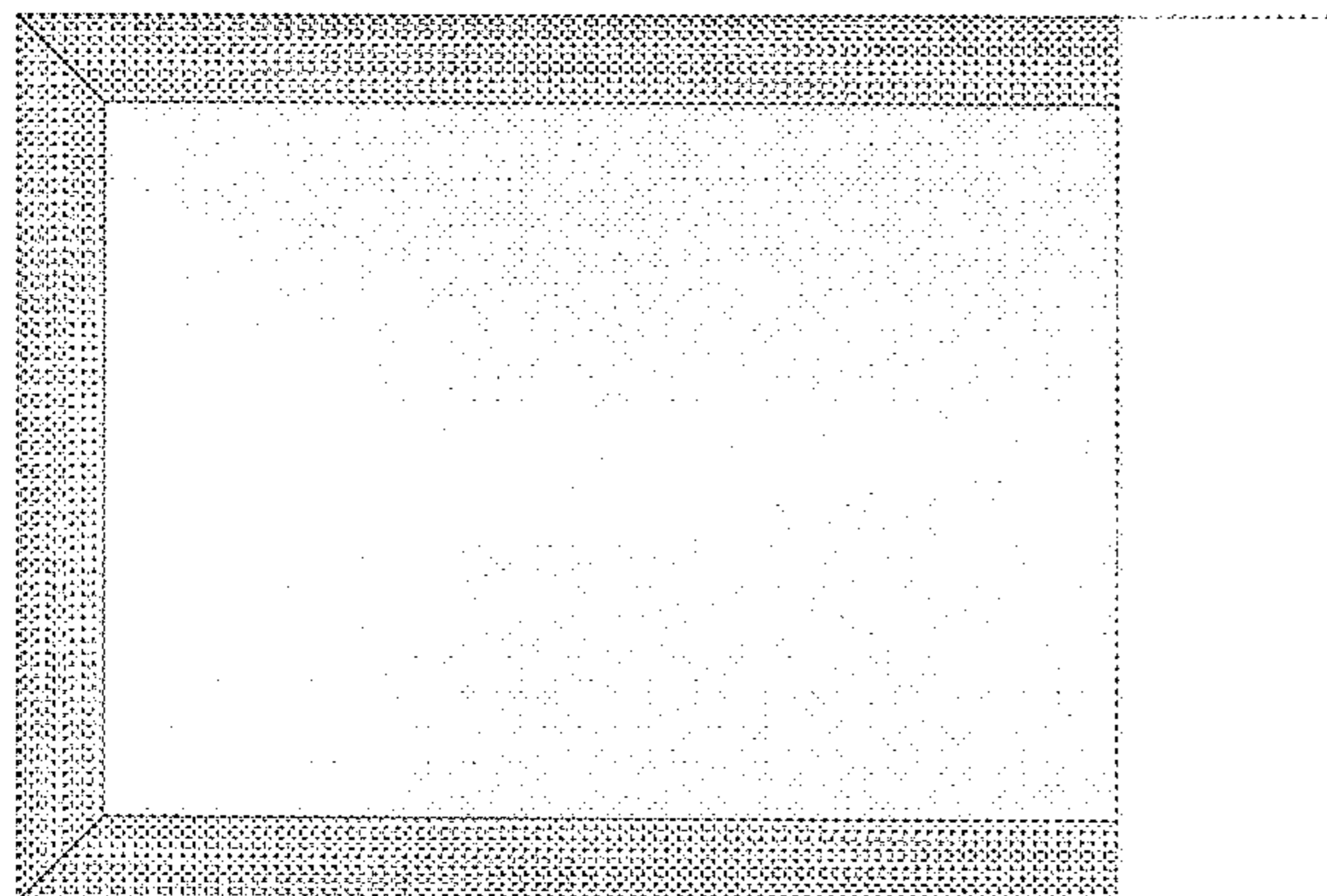
FIG. 7 is a right, side view of the pillowcase with mesh insert shown in FIG. 1, where the pillowcase is depicted as covering a pillow.

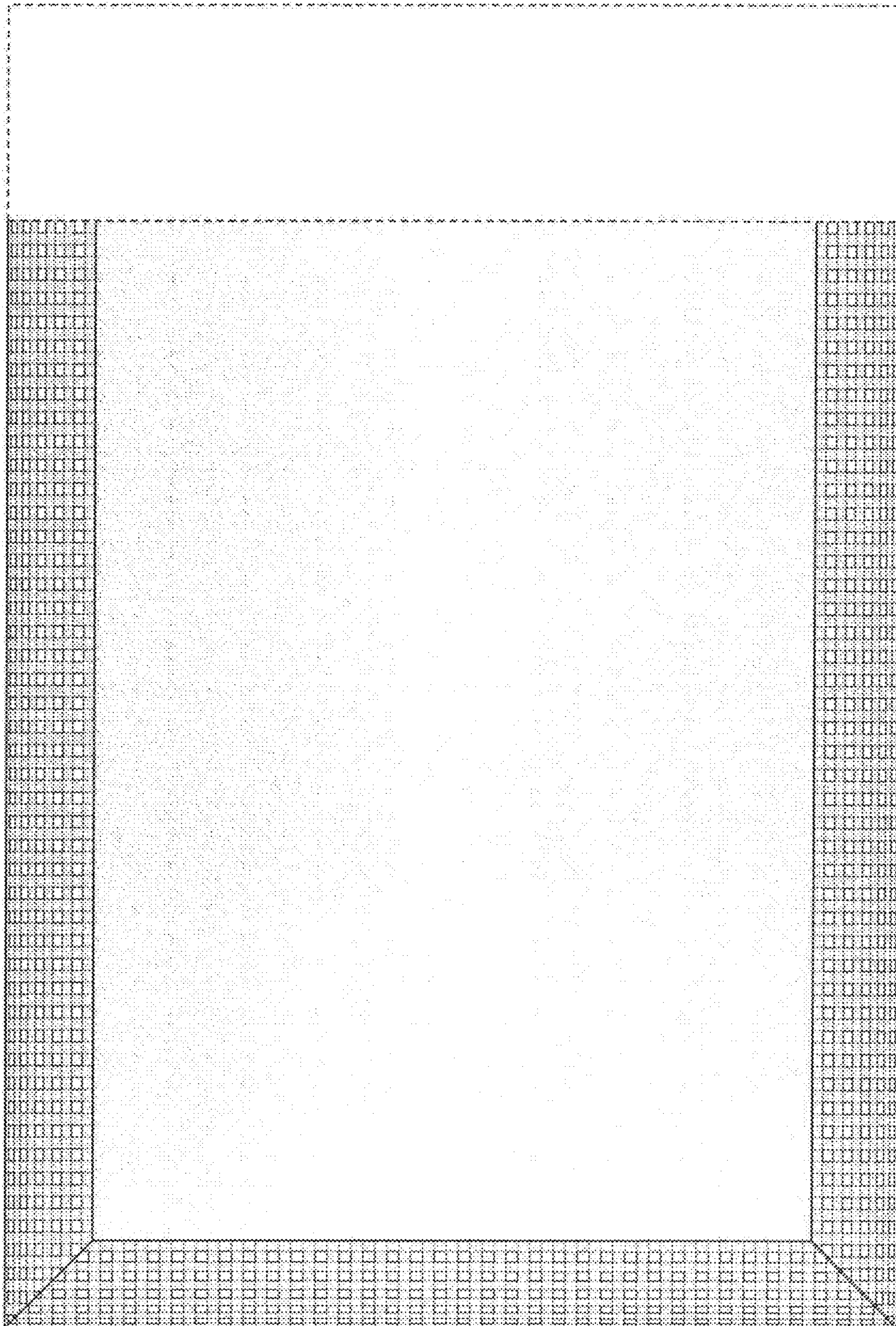

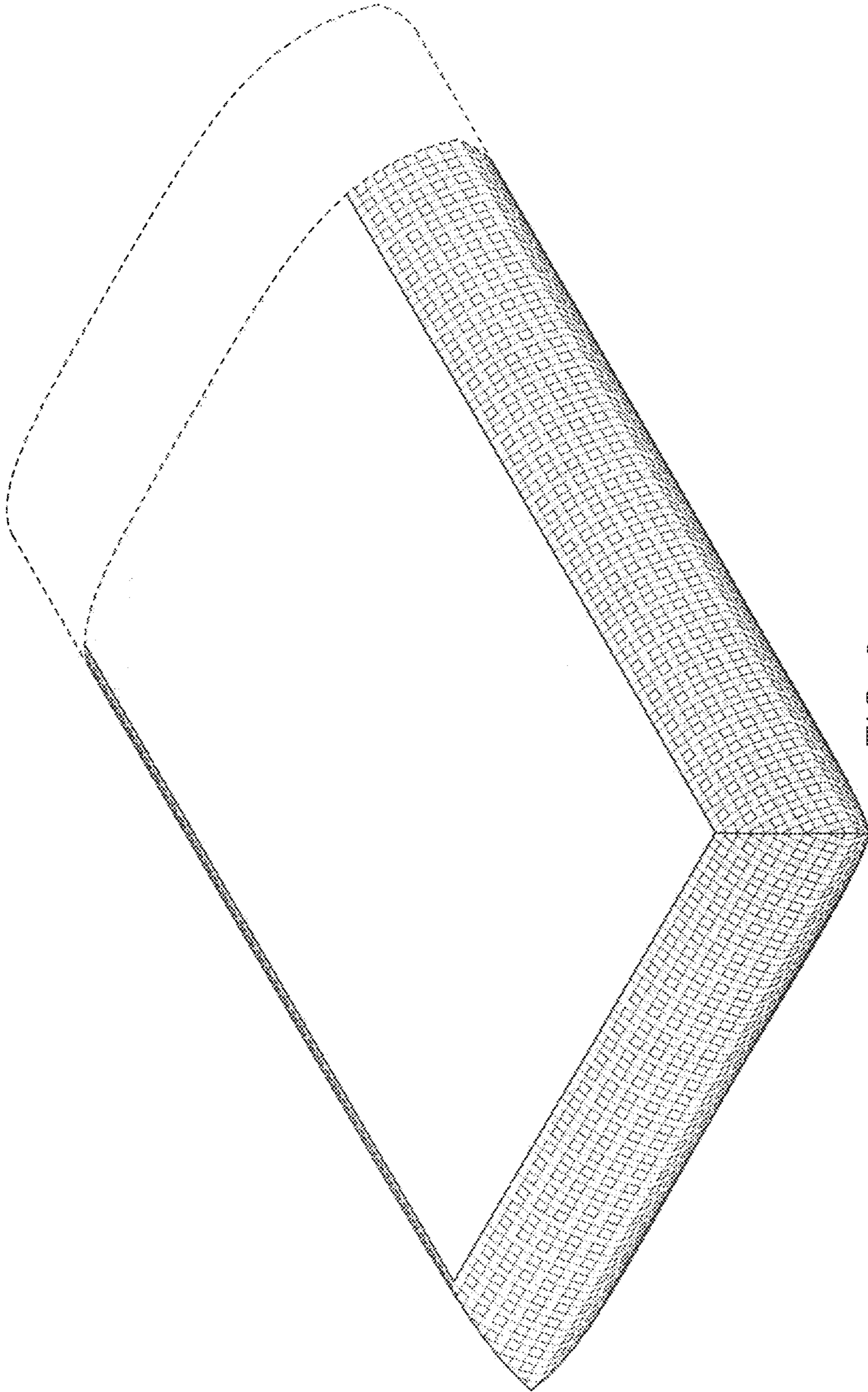

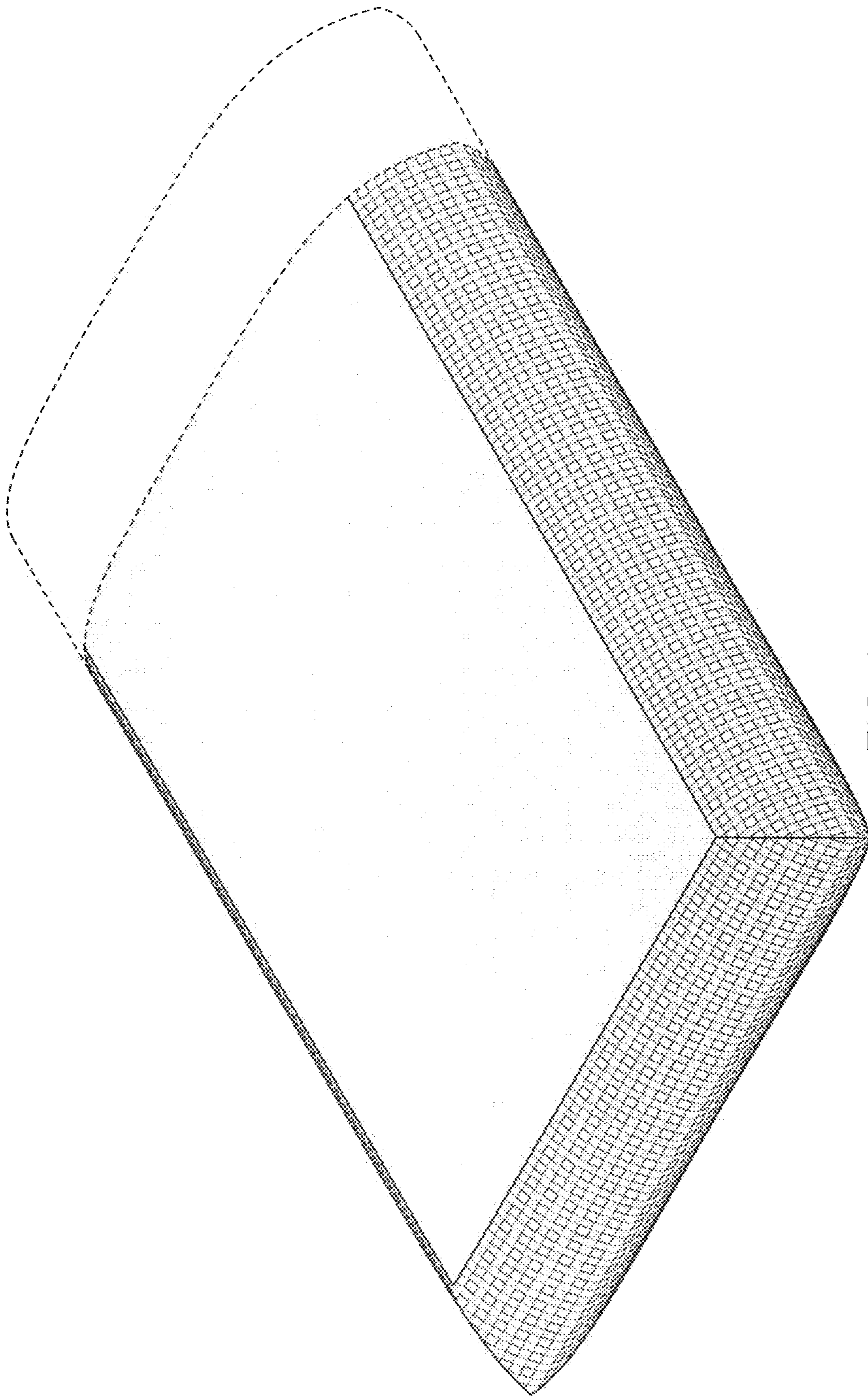

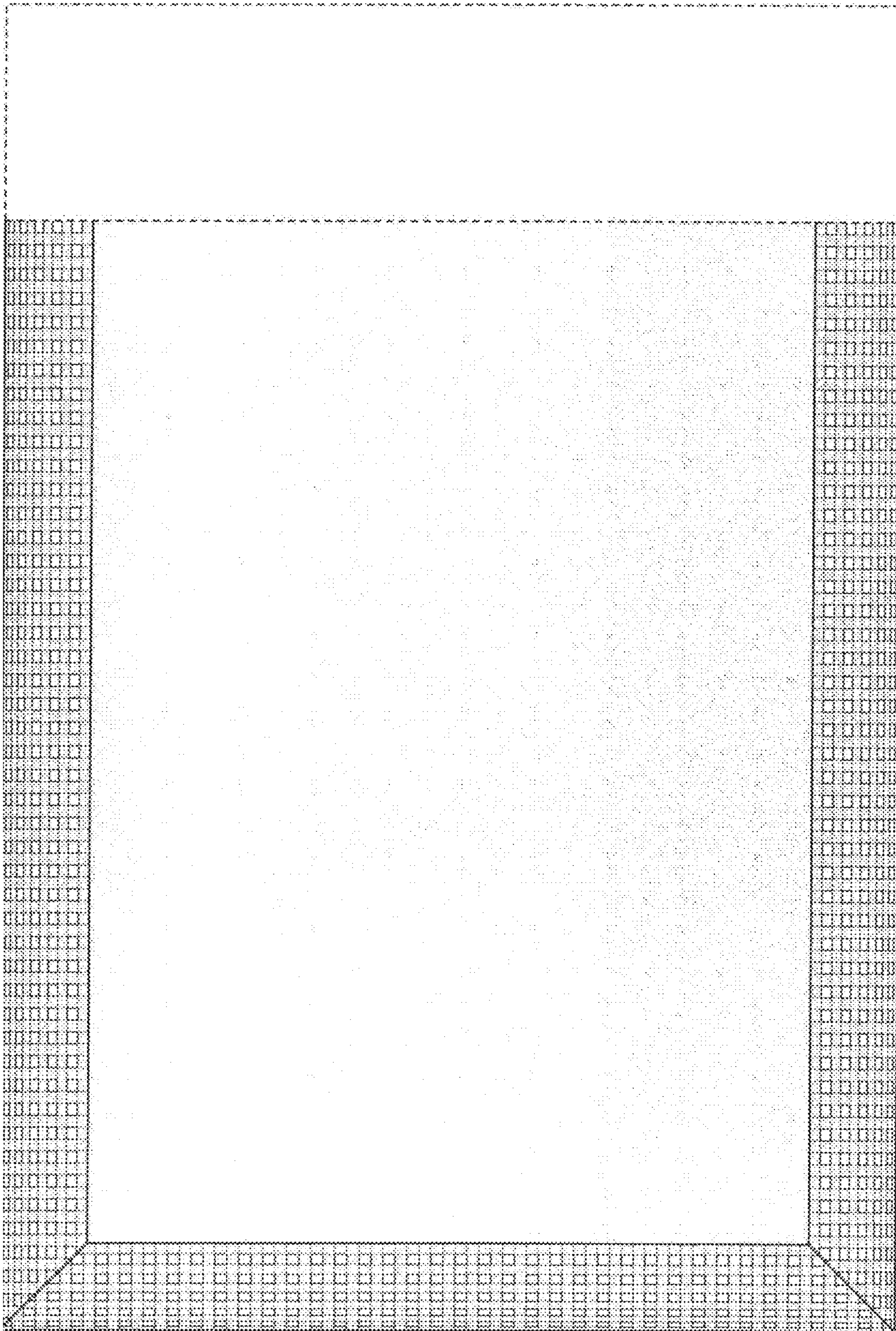

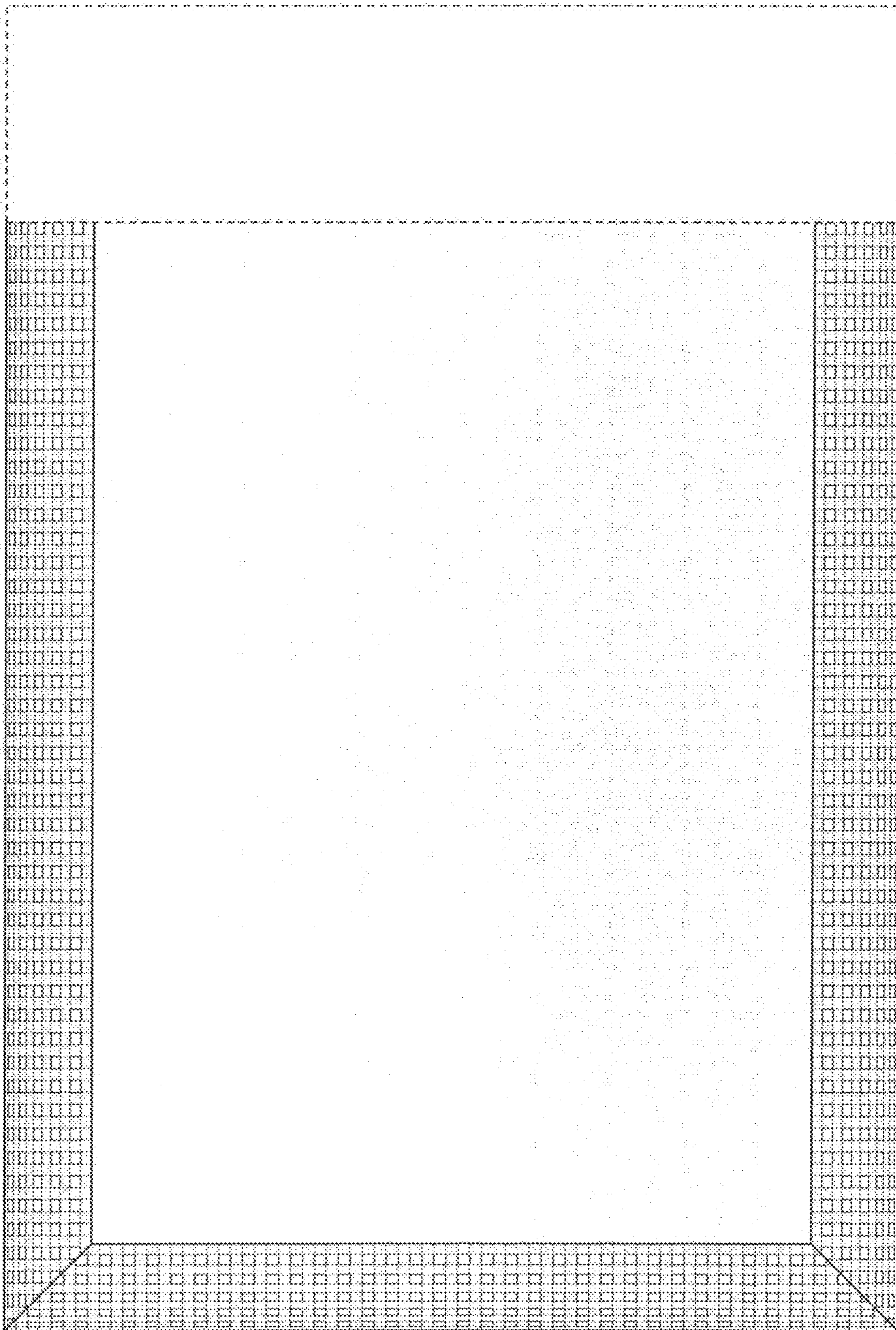

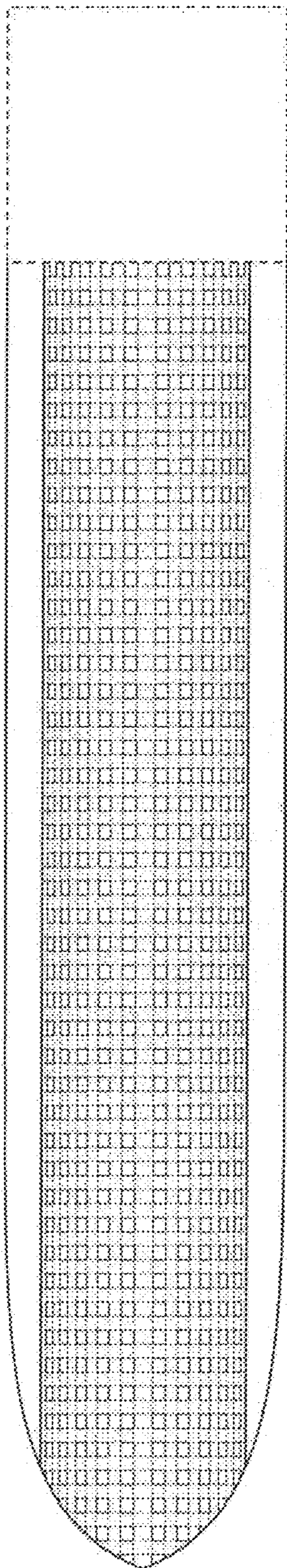

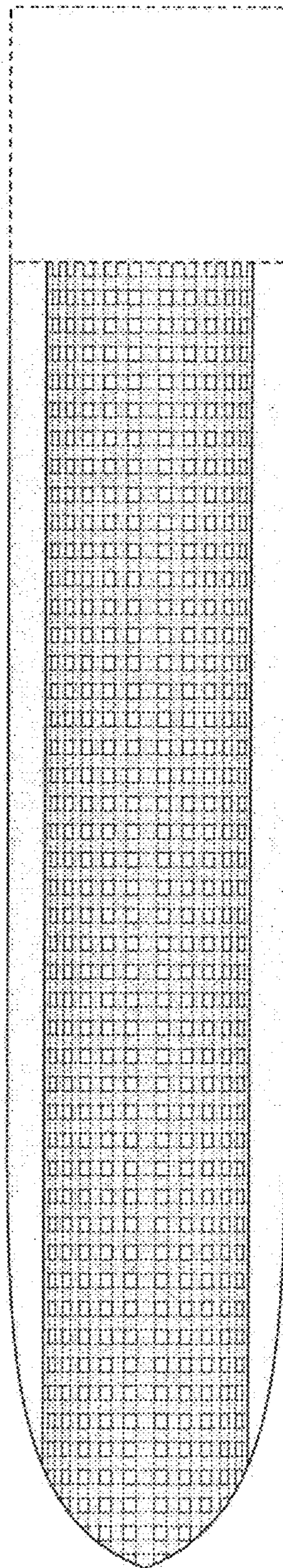

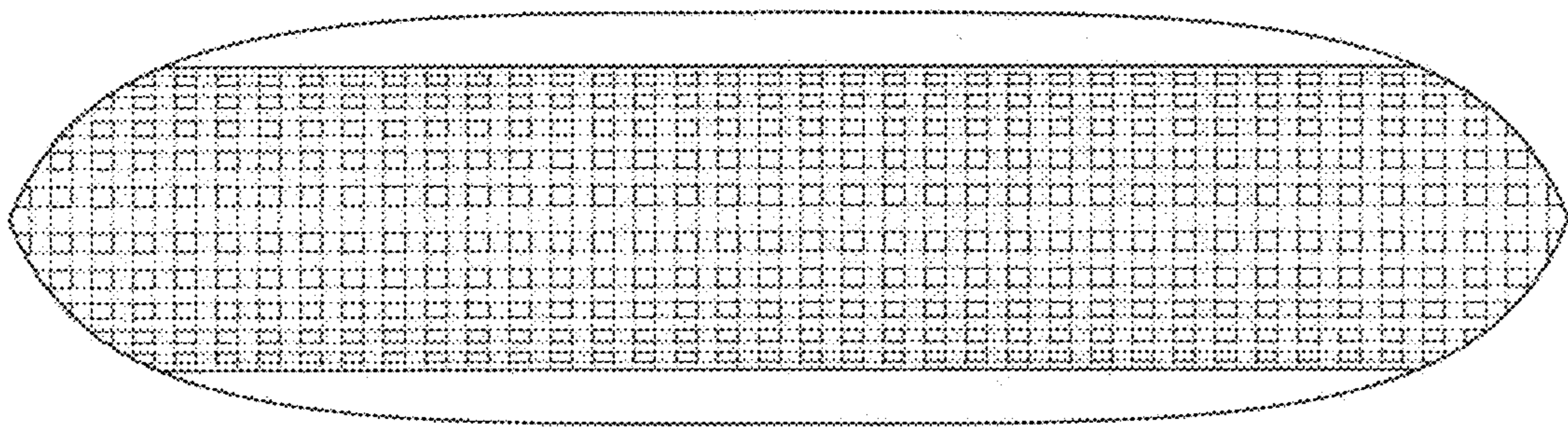
