(57) **CLAIM**

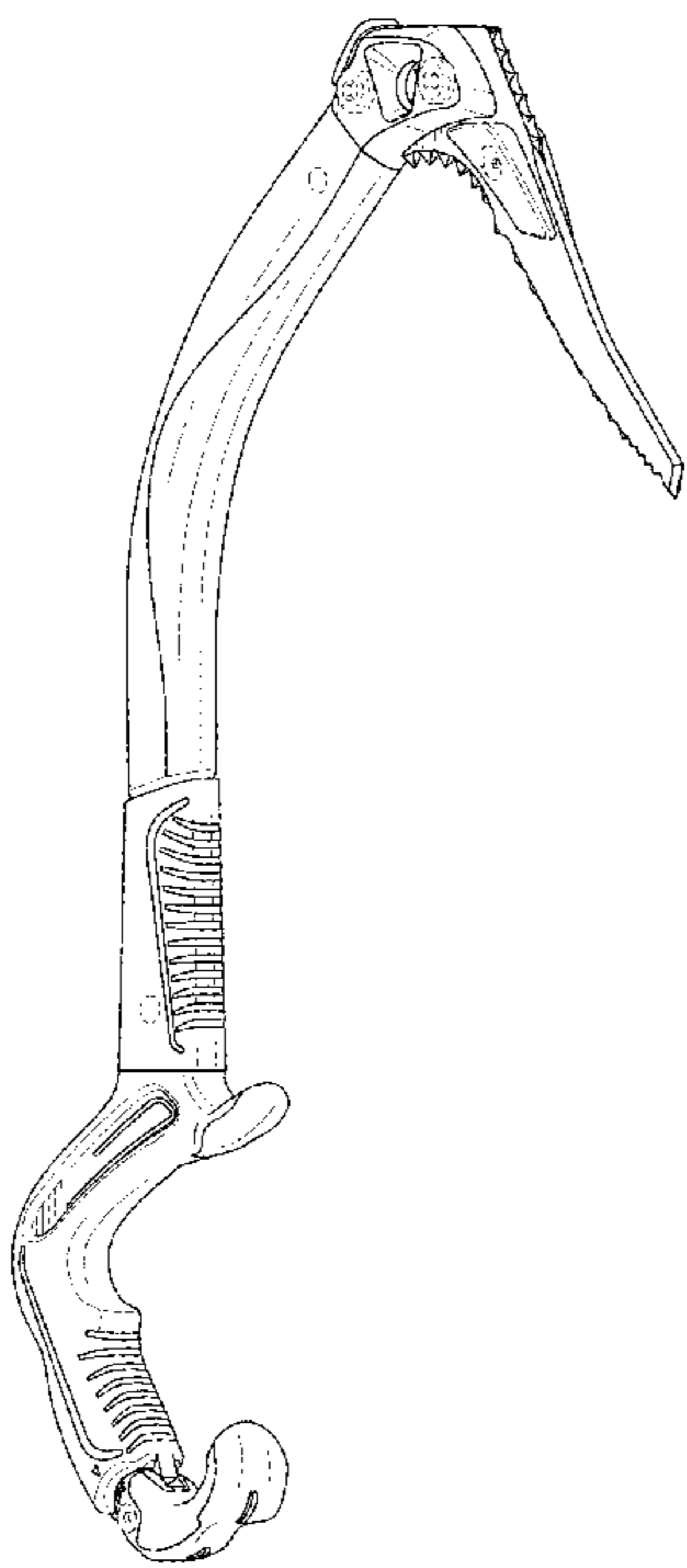
The ornamental design for an ice axe, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, left-side perspective view of the ice axe; FIG. 2 is a left-side elevational view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a front elevational view thereof; FIG. 6 is a right-side elevational view thereof; FIG. 7 is a bottom plan view thereof; and, FIG. 8 is a rear, right-side, top perspective view thereof. The broken lines depict portions of the ice axe that form no part of the claimed design.

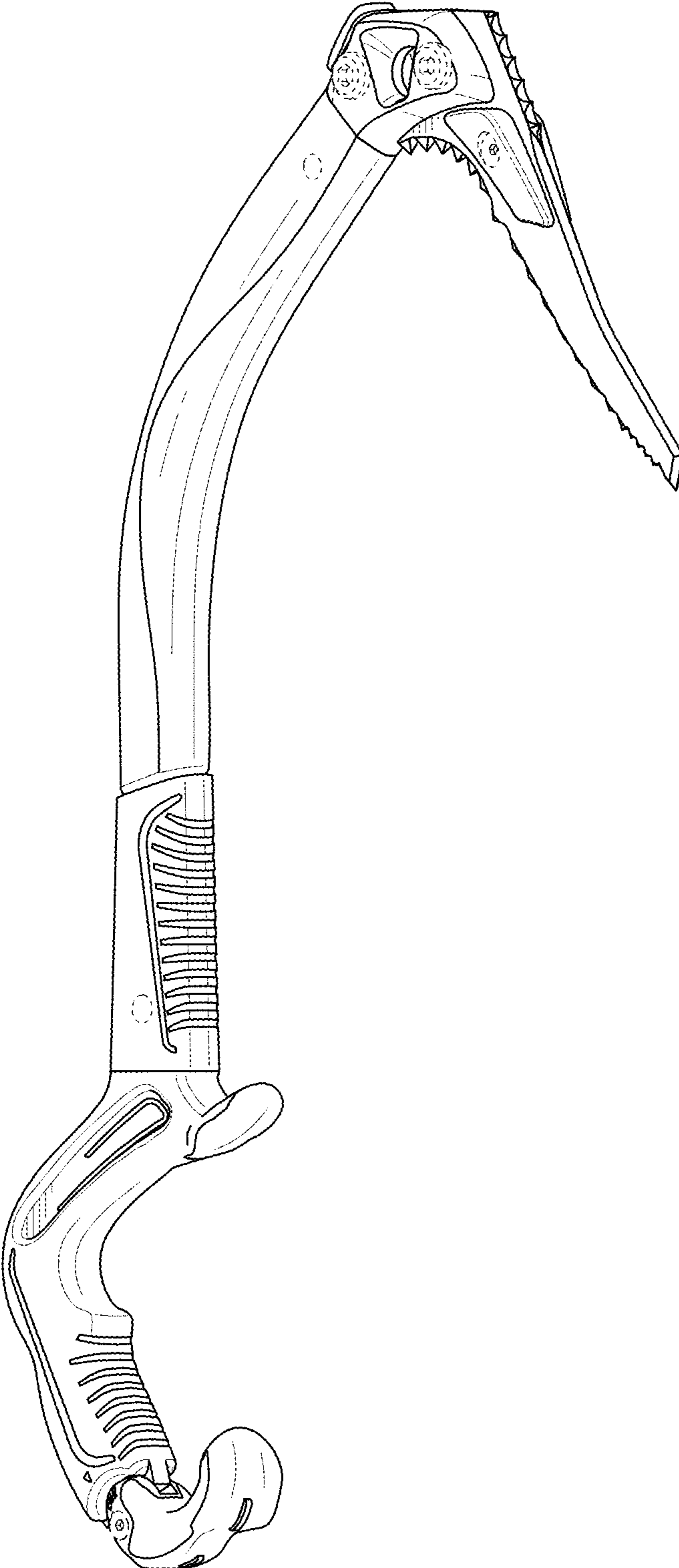

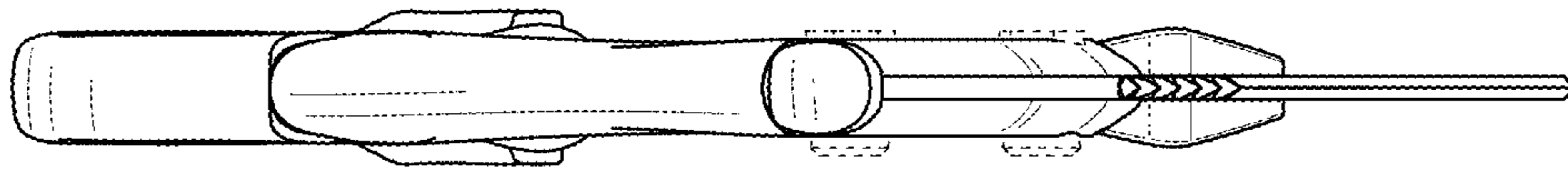

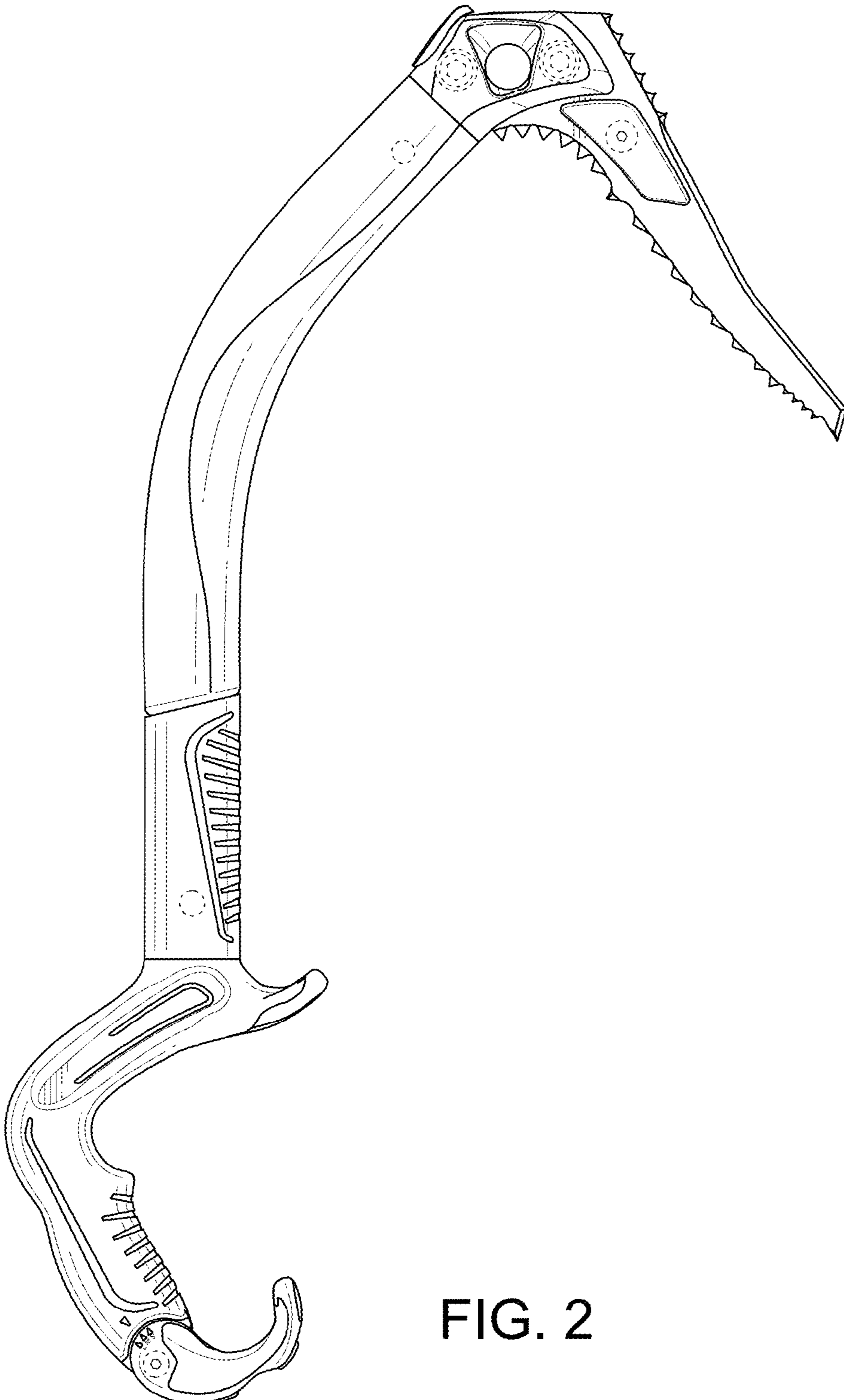

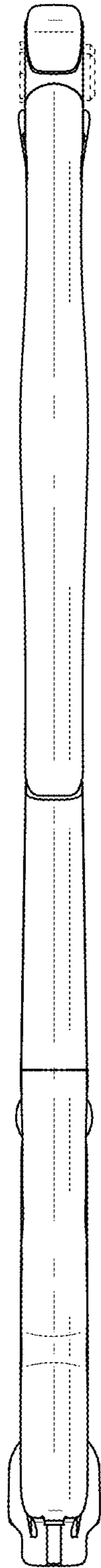

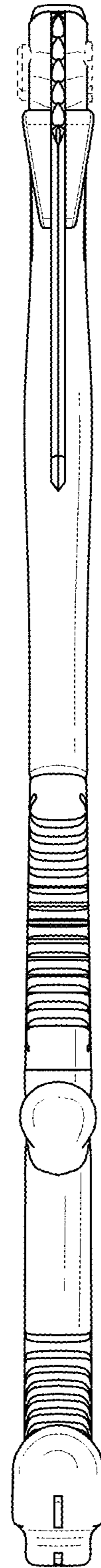

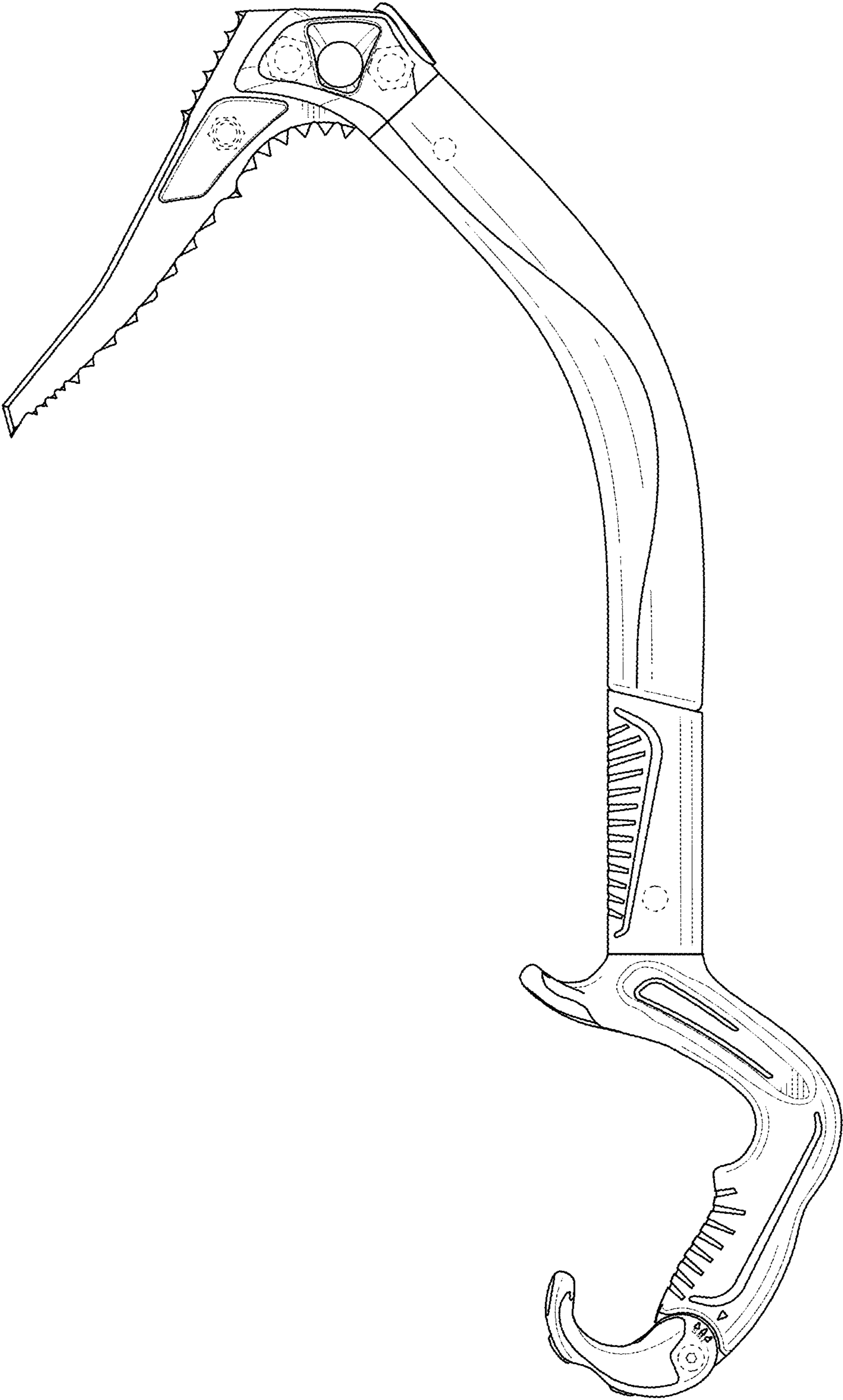

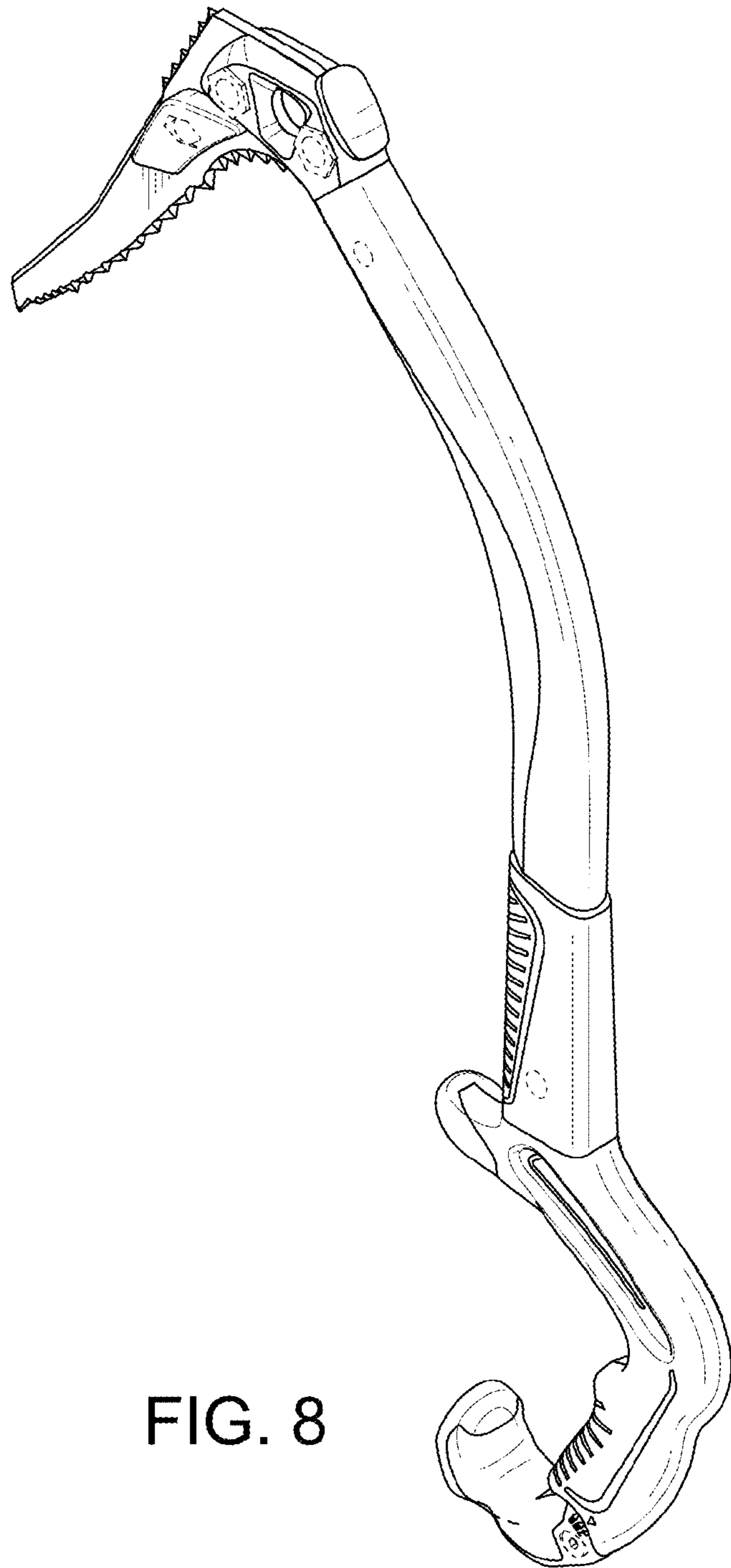

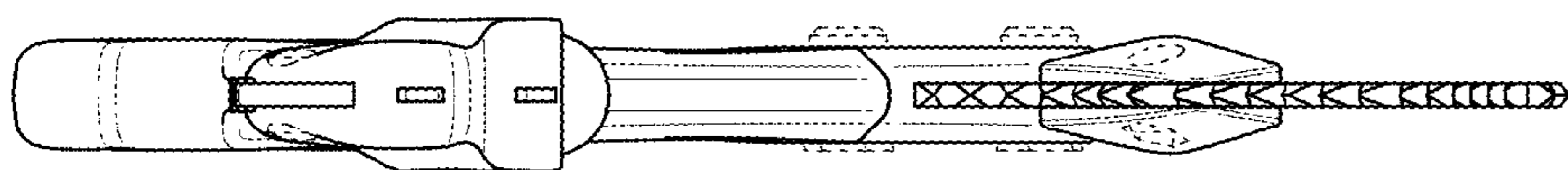
