(57) **CLAIM**

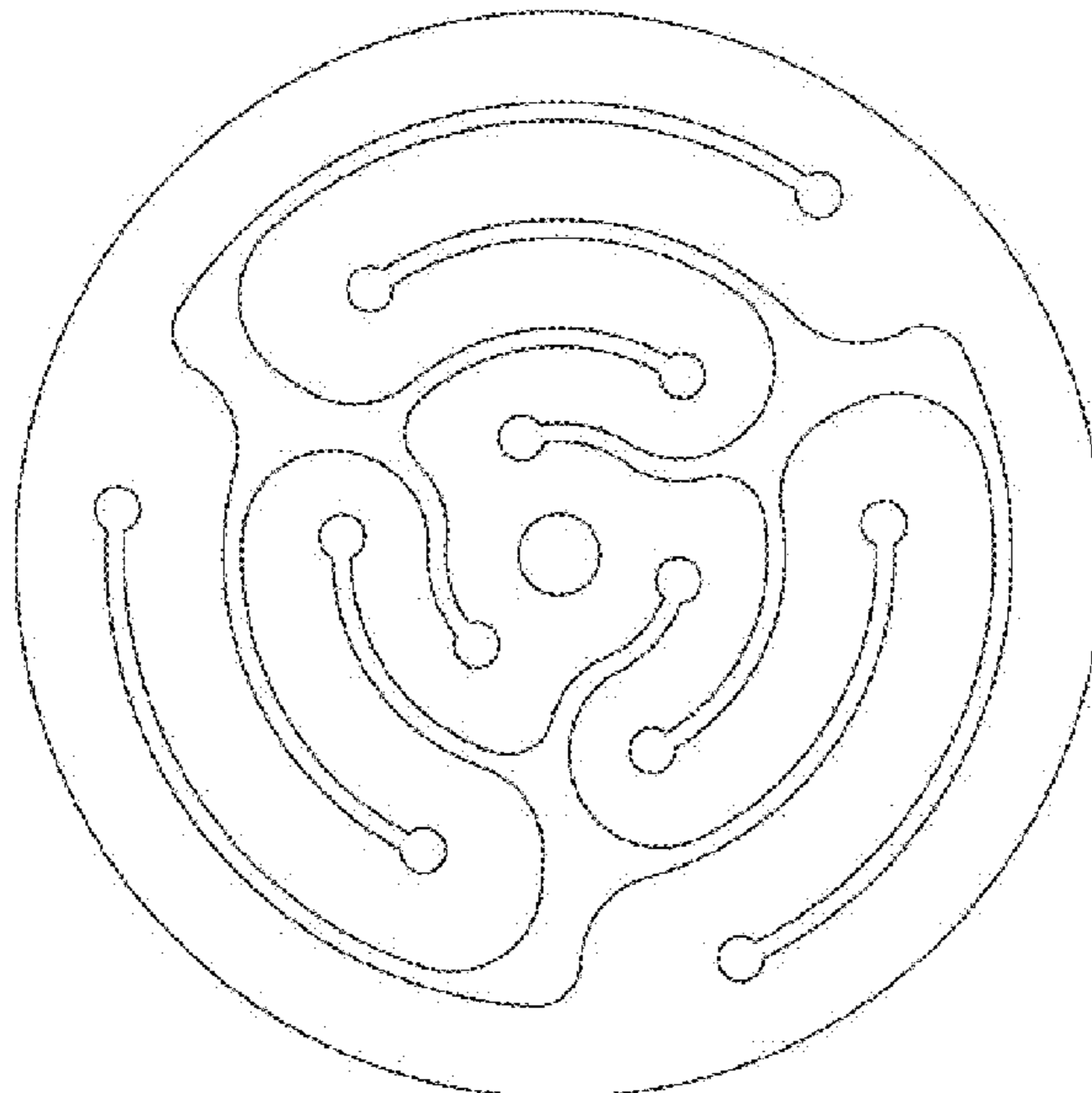
The ornamental design for a motor membrane, as shown and described.

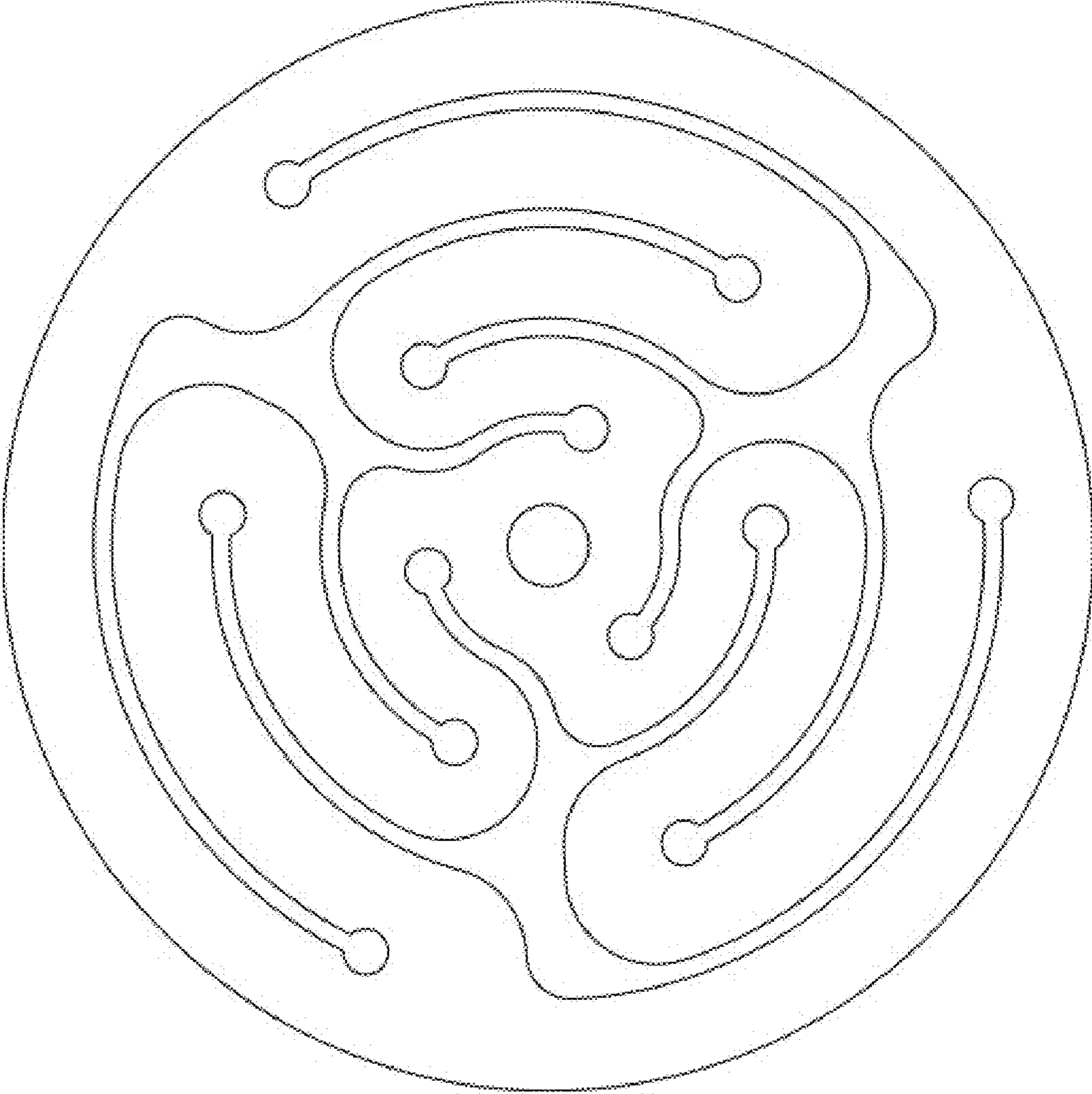

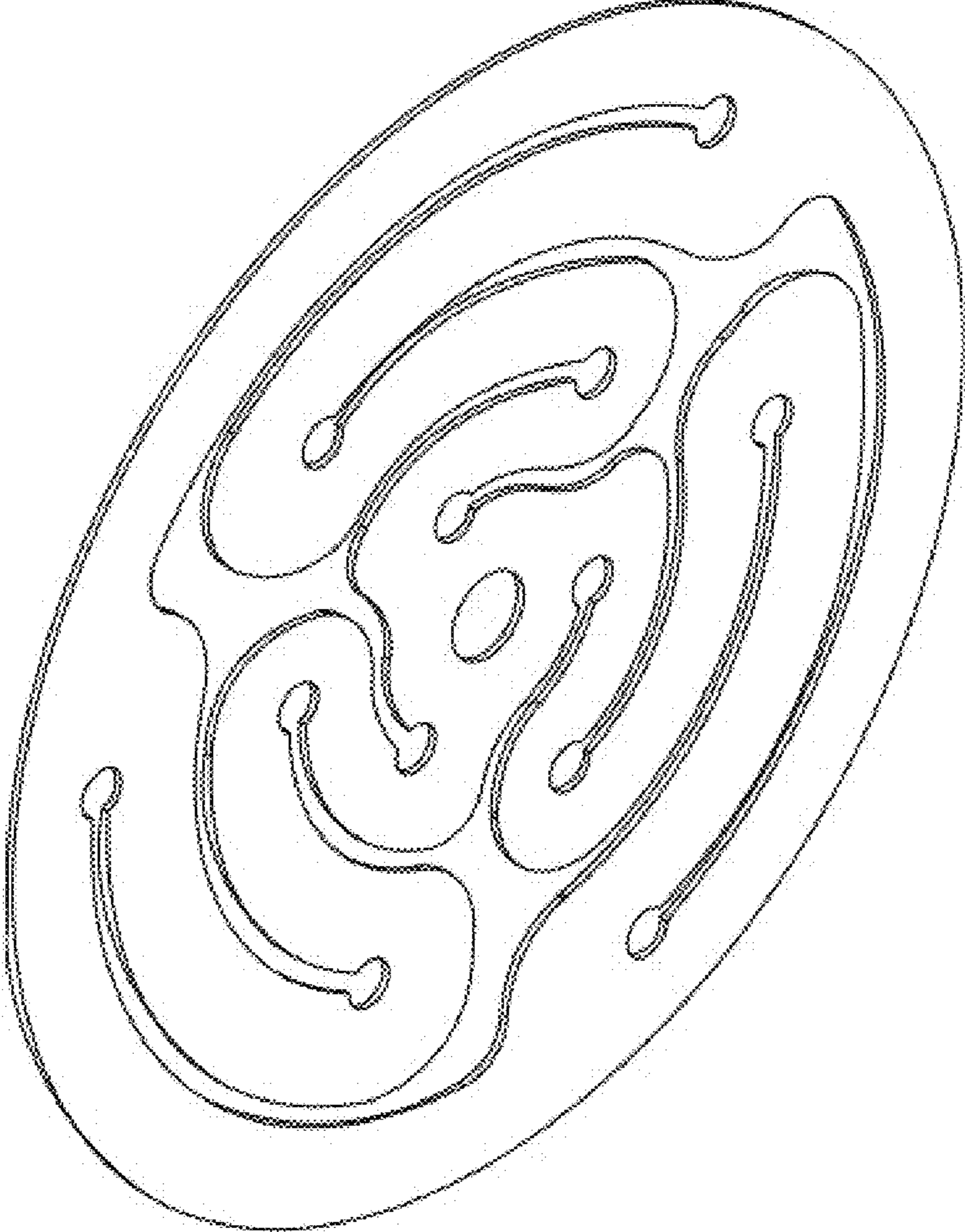

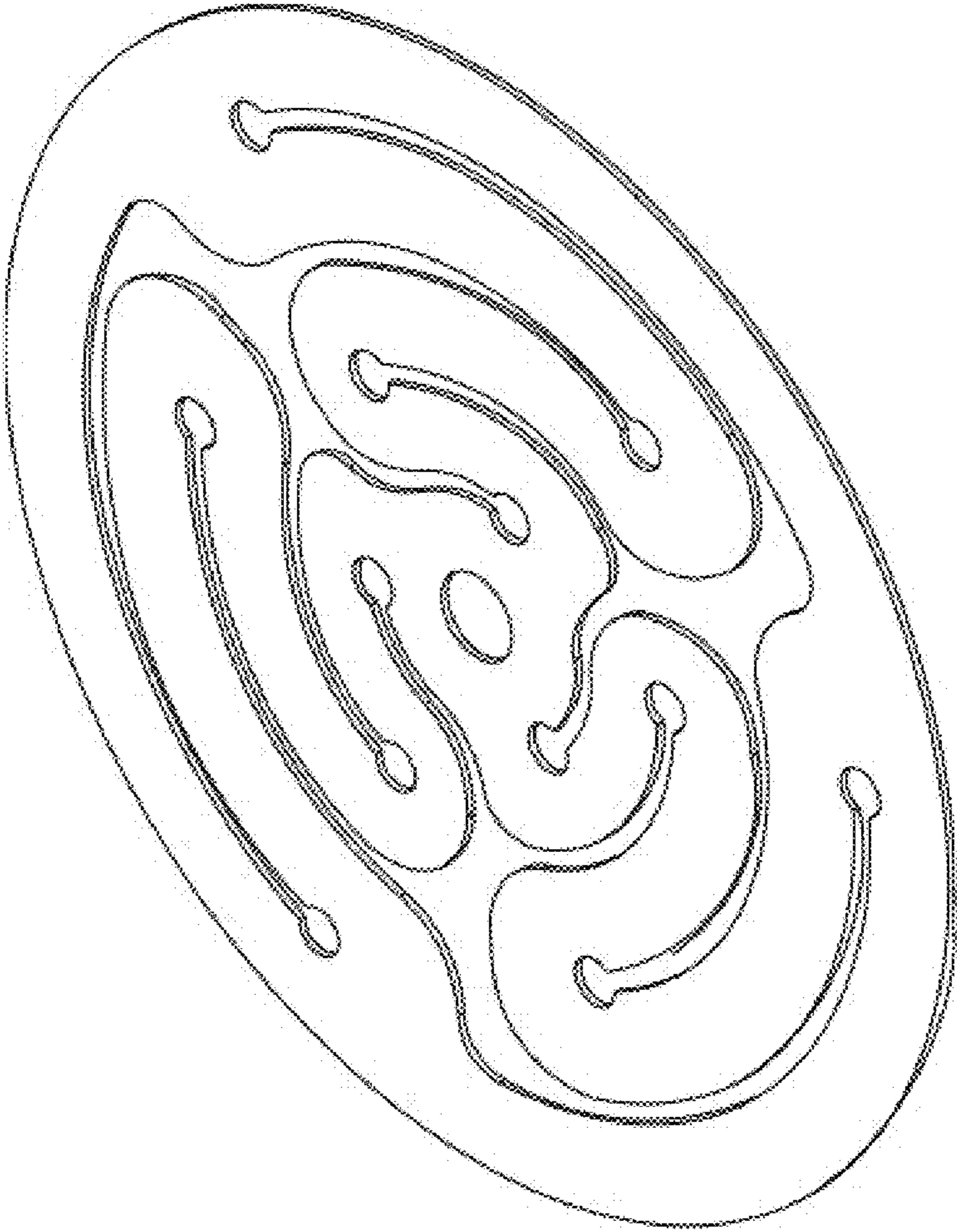

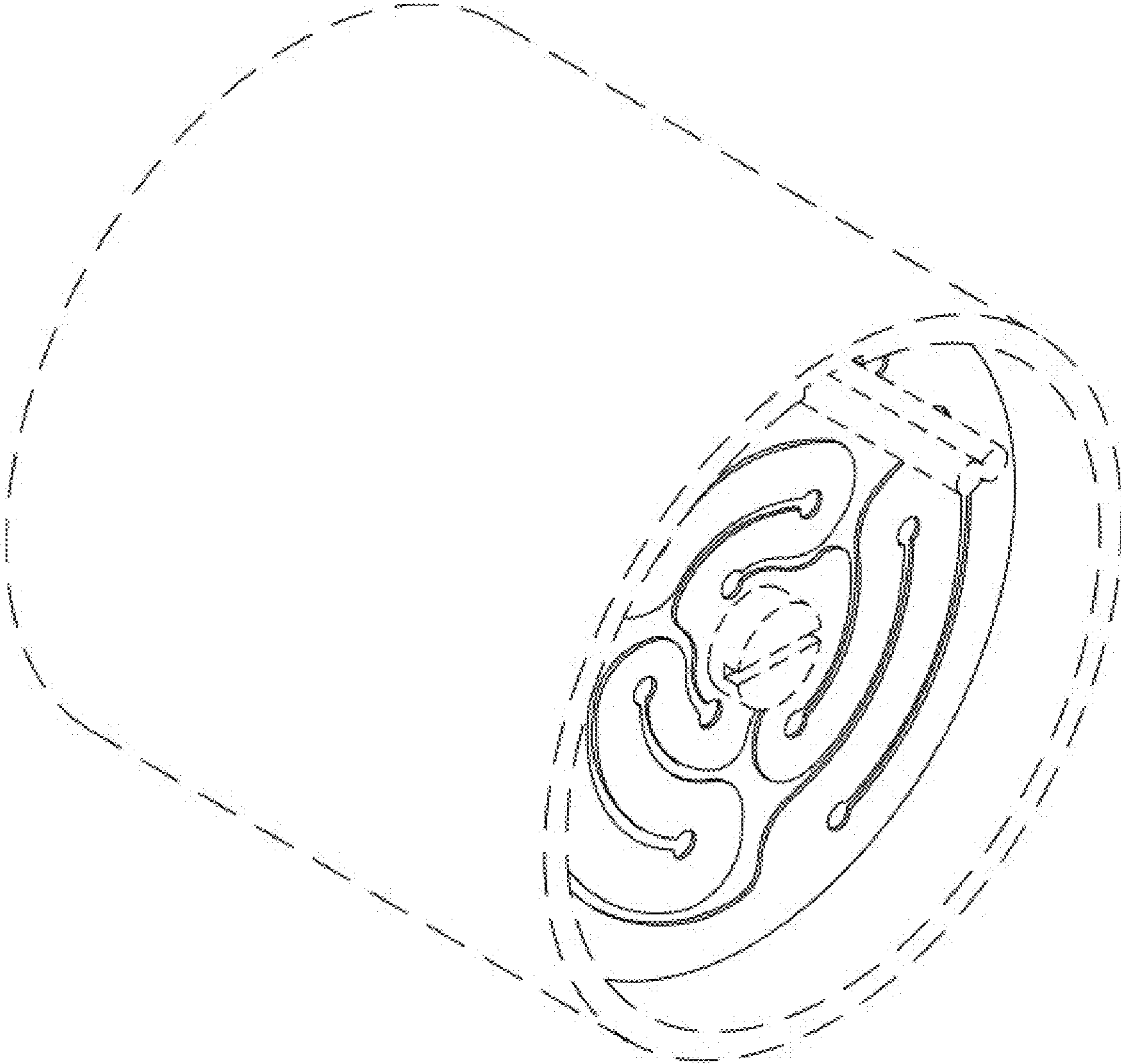

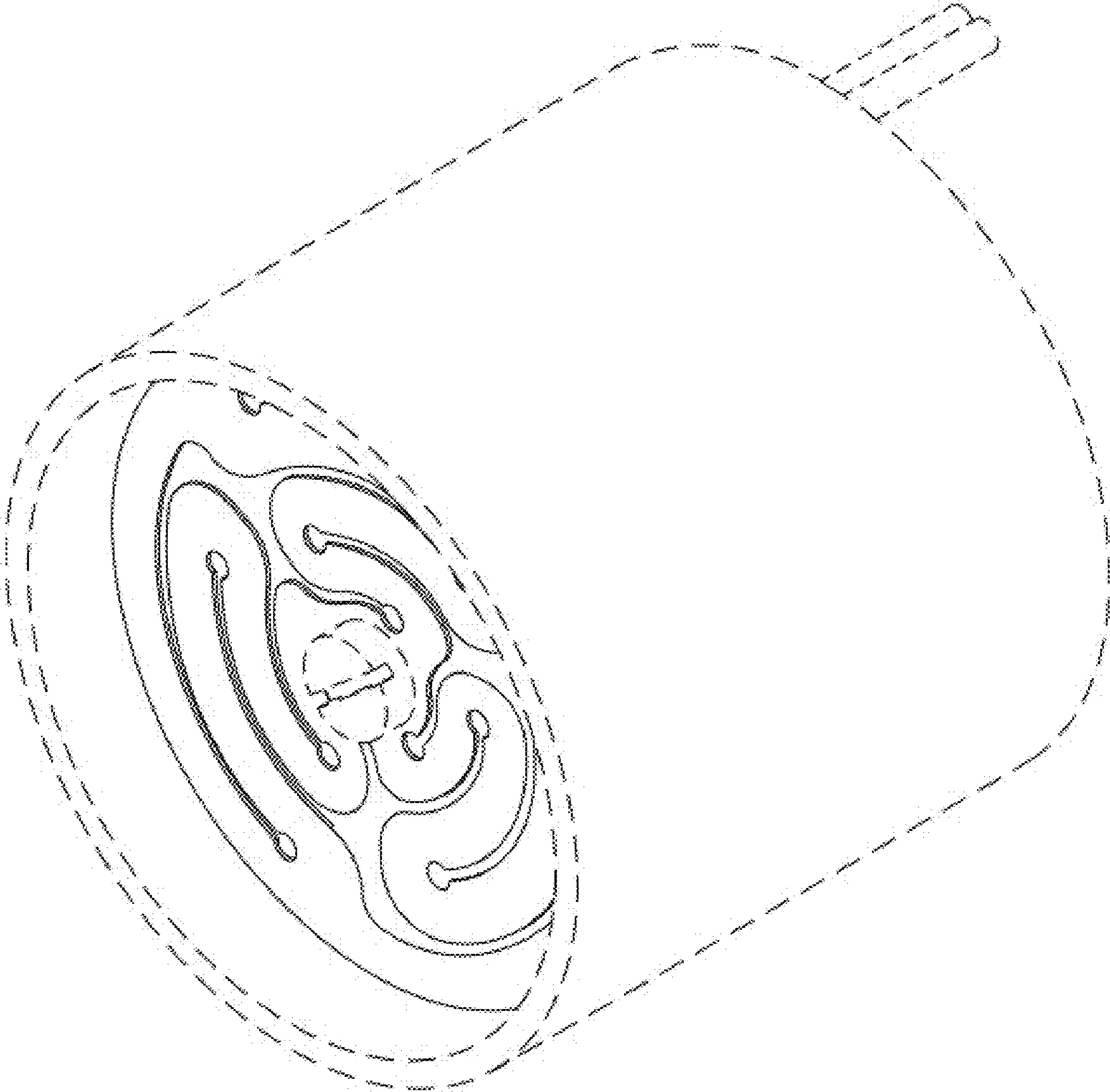
