DESCRIPTION
FIG. 1 is a perspective view of a remote control in accordance with an embodiment of the present design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is an inverted top end elevation view thereof;
FIG. 5 is a bottom end elevation view thereof;
FIG. 6 is a right side elevation view thereof; and,
FIG. 7 is a left side elevation view thereof.

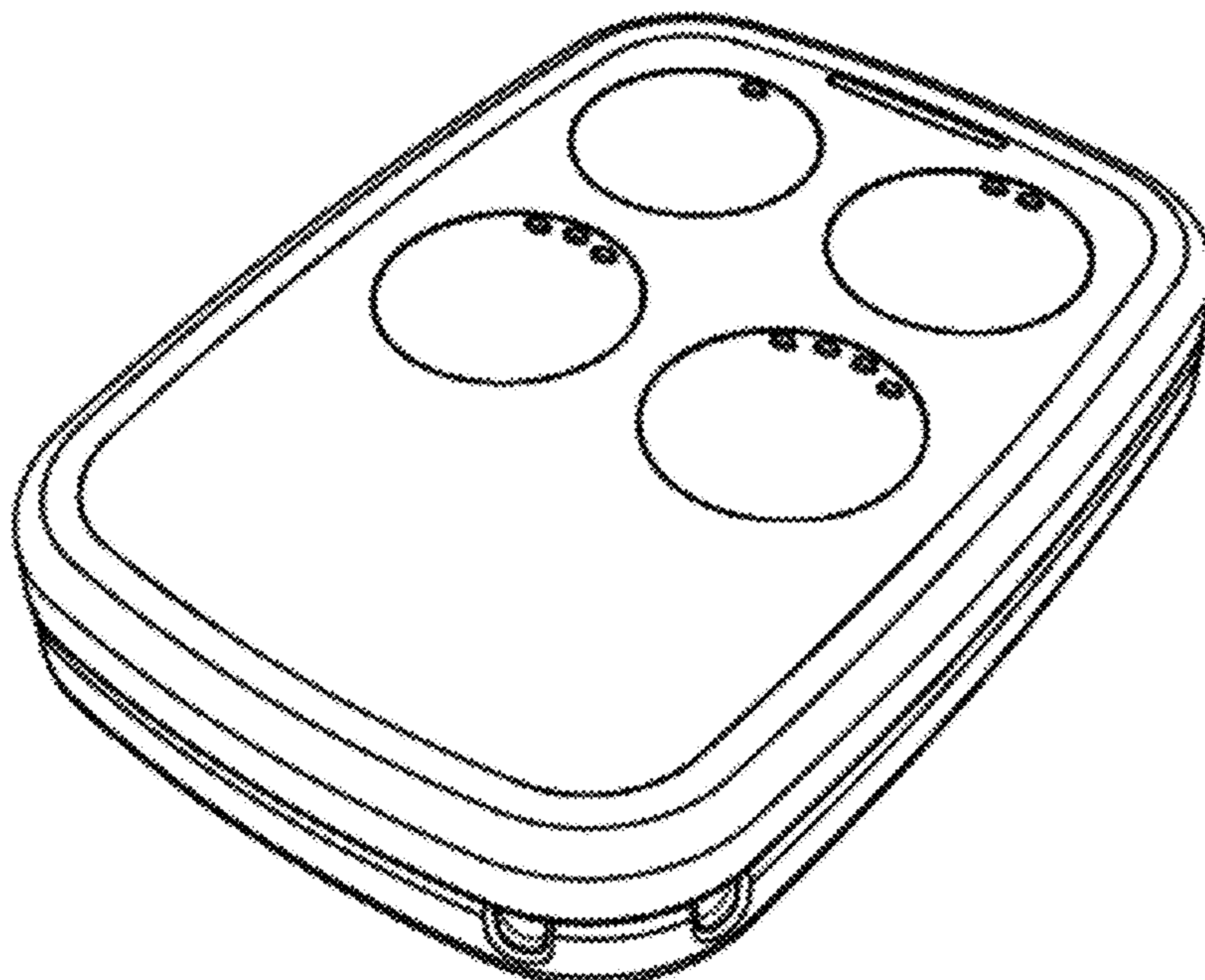

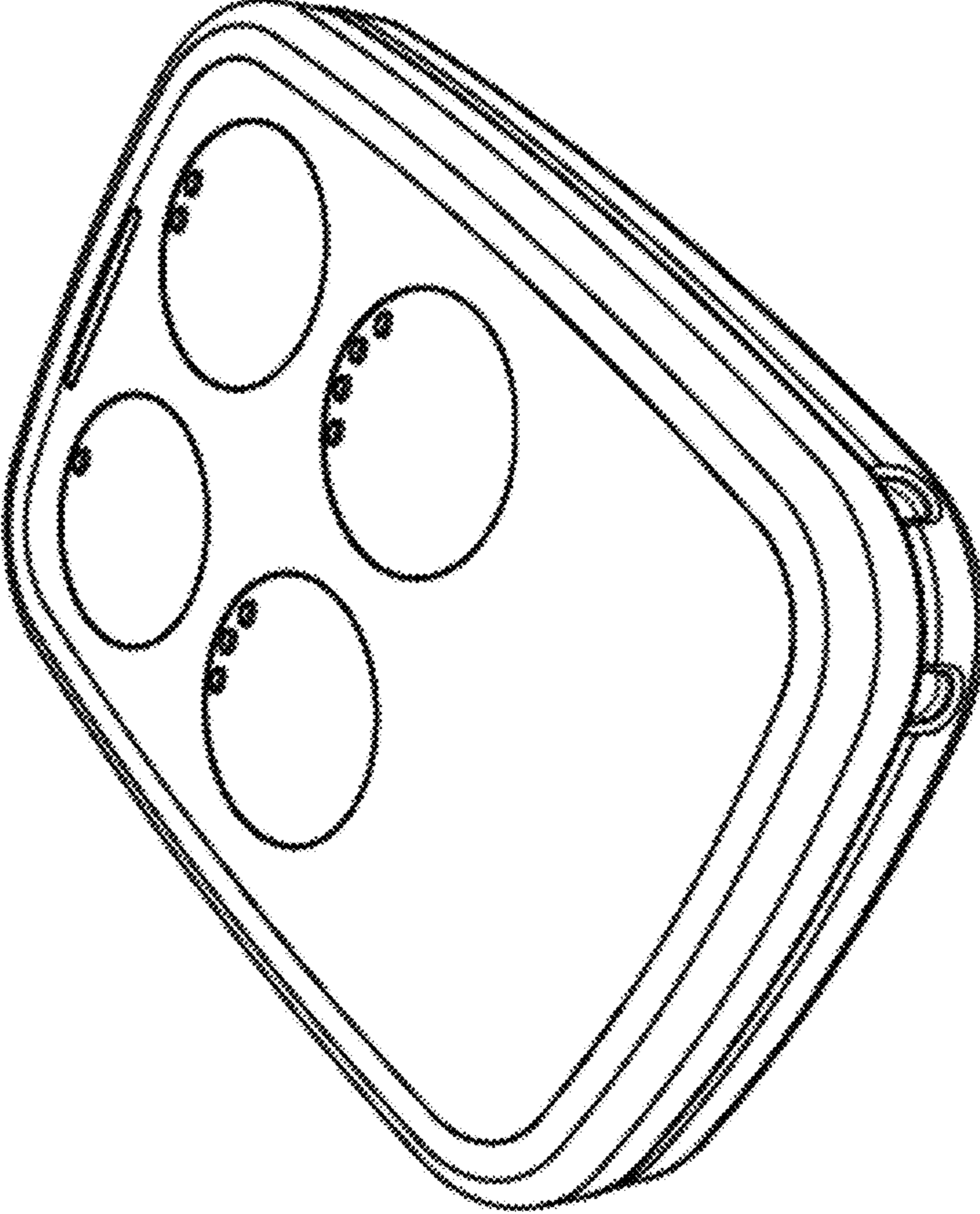

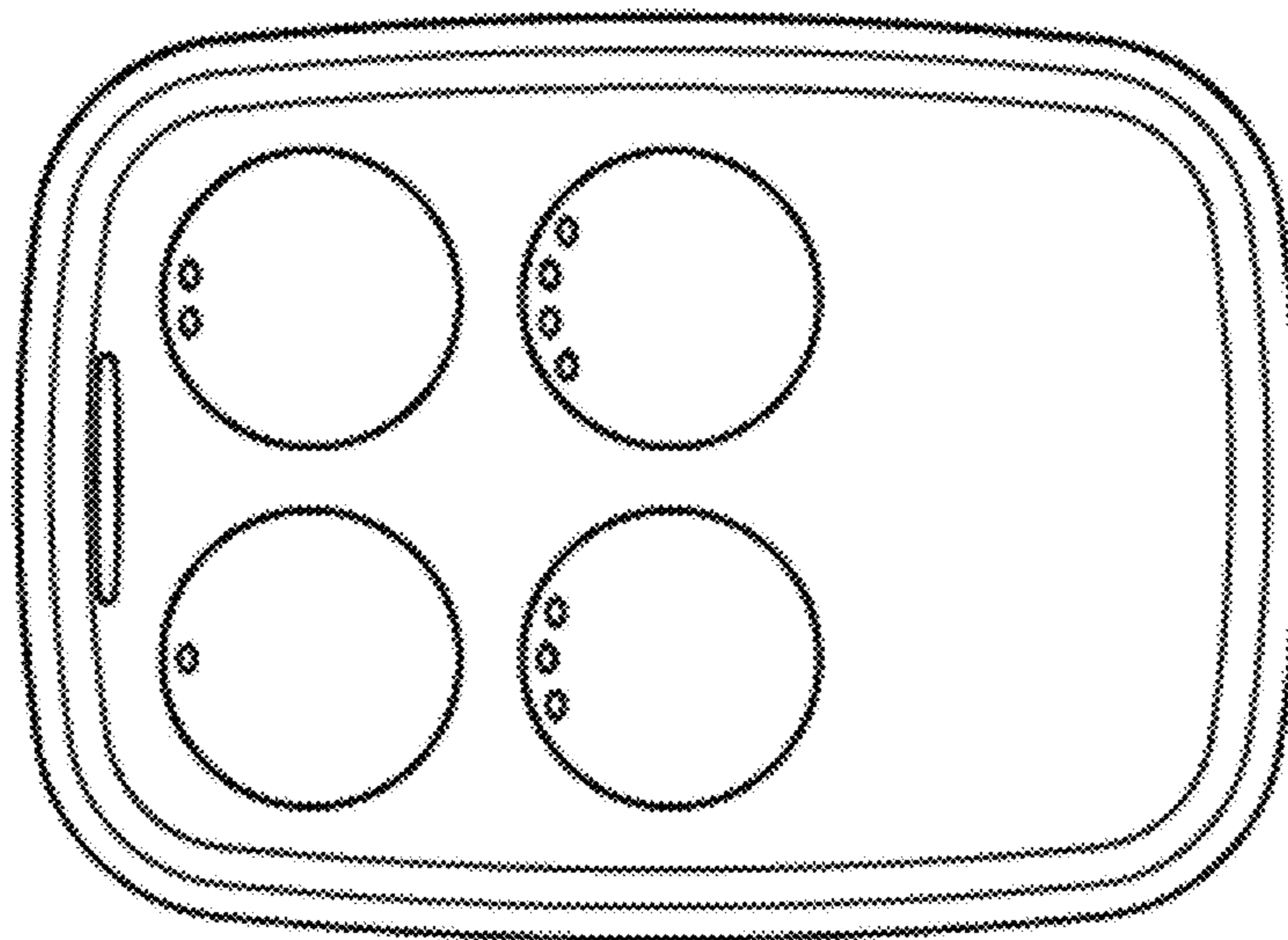

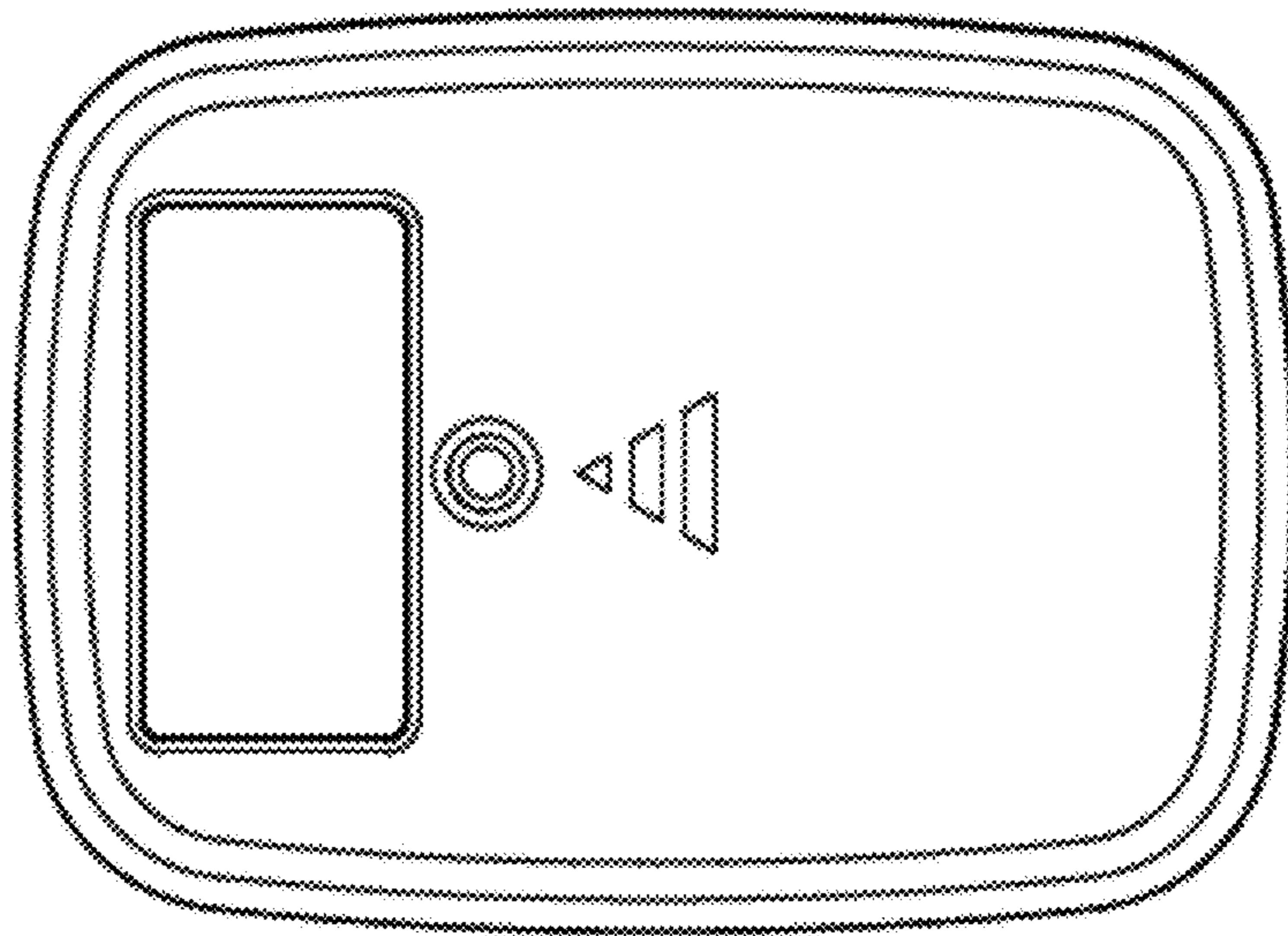

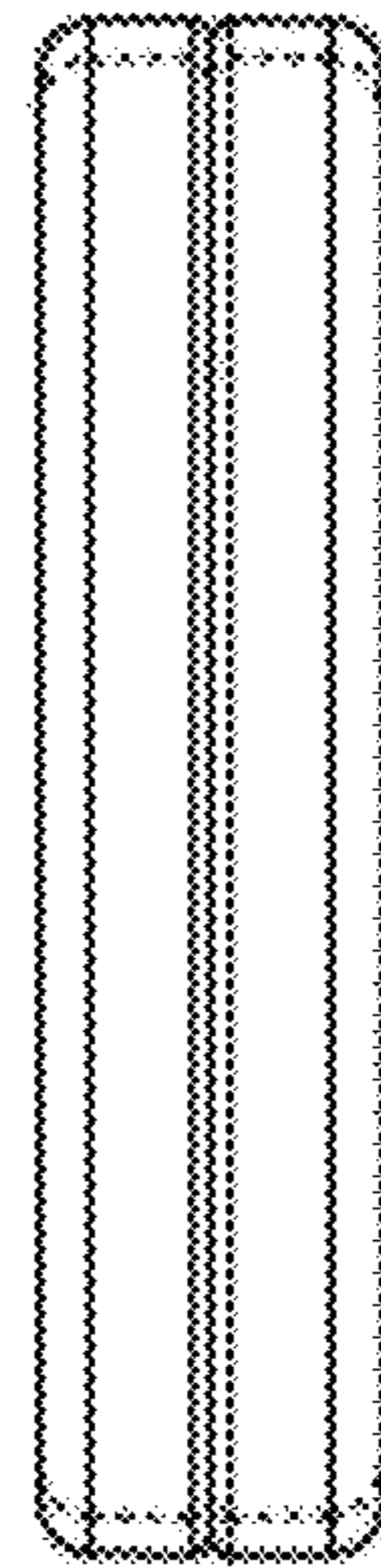

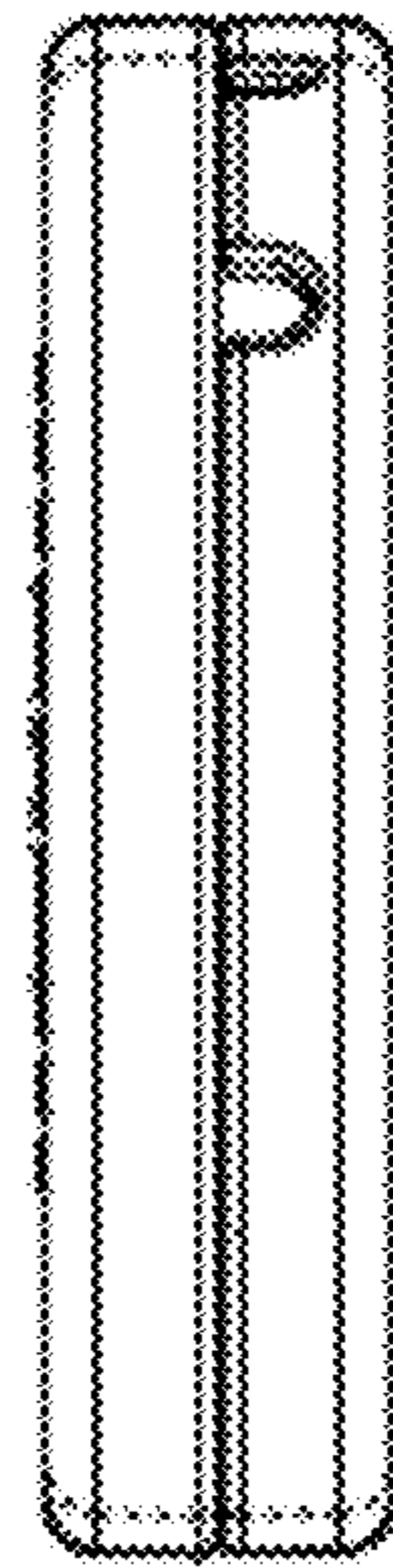

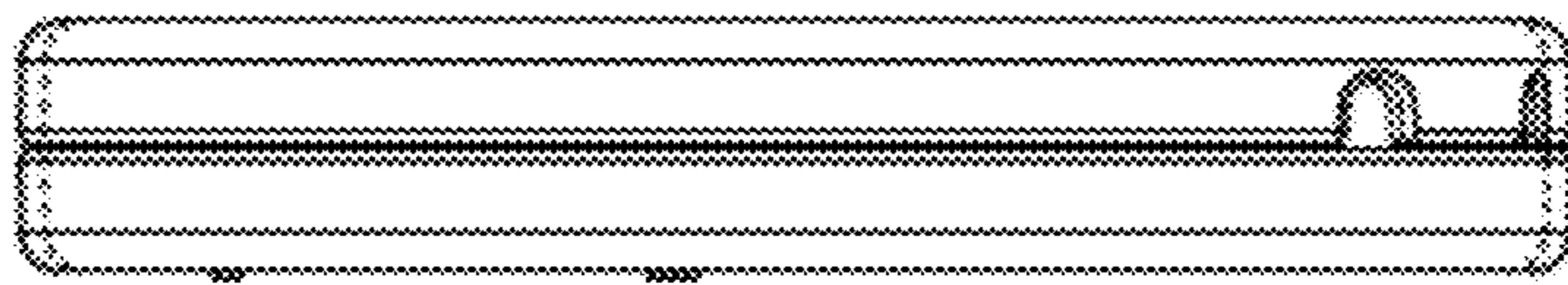
