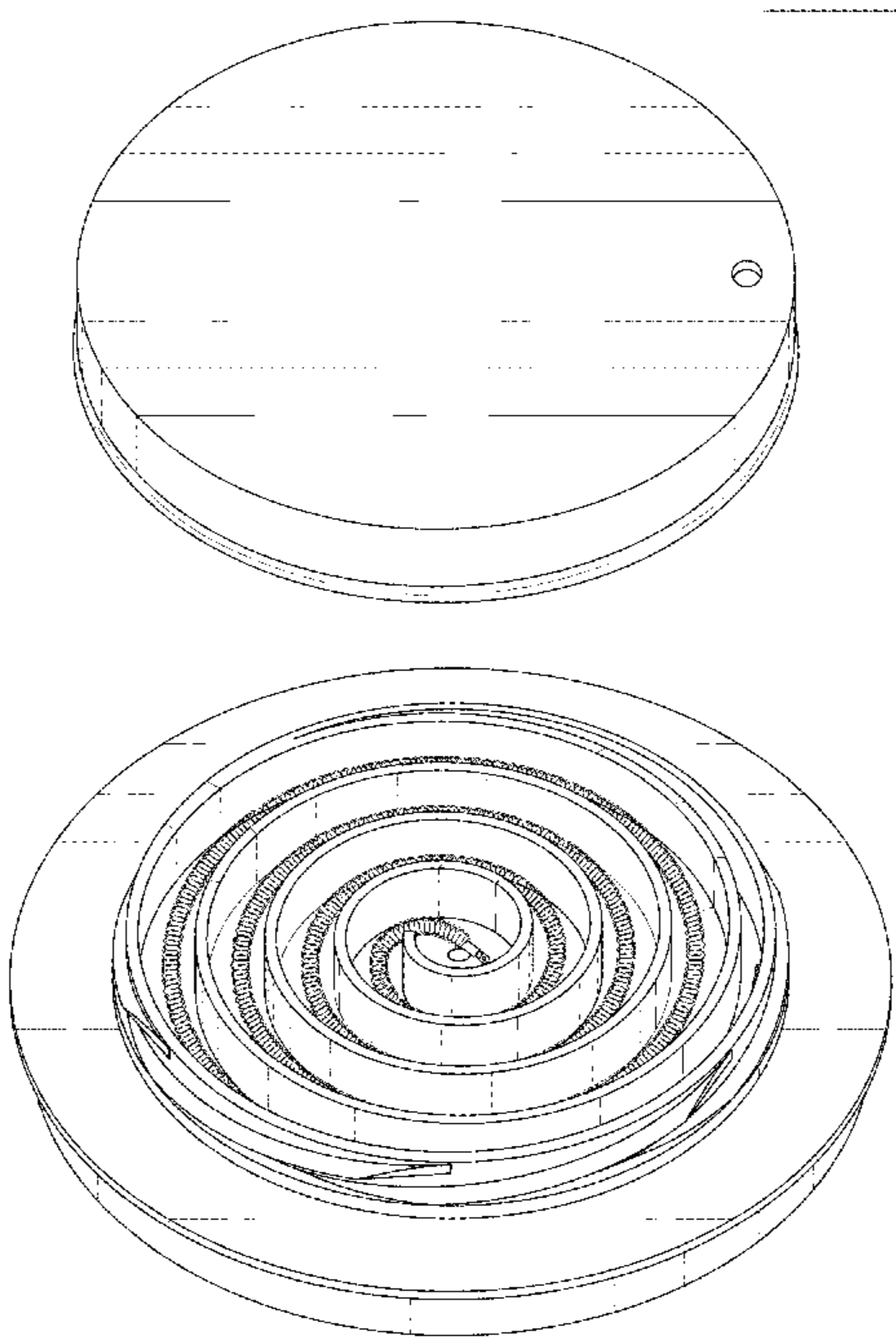
(57) **CLAIM**

The ornamental design for a water heater insert, as shown and described.

DESCRIPTION

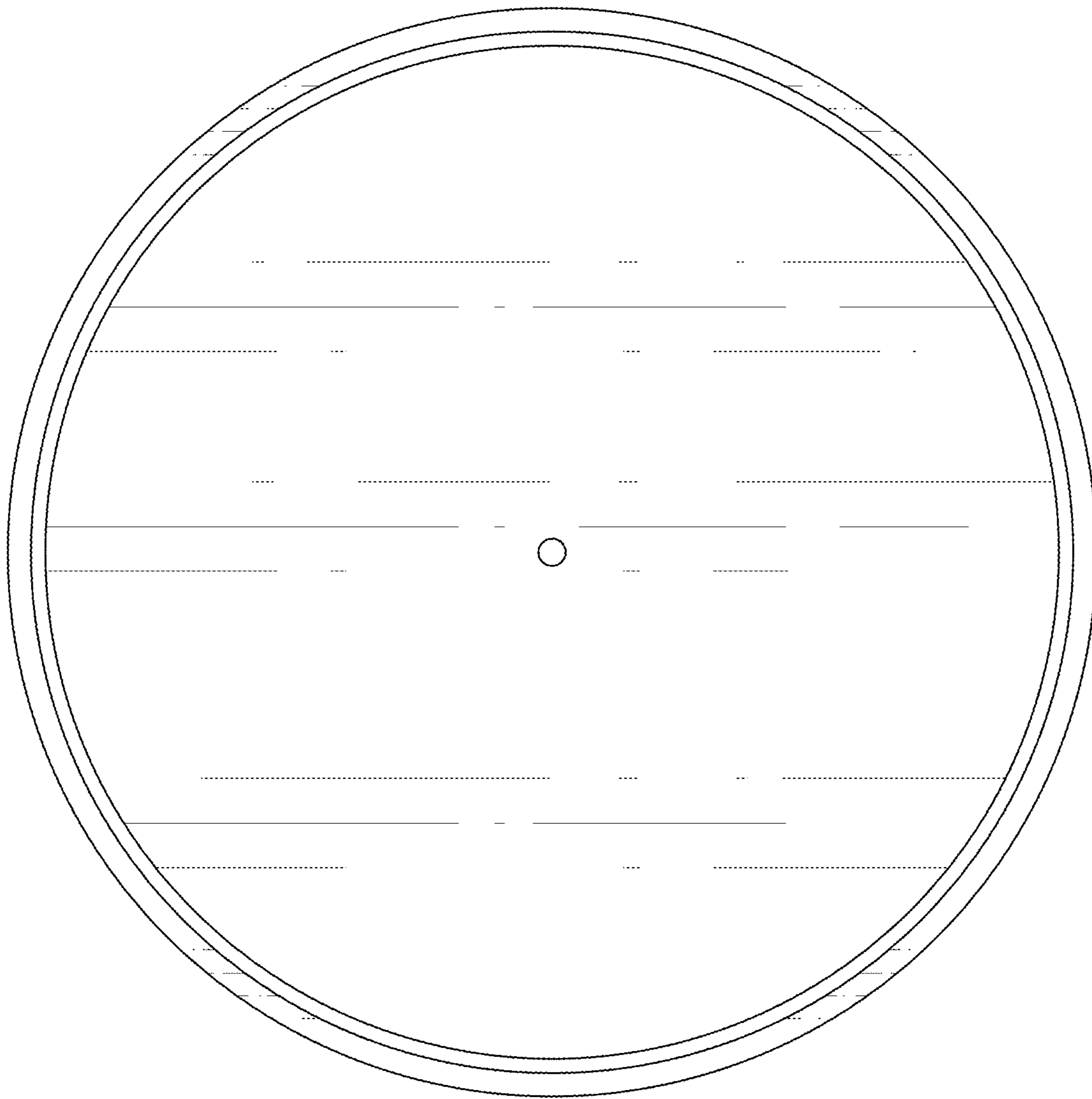

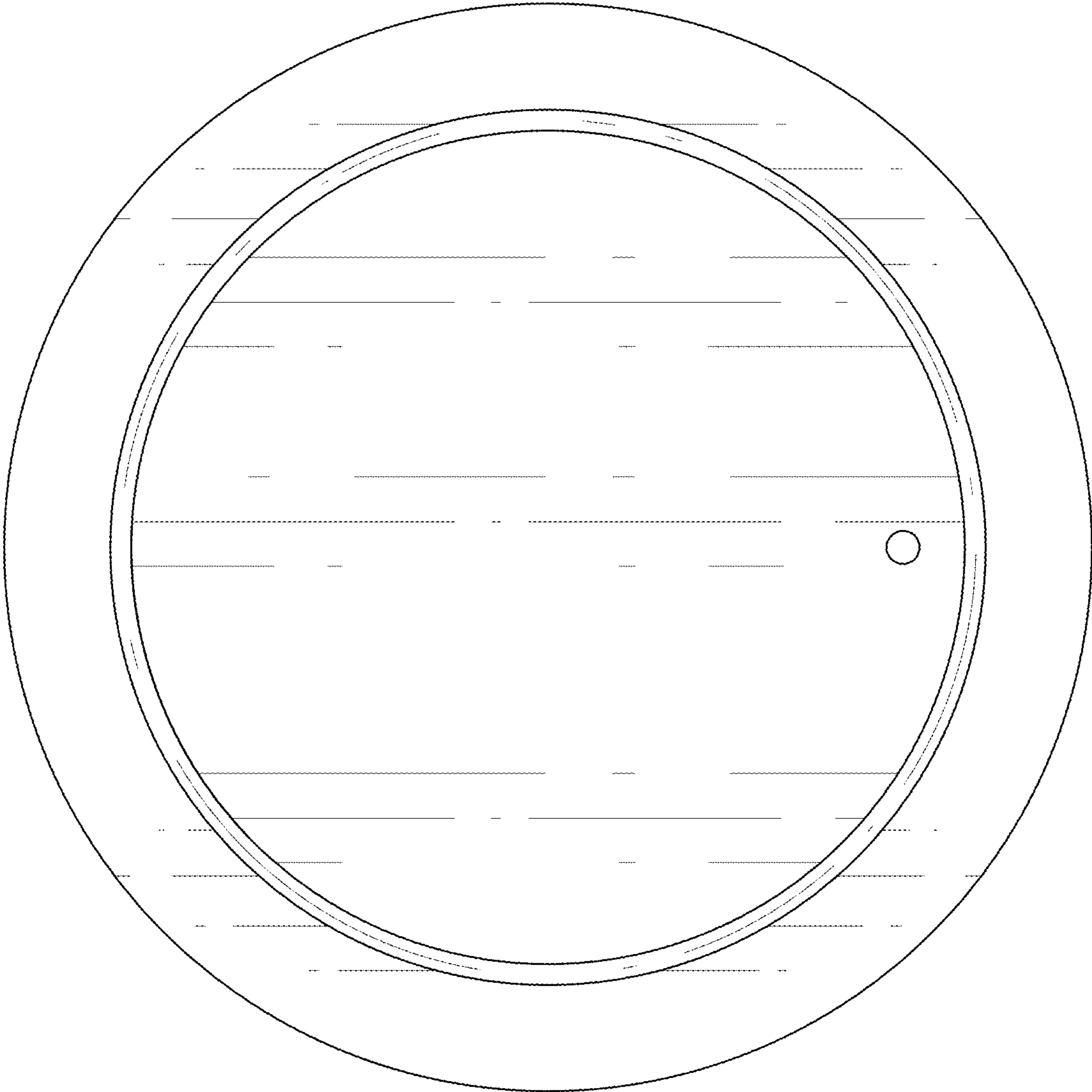

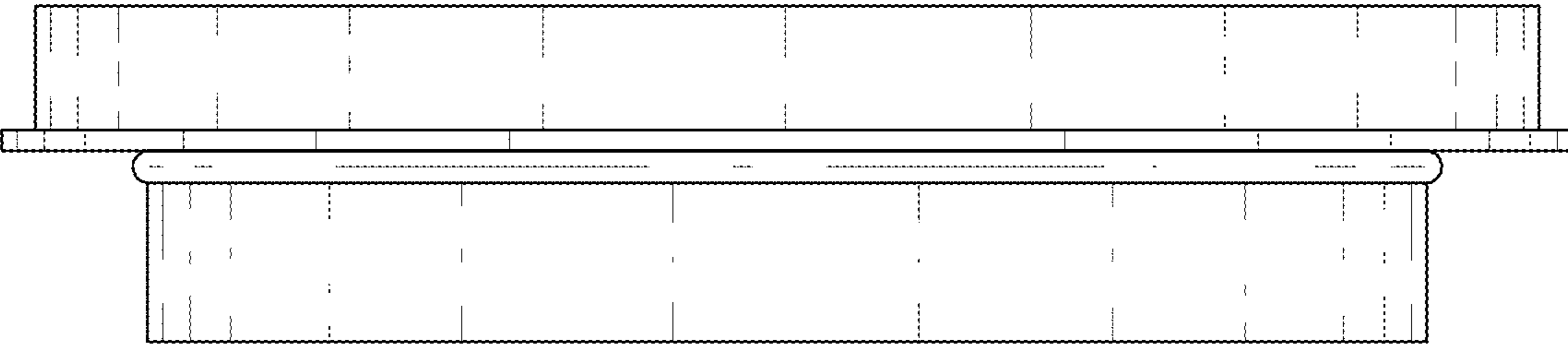

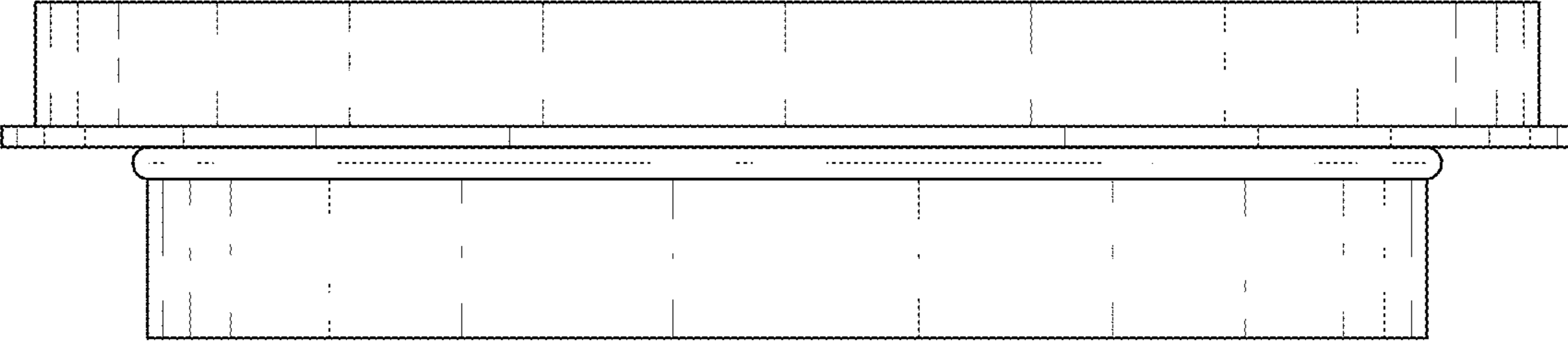

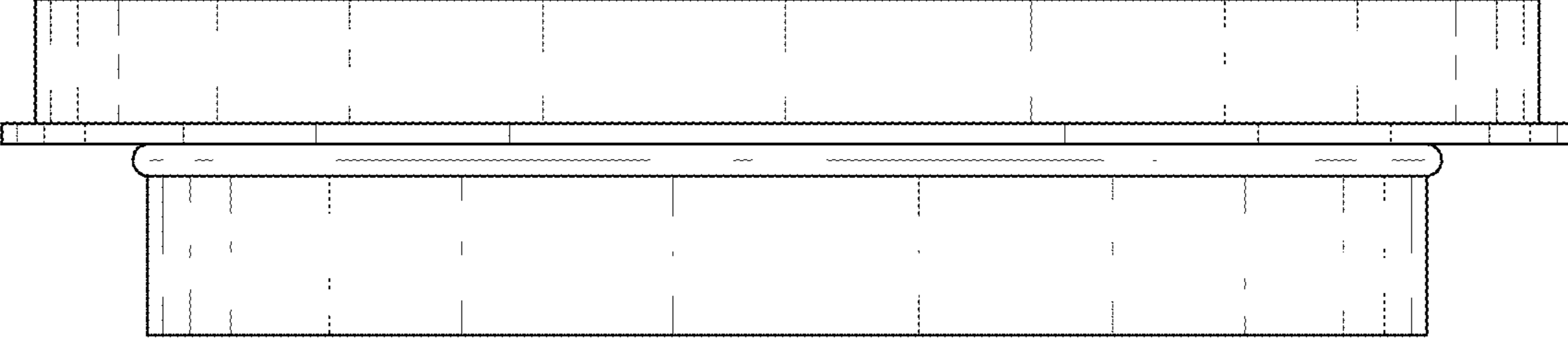

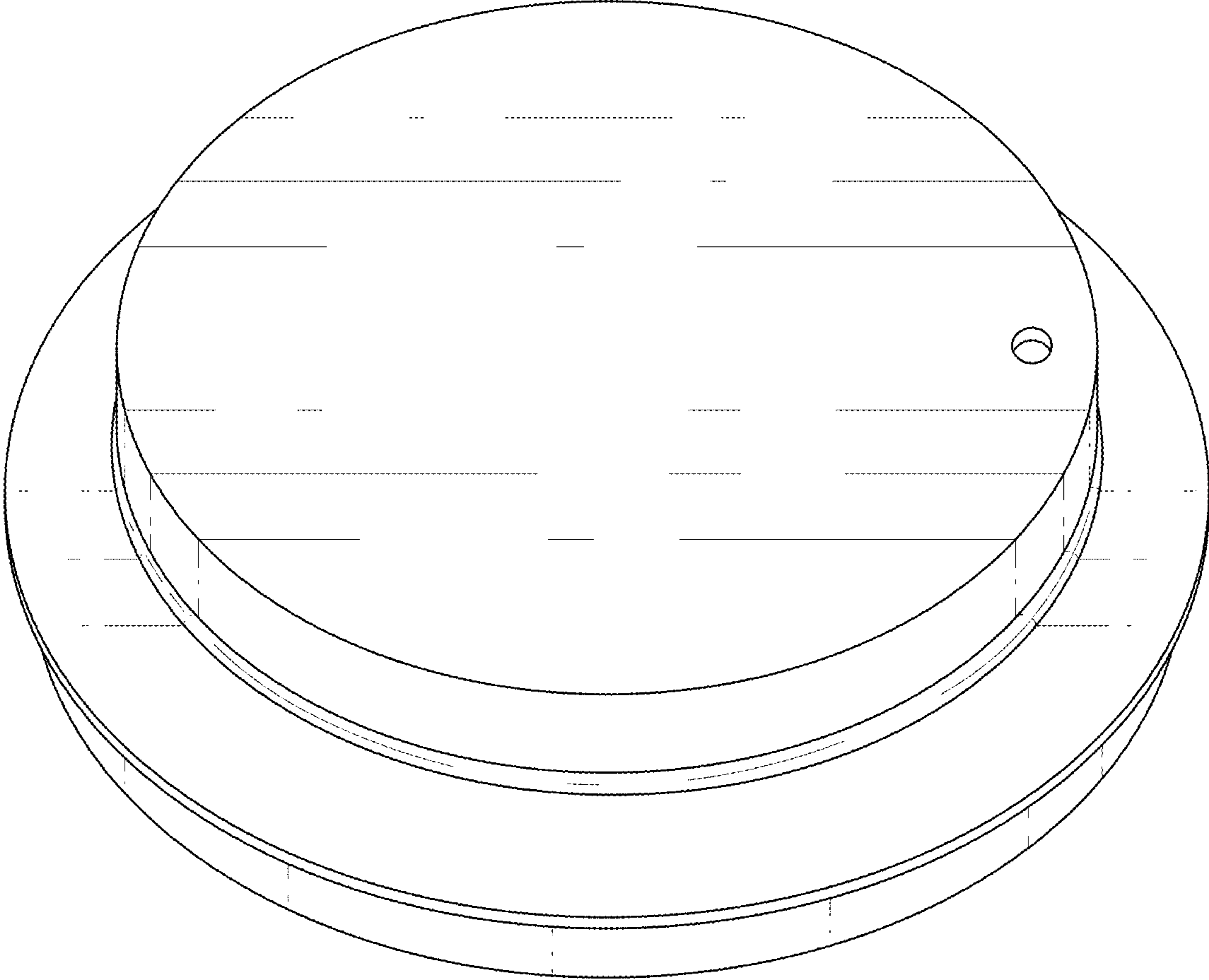

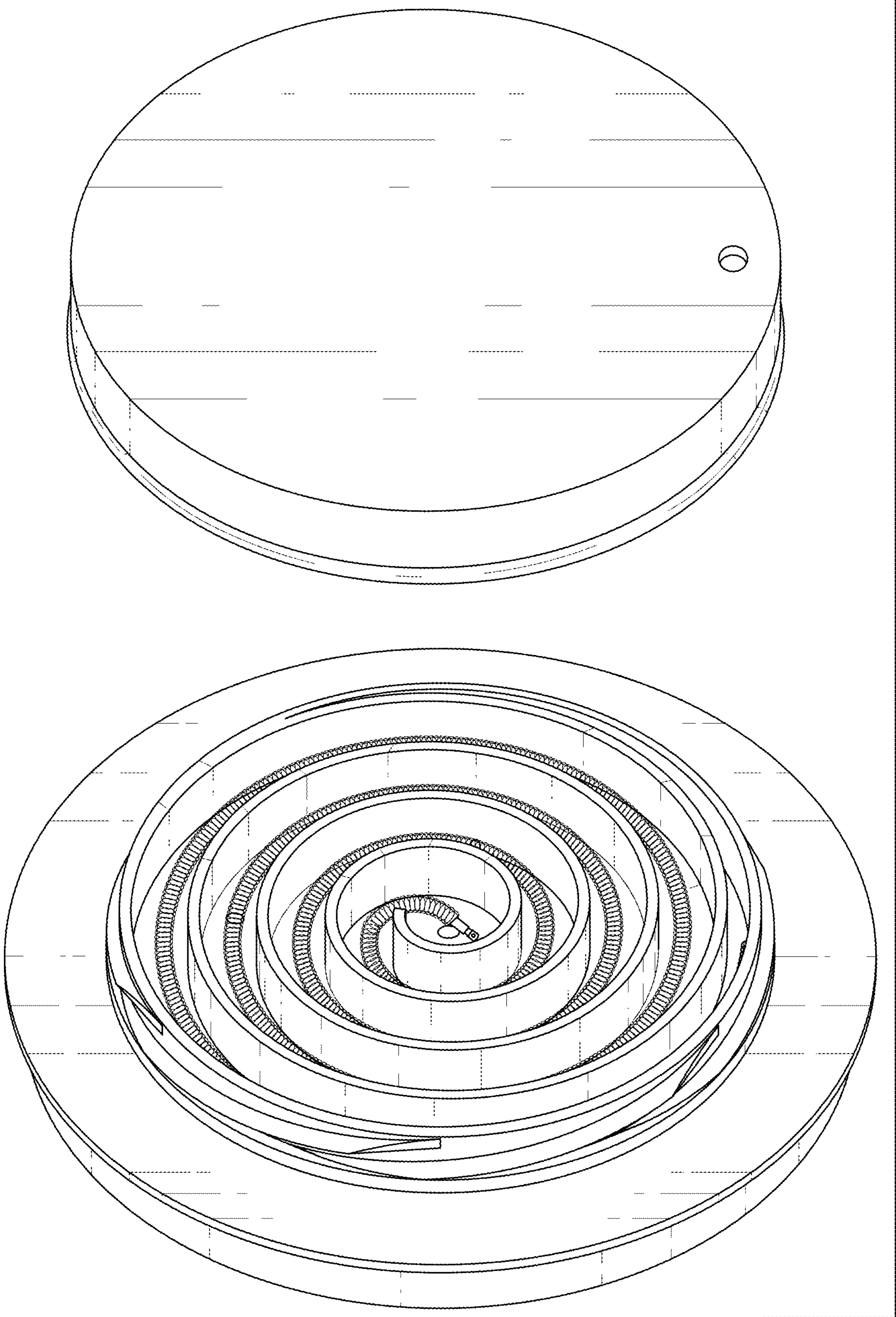

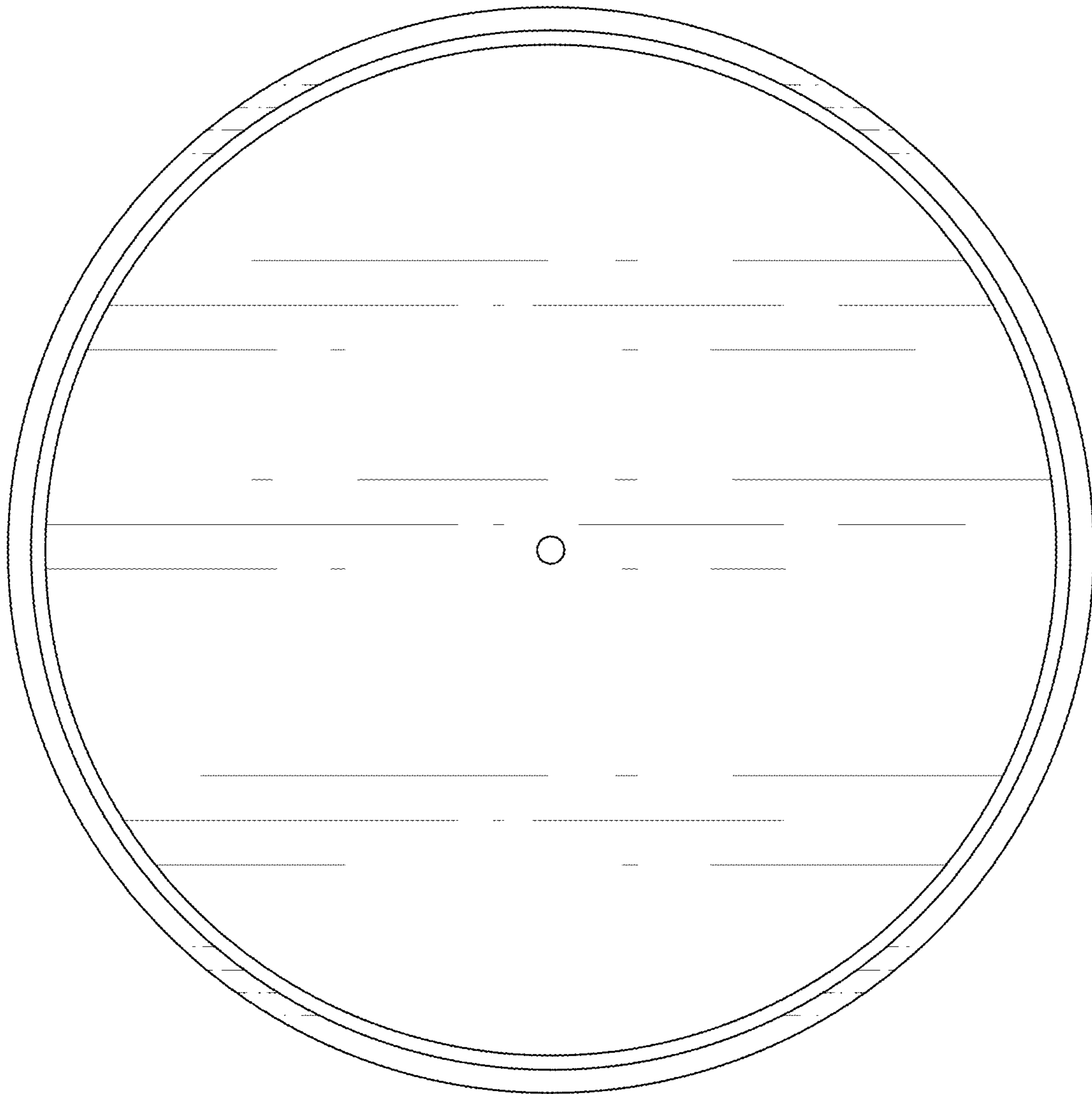

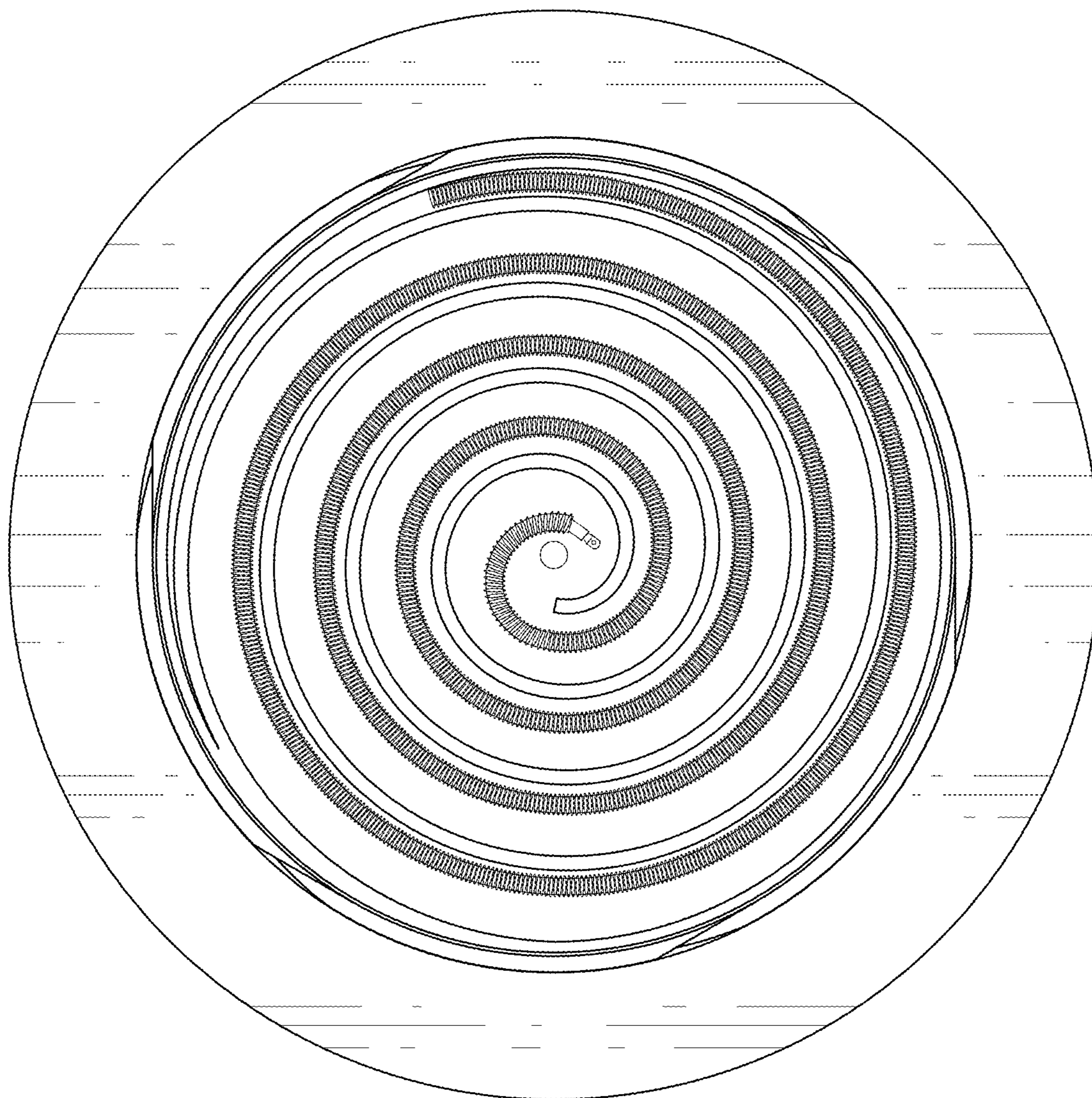

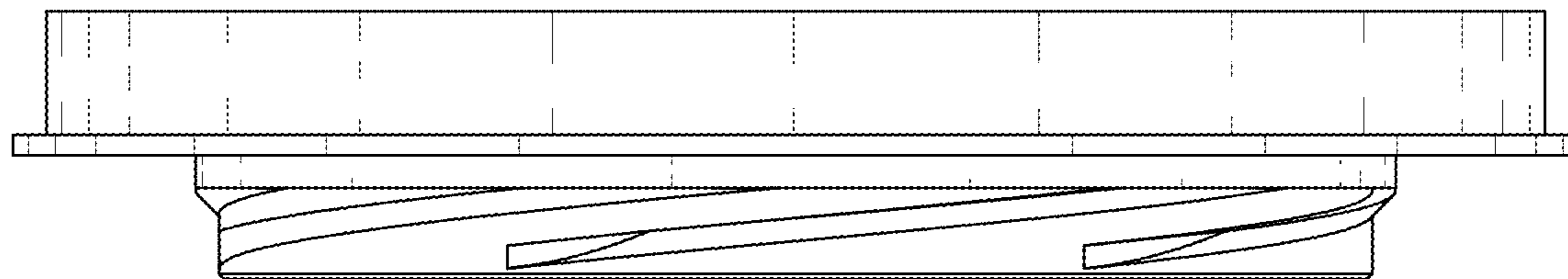

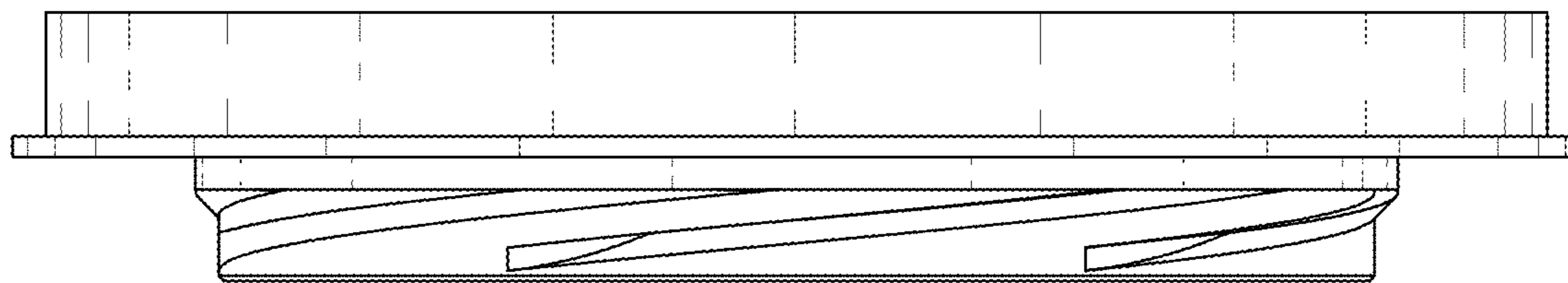

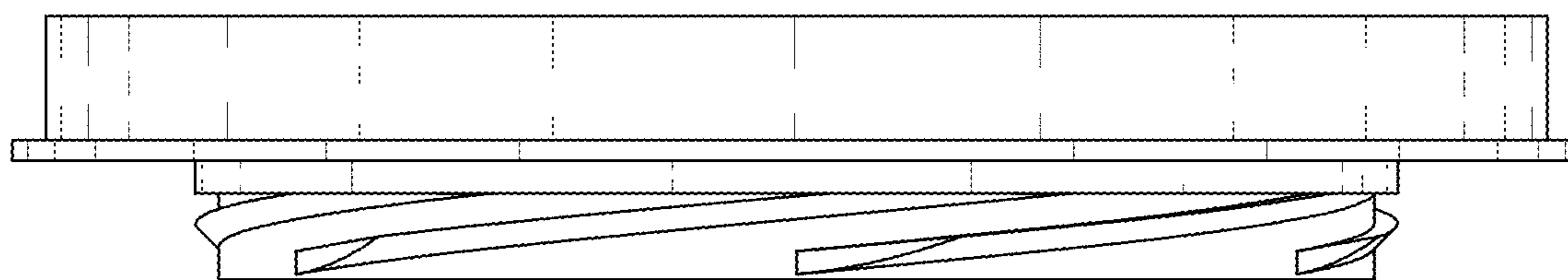

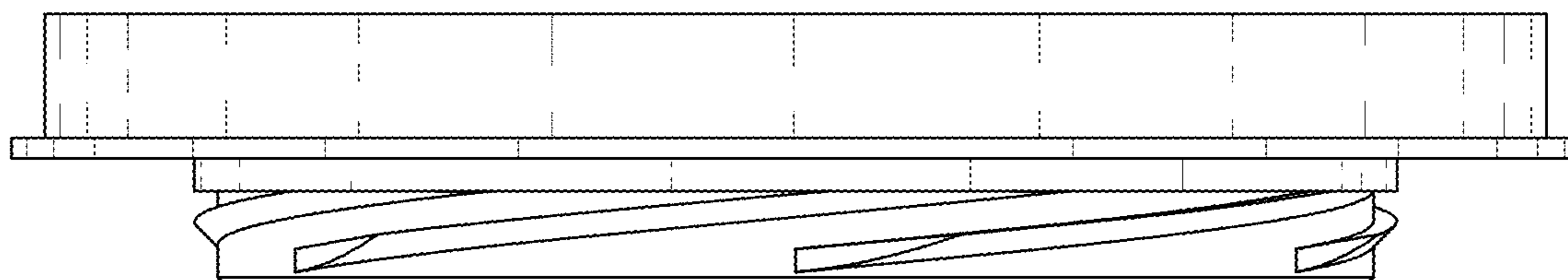

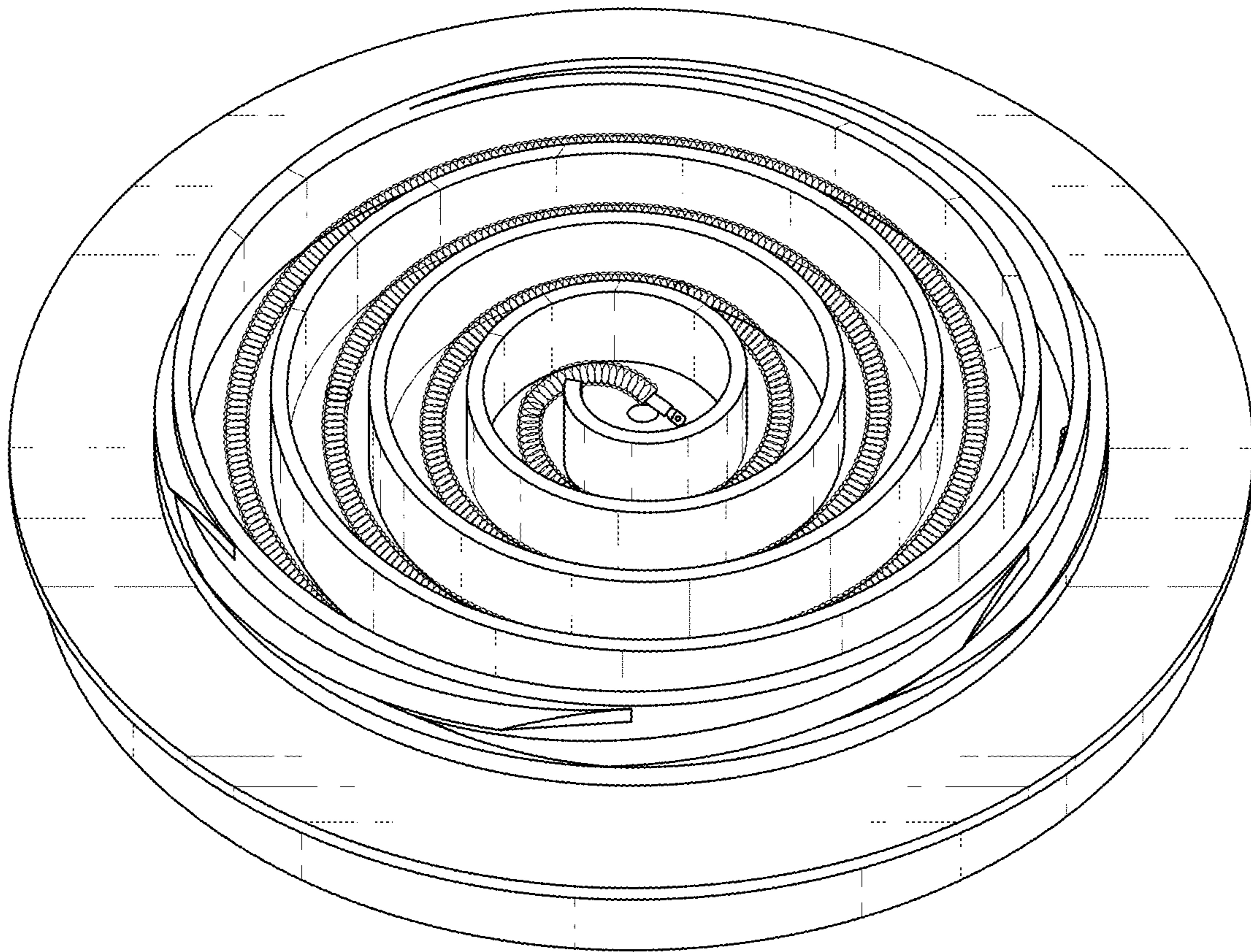

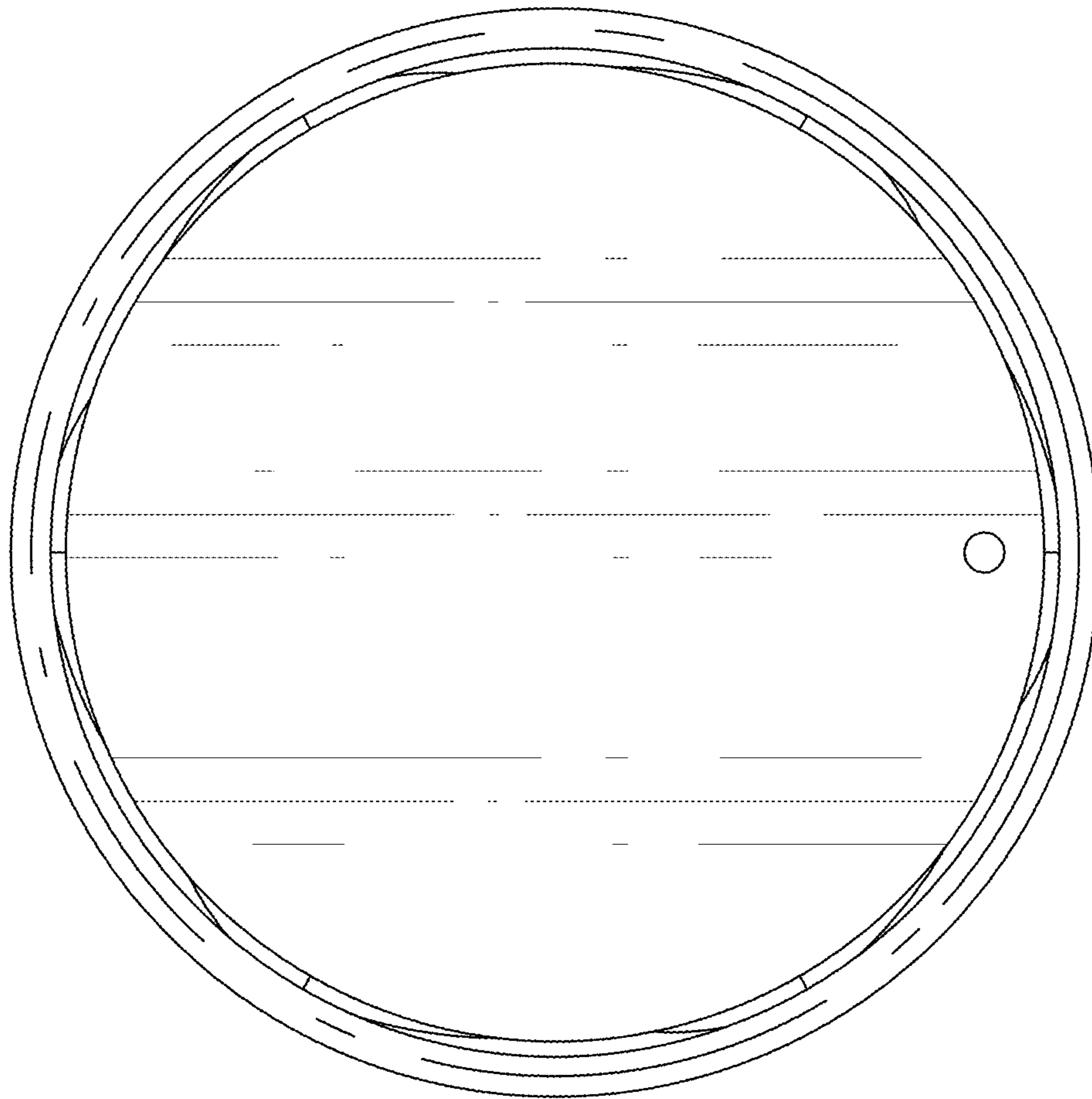

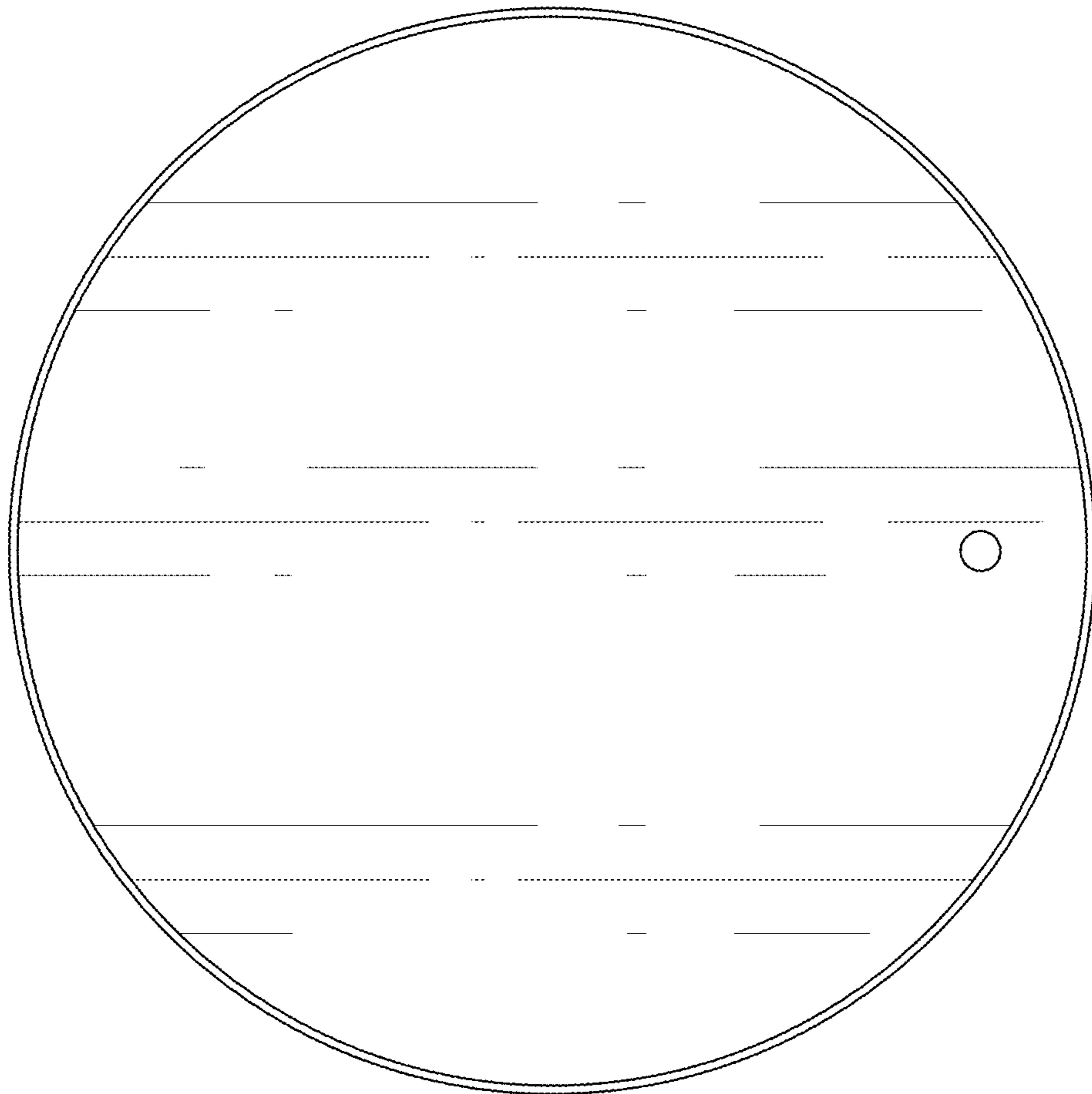

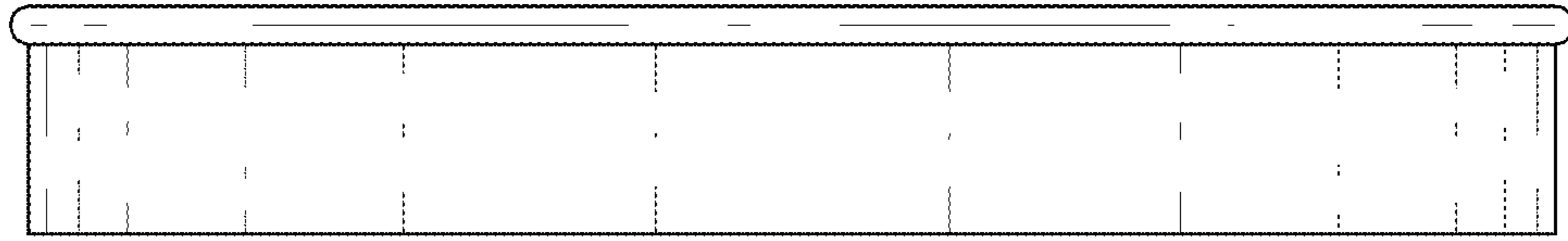

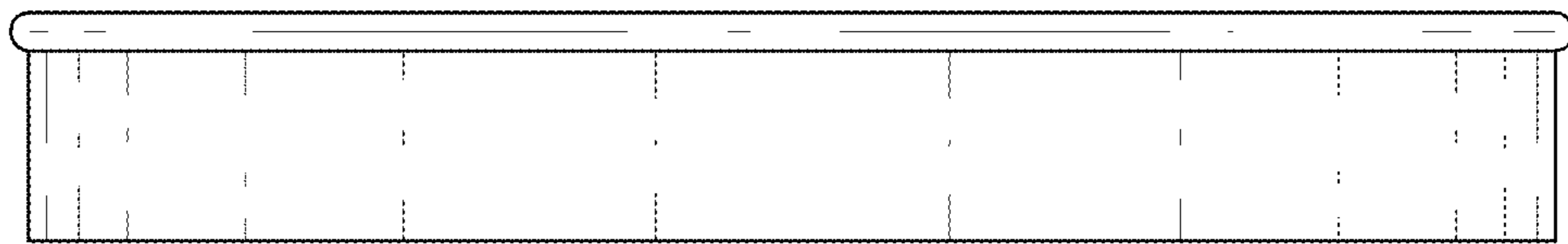

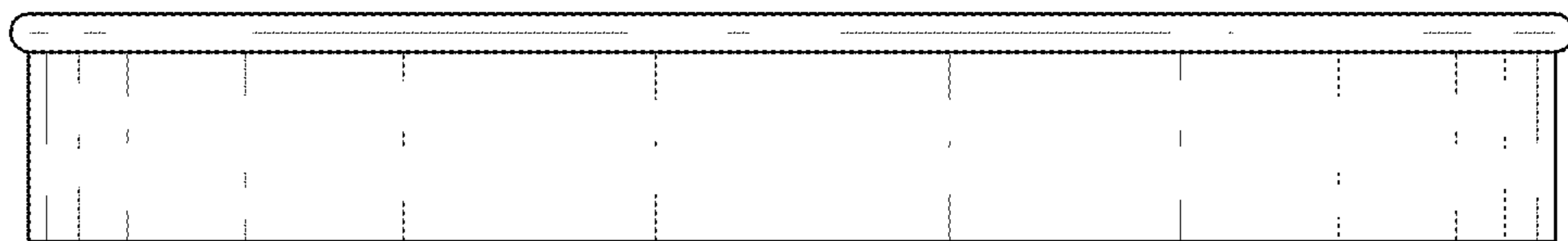

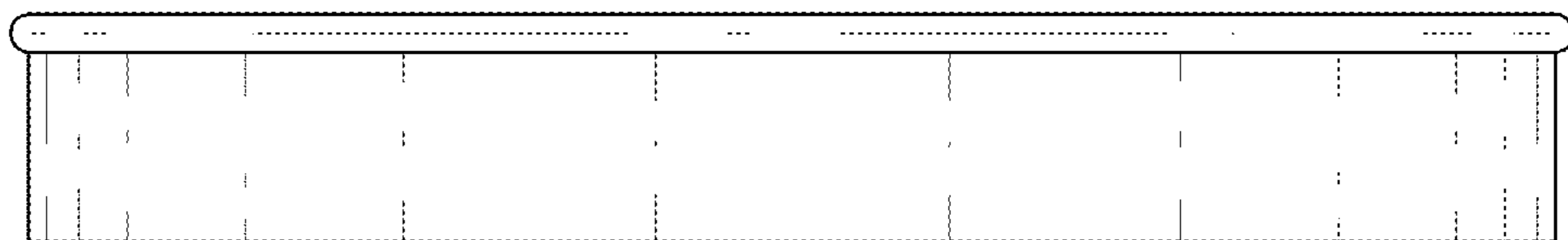

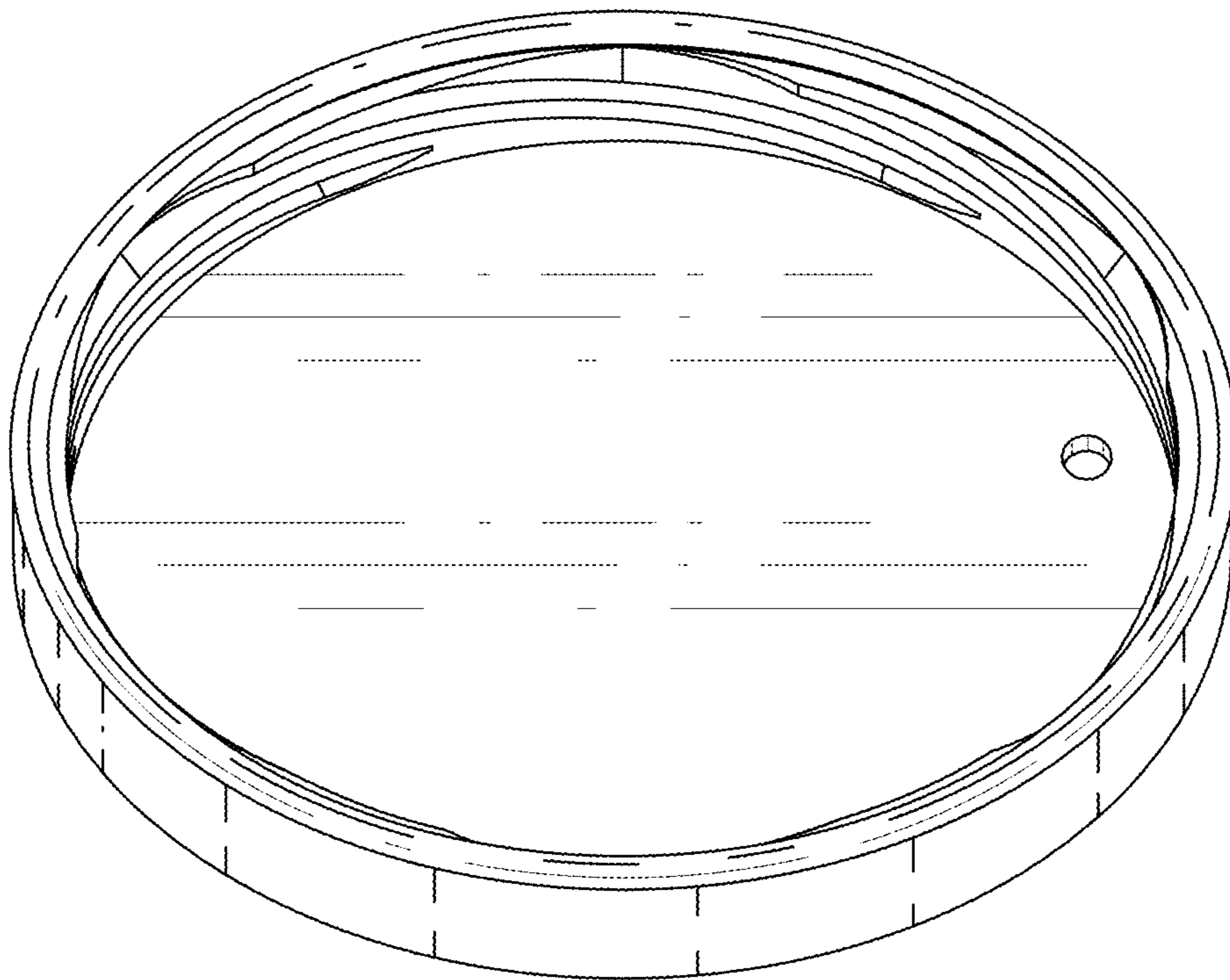
