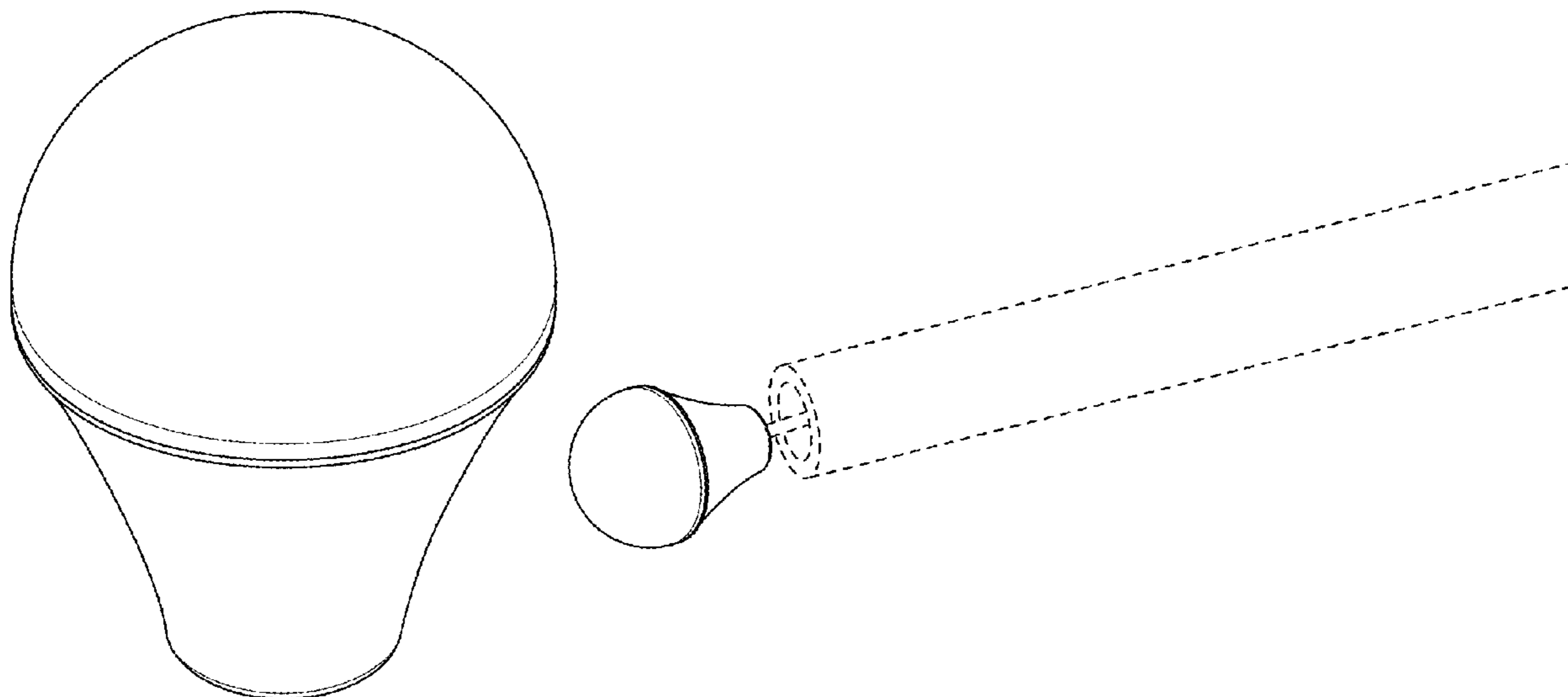
(57) **CLAIM**

The ornamental design for an electrosurgical probe ceramic tip, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of an electrosurgical probe ceramic tip;
FIG. 2 is a side view of the electrosurgical probe ceramic tip;
FIG. 3 is a top view of the electrosurgical probe ceramic tip;
FIG. 4 is a bottom view of the electrosurgical probe ceramic tip;
FIG. 5 is a bottom perspective view of the electrosurgical probe ceramic tip; and,

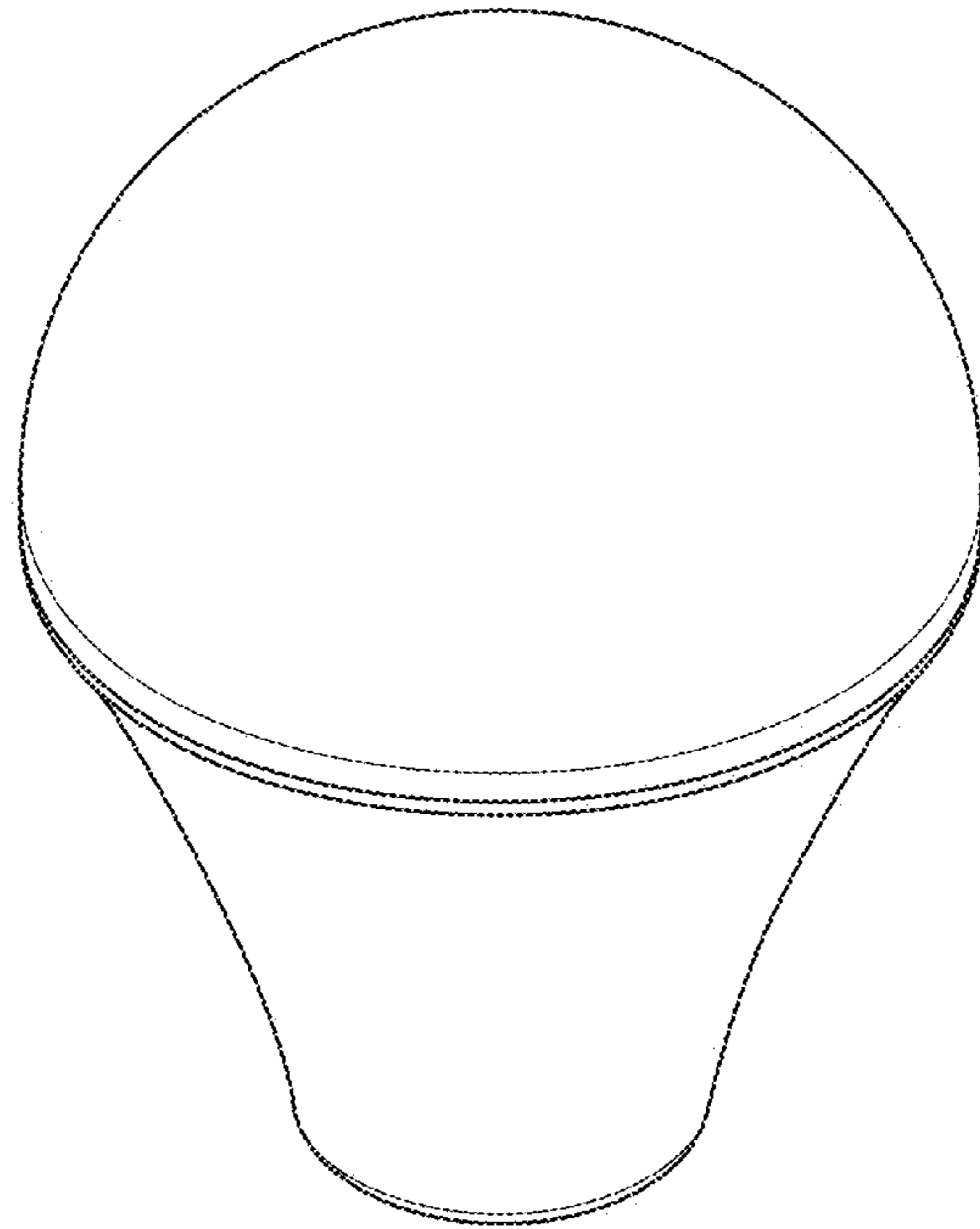

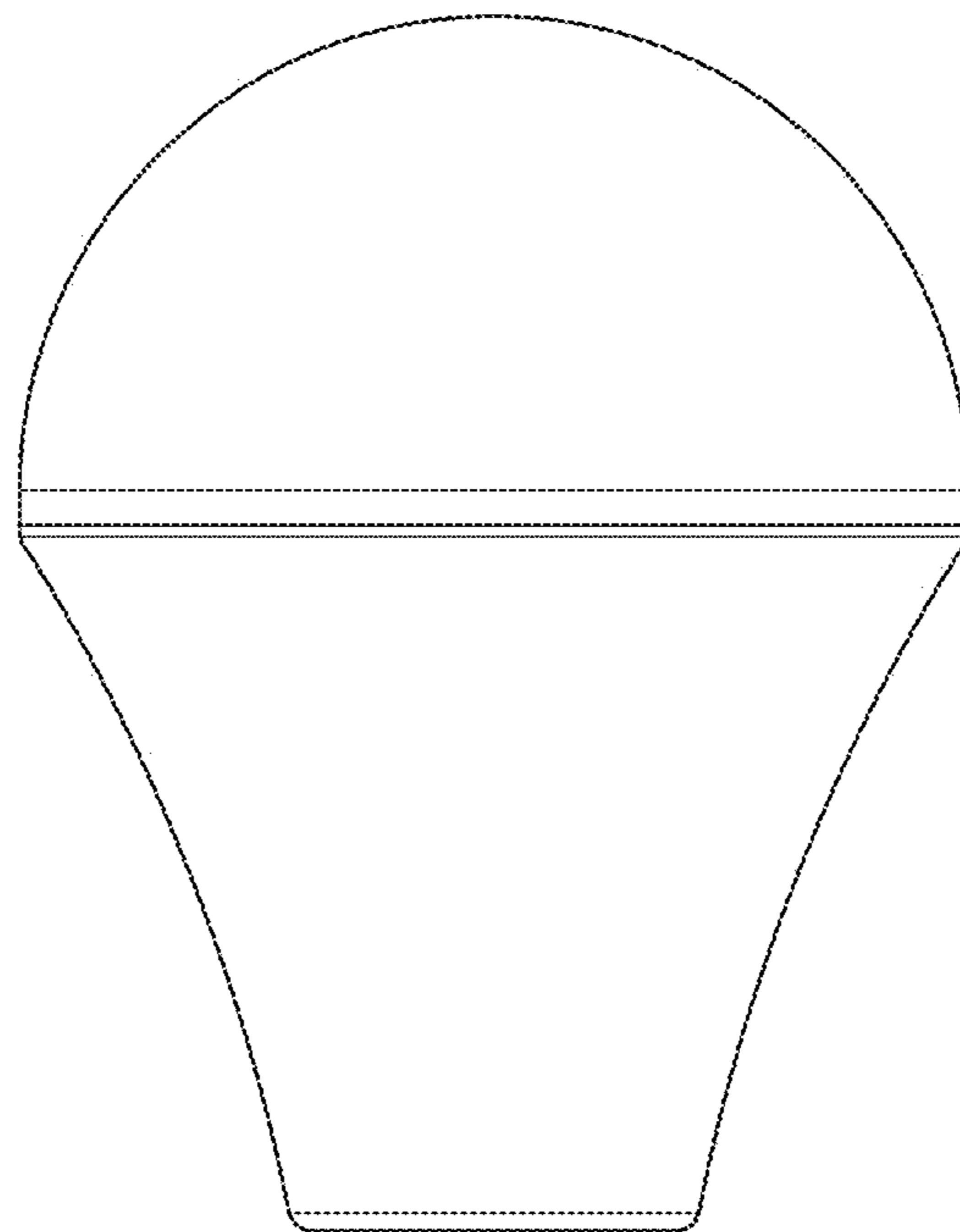

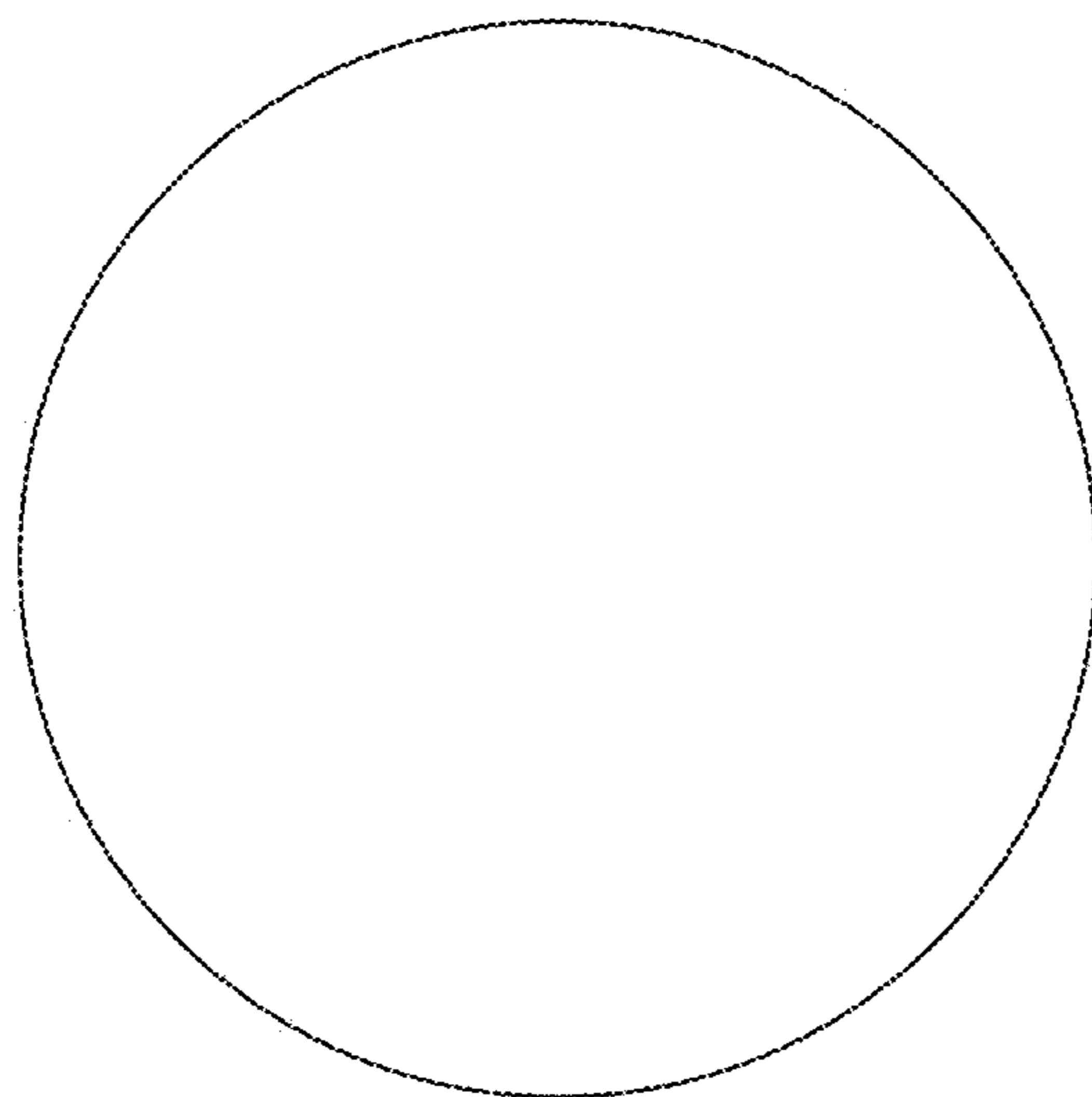

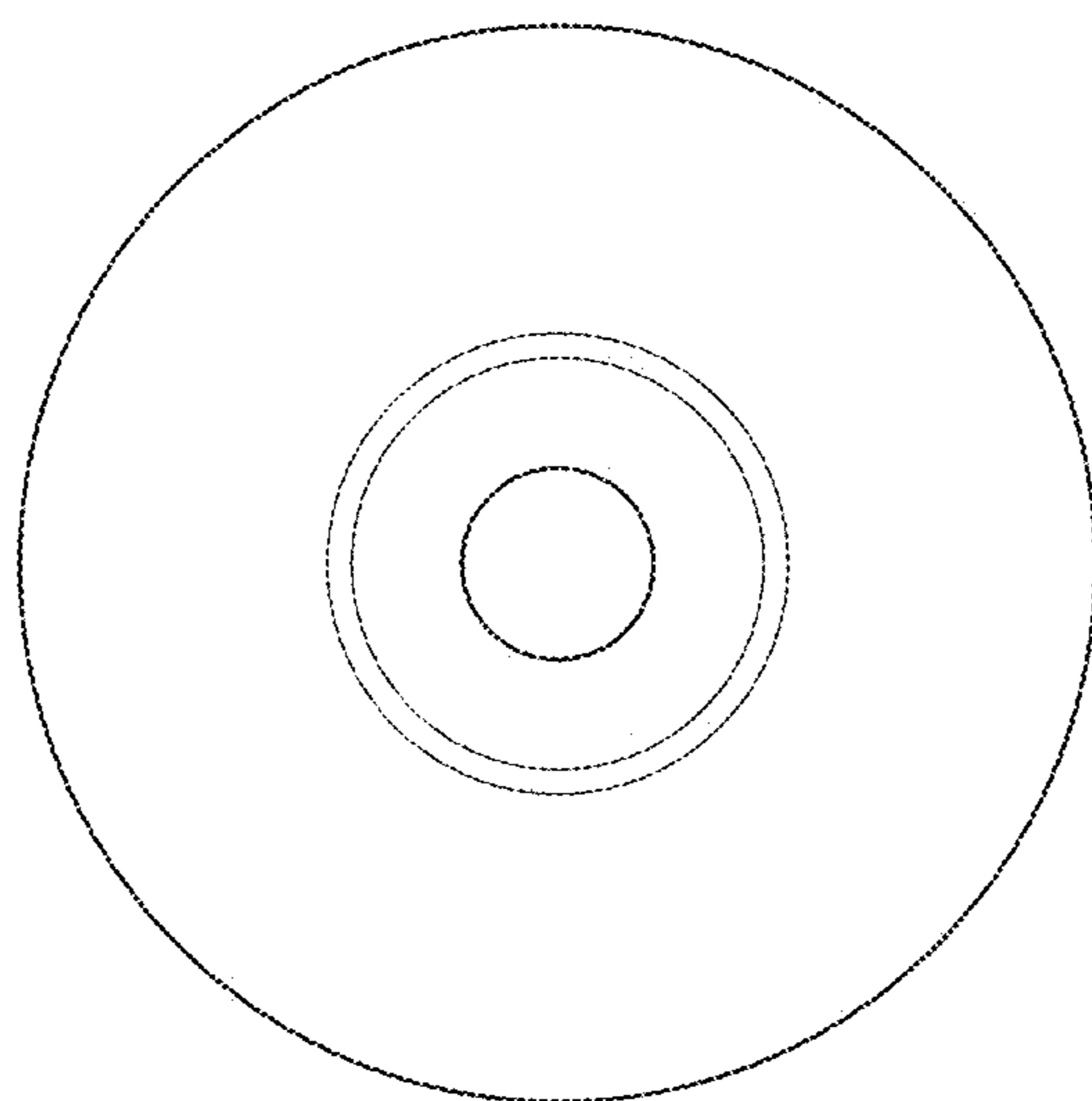

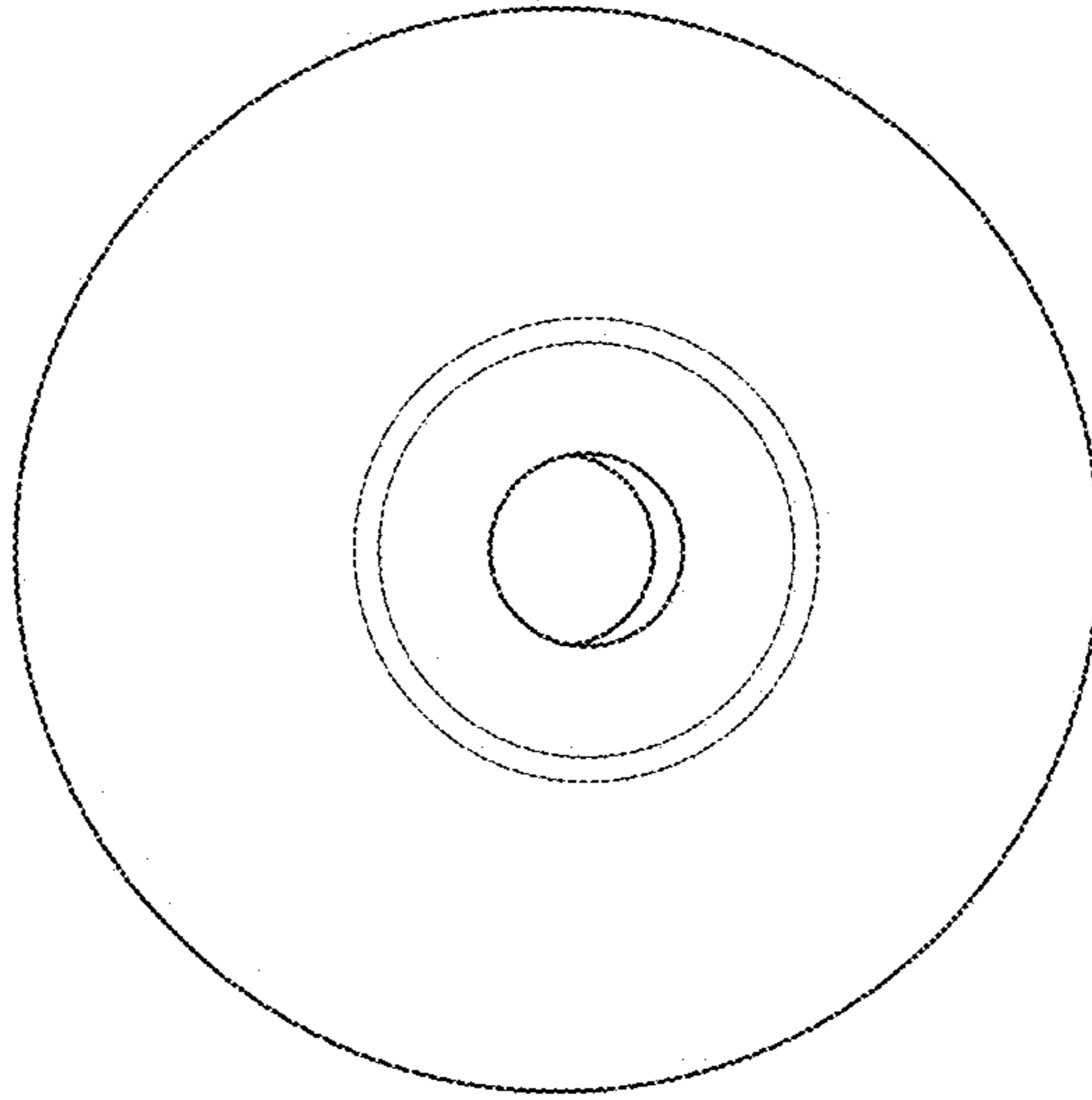

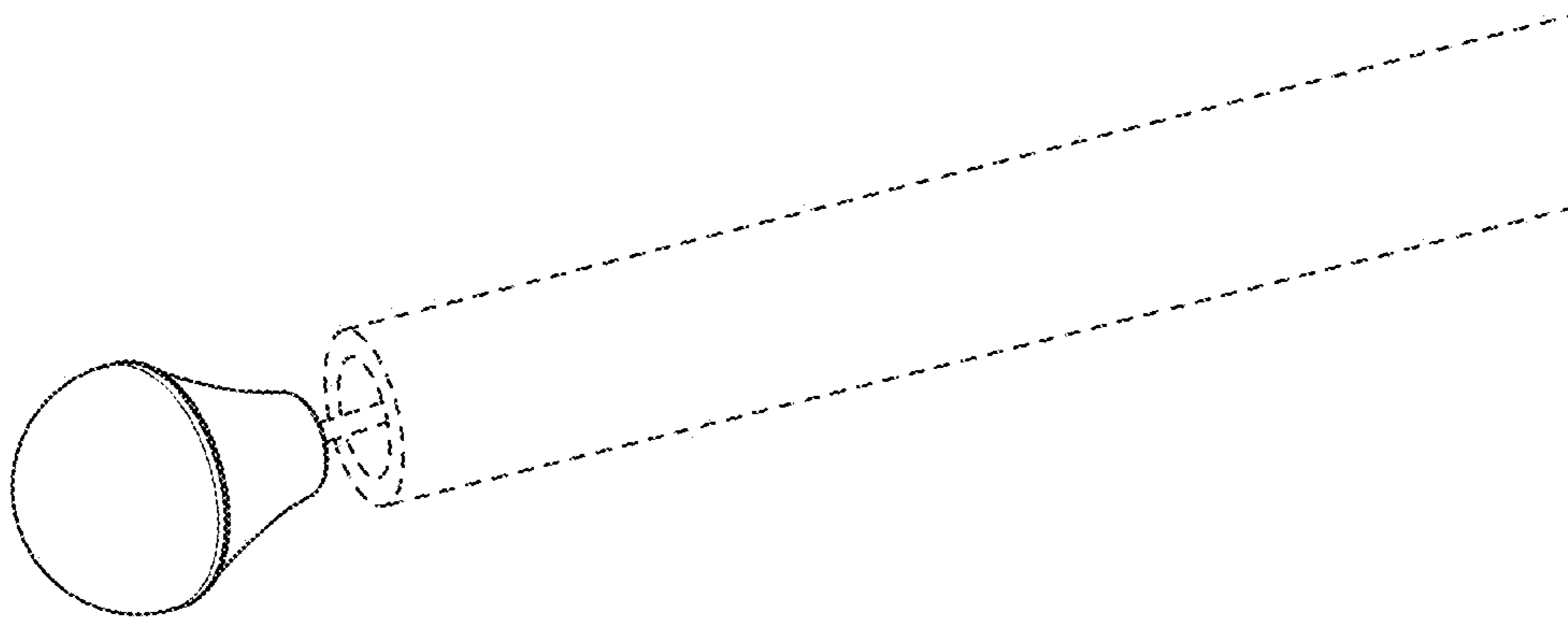
