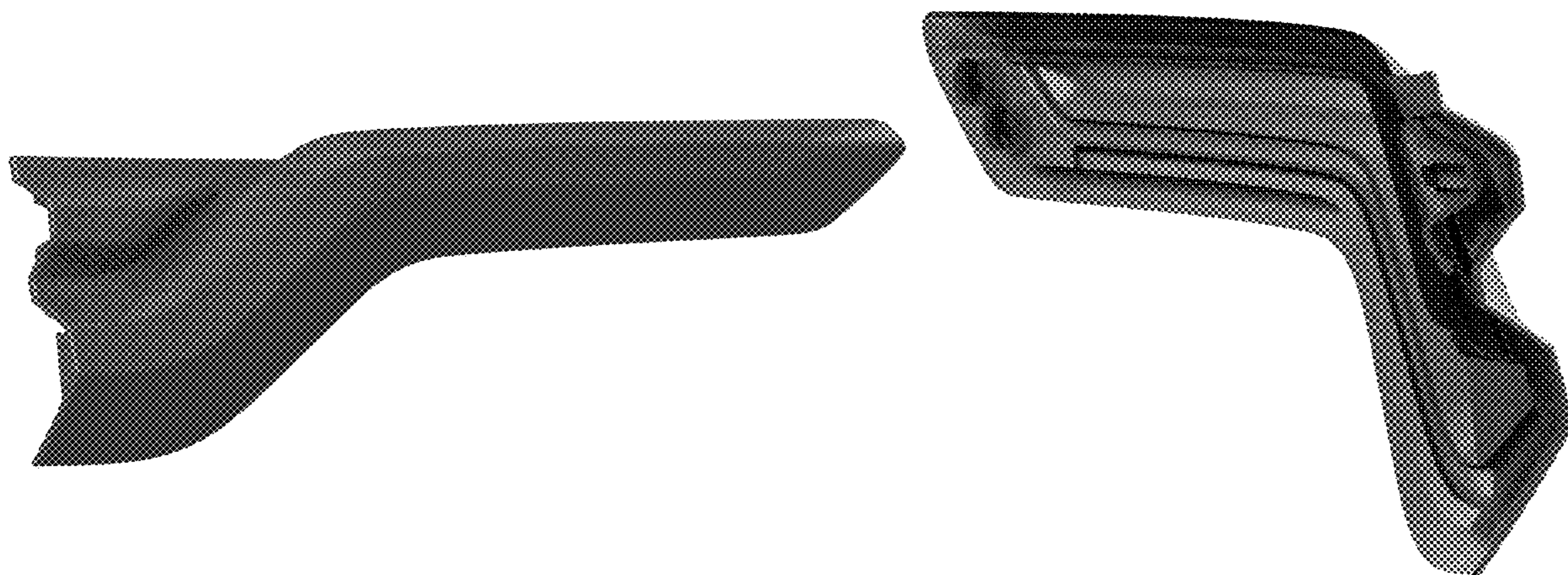

The ornamental design for a rear lamp on vehicle liftgate, as shown and described.

DESCRIPTION
FIG. 1 is a front view of a rear lamp on vehicle liftgate showing our new design;

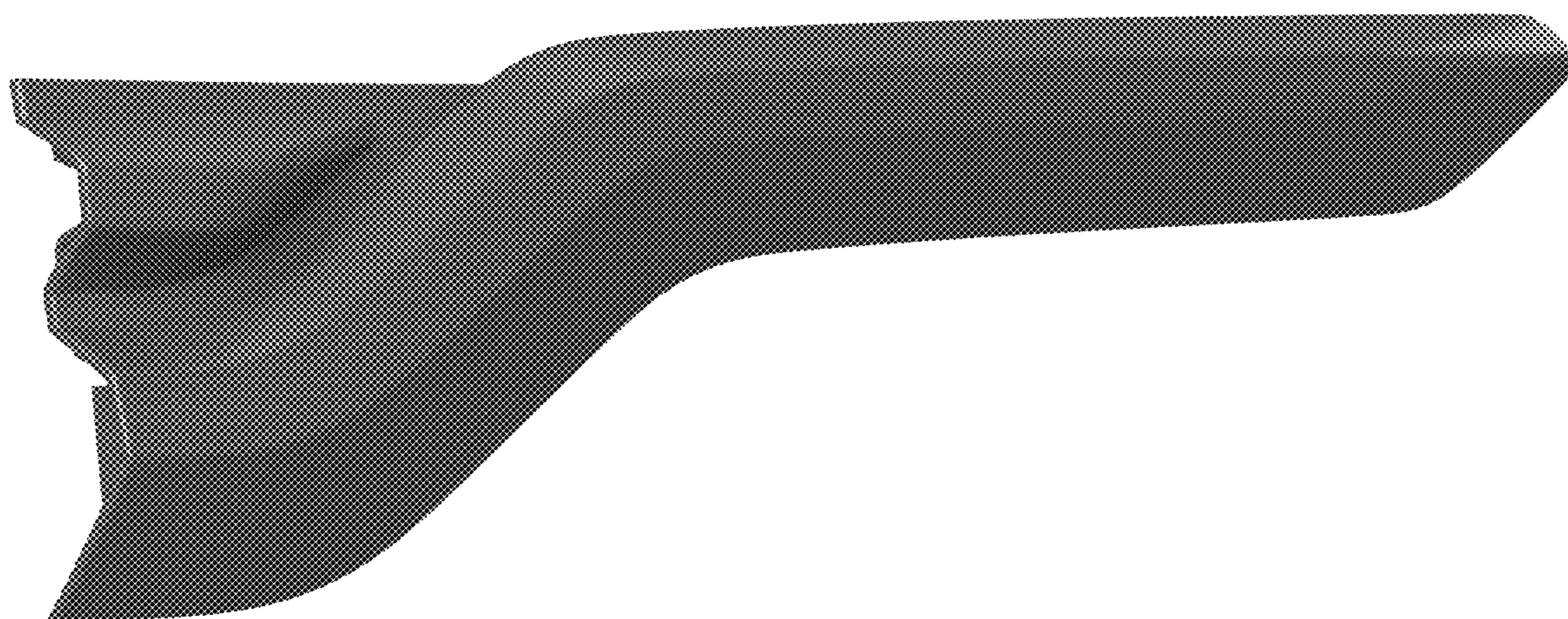

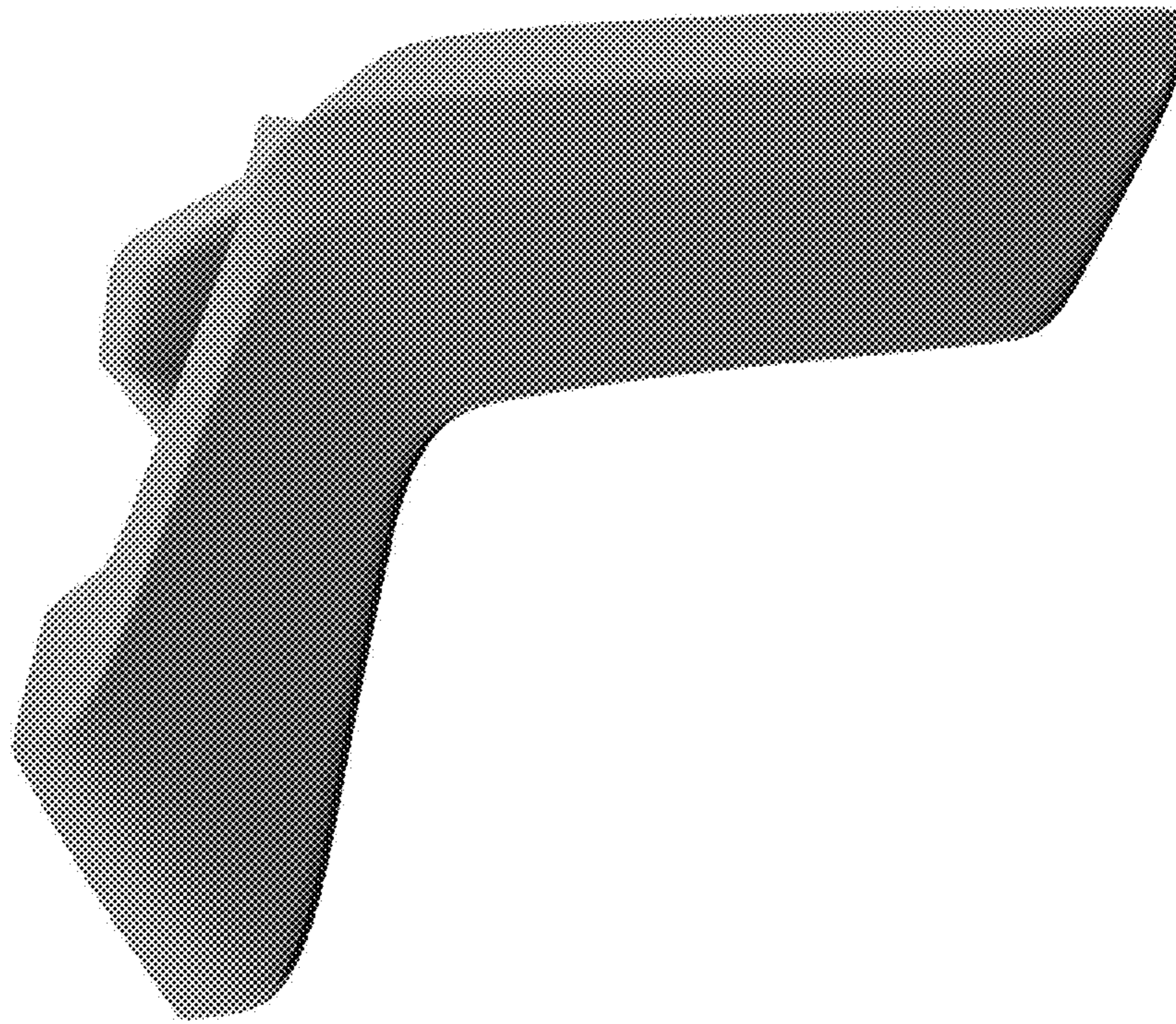

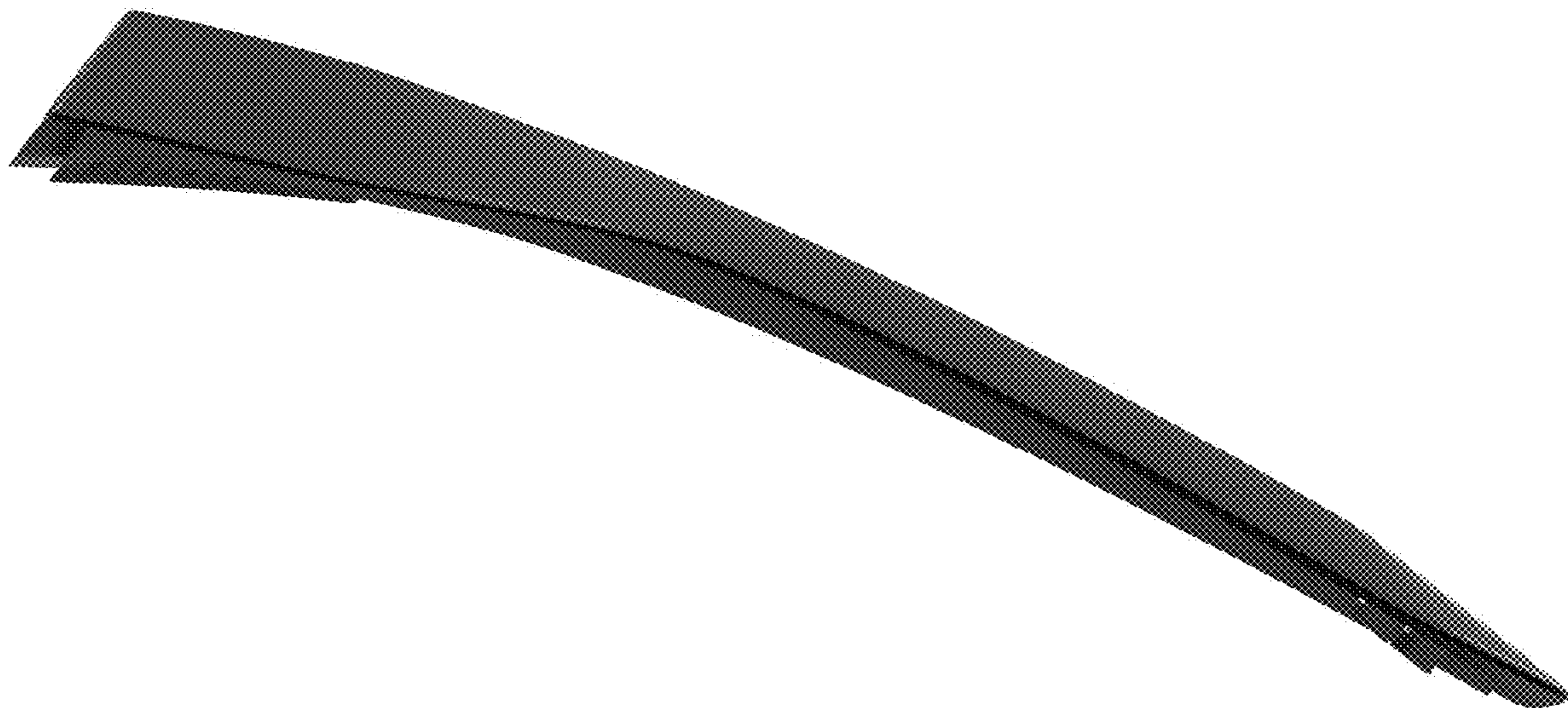

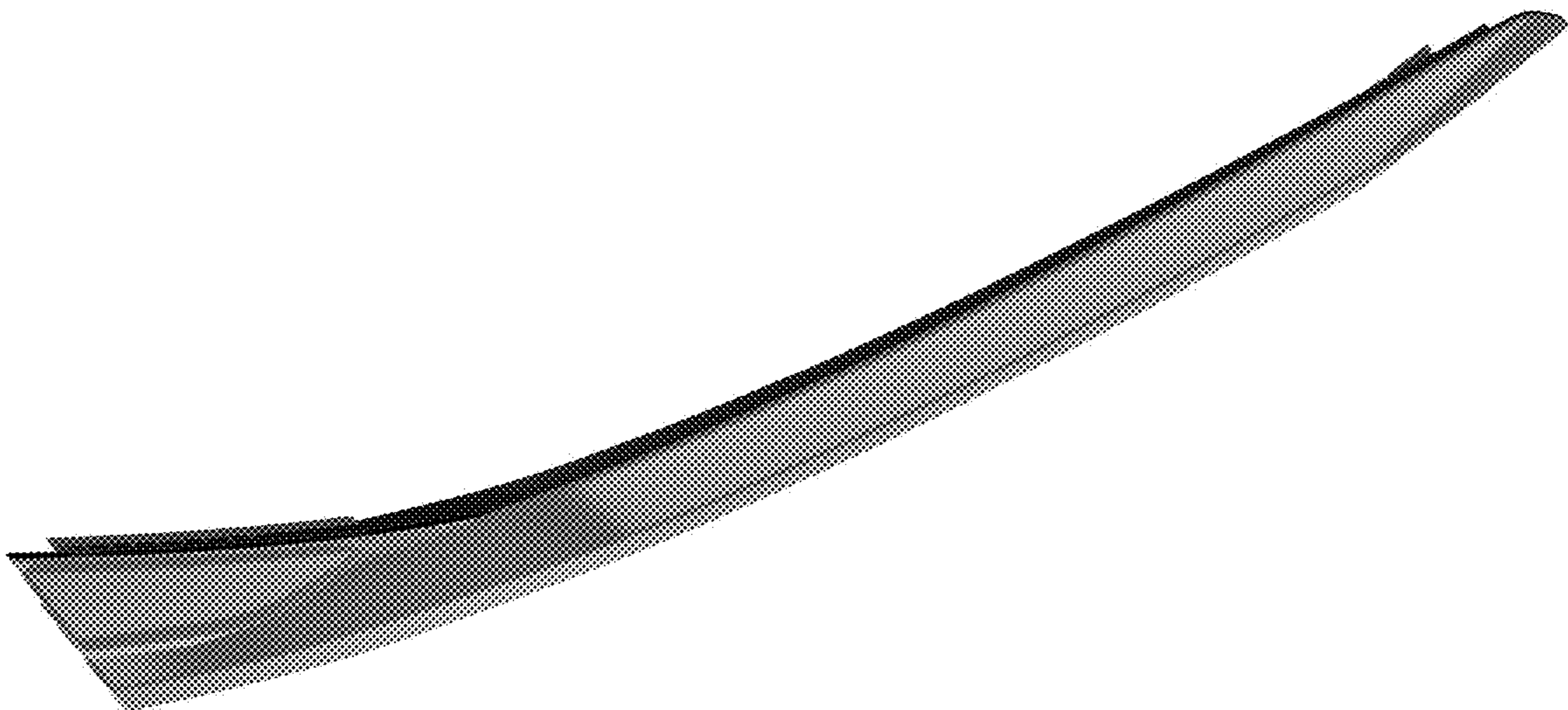

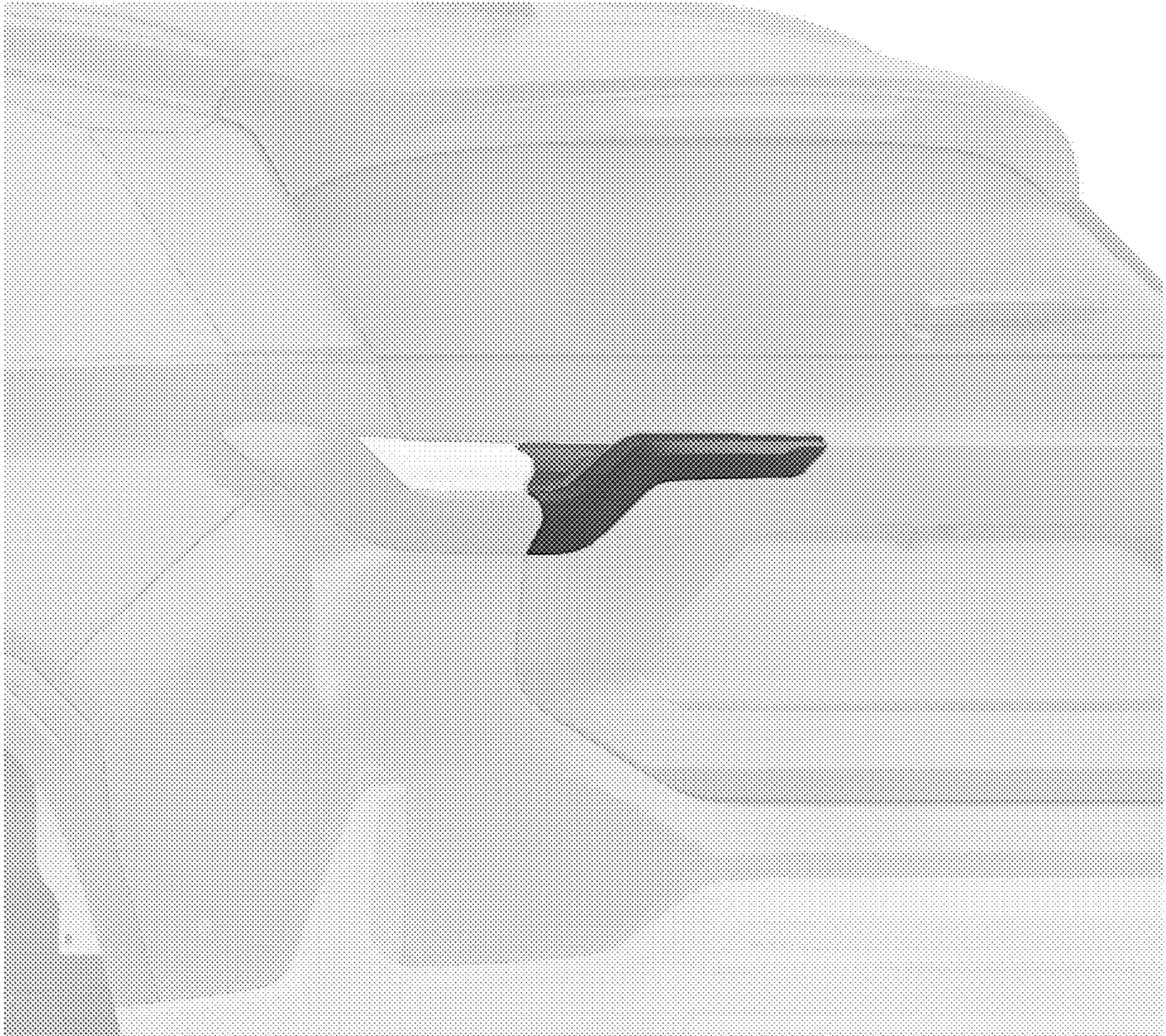
