(57) **CLAIM**

The ornamental design for a street lamp, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a street lamp constructed in accordance with the invention;

FIG. 2 is a front view of the street lamp shown in FIG. 1; FIG. 3 is a right side view of the street lamp shown in FIG. 1;

FIG. 4 is a rear view of the street lamp as shown in FIG. 1; FIG. 5 is a left side view of the street lamp shown in FIG. 1;

FIG. 6 is a top plan view of the street lamp shown in FIG. 1; and,

FIG. 7 is a bottom plan view of the street lamp shown in FIG. 1.

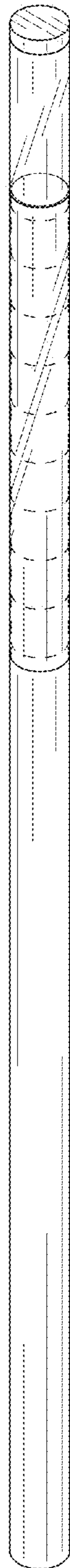

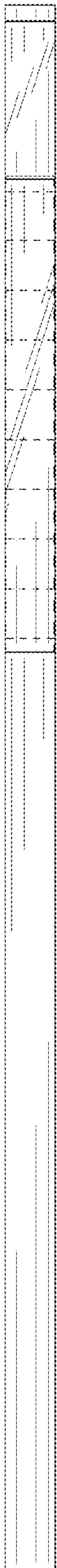

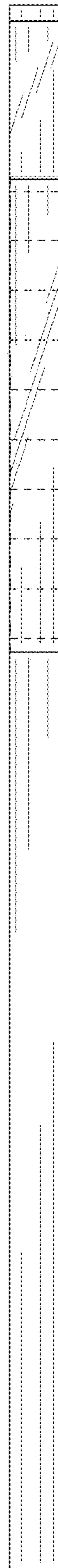

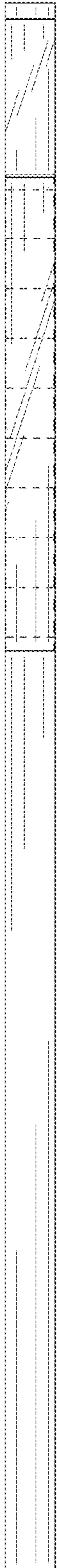

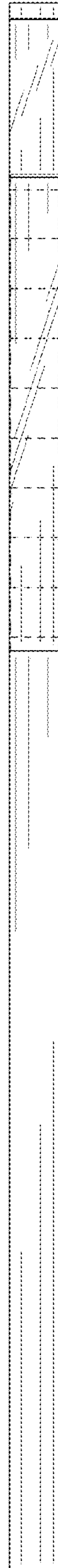

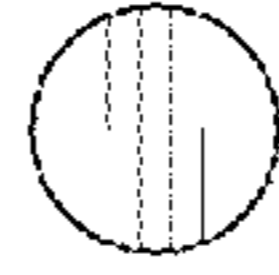

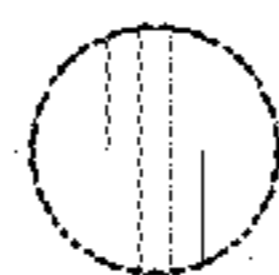
