The ornamental design for a hair accessory, as shown and described.

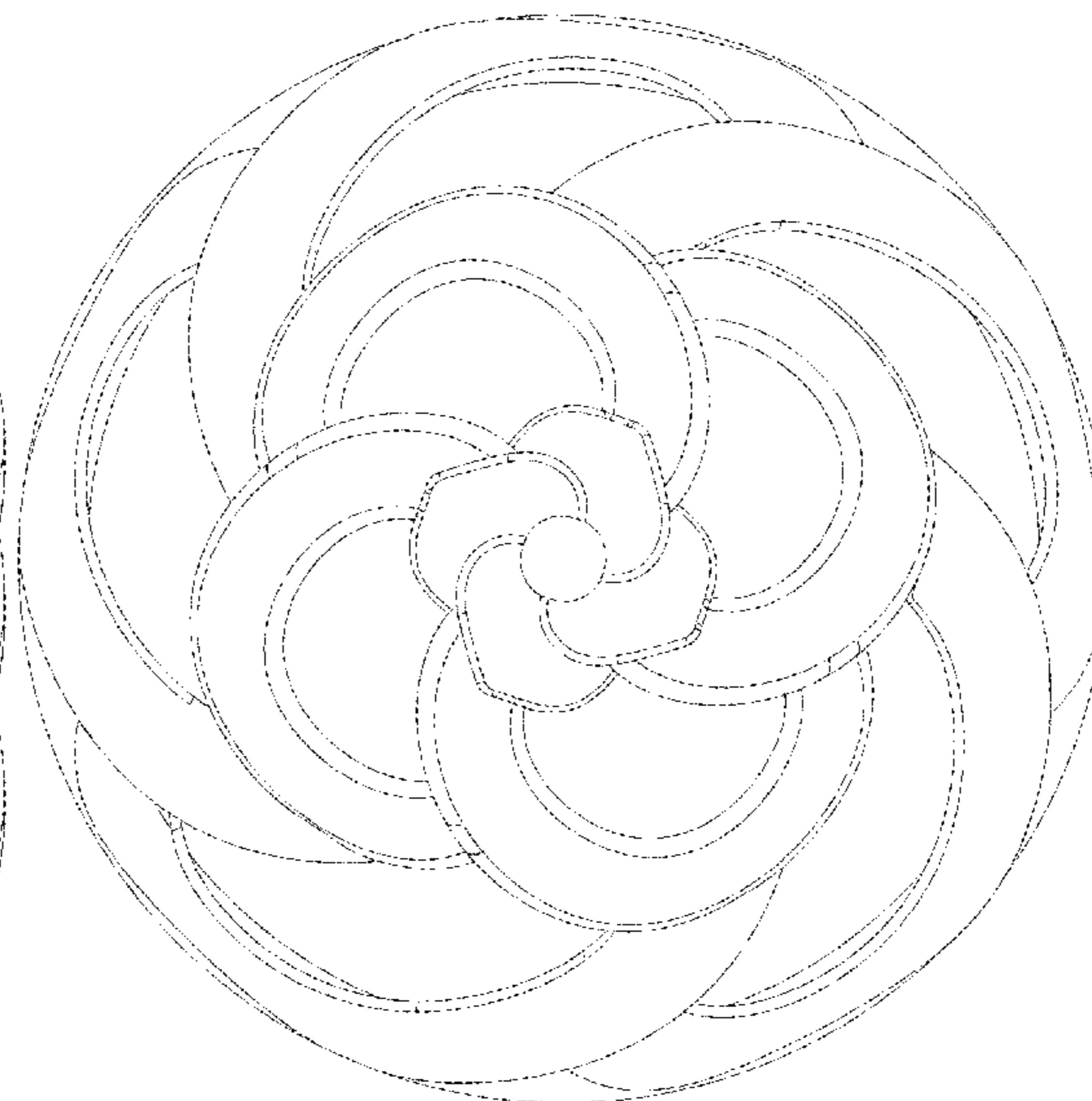
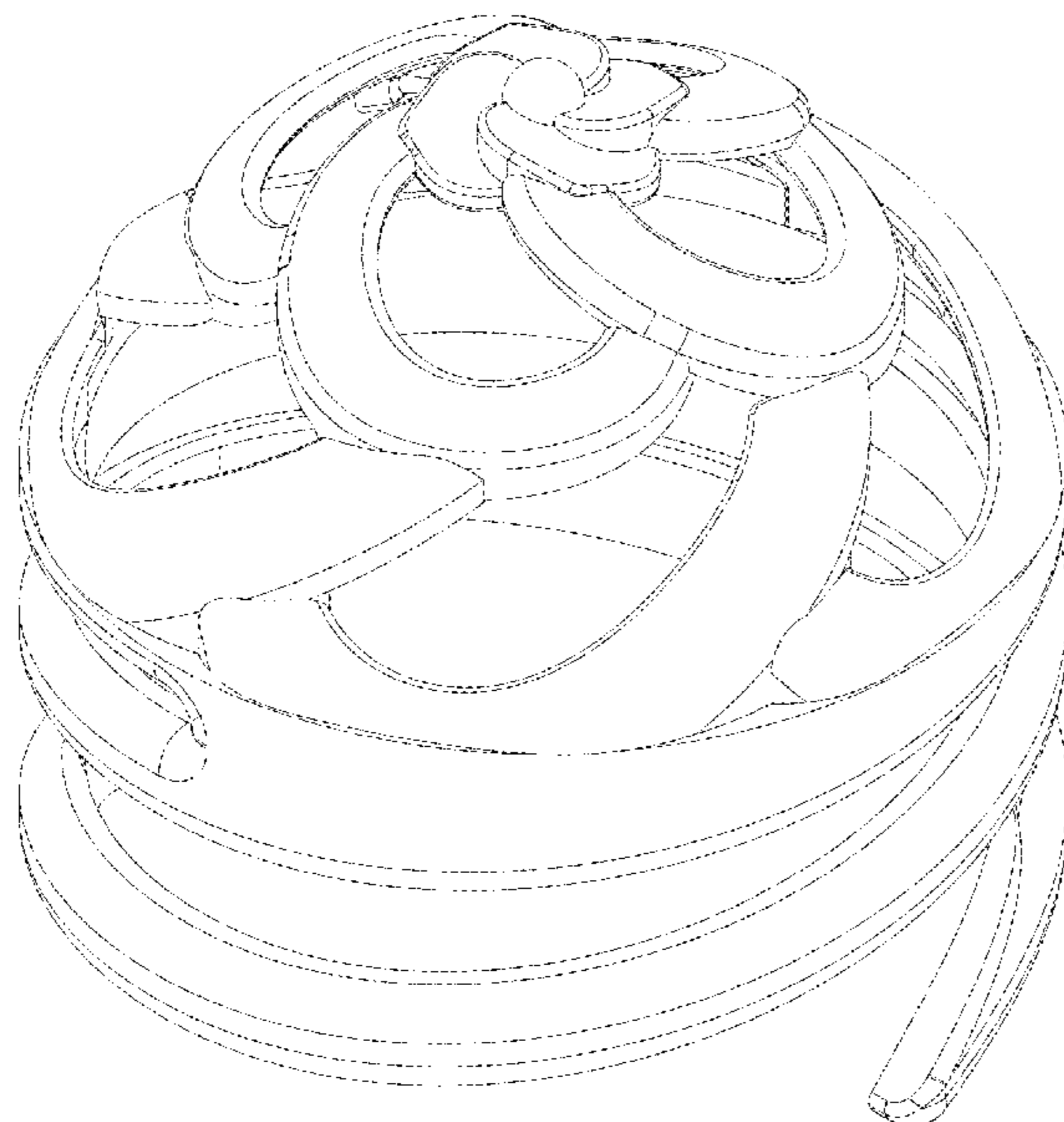
DESCRIPTION

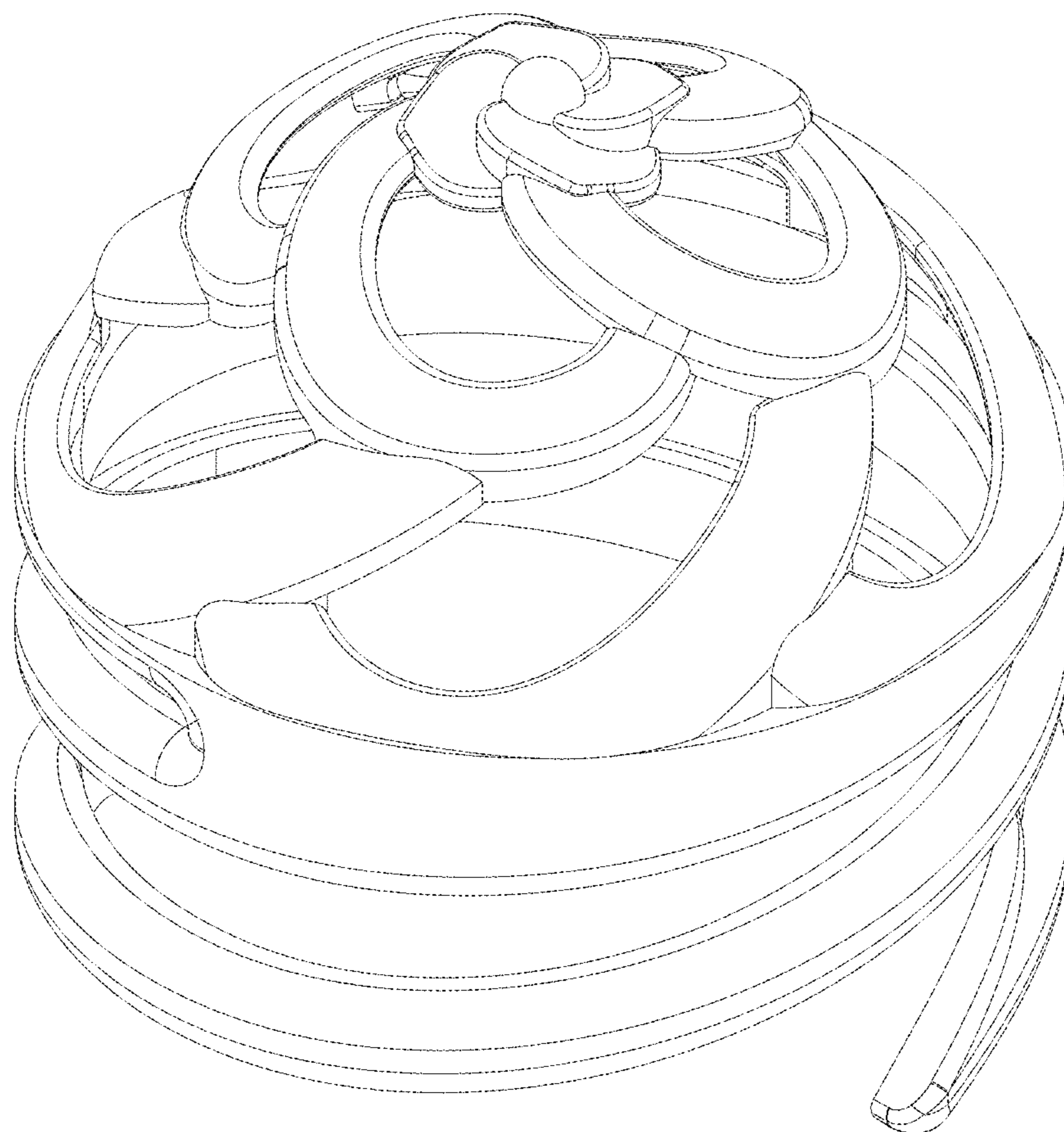

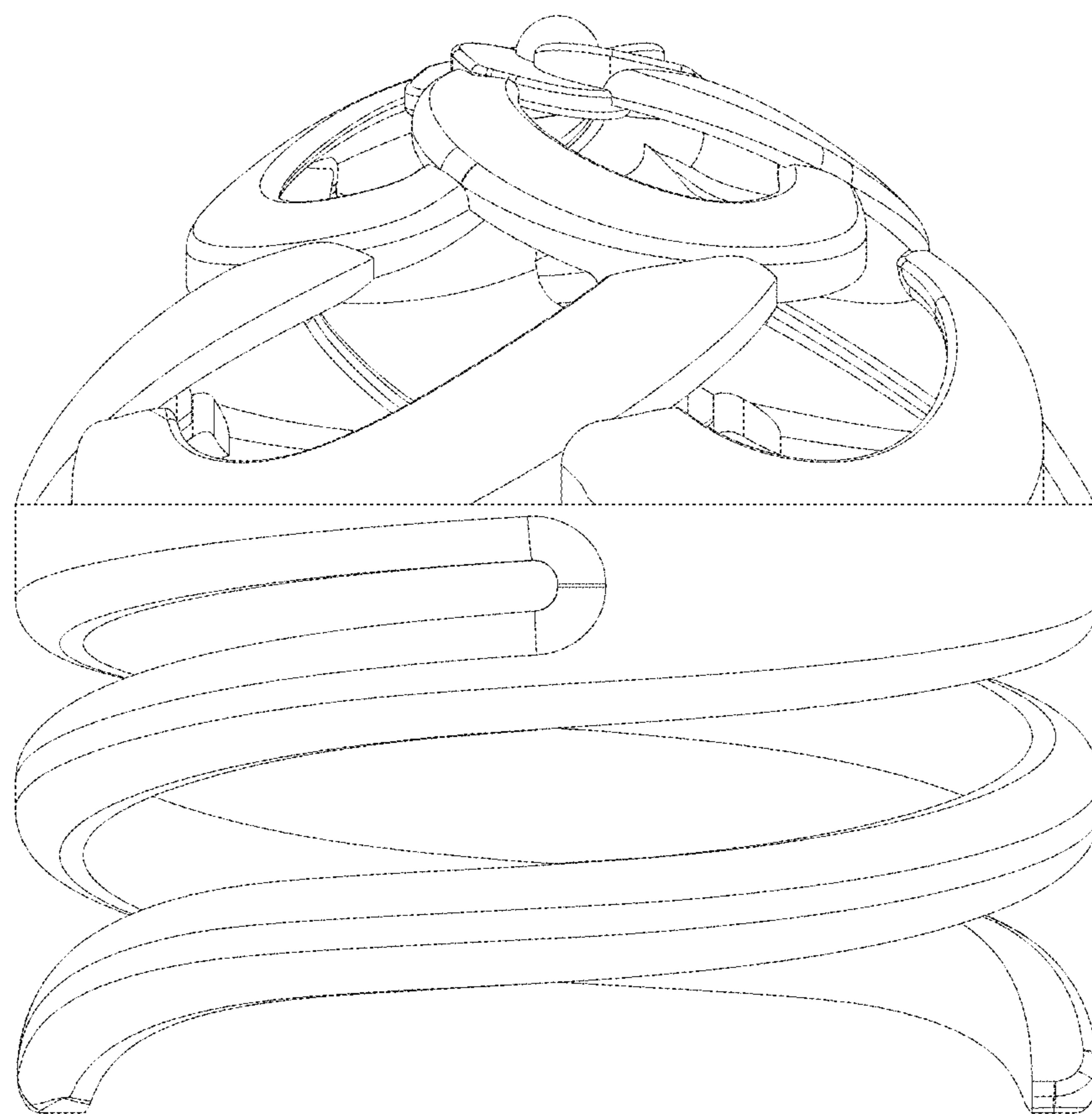

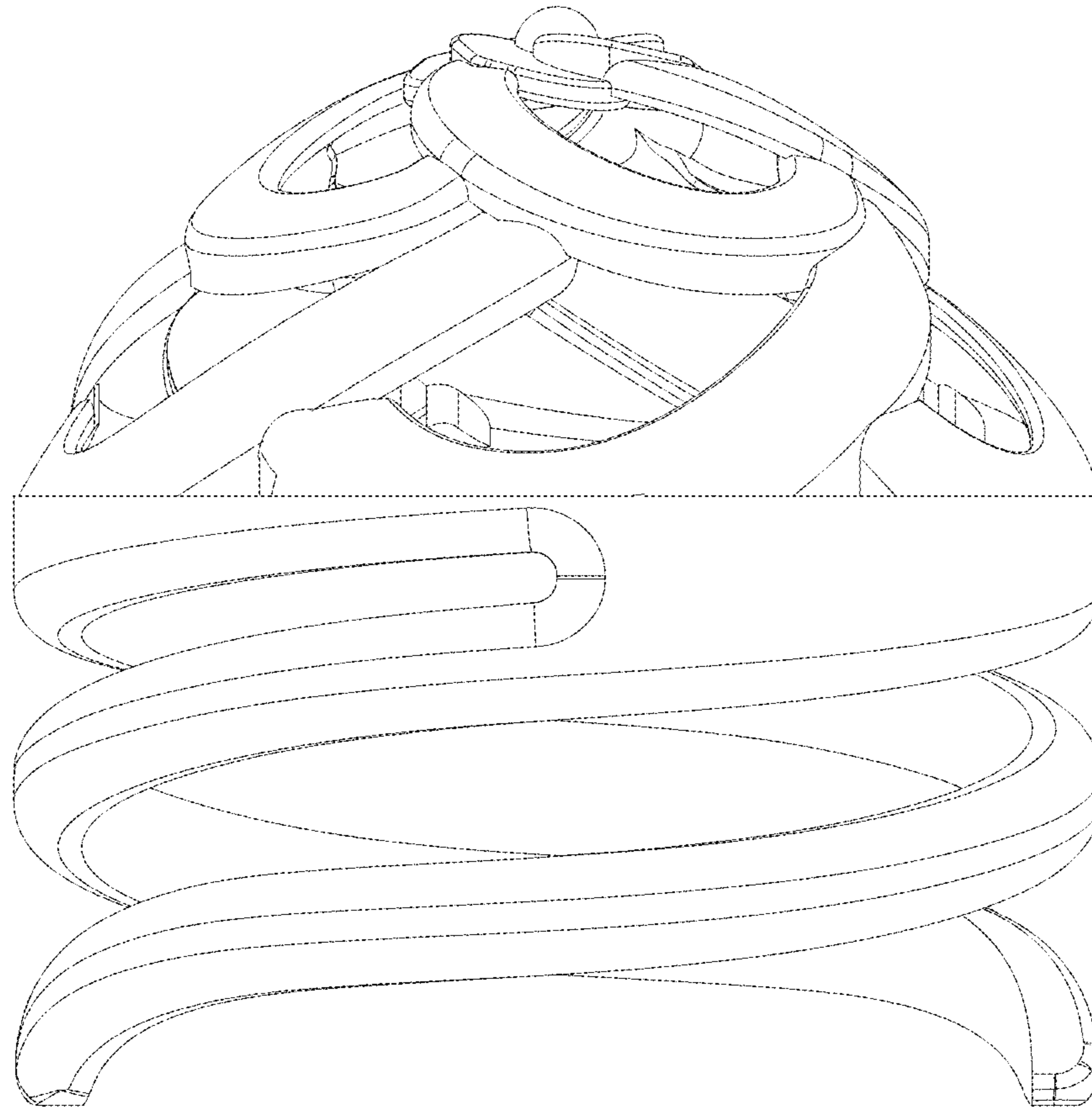

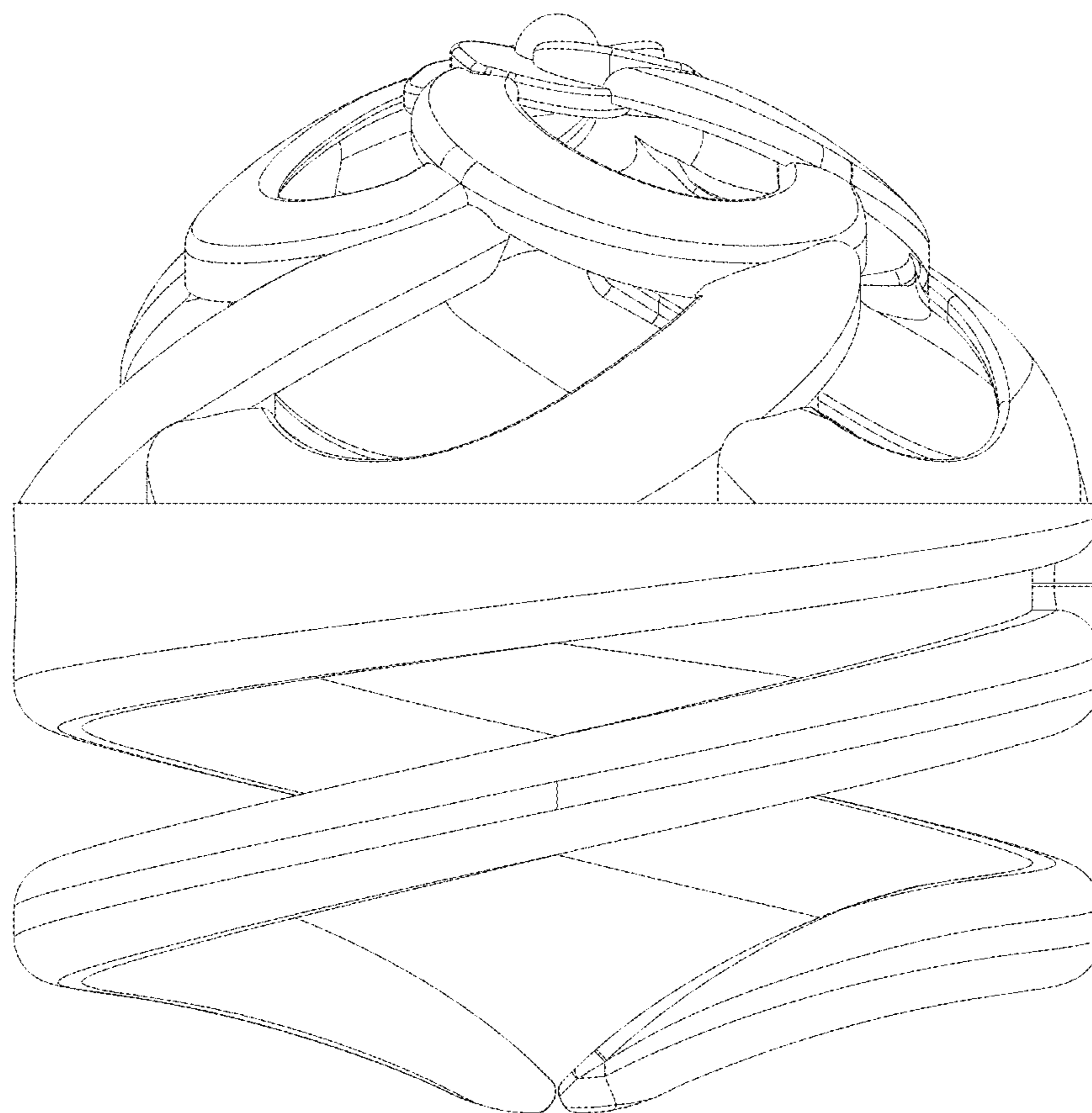

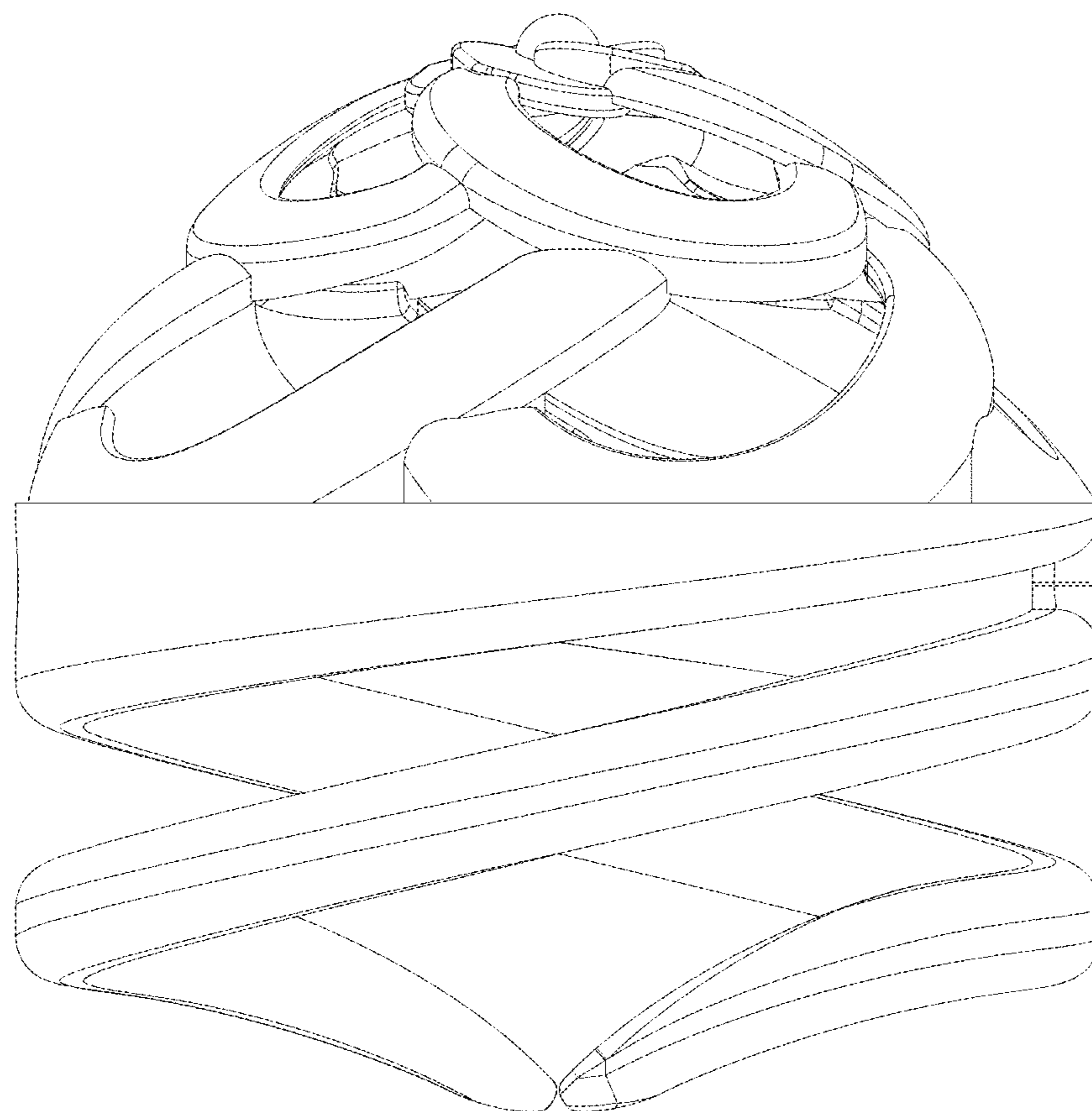

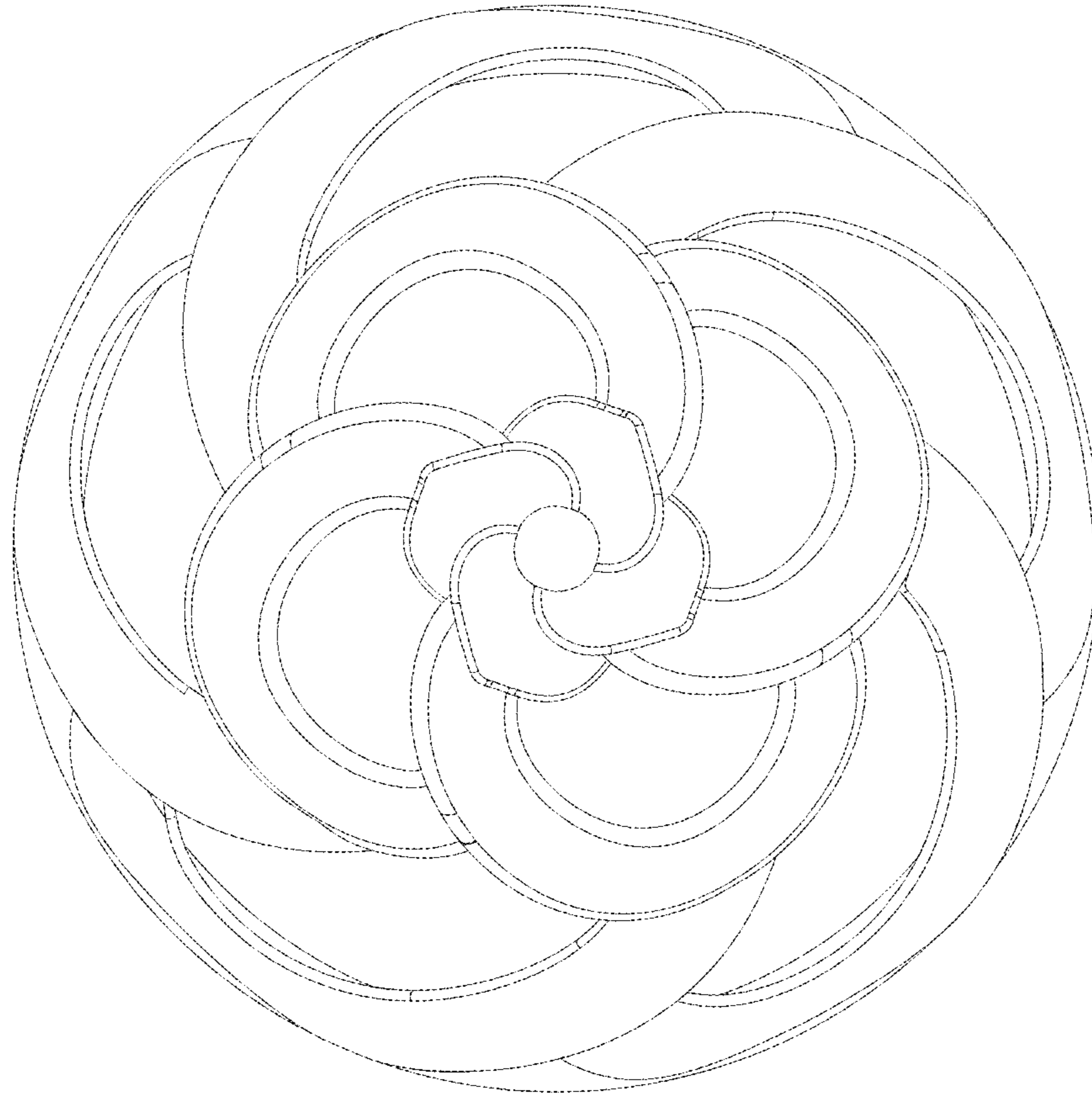

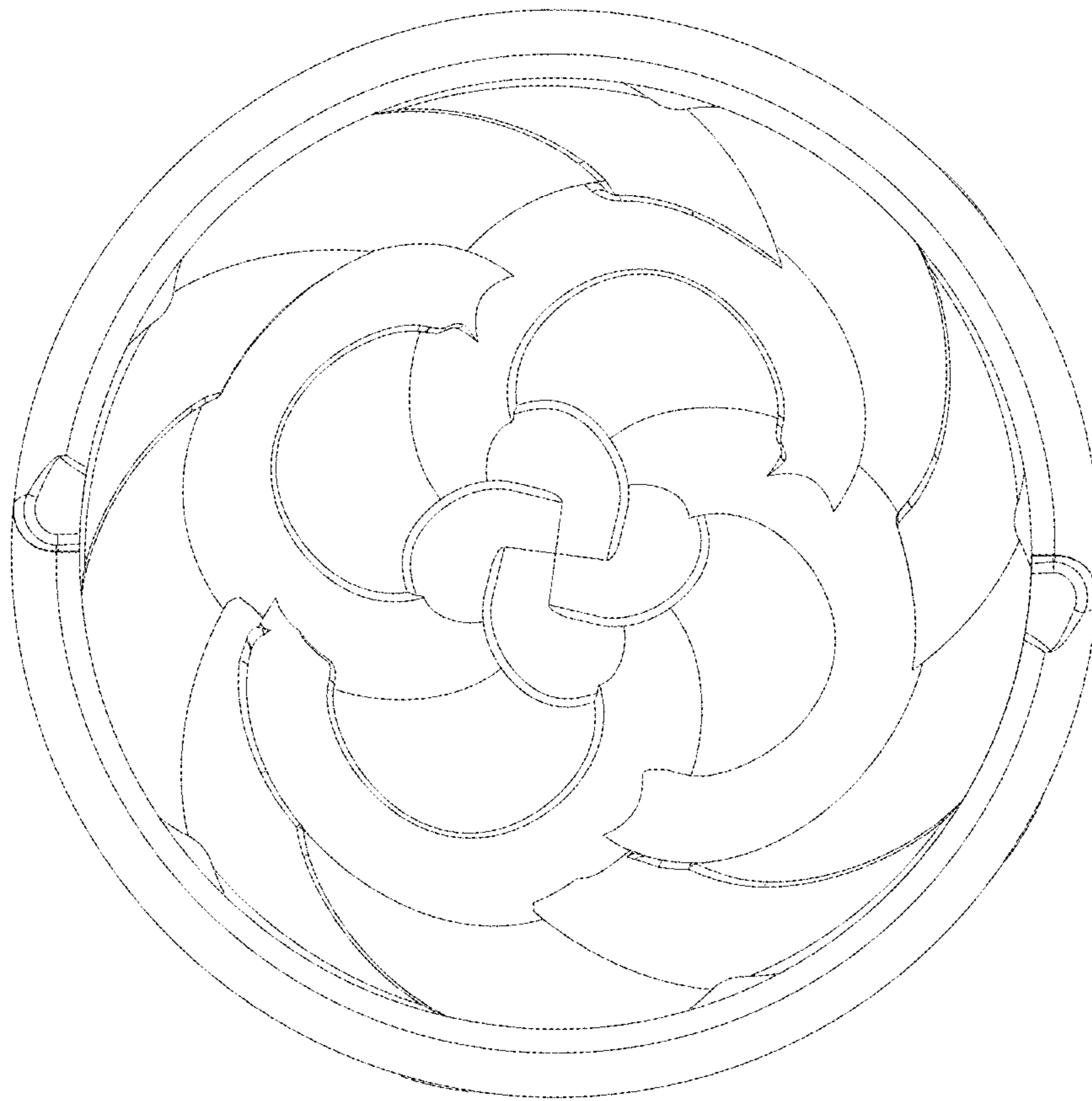
