**DESCRIPTION**

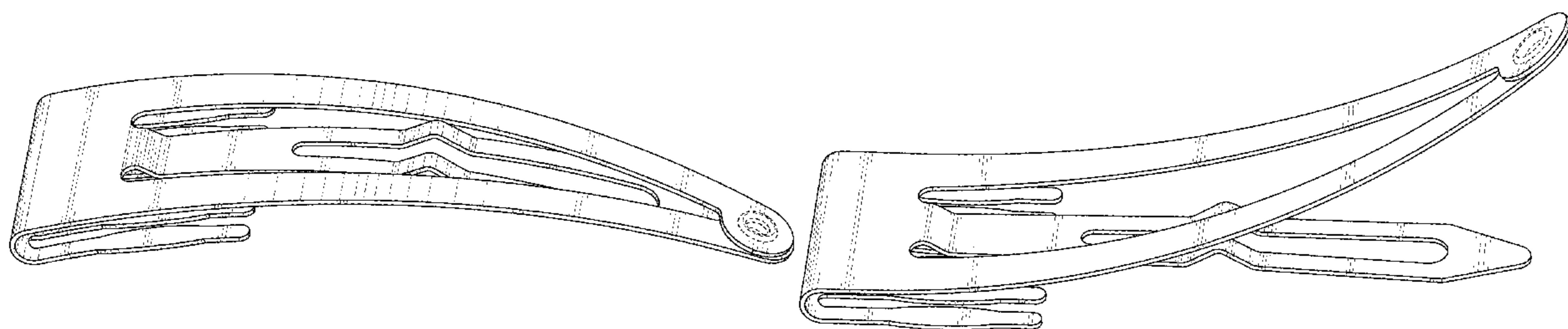
FIG. 1 is a perspective view of a hair clip showing the new design in a closed configuration;

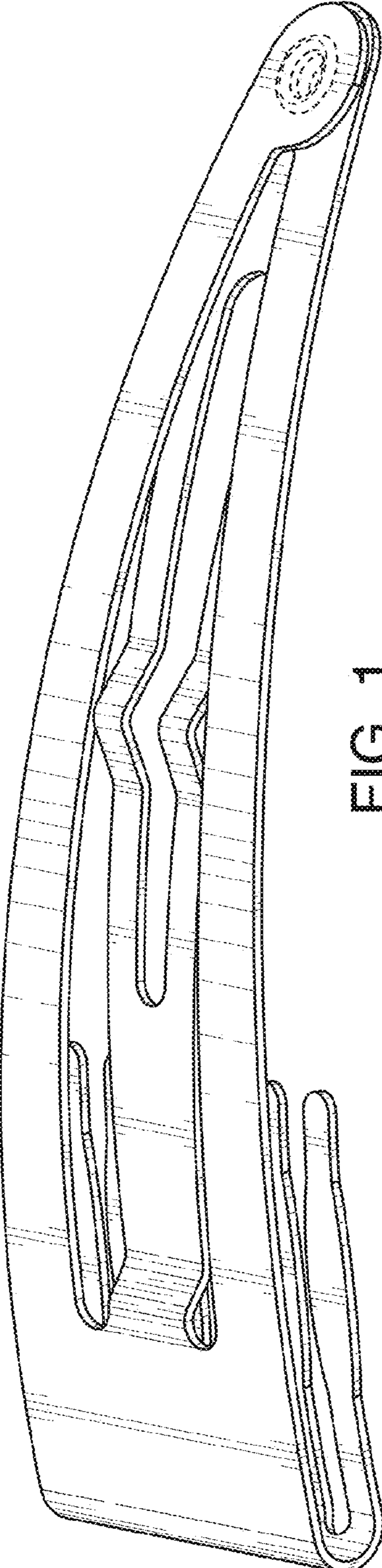

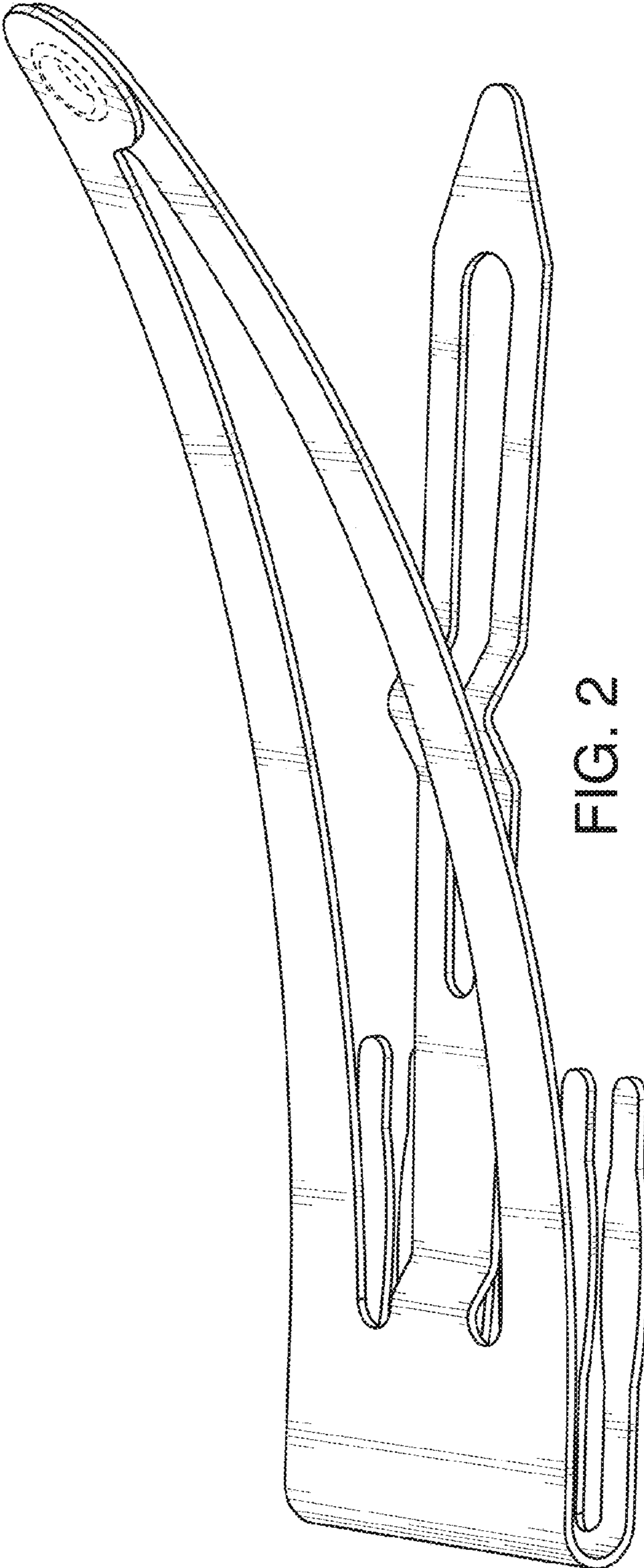

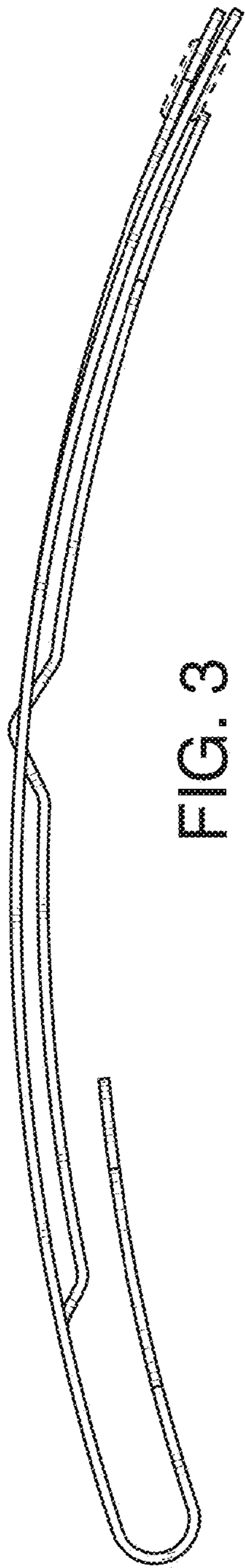

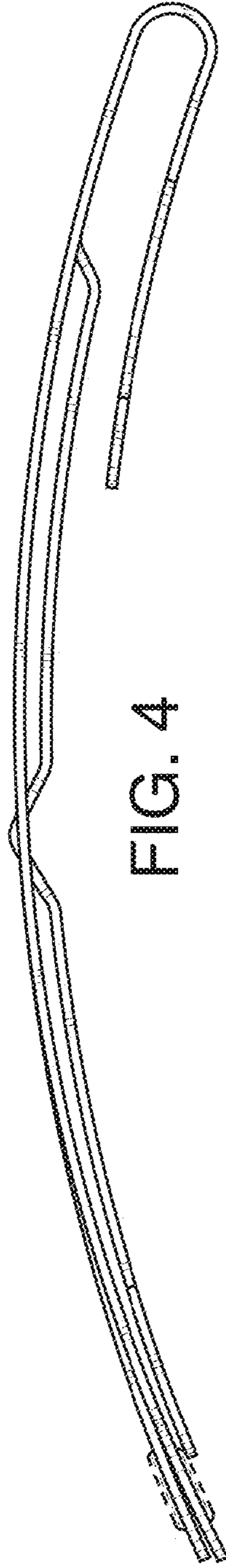

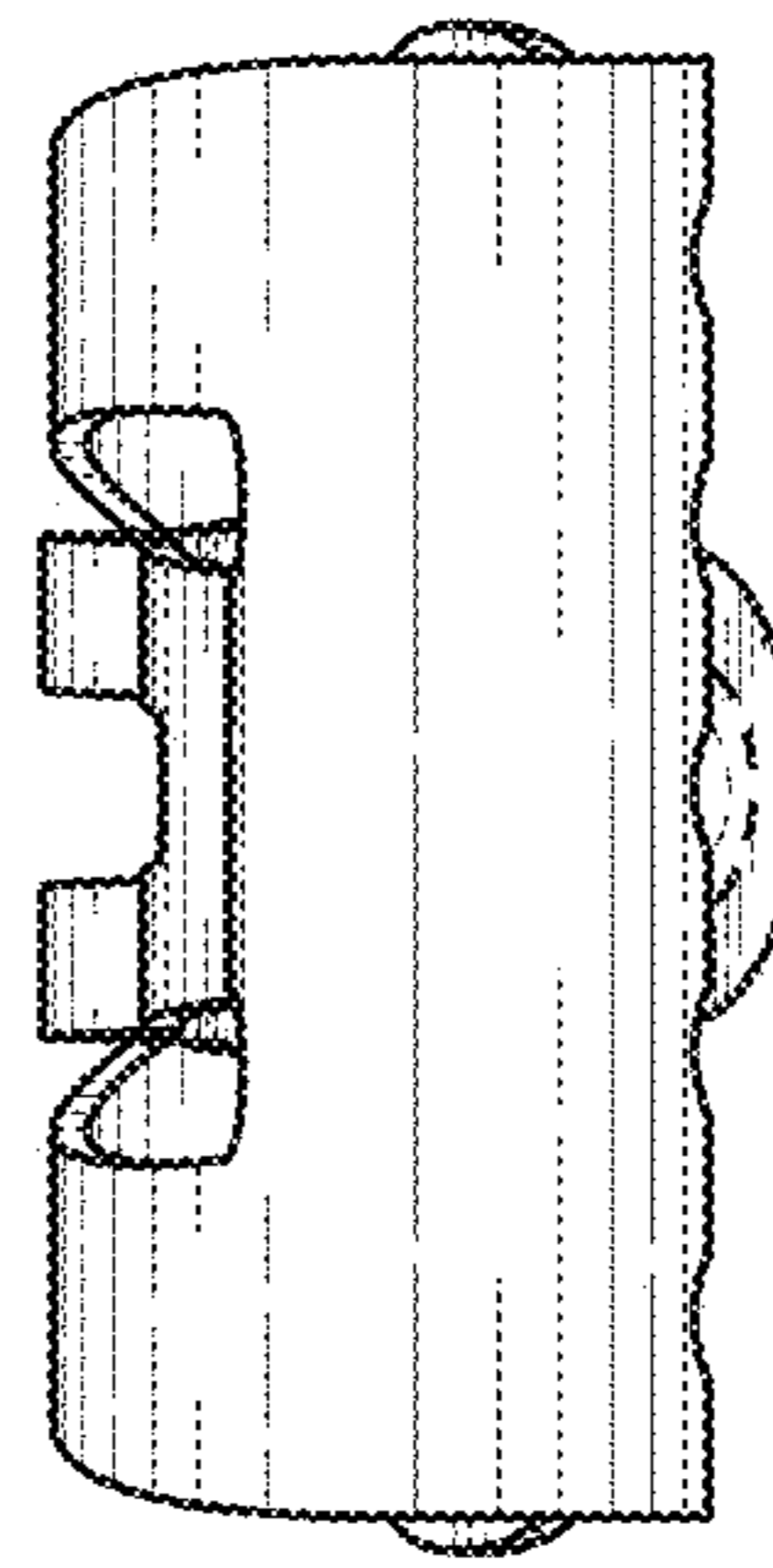

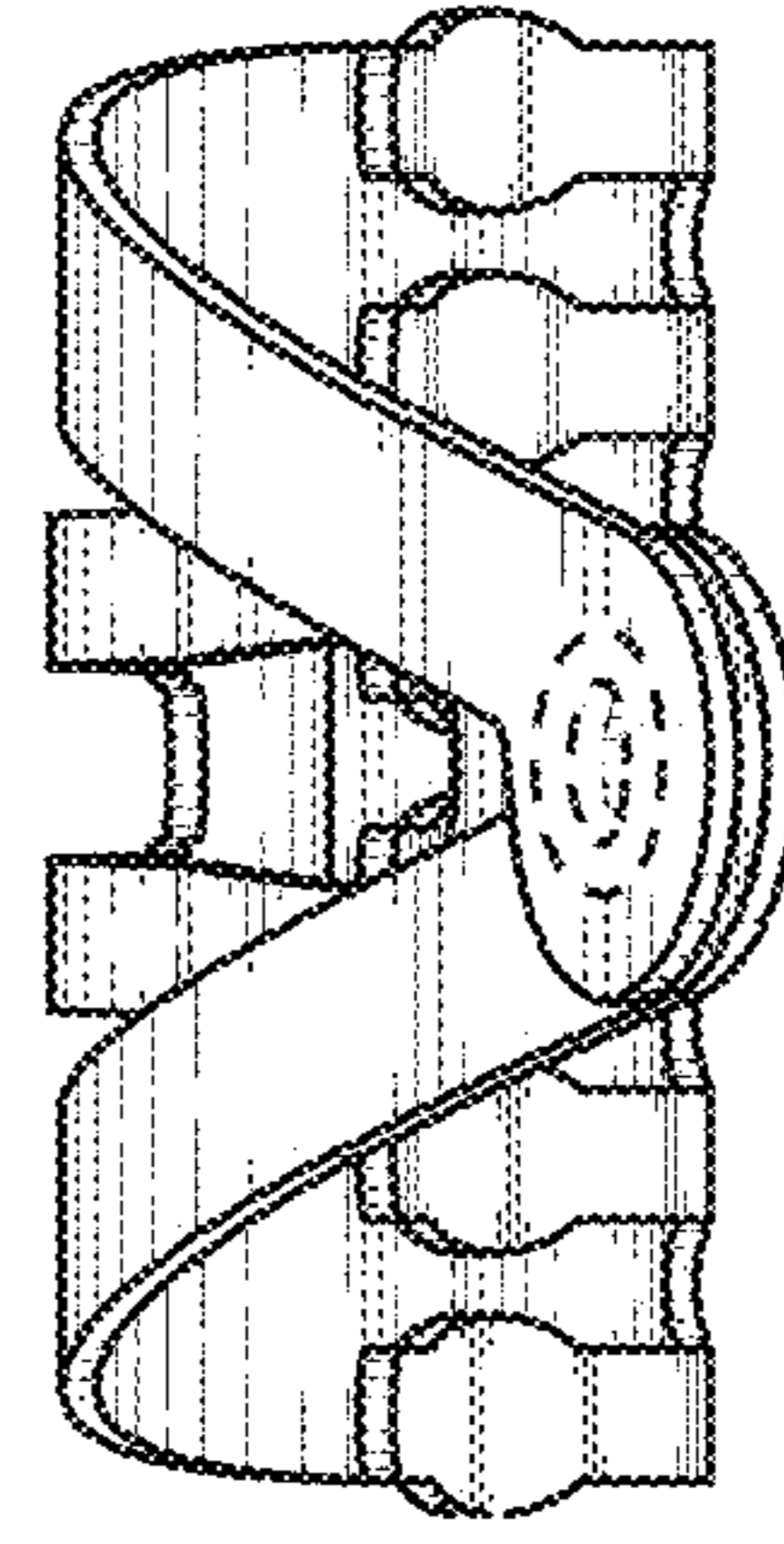

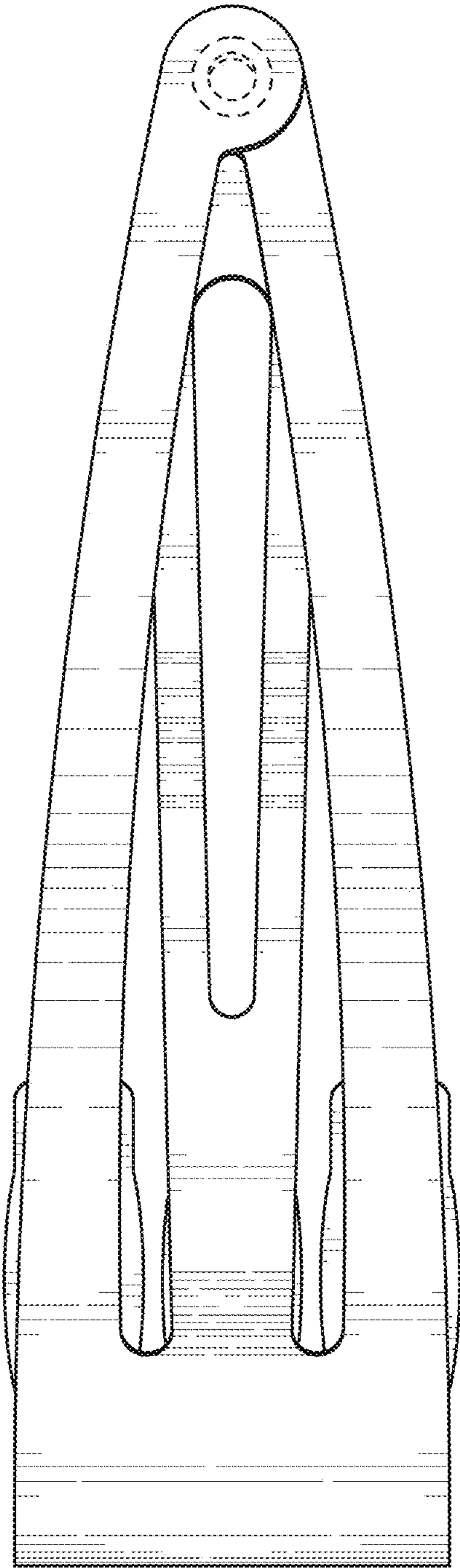

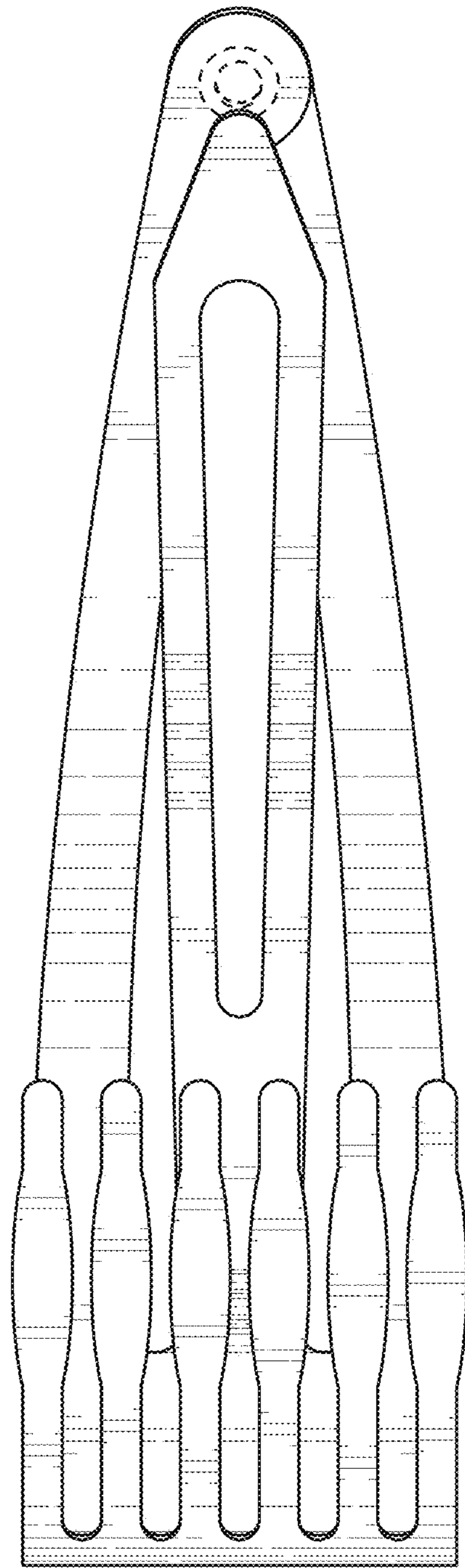
