DESCRIPTION

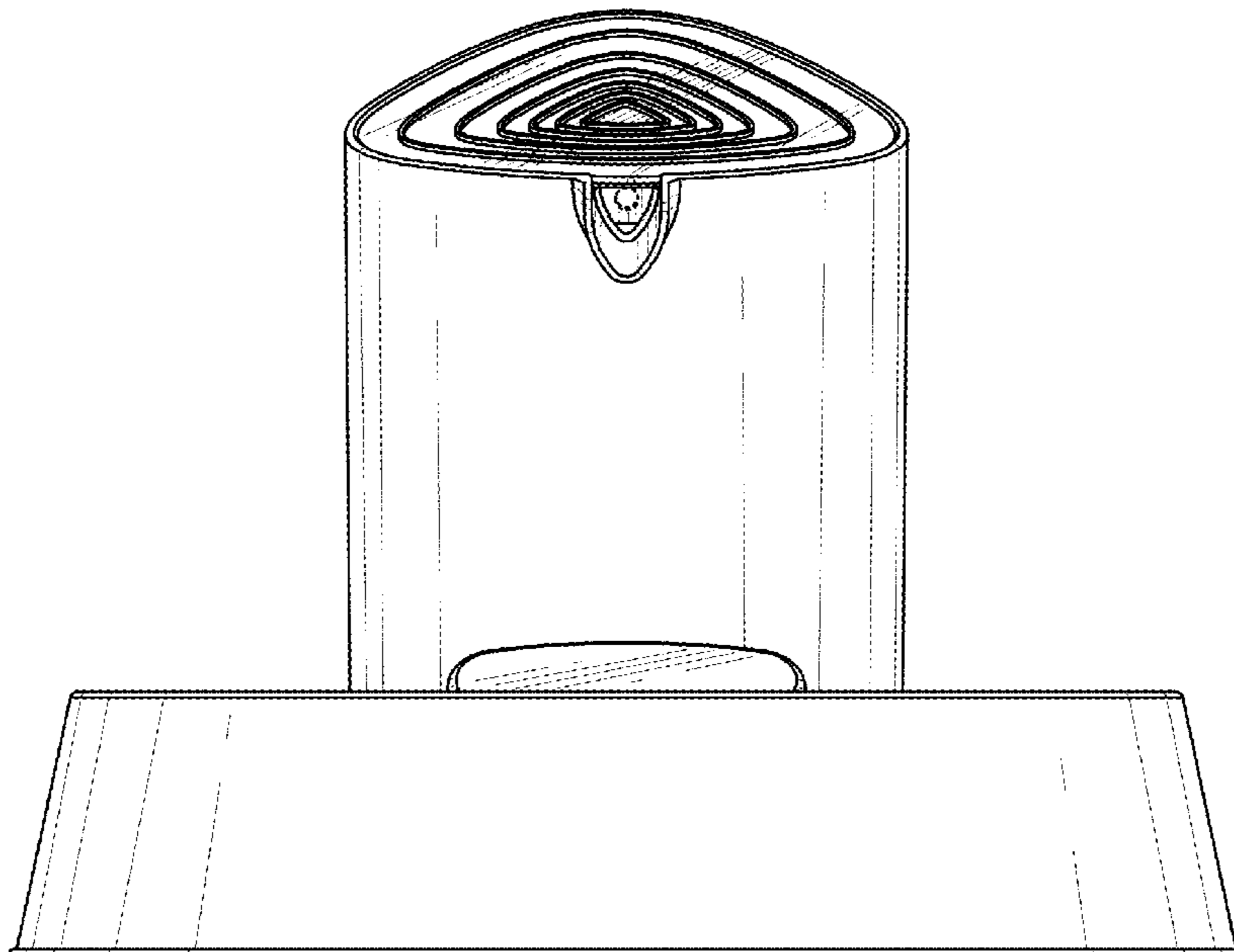
FIG. 1 is a front elevational view of a smart water dispenser showing our new design;

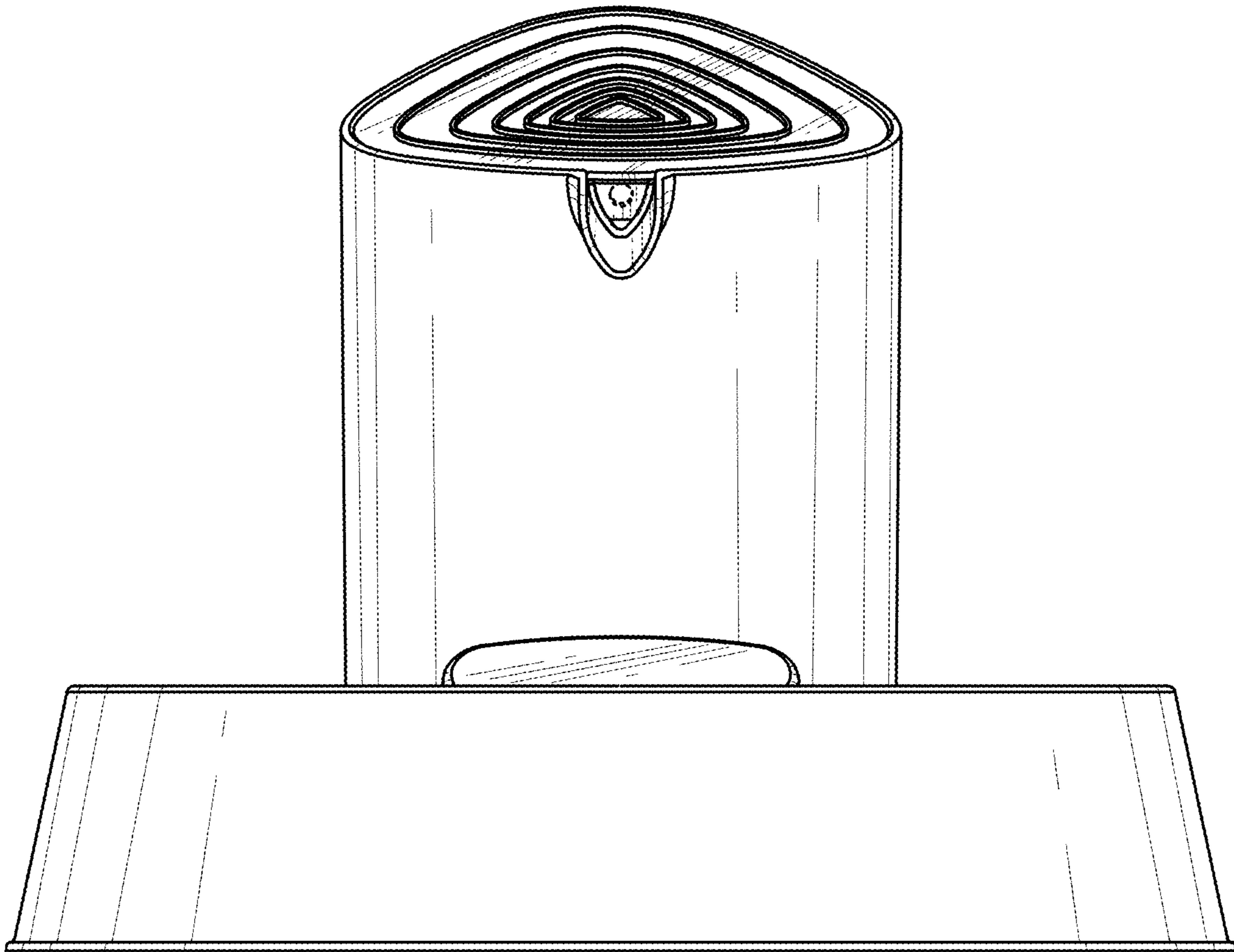

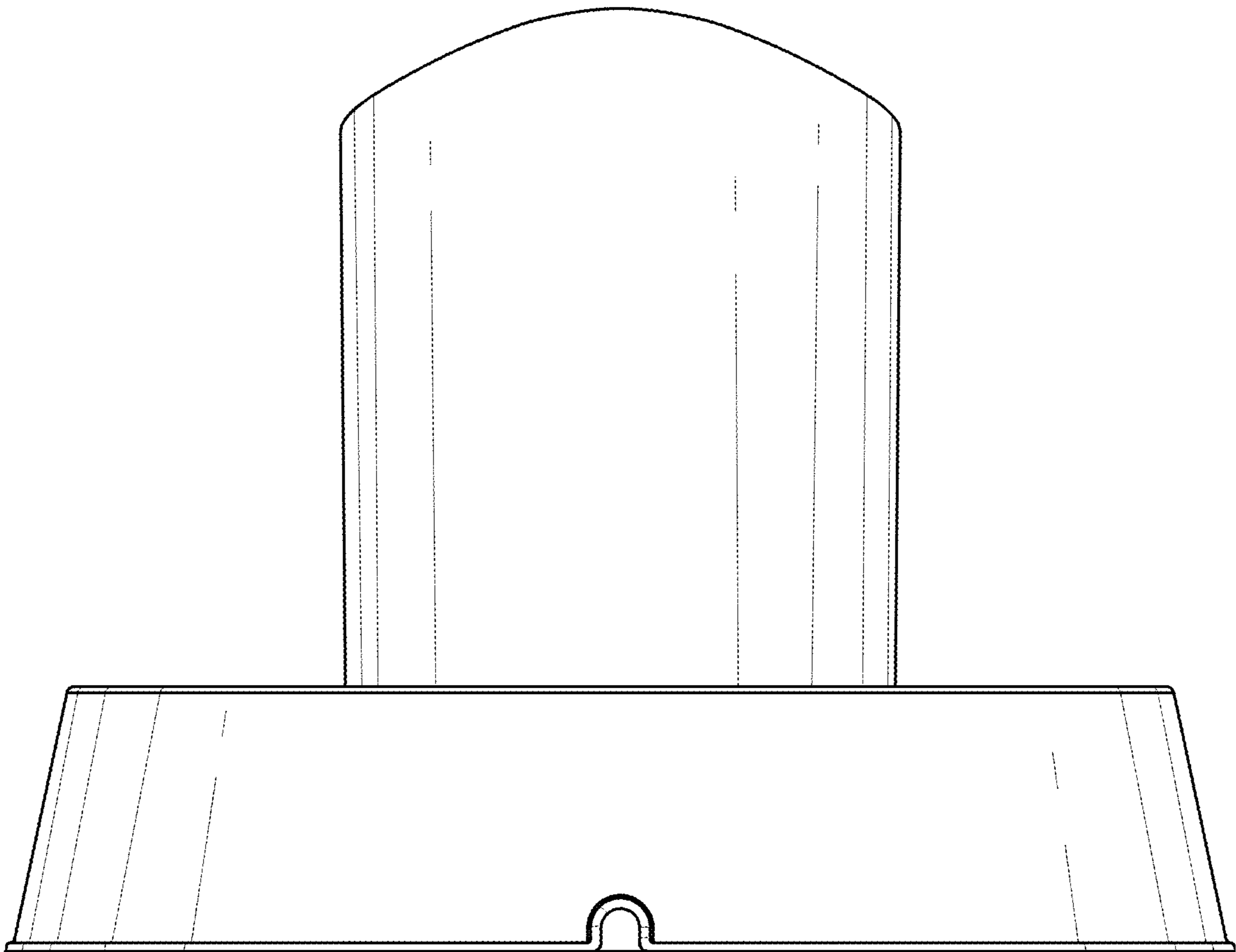

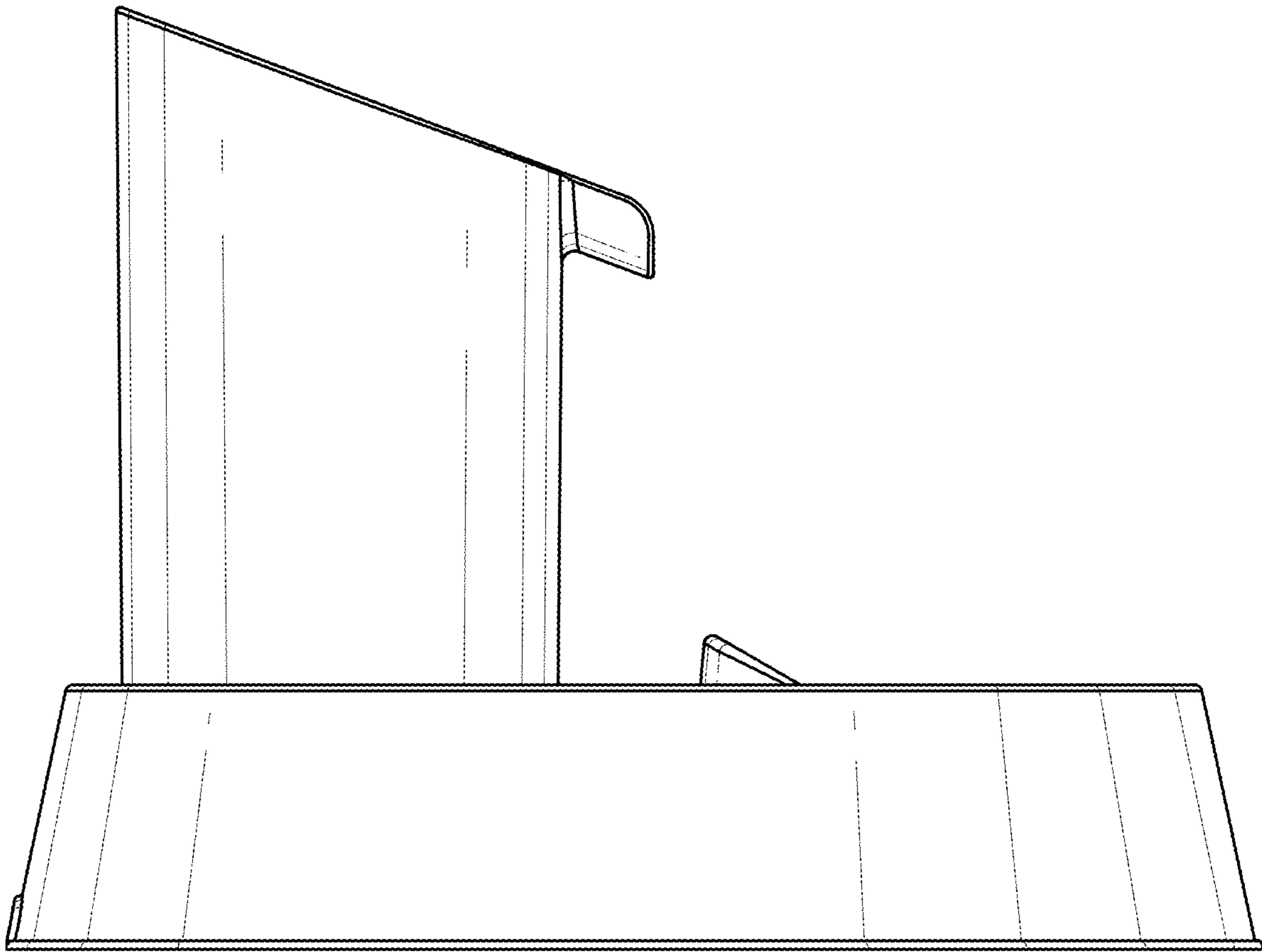

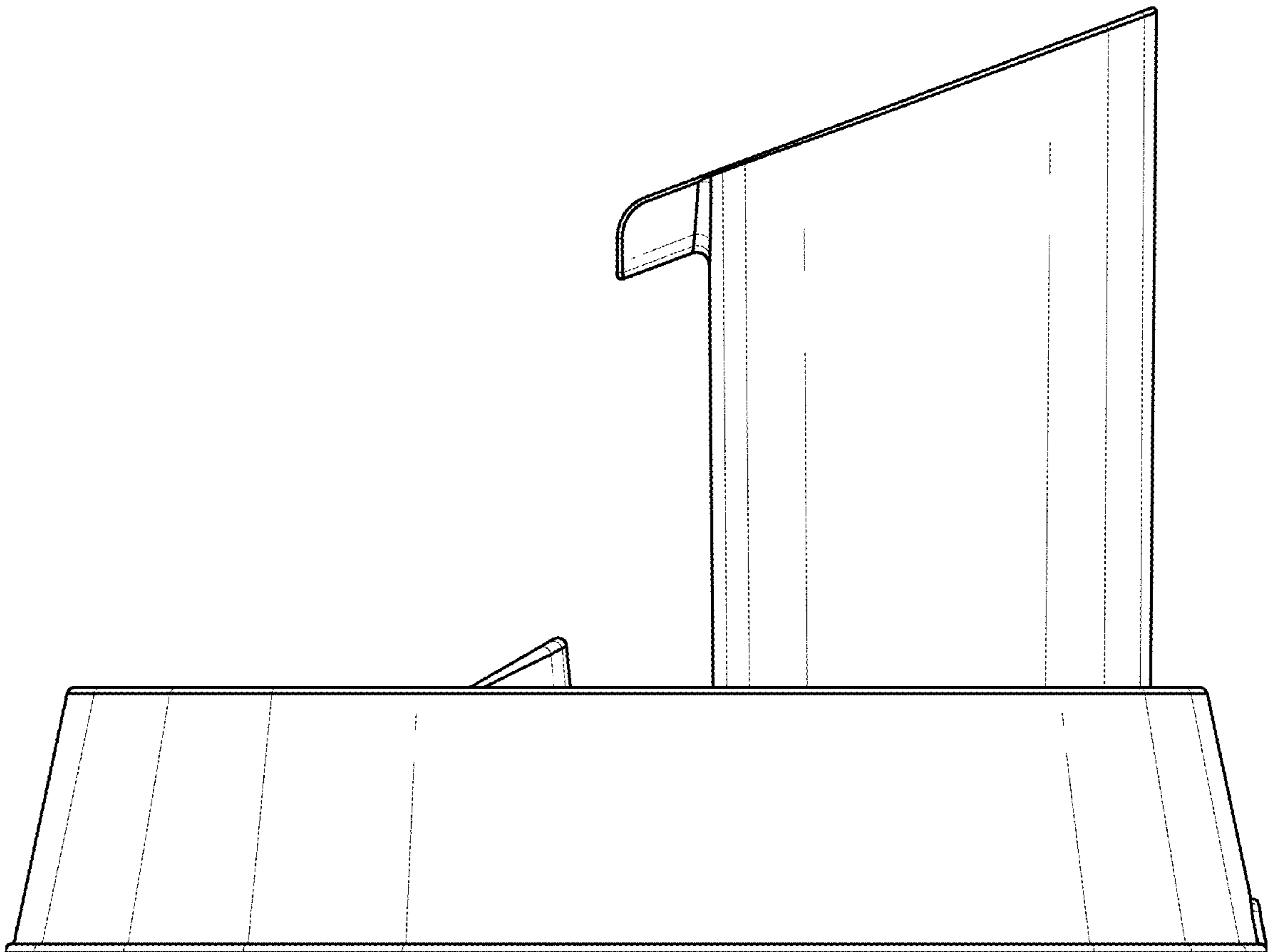

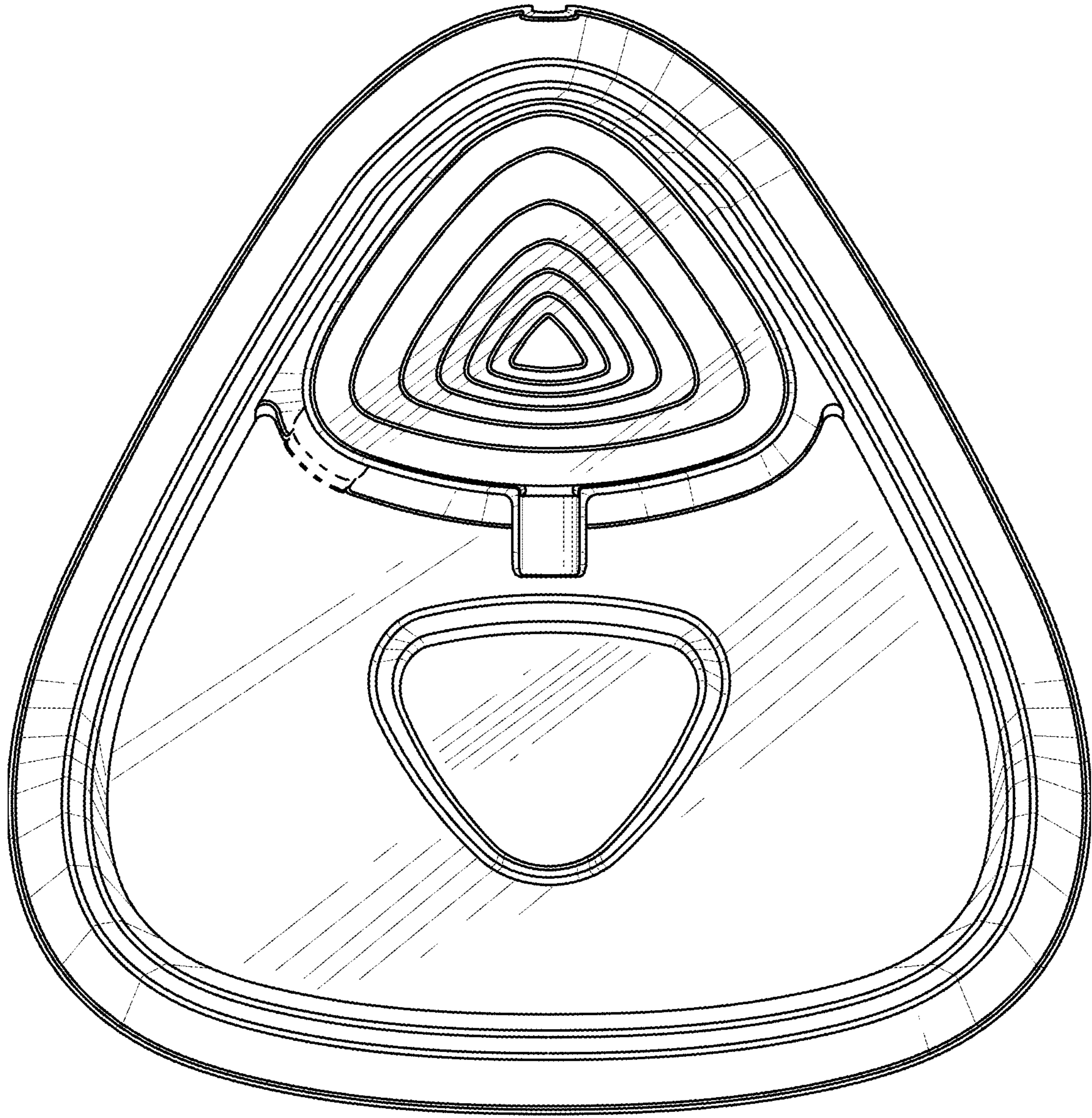

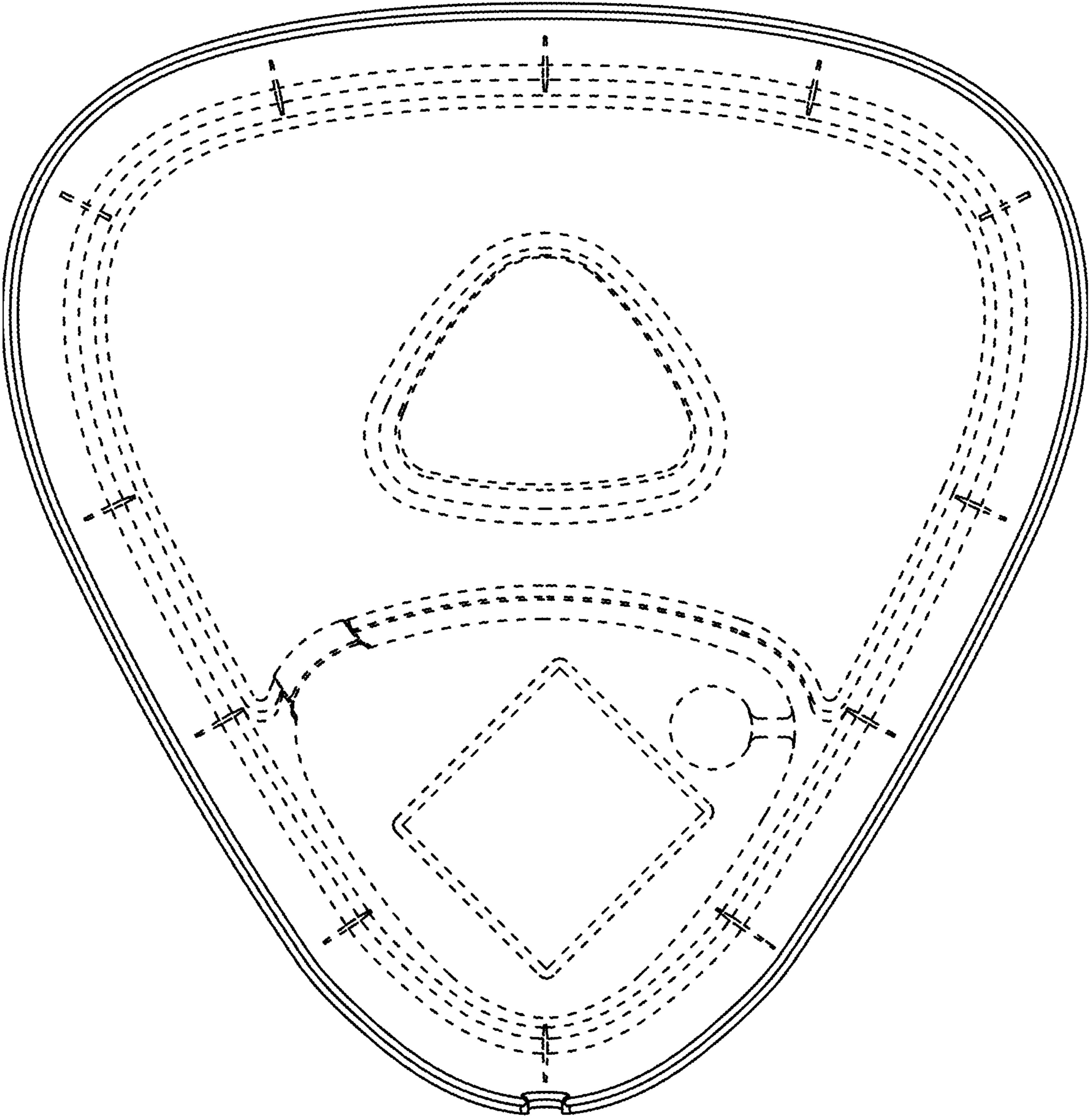

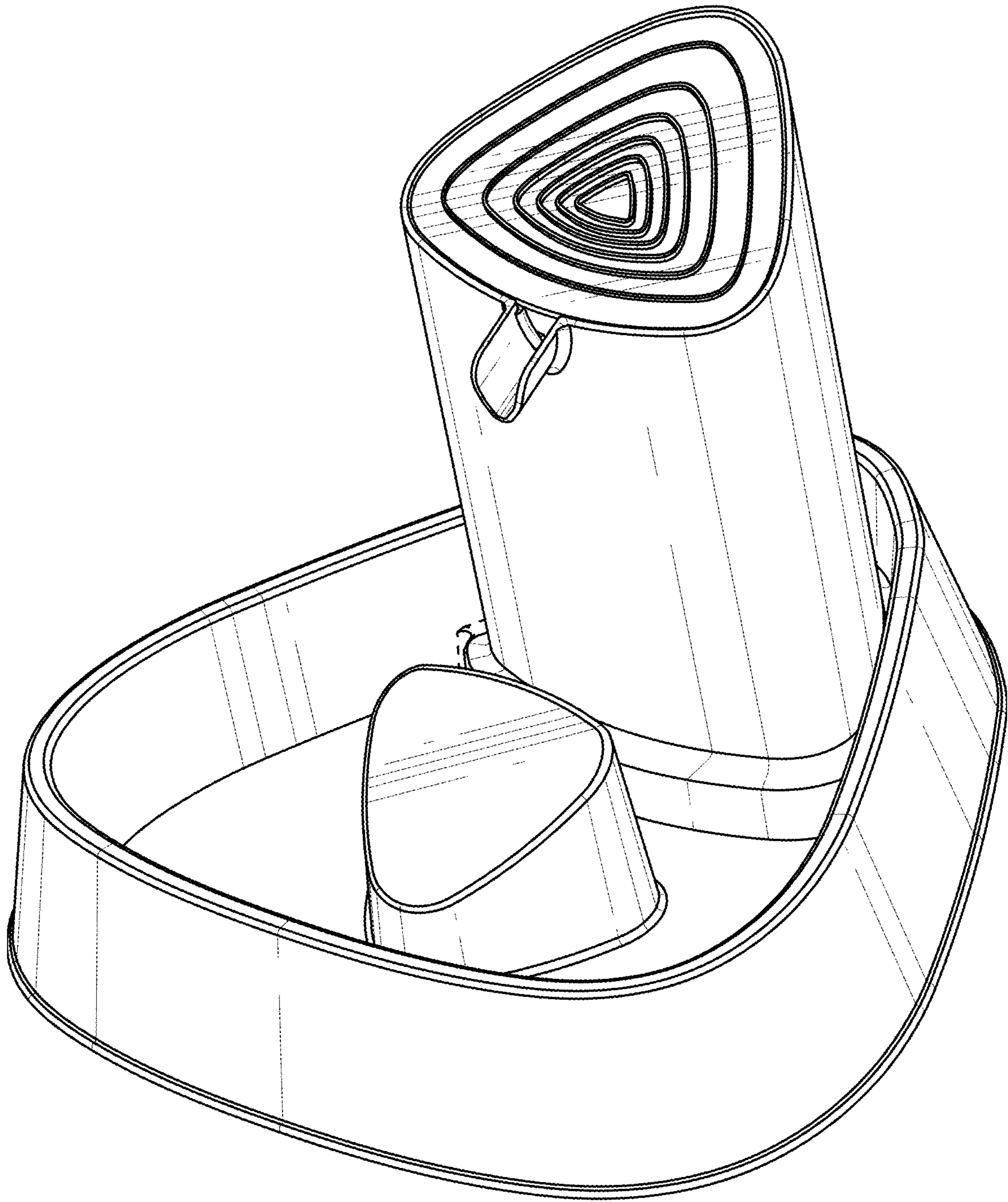
