DESCRIPTION

FIG. 1 is a top elevation view of a shoe upper, showing my new design;

FIG. 3 is a bottom view thereof;

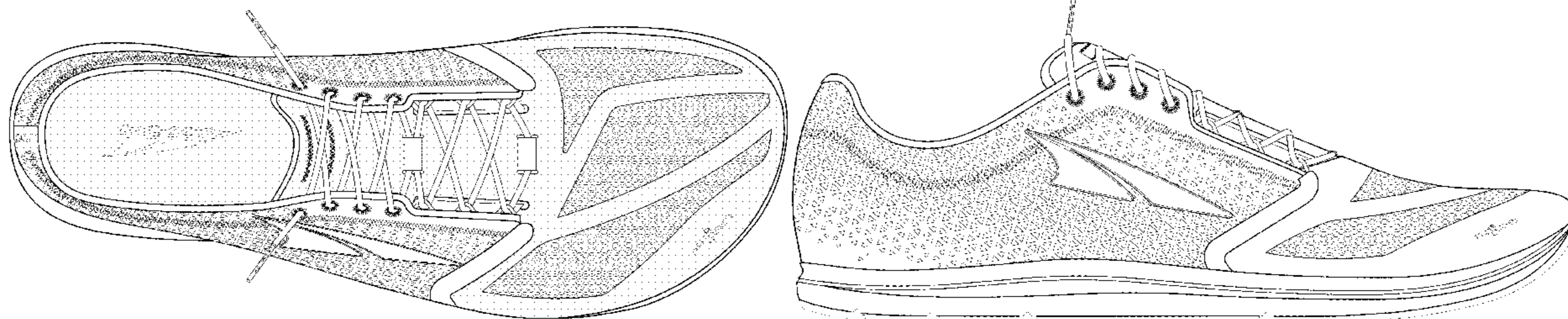
FIG. 4 is a left side view thereof;

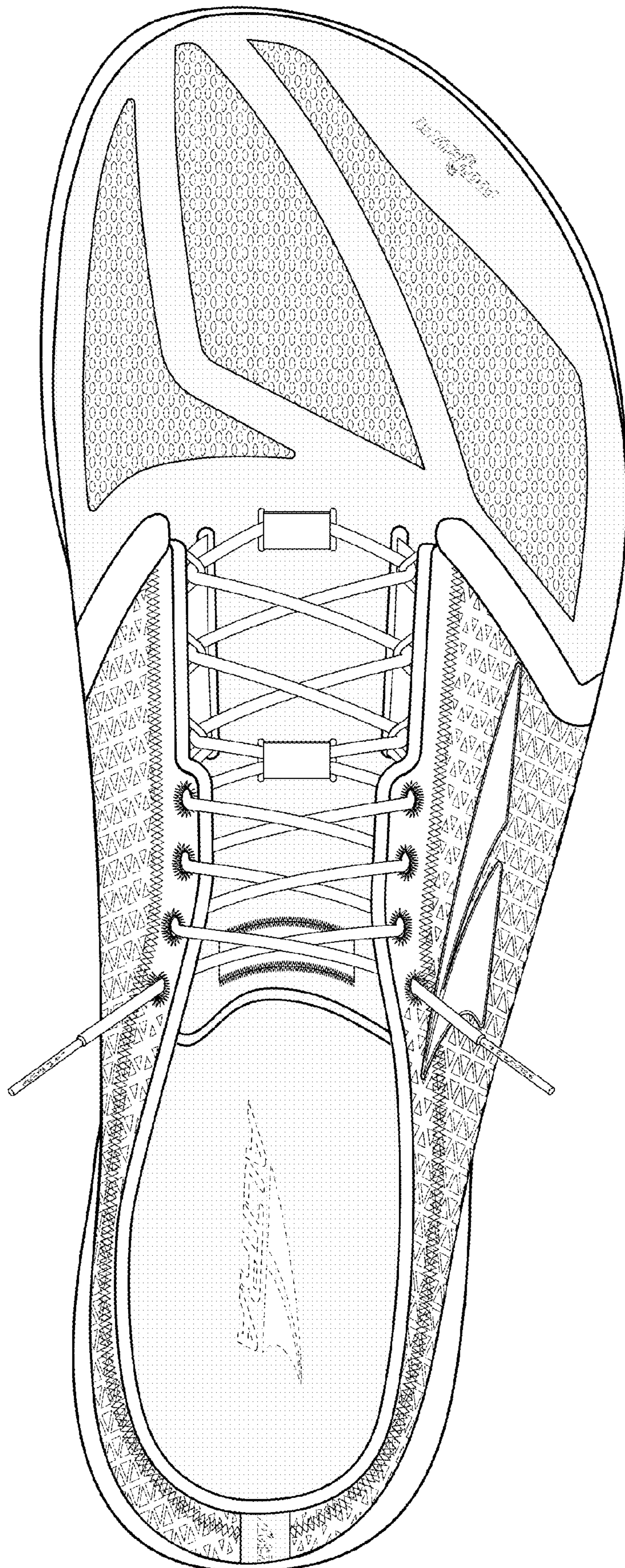

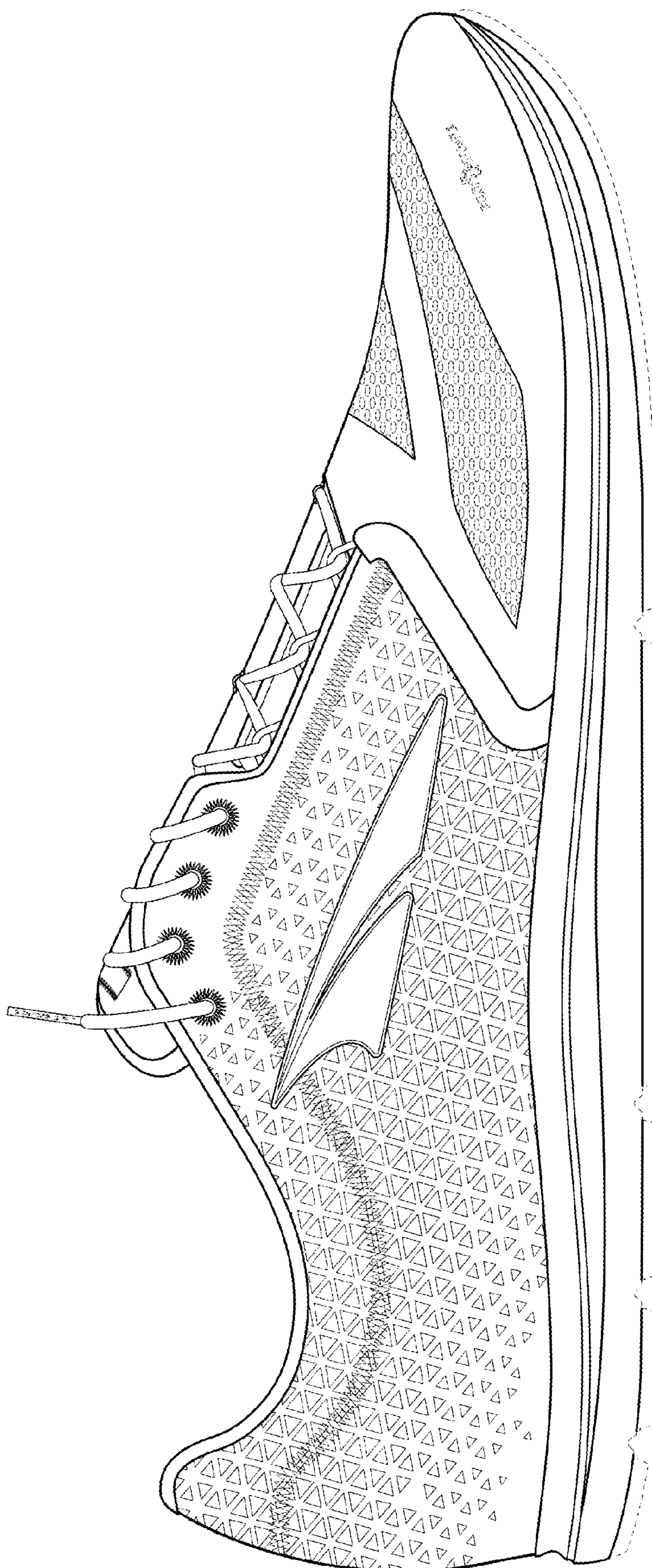

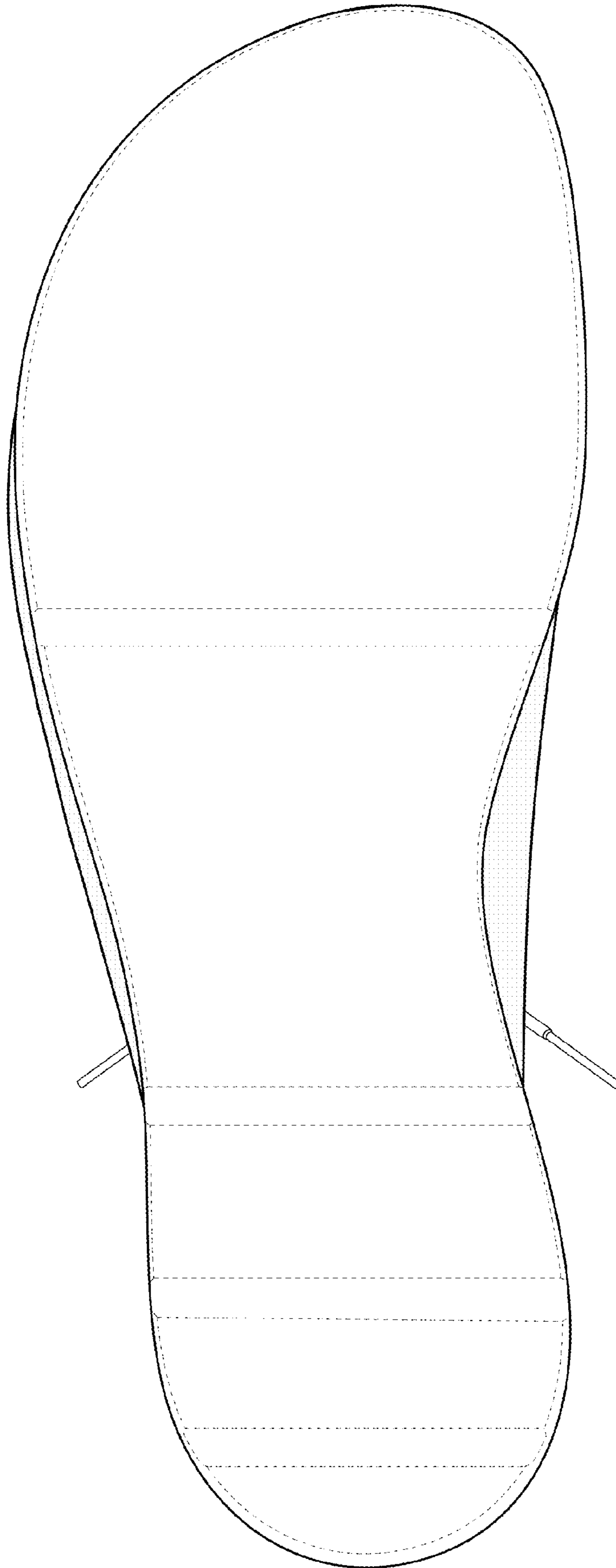

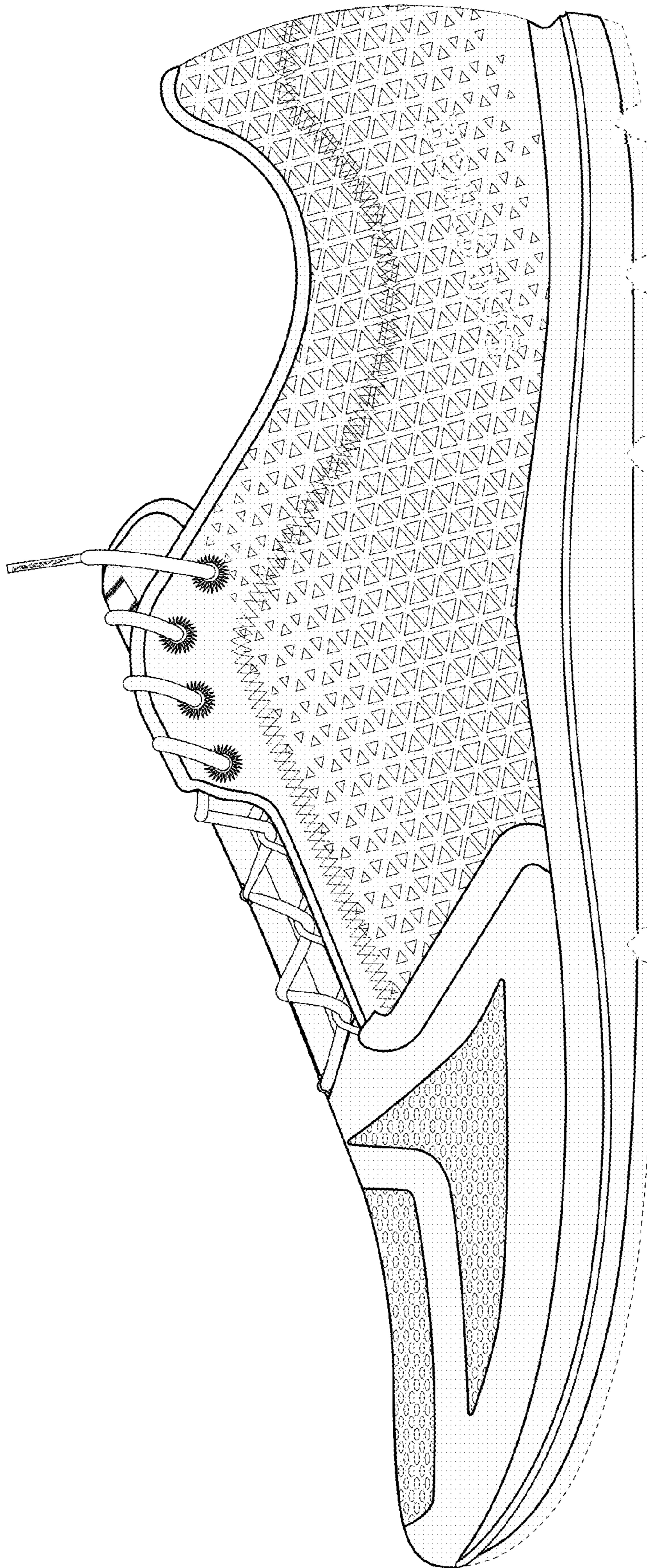

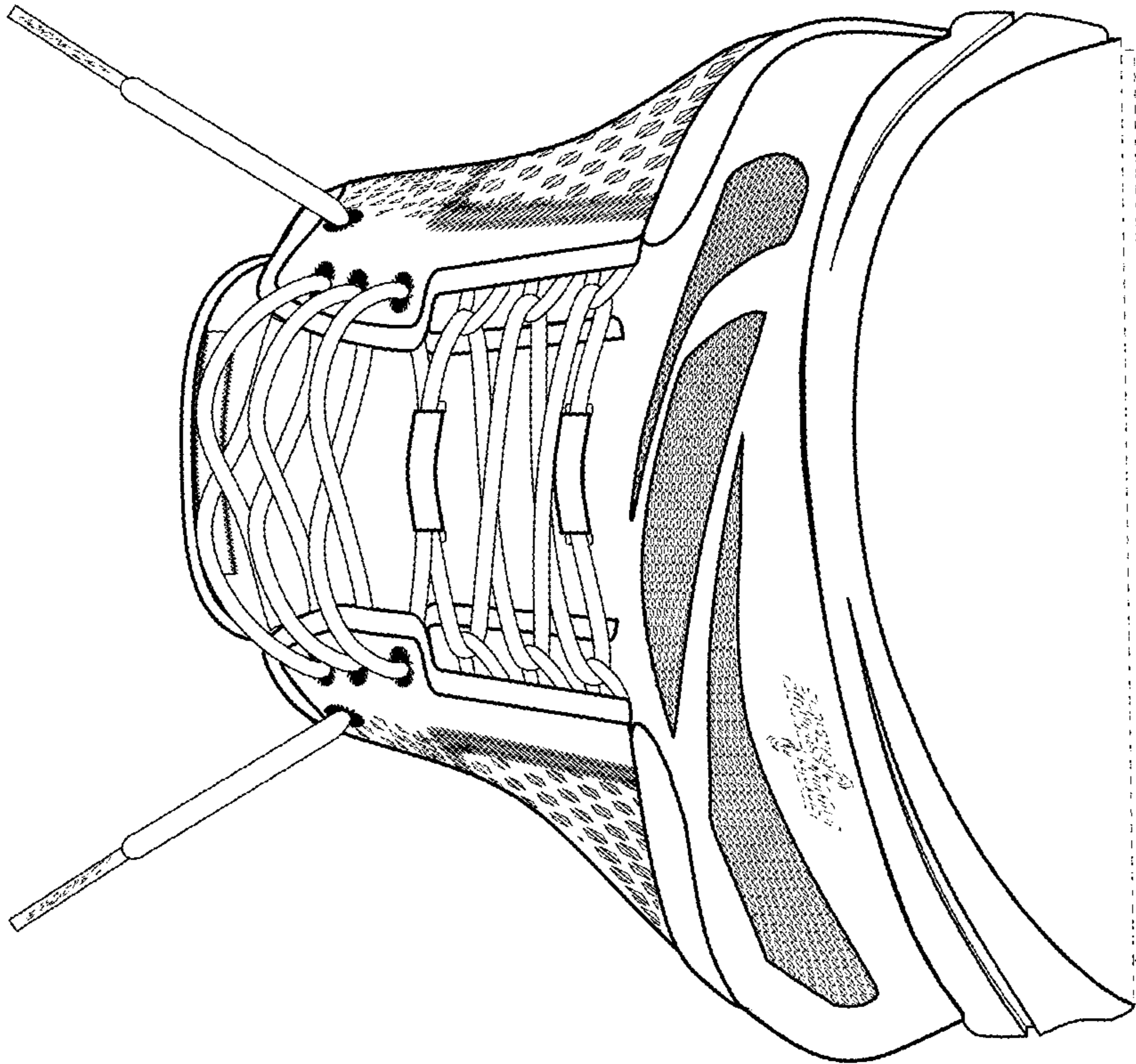

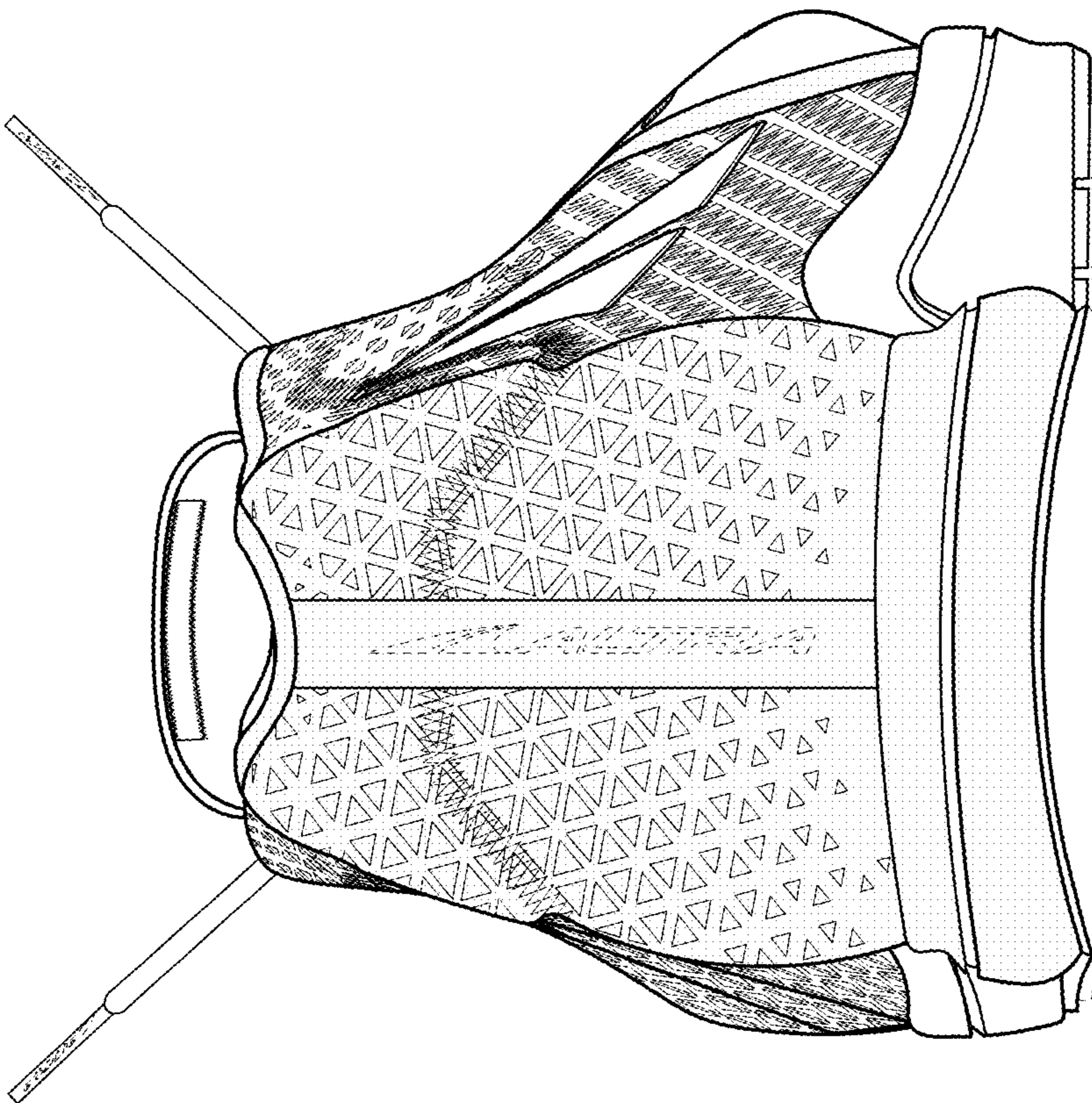
