The ornamental design for a footwear, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the footwear embodying the new design;

FIG. 2 is a right side view thereof;

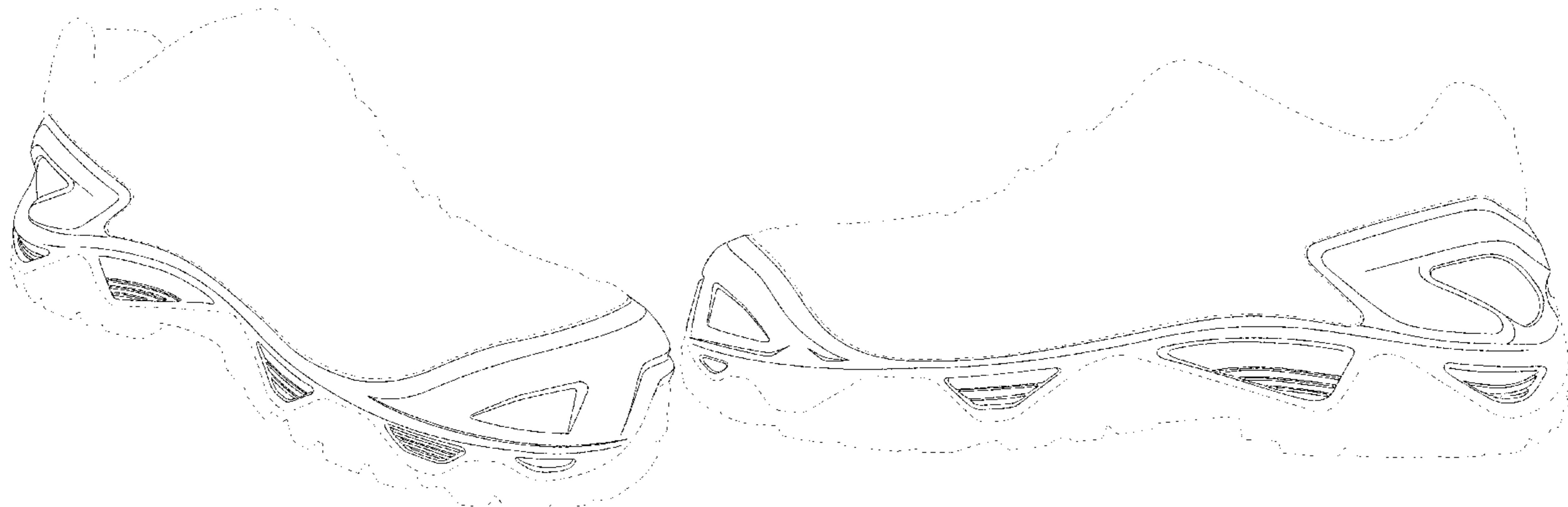
FIG. 3 is a left side view thereof;

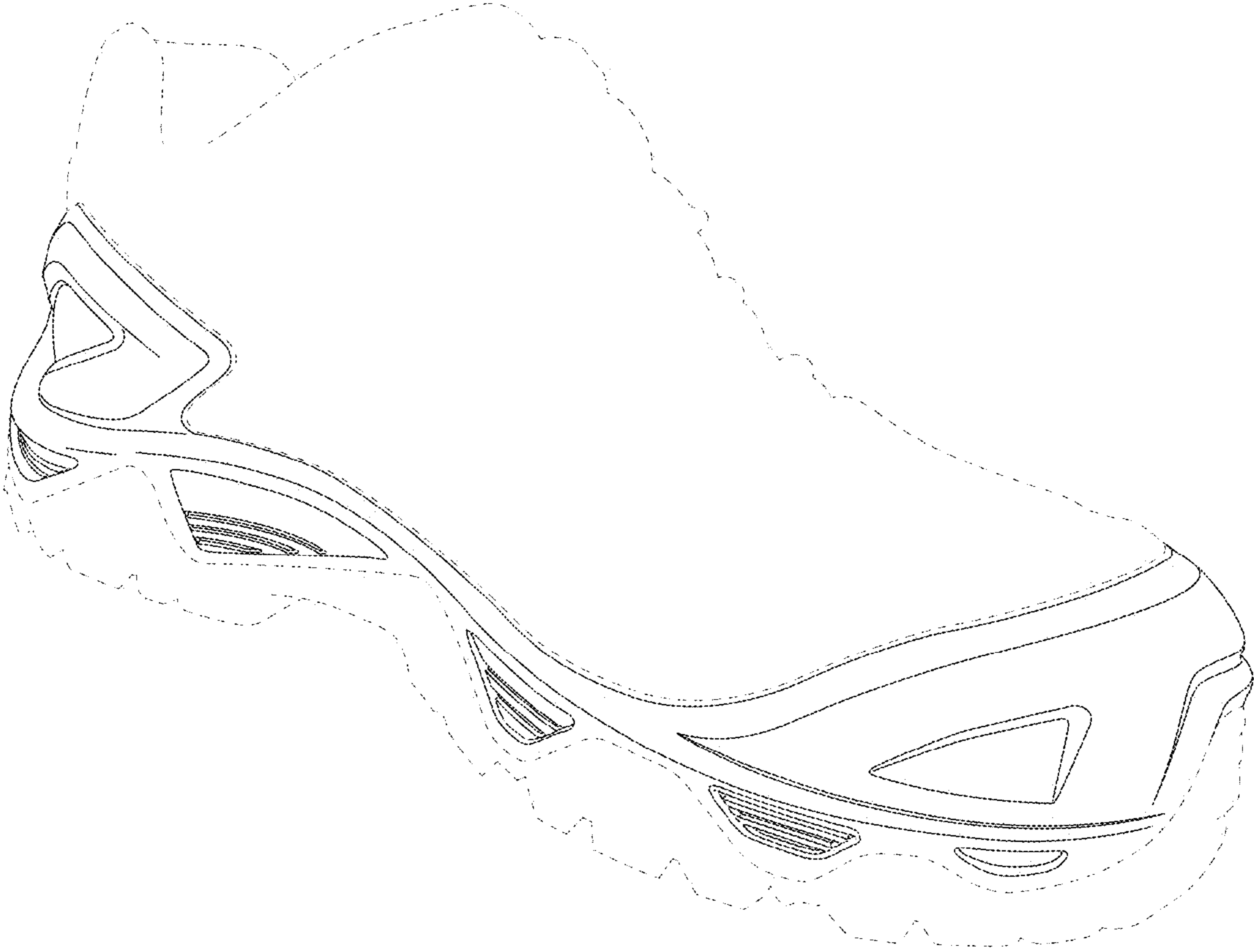

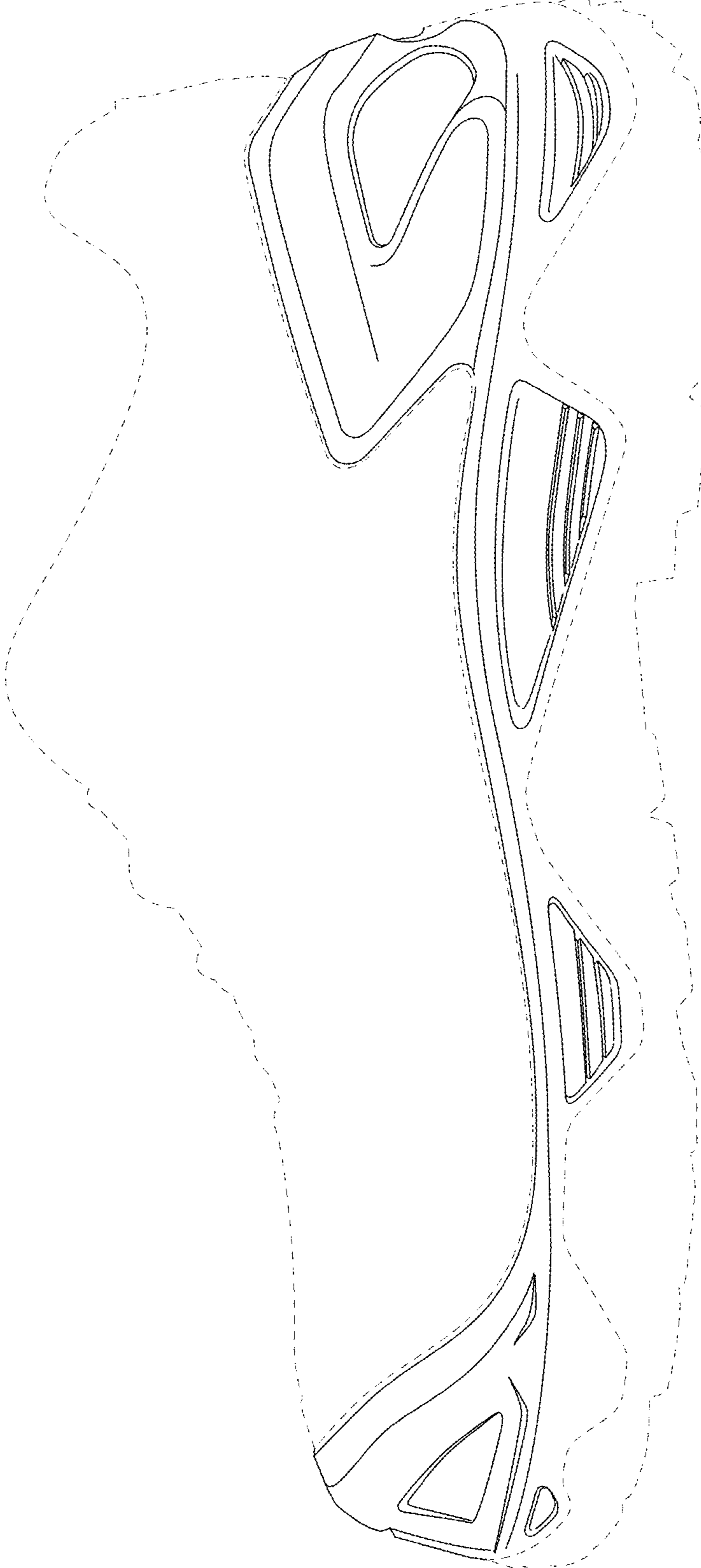

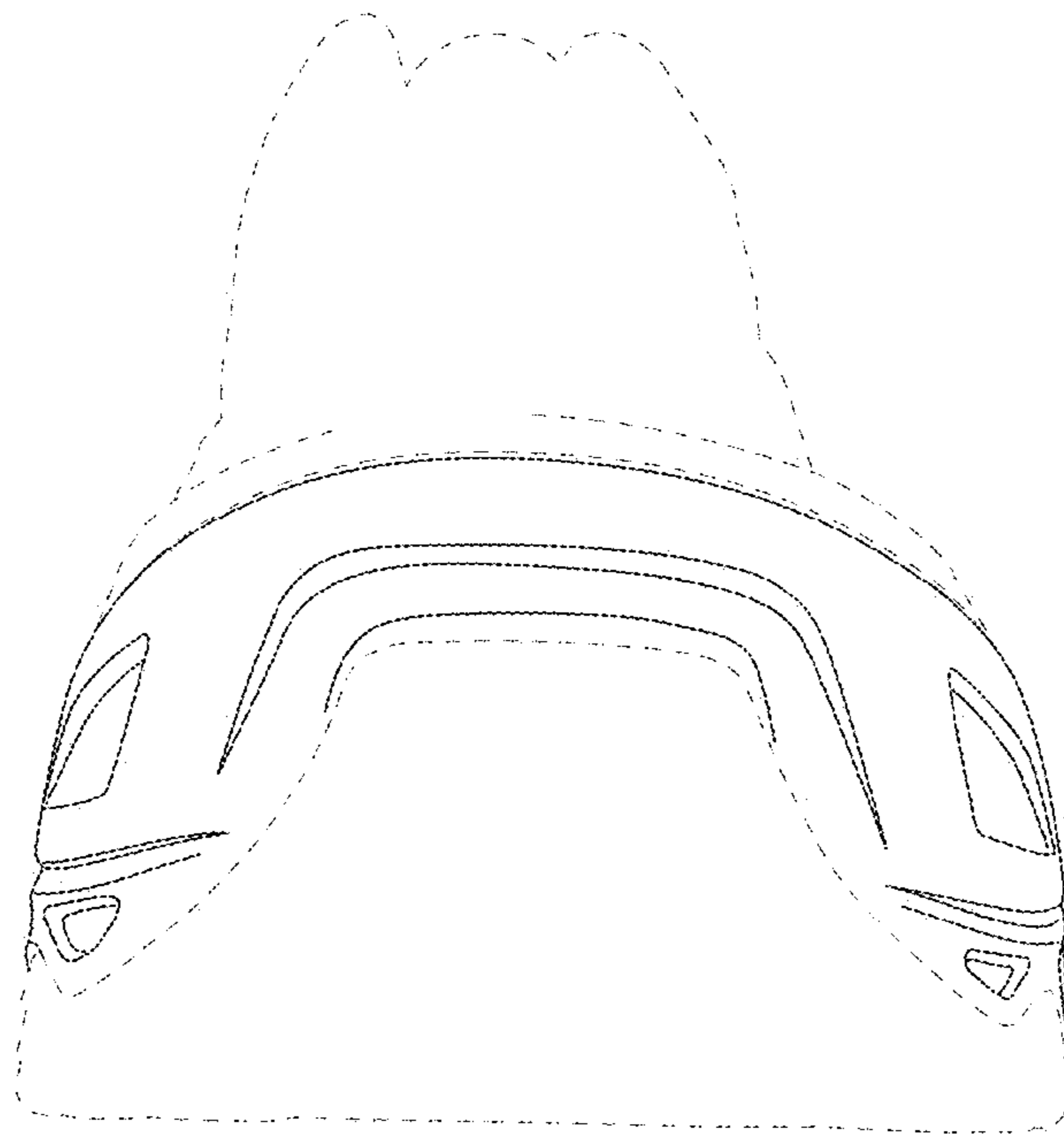

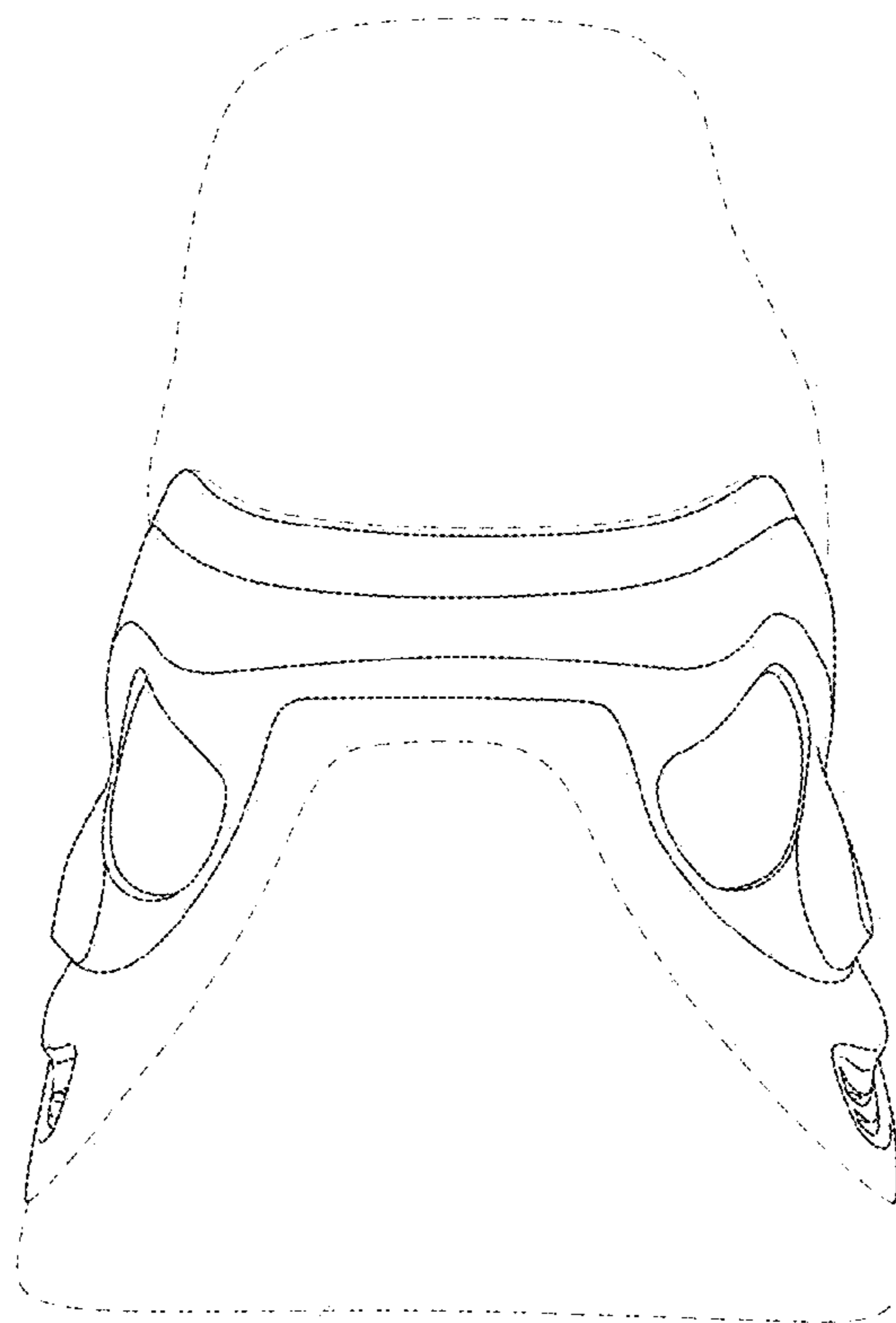
