The ornamental design for a golf bag top cuff, as shown and described.

**DESCRIPTION**

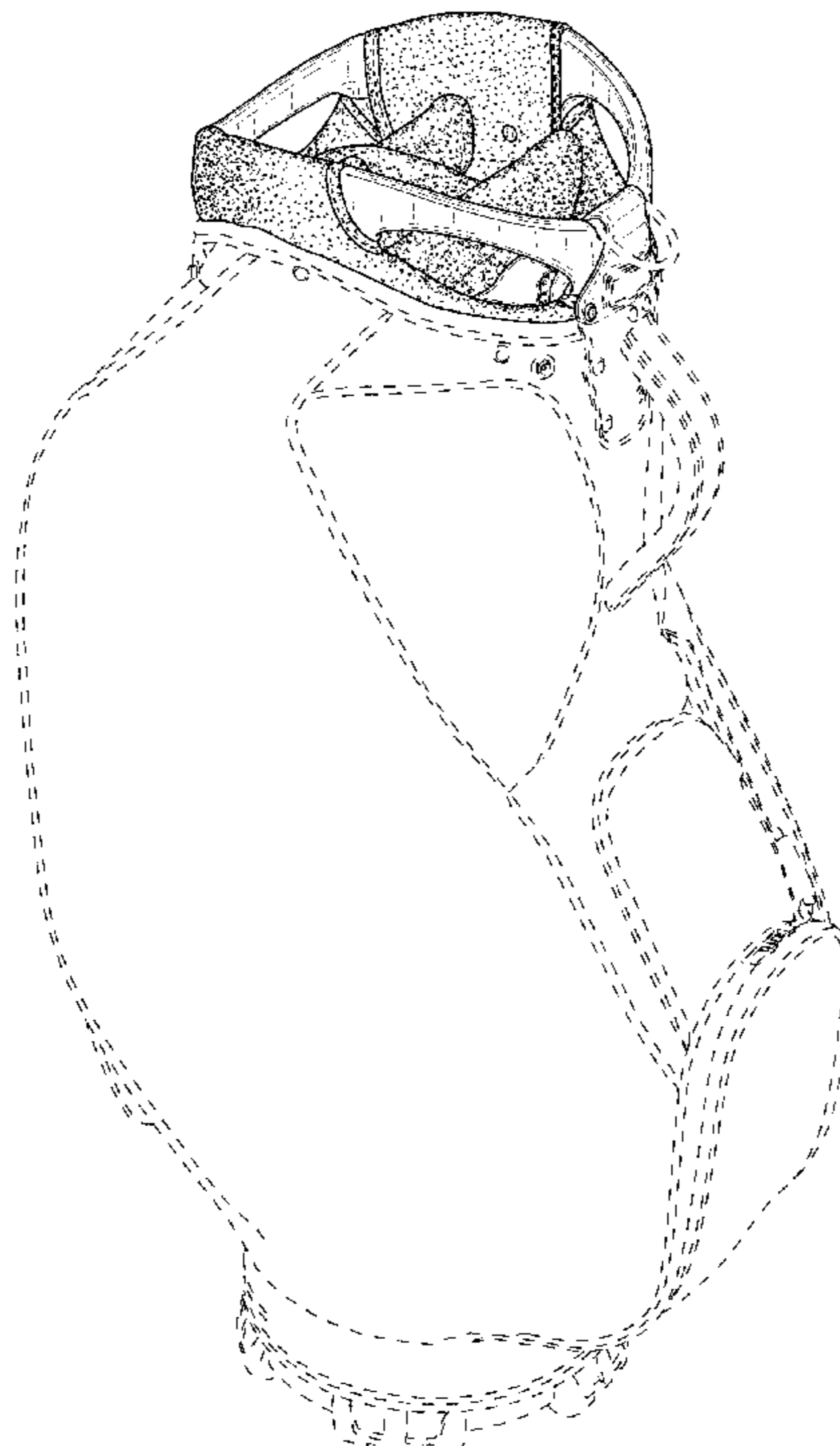
FIG. 1 is a perspective view of the golf bag top cuff of this invention;  
 FIG. 2 is a rear view of the golf bag top cuff of this invention;  
 FIG. 3 is a top plan view of the golf bag top cuff of this invention;  
 FIG. 4 is a front view of the golf bag top cuff of this invention;  
 FIG. 5 is a first side view of the golf bag top cuff of this invention; and,  
 FIG. 6 is a second side view of the golf bag top cuff of this invention.  
 In FIGS. 1-6, the broken lines depict unclaimed portions of the golf bag. The darker broken lines visible on the surface of the top cuff of the golf bag in FIGS. 1-6 represent claimed stitching. The dot-dashed boundary line visible in FIGS. 1 and 3 represents the bounds of the claim. None of the broken lines disclosed are part of the claimed design.

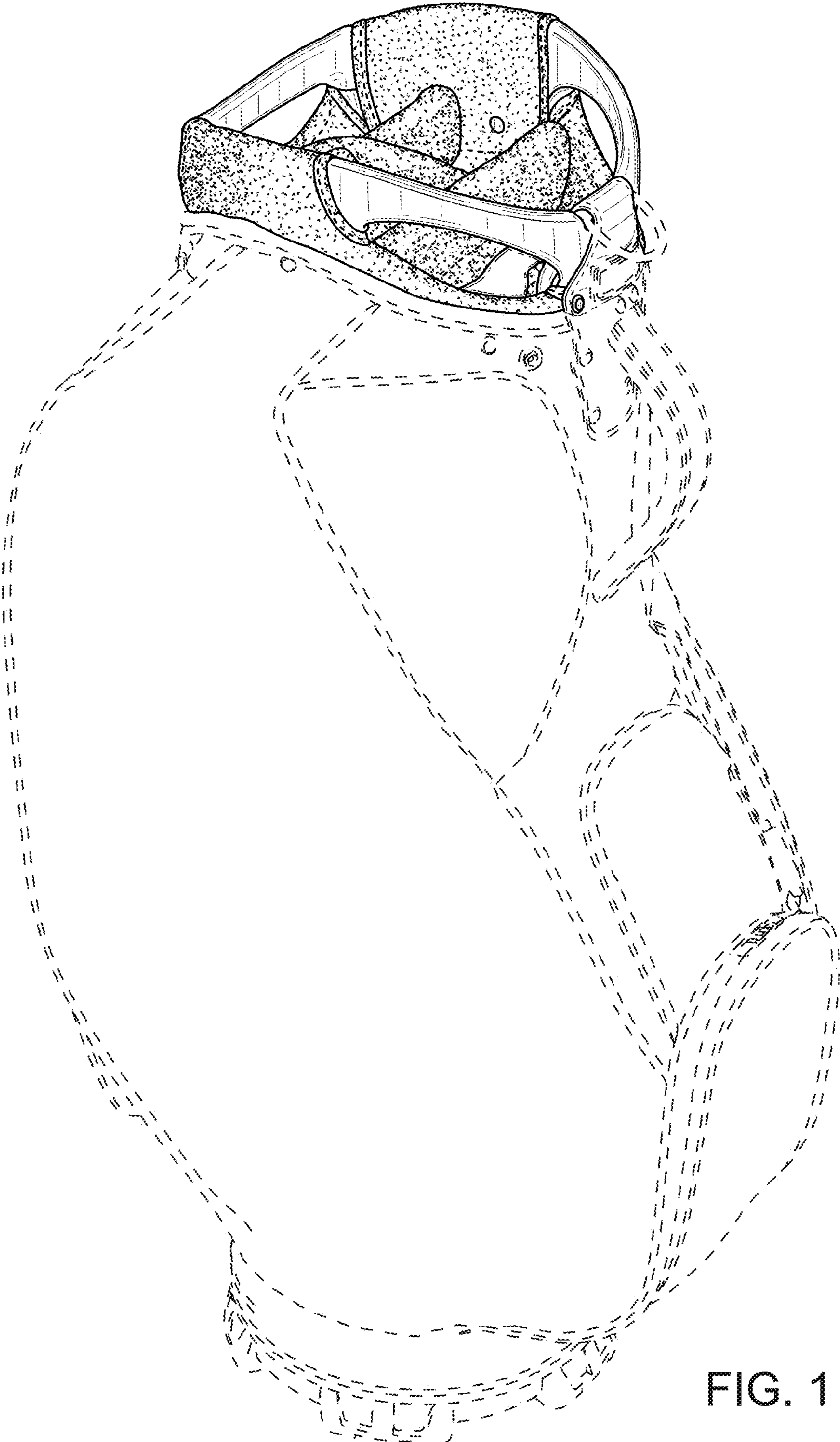

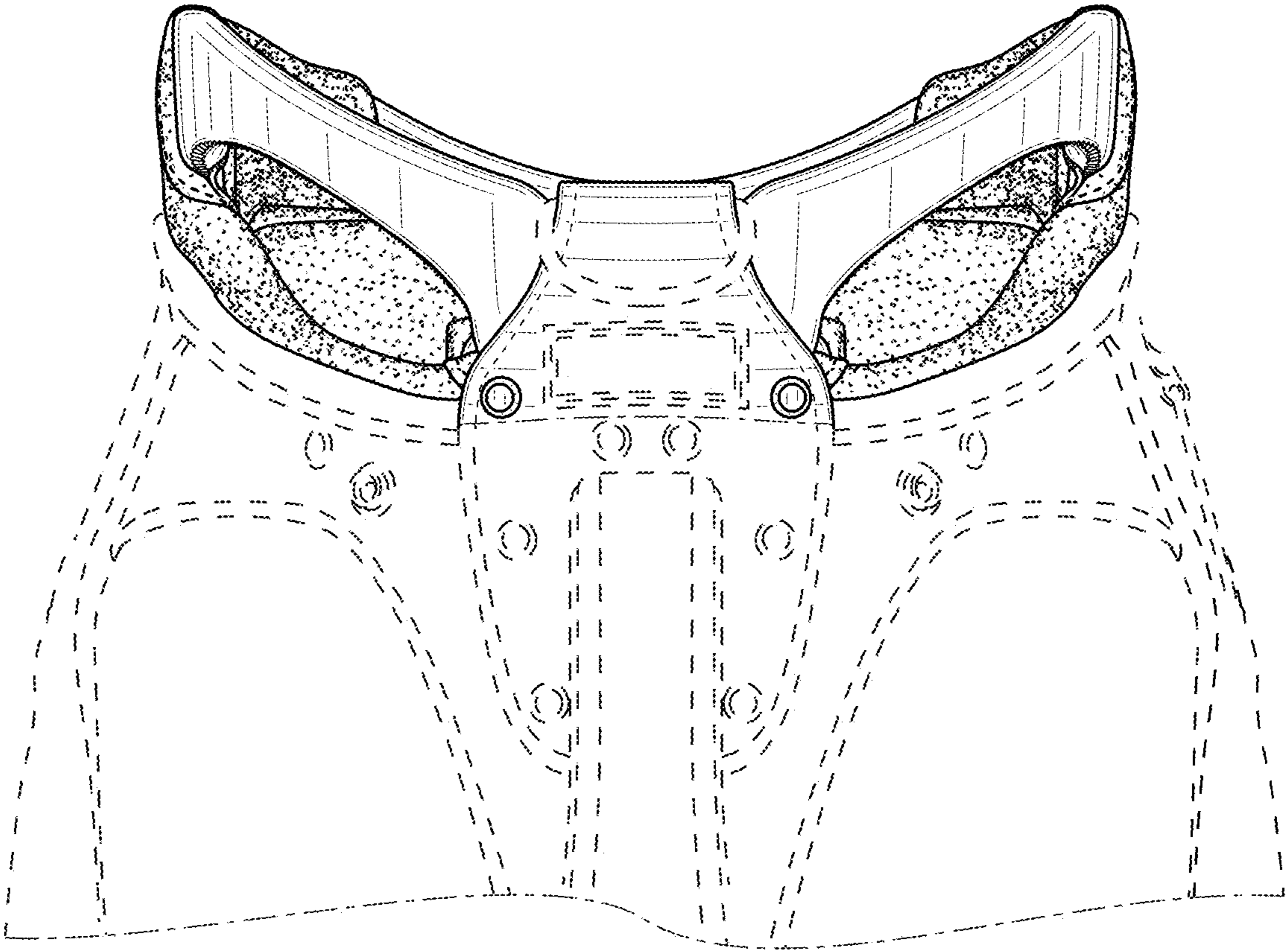

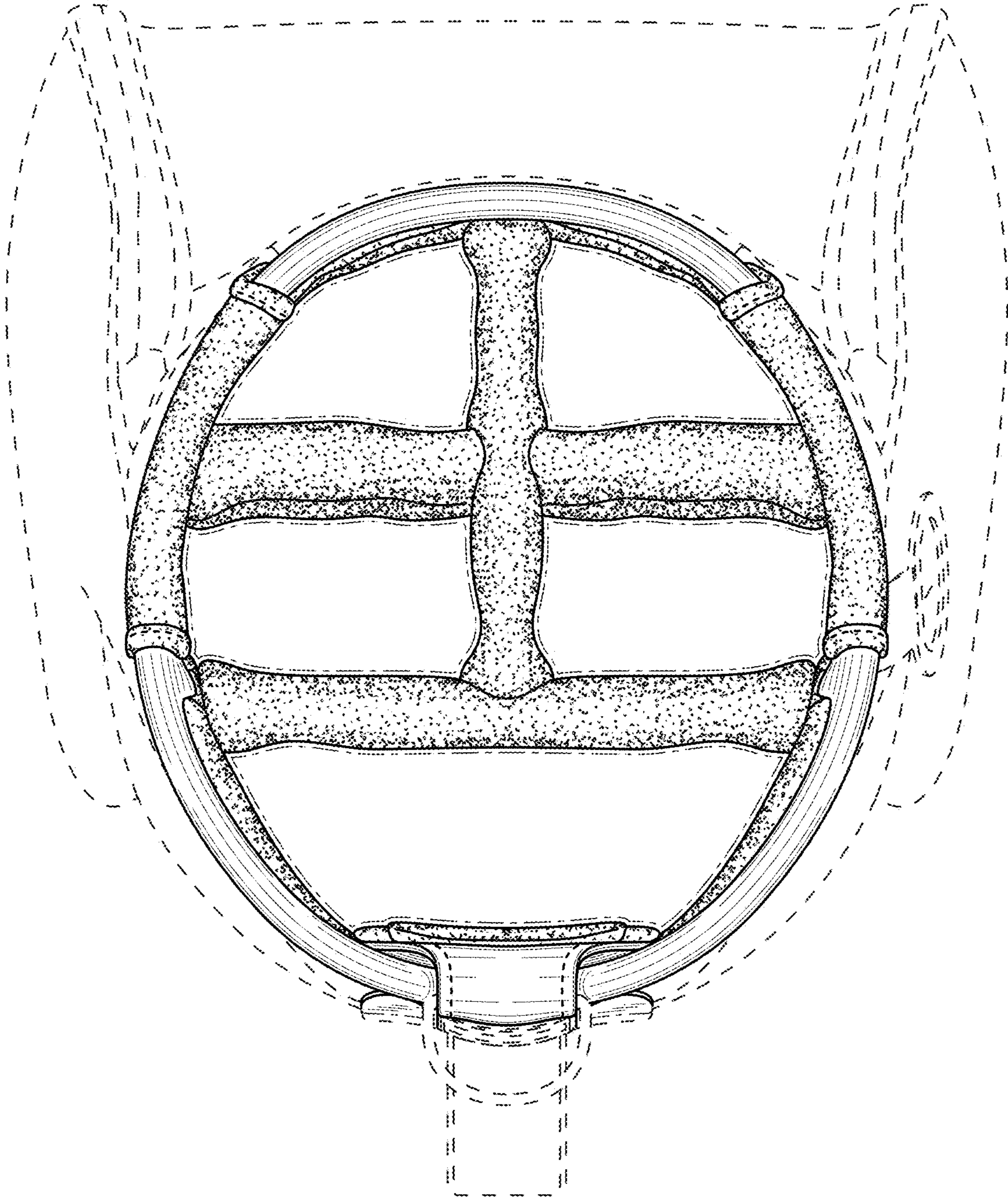

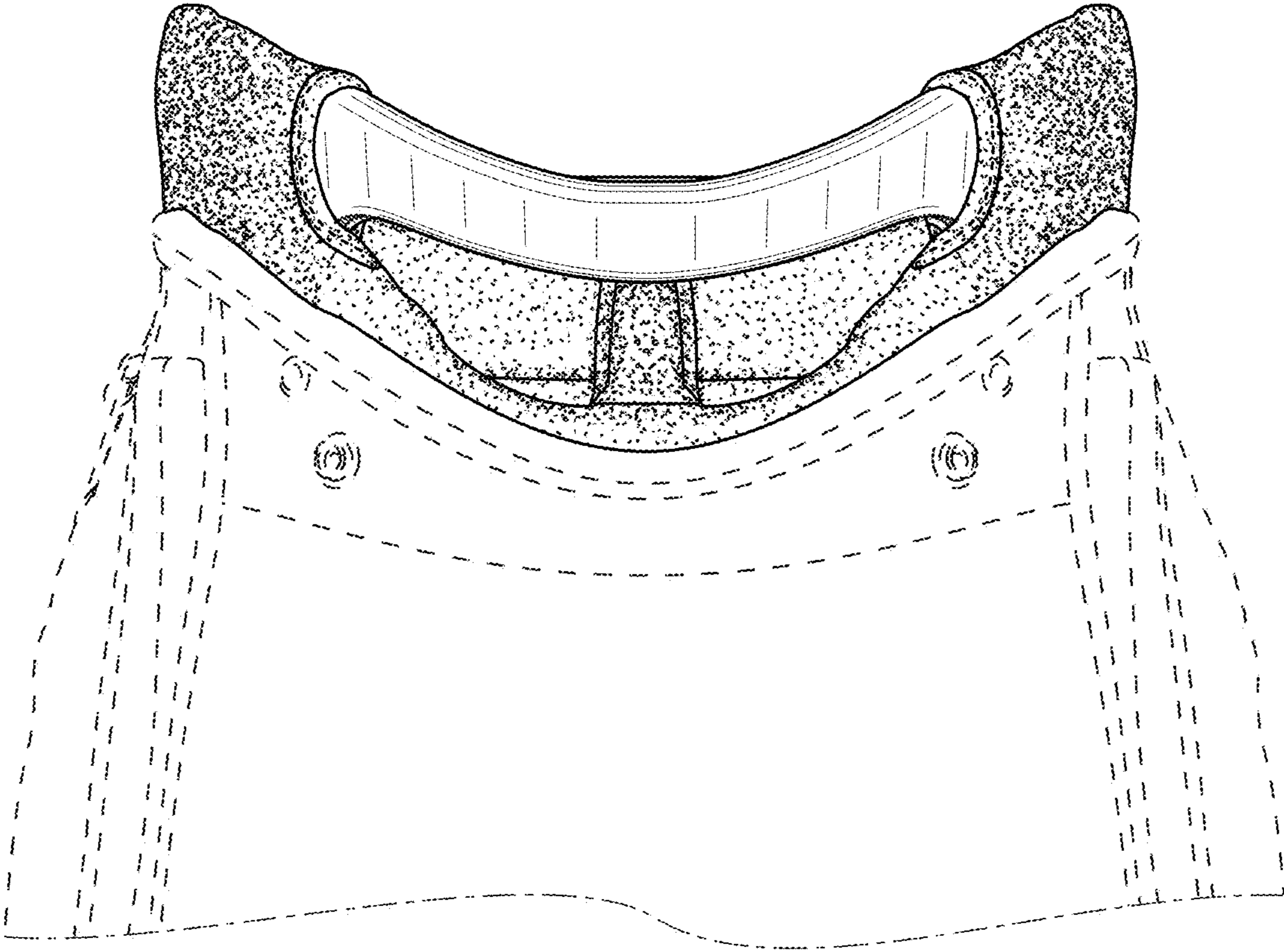

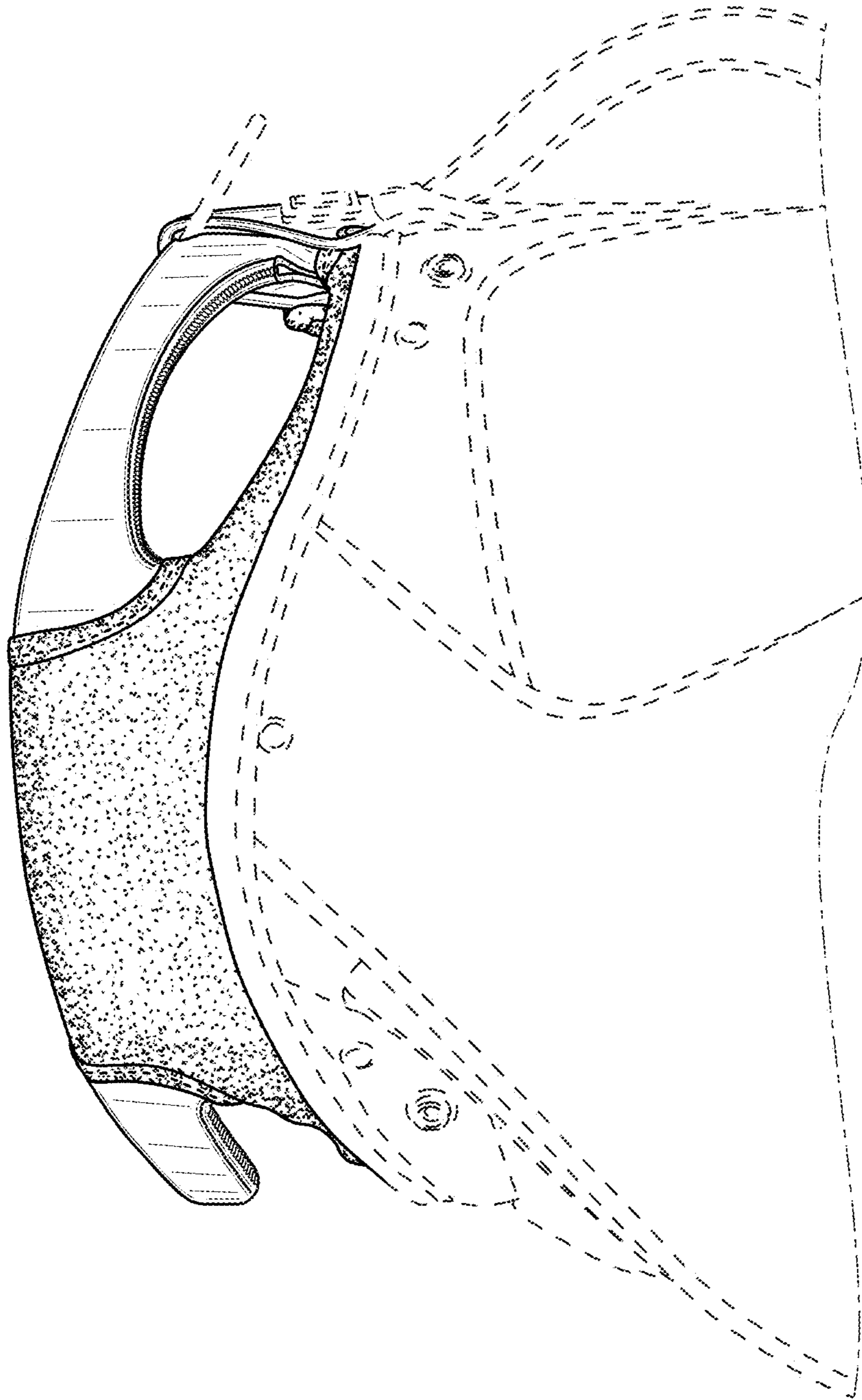

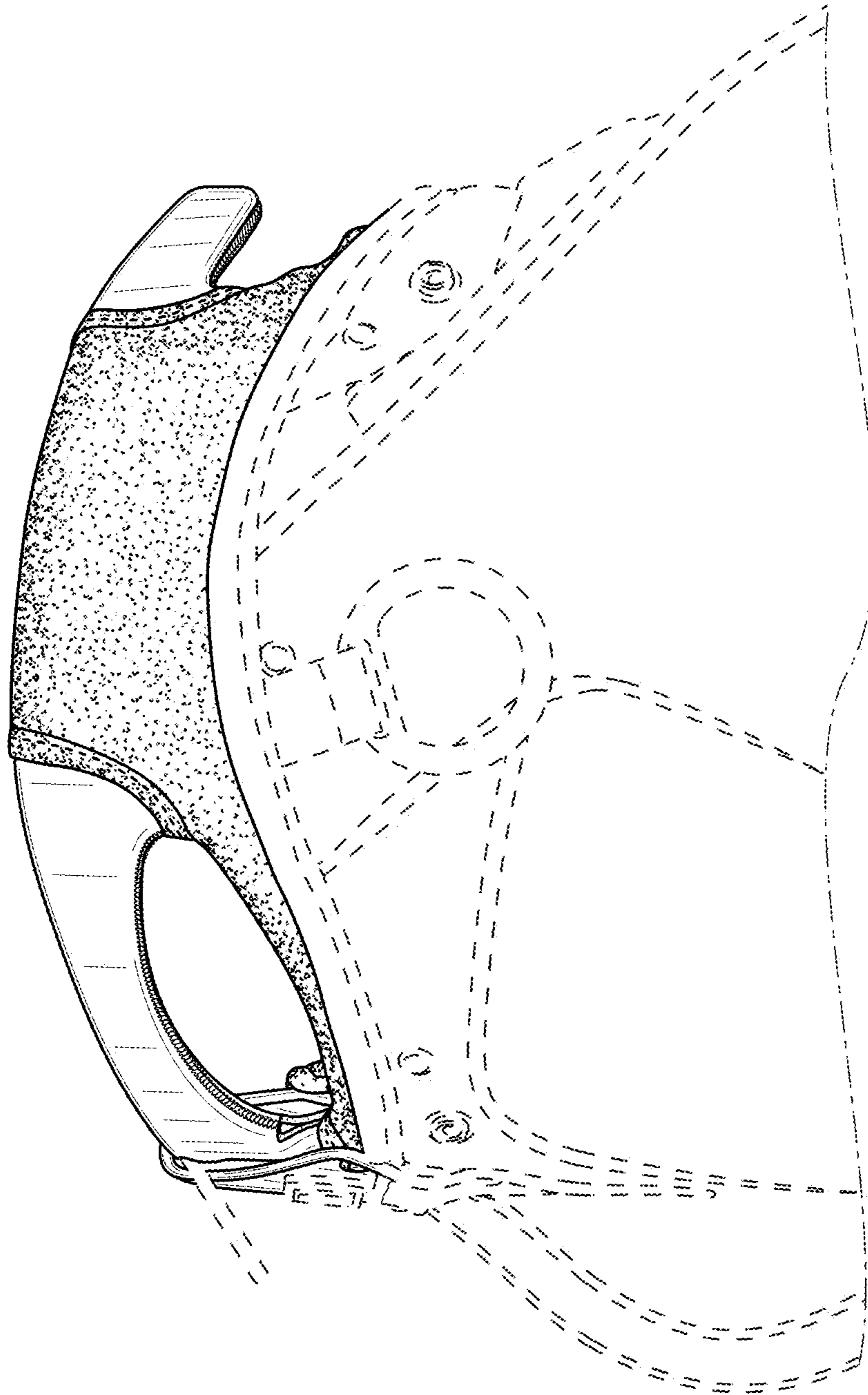
