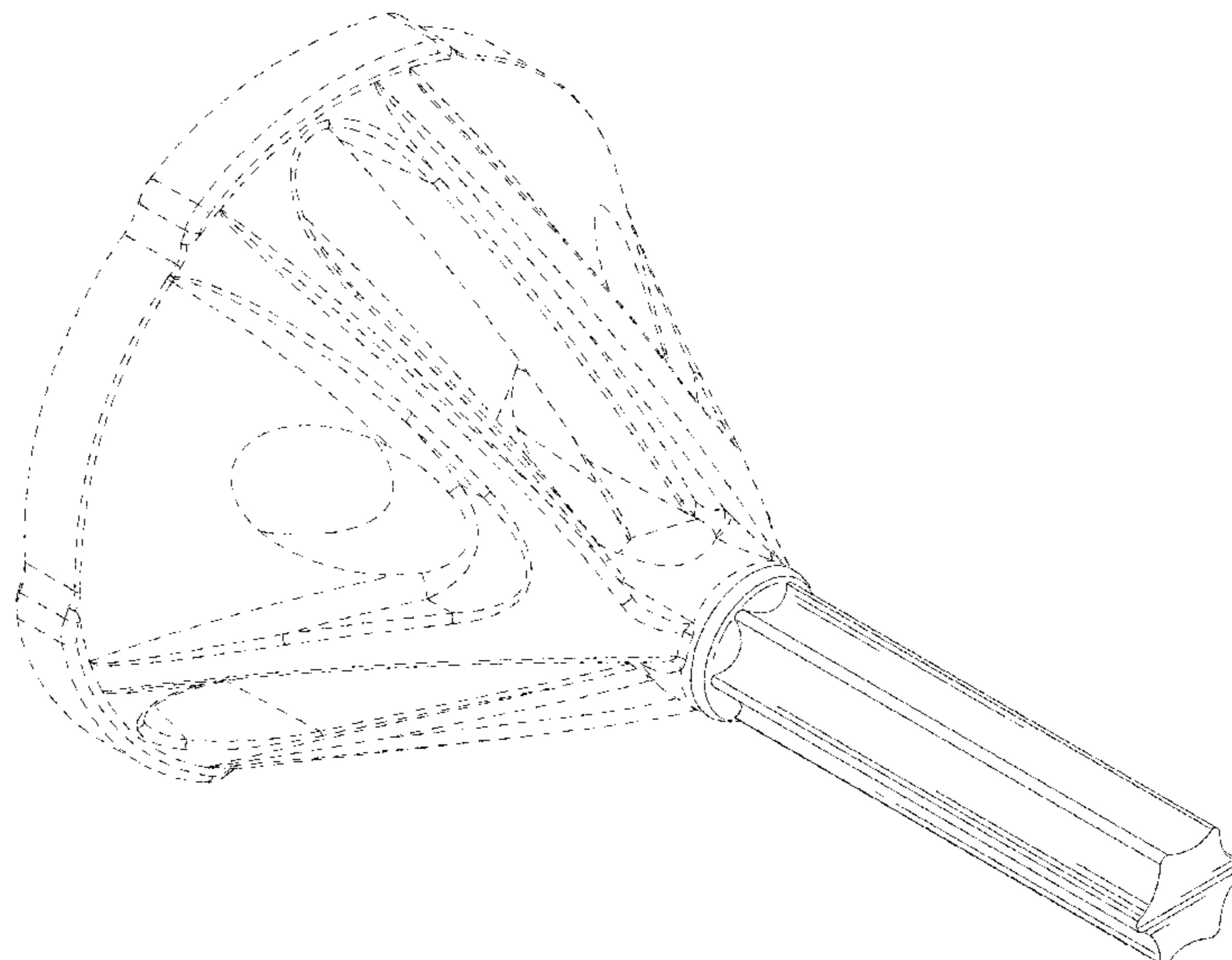
The ornamental design for a cutting tool, as shown and described.

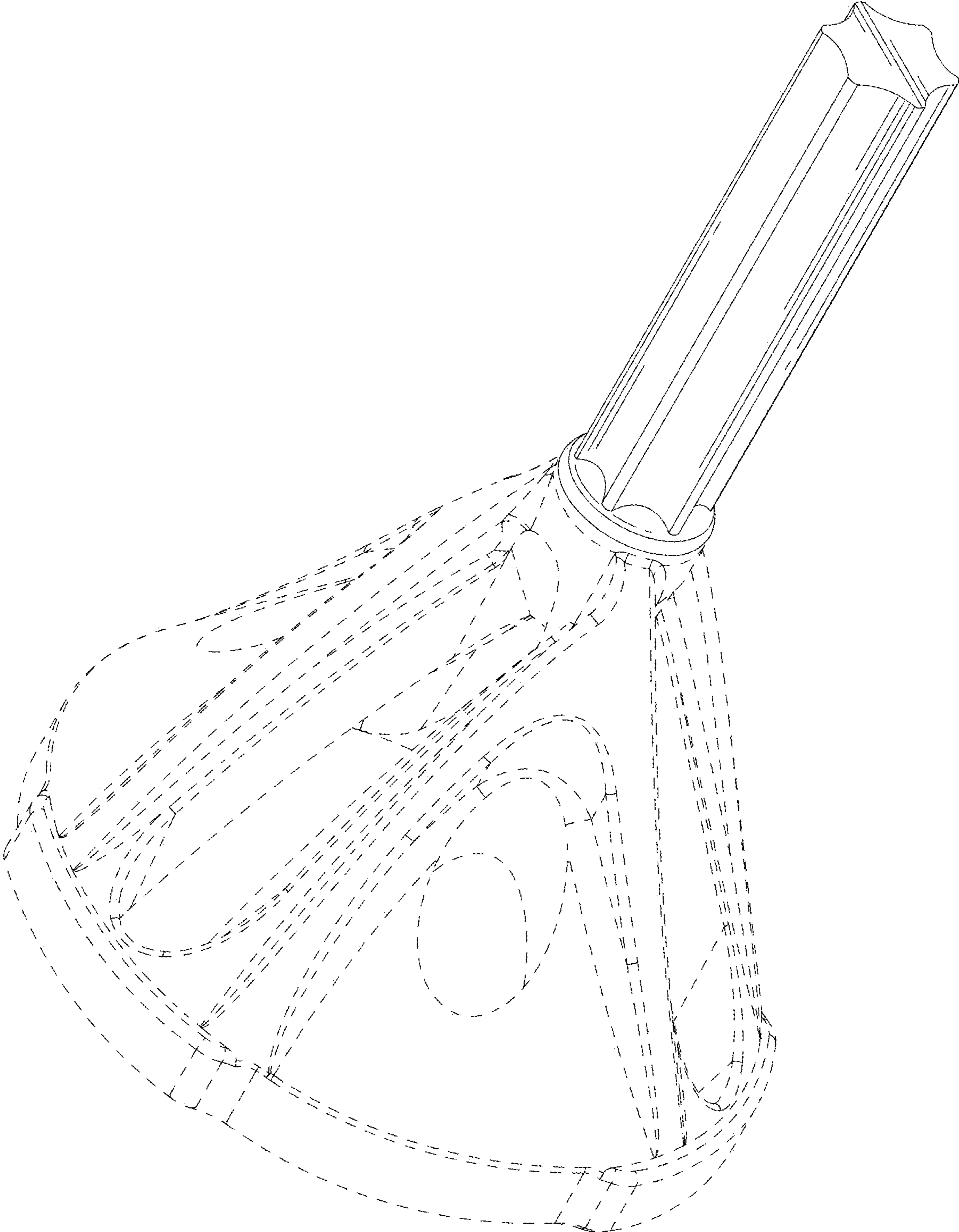

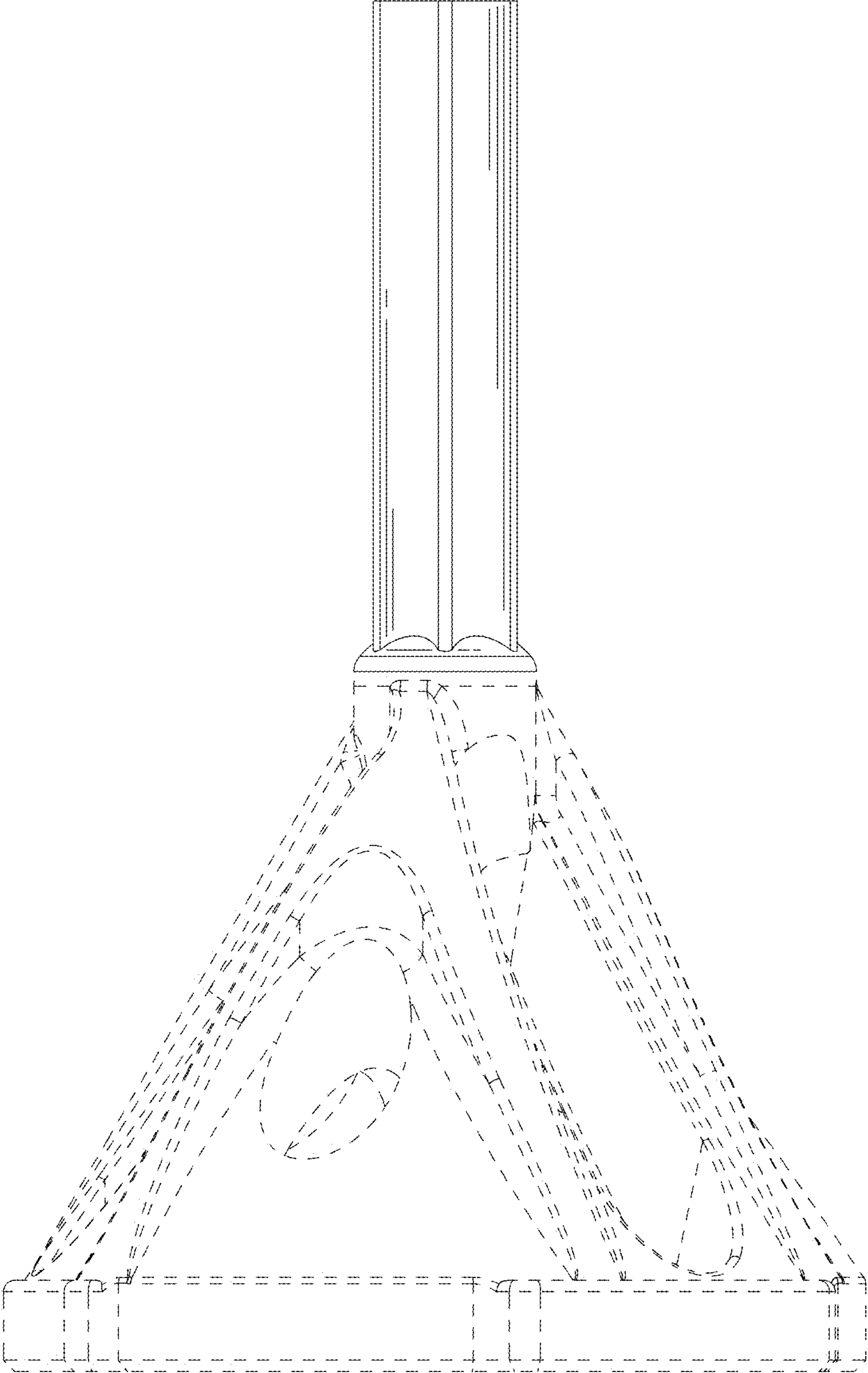

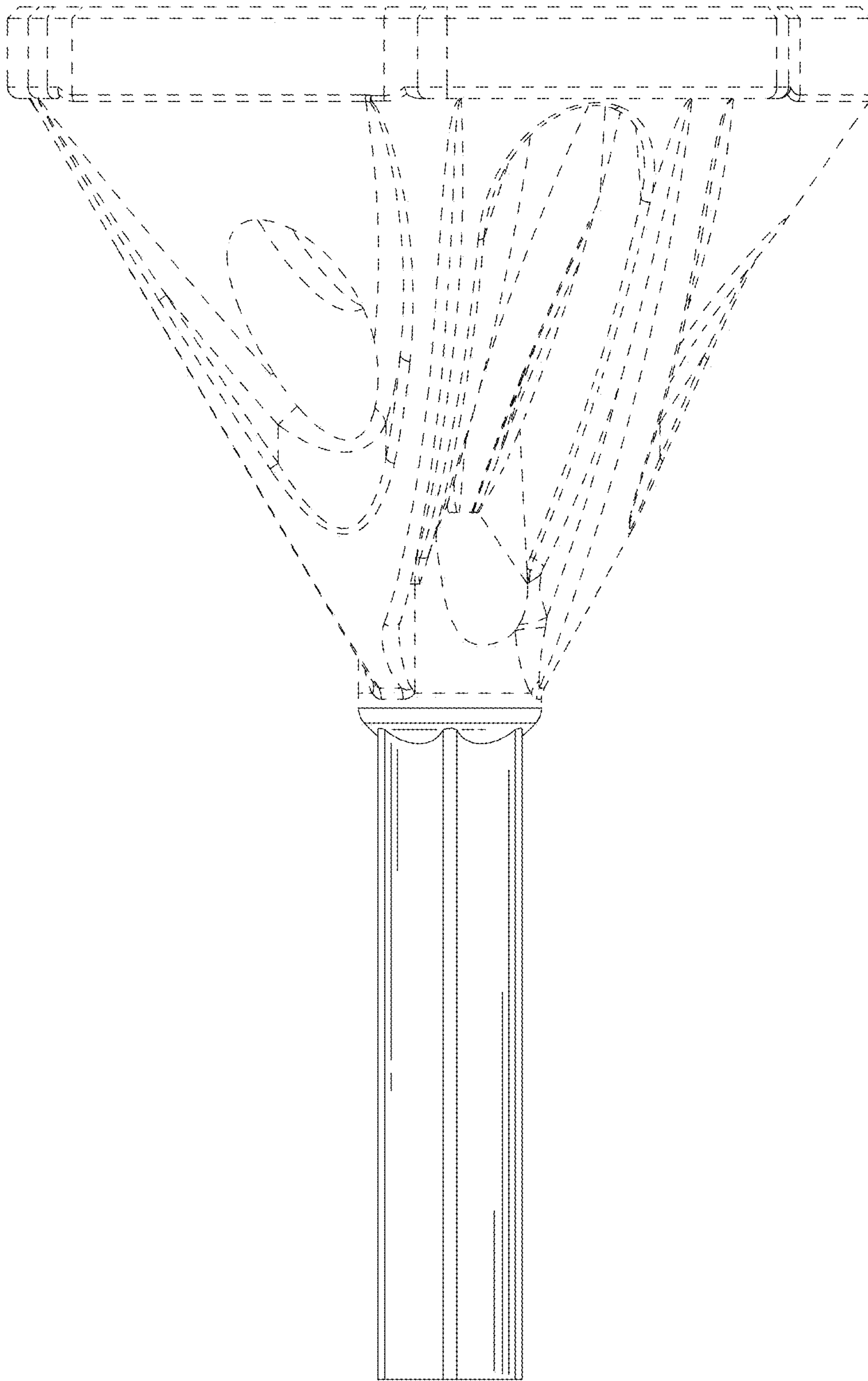

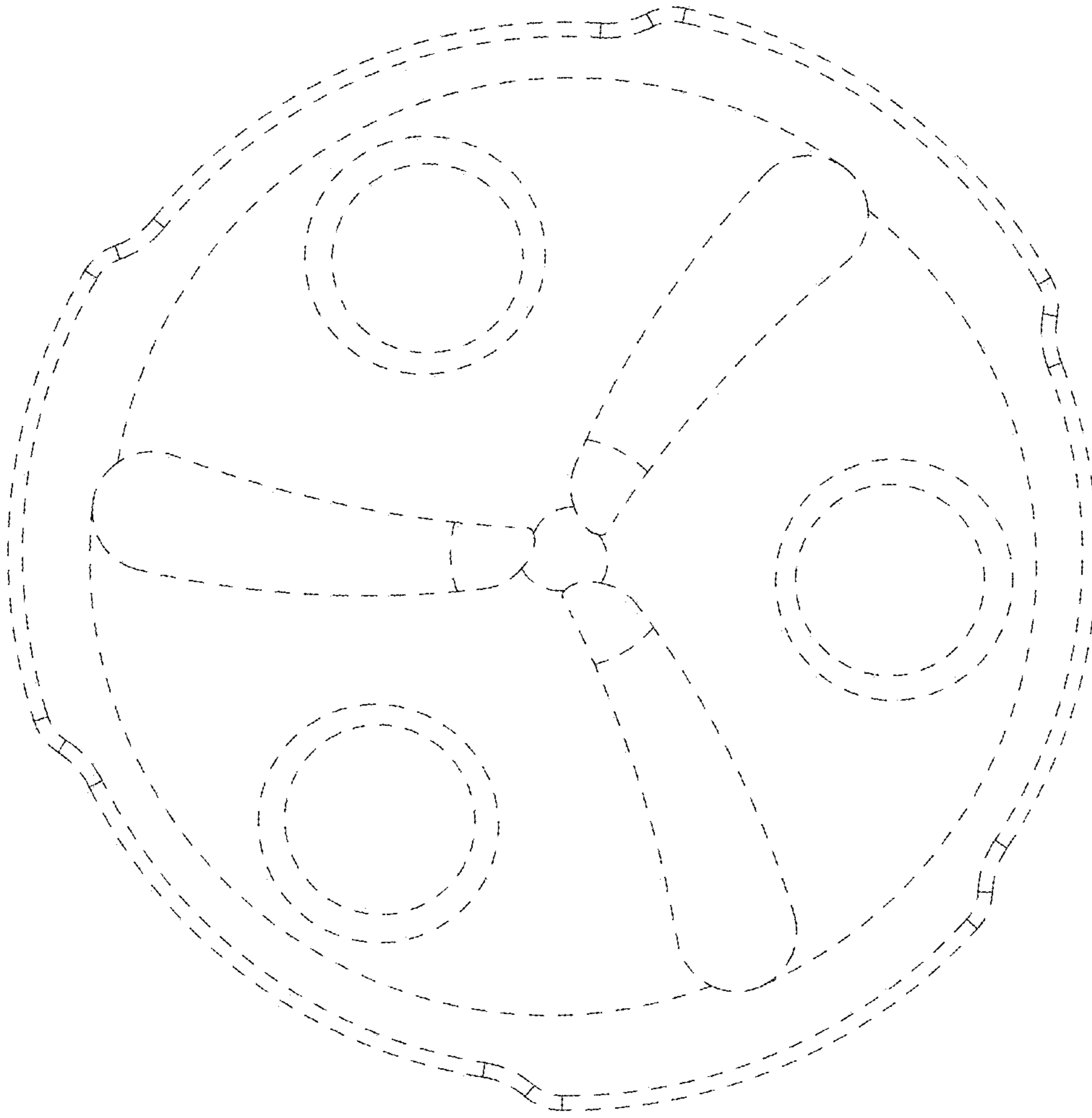

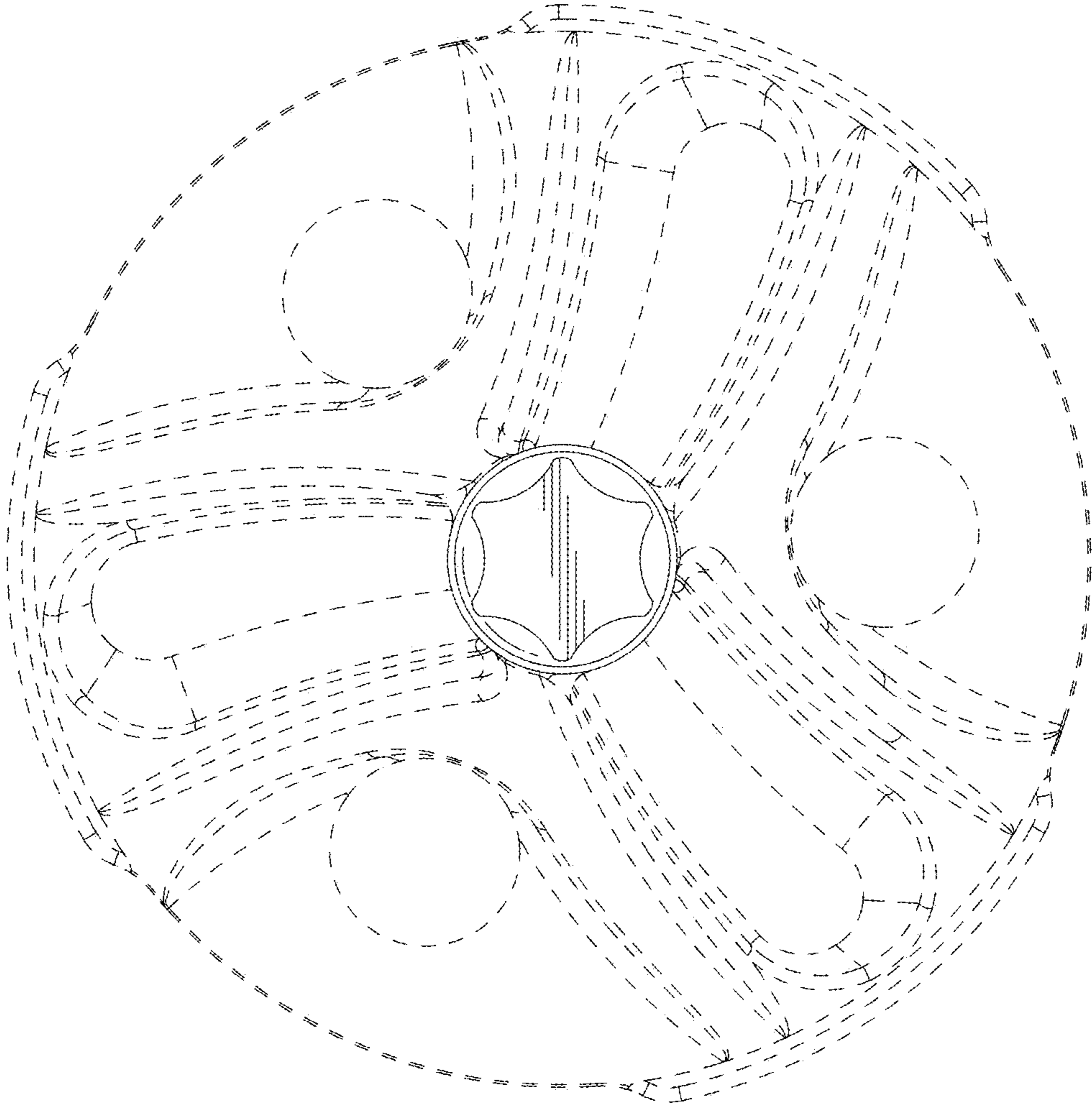

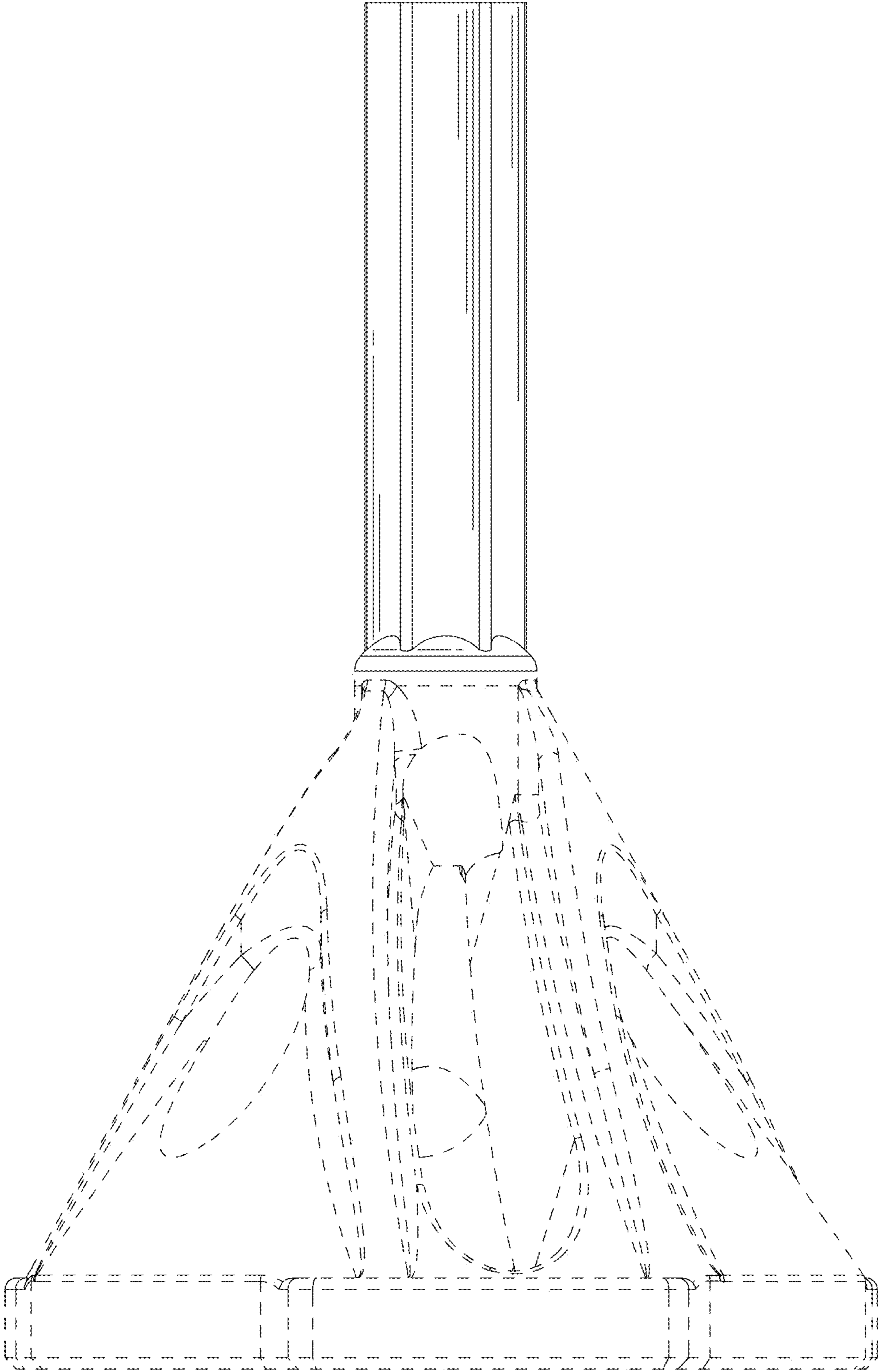

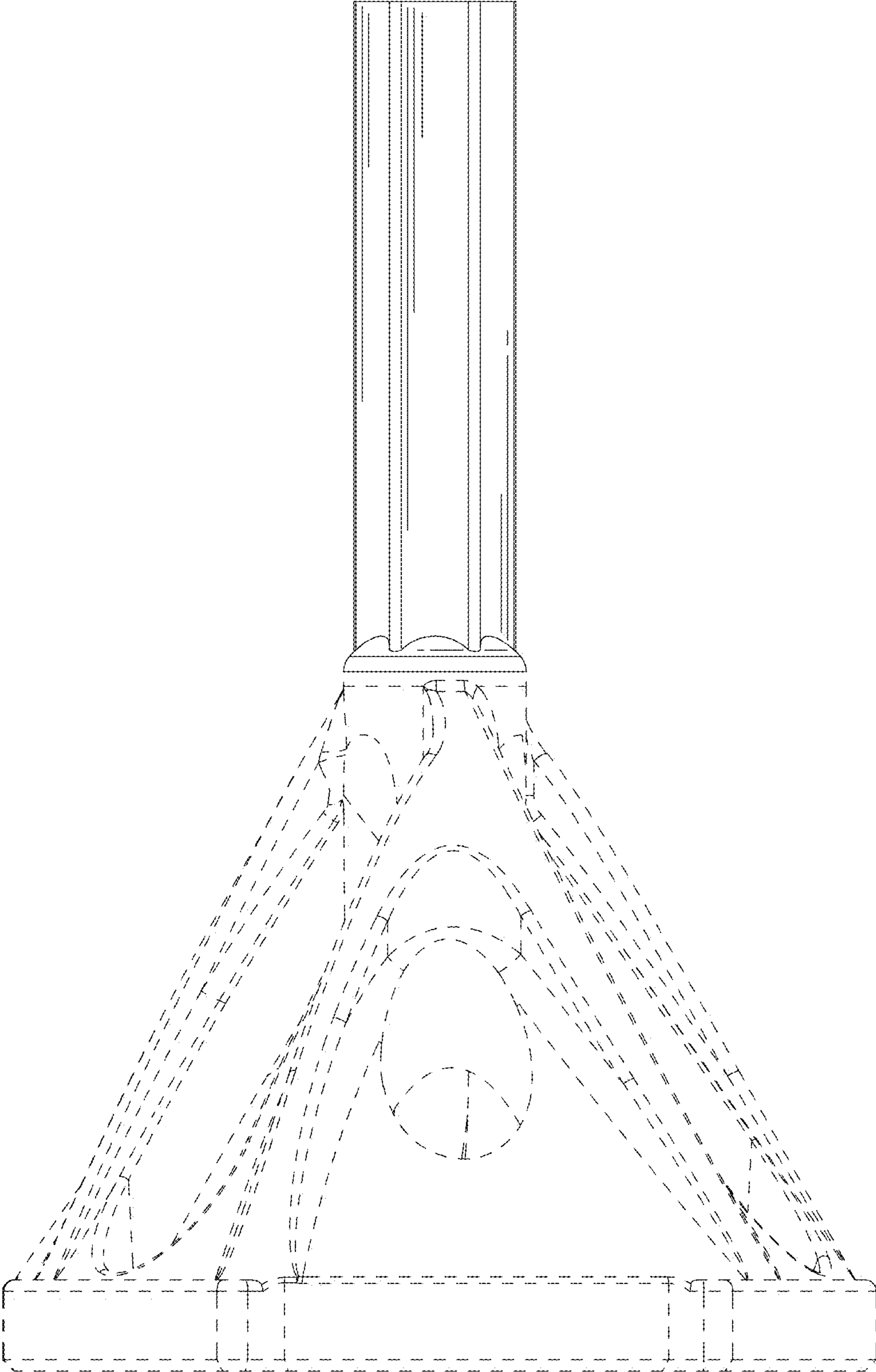
