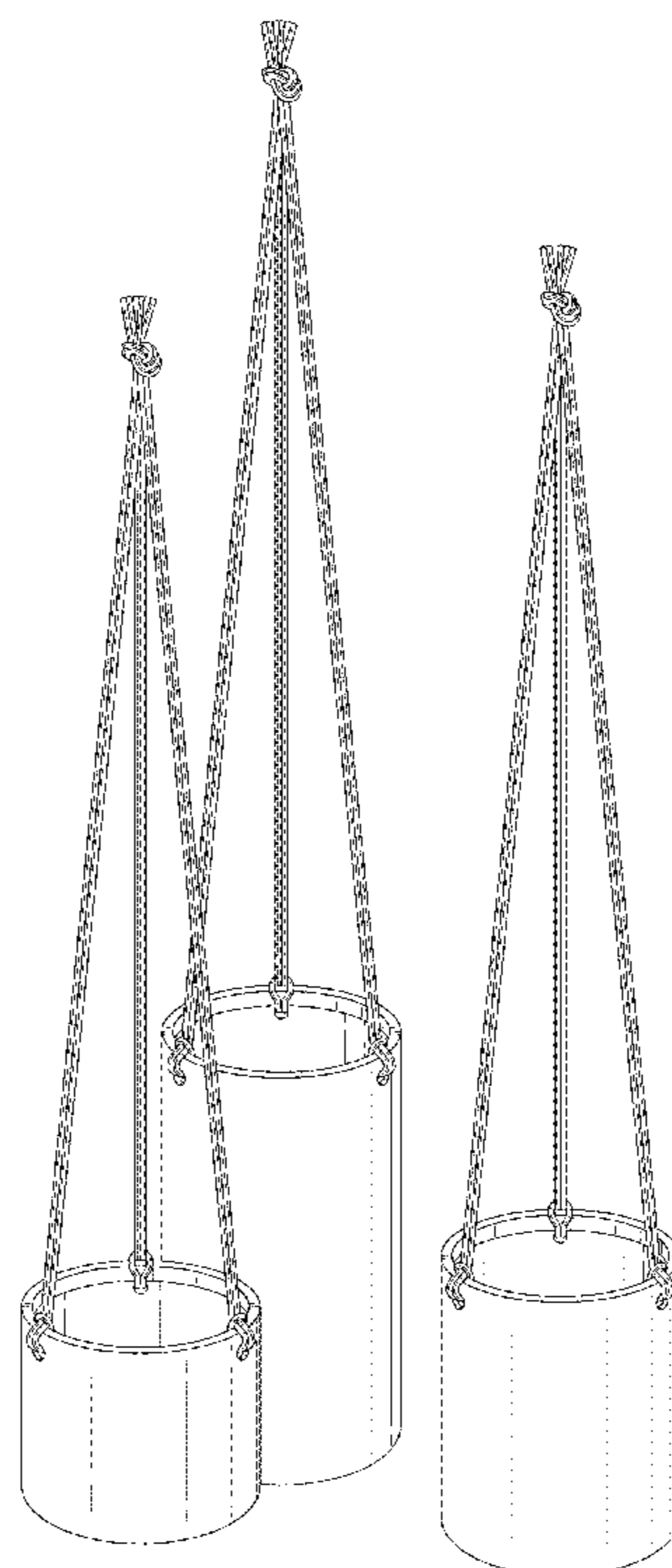
(57) **CLAIM**

I claim the ornamental design for a plant hangers, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a plant hangers showing my new design;
FIG. 2 is a front view thereof;

FIG. 5 is a left-side view thereof;

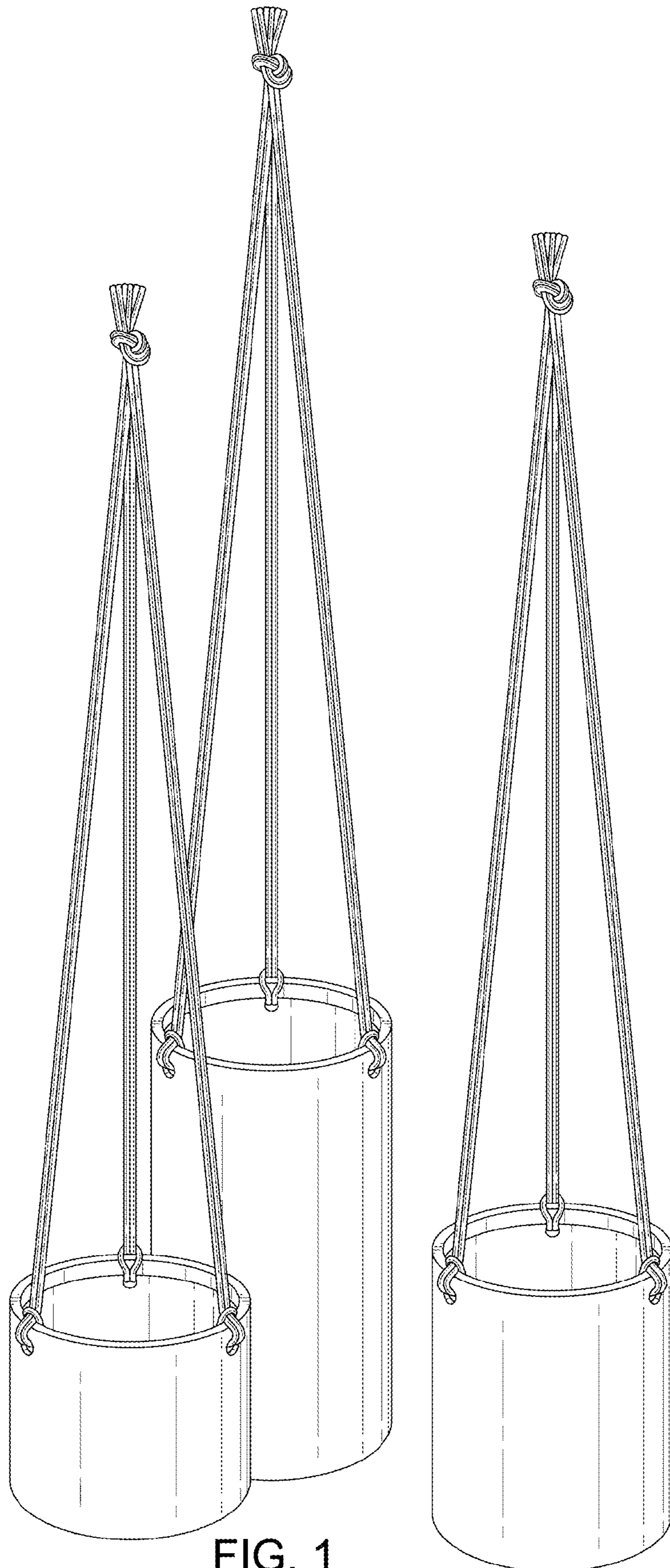

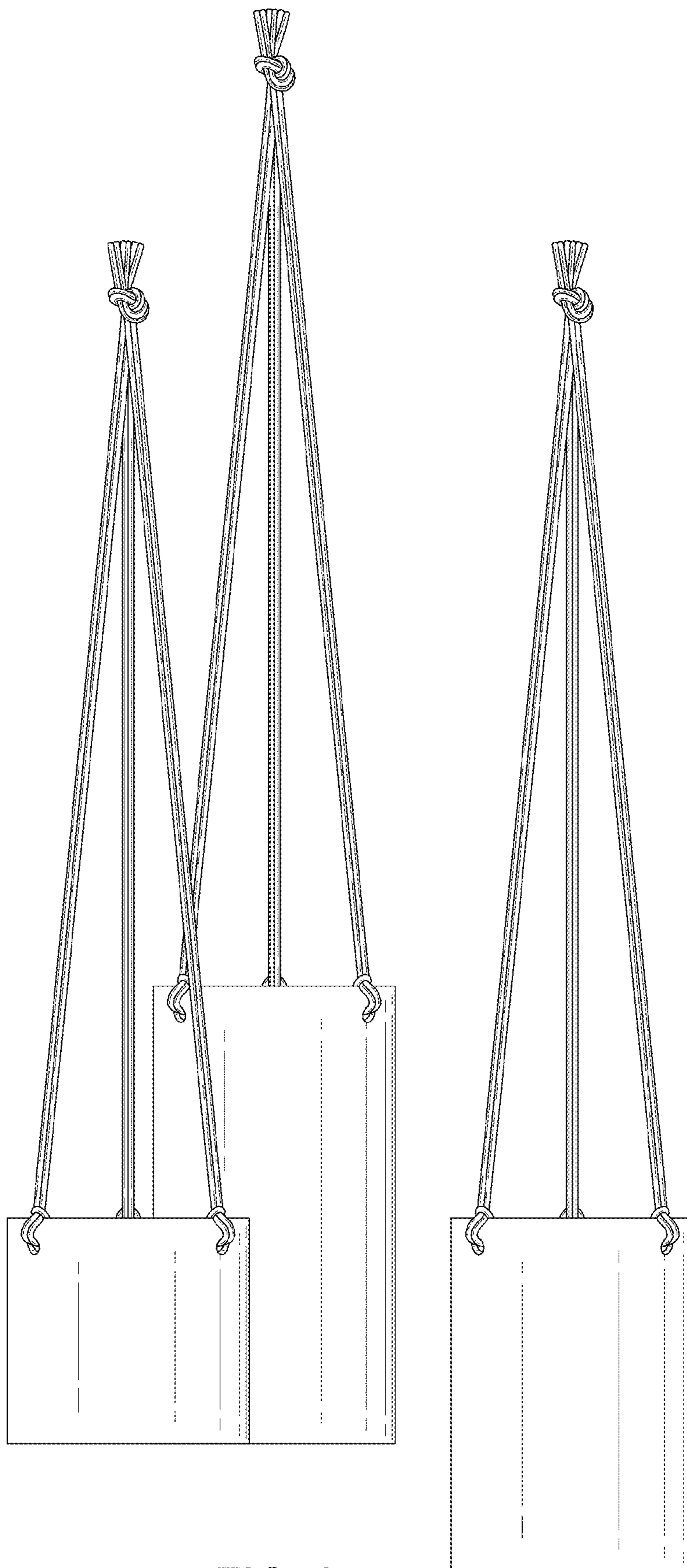

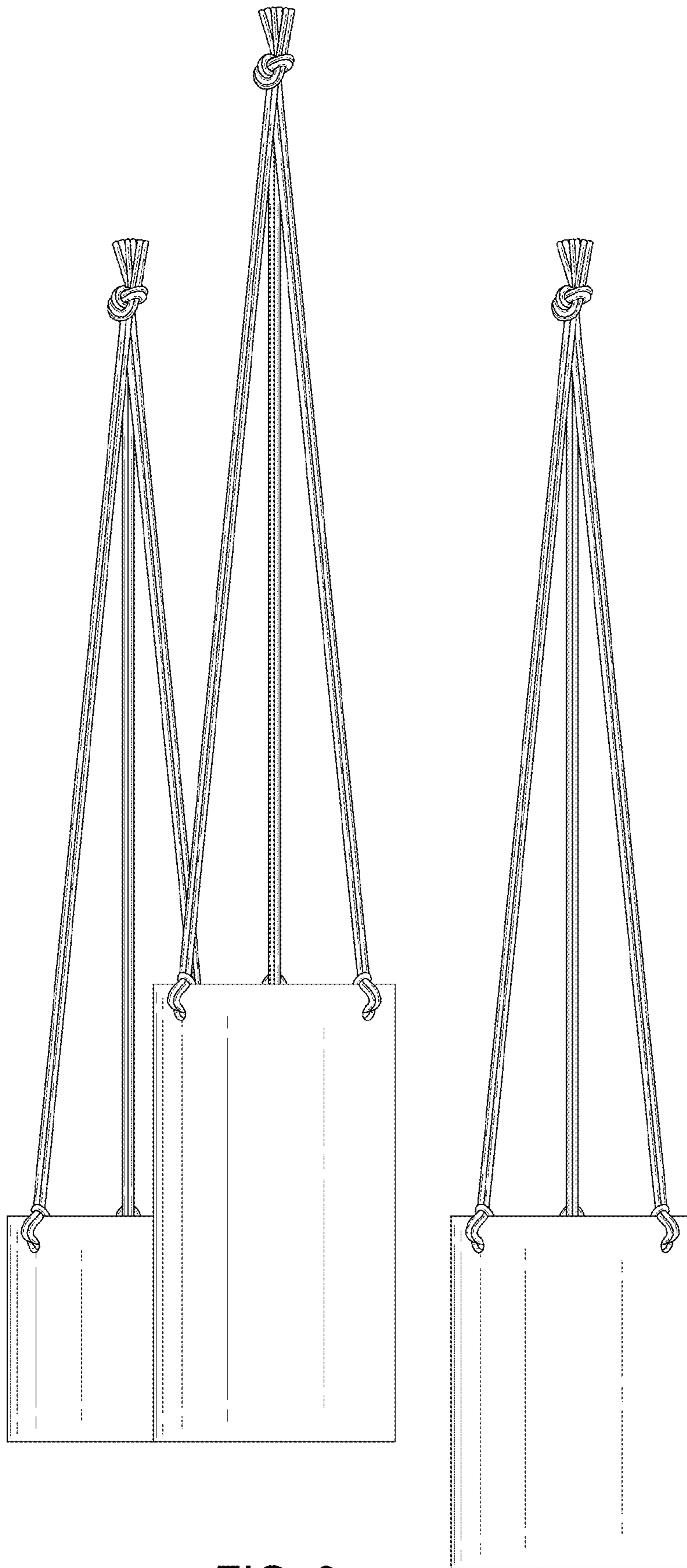

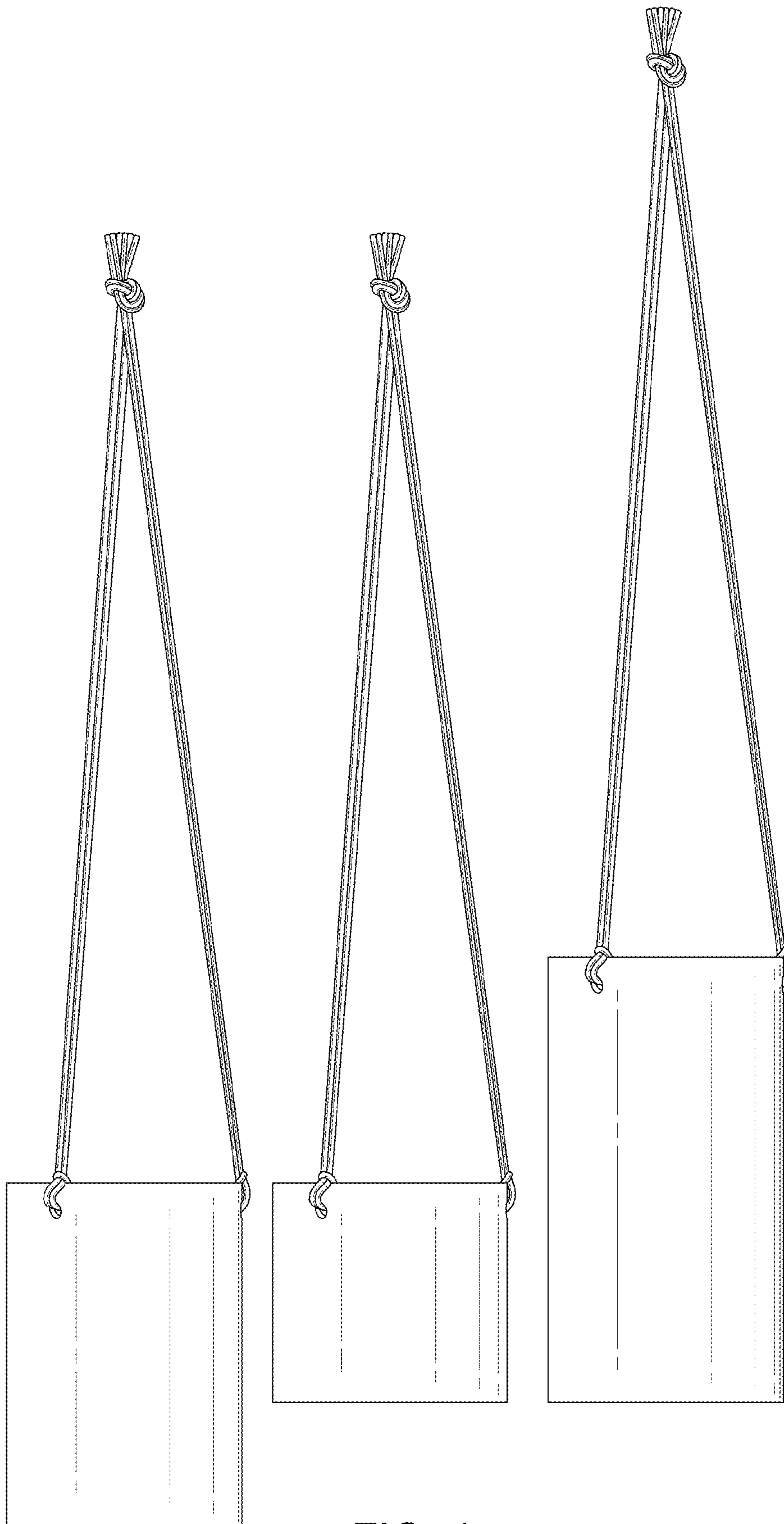

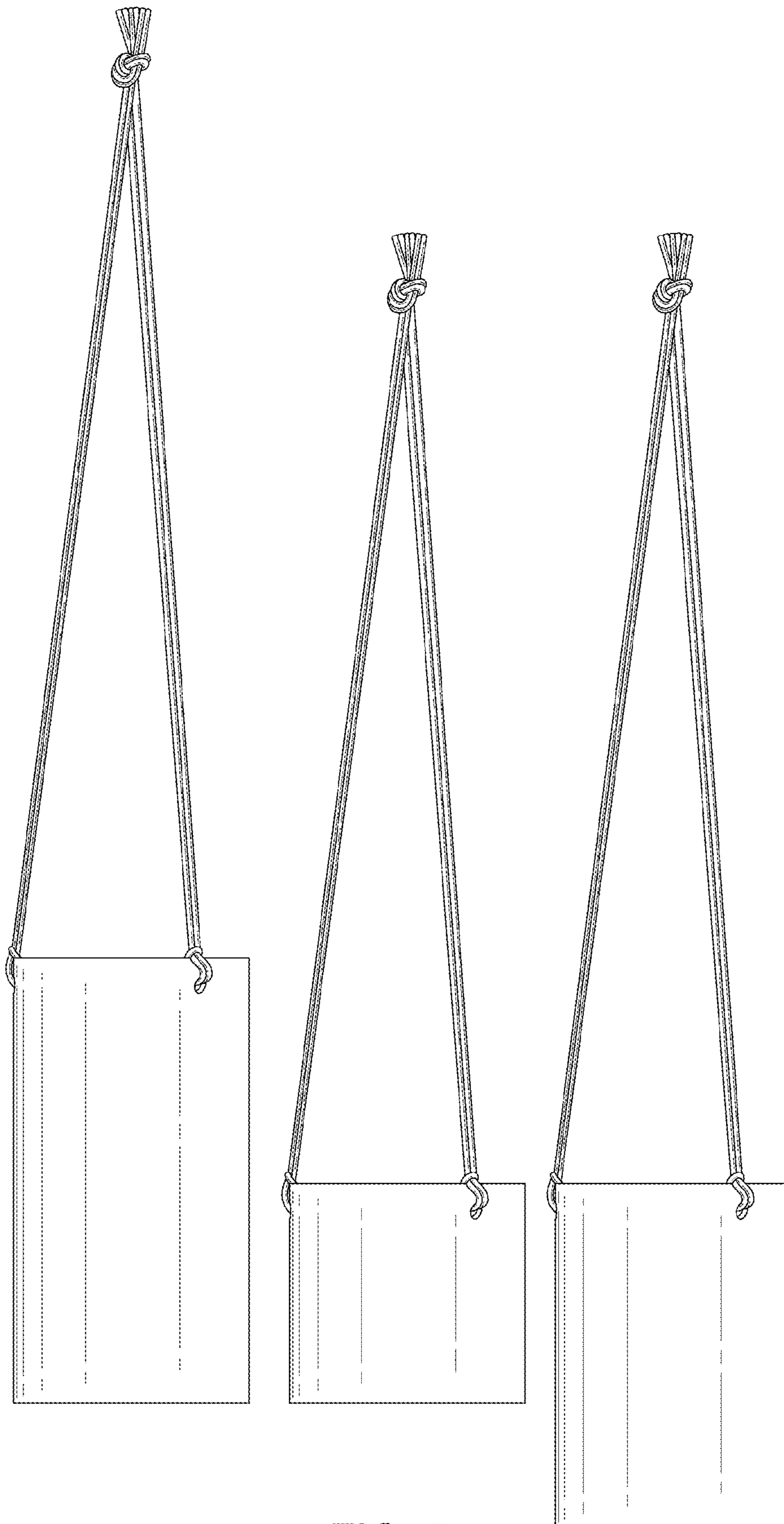

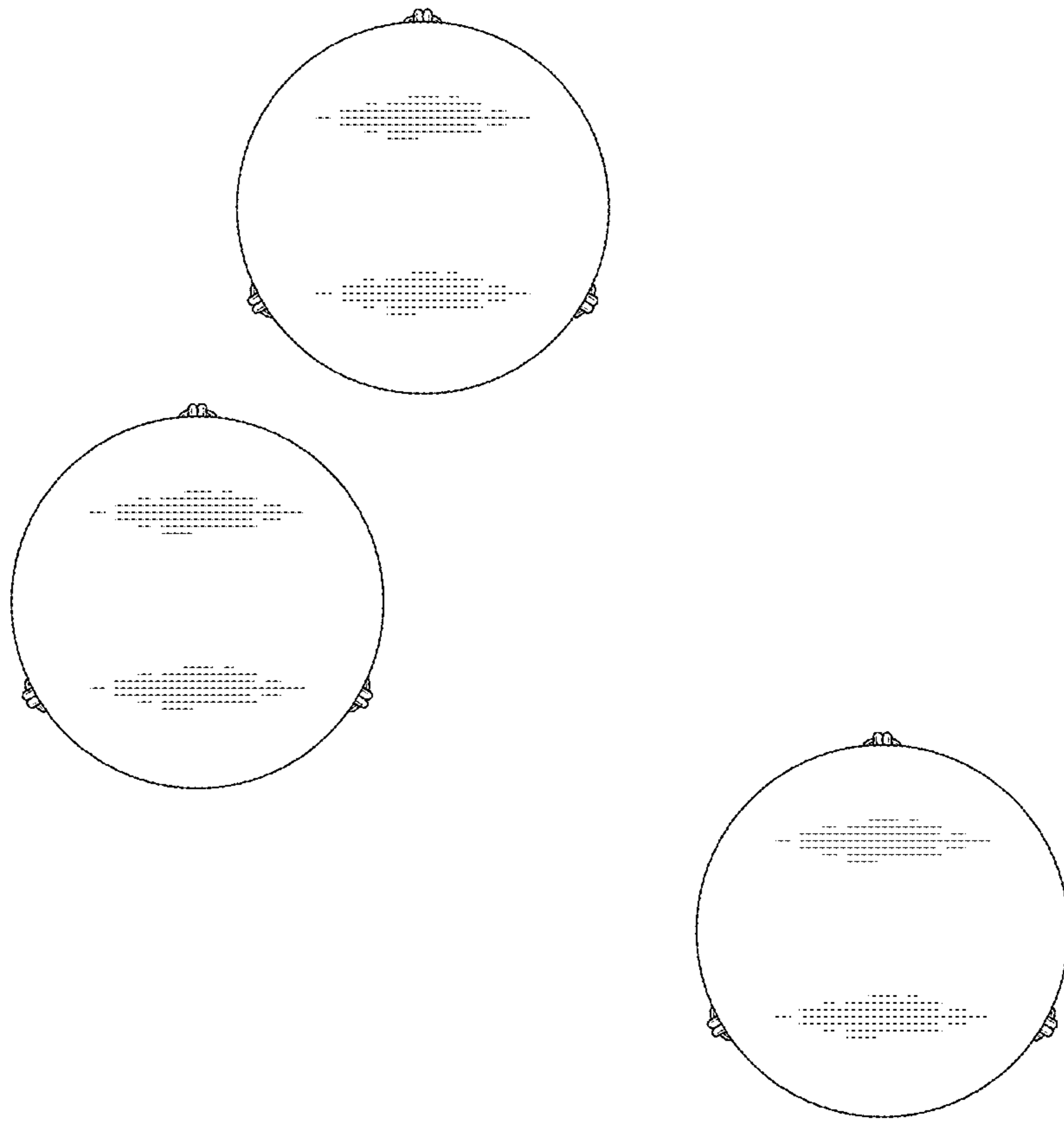

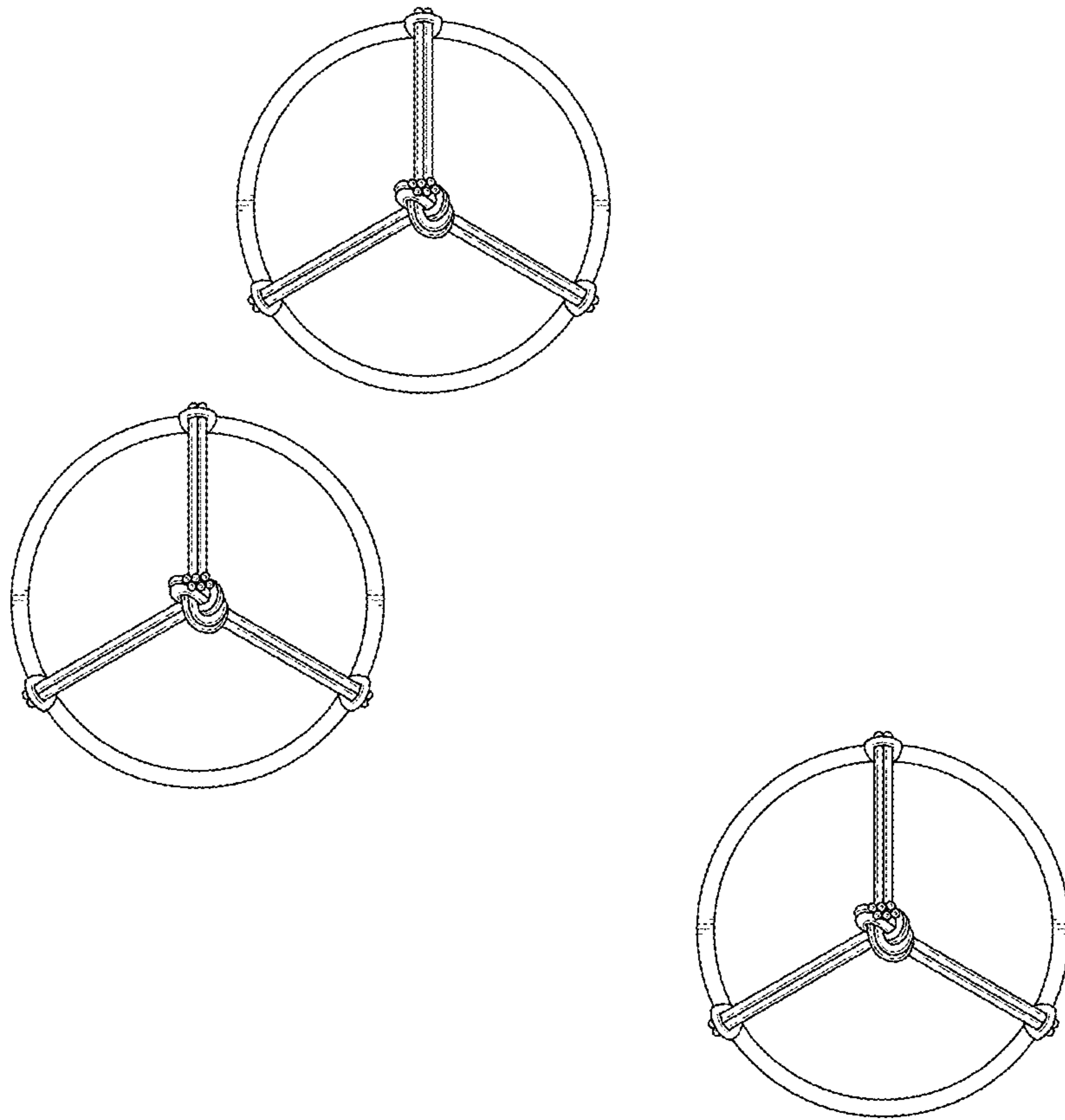
