(57) **CLAIM**

The ornamental design for a bullet-shaped beverage container, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of the bullet-shaped beverage container, wherein the cap and shell portion of the beverage container is shown depicted in dashed broken lines illustrating portions forming no part of the claimed design; FIG. 2 is a left-side elevational view, which mirrors the right-side elevational view, of the beverage container depicted in FIG. 1; FIG. 3 is a rear elevational view of the beverage container depicted in FIG. 1; FIG. 4 is a top plan view of the beverage container depicted in FIG. 1; and, FIG. 5 is a perspective view of the beverage container depicted in FIG. 1.

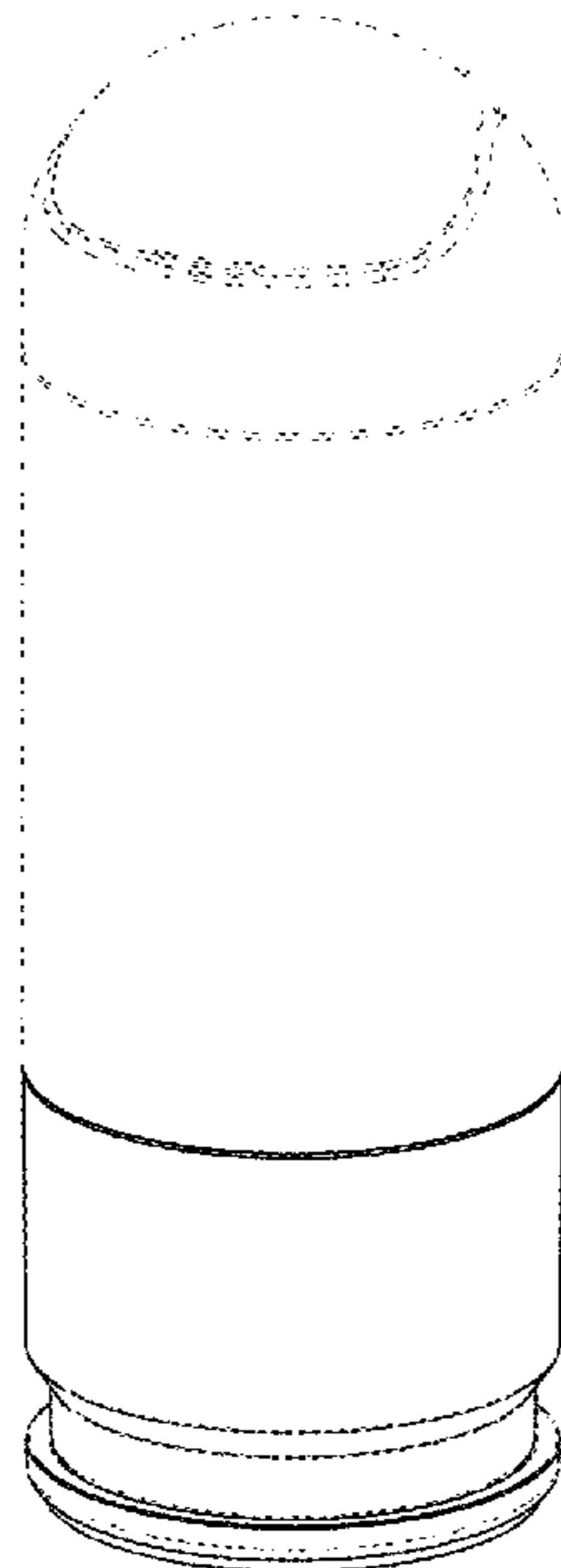

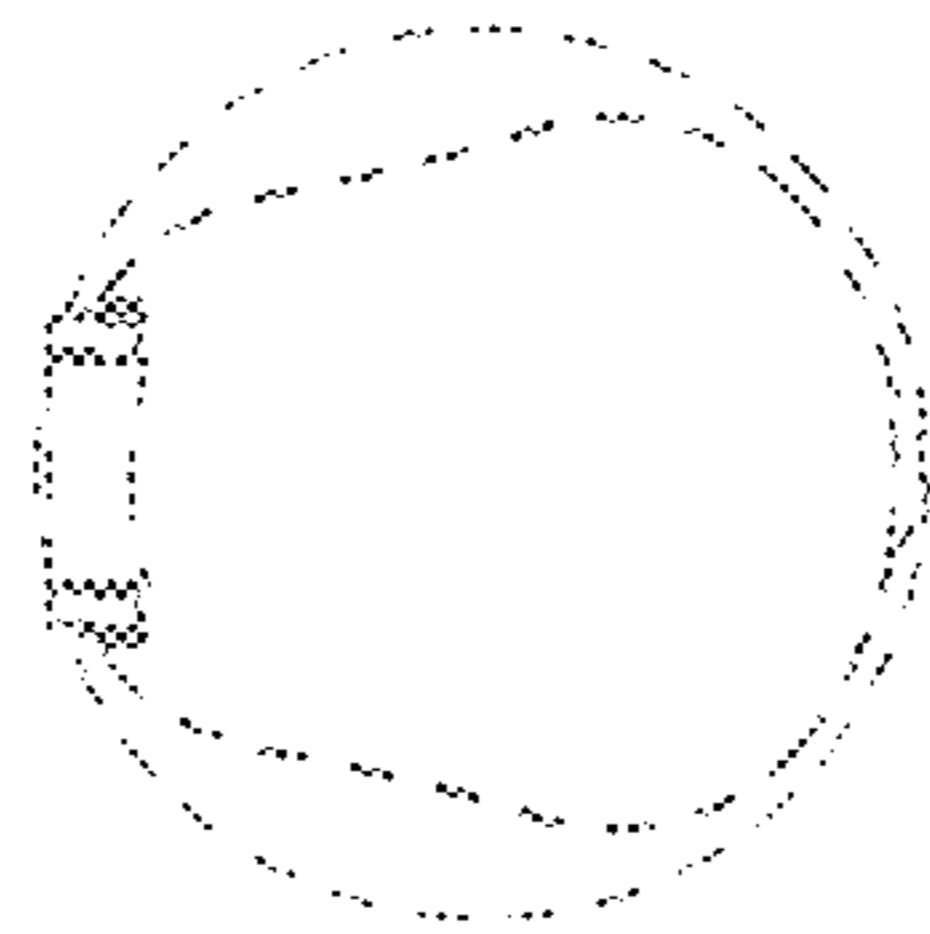
