(57) **CLAIM**

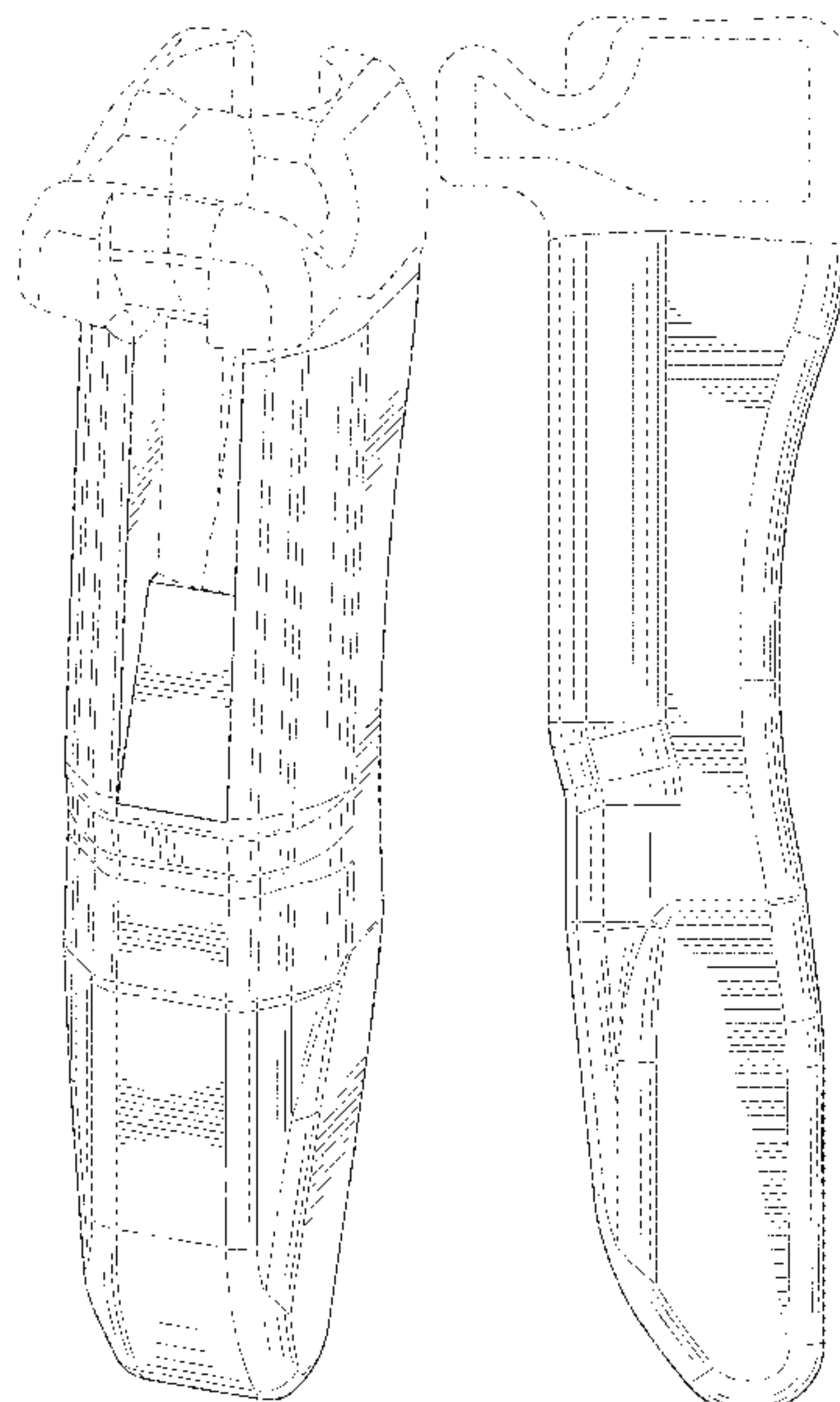
We claim the ornamental design for an insert pin for slide fastener, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of our new design.

FIG. 5 is a right-side view thereof.

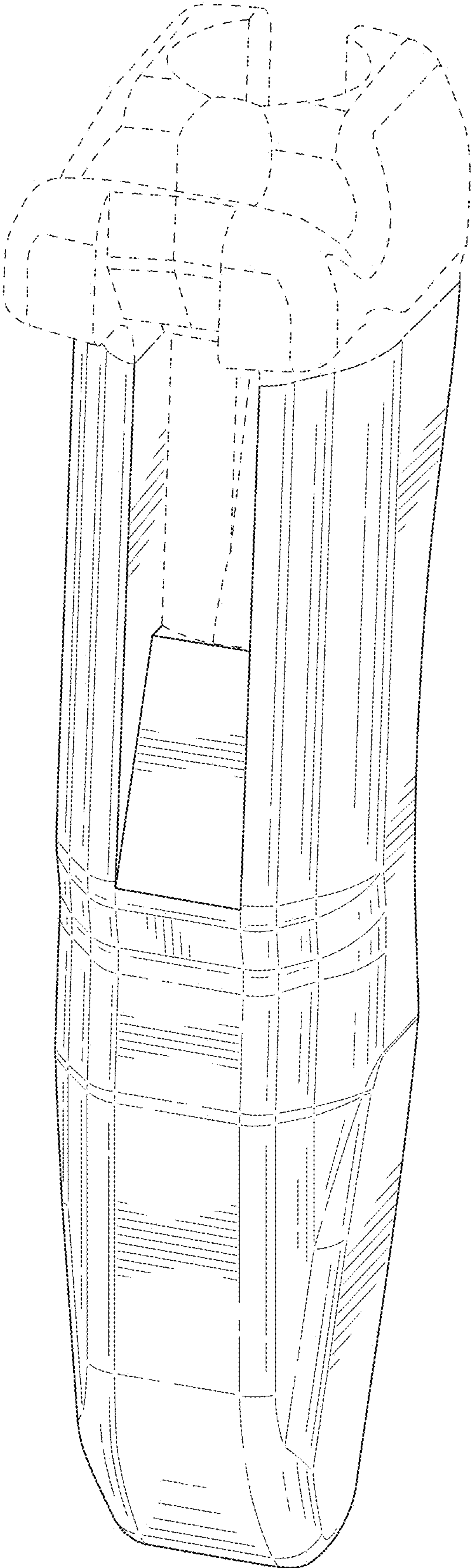

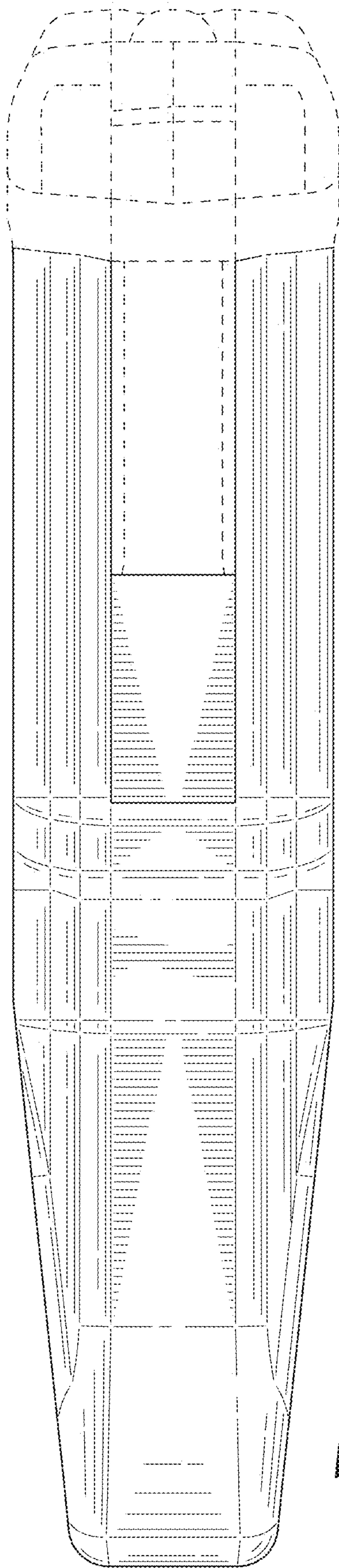

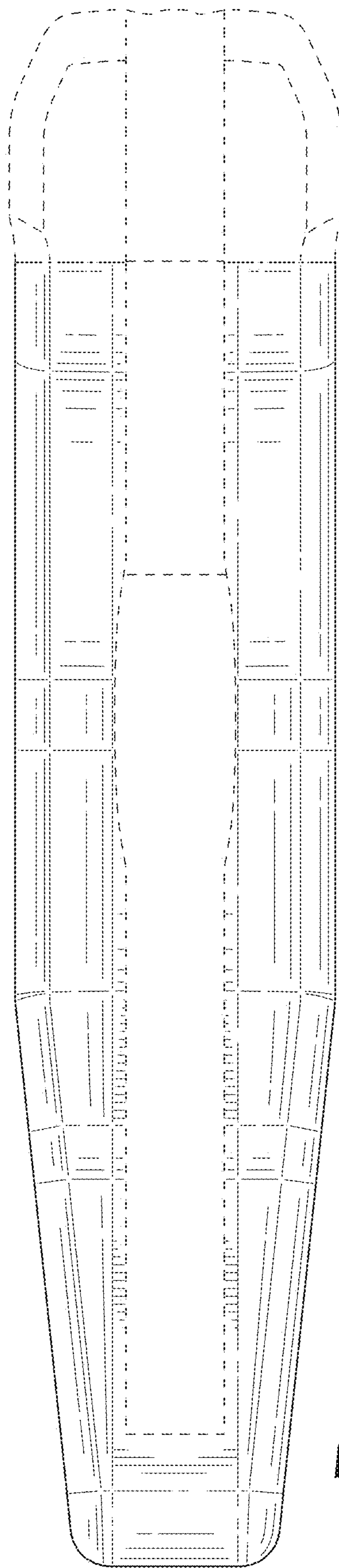

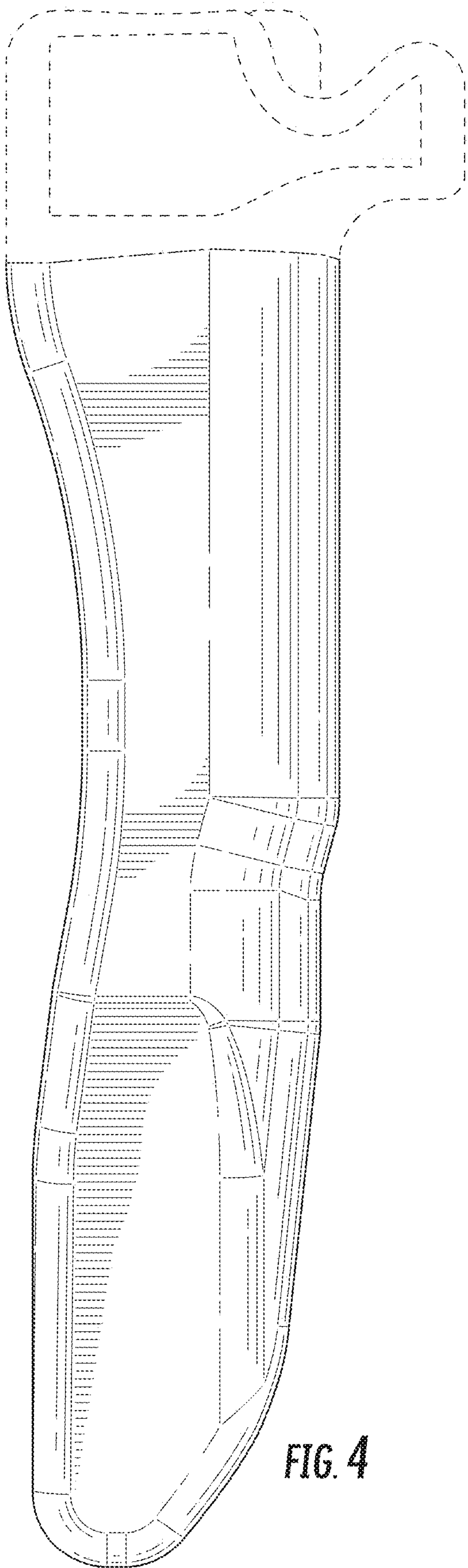

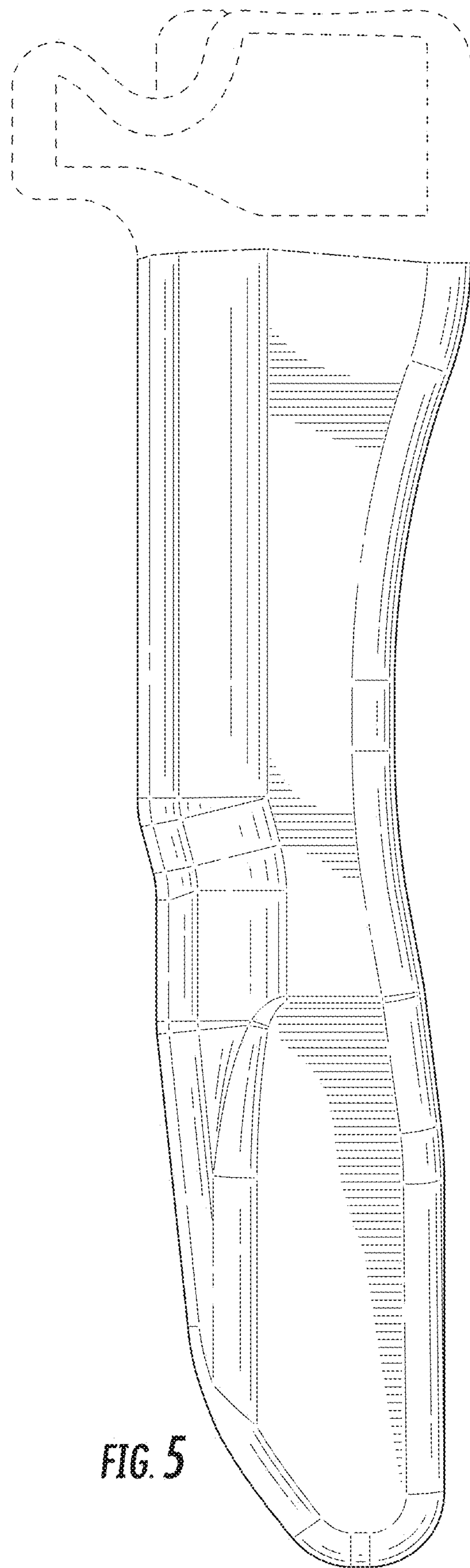
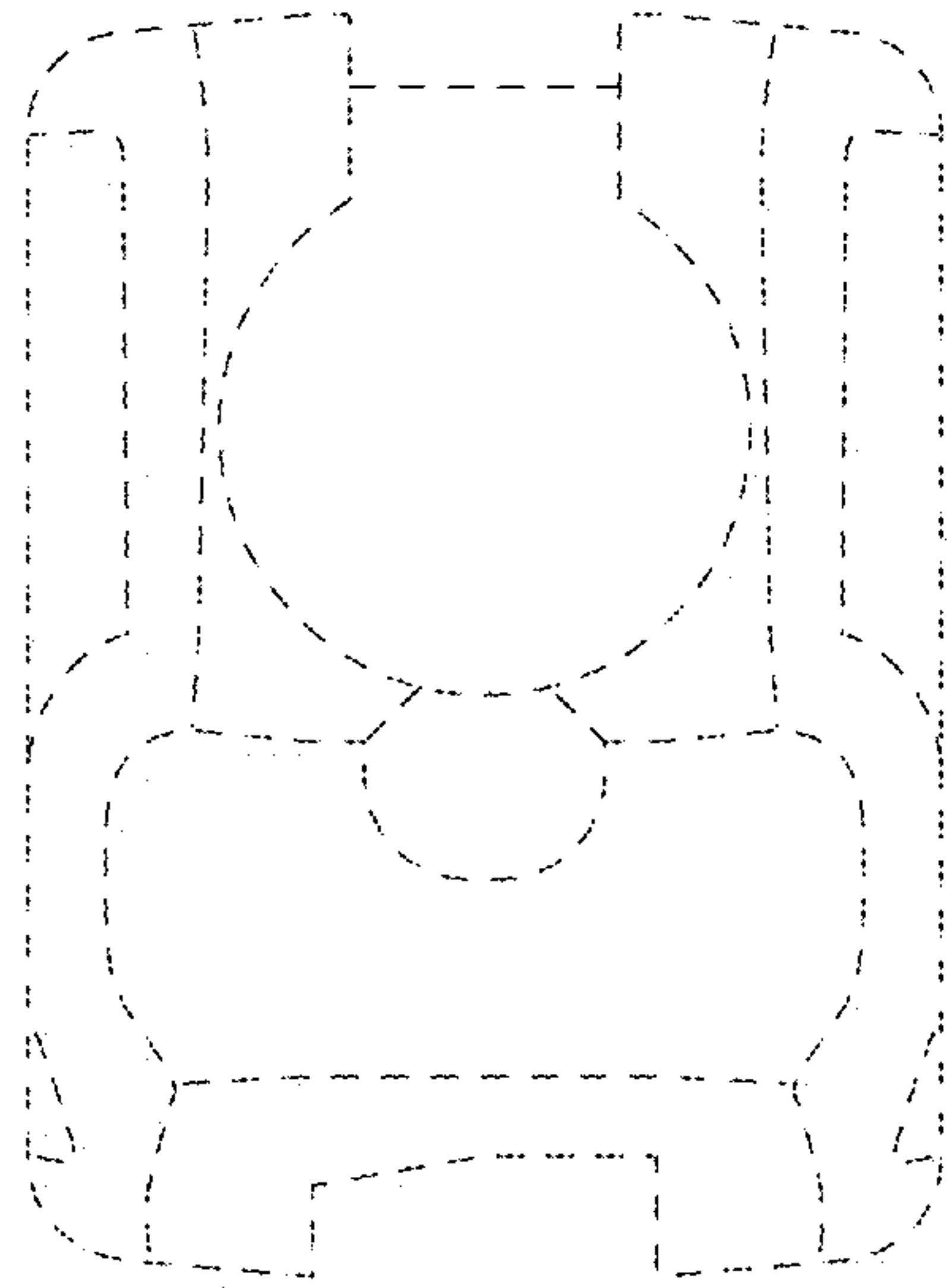
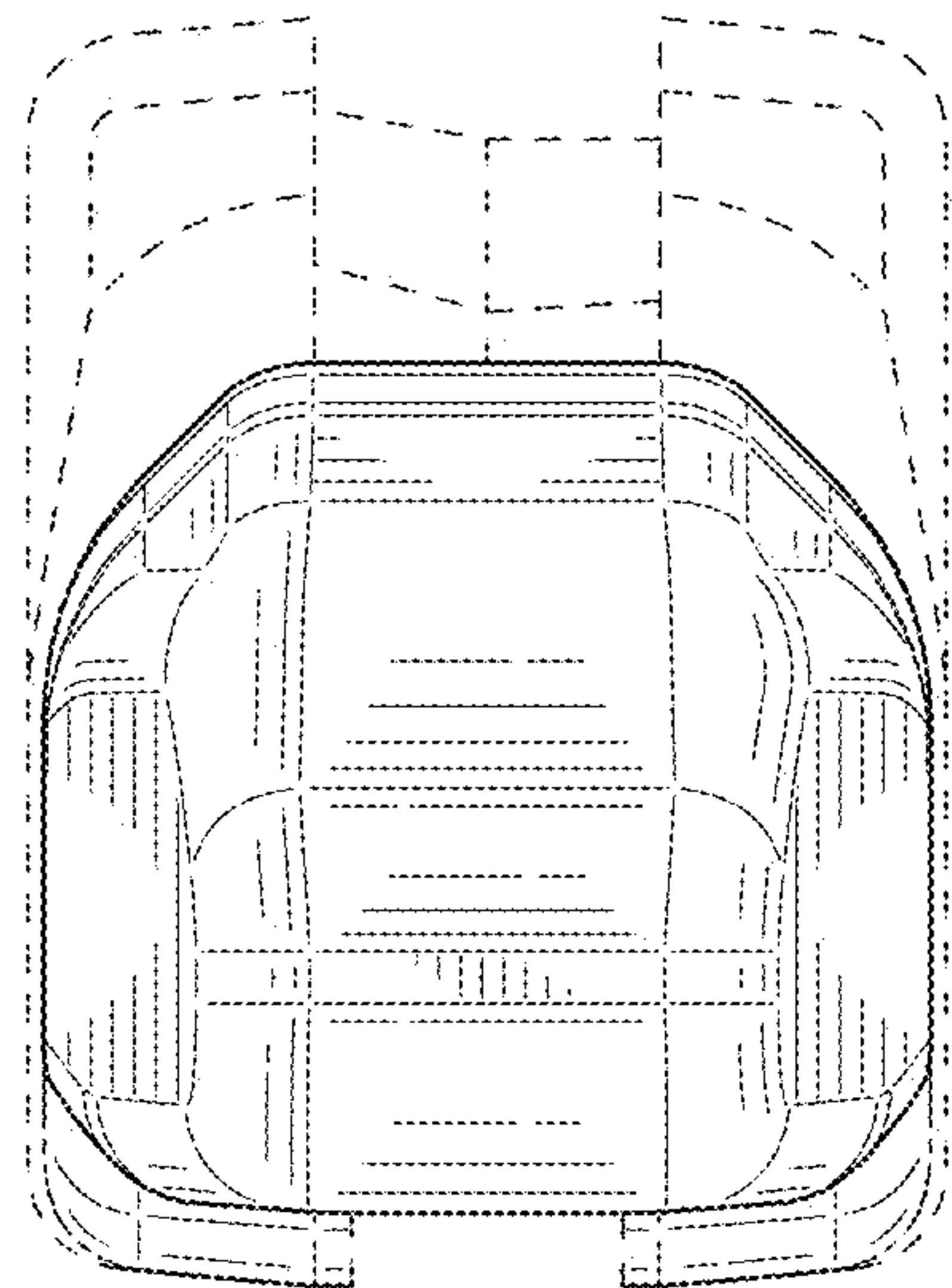
