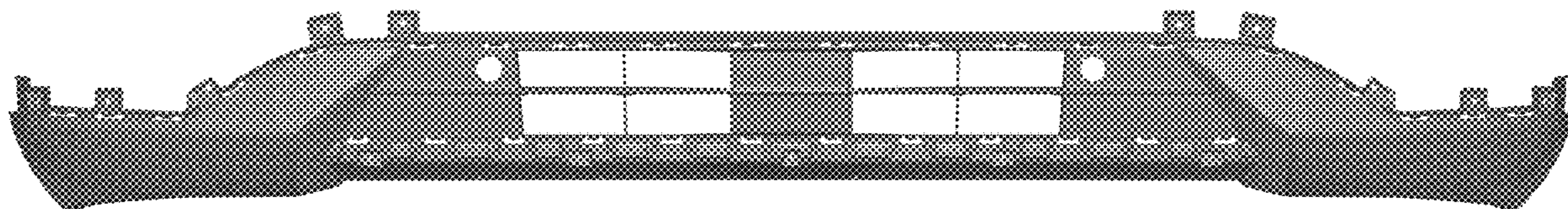
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front elevational view of a vehicle front lower grille, showing our new design;

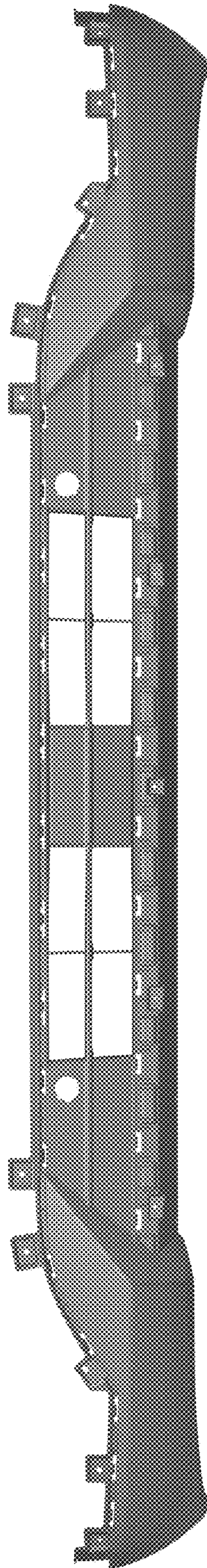

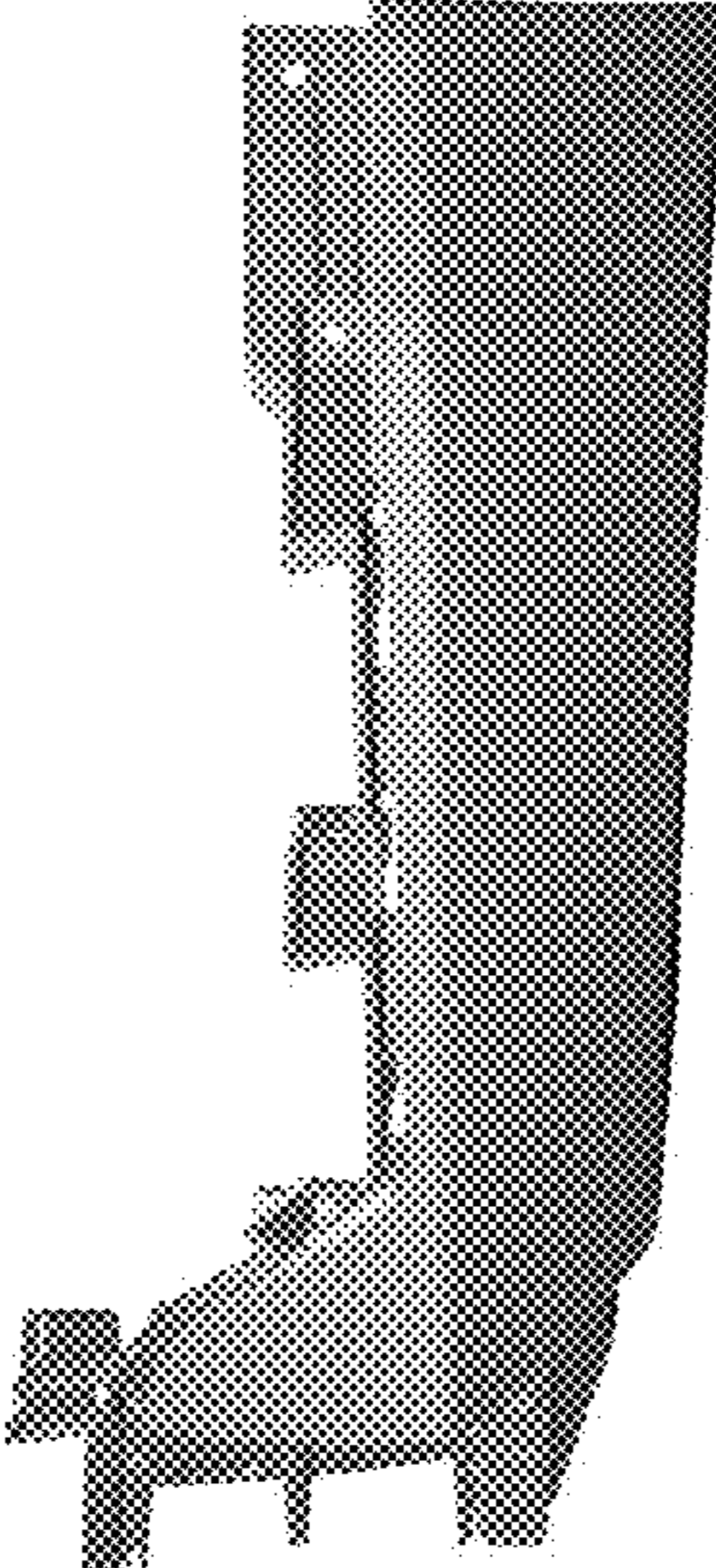

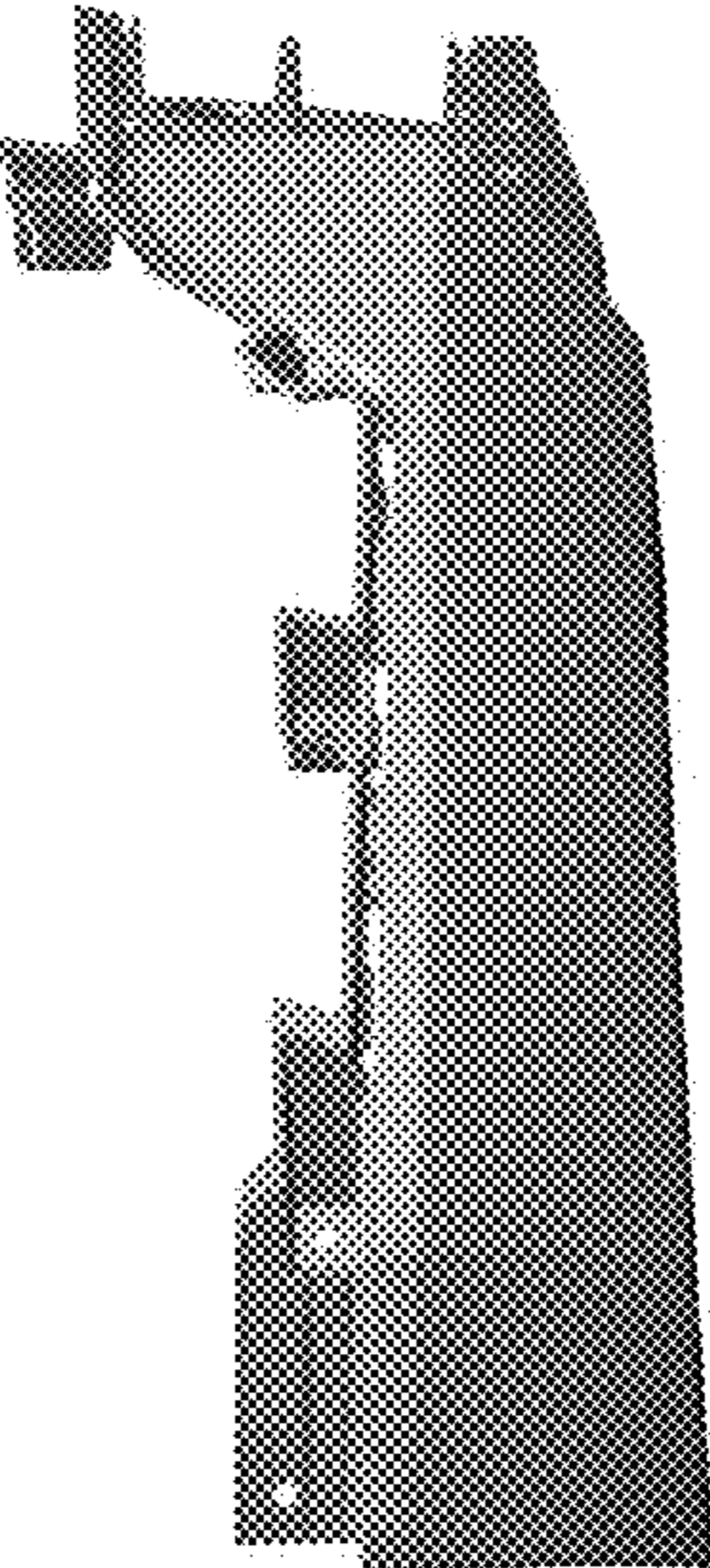

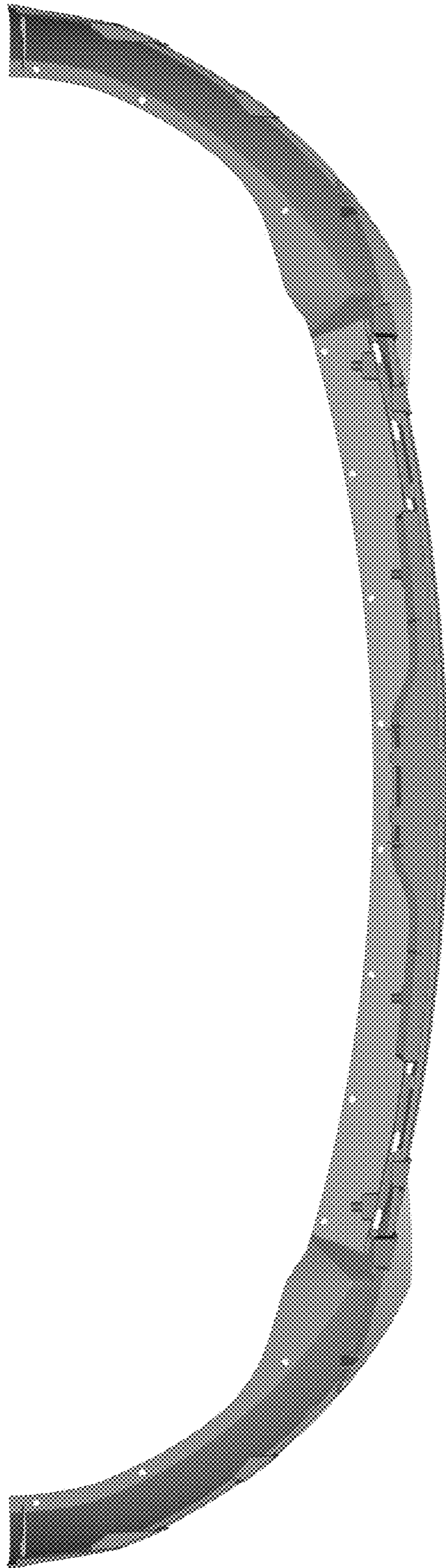

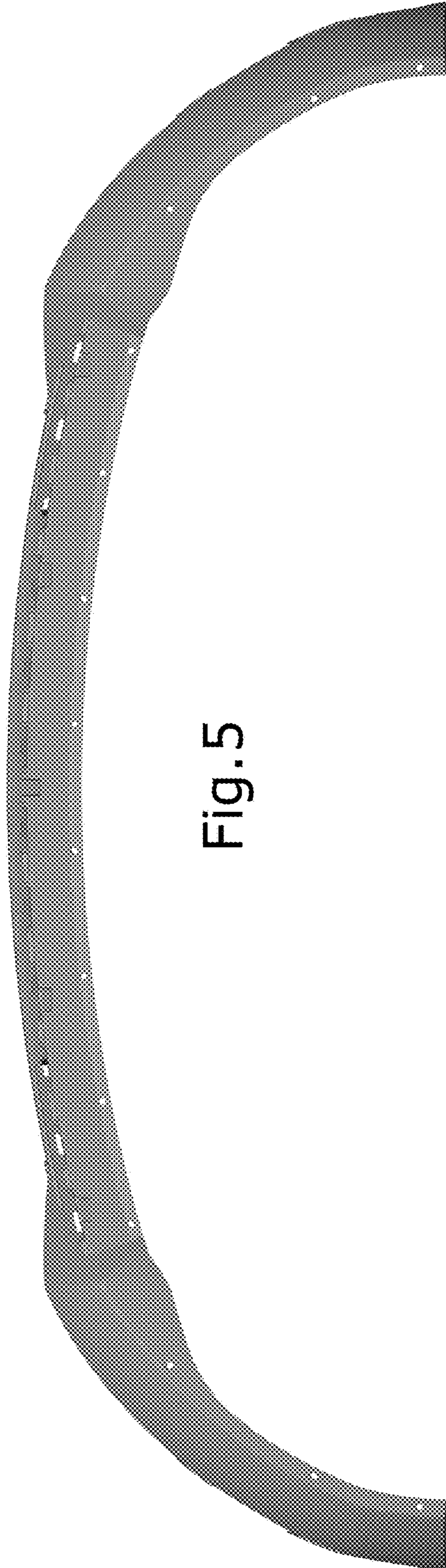

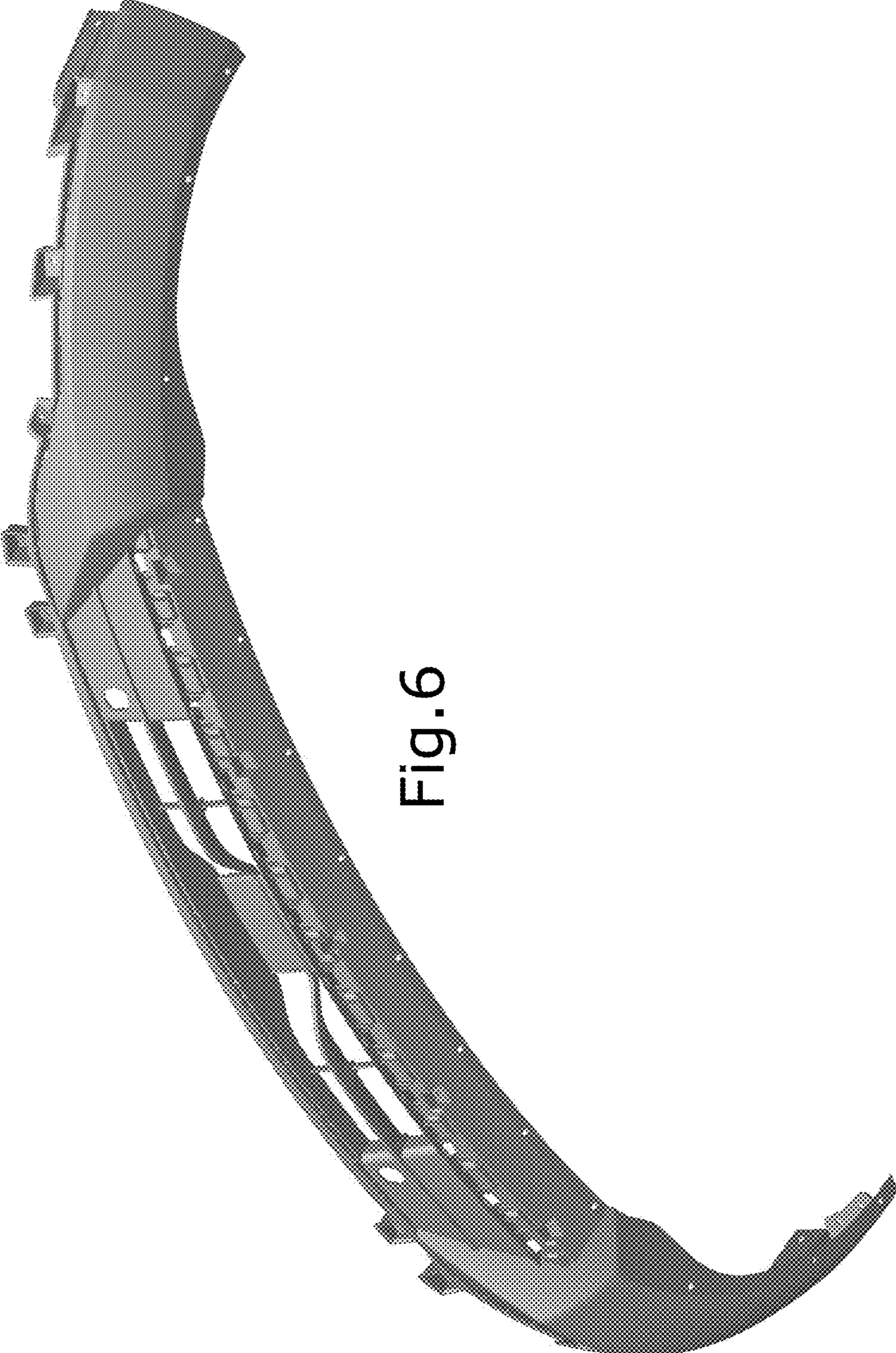

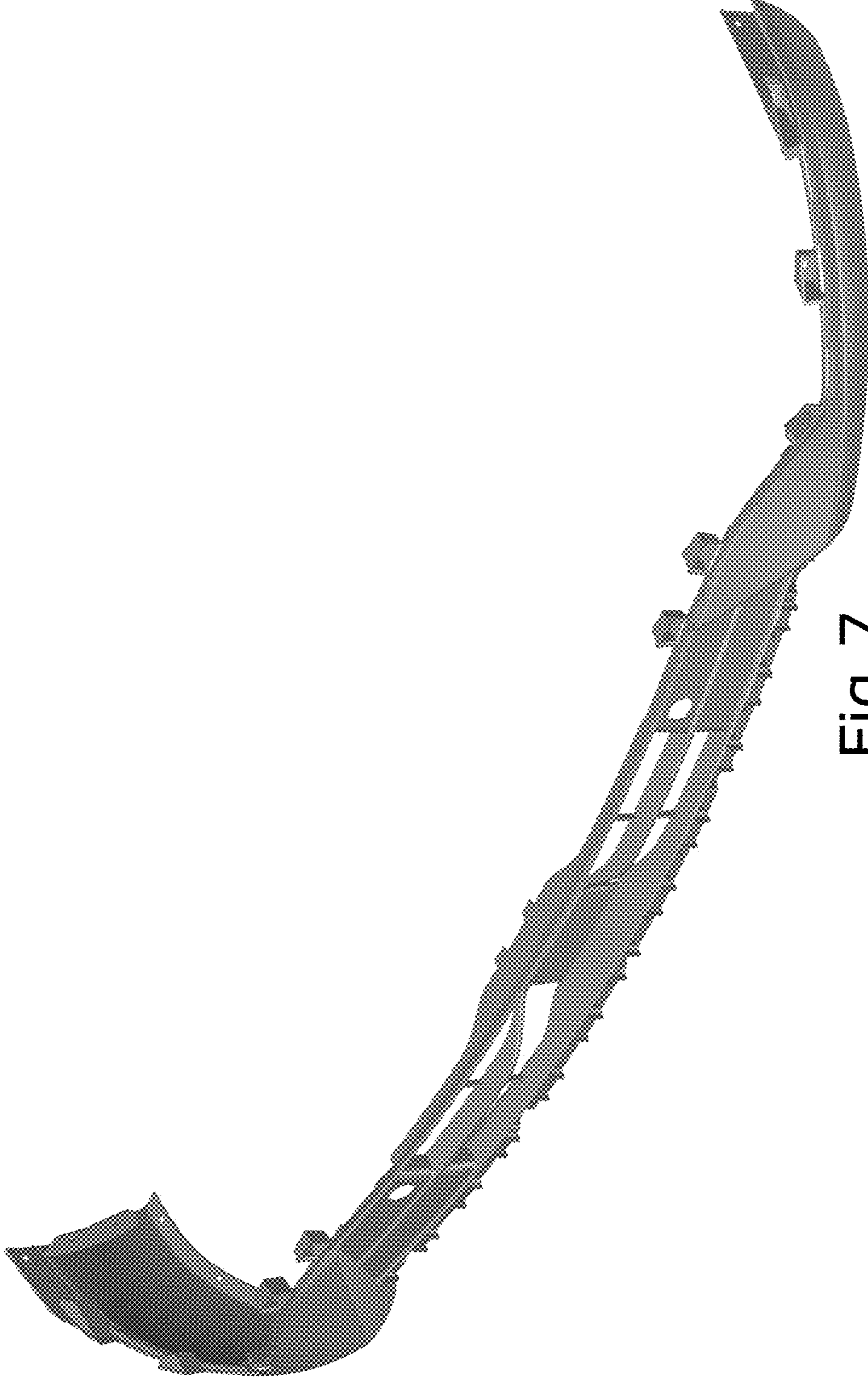
