(57) **CLAIM**

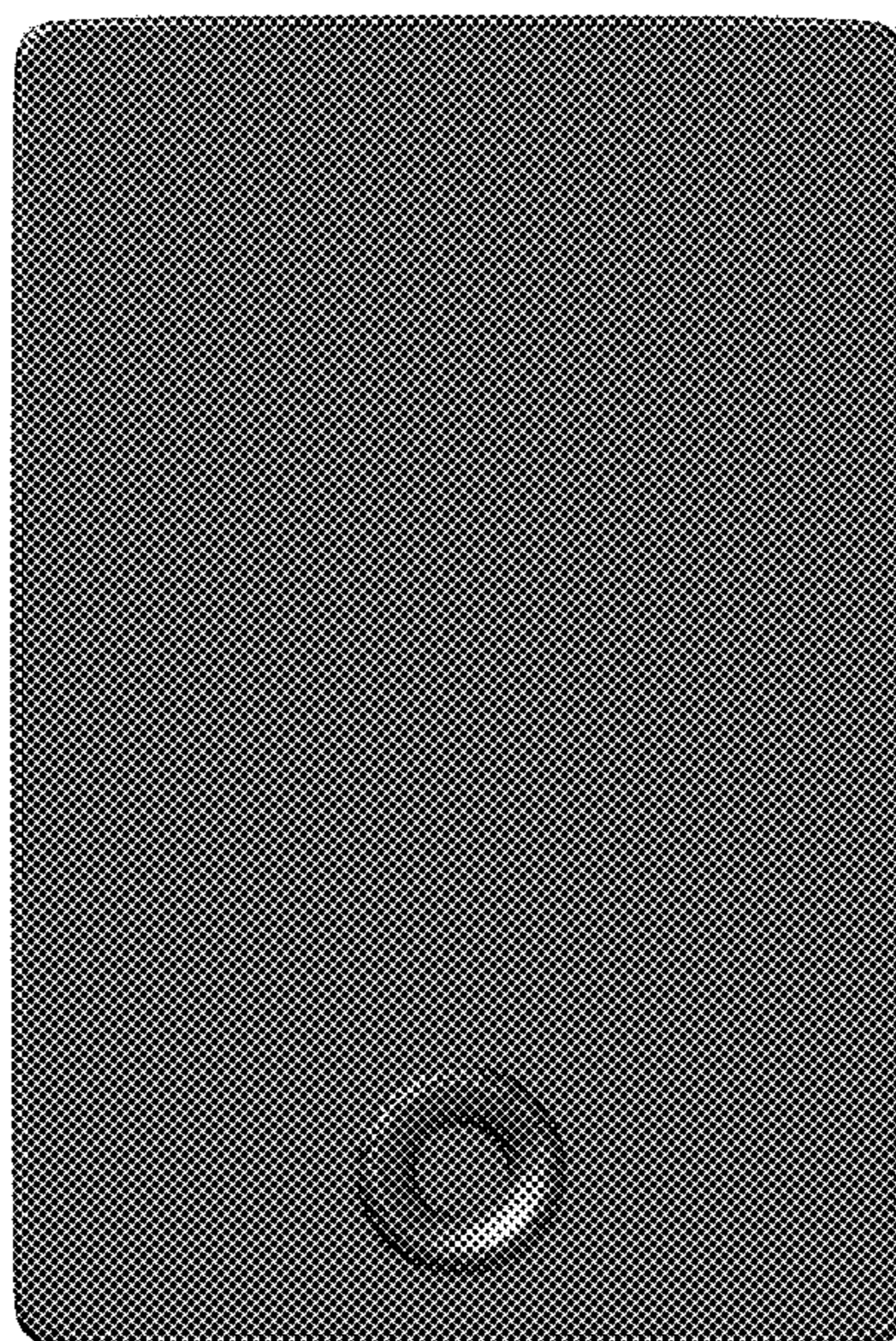
The ornamental design for a vehicle center display, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a vehicle center display, showing our new design;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is a left side elevational view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a top, front and left side perspective view thereof; and,
FIG. 7 is a bottom, front and left side perspective view thereof.

The claimed design is indicated by the relatively dark portions in the figures. The relatively light portions form no part of the claimed design.

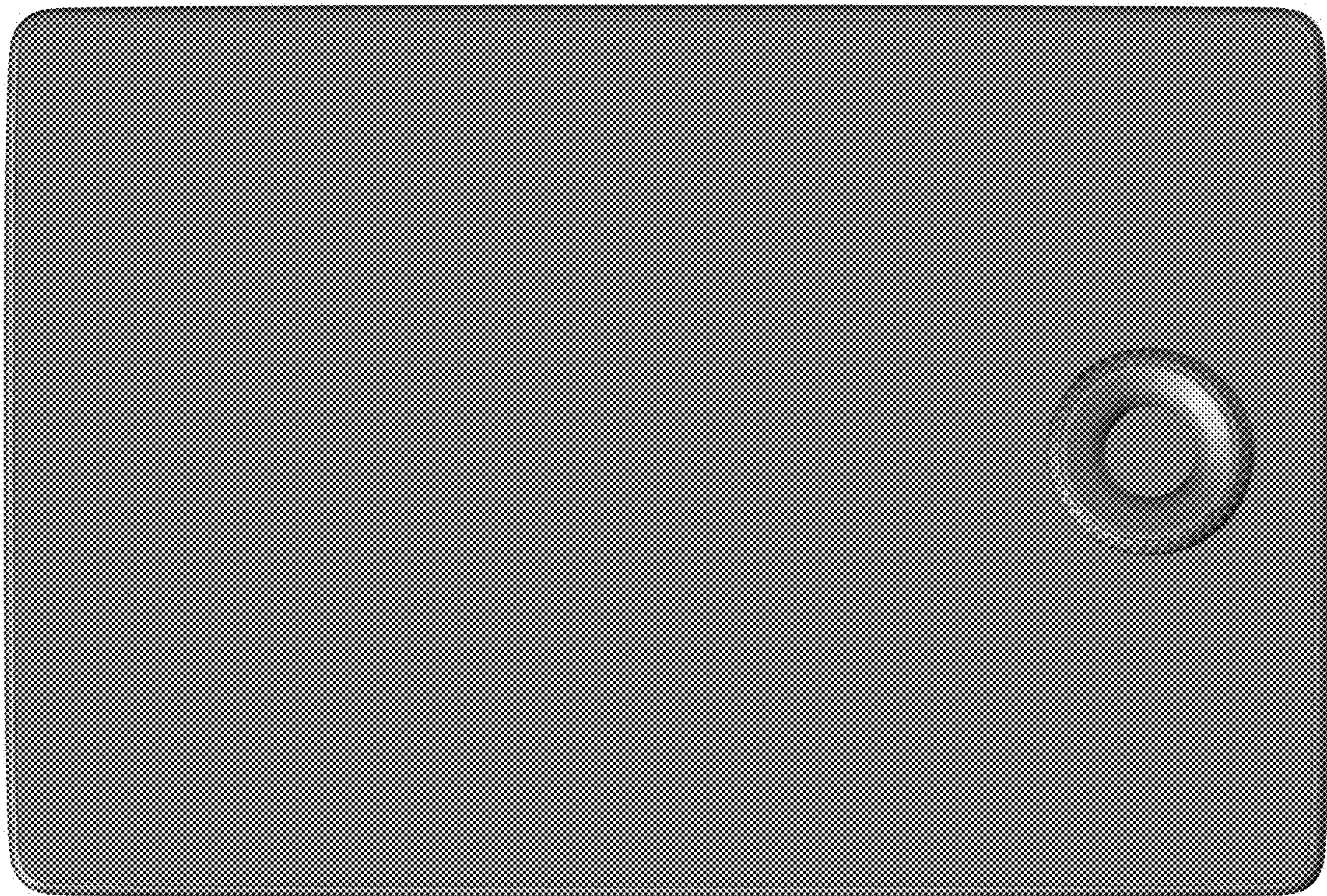

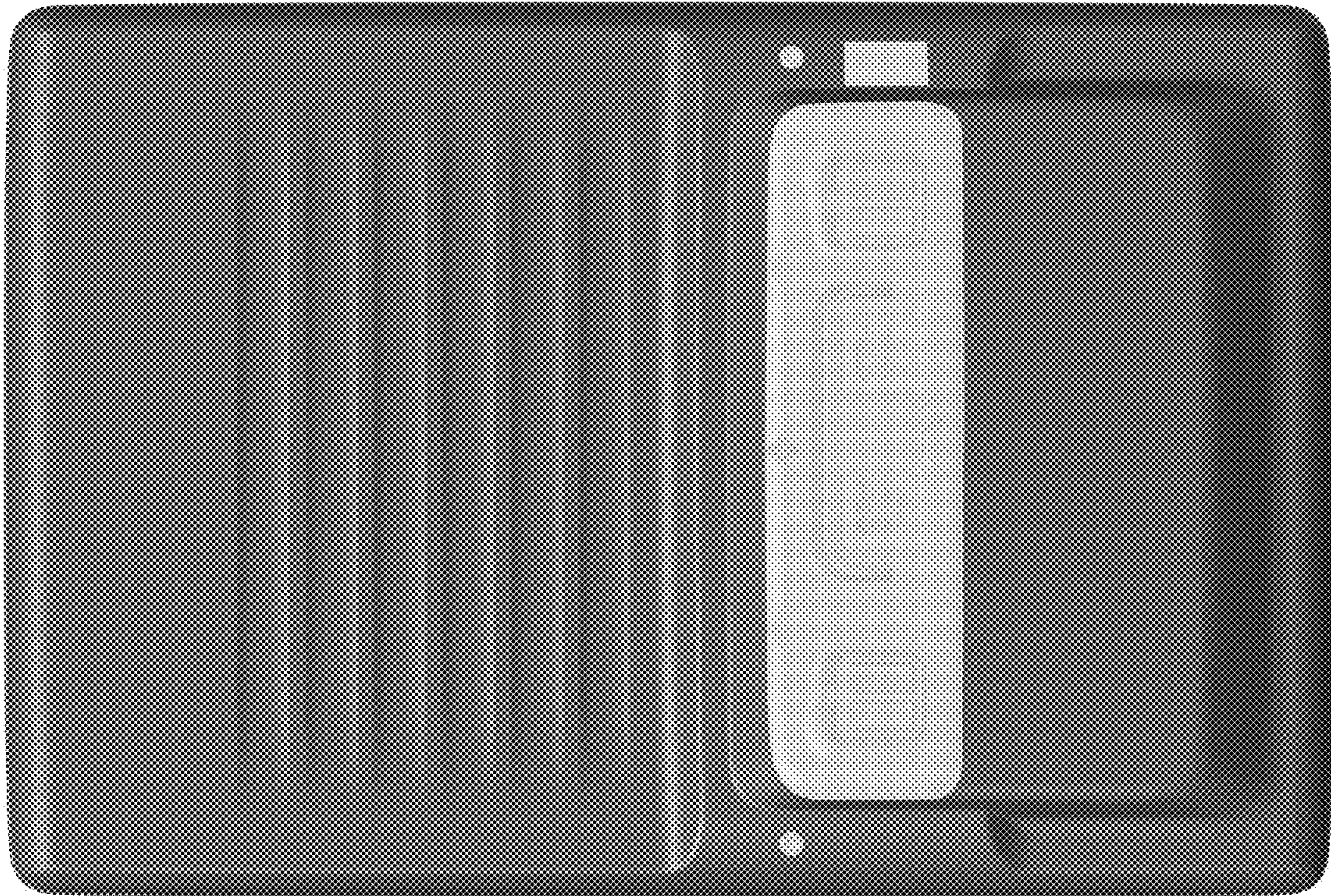
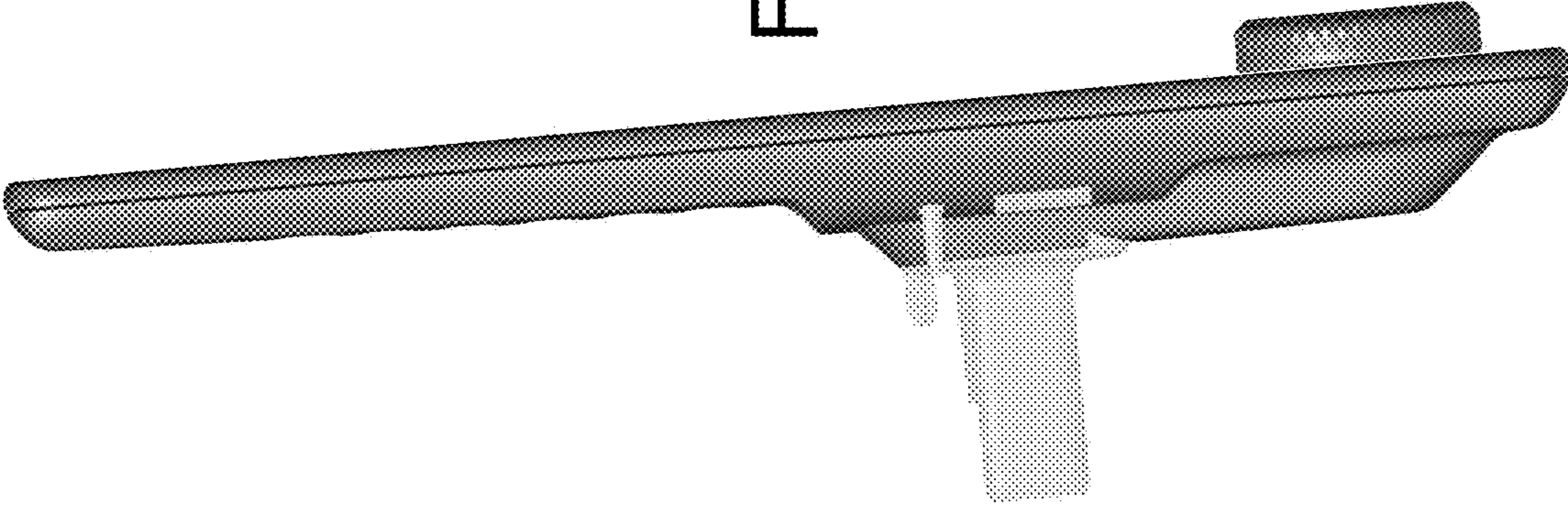

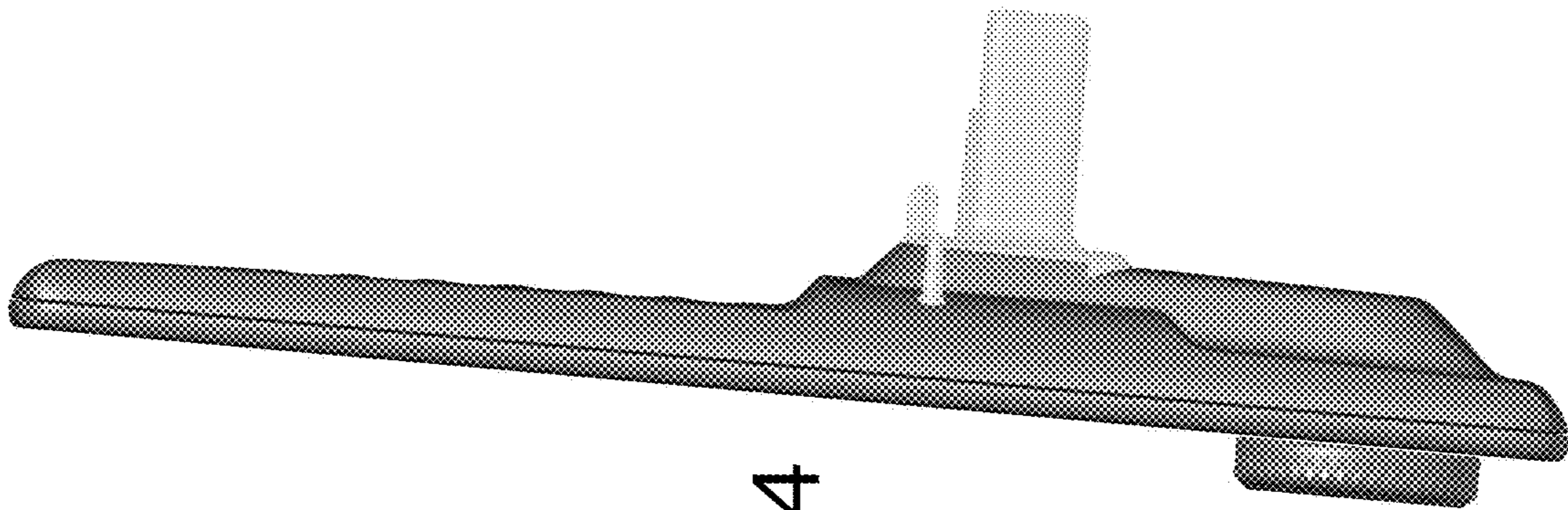

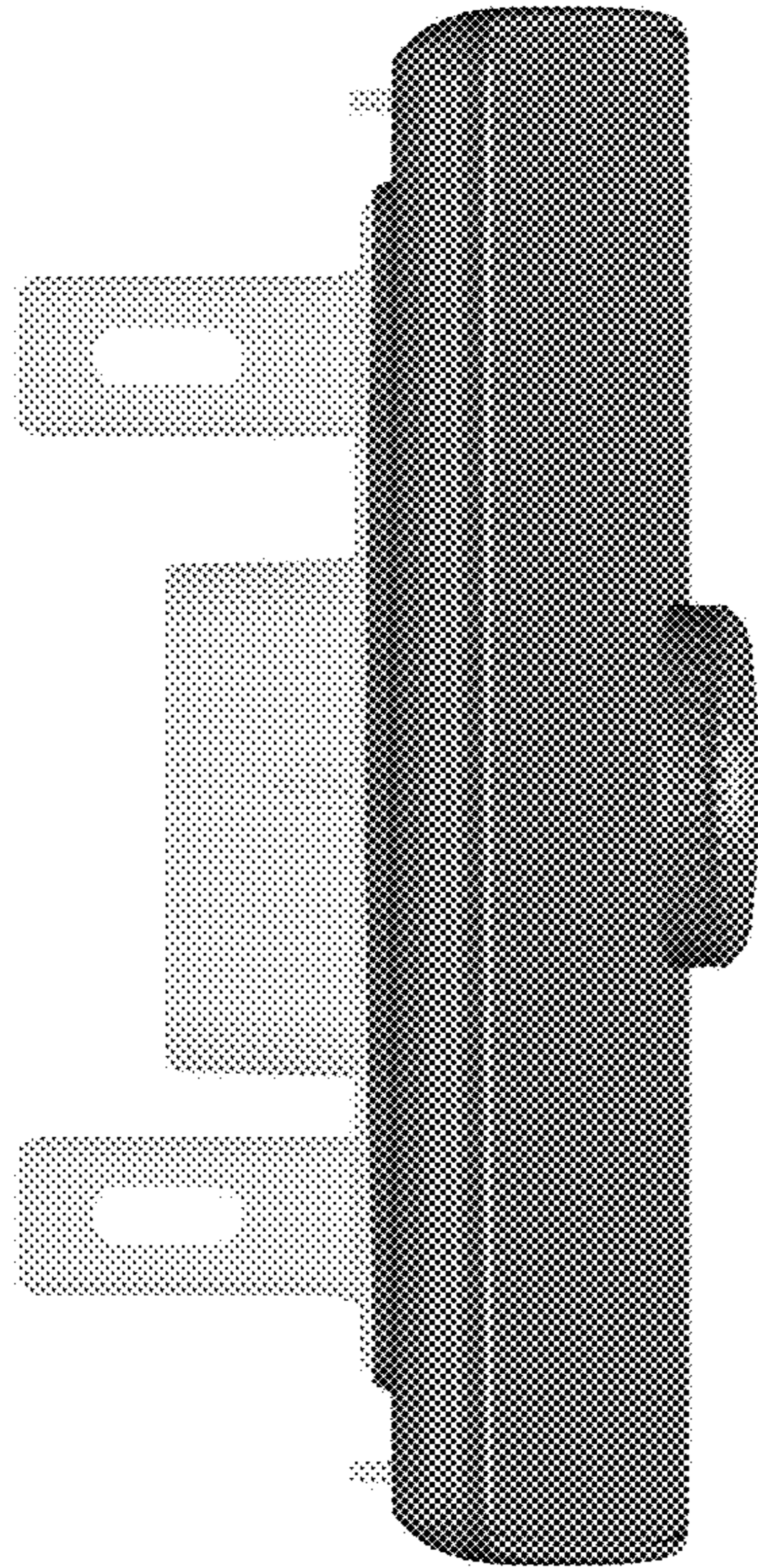

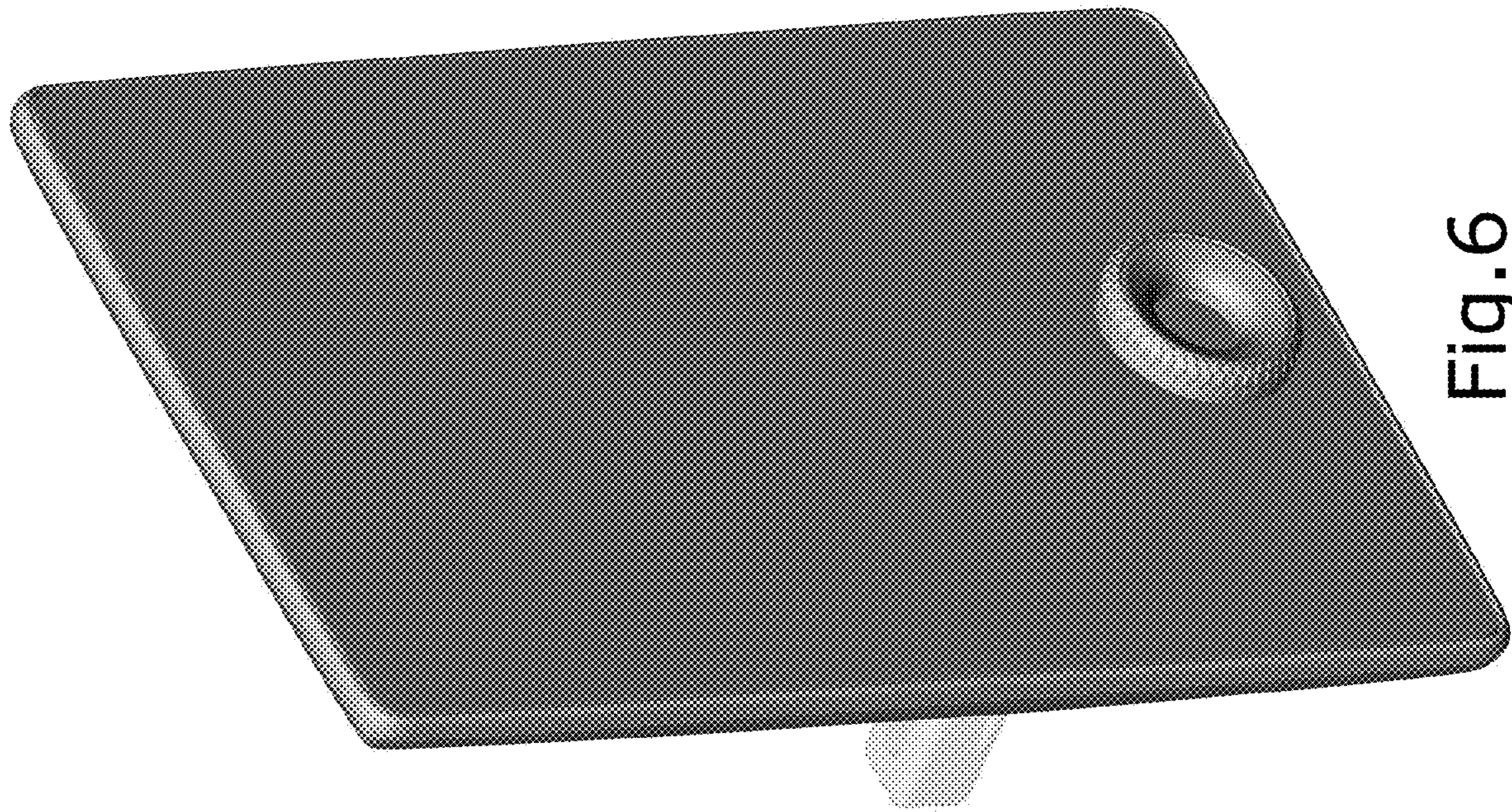

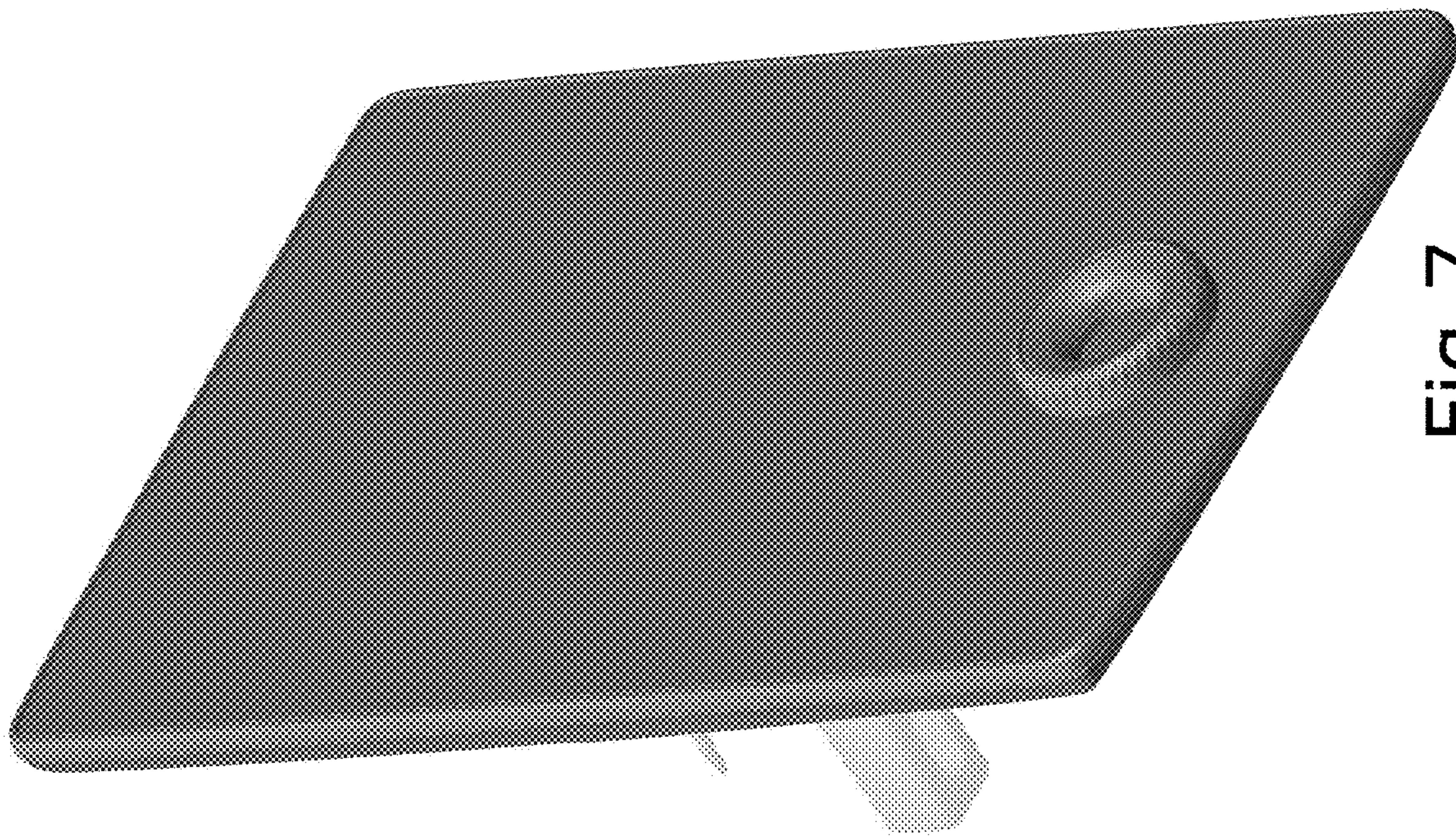
