The subject matter shown in broken lines, and any surfaces of the case not shown, including interior surfaces, form no part of the claimed design.

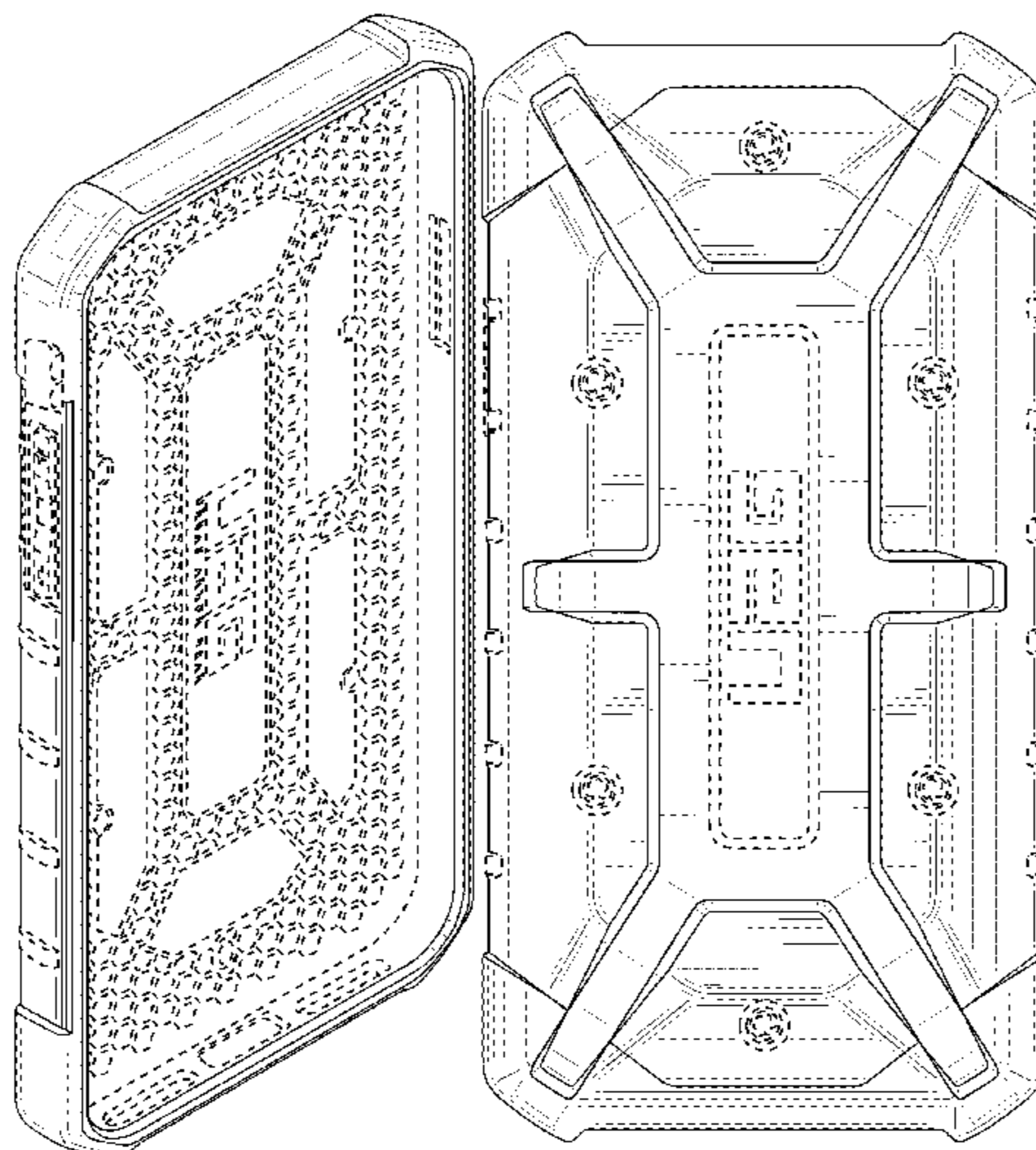

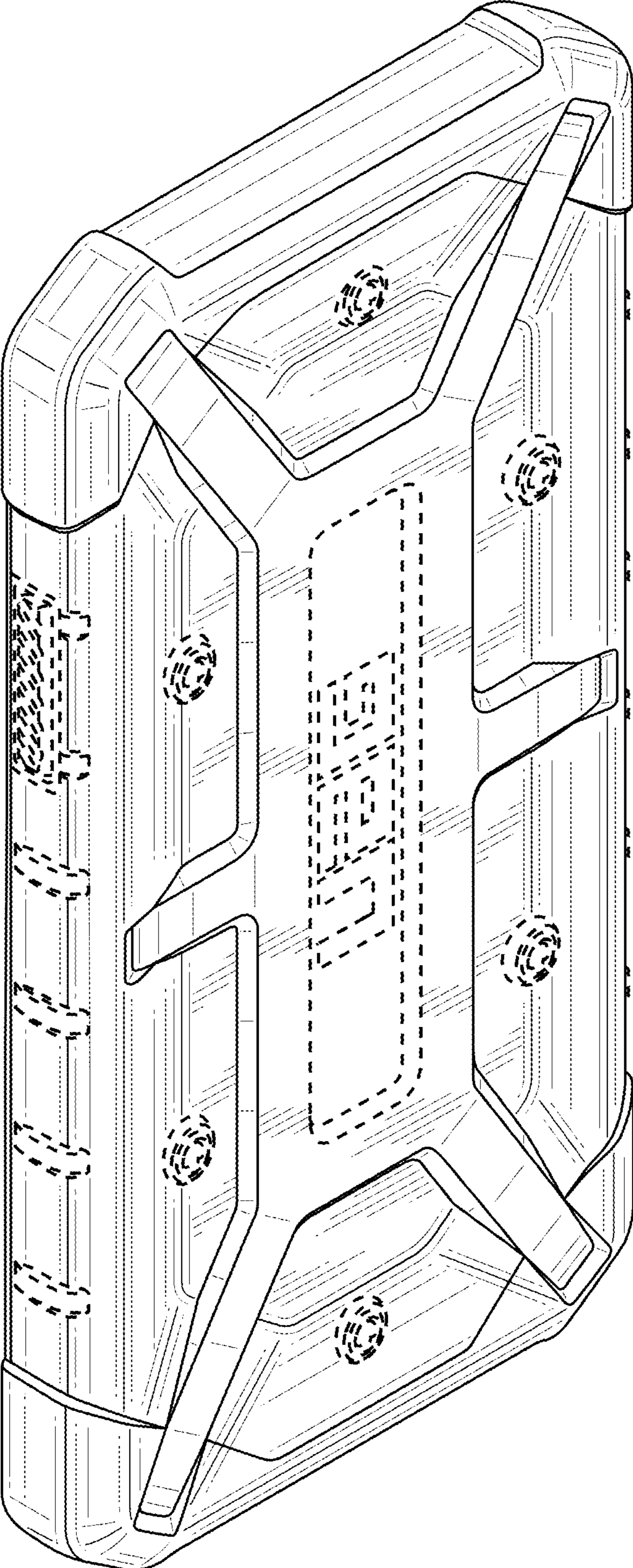

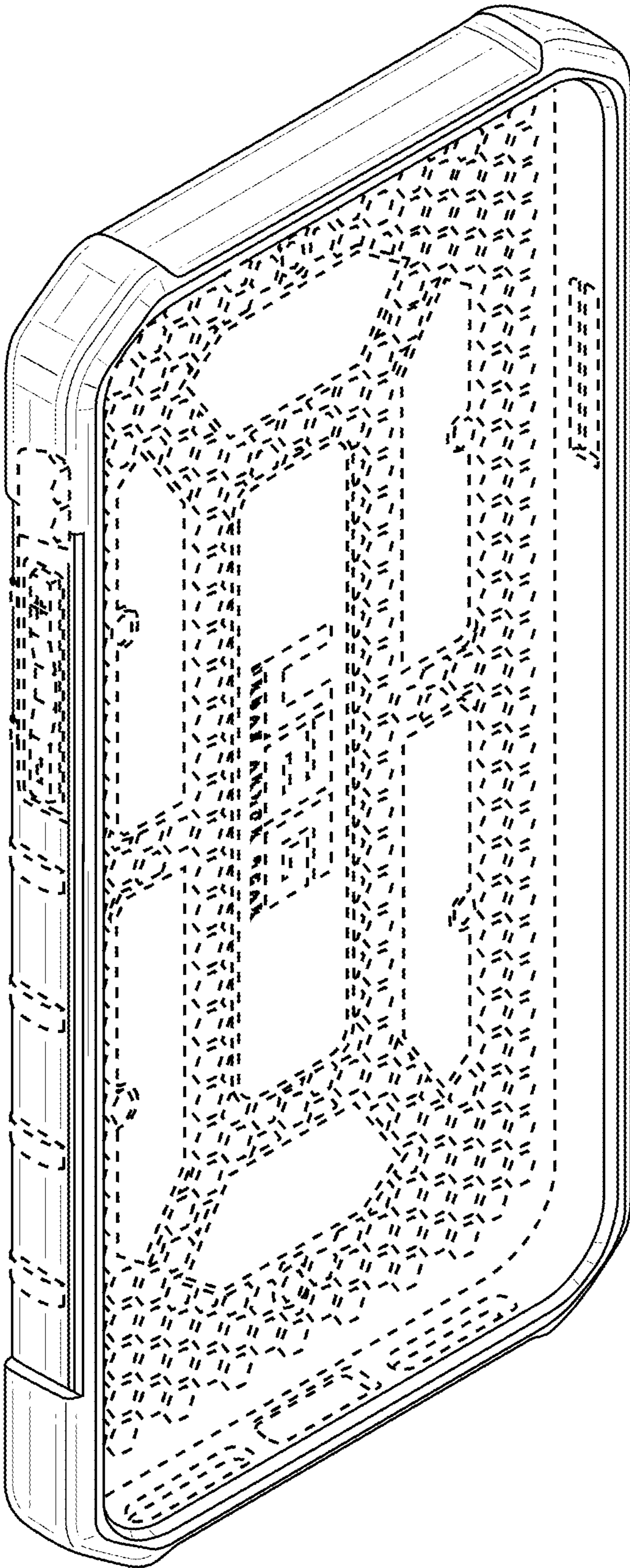

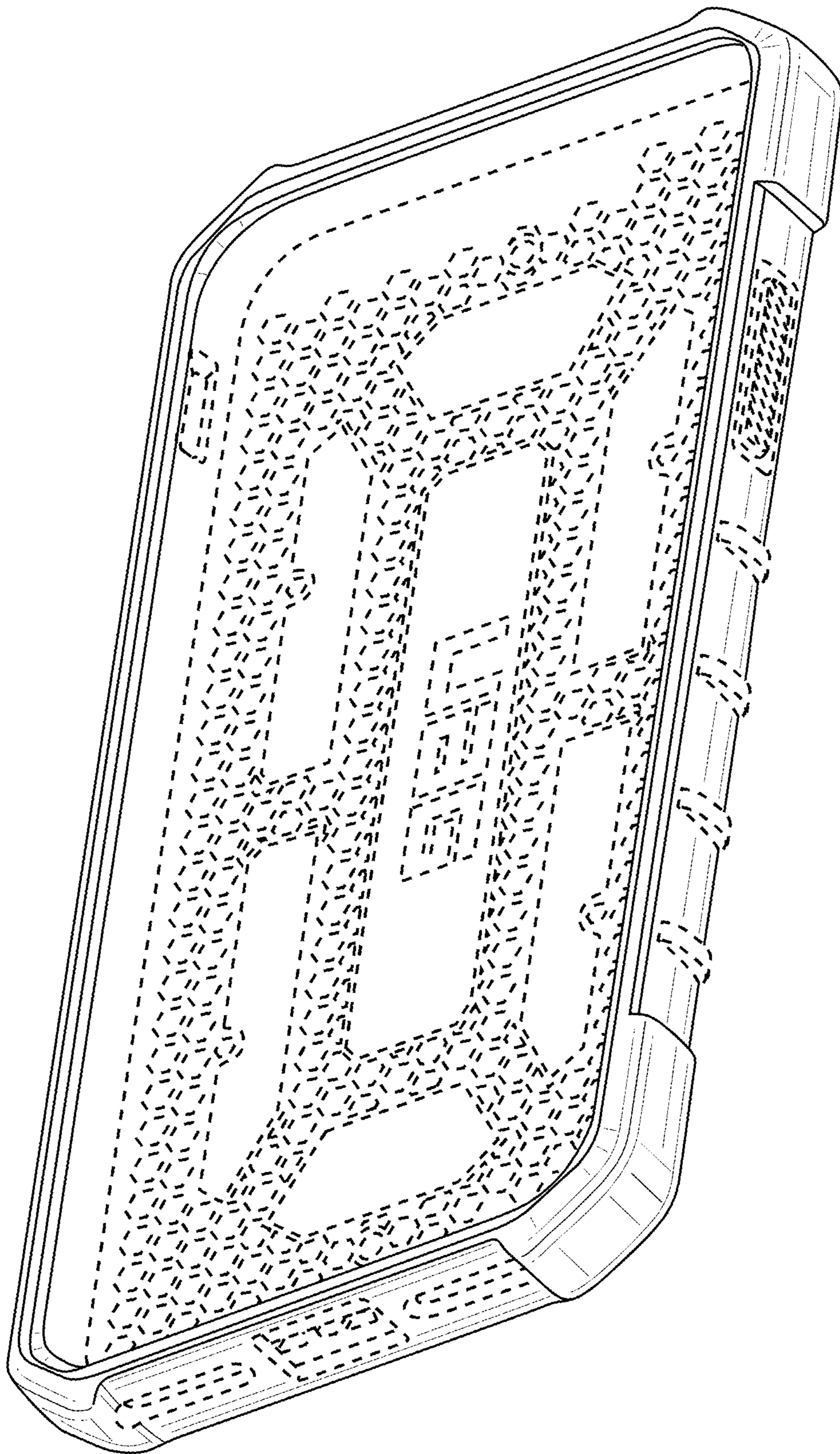

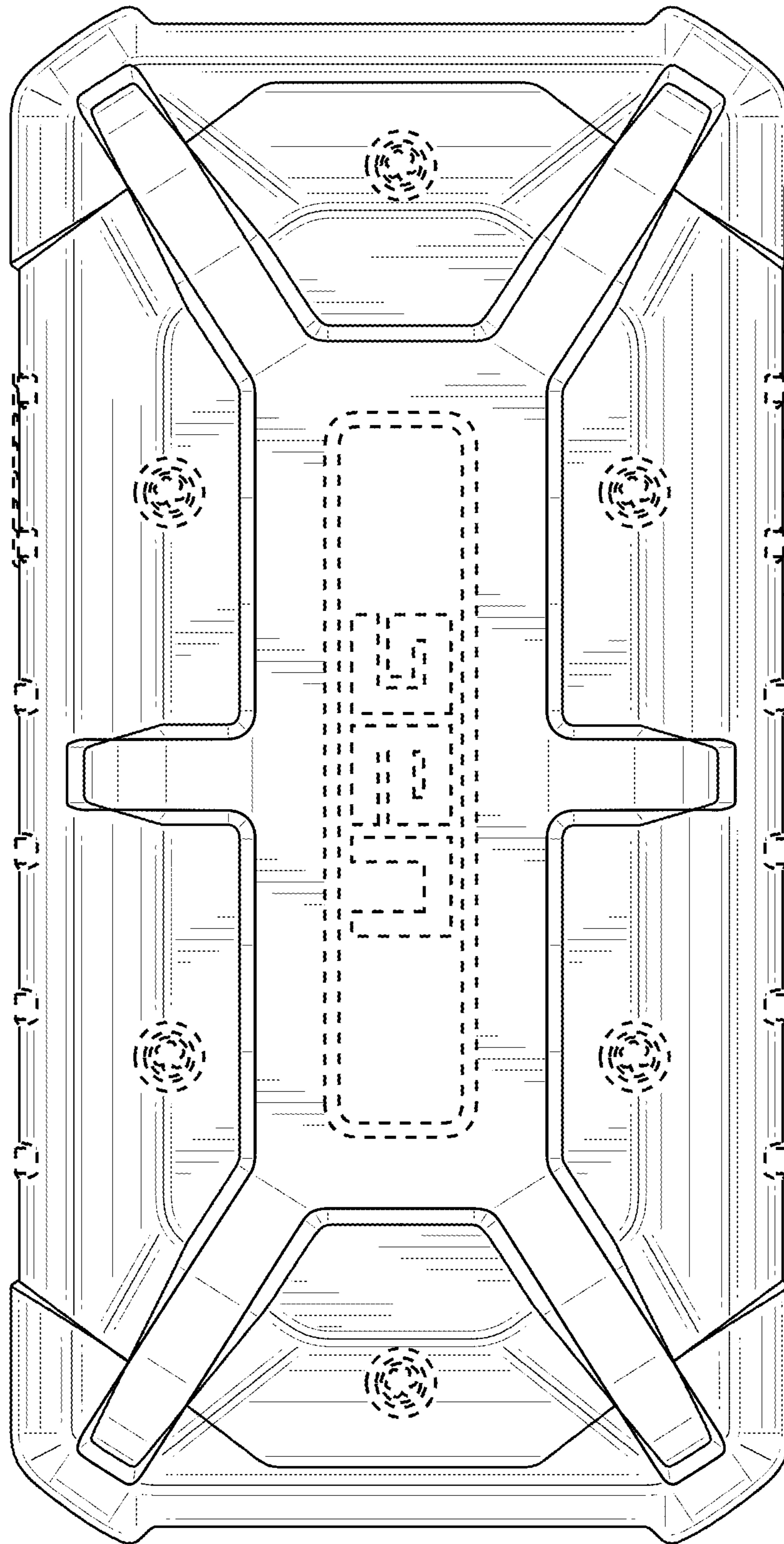

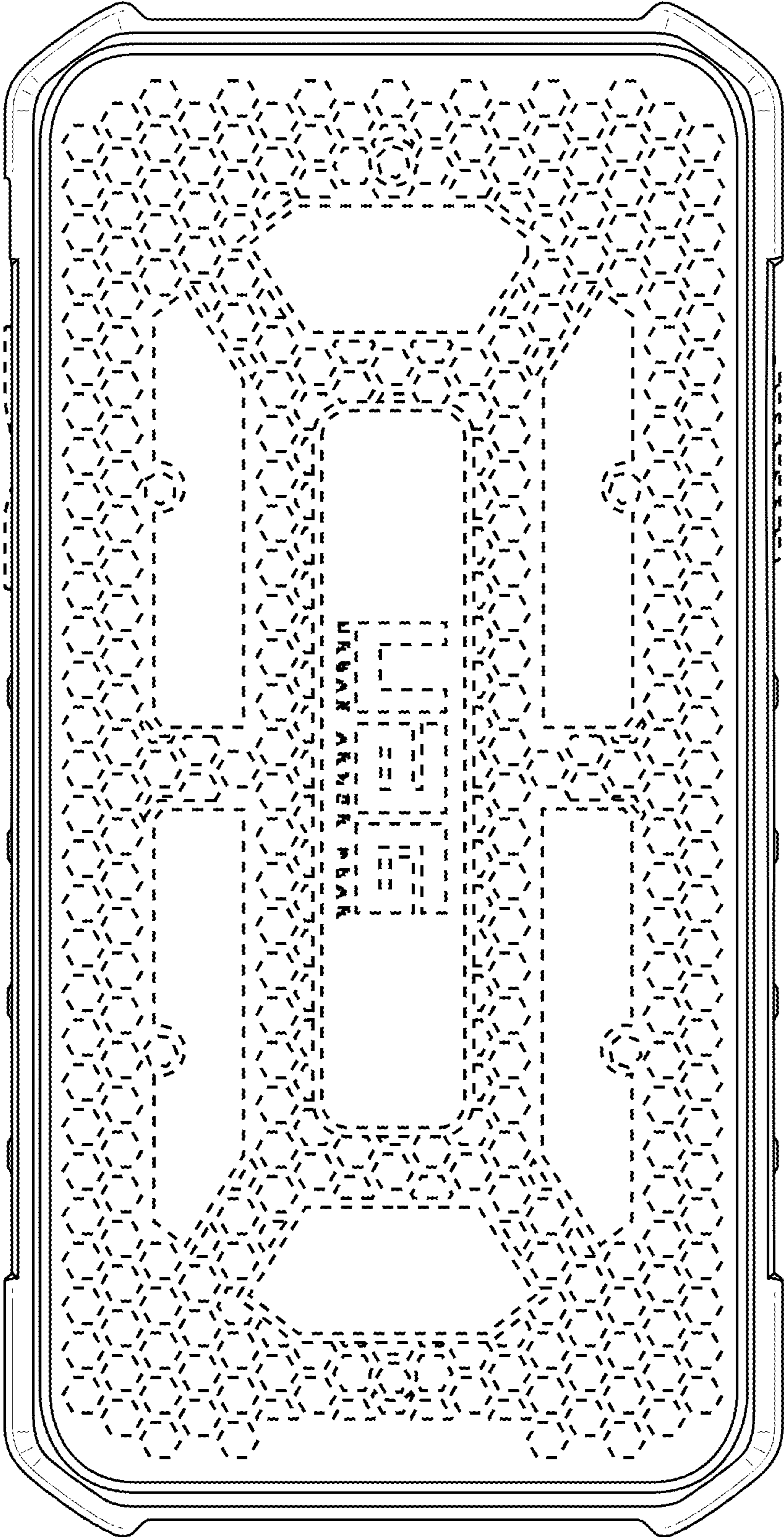

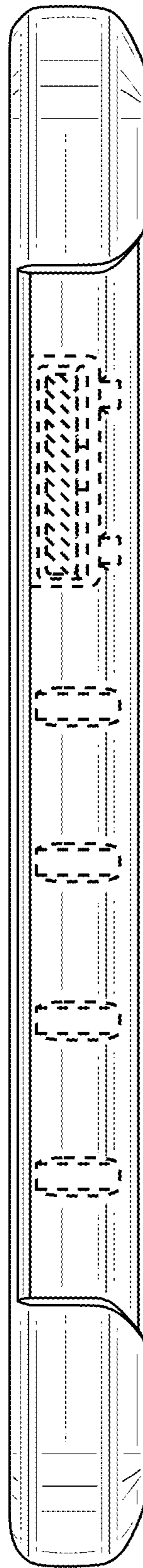

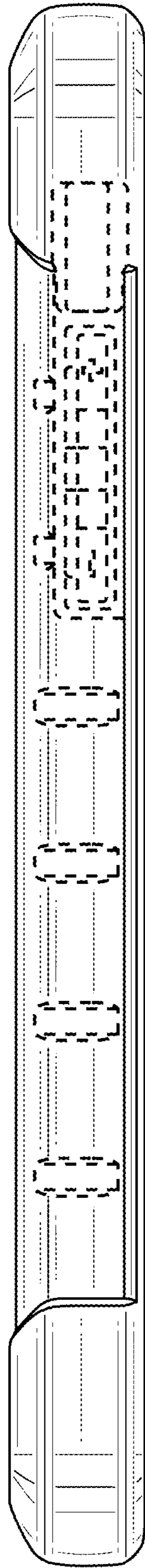

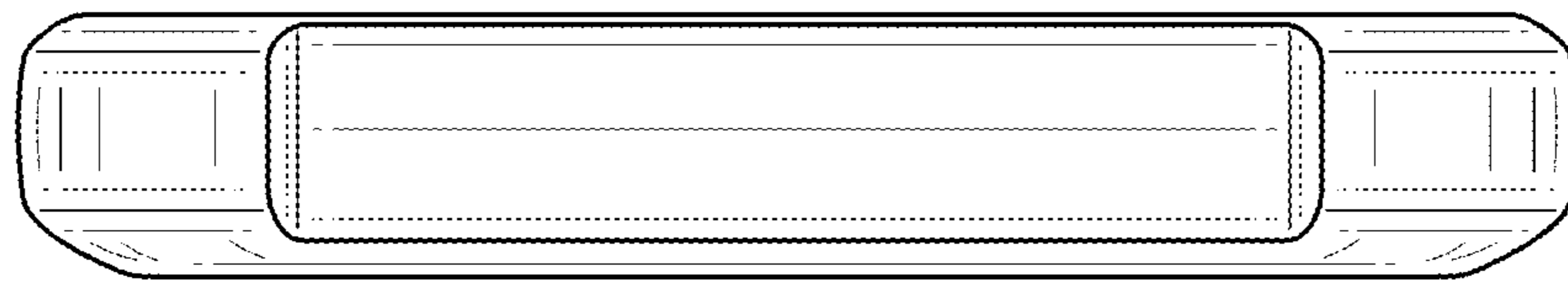

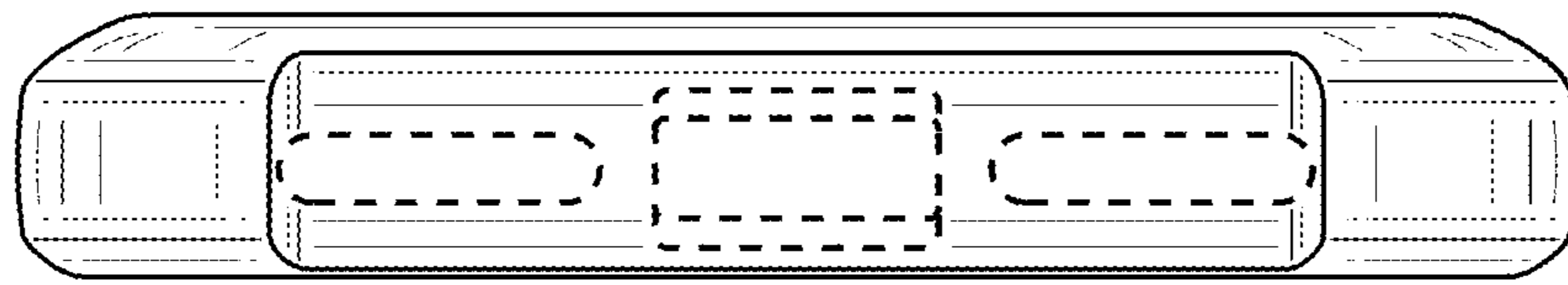
