(57) **CLAIM**

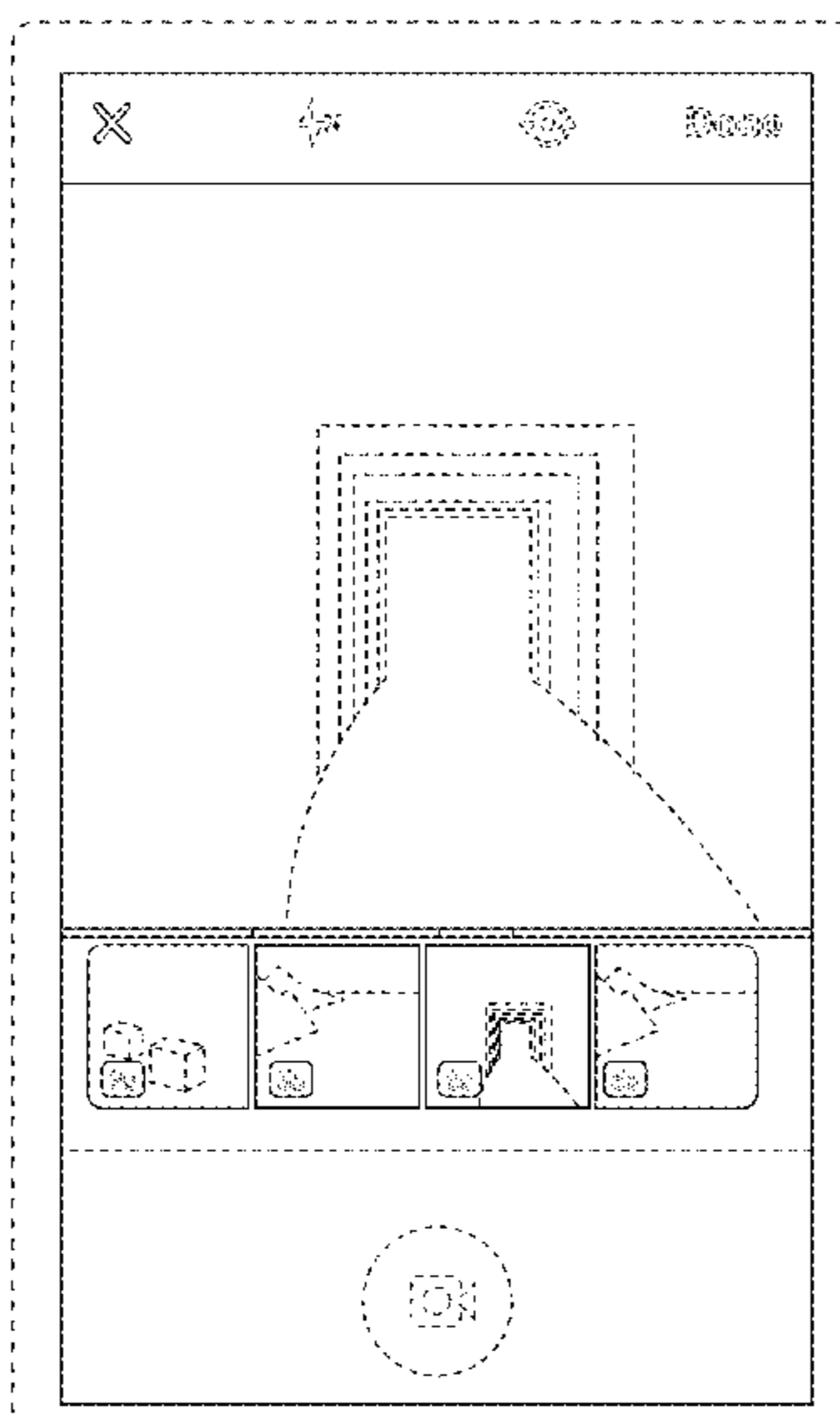
What is claimed is the ornamental design for a media sharing device with graphical user interface, as shown and described.

**DESCRIPTION**

The sole FIGURE is a front view of a media sharing device with graphical user interface.  
The outermost solid-line rectangle illustrates the perimeter of the display screen of a media sharing device. The broken lines outside this perimeter illustrates portions of the media sharing device and form no part of the claimed design. The remaining broken lines illustrate portions of a graphical user interface and form no part of the claimed design.
