(57) **CLAIM**

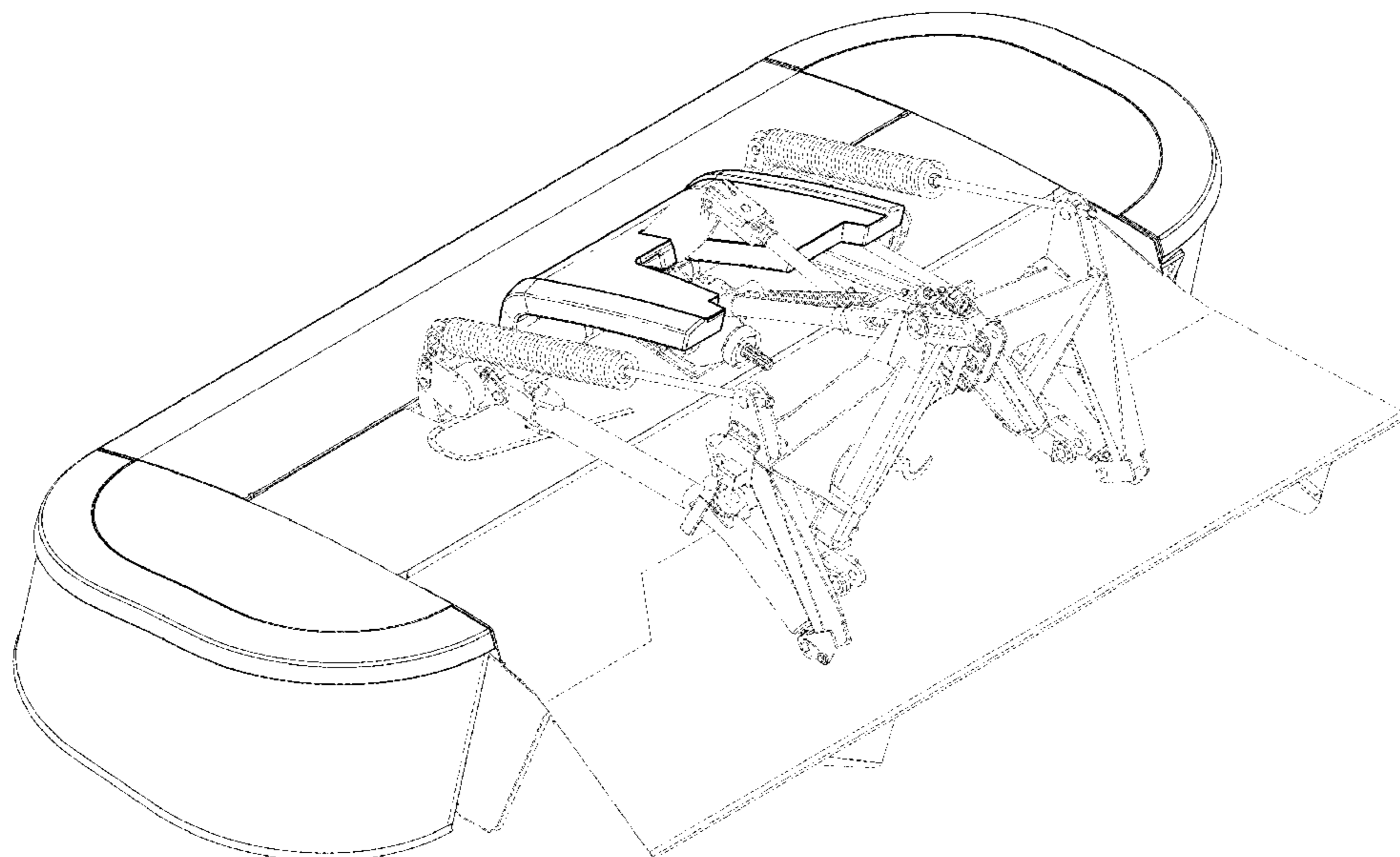
The ornamental design for a combination agricultural suspension and mower units, as shown and described.

**DESCRIPTION**

FIG. 1 is an upper, left, rear perspective view of a combination agricultural suspension and mower units, showing my new design;

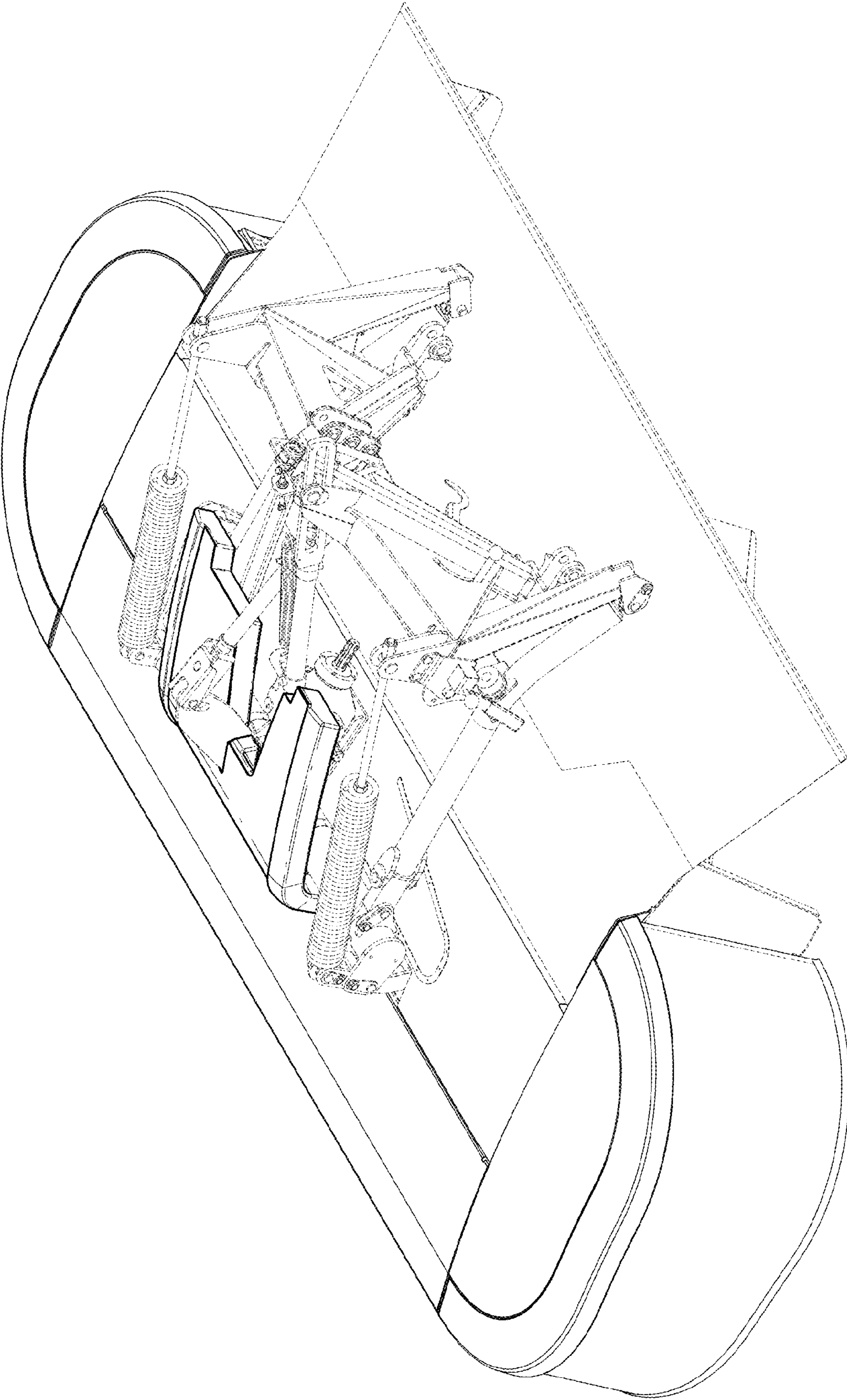
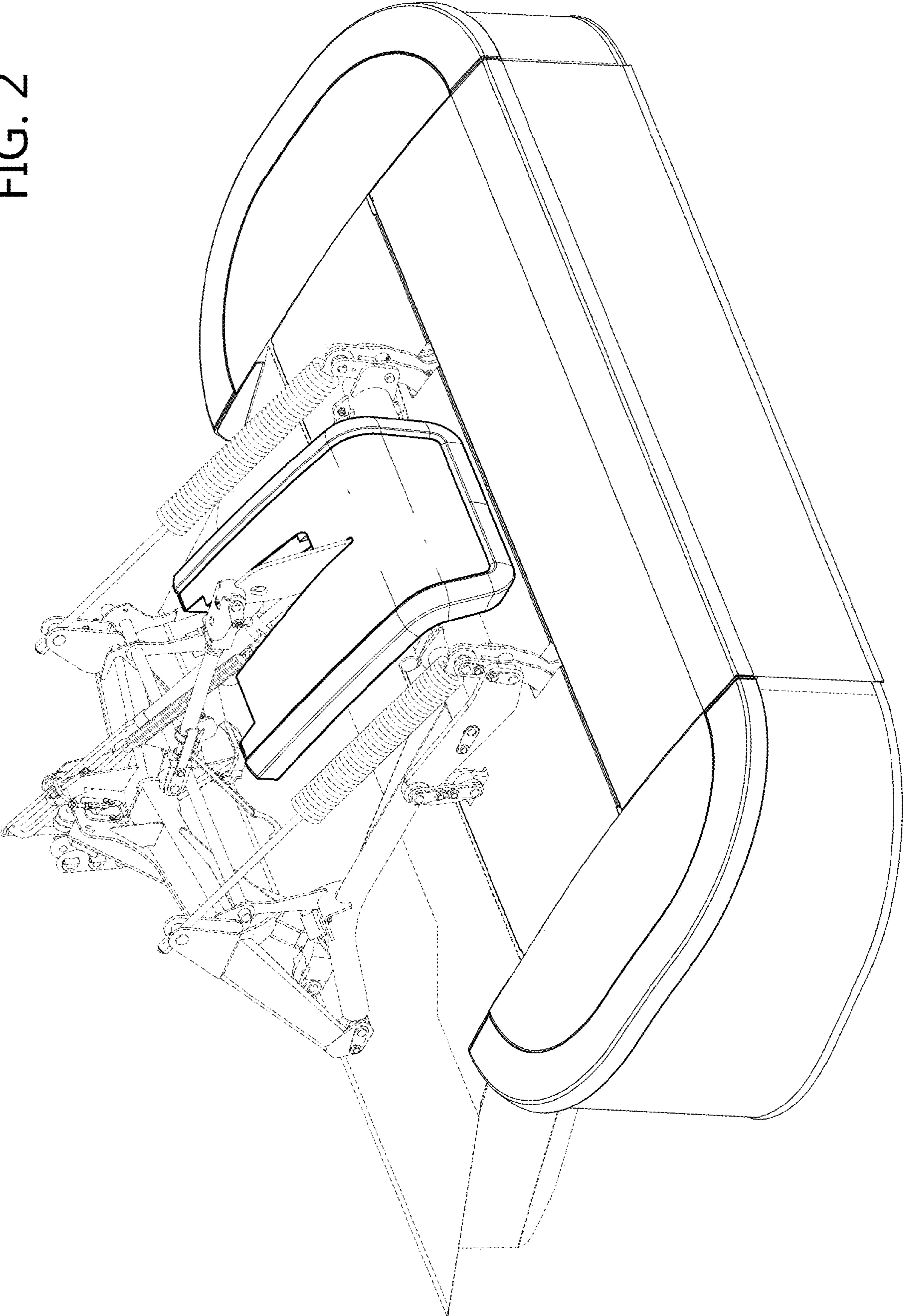

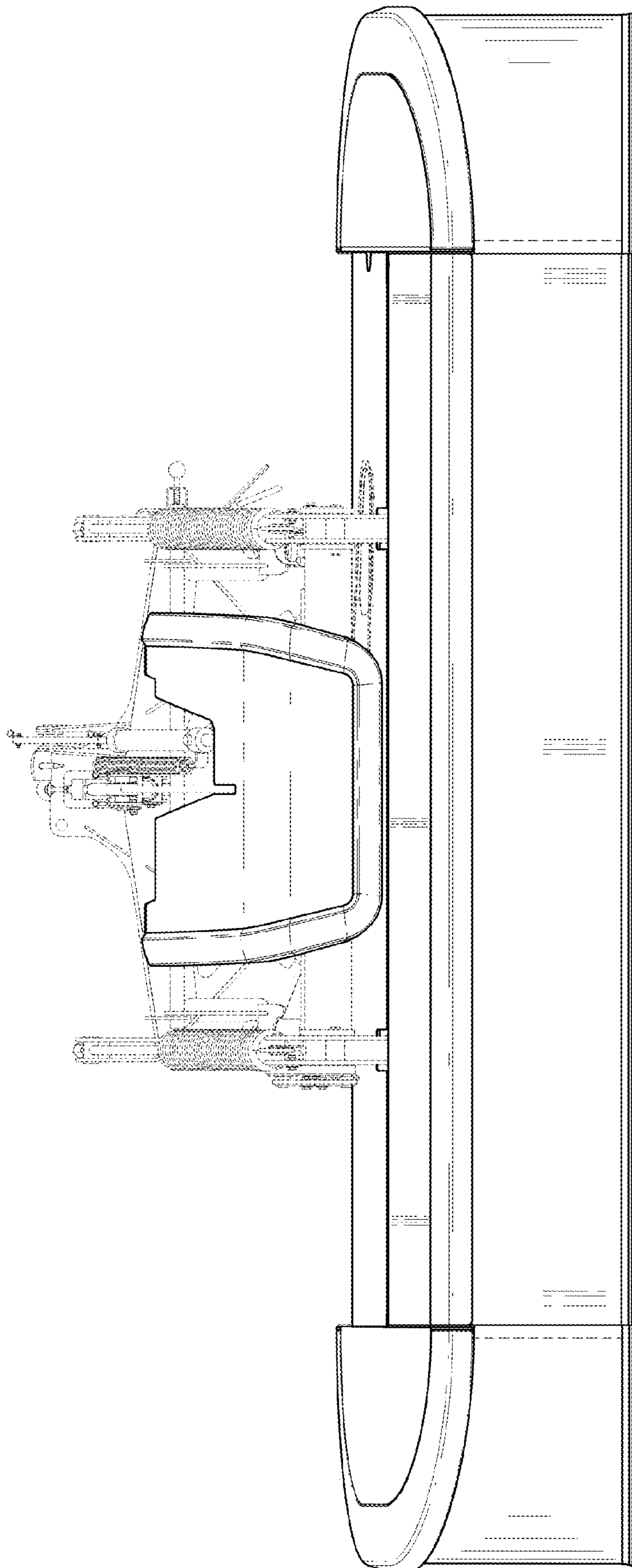

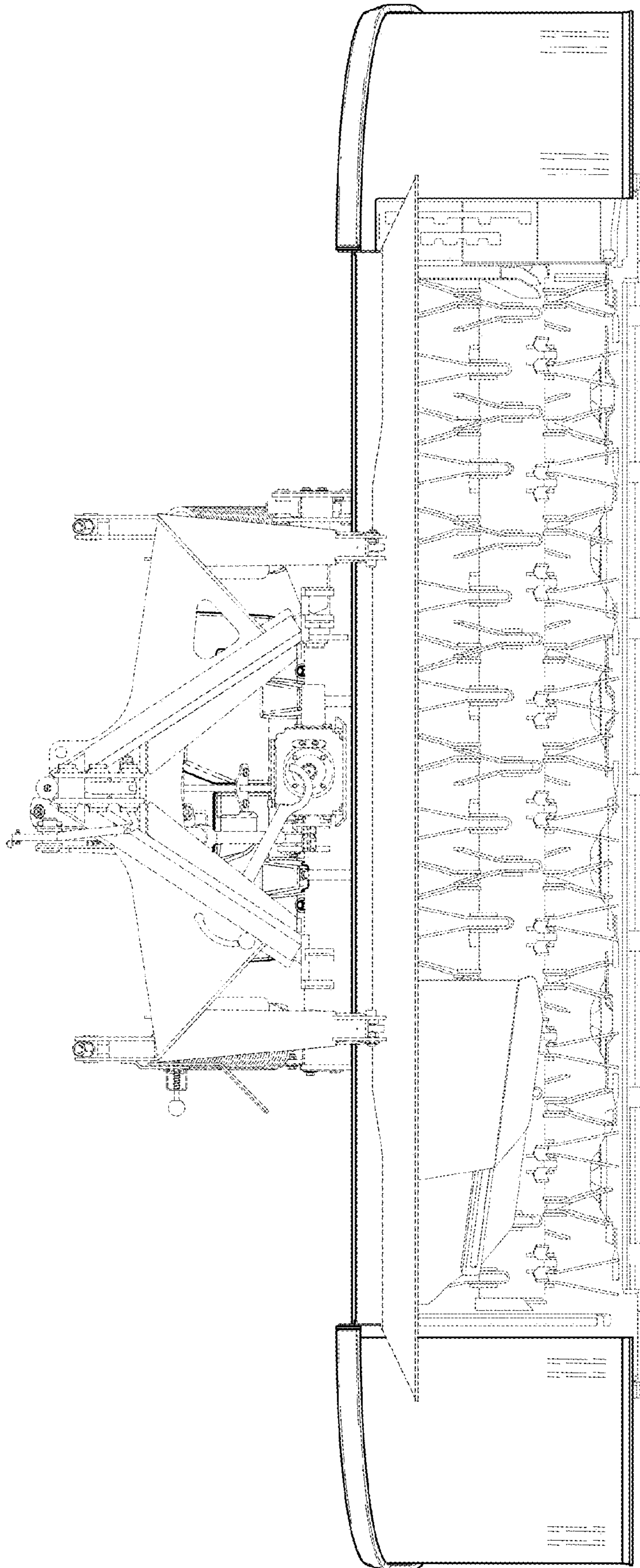

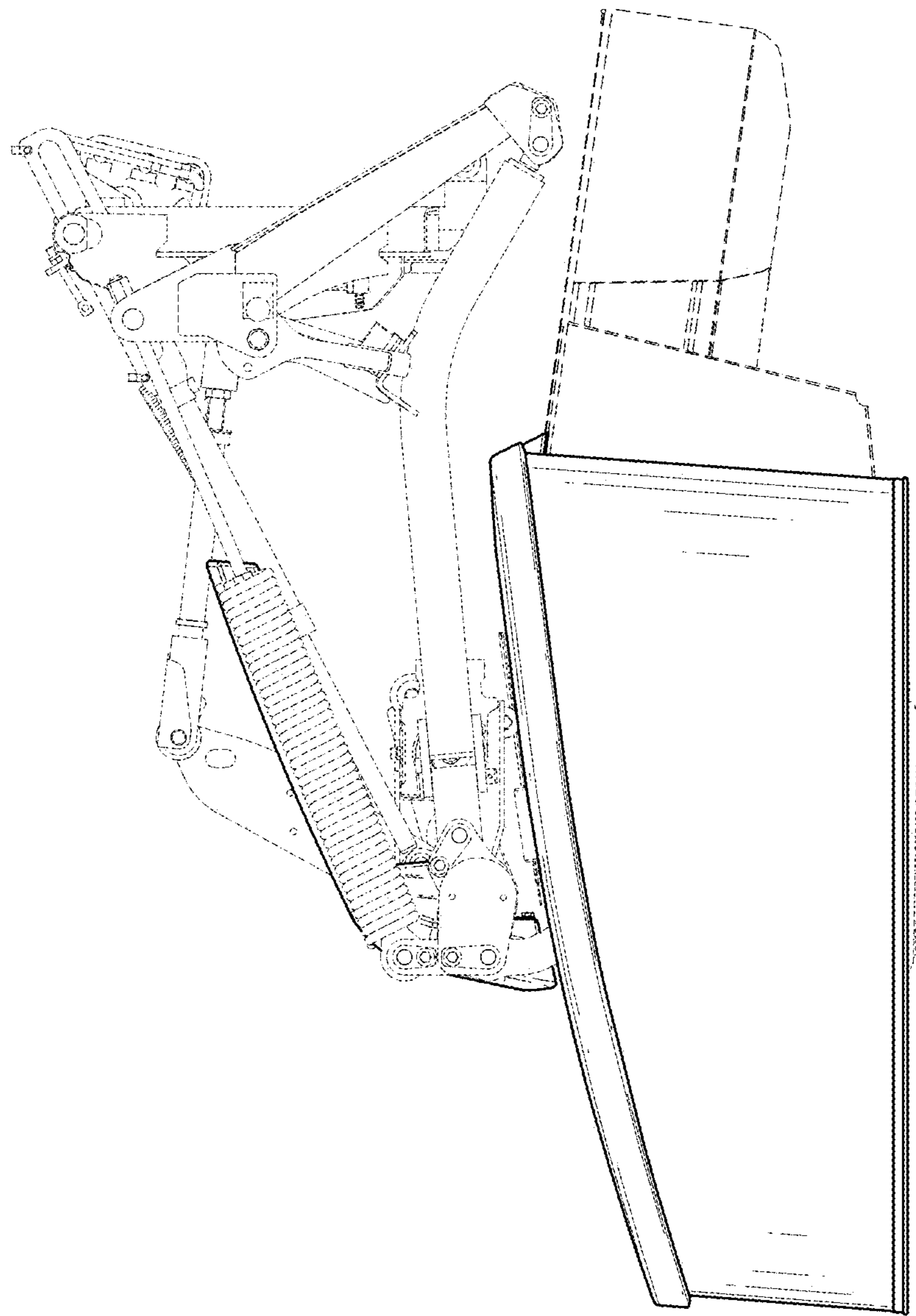

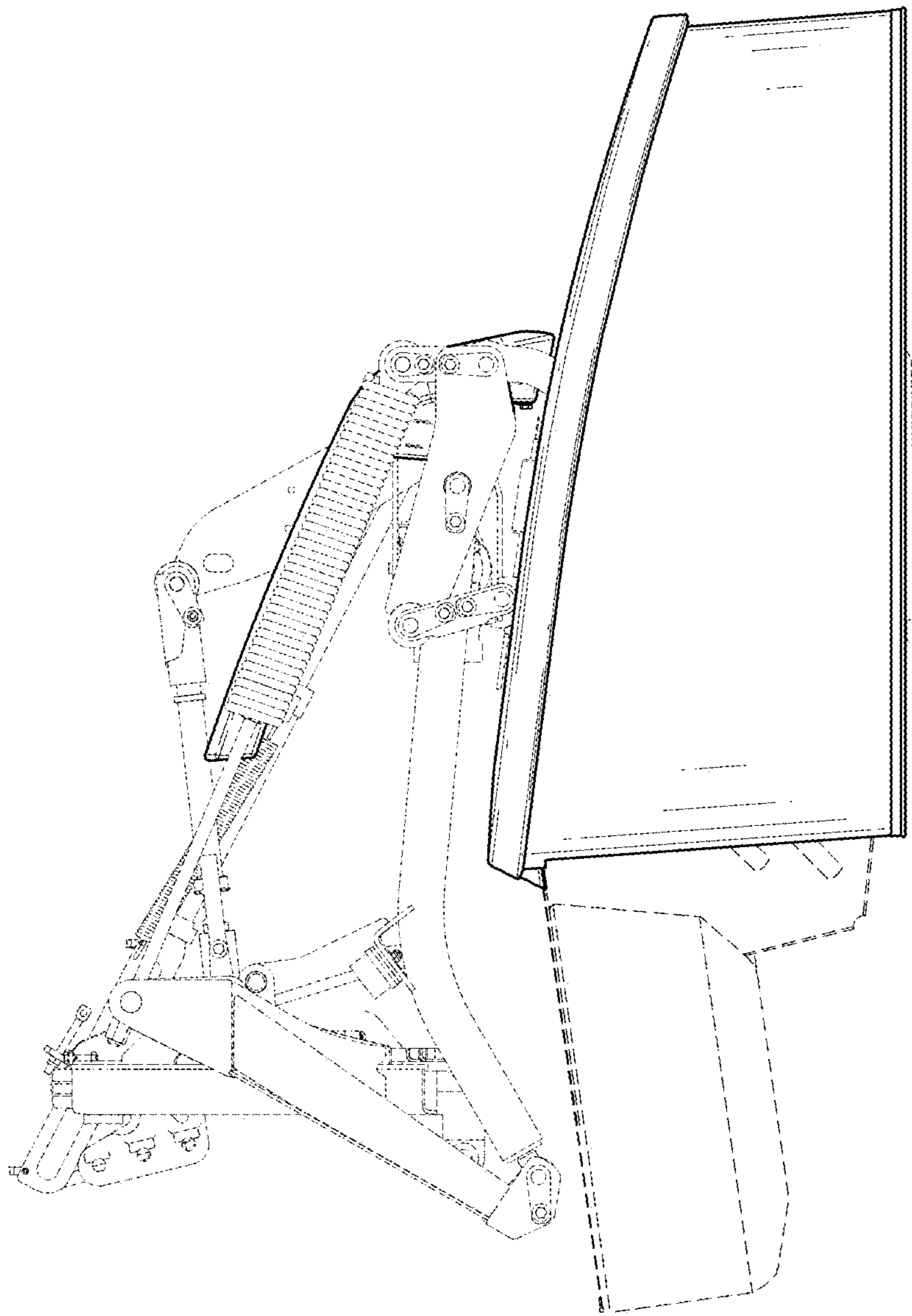
