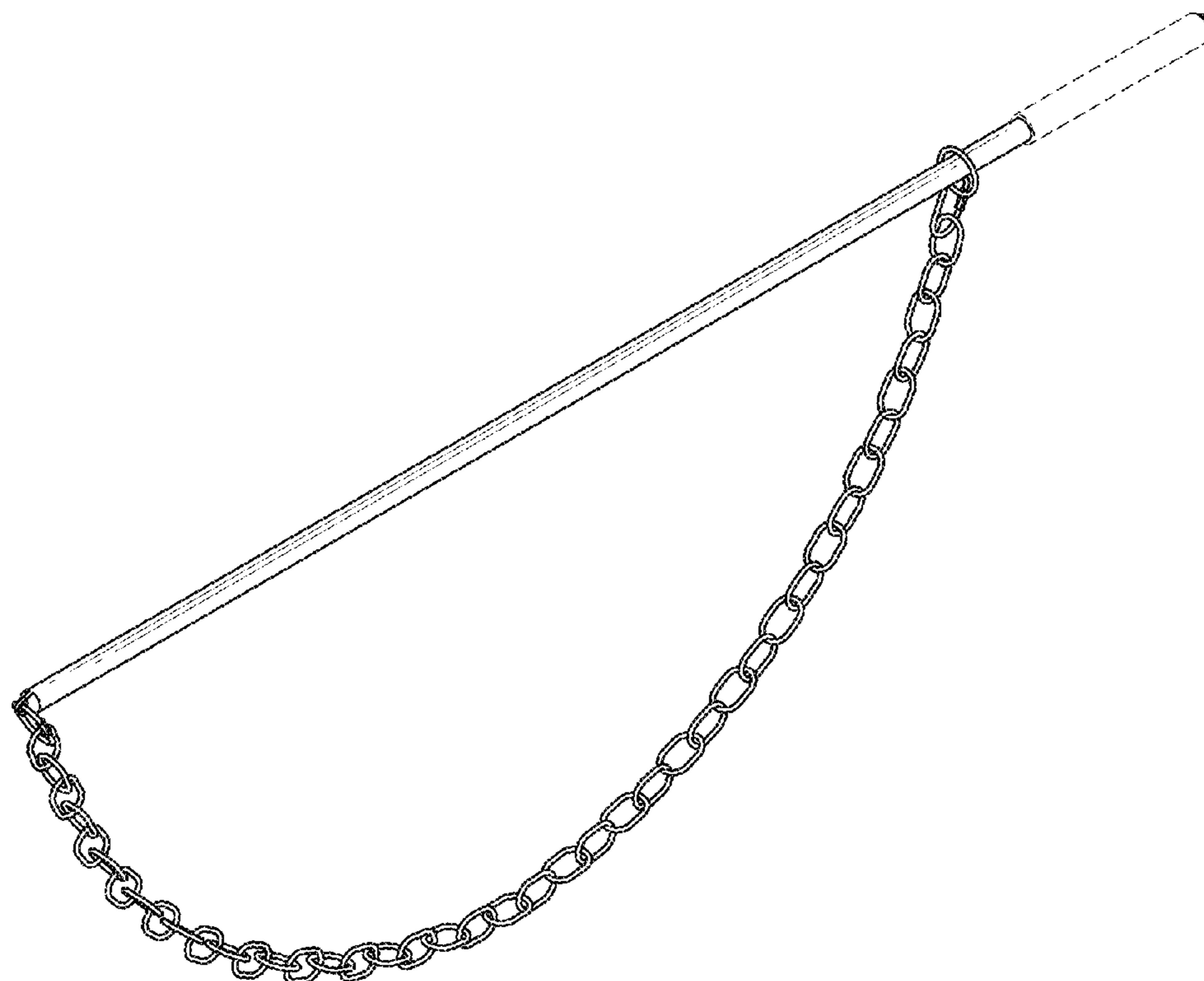
(57) **CLAIM**

The ornamental design for a fish tailer, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a fish tailer according to the present design;

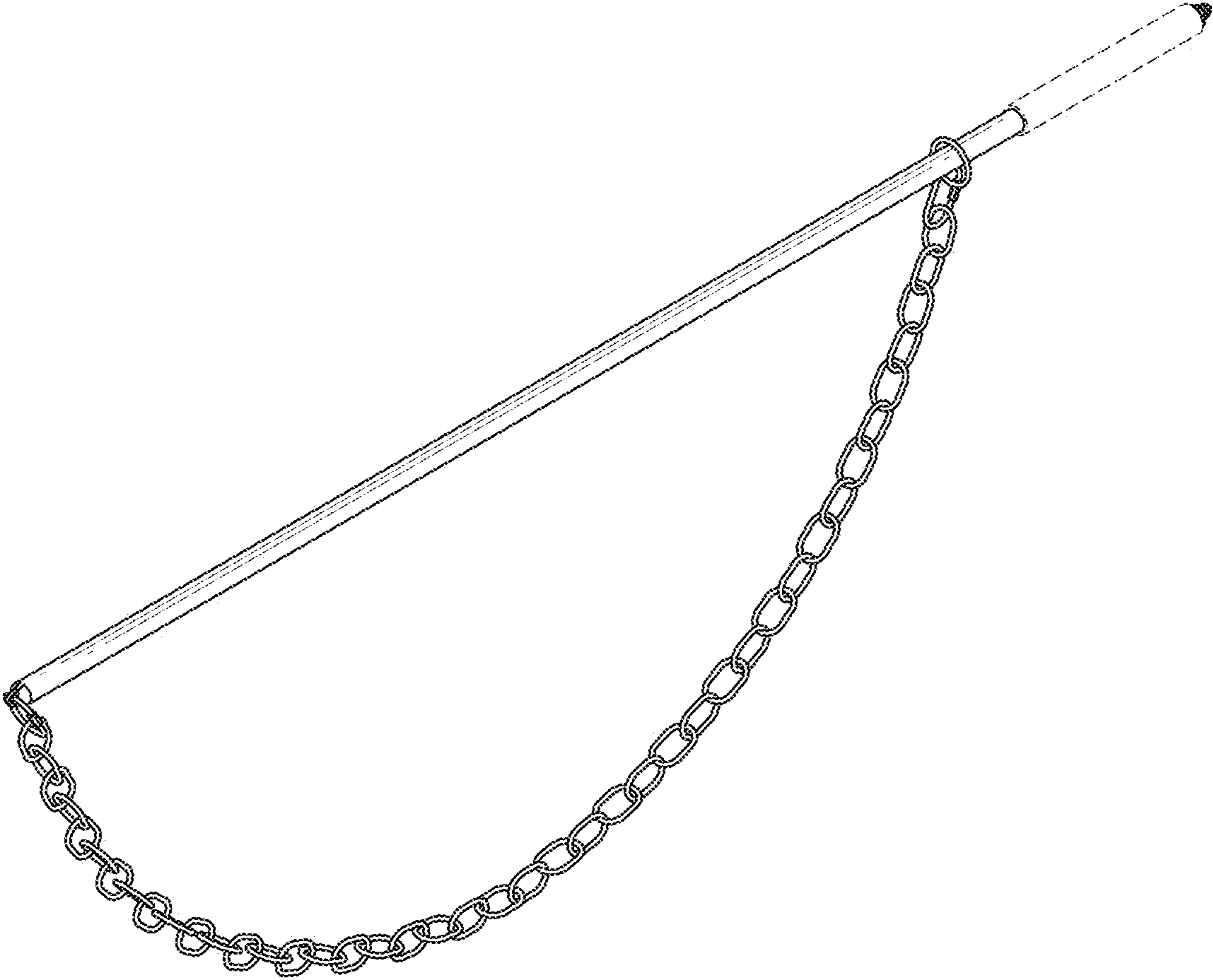

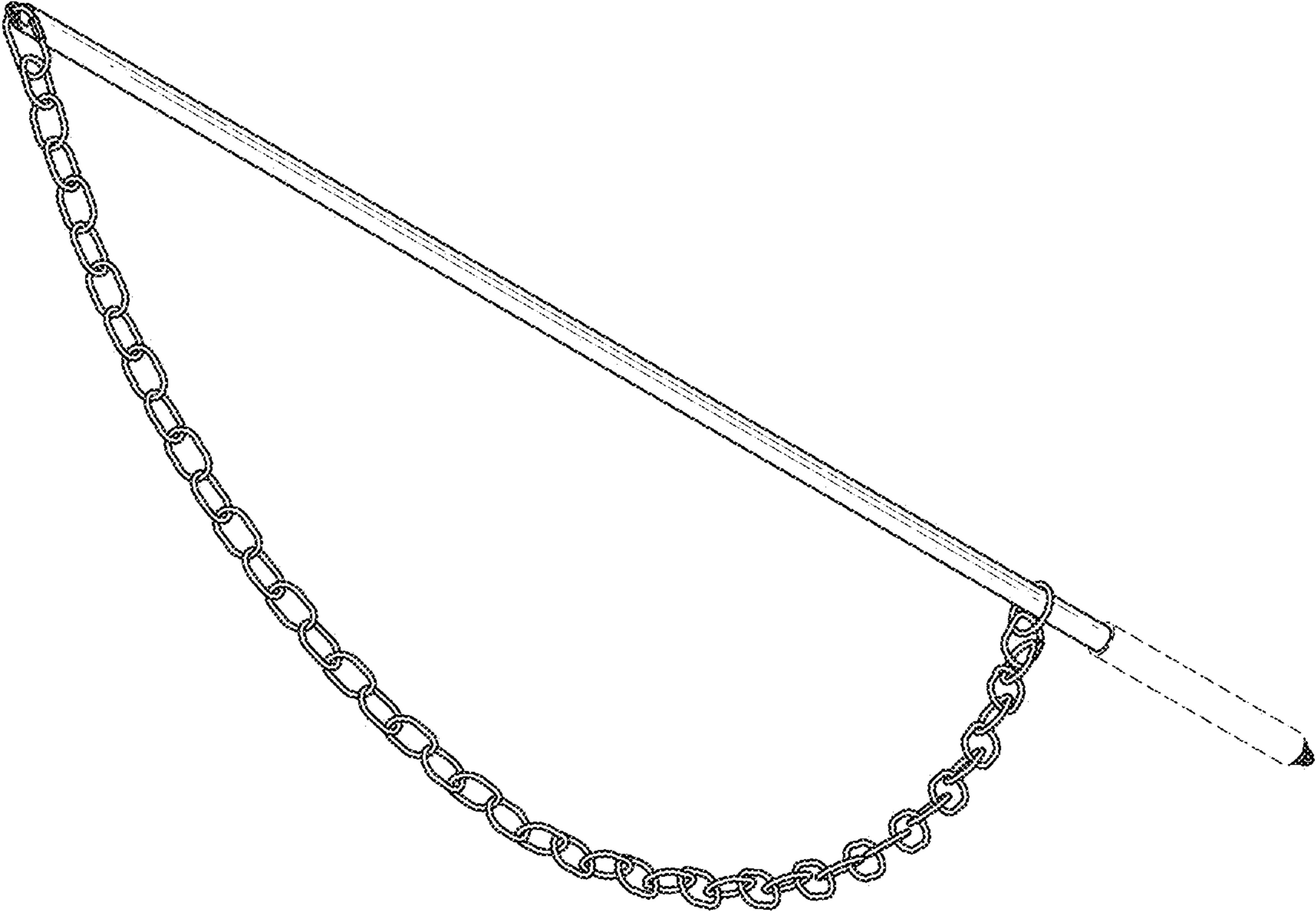

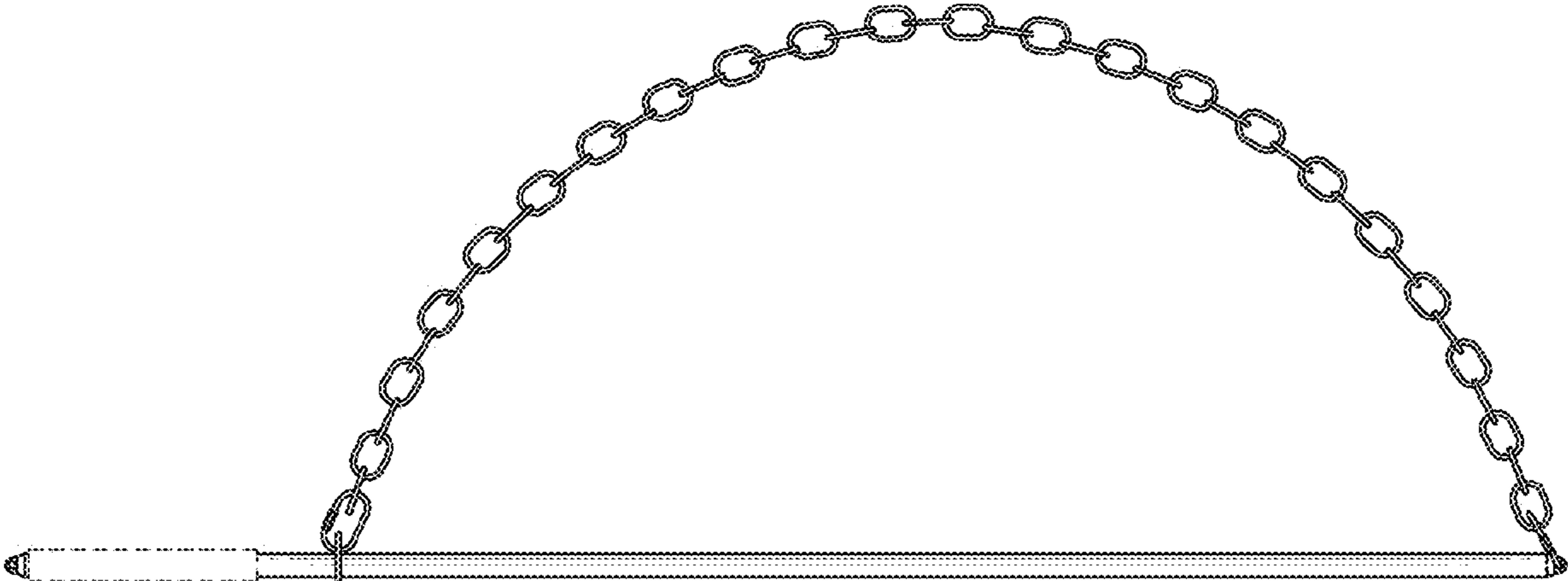

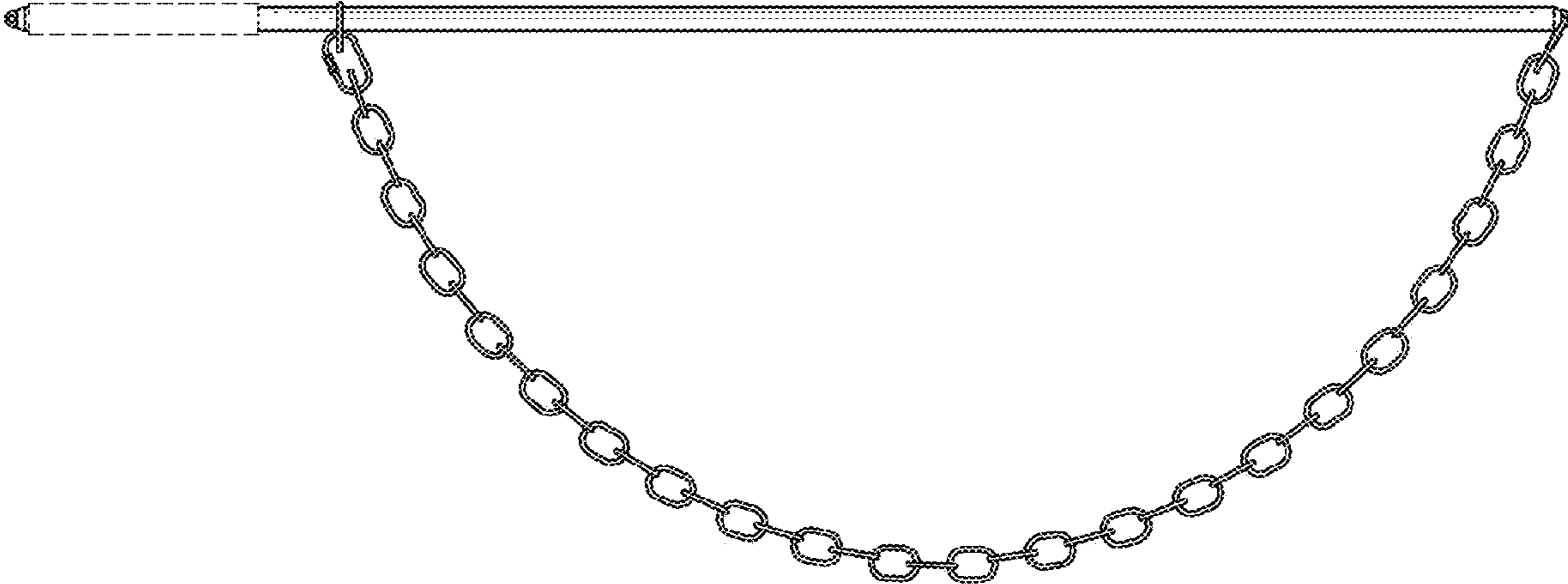
