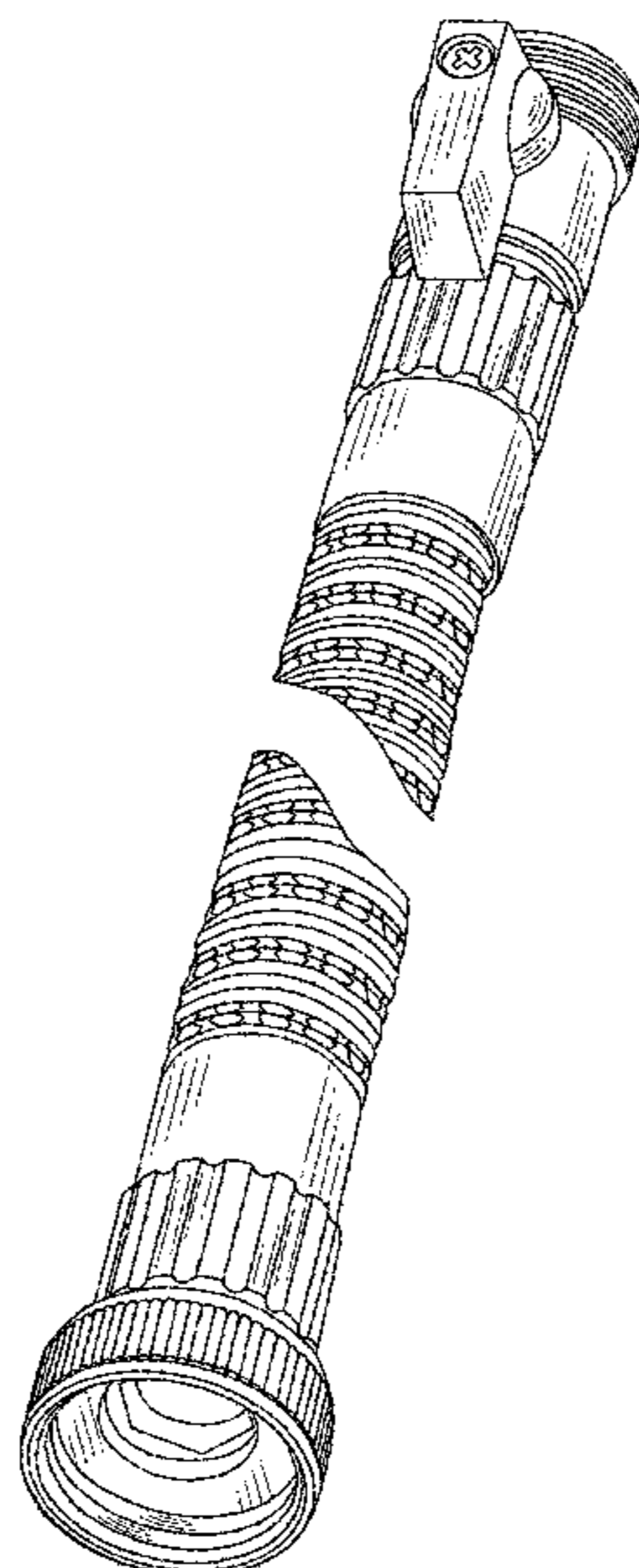

FIG. 1 is a perspective view of a hose showing my new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a left side elevation view thereof;
FIG. 5 is a right side elevation view thereof;
FIG. 6 is top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.
The hose is shown with a symbolic break in its length. The appearance of any portion of the hose between the break lines forms no part of the claim.
The broken lines depict portions of the hose that form no part of the claim.

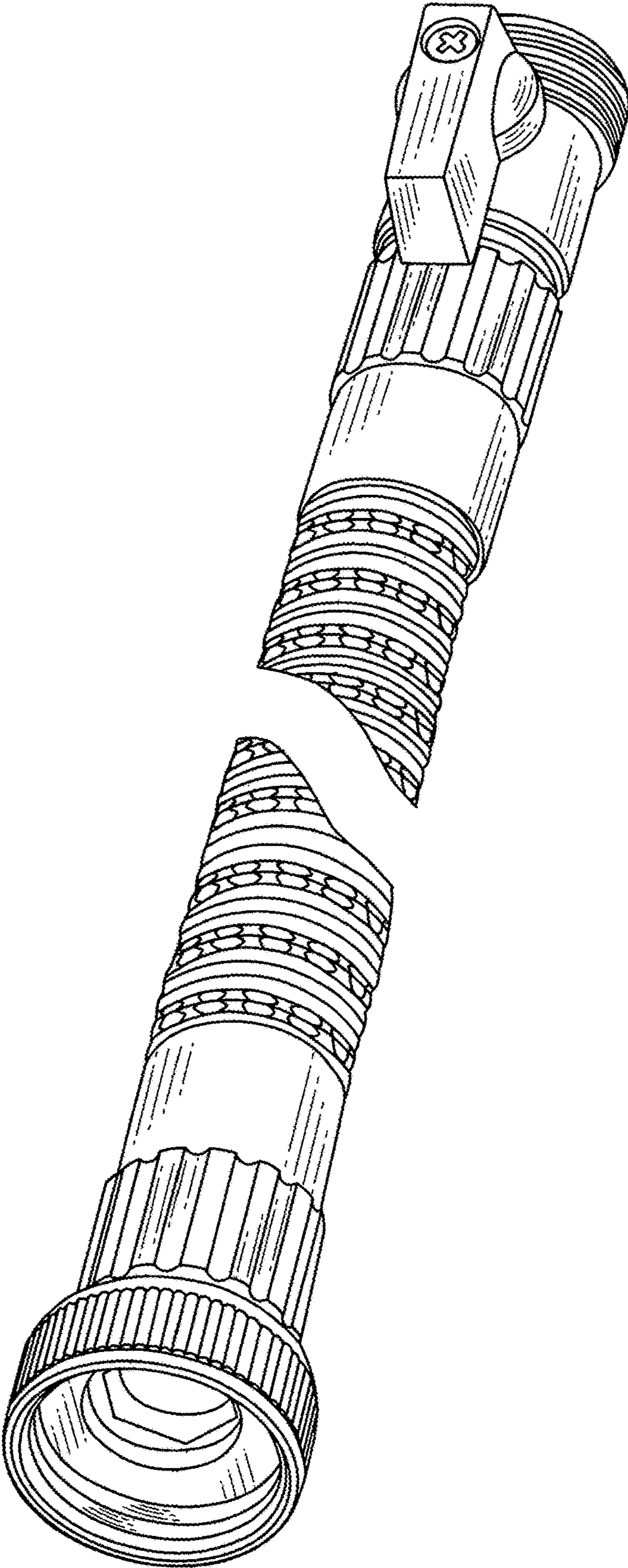

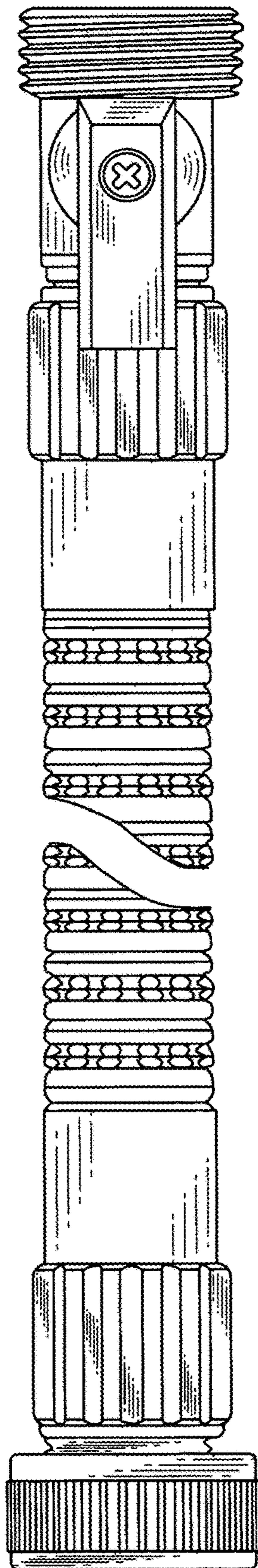

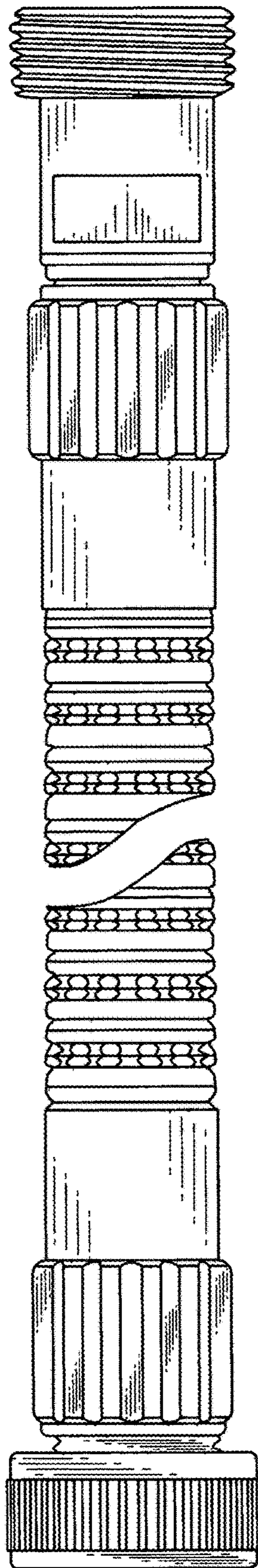

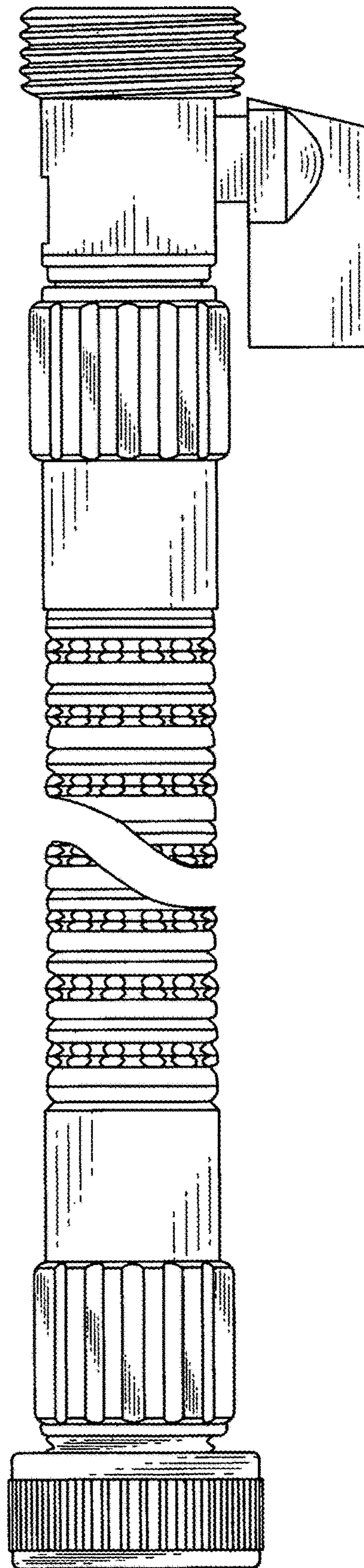

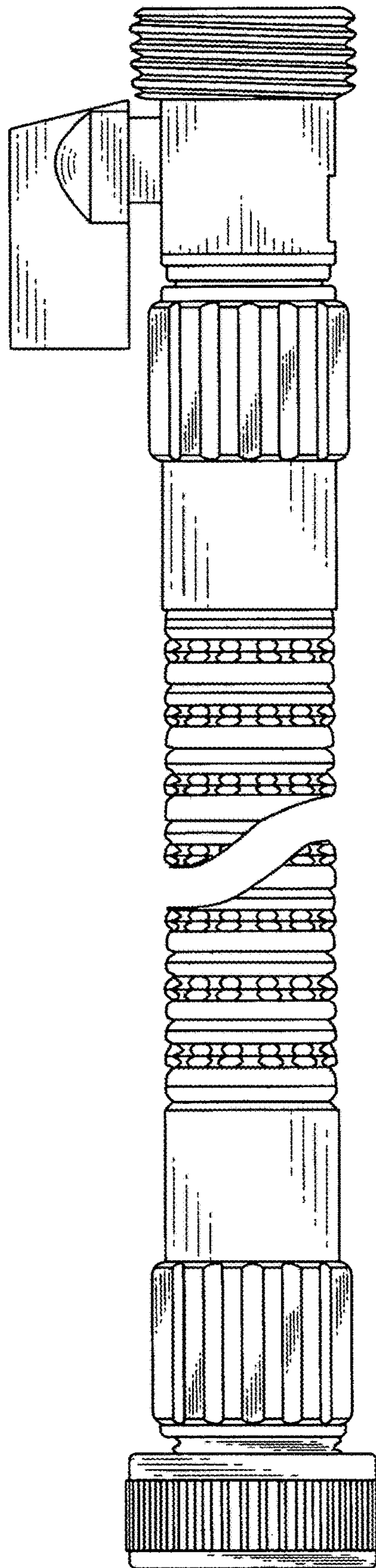

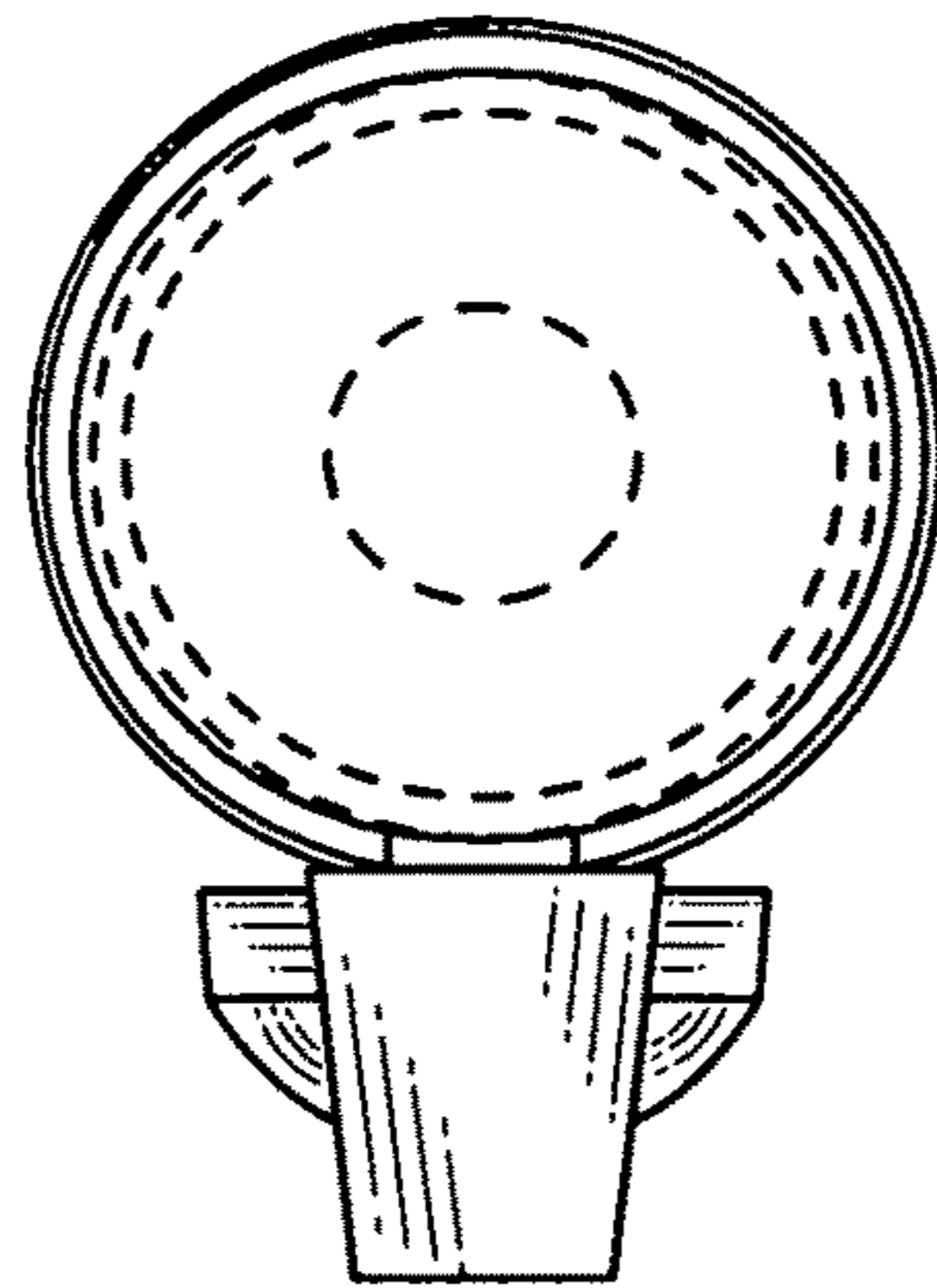

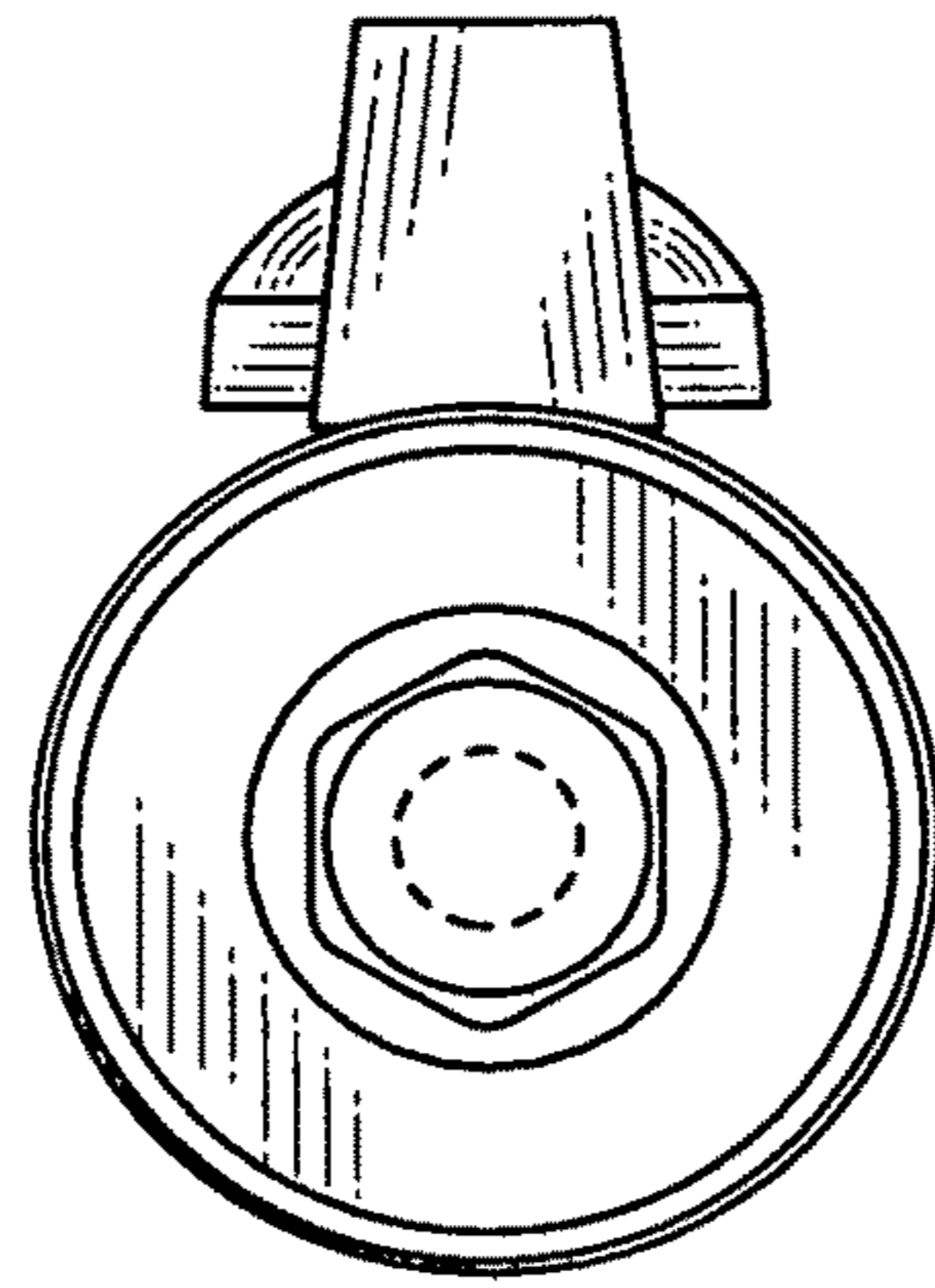
