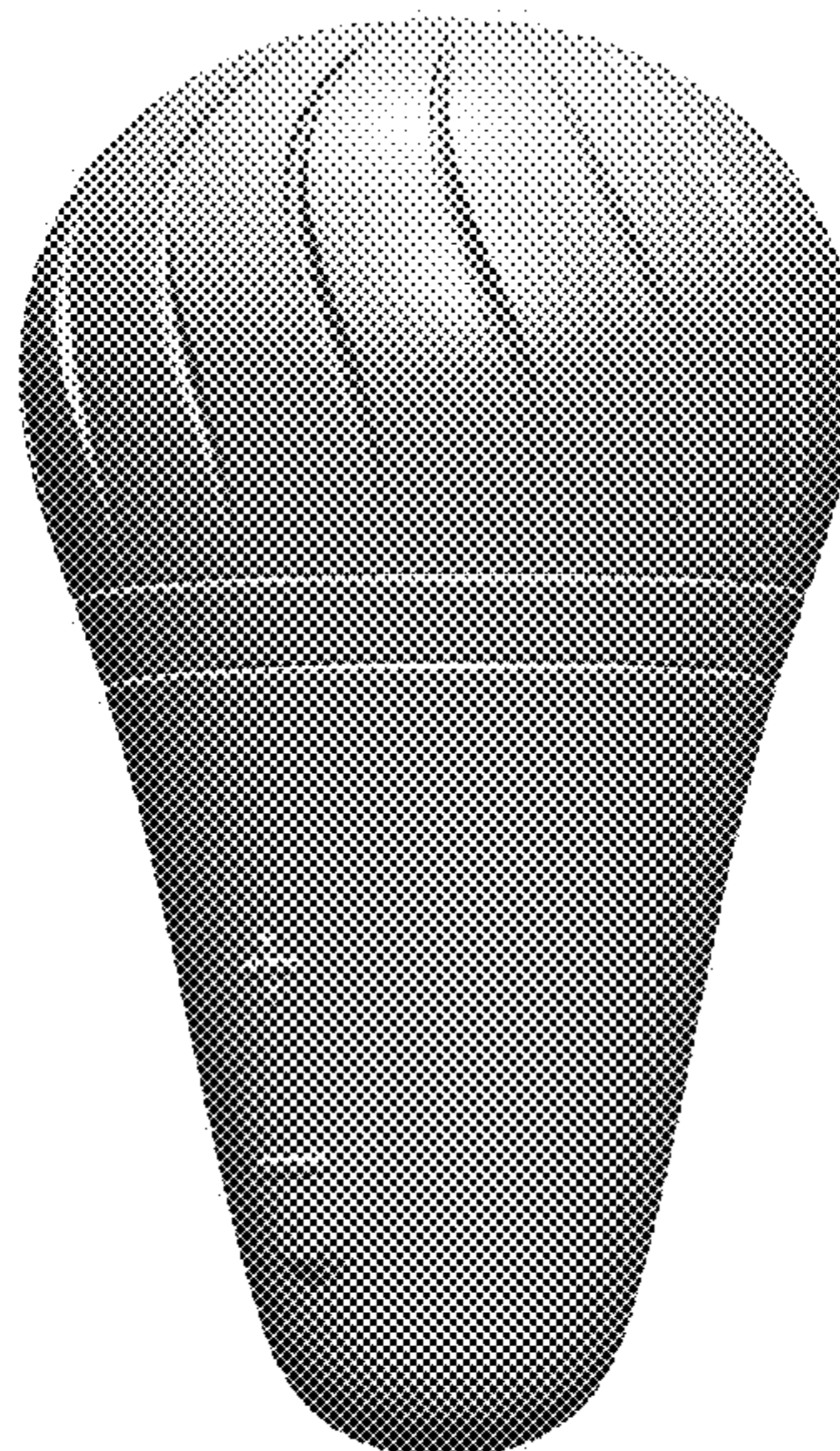
The ornamental design for a sex toy, as shown and described.

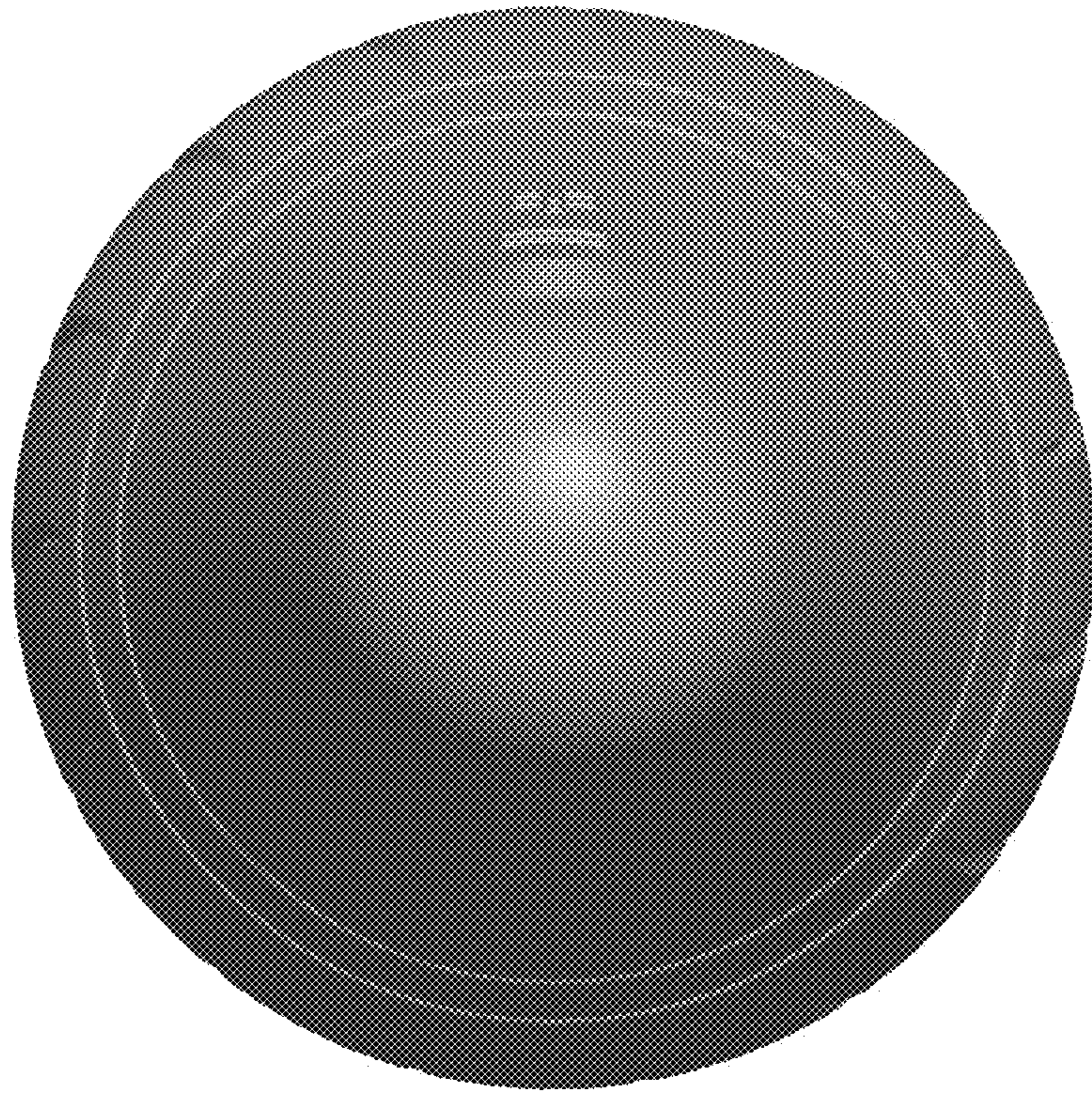

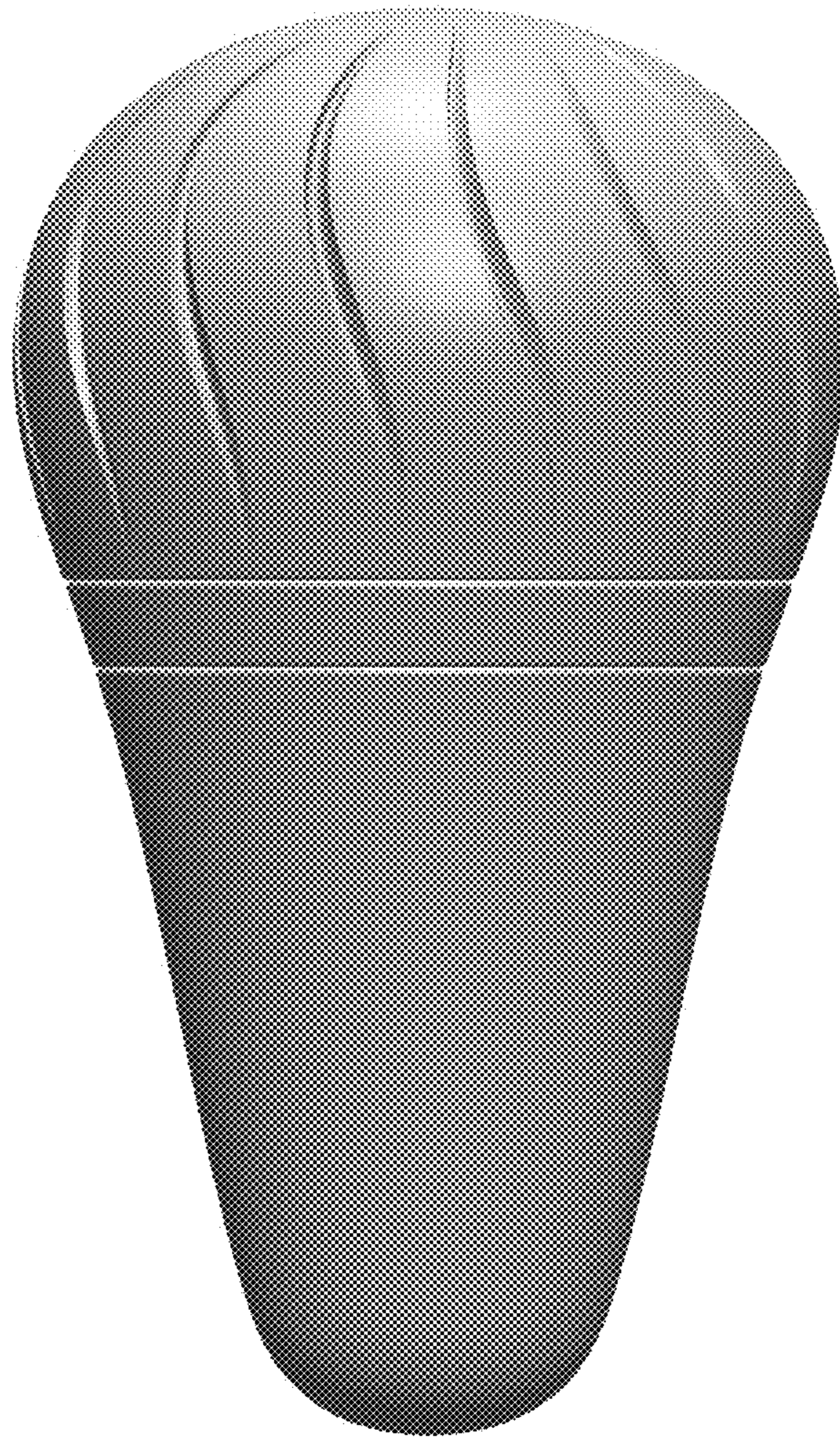

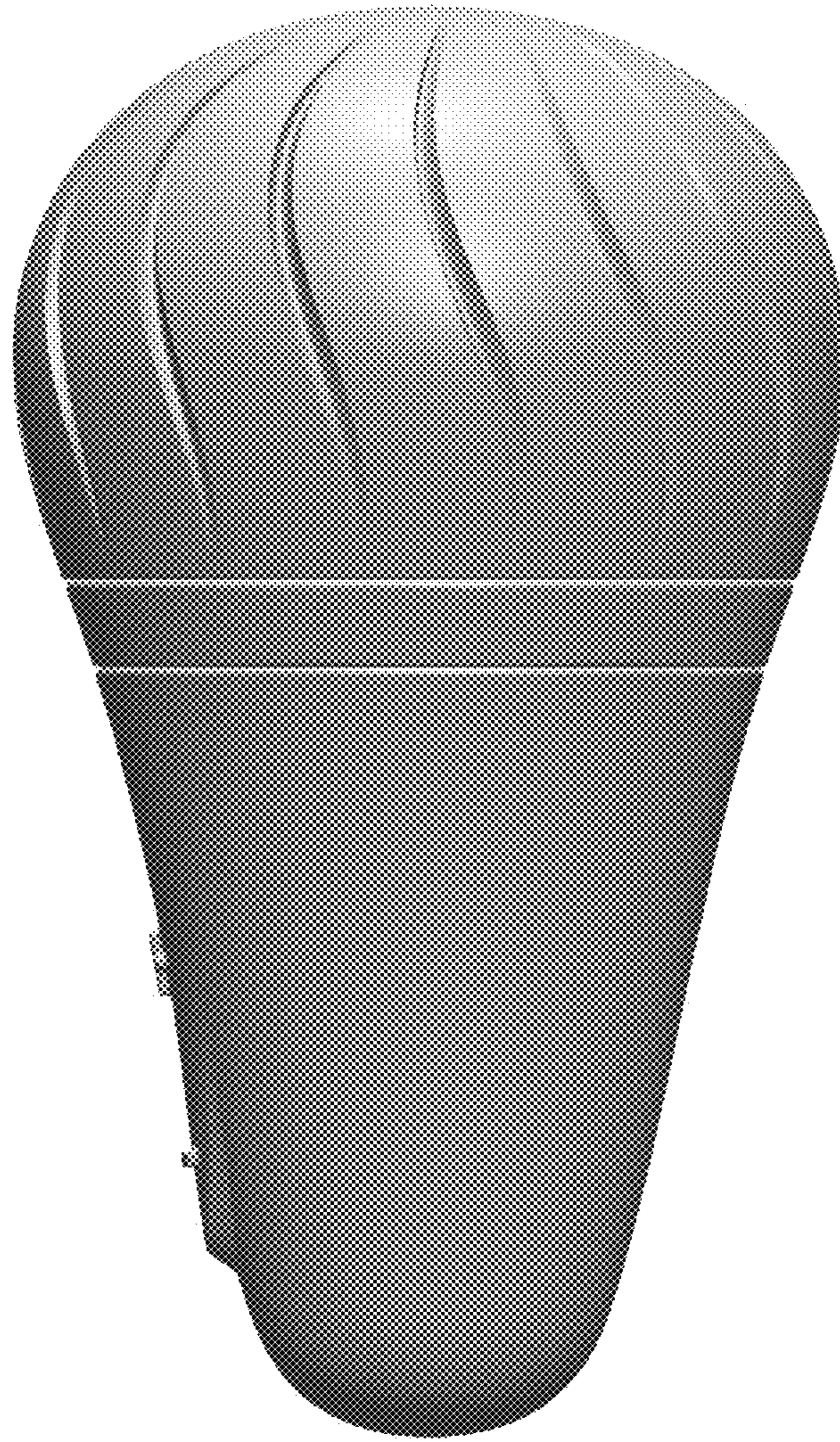

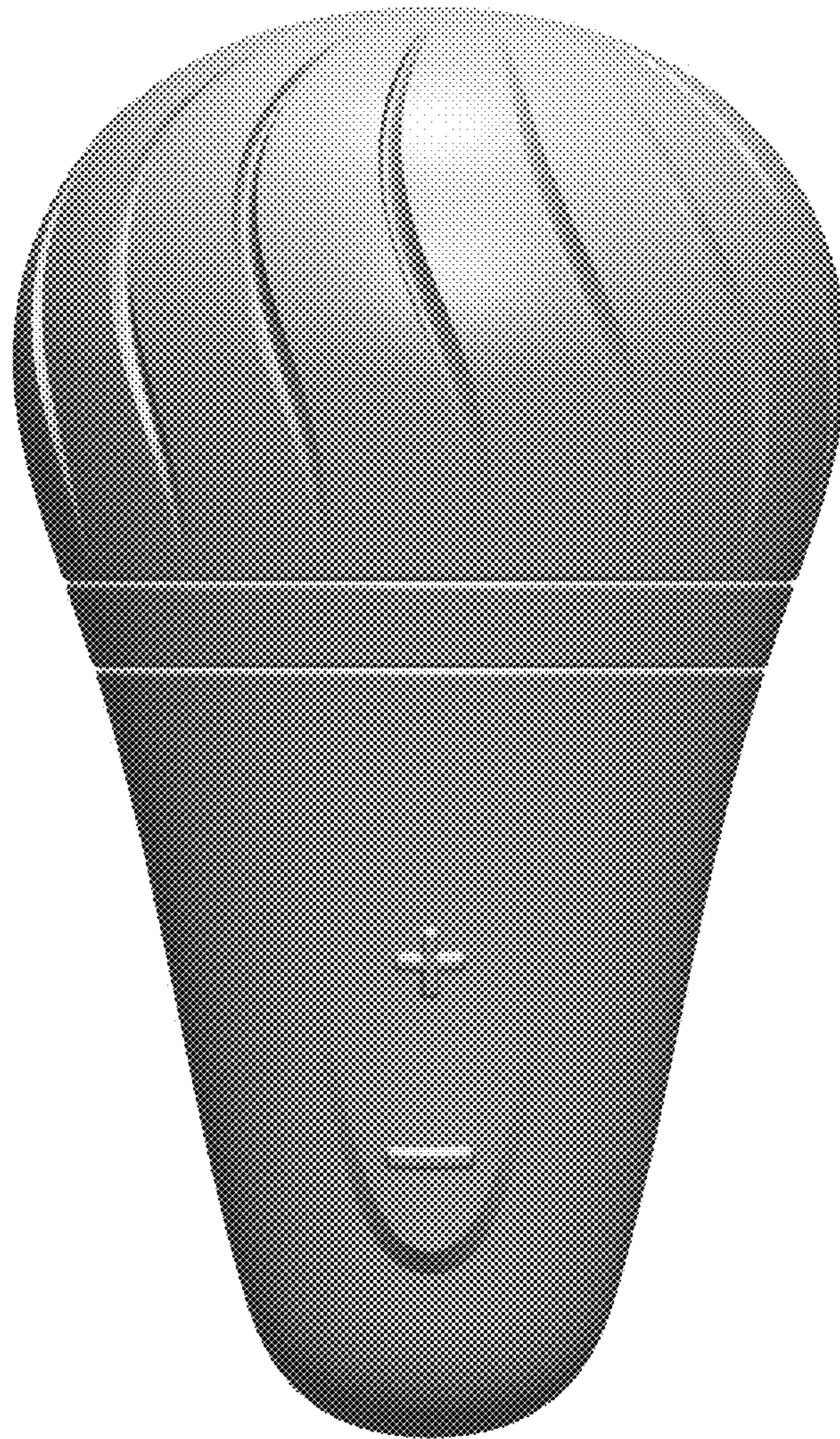

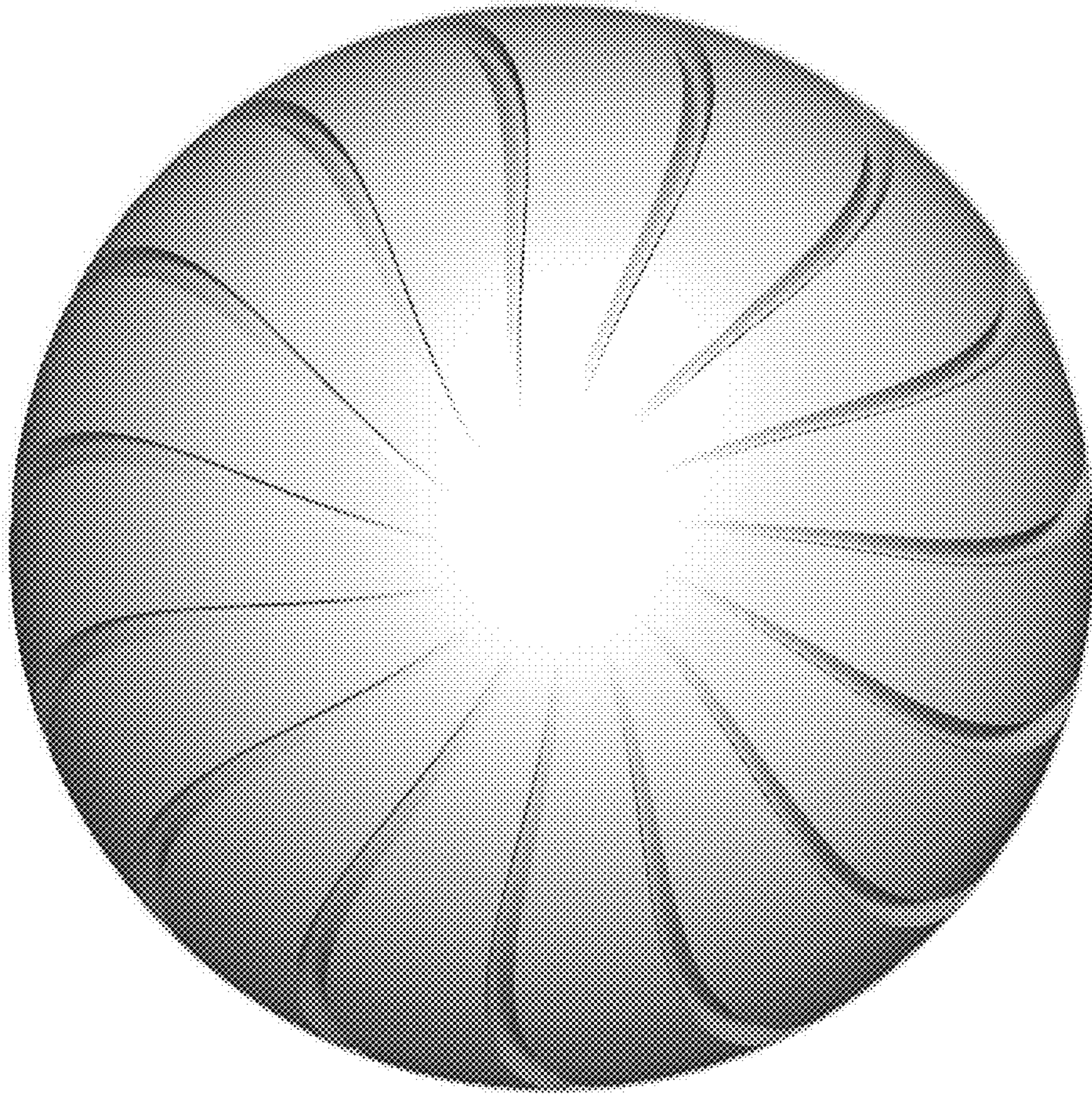
