(57) **CLAIM**

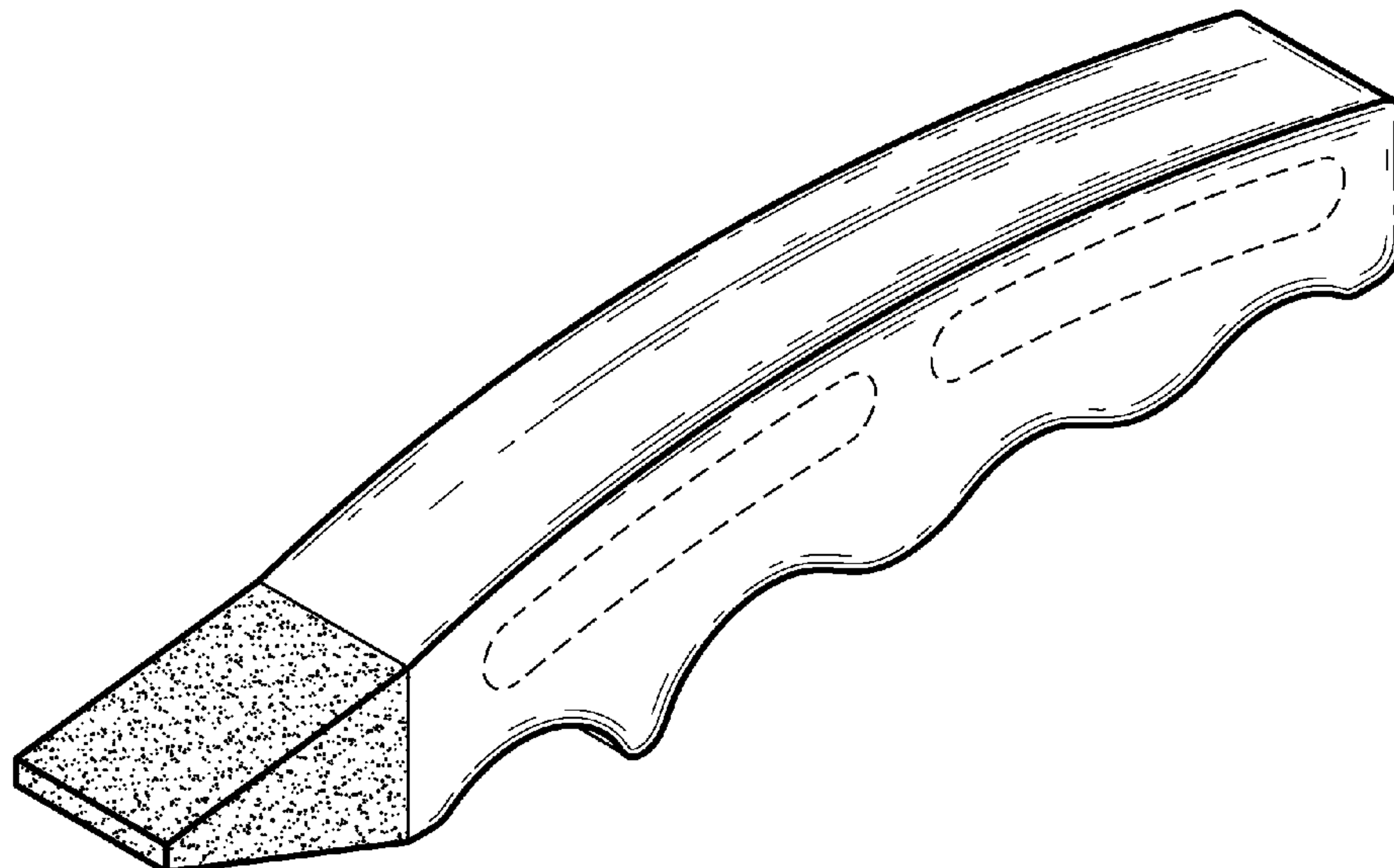
The ornamental design for an animal grooming tool, as shown and described.

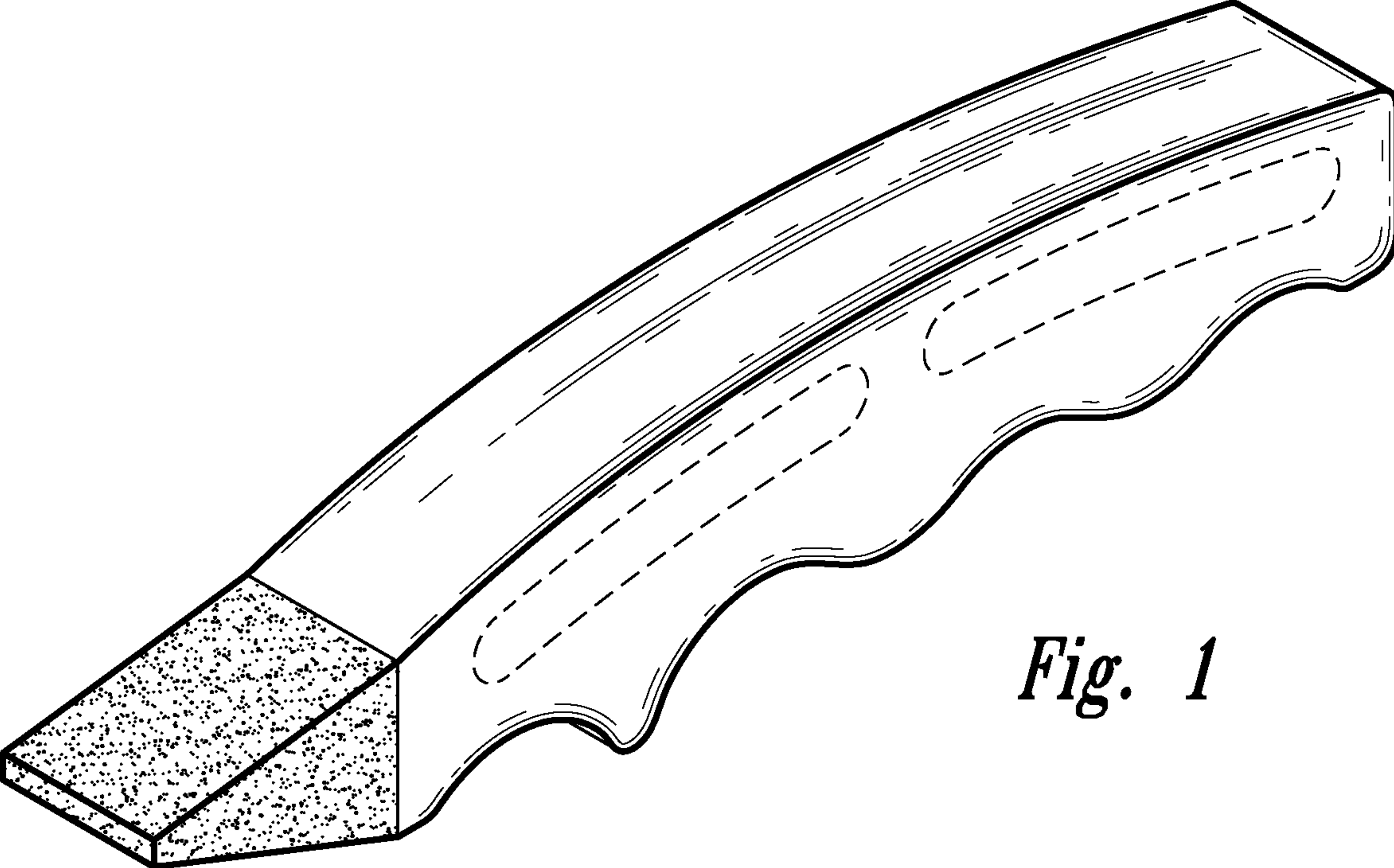

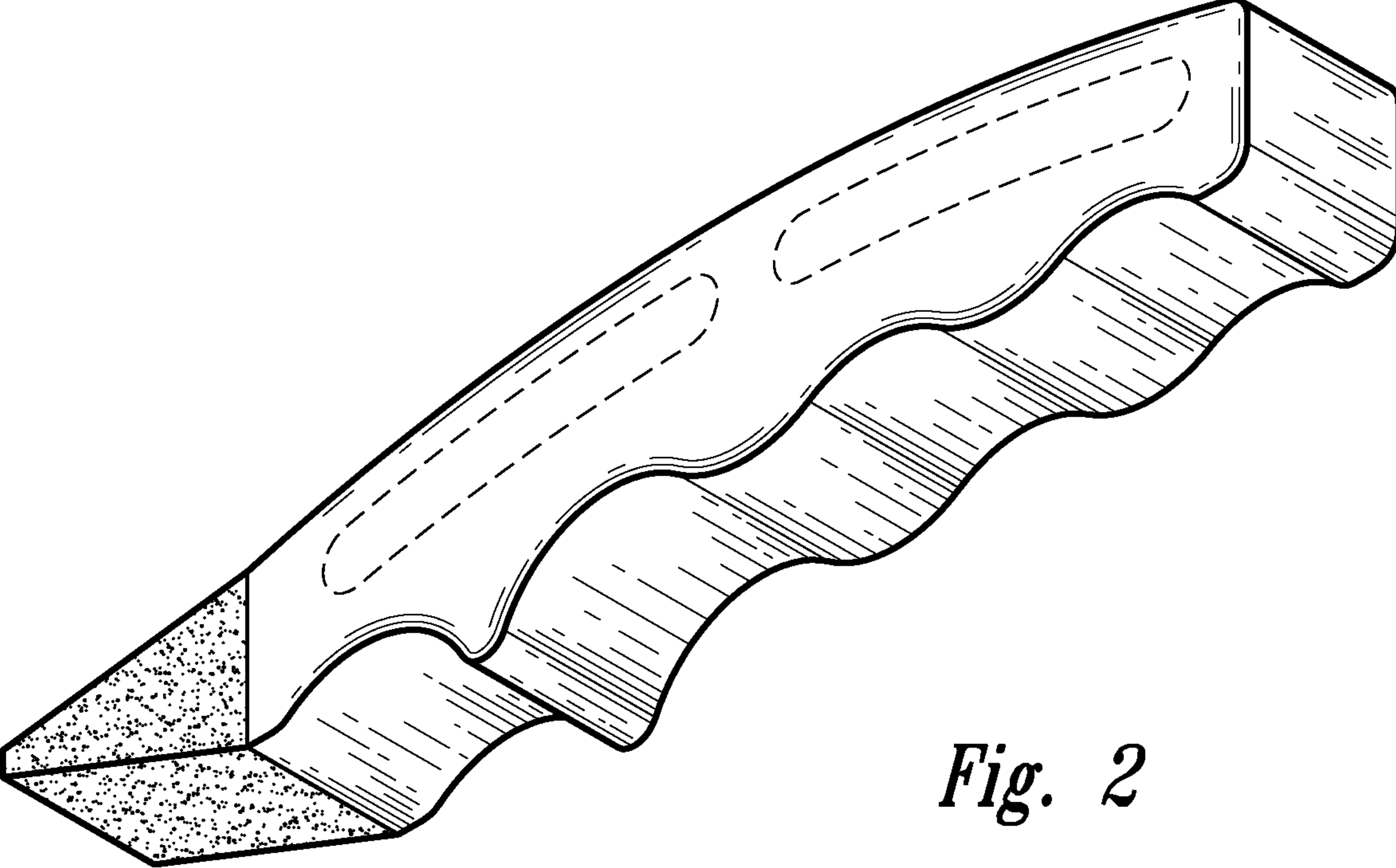

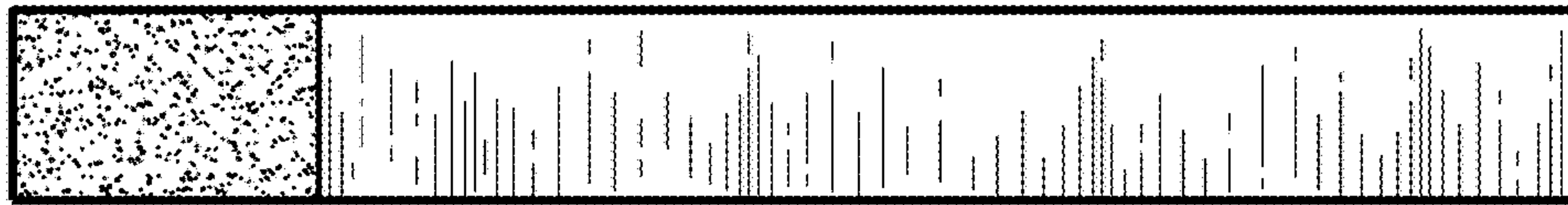

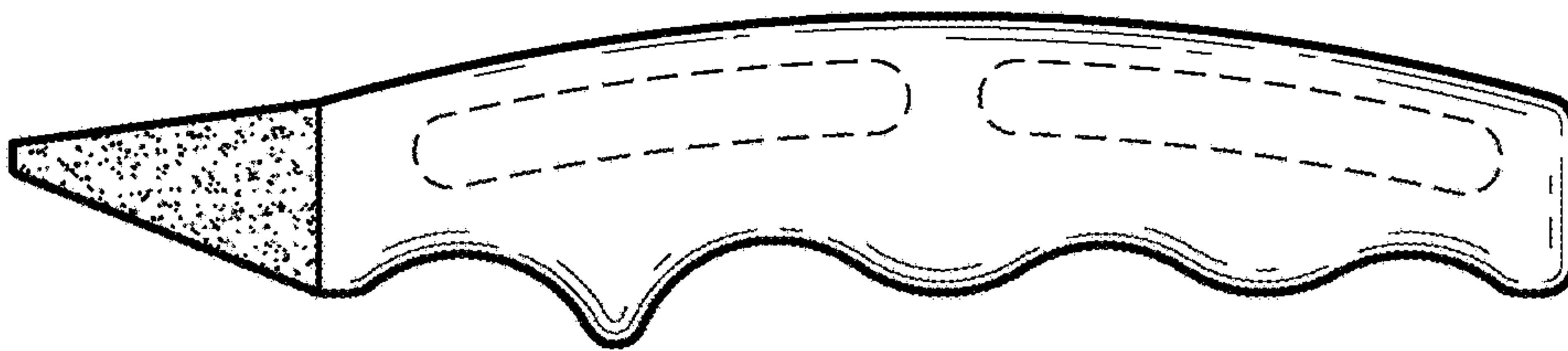

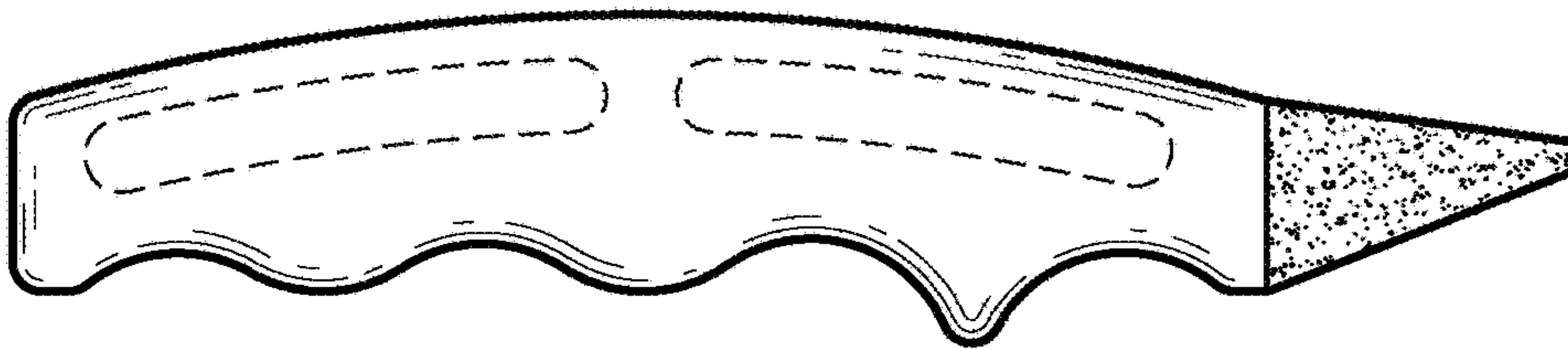

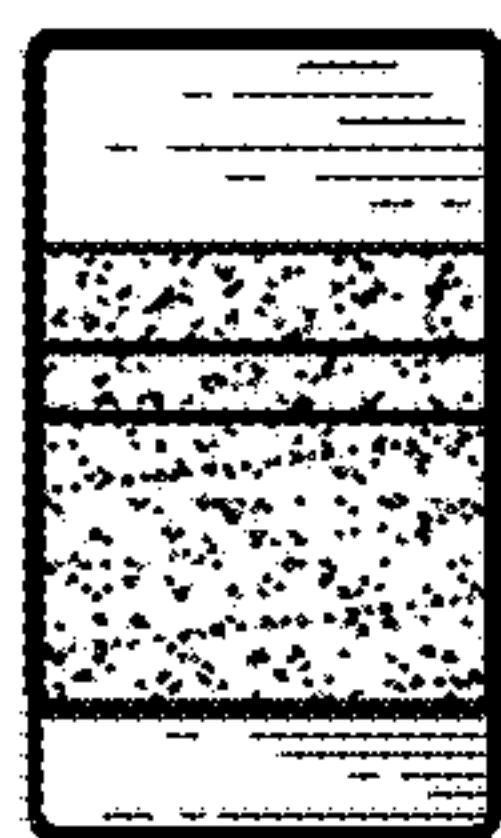

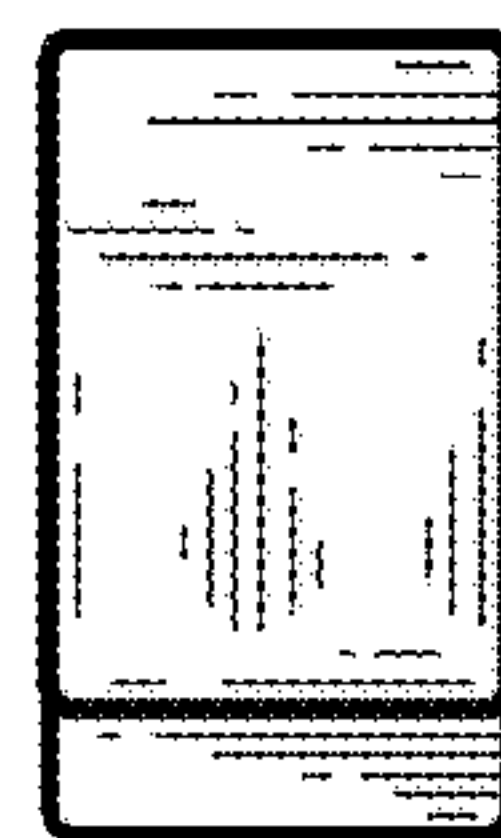
