DESCRIPTION

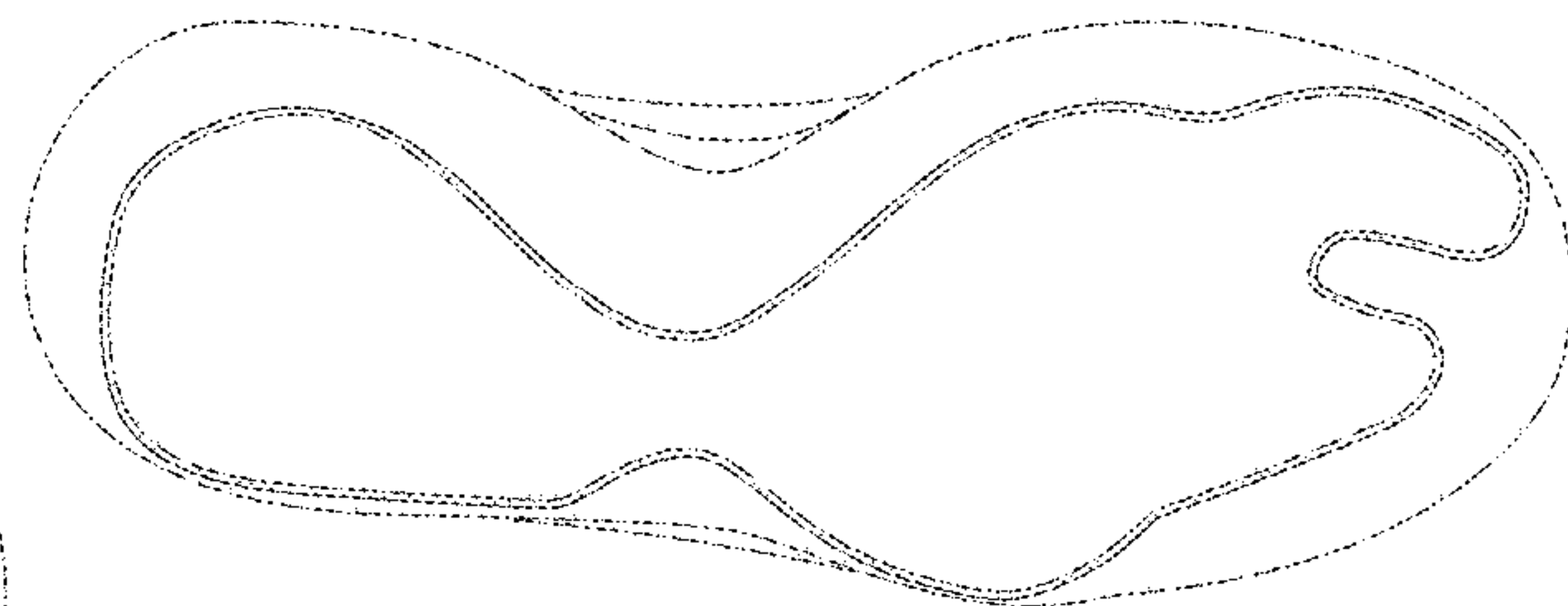
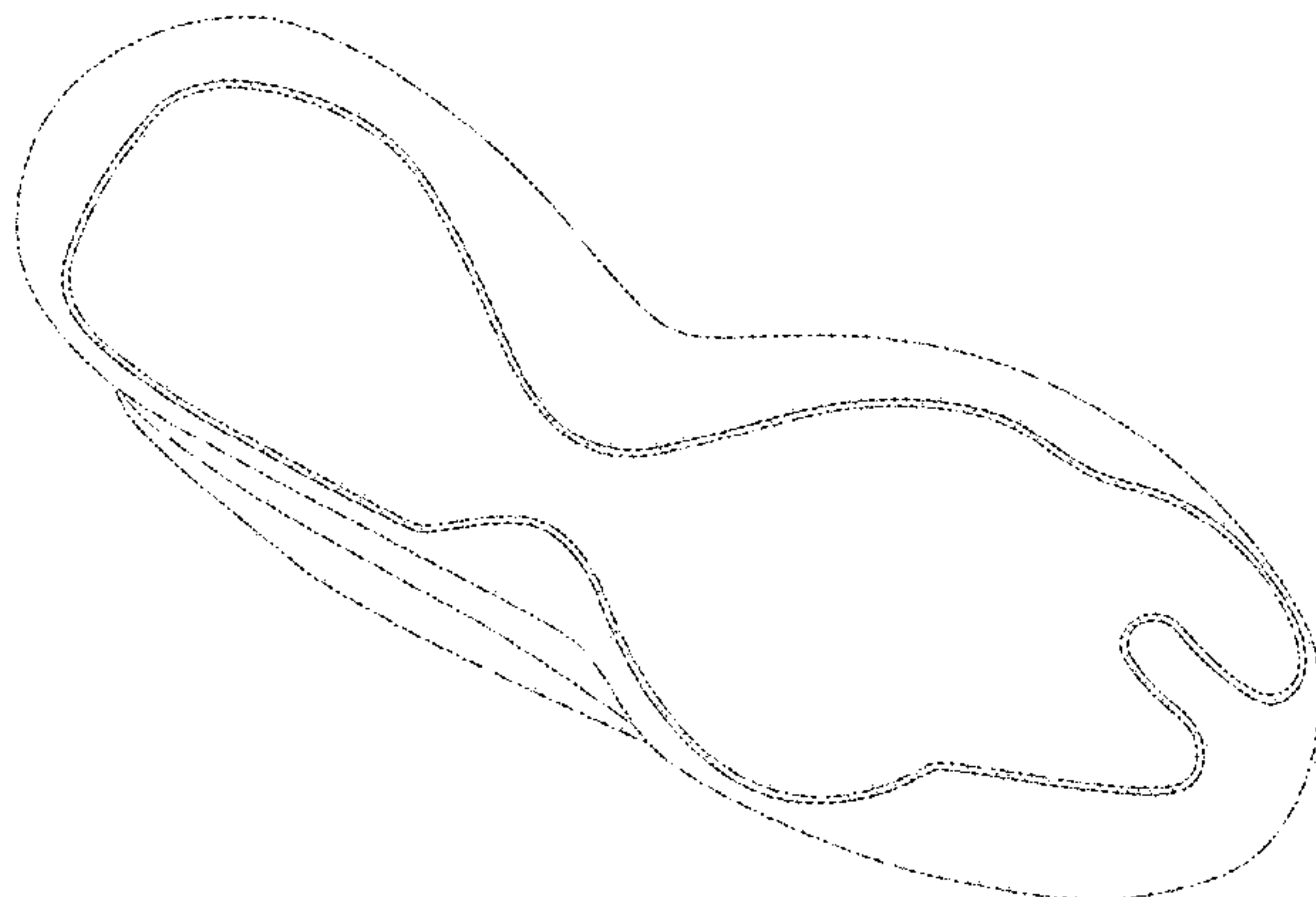
FIG. 1 is a front bottom perspective view of a shoe showing my new design;

FIG. 2 is a bottom view thereof; and,

FIG. 3 is a rear bottom perspective view thereof.

The broken line immediately adjacent to the inside of the shaded area defines the internal bounds of the claimed design and forms no part thereof. The solid outer line boundary represents the peripheral boundary of a surface ornamentation pattern. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

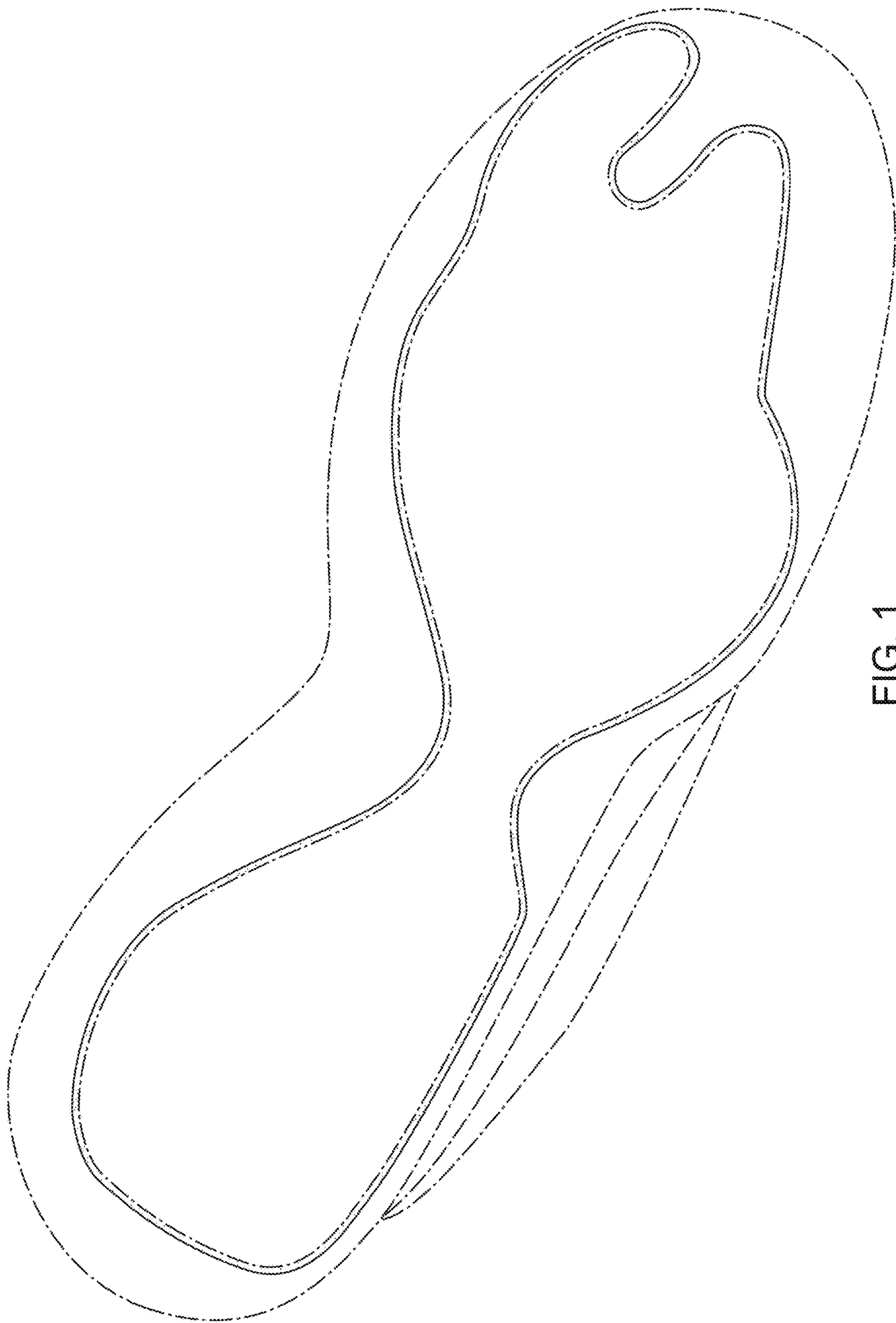

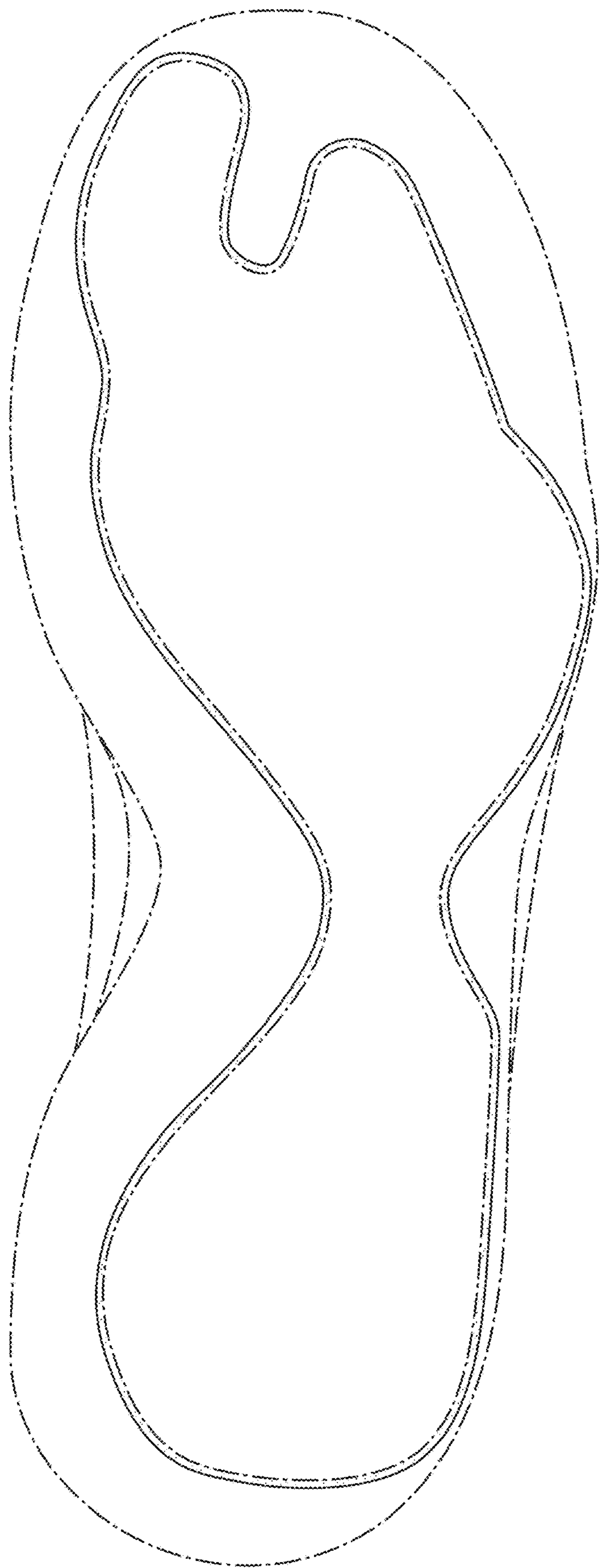

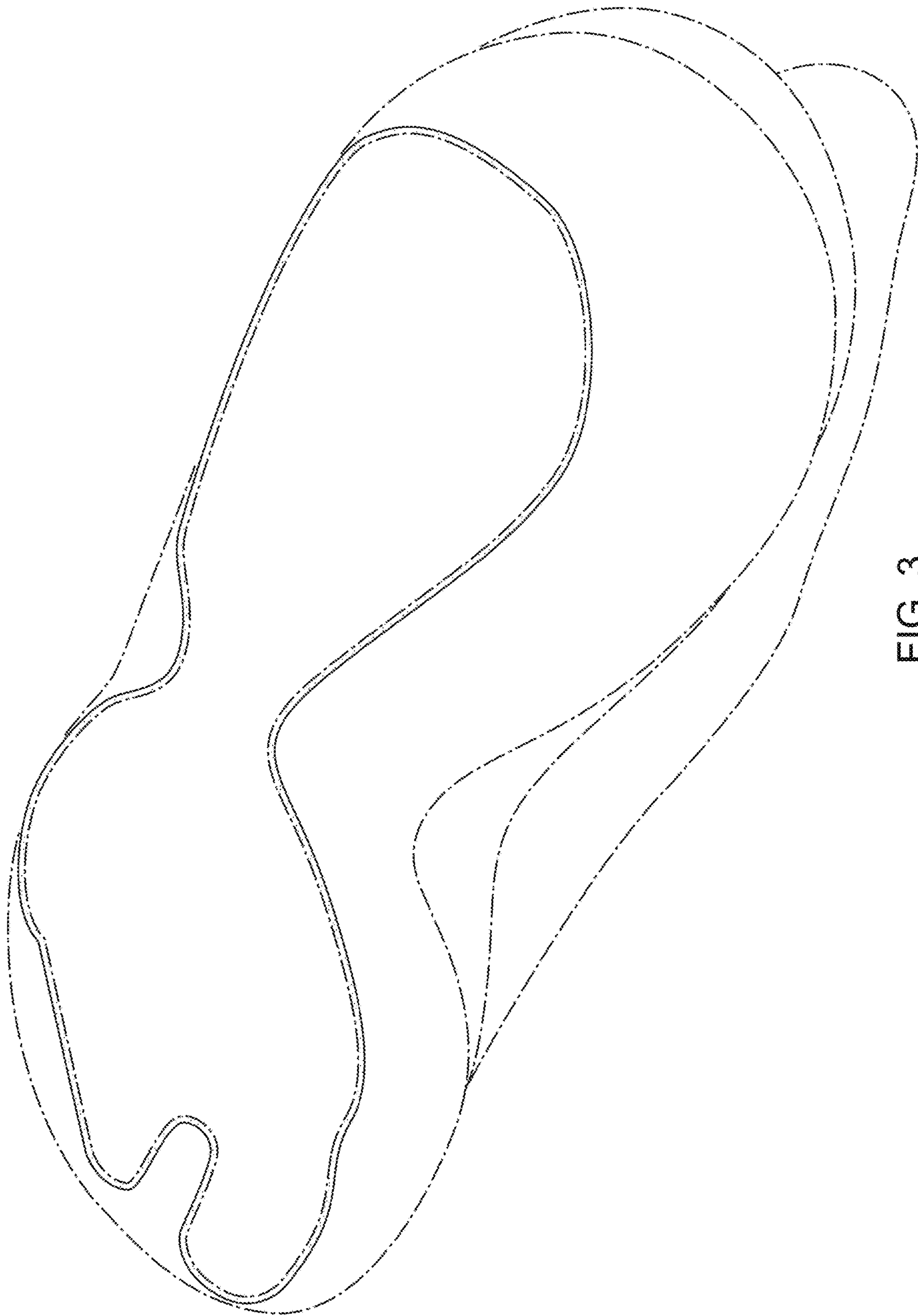
