(57) **CLAIM**

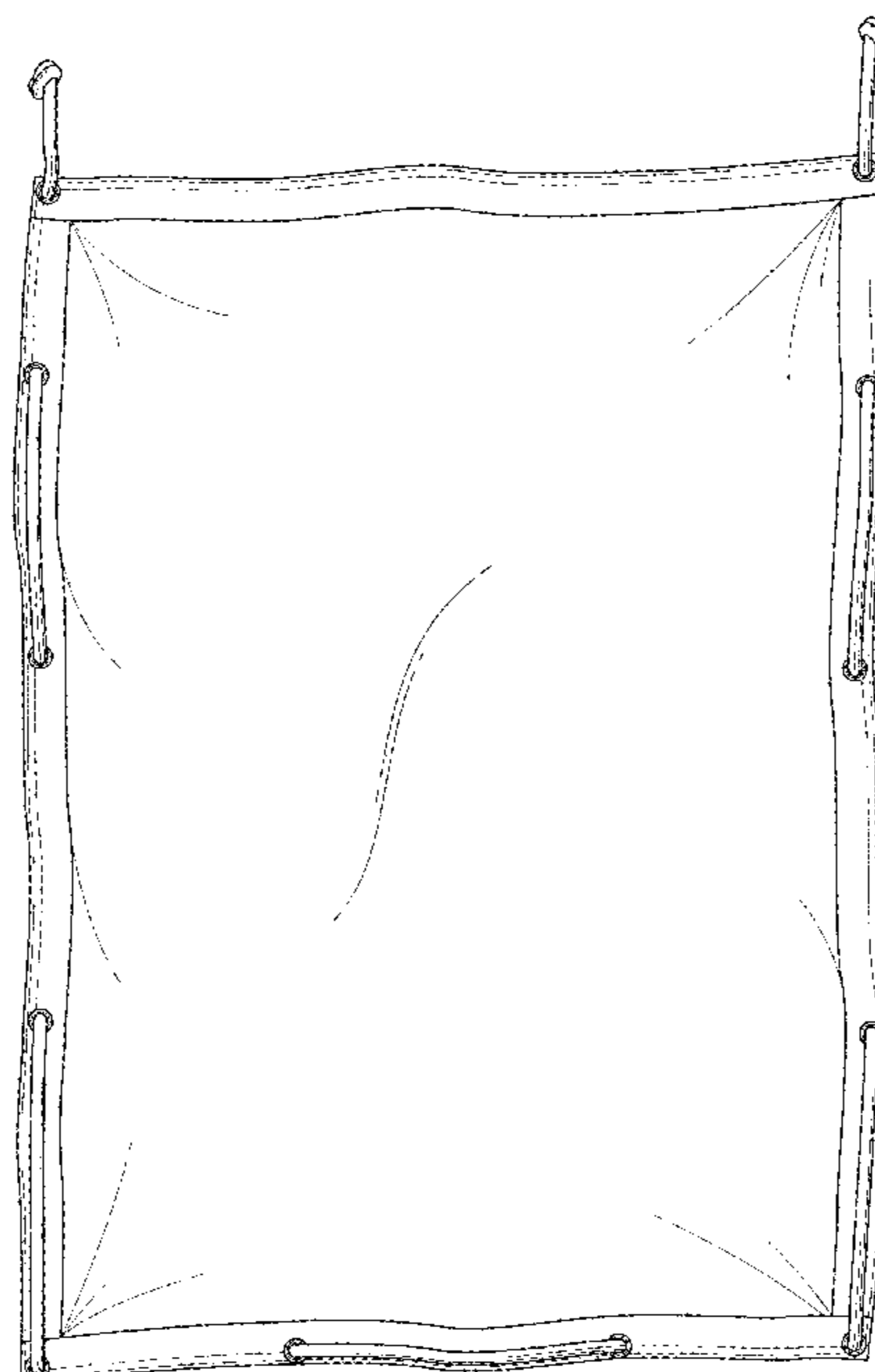
The ornamental design for a carrying wrap, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a carrying wrap showing my new design in its unwrapped position;
FIG. 2 is a bottom plan view thereof;
FIG. 3 is a top plan view of the wrap, unwrapped in use;
FIG. 4 is an enlarged scale top plan view of the wrap, wrapped in a position of use; and,
FIG. 5 is a reduced scale left side elevation view of the wrap in another position of use, the right side elevation view being a mirror image.
The broken lines showing beach accessories and a human figure depict environmental subject matter that does not form part of the claimed design.

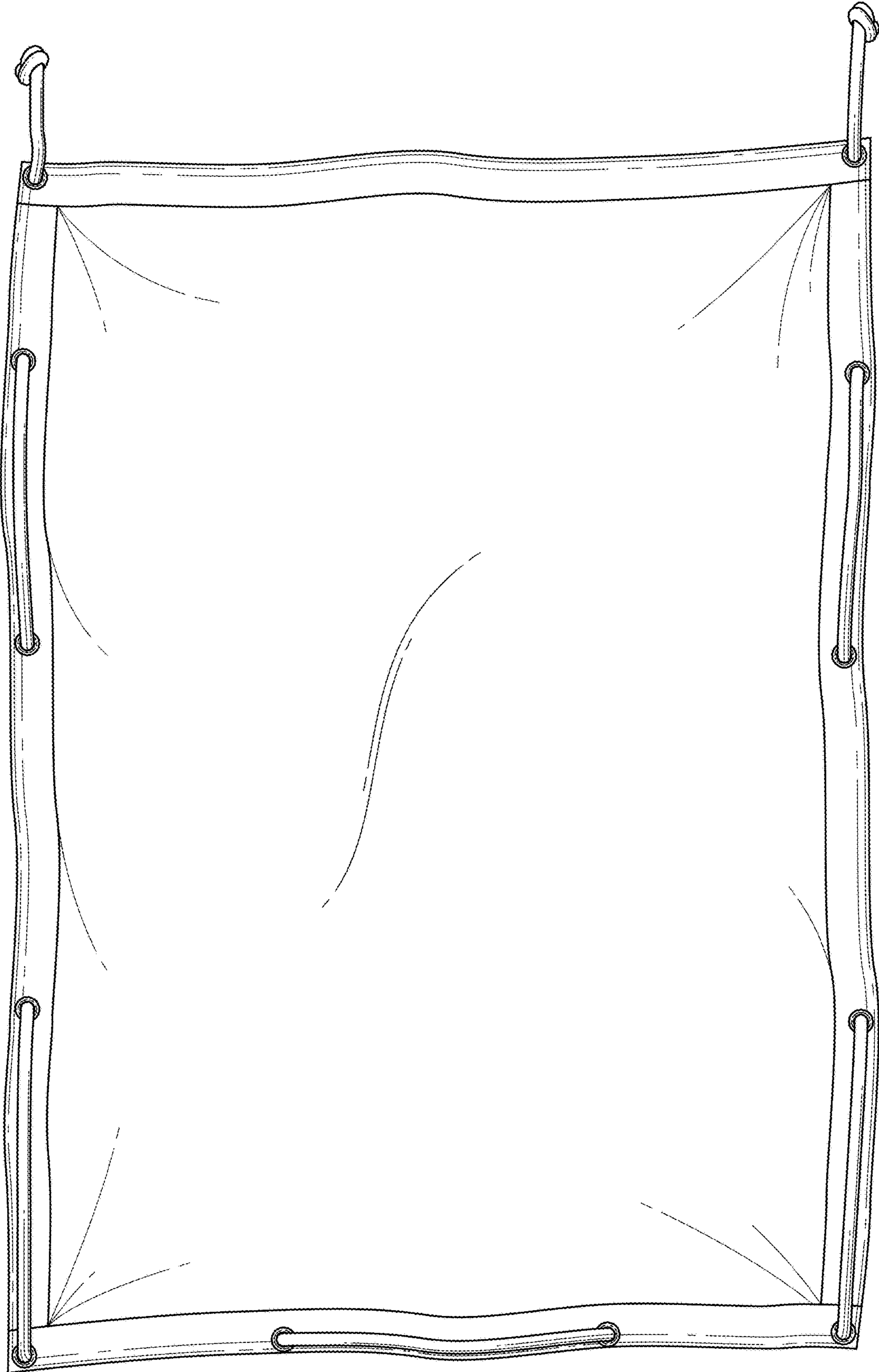

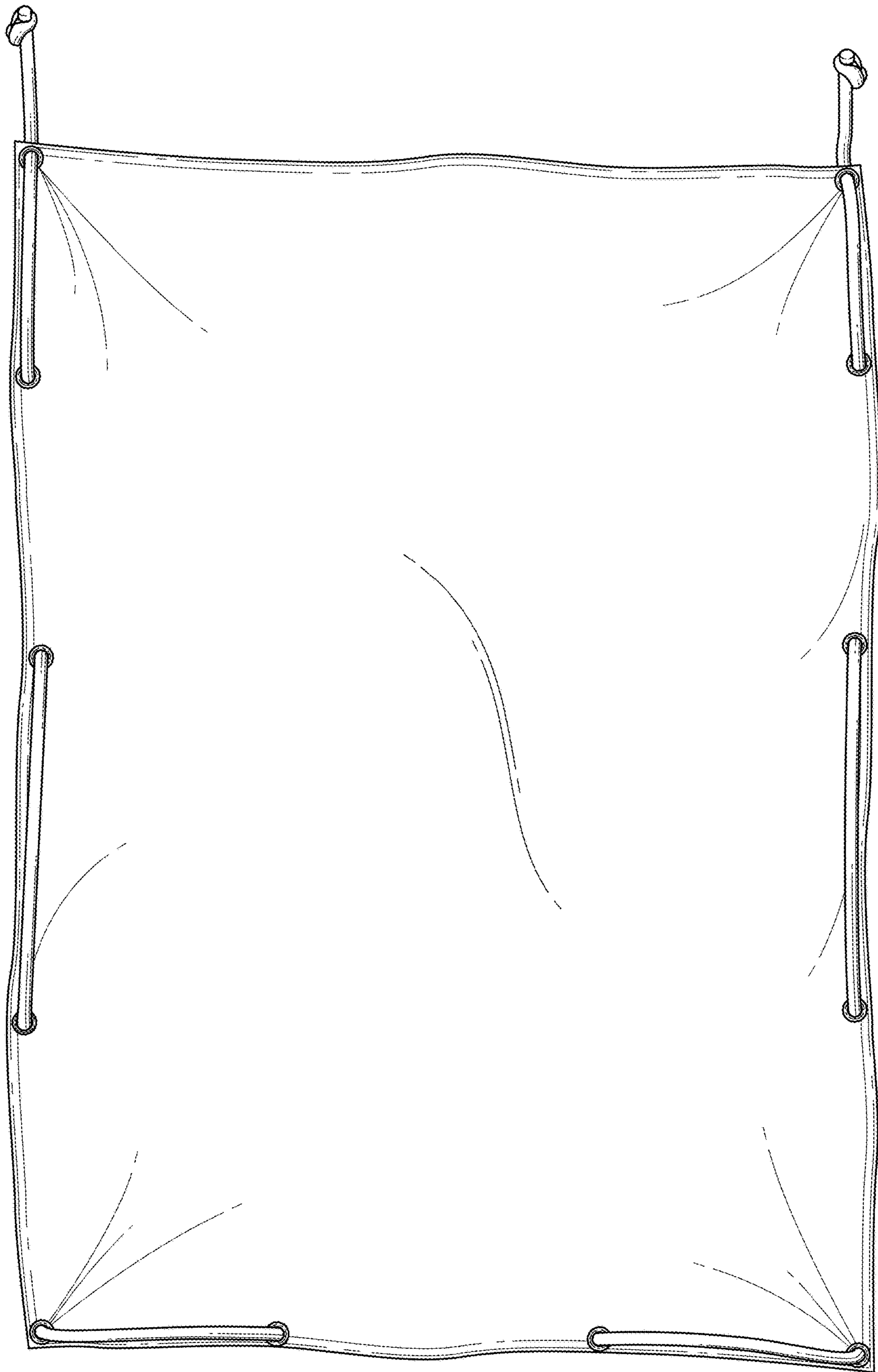

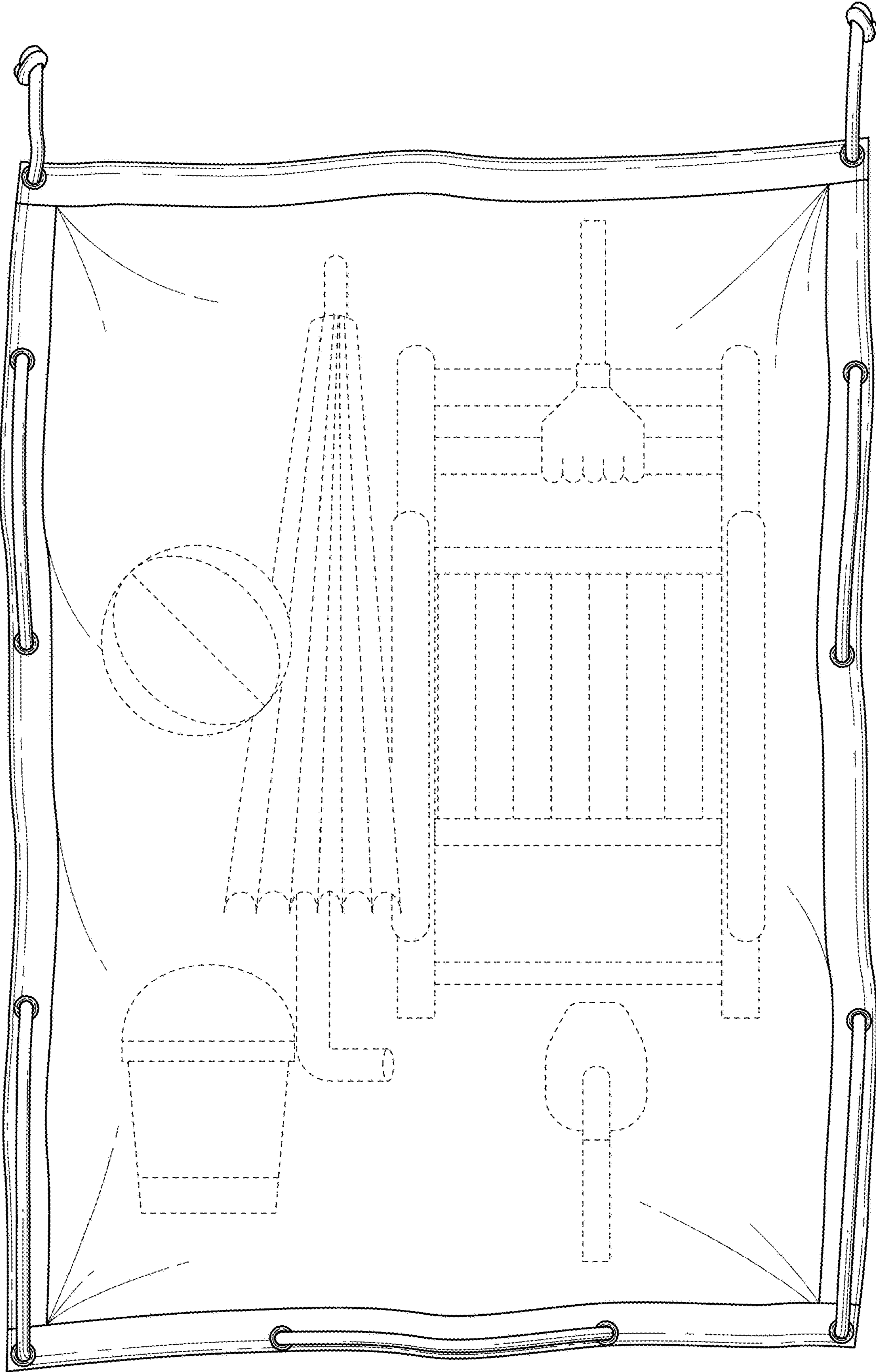

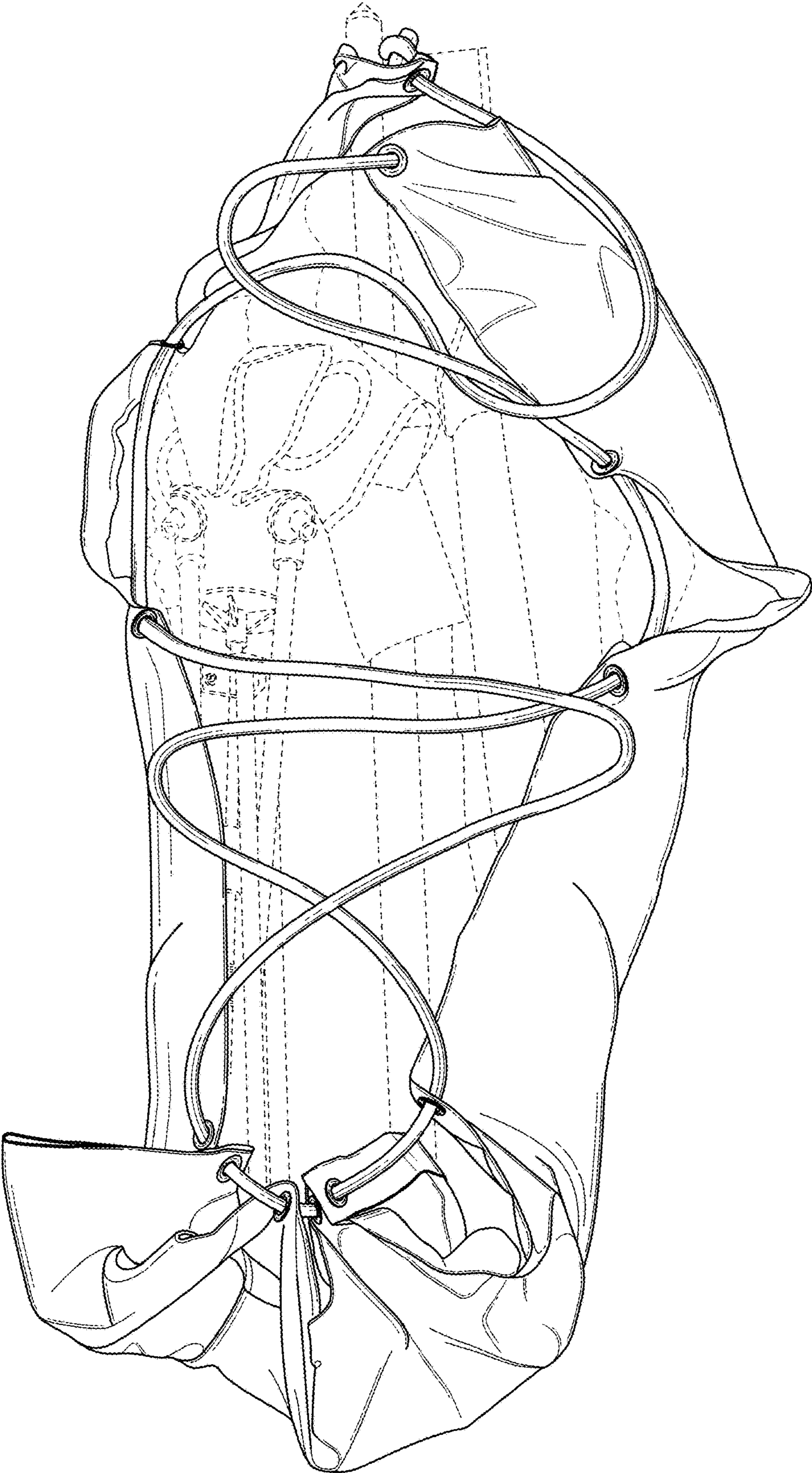

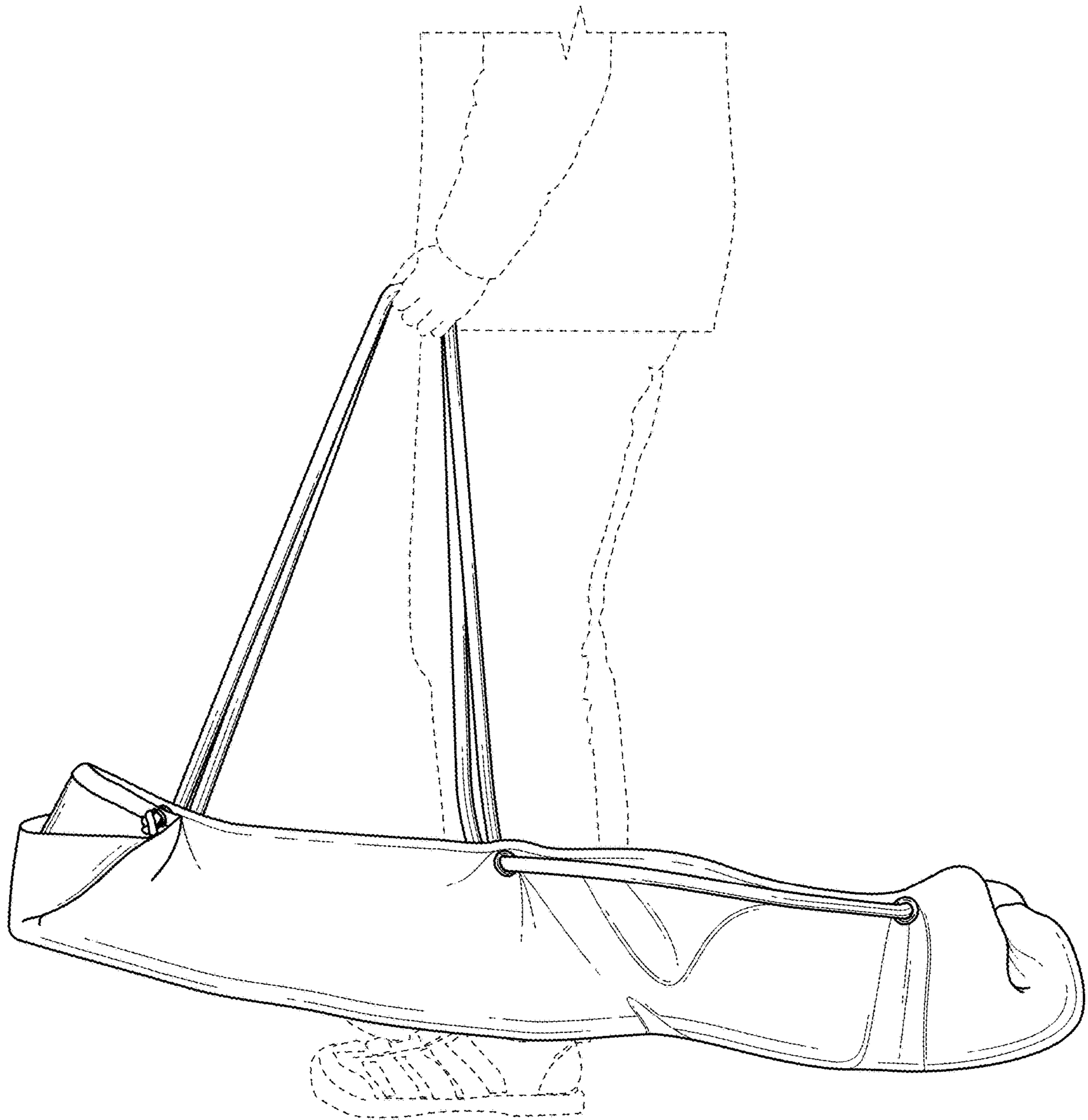
