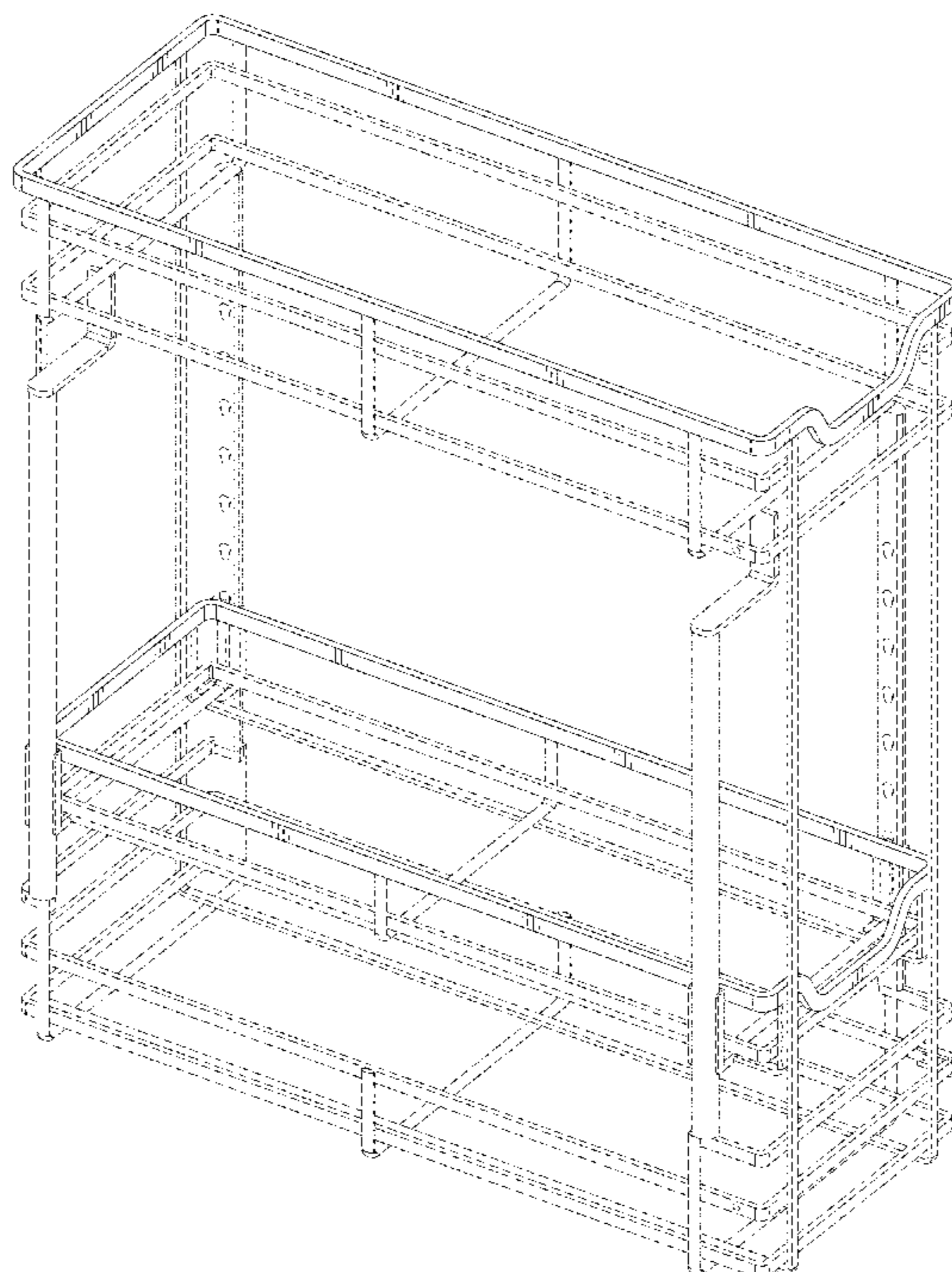
FIG. 1 is a perspective view of a basket pullout frame shown

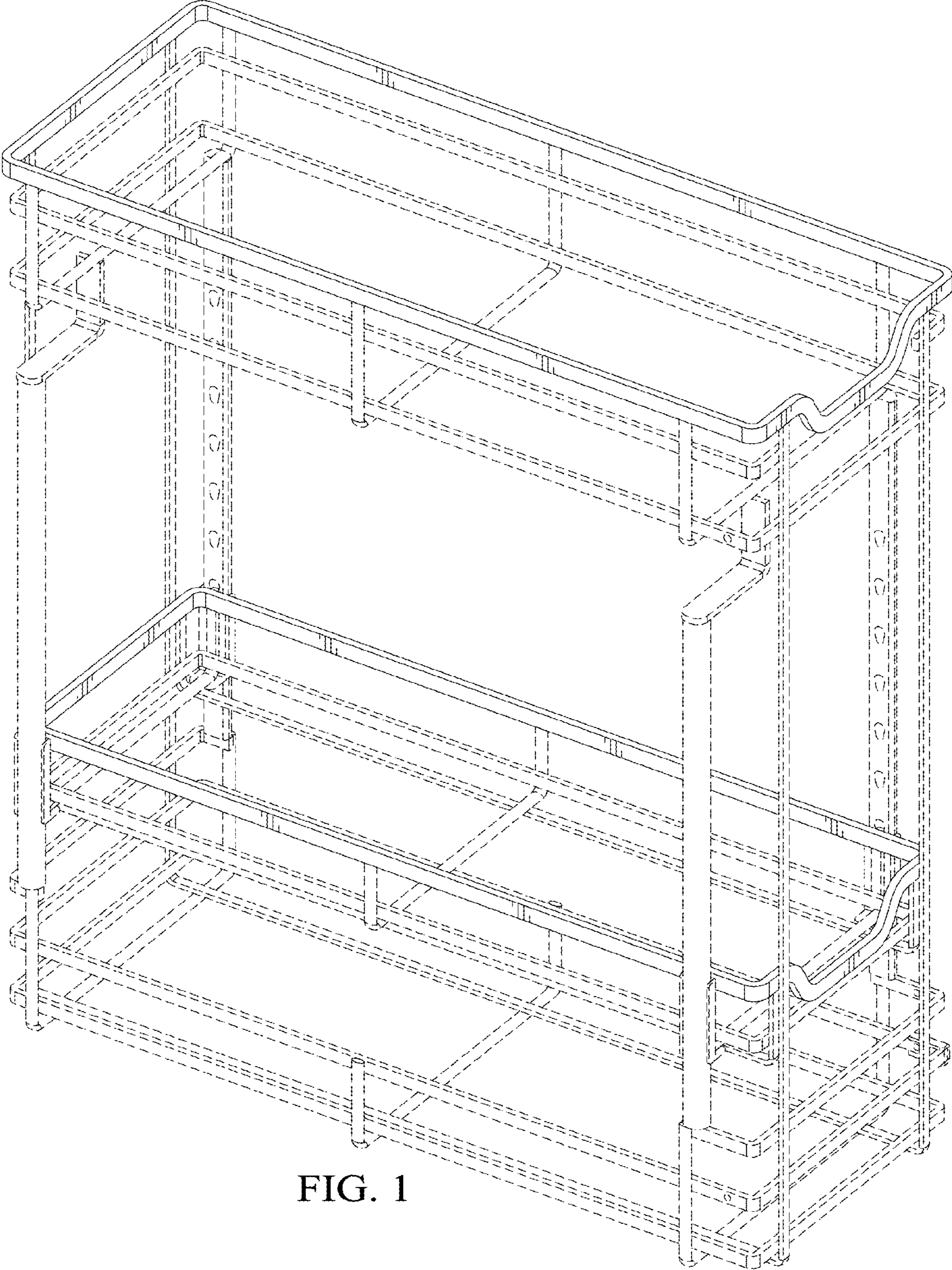

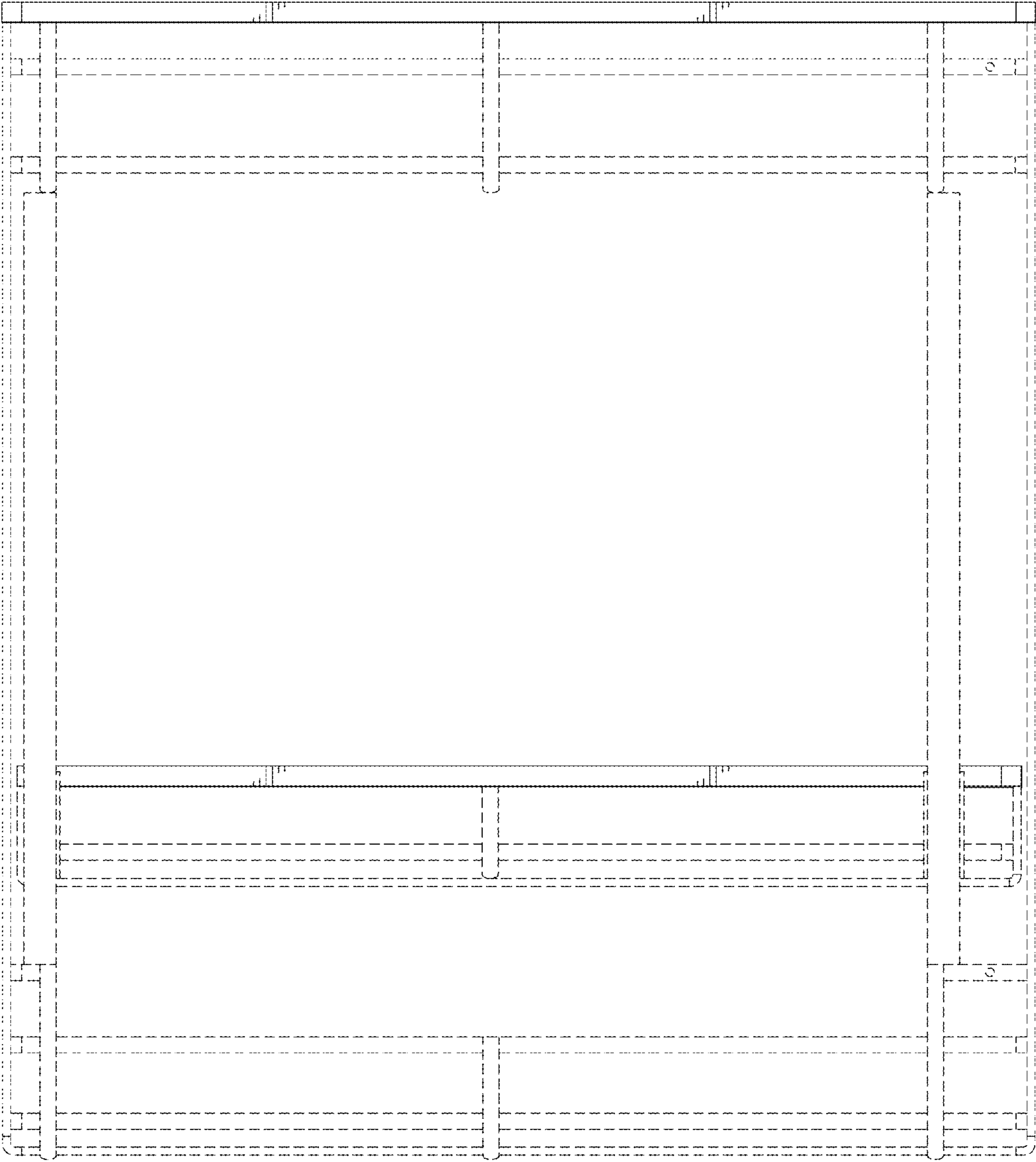

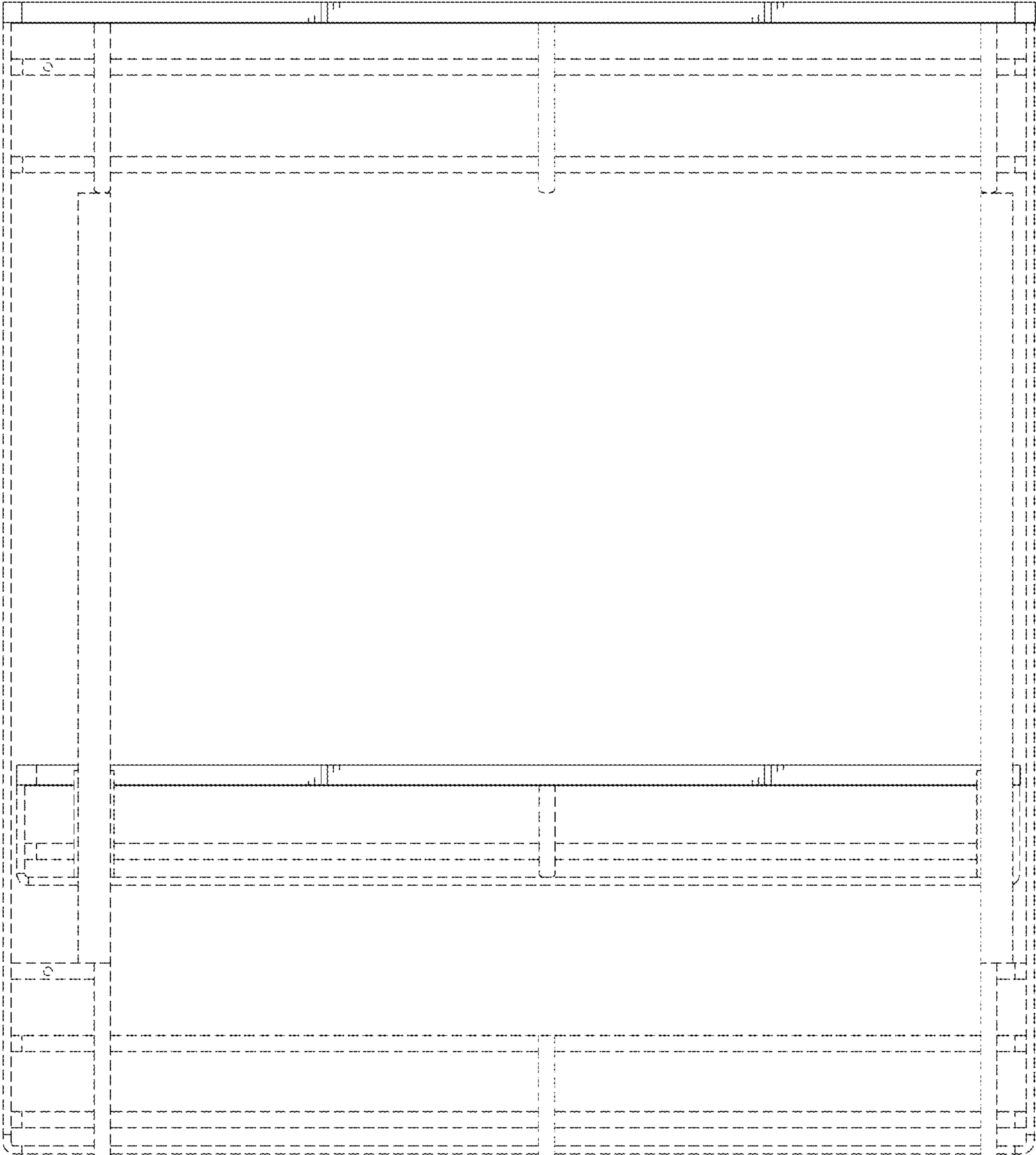

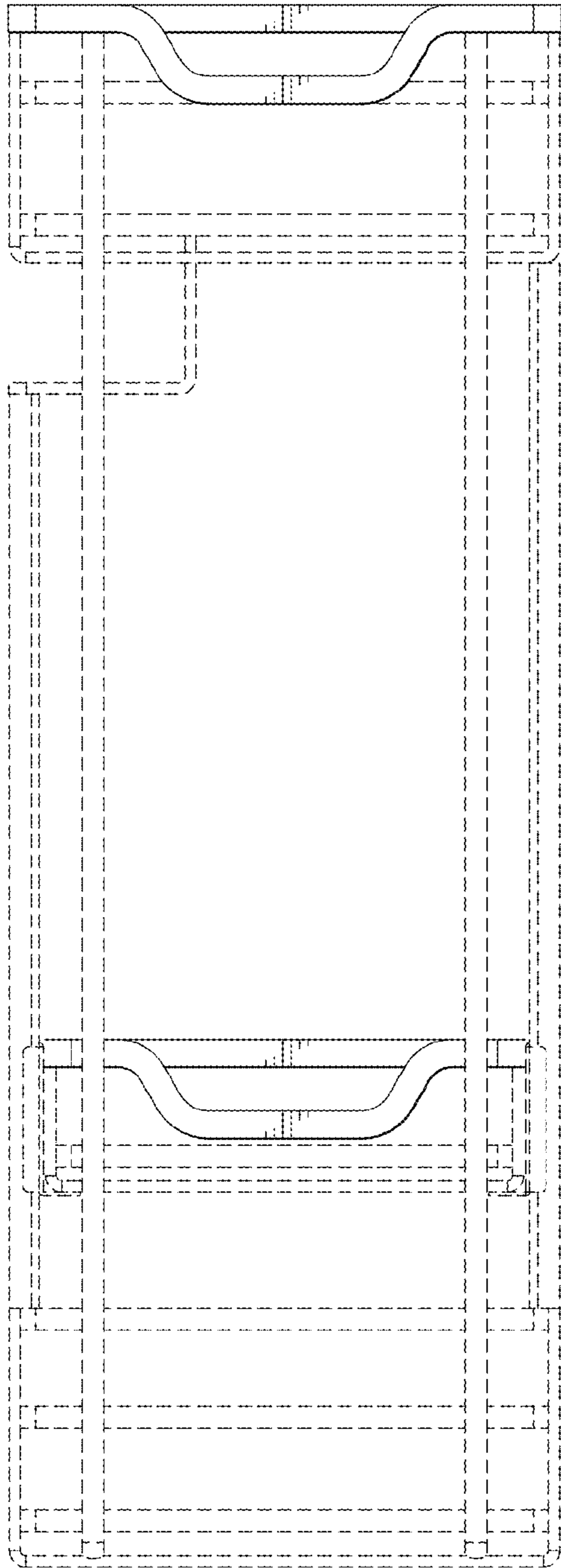

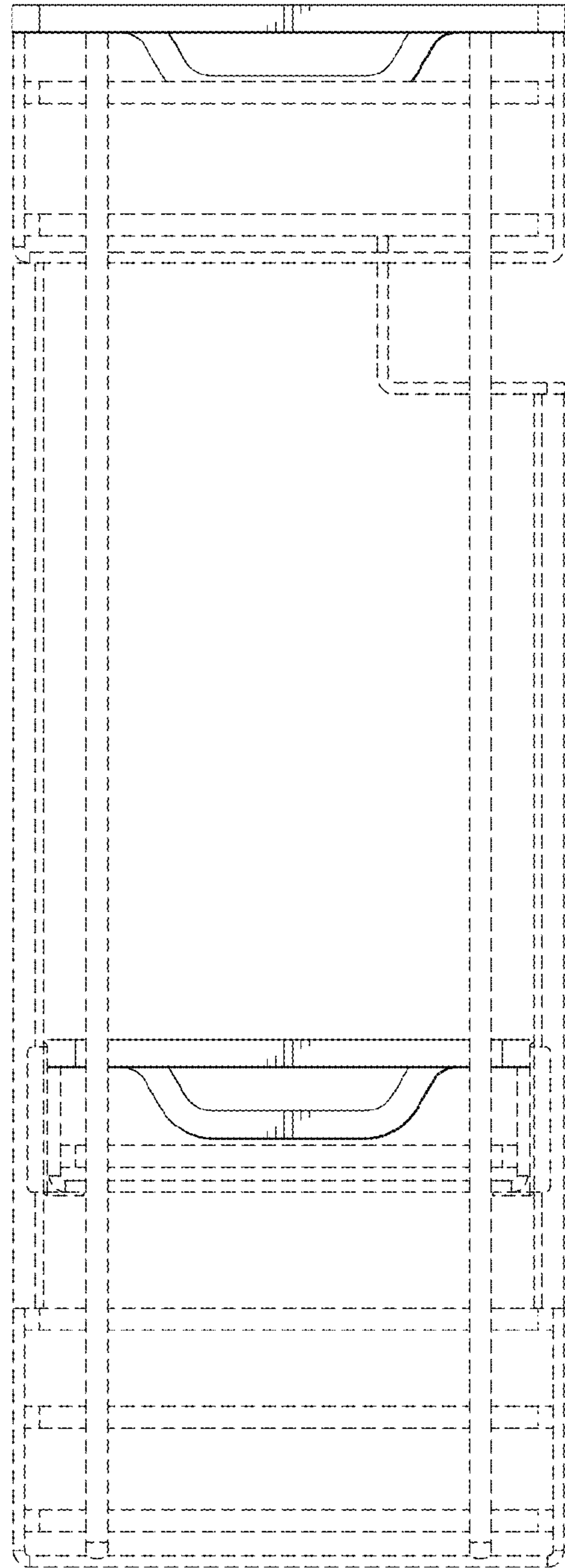

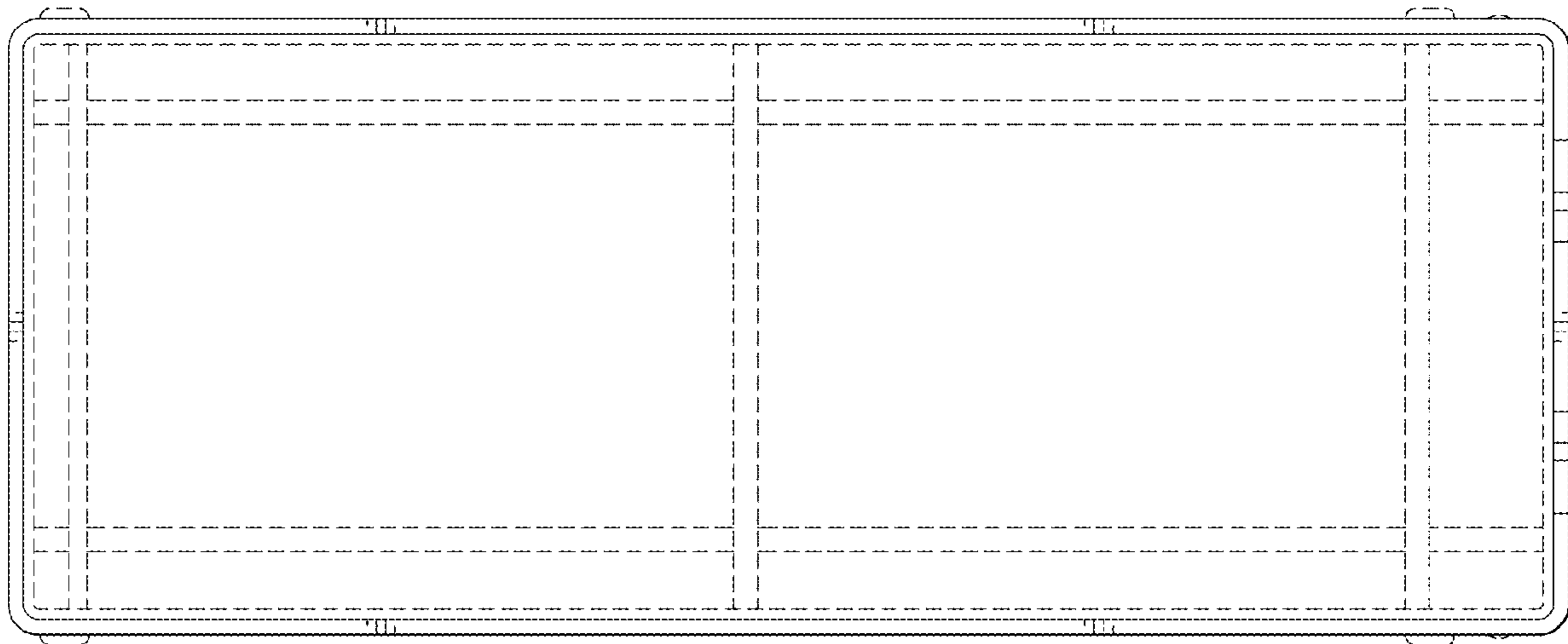

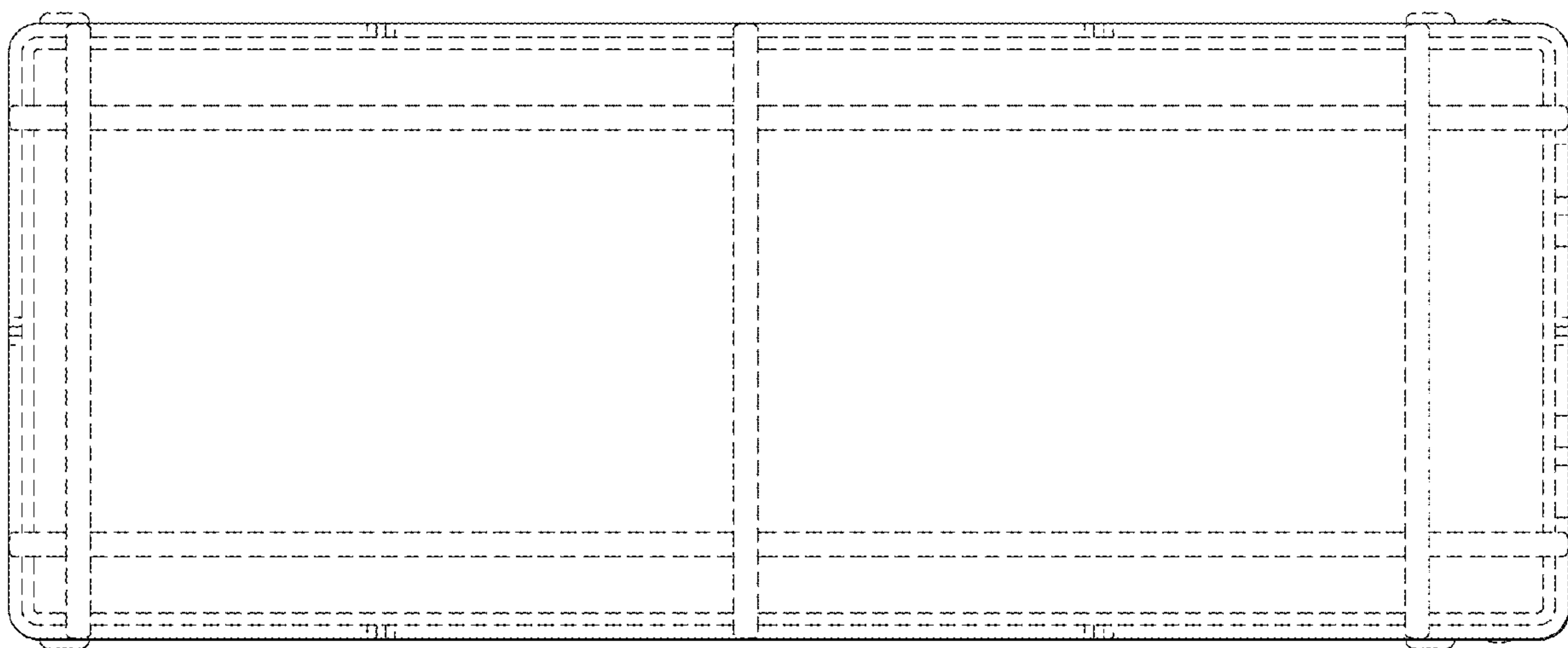

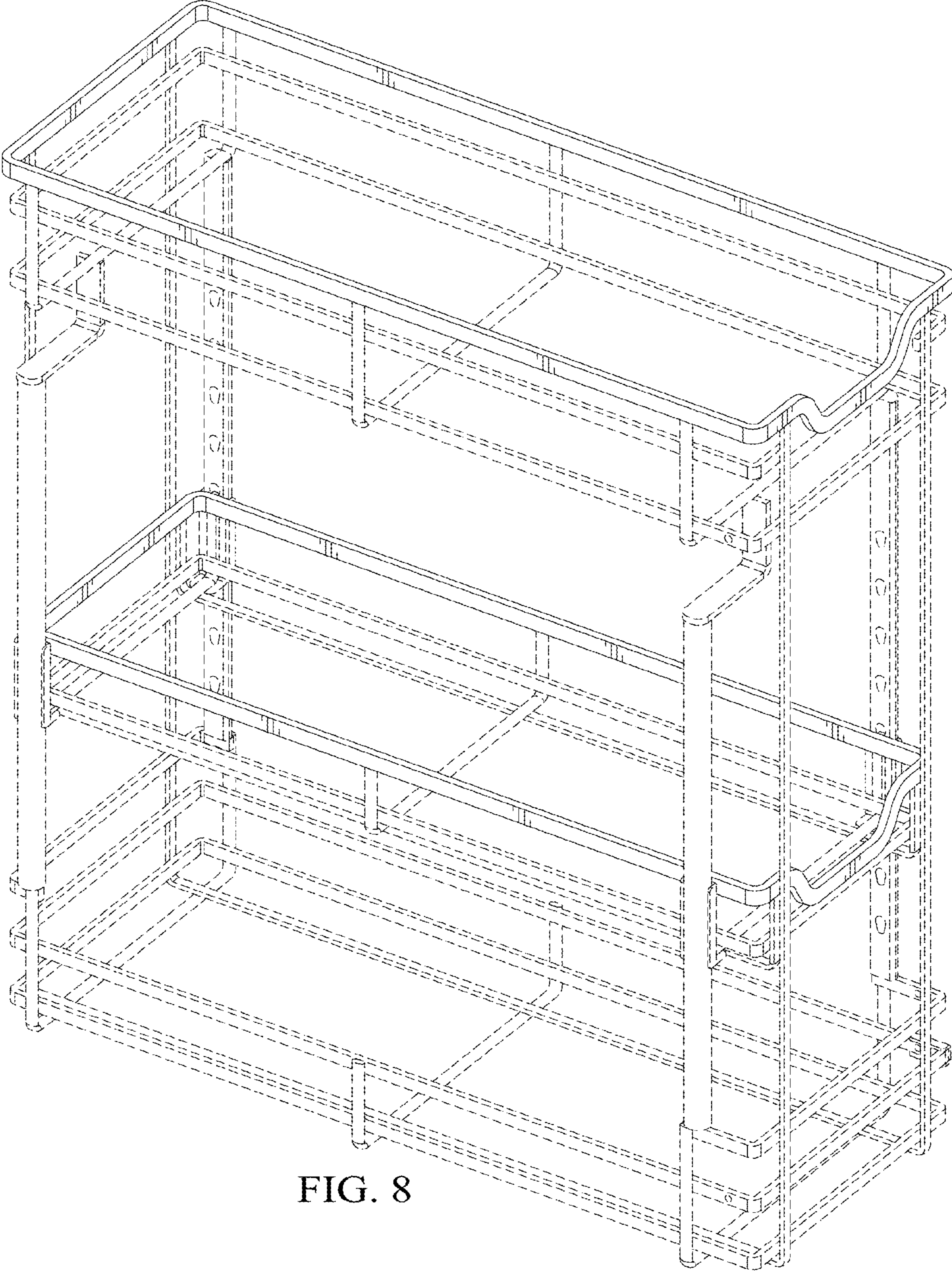

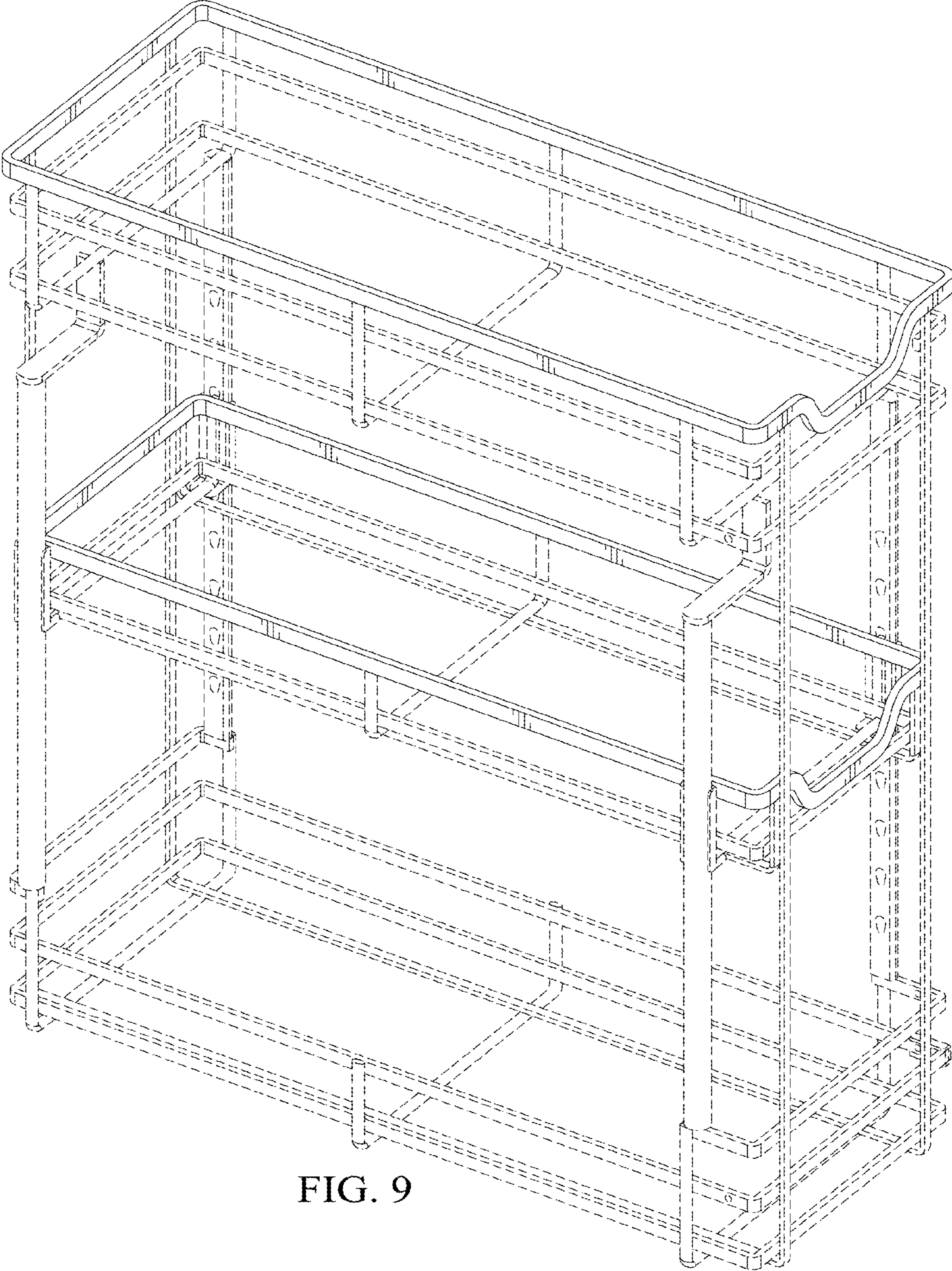

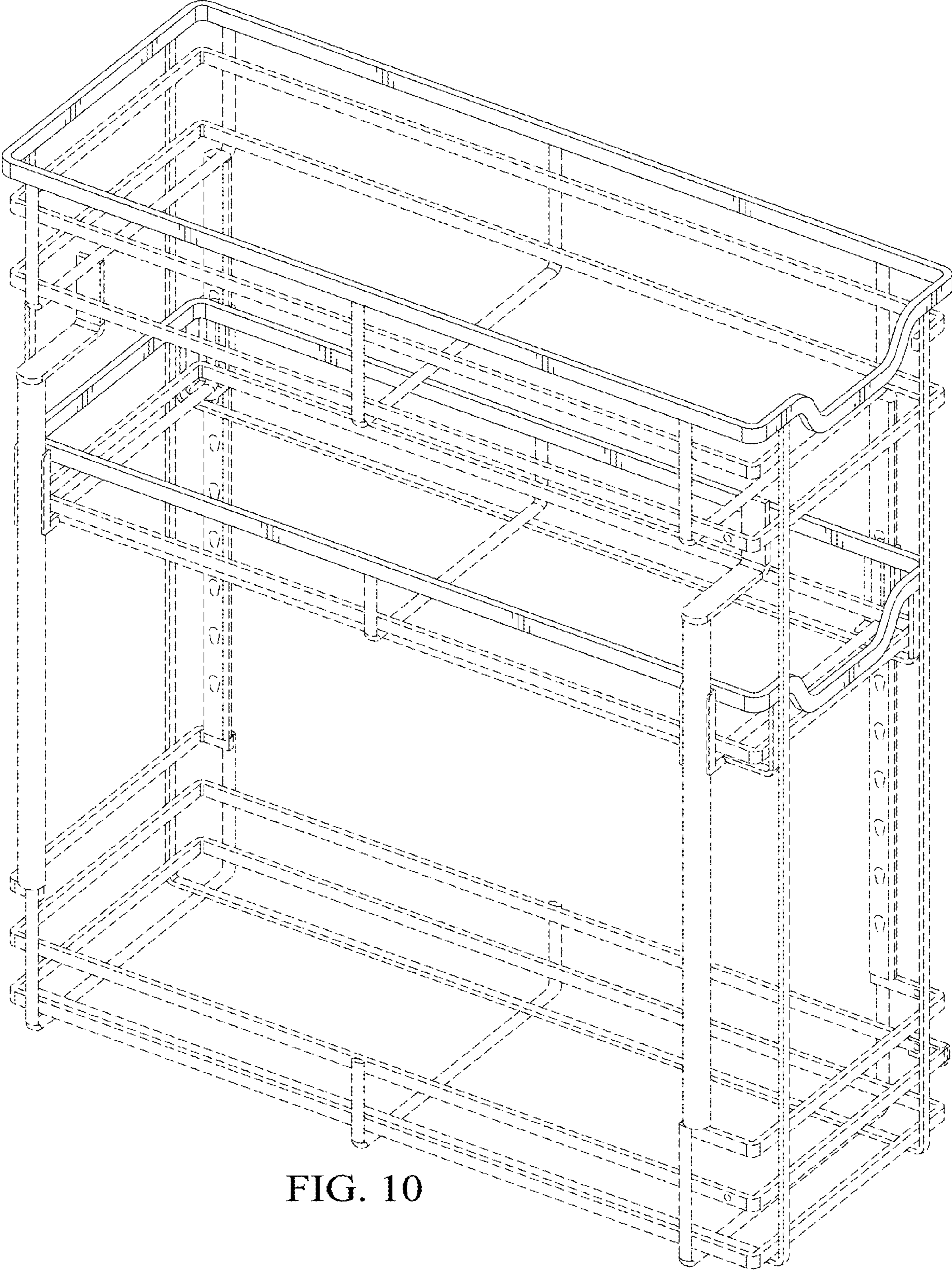
