FIG. 13 is a bottom plan view of the lower detachable fruit bowl.  
The banana hanger and fruit bowl are shown separately for clarity of illustration.

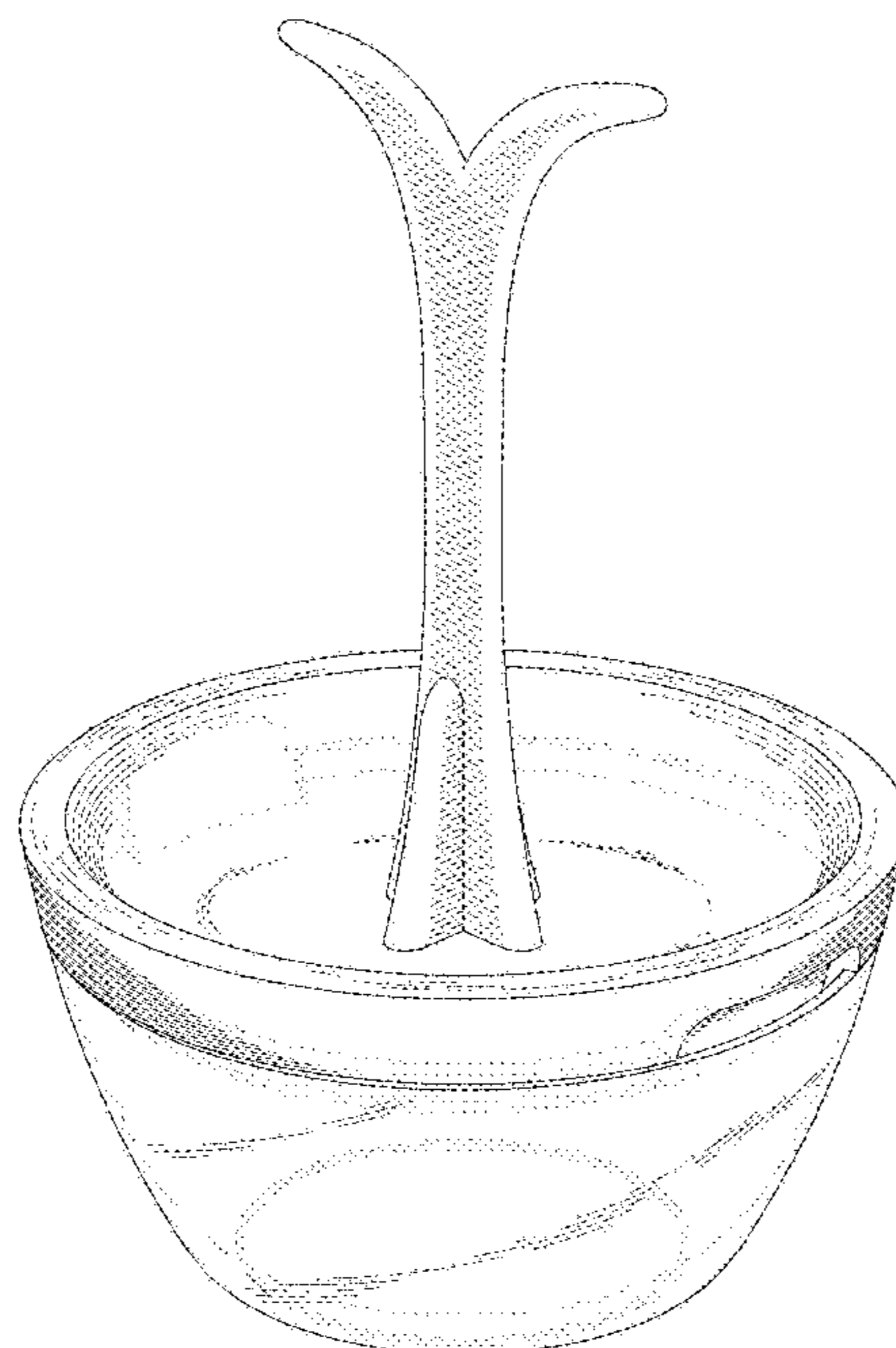

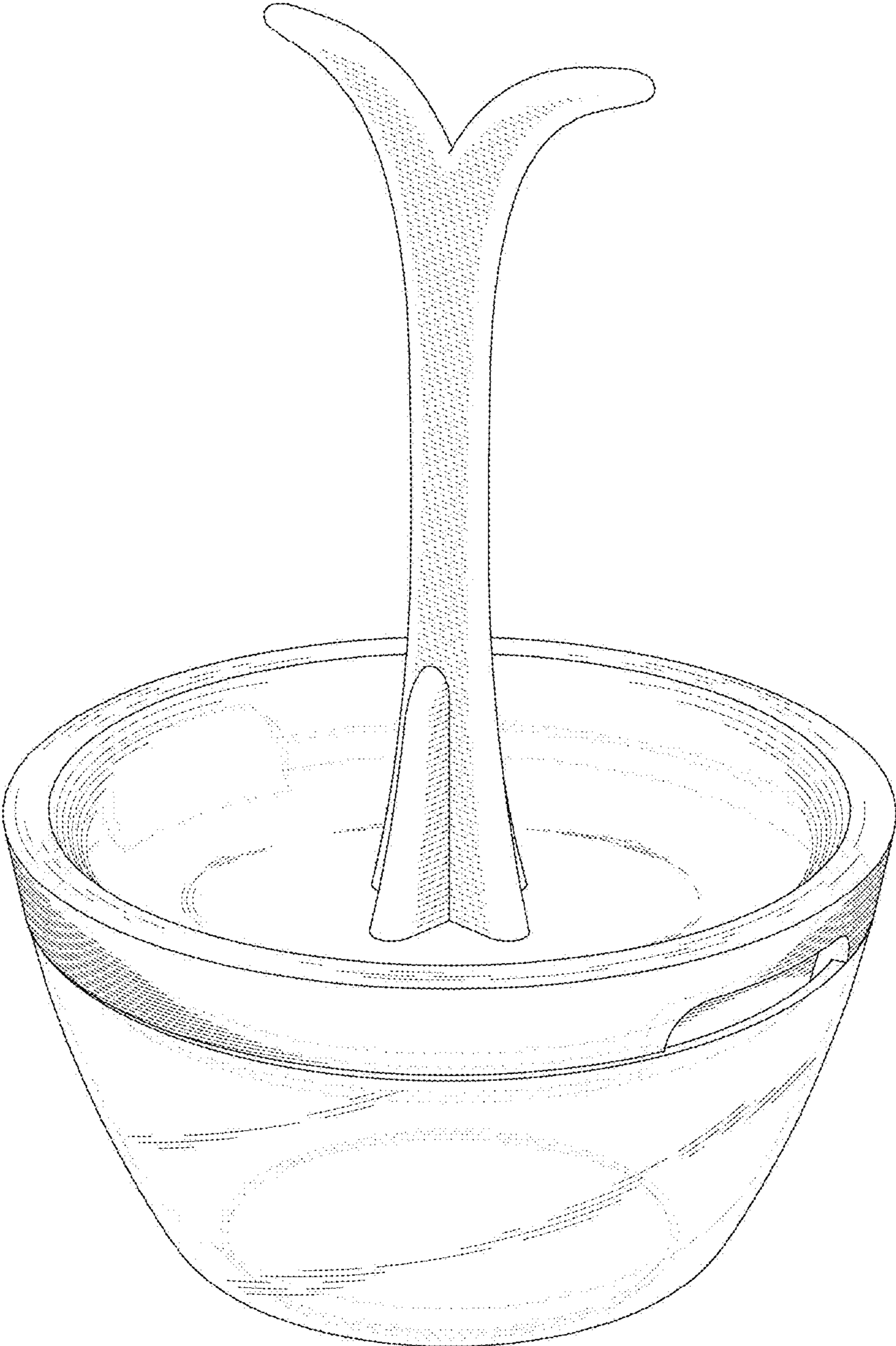

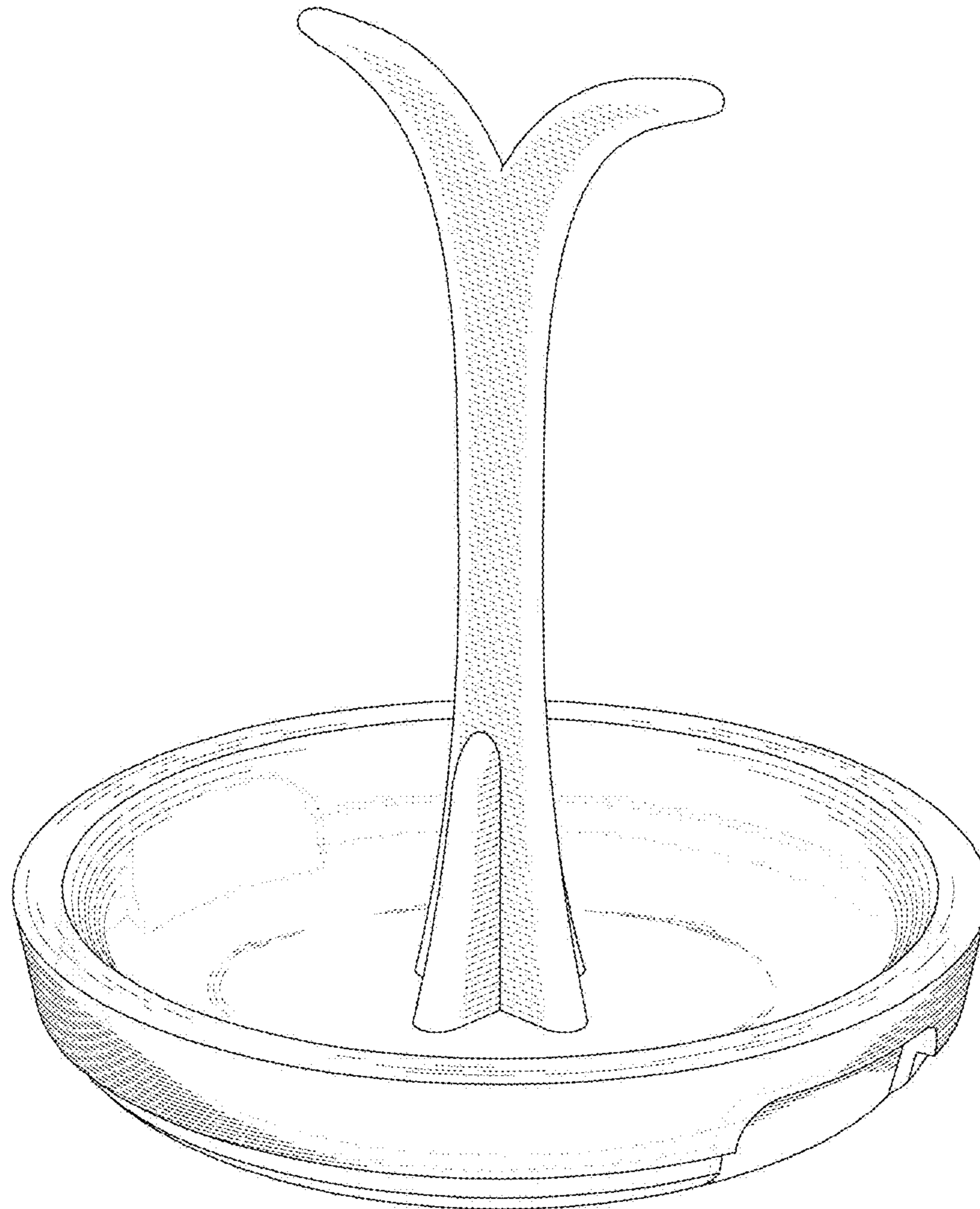

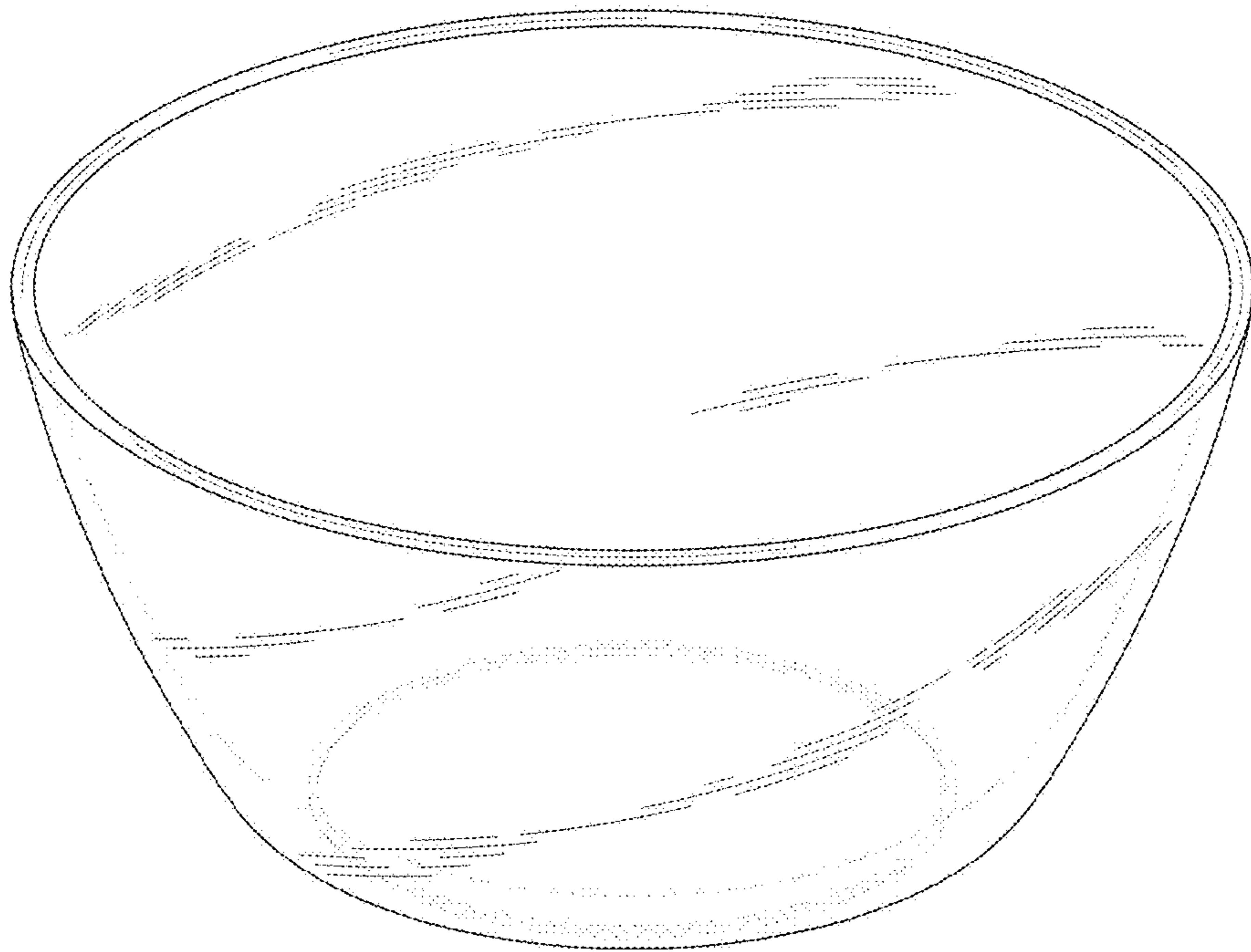

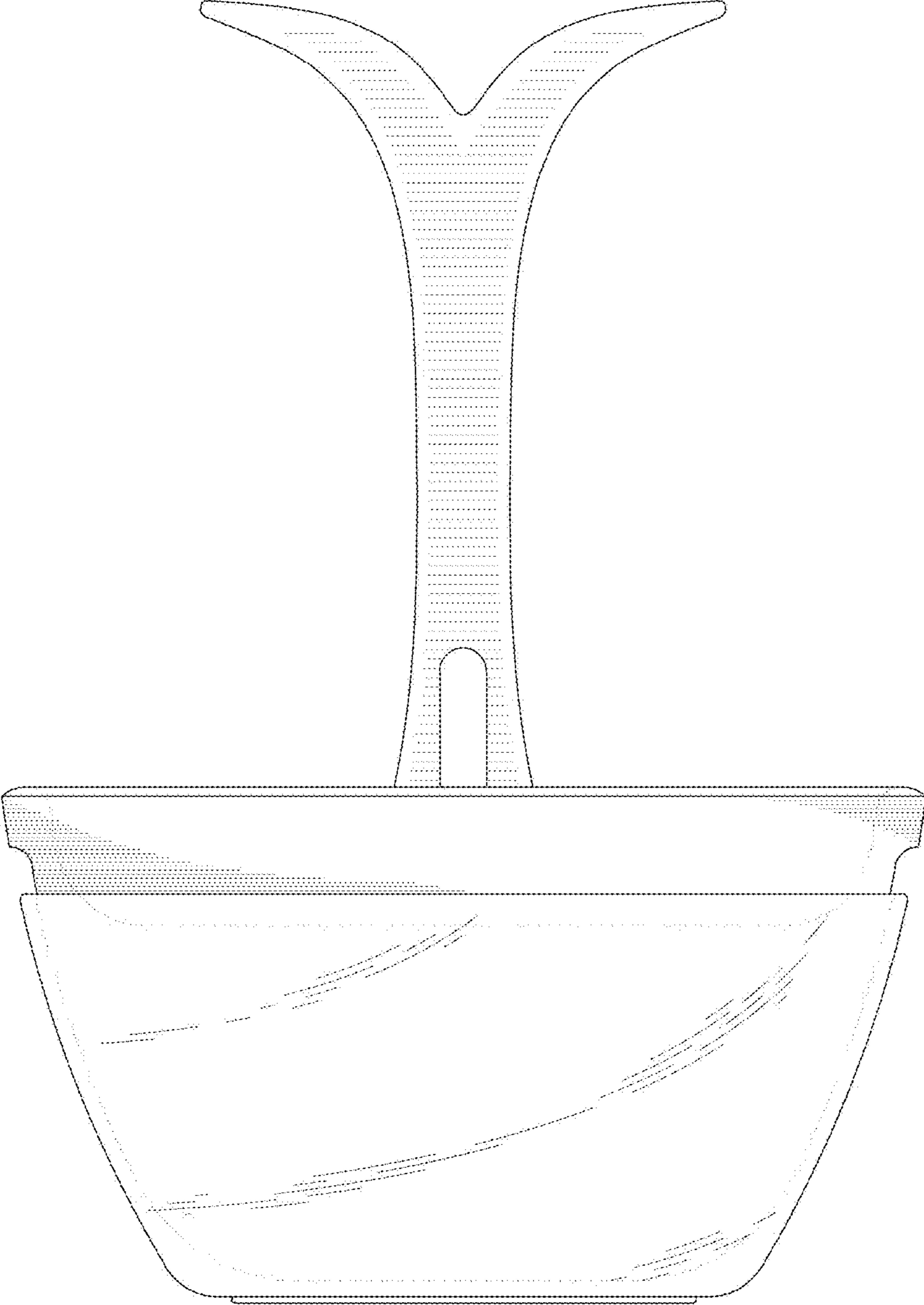

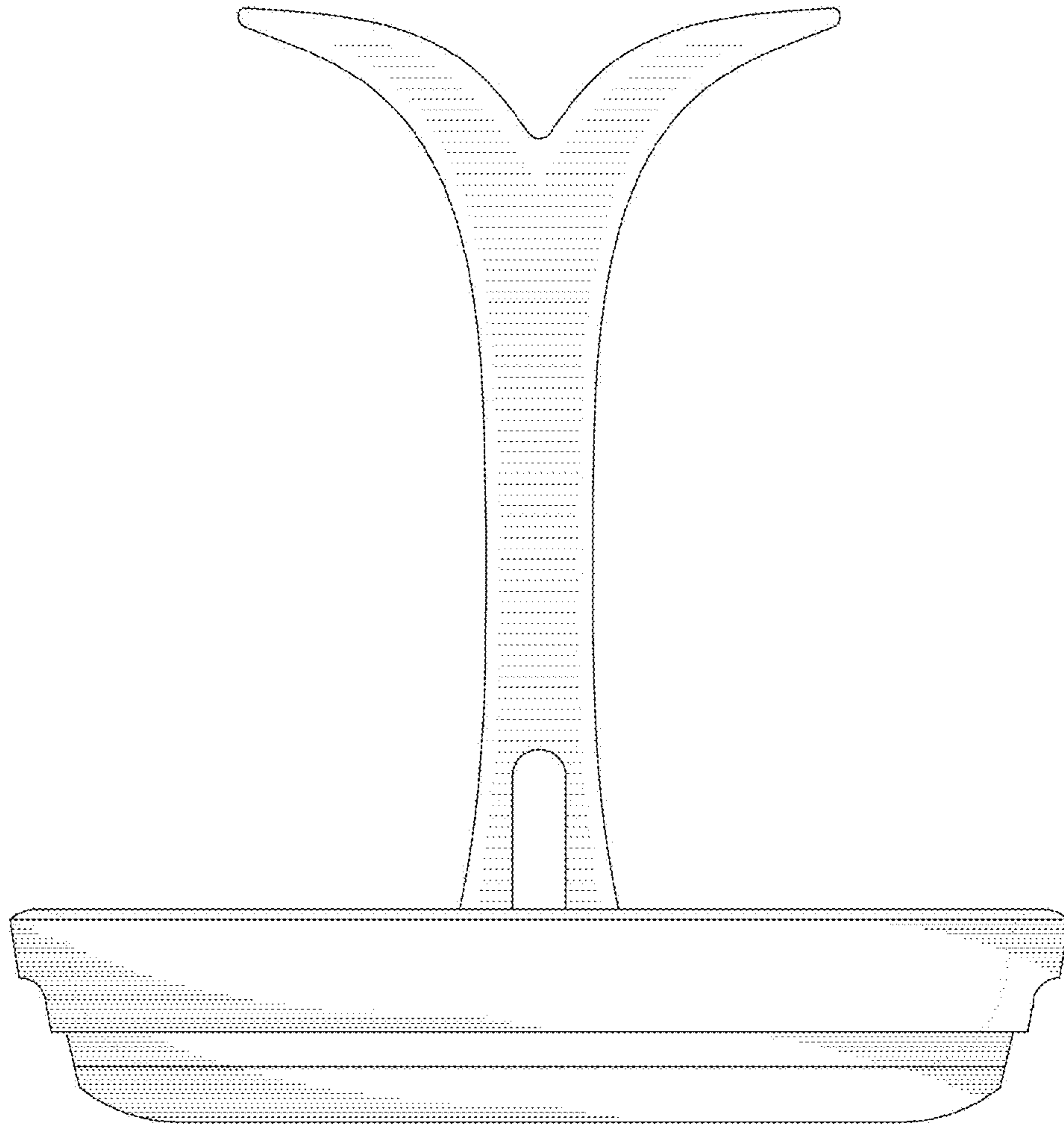

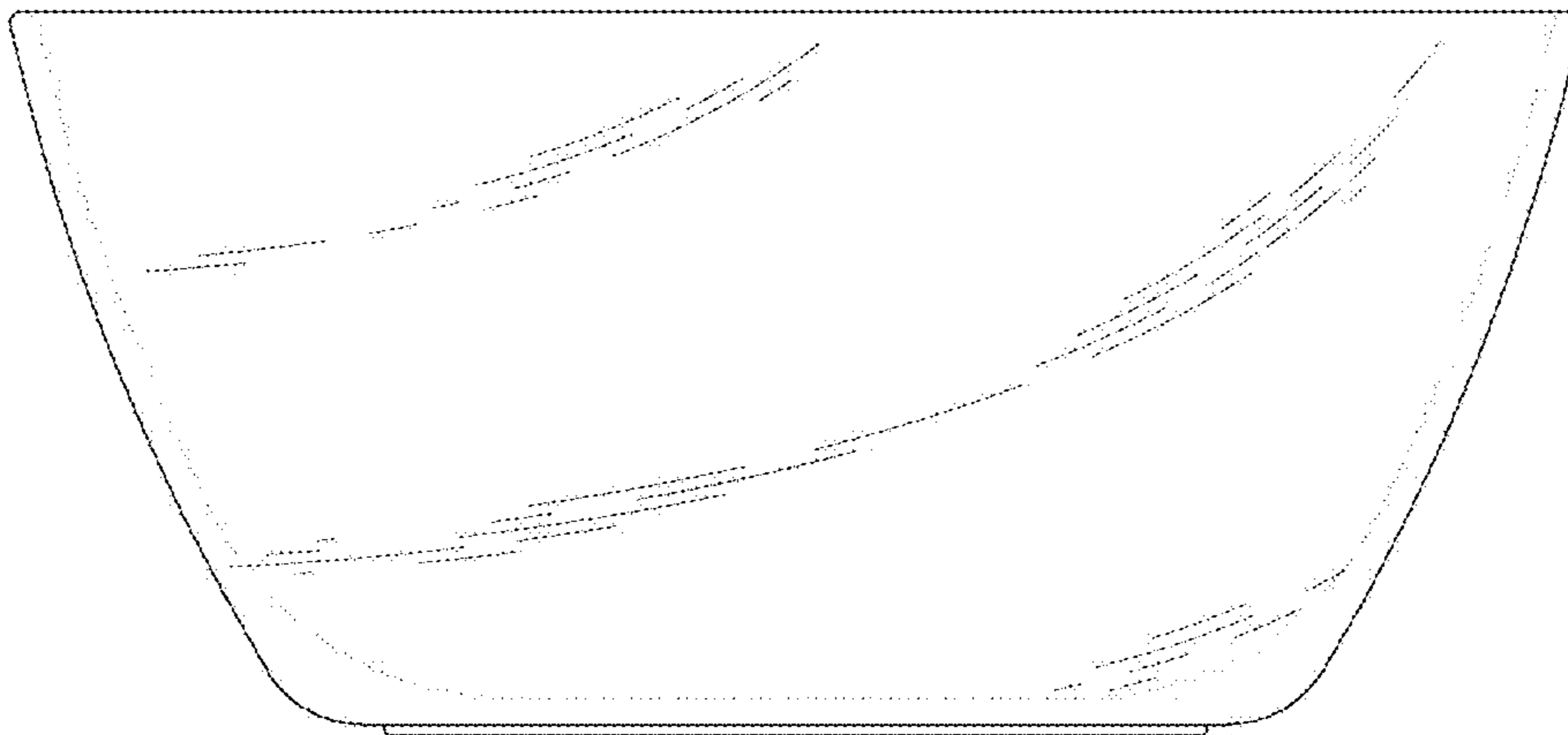

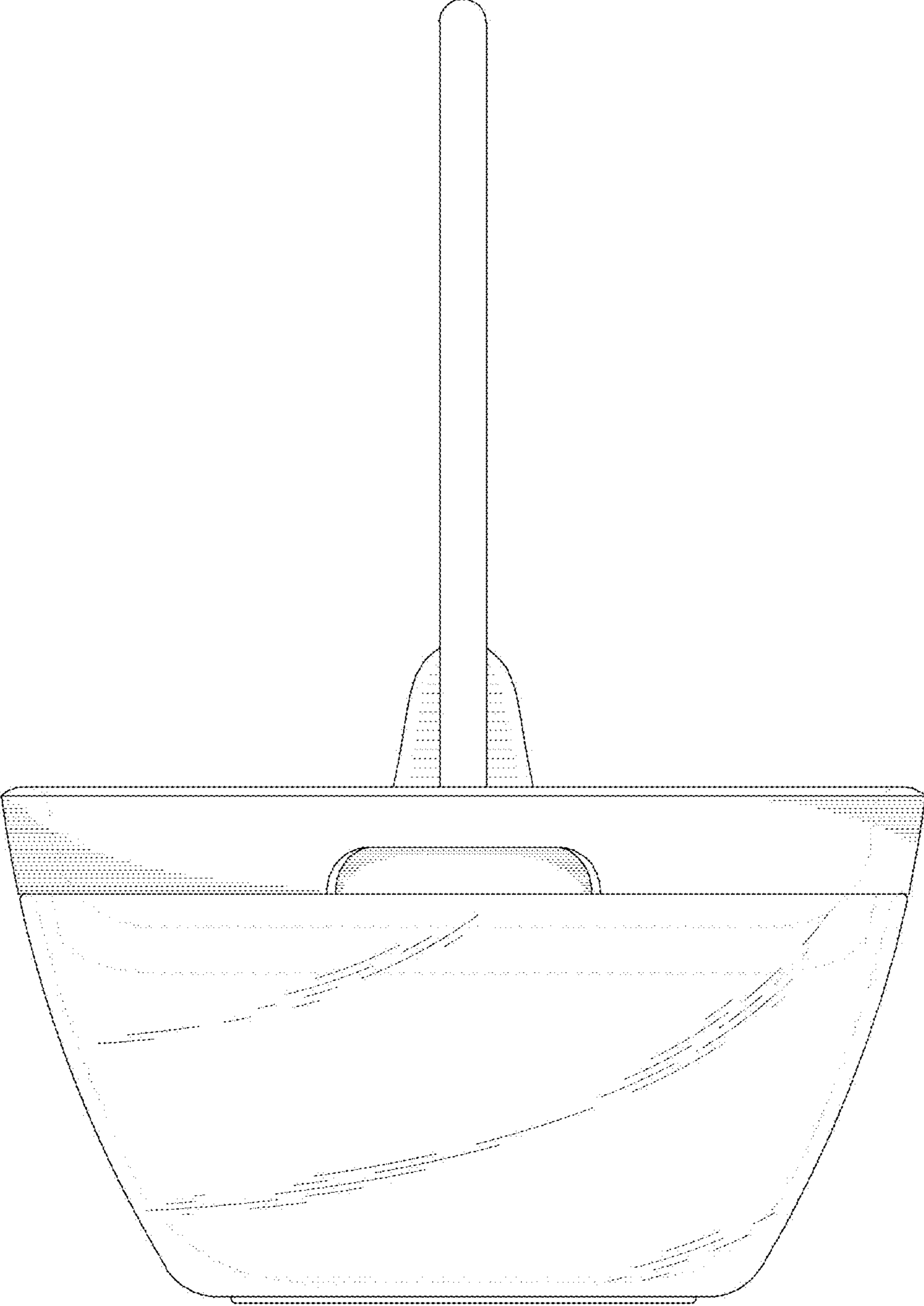

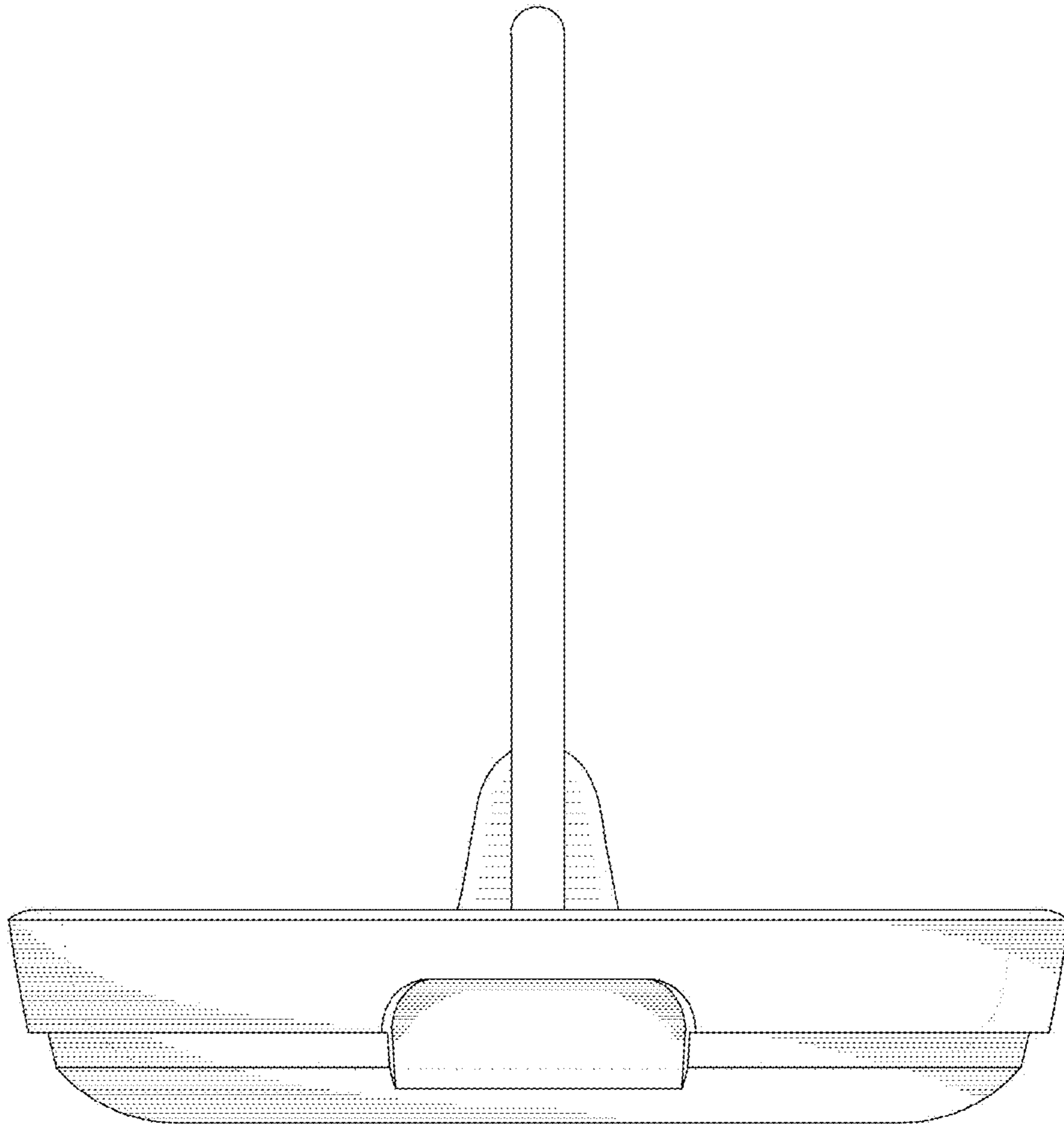

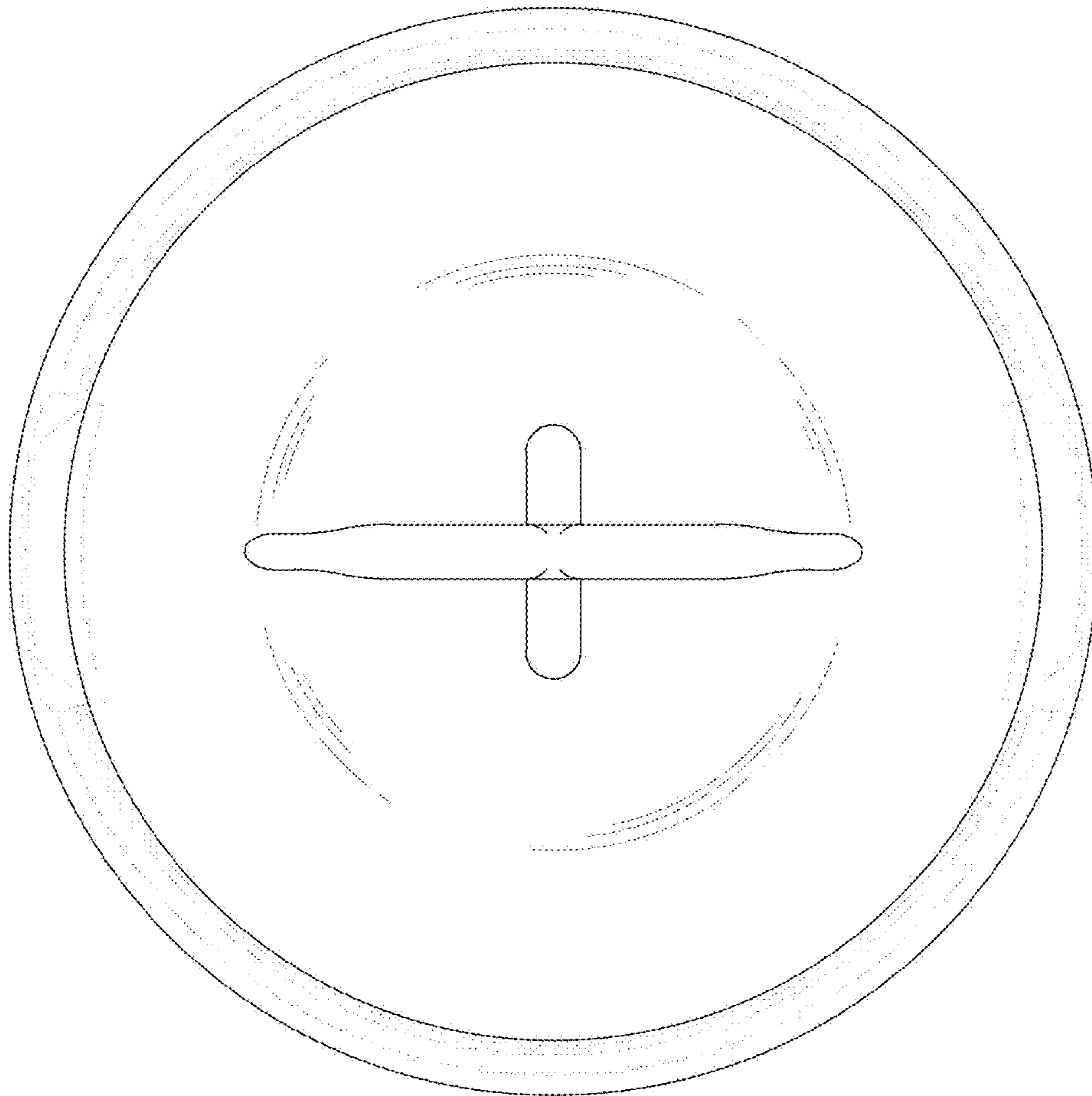

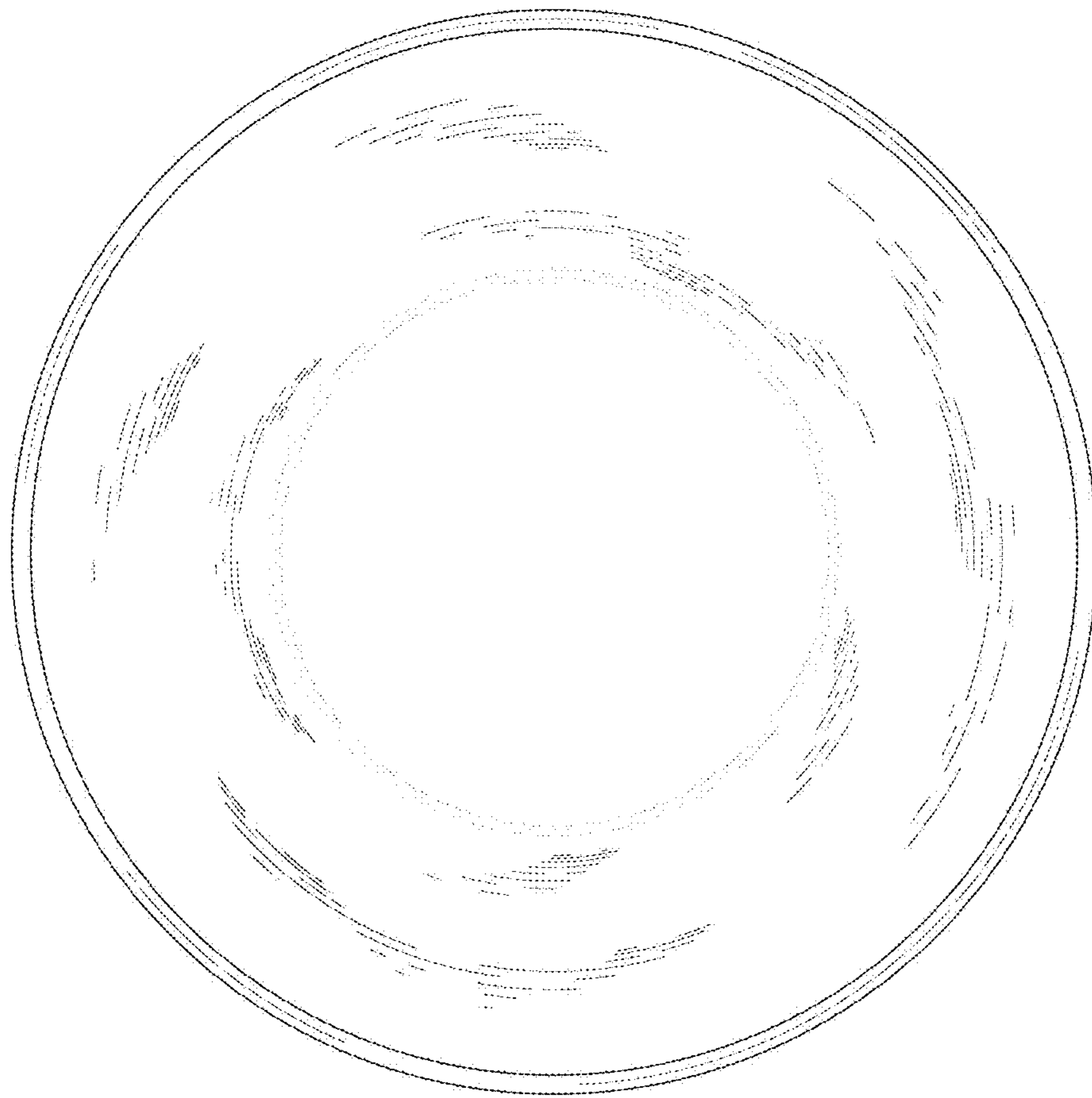

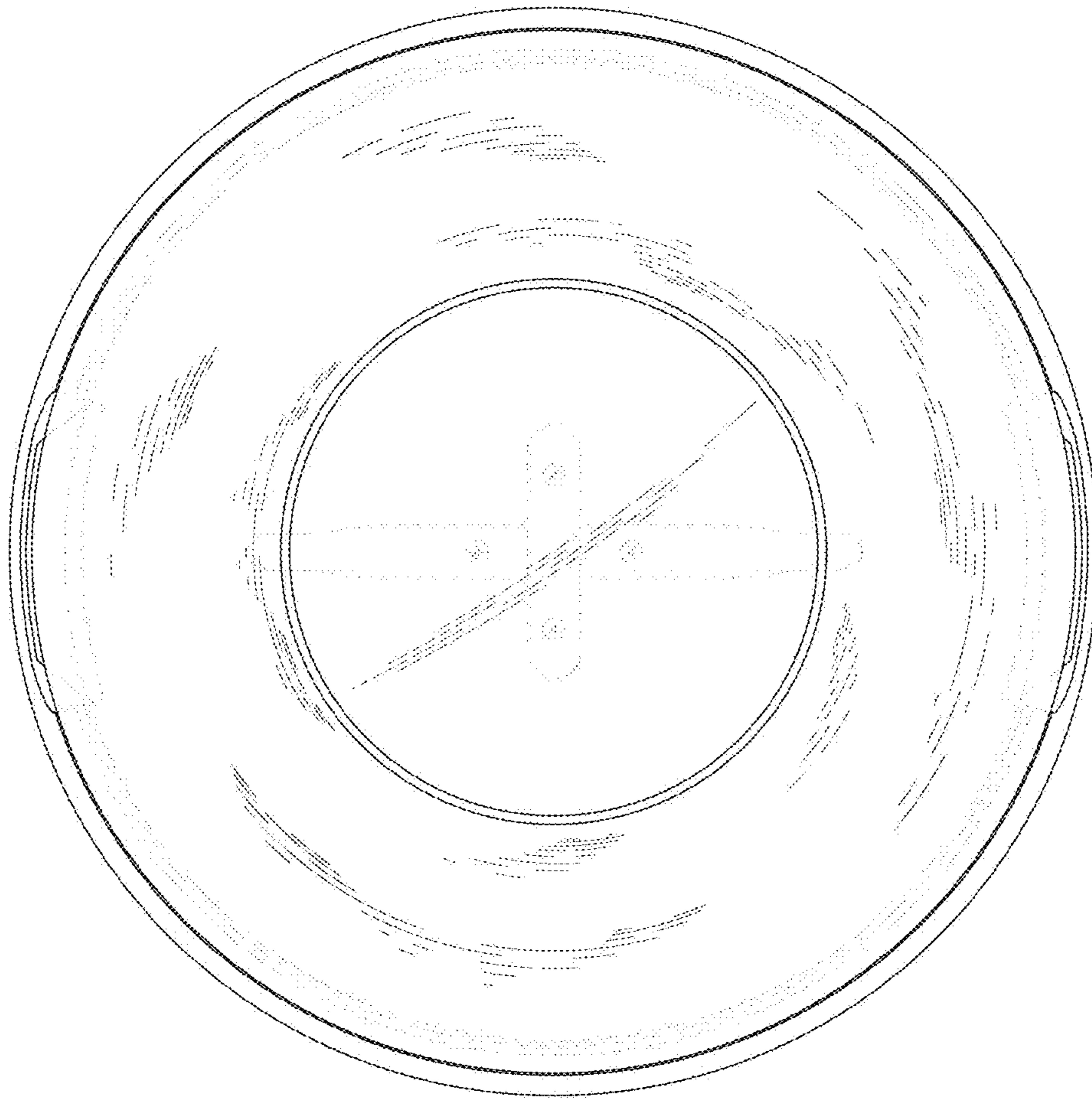

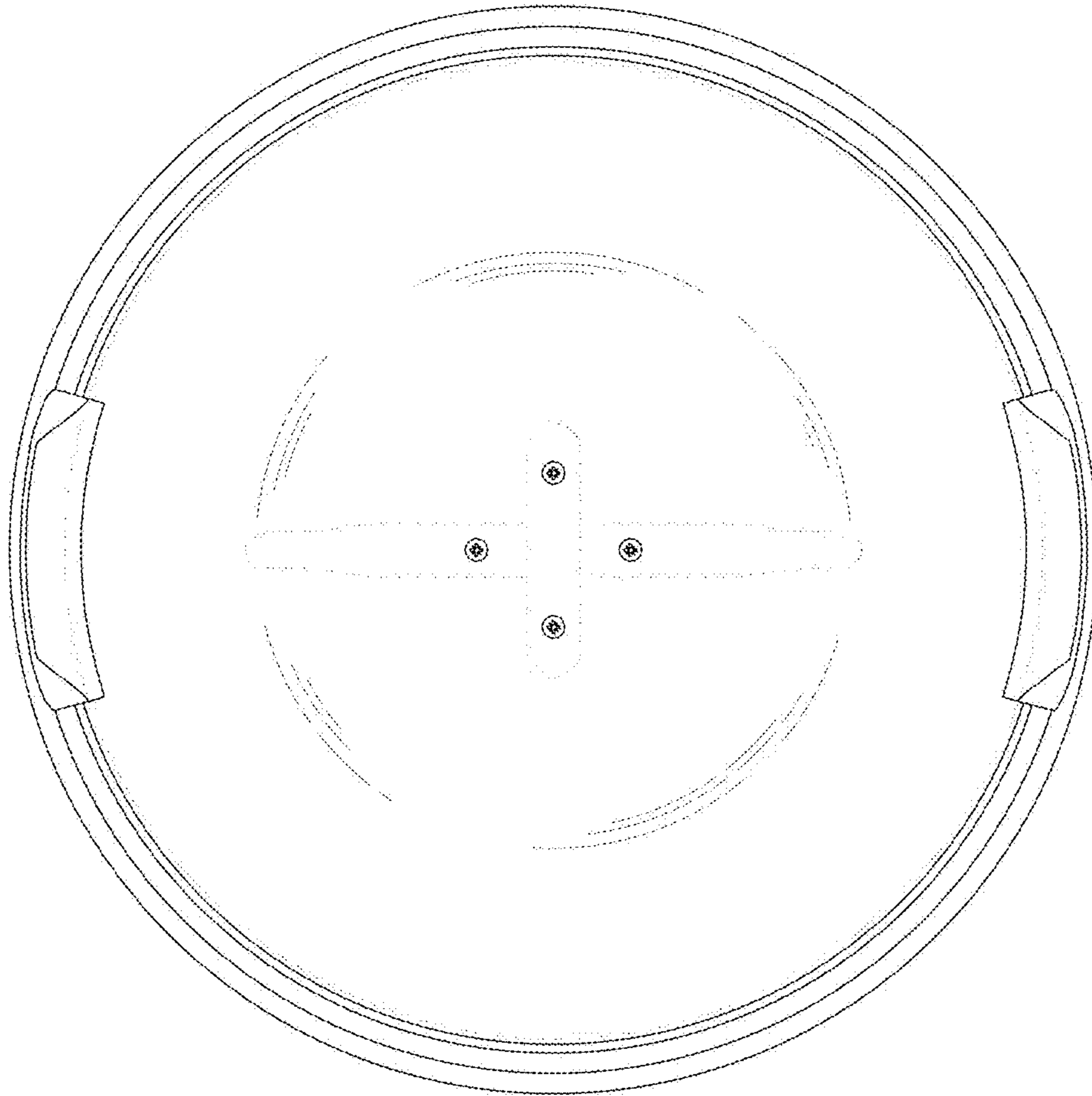

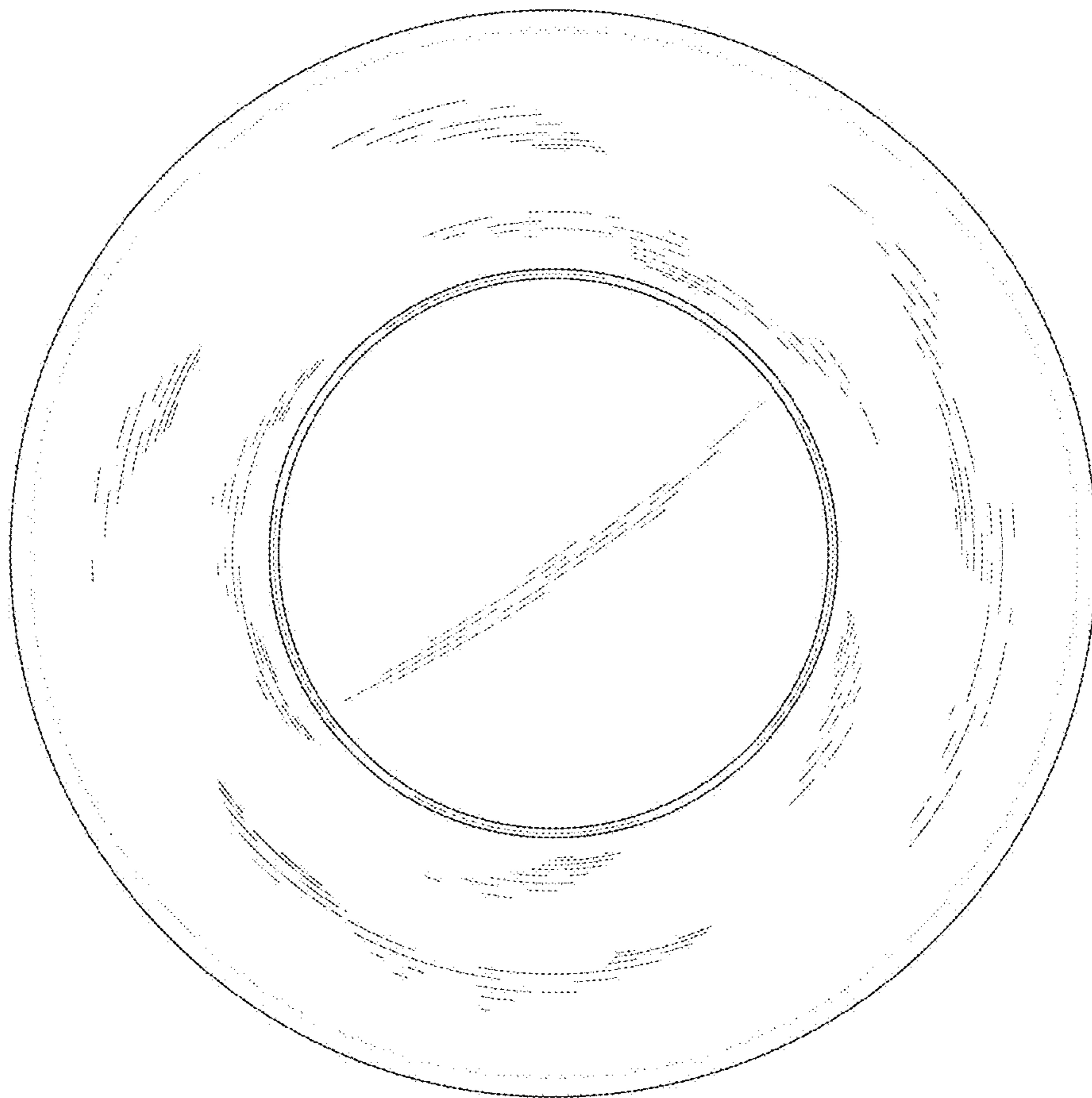
