We claim the ornamental design for a one piece side rail cover shifter rail for filter press, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a one piece side rail cover shifter rail for filter press showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a back view thereof; and,
FIG. 5 is a cross sectional view thereof taken along line 5-5 of FIG. 4.

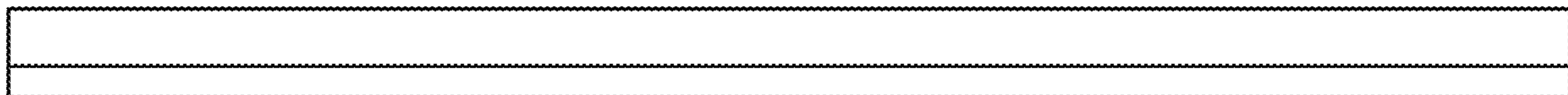

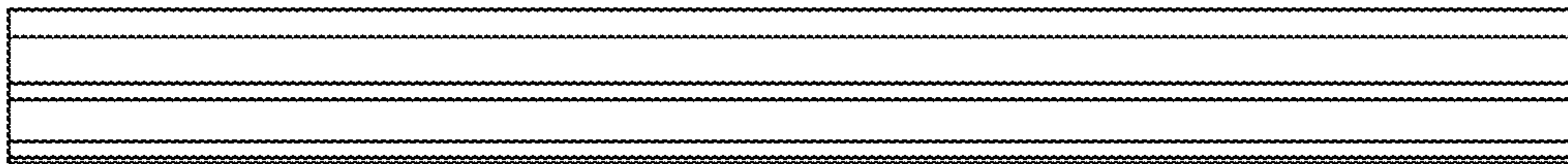

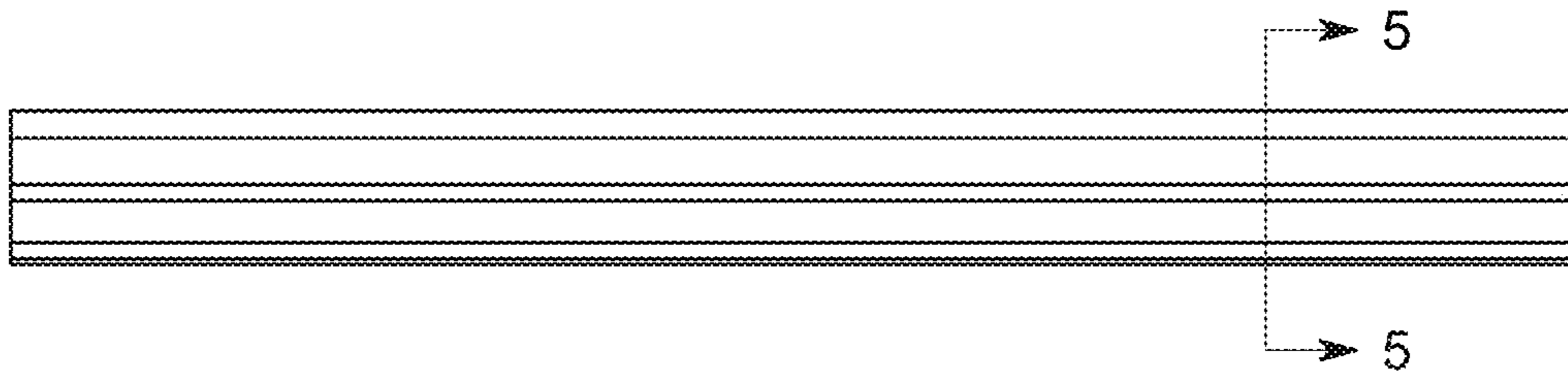

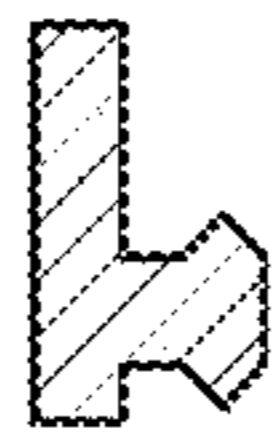
