DESCRIPTION

FIG. 1 is a front side view of a stopper for a water bladder; FIG. 2 is a left side view of the stopper for the water bladder; FIG. 3 is a right side view of the stopper for the water bladder; FIG. 4 is a top view of the stopper for the water bladder; FIG. 5 is a bottom view of the stopper for the water bladder; and, FIG. 6 is a back side view of the stopper for the water bladder. In the drawings, the broken lines show portions of a water bladder that form no part of the claim.

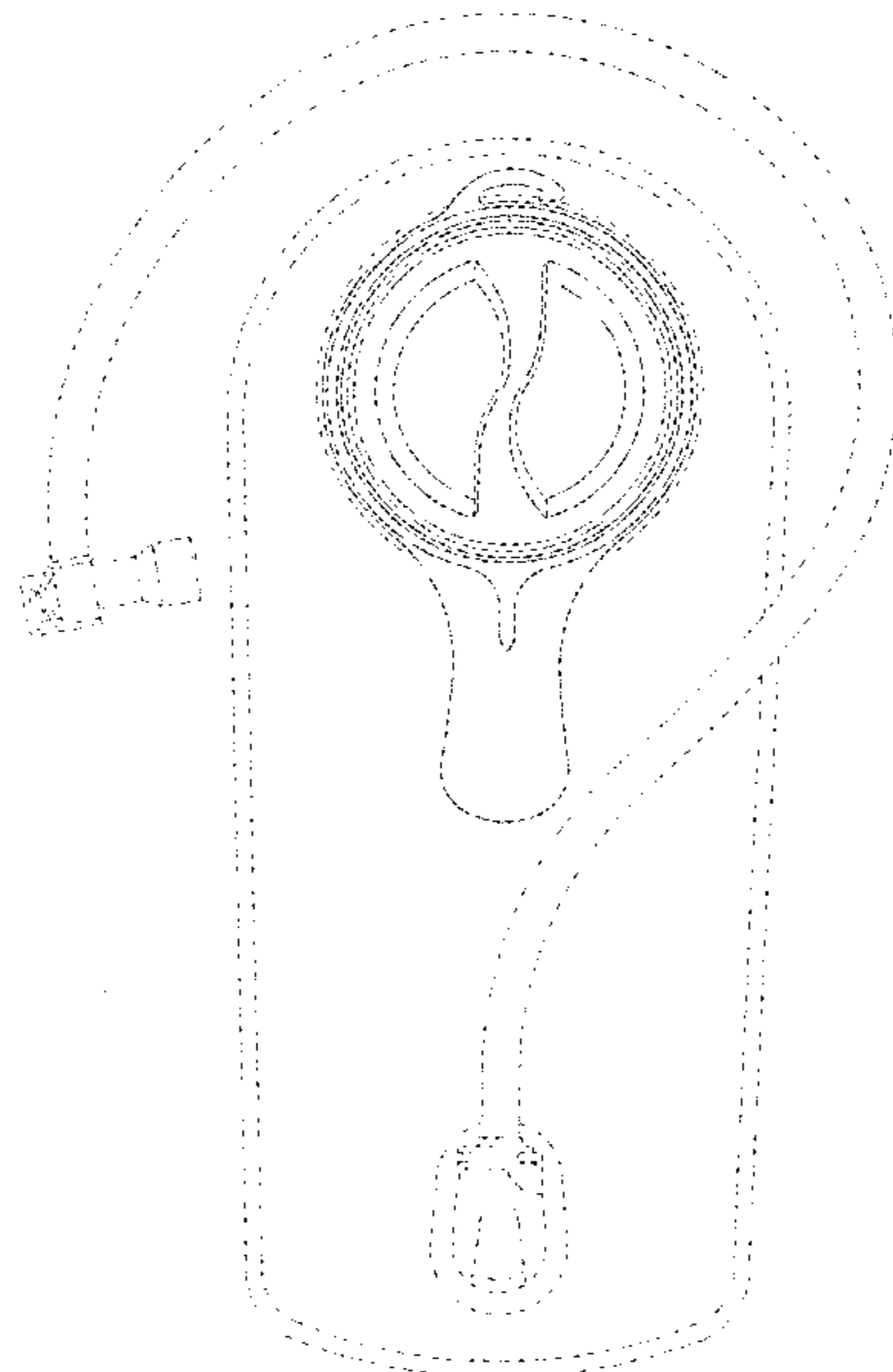
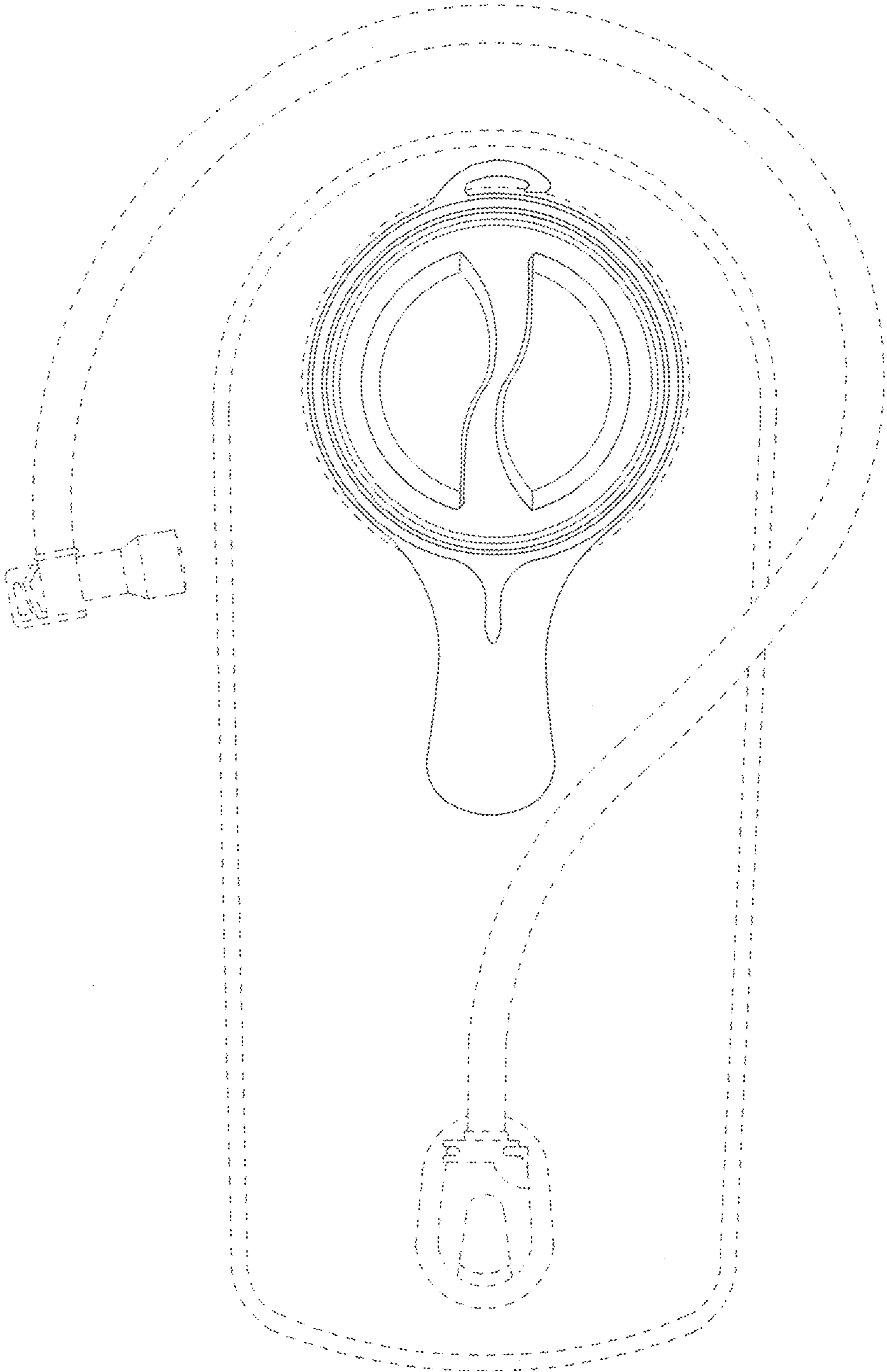

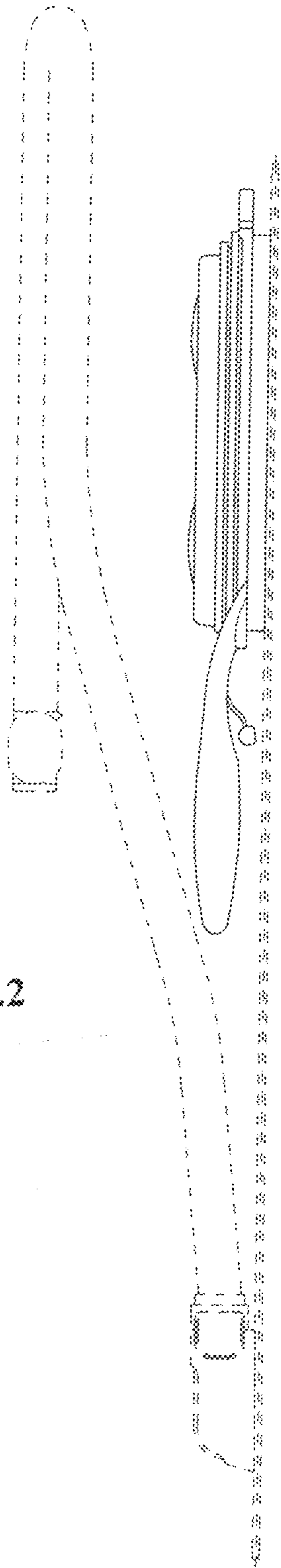

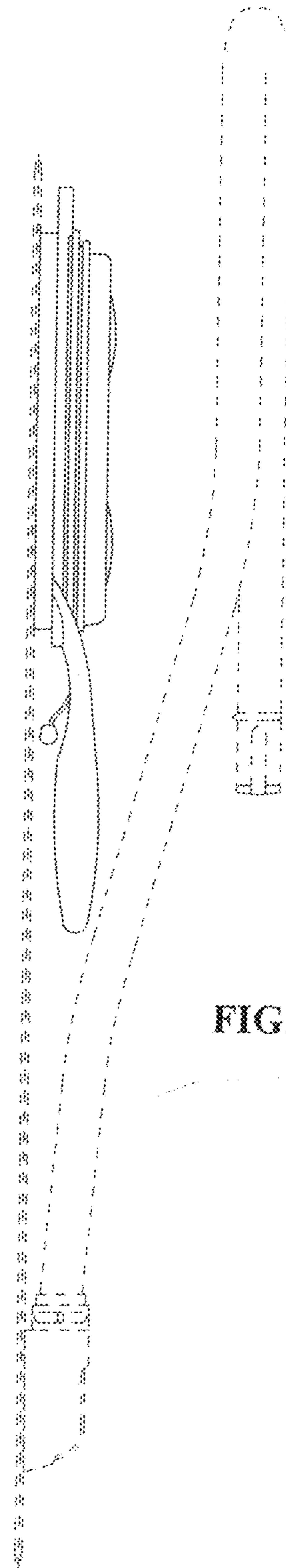

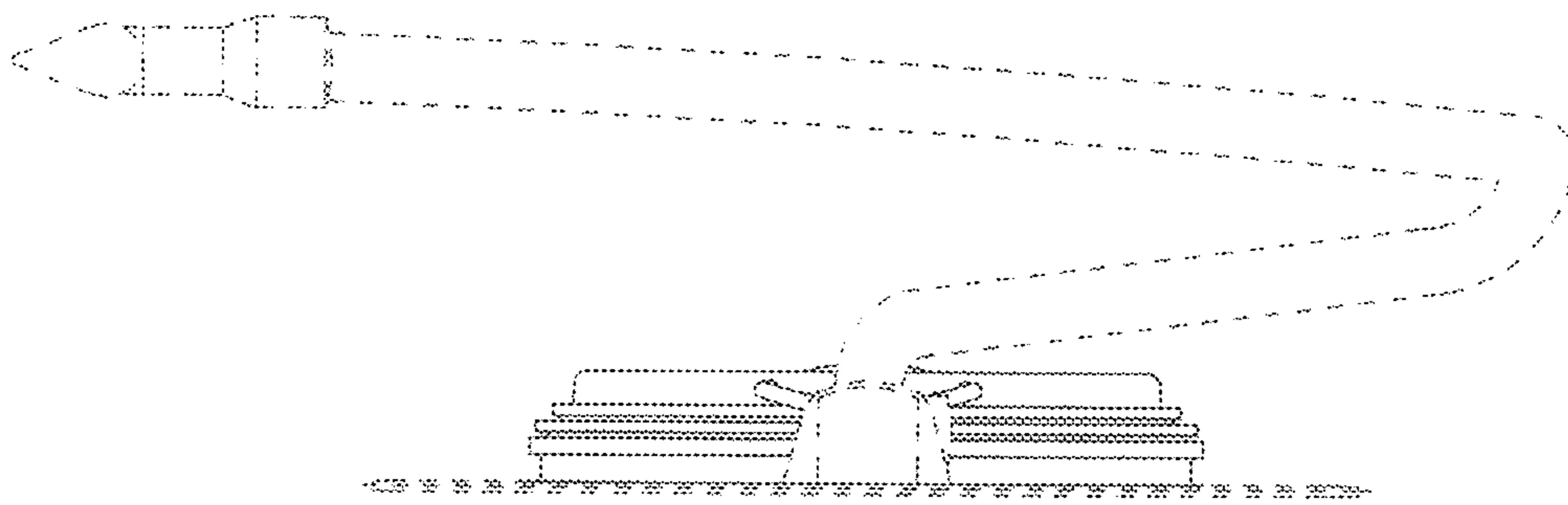
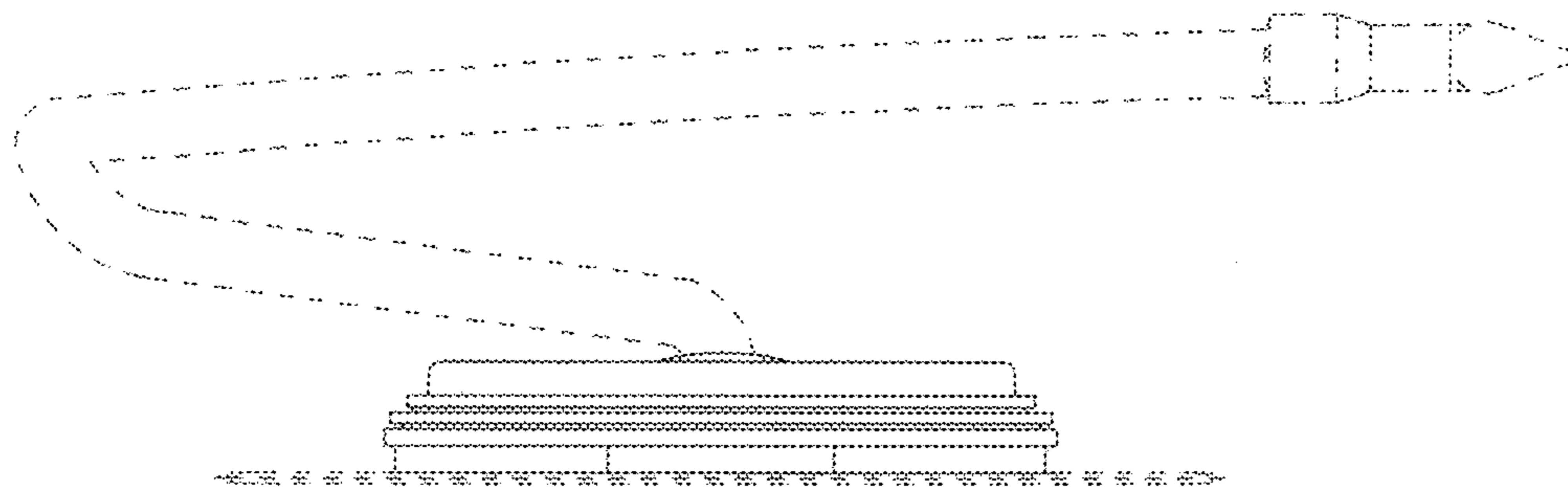

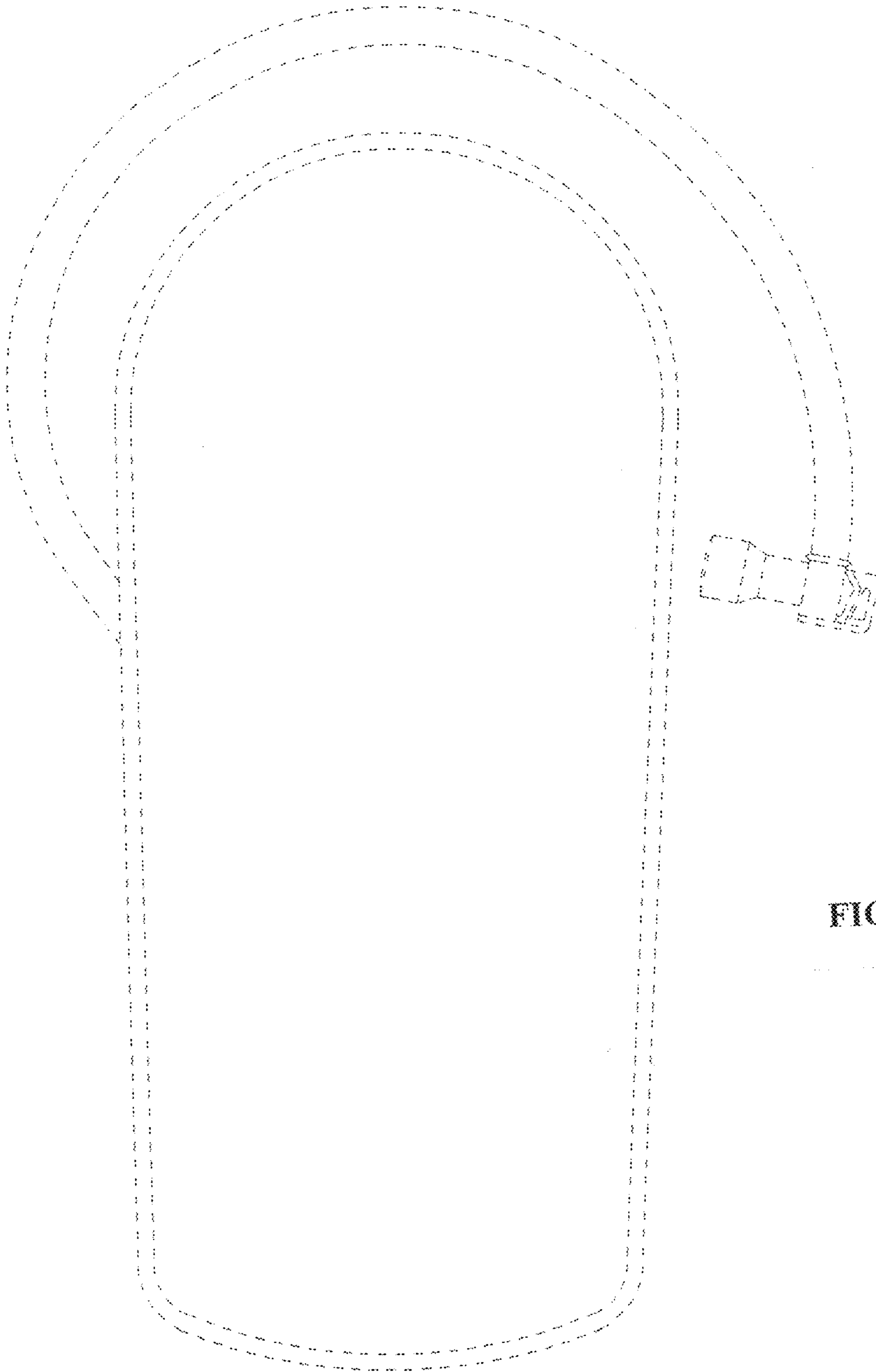
