FIG. 15 is a front view of a fourth embodiment of a wristband shown with a charm;

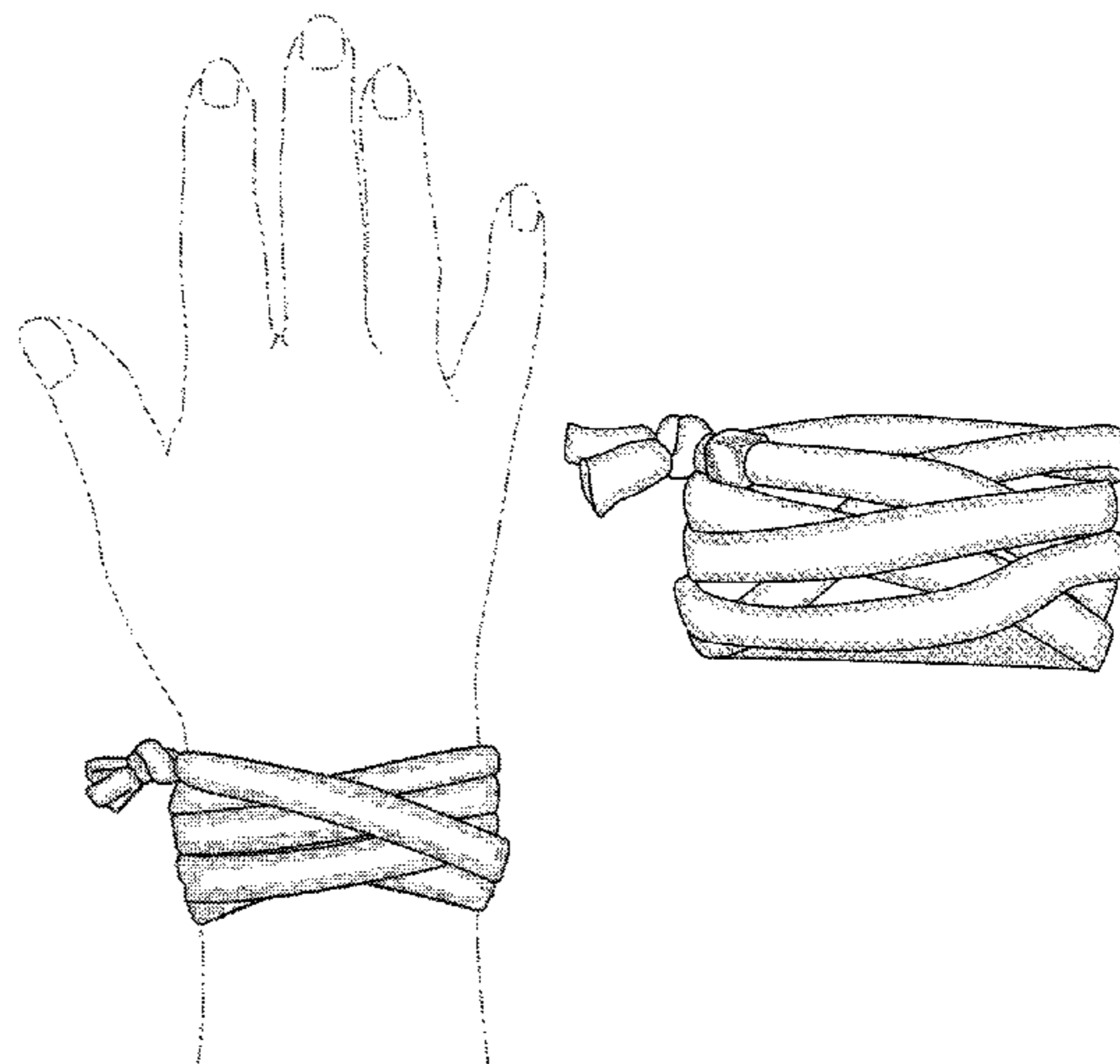
FIG. 16 is a side view therefore shown without the charm;

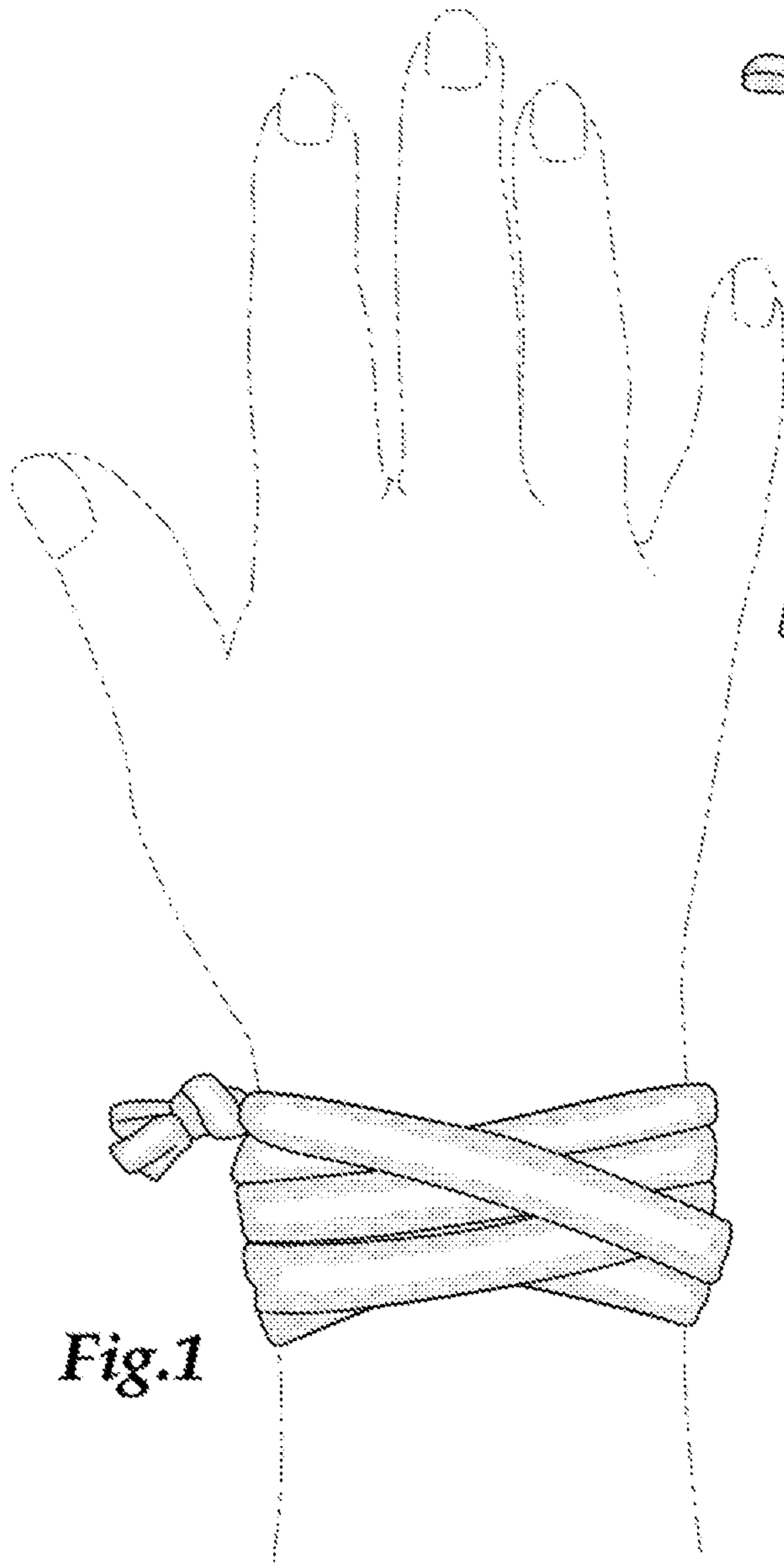

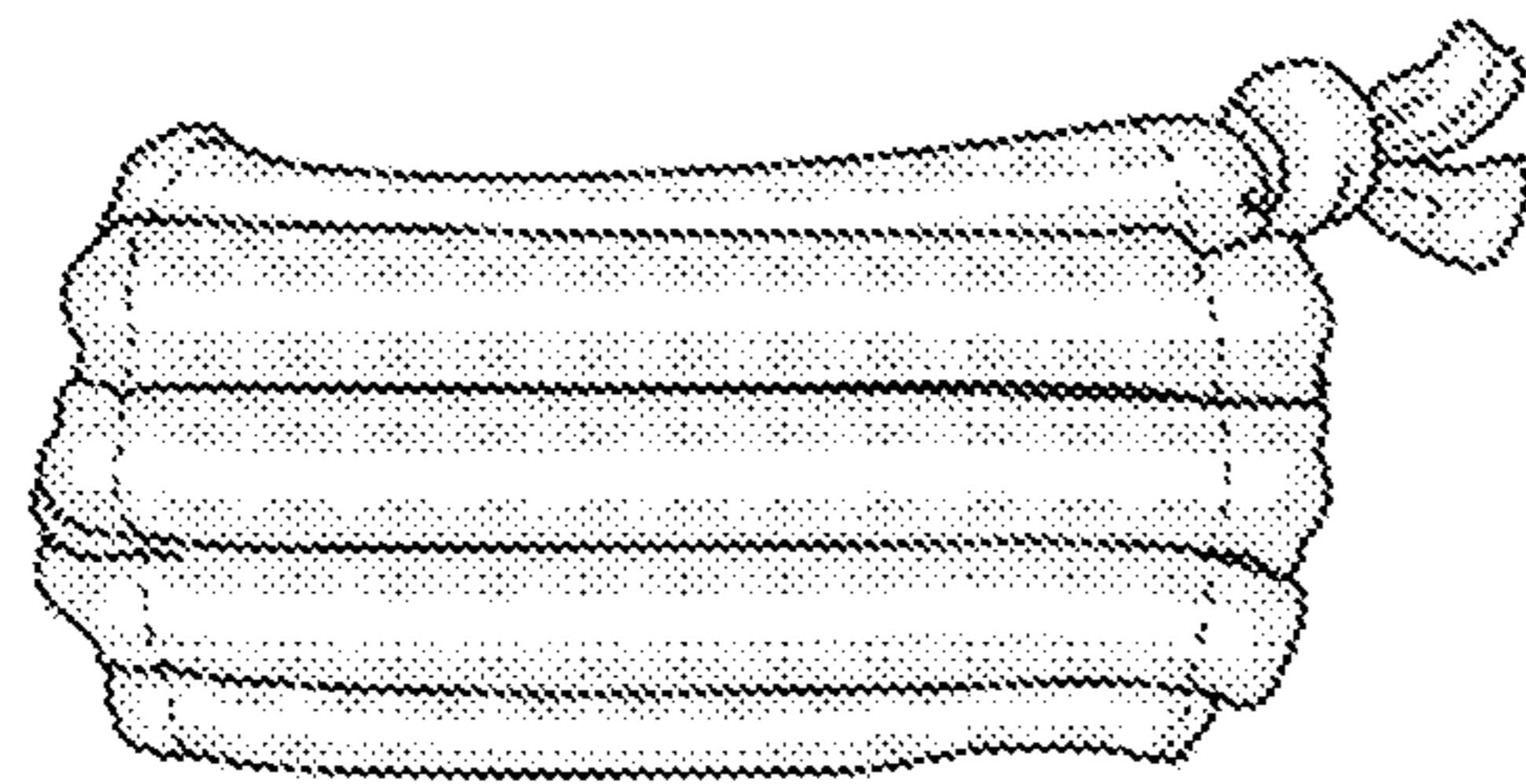

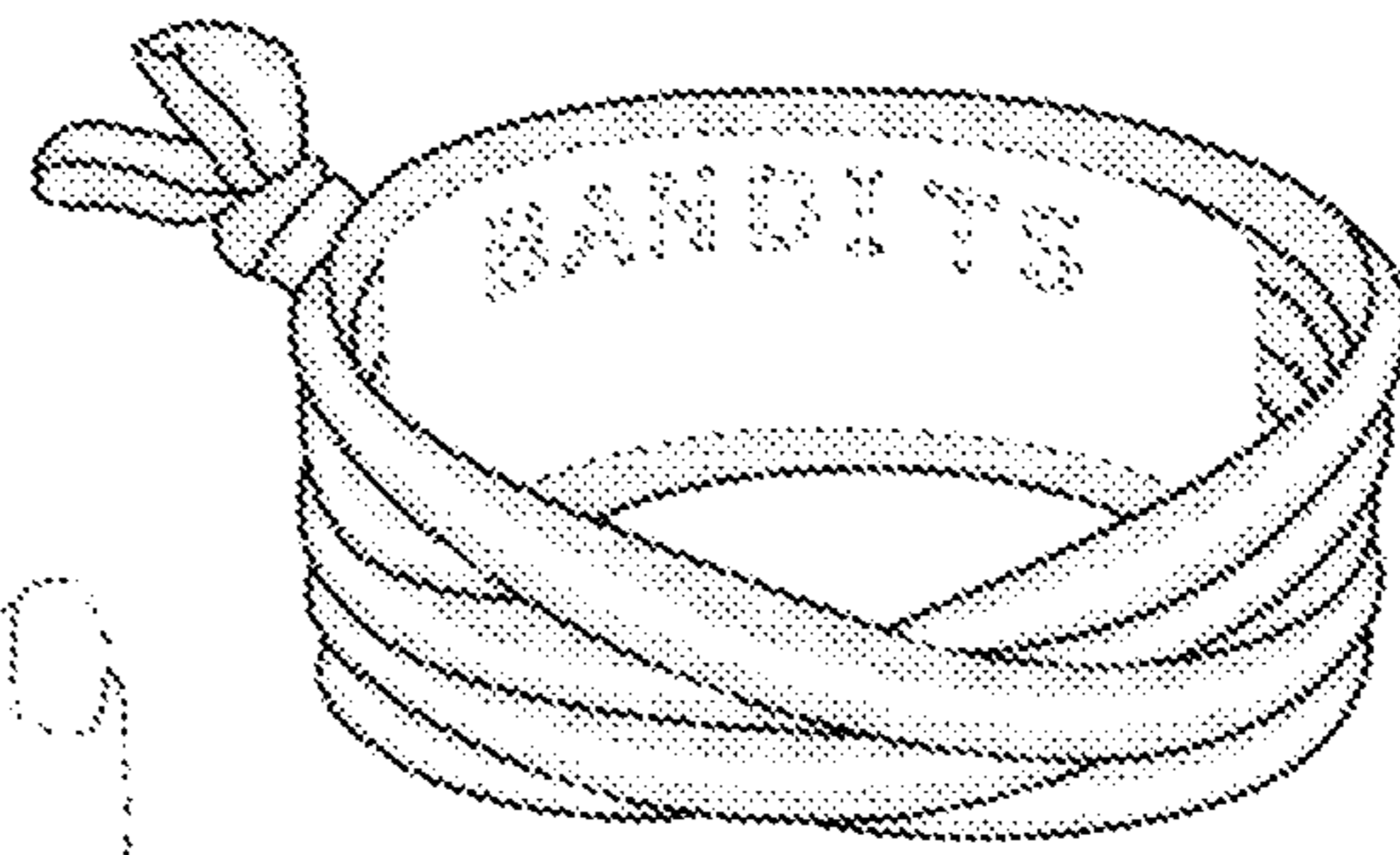

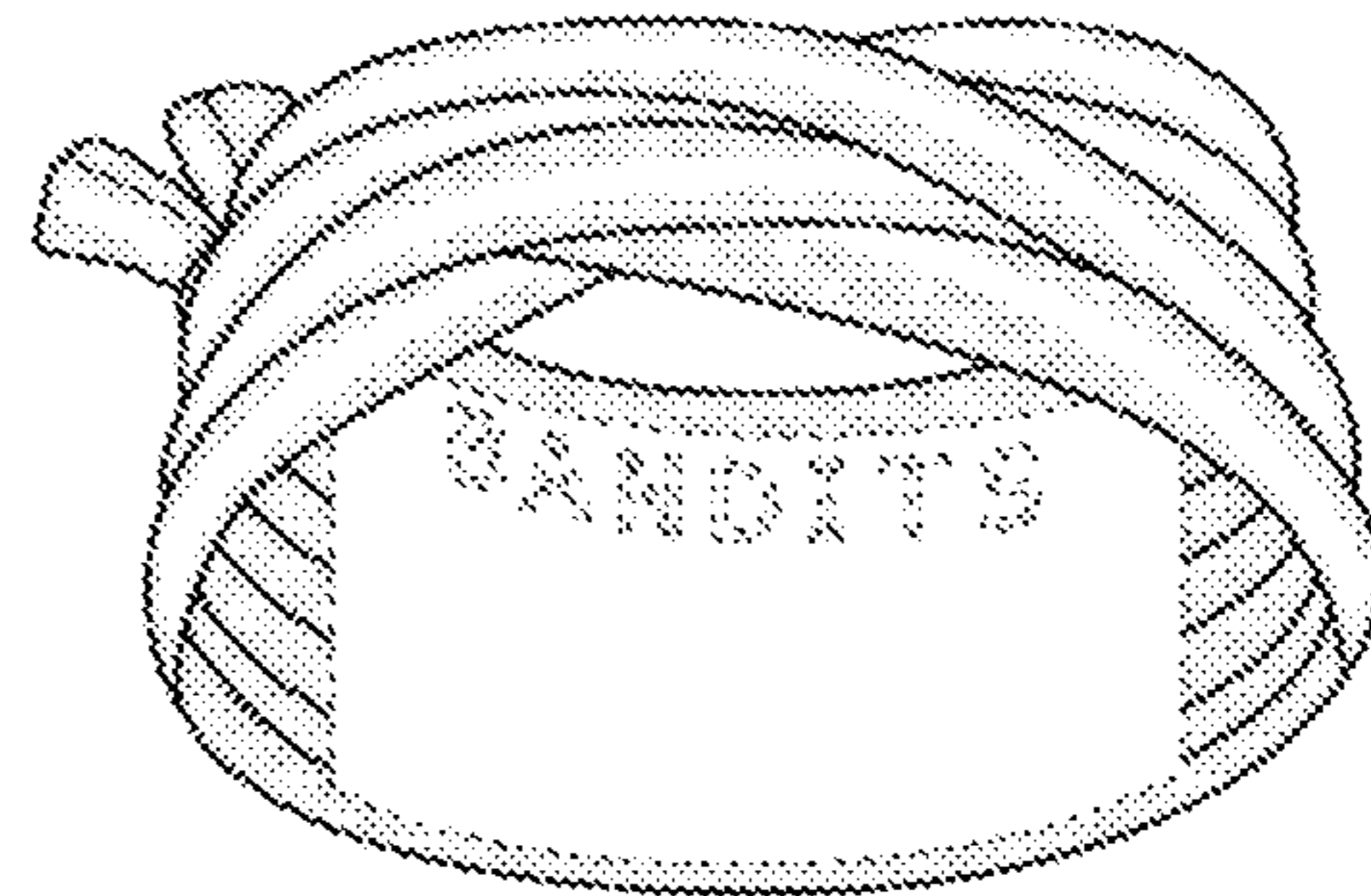

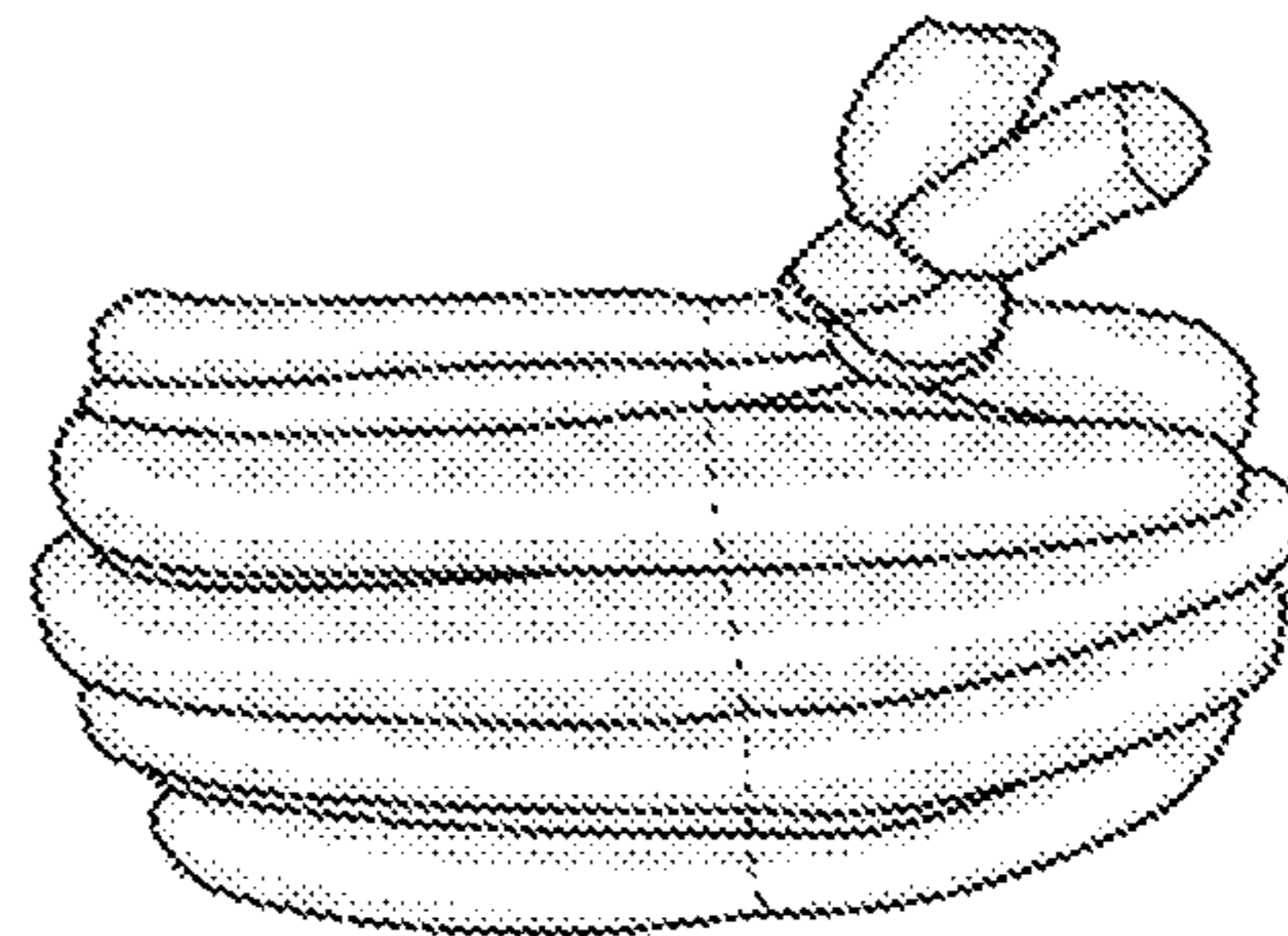

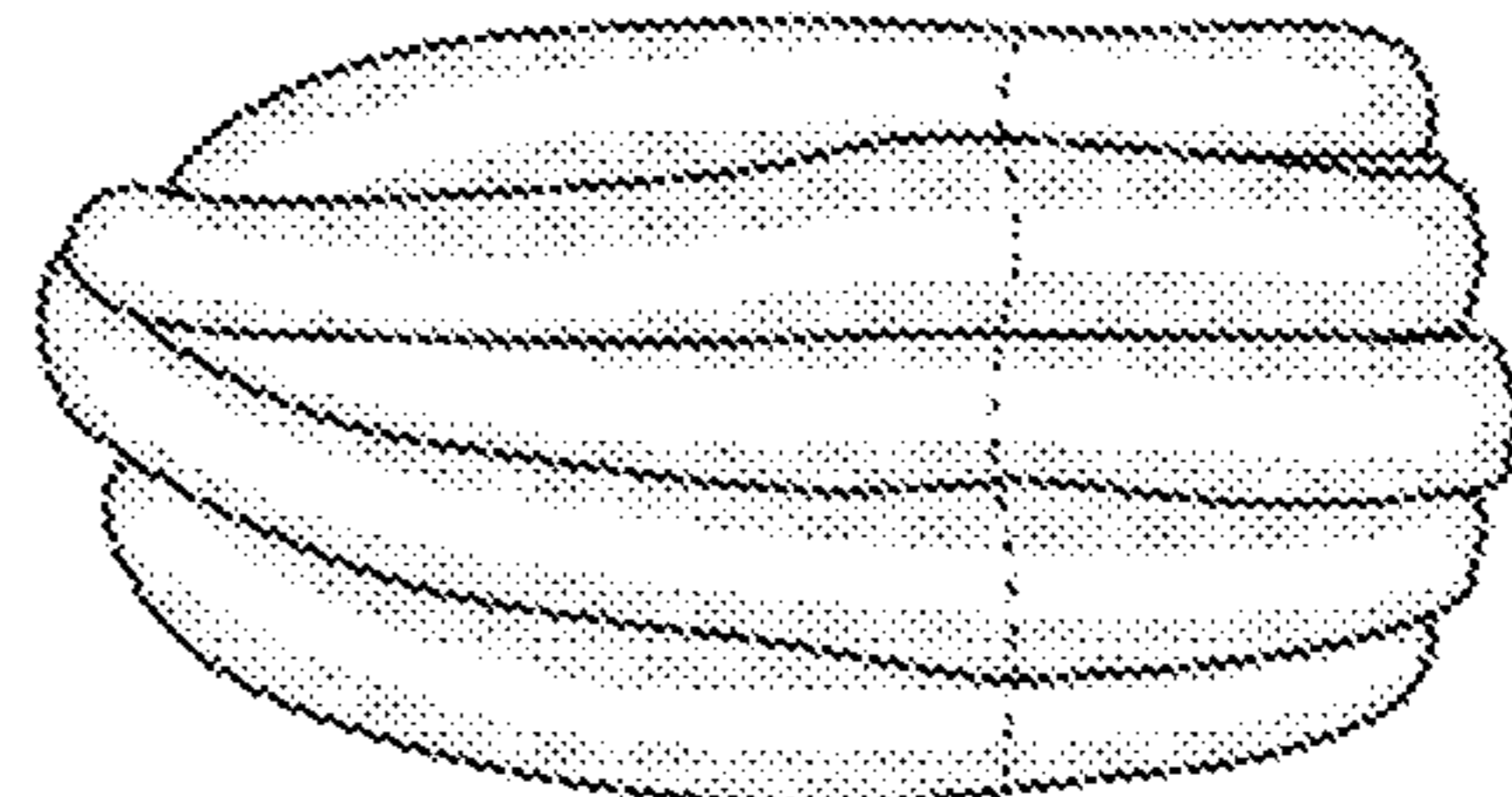

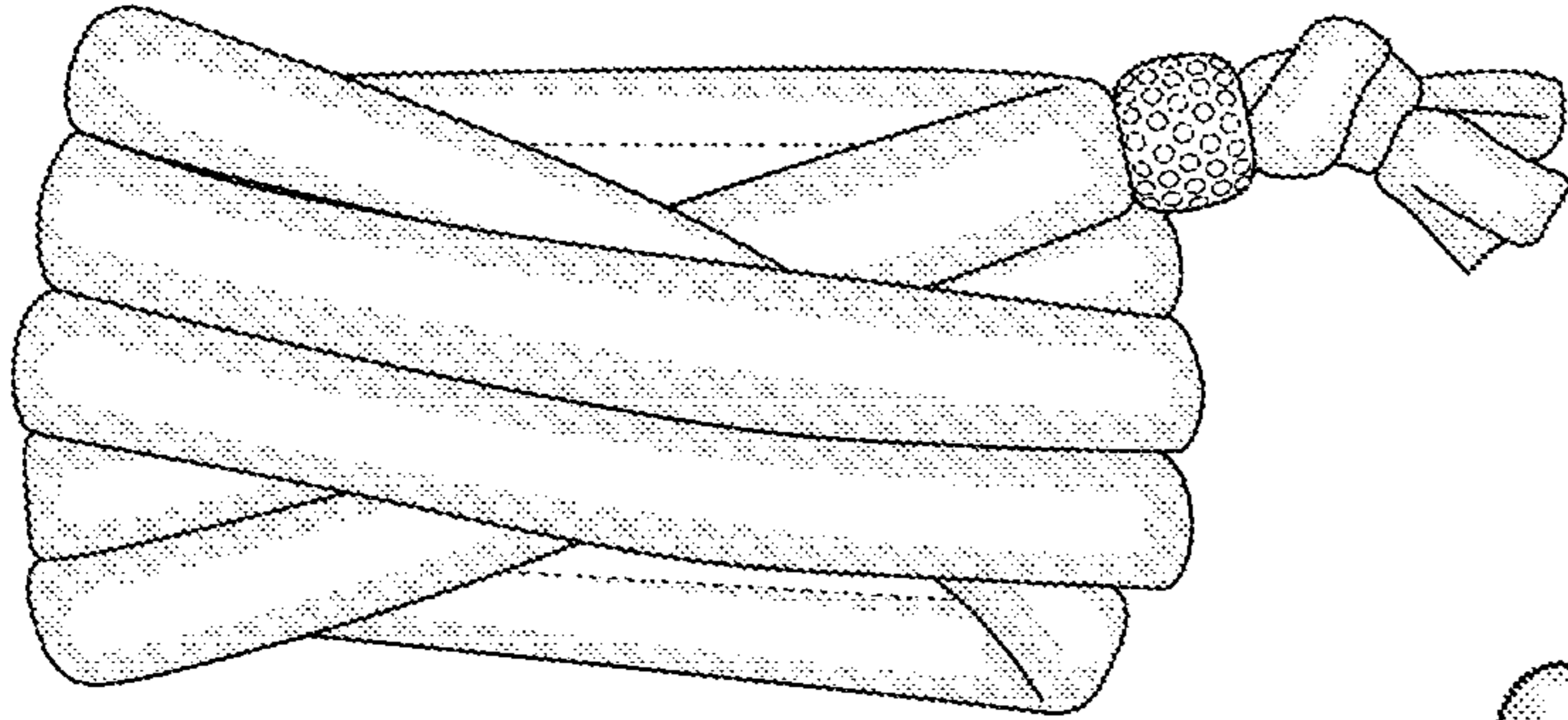

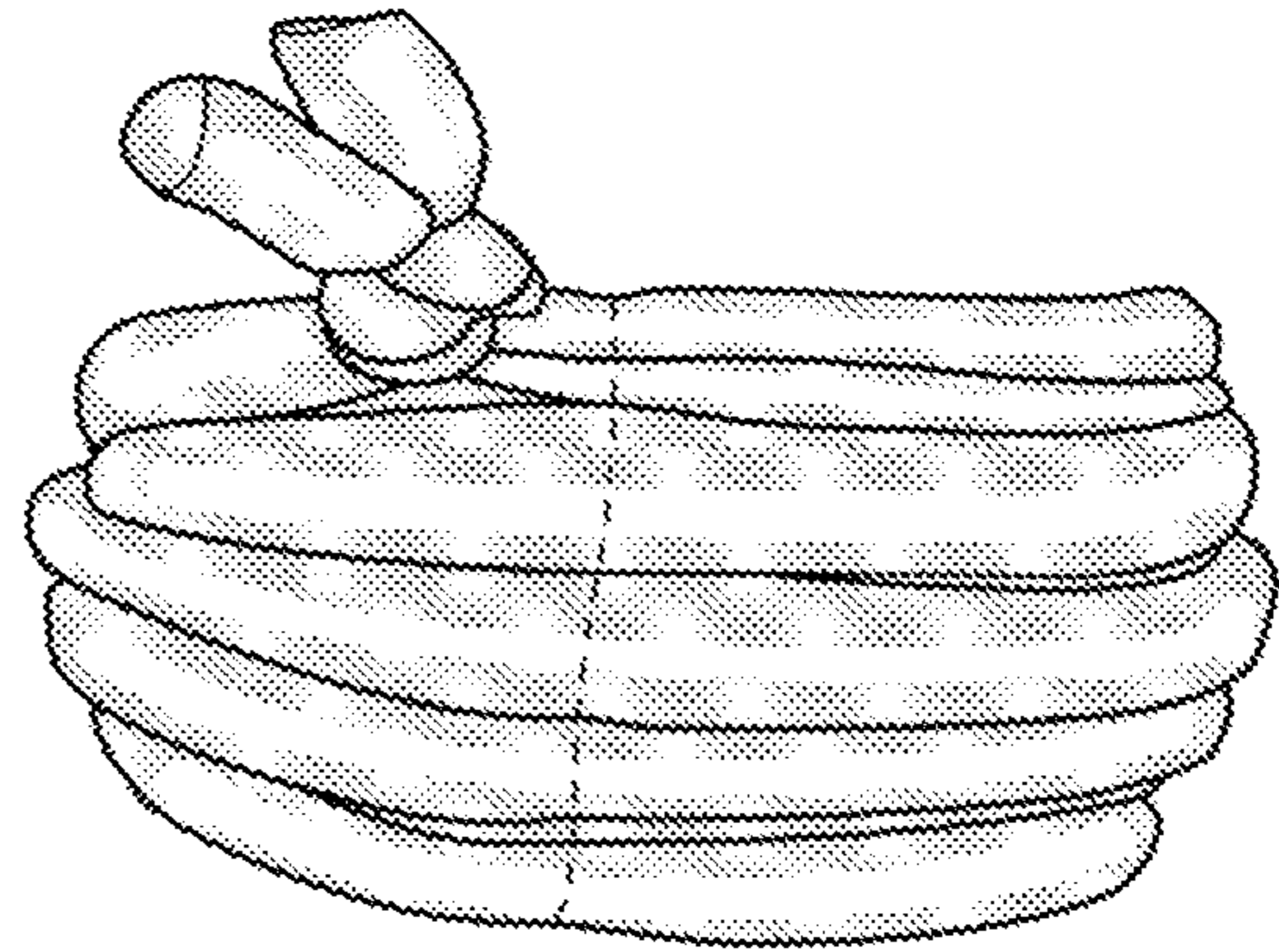

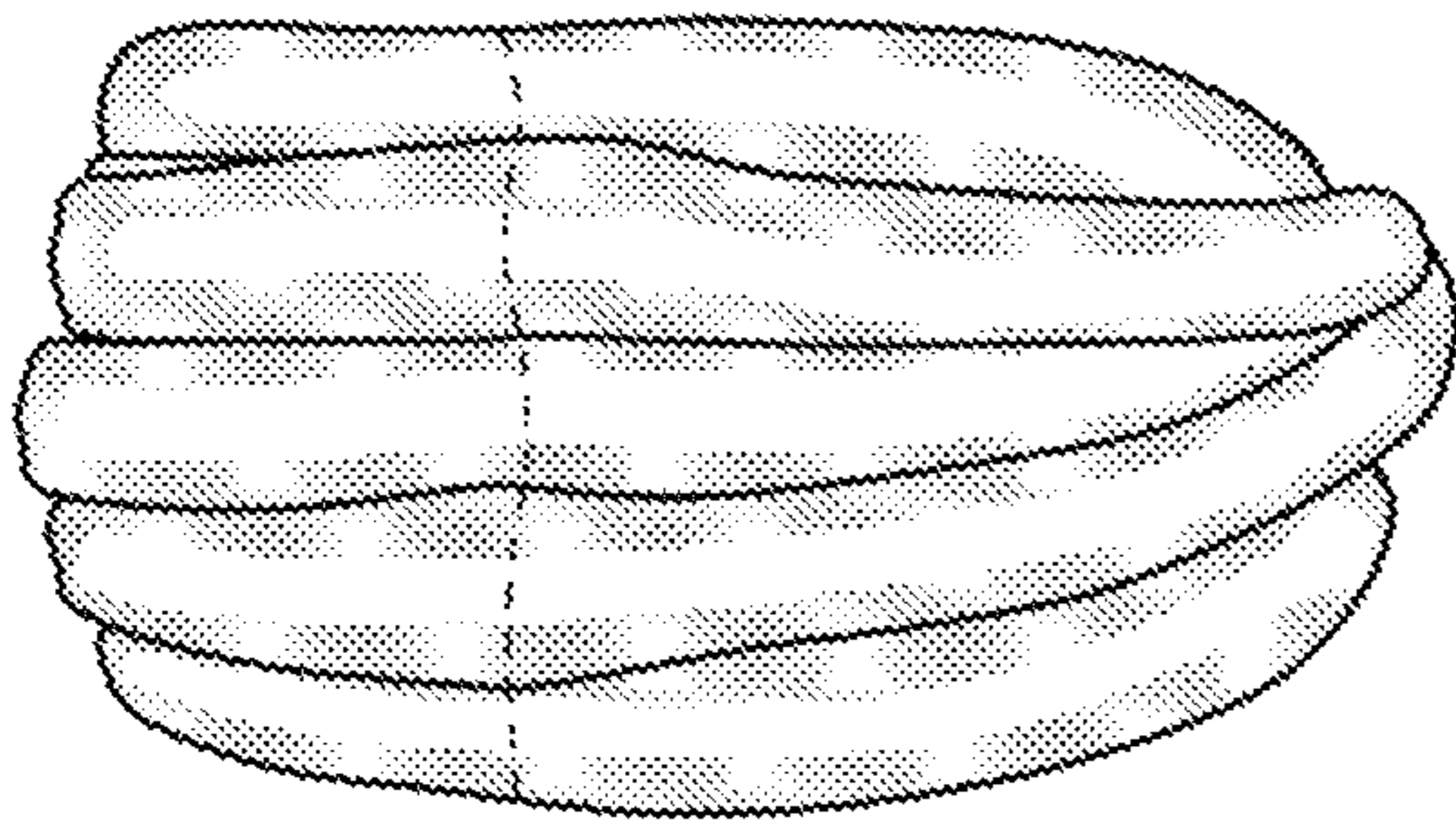




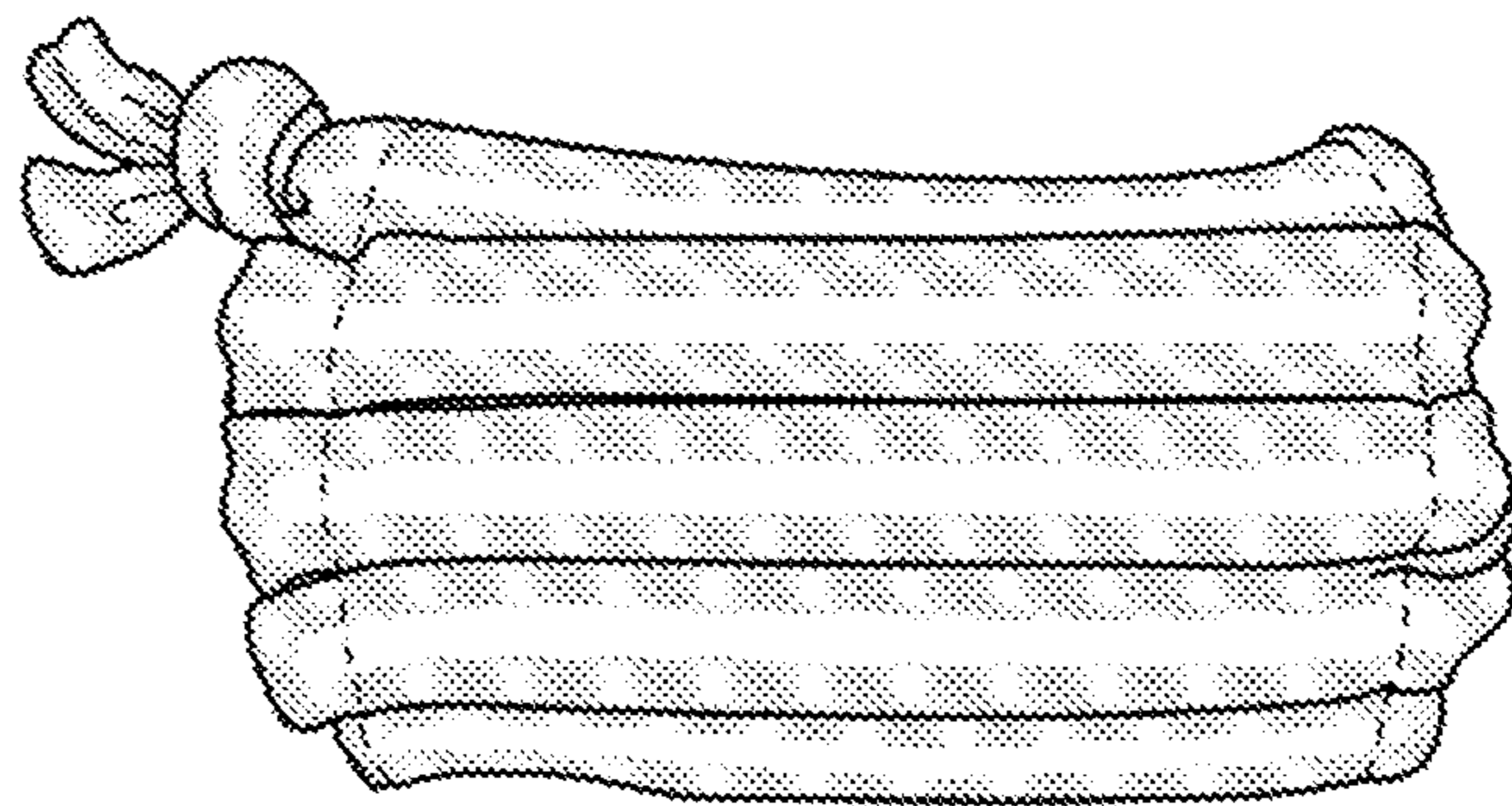

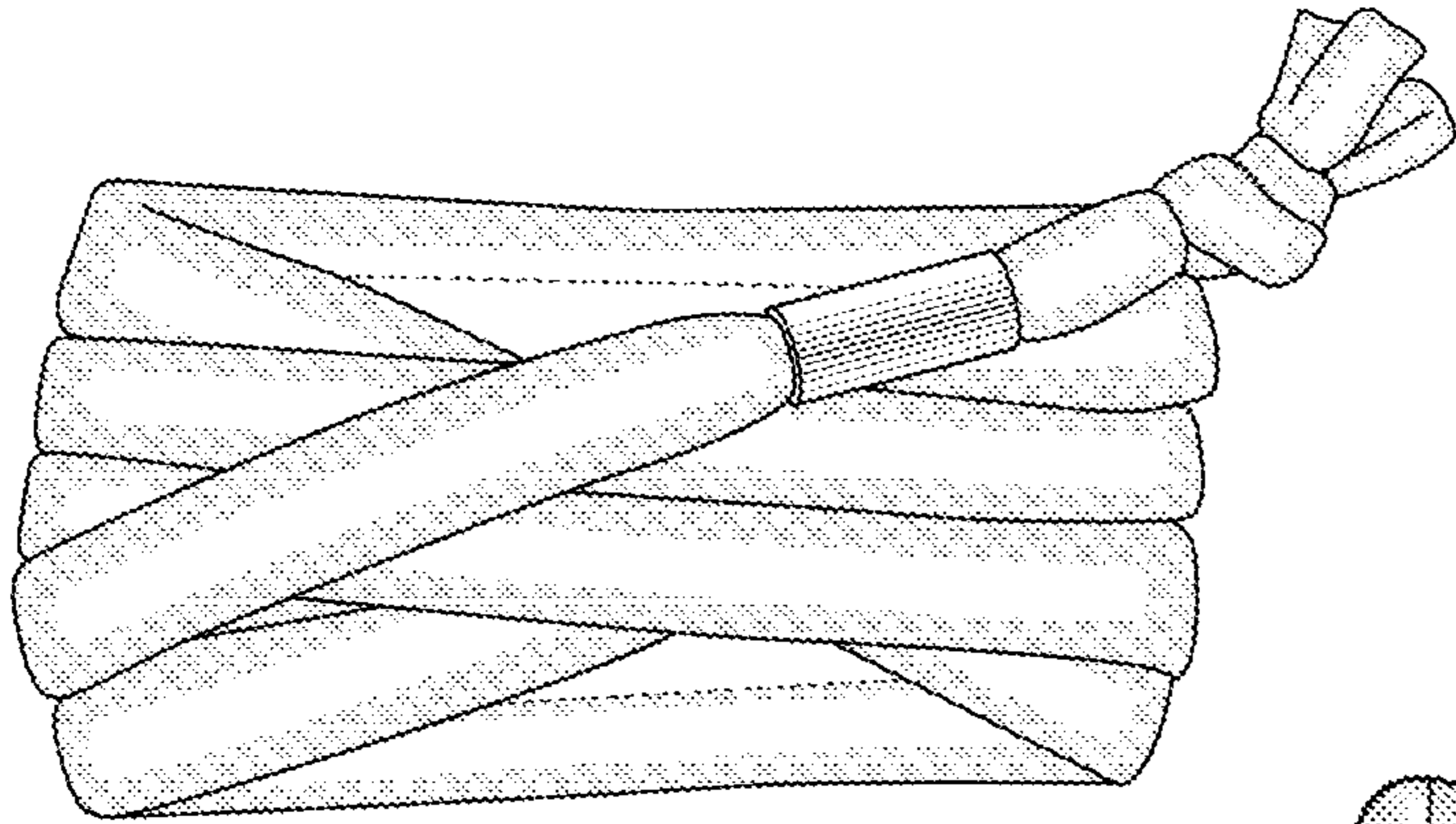

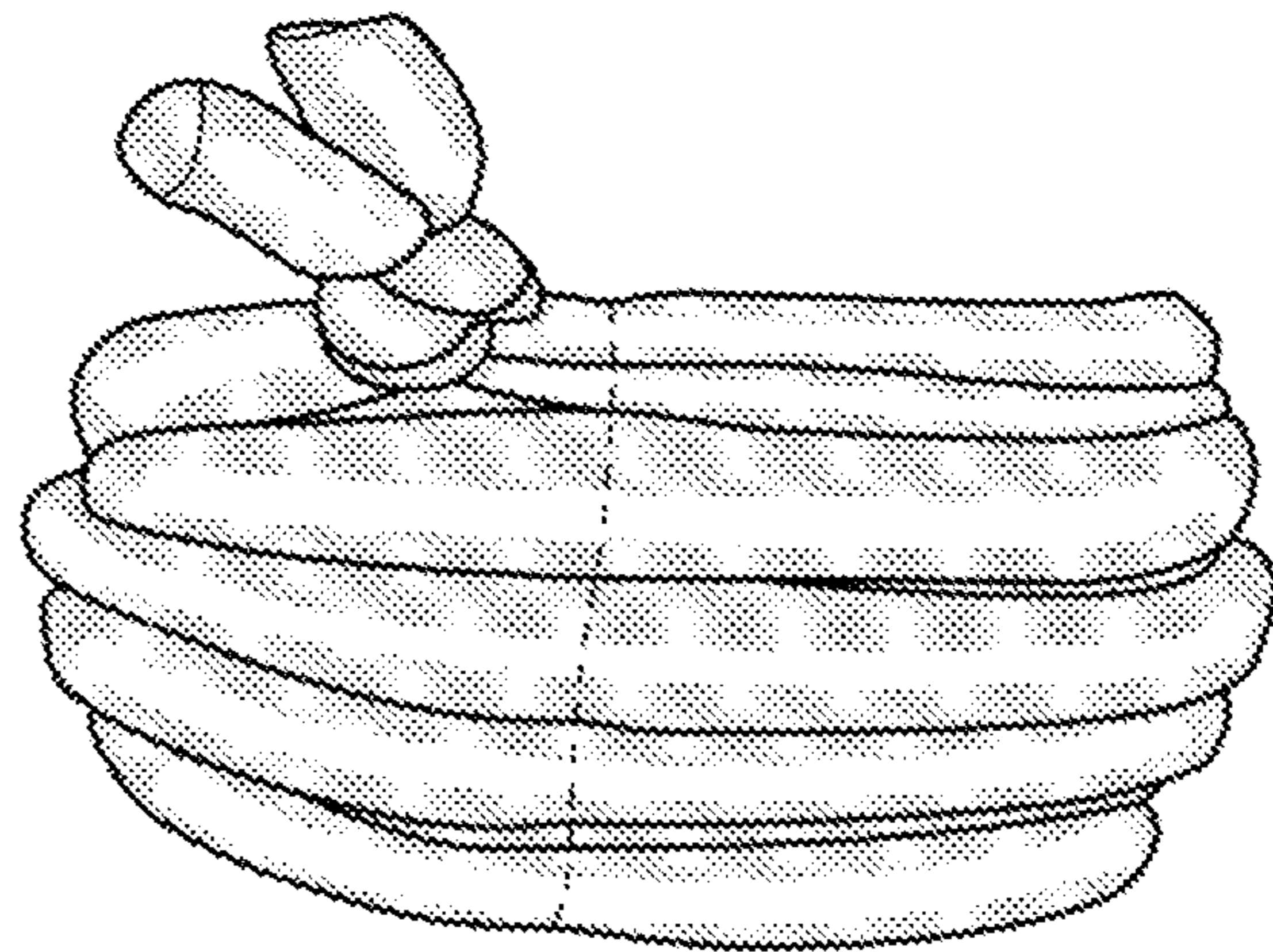

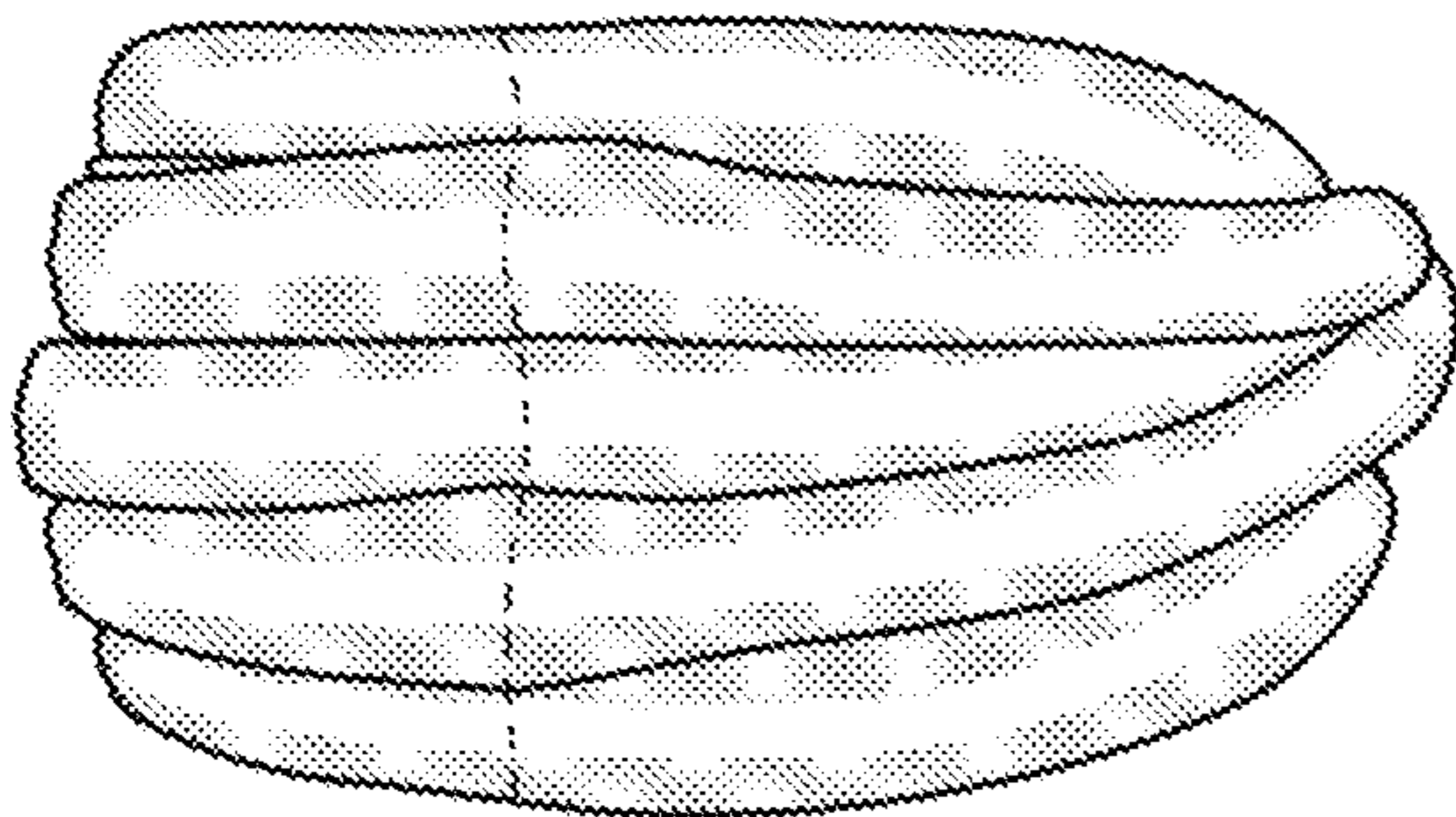

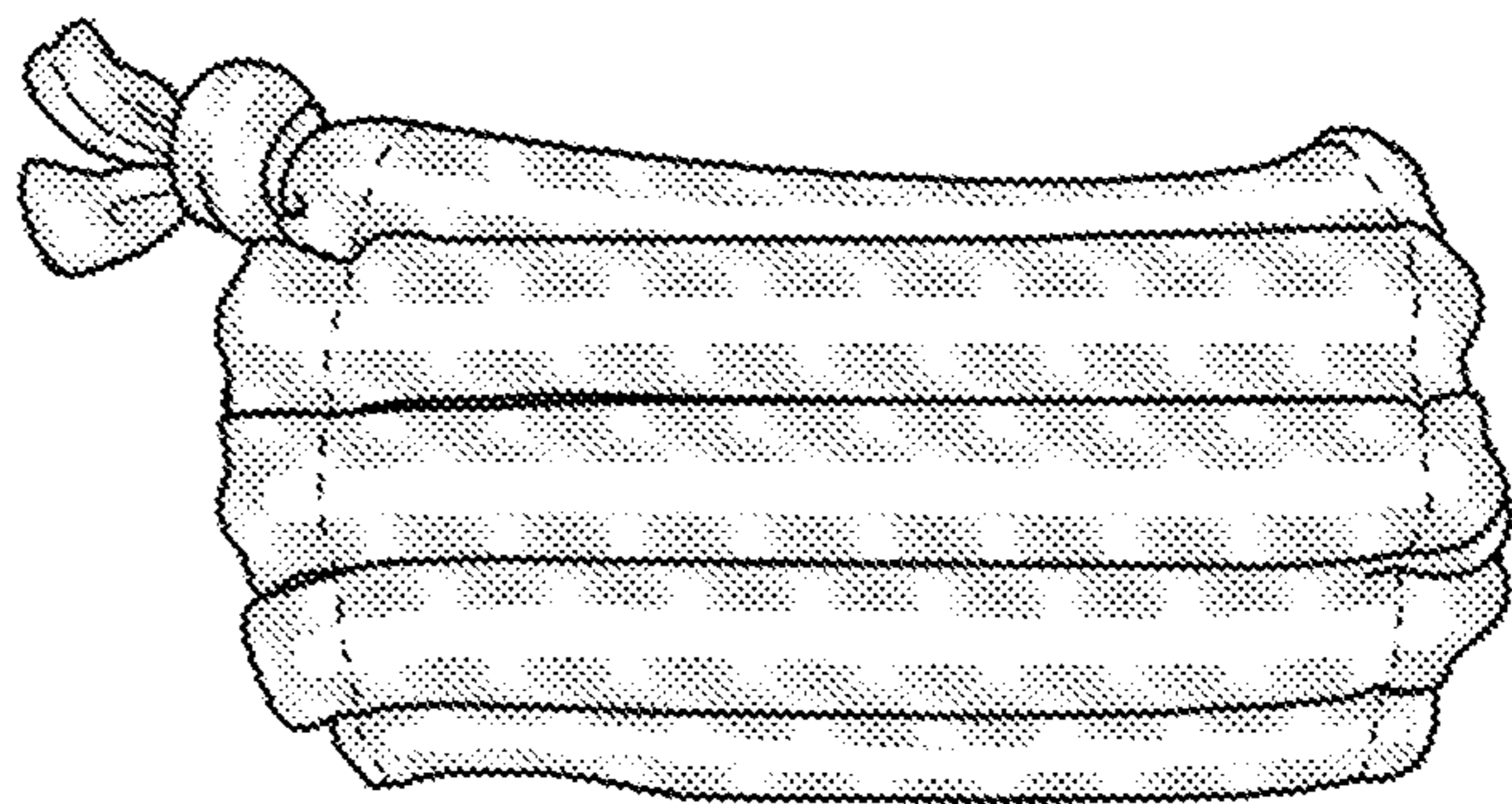

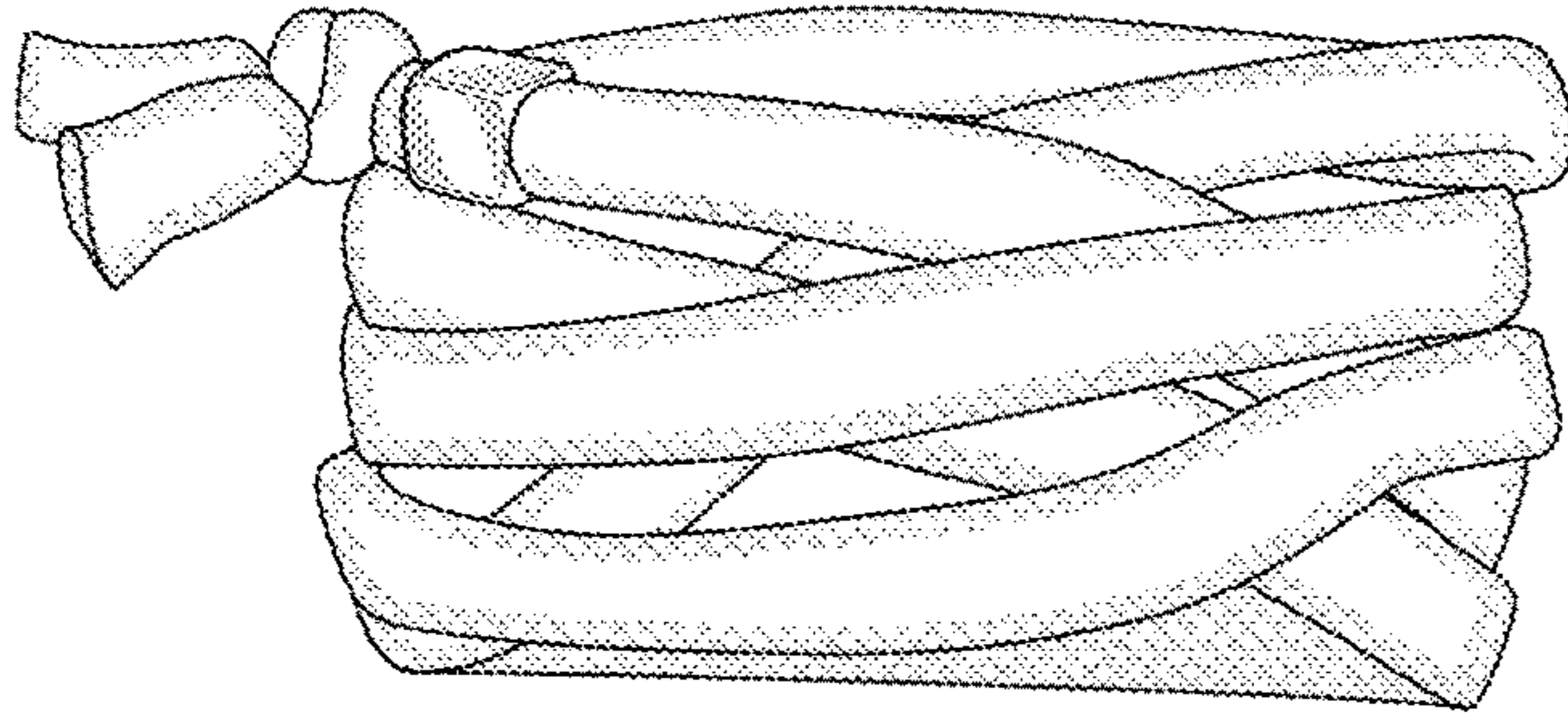

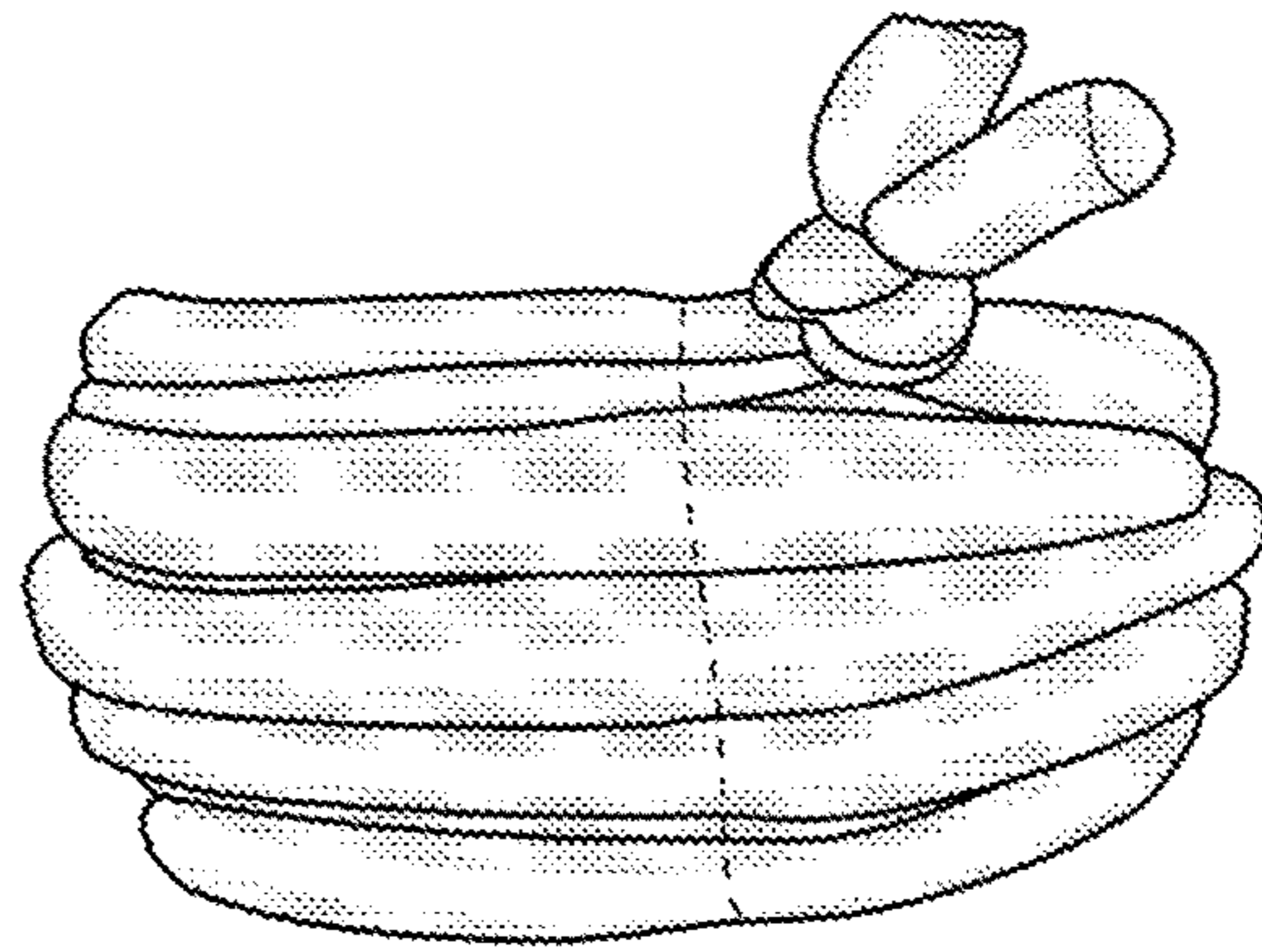

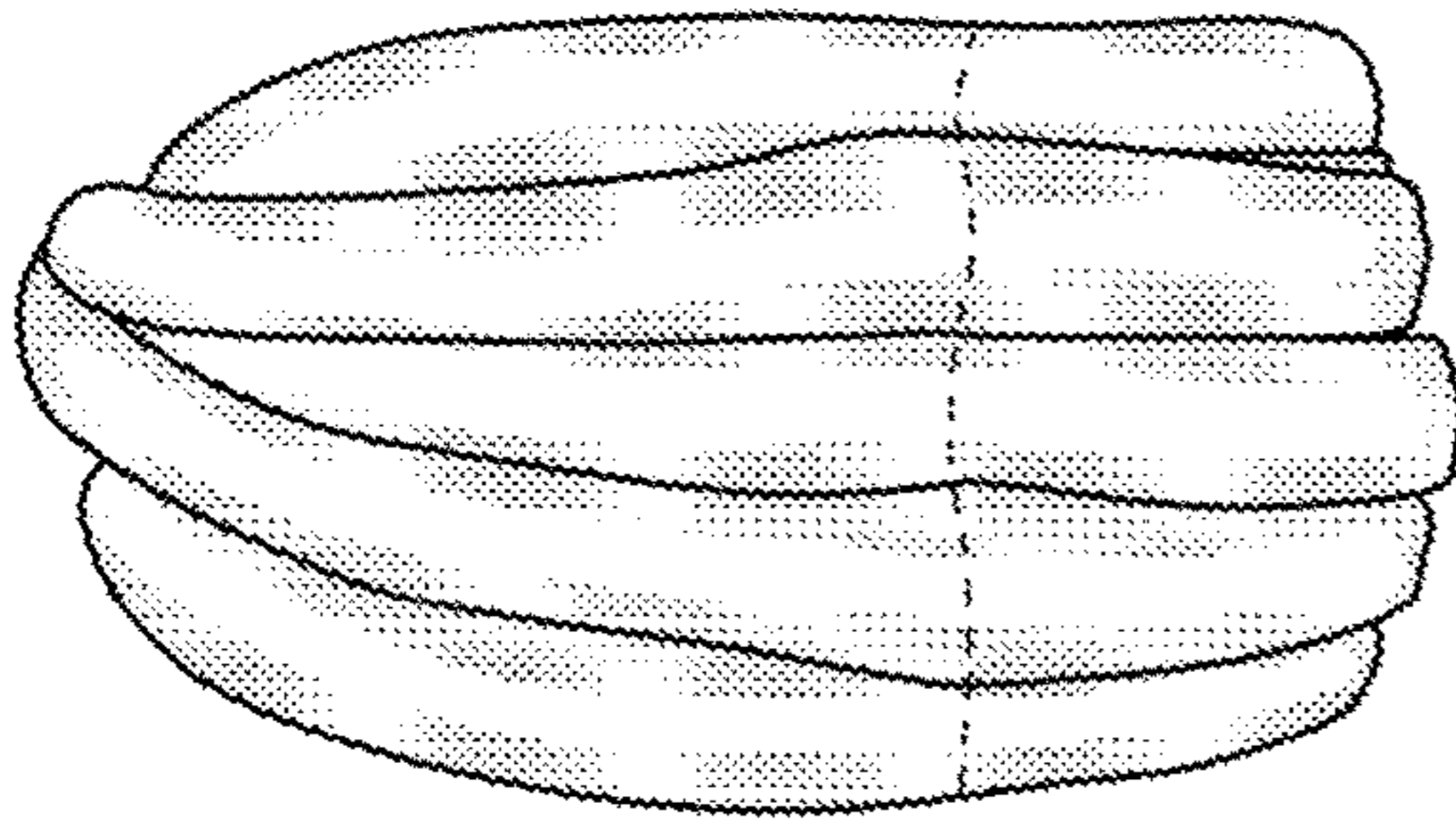




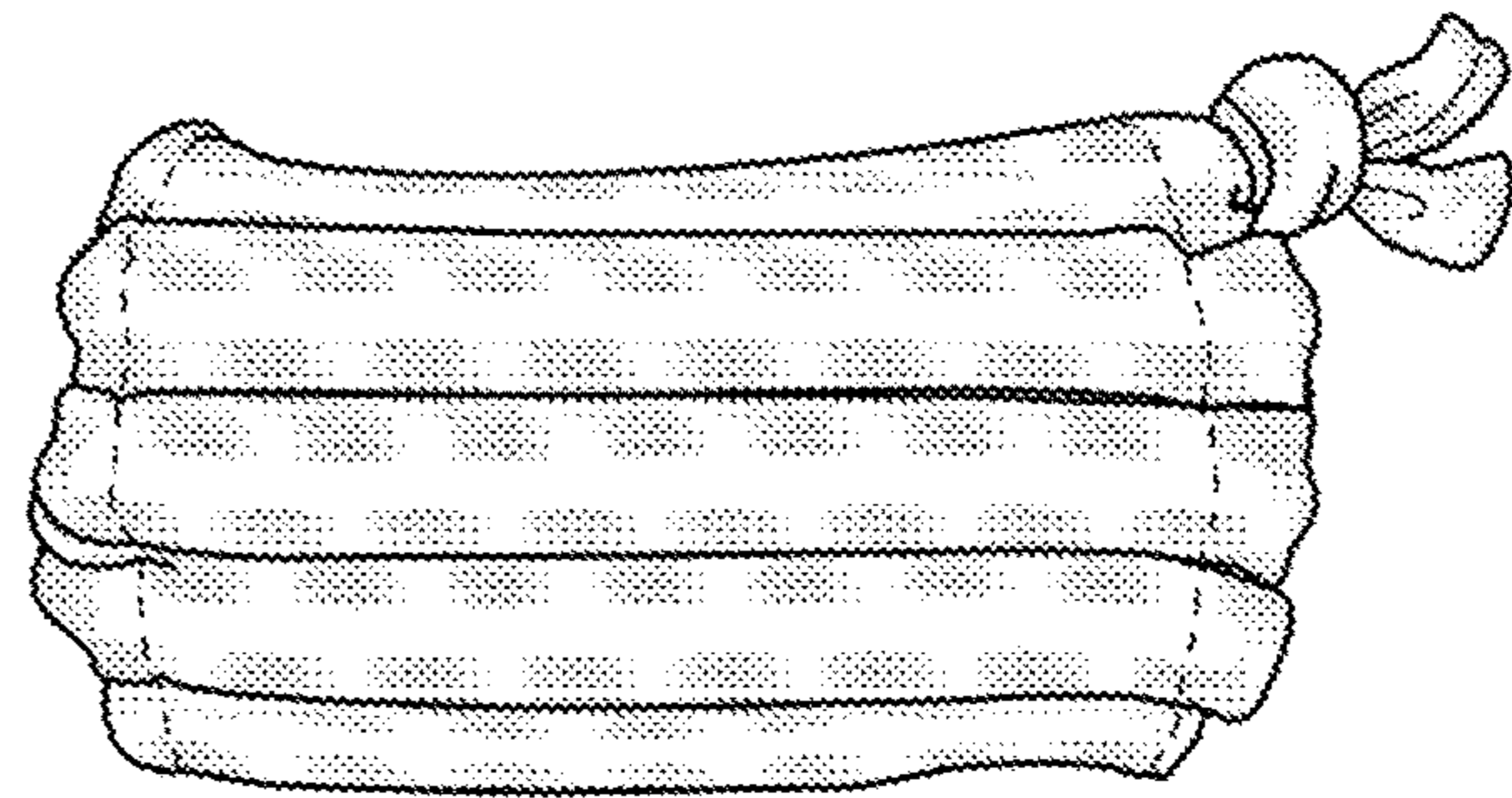
