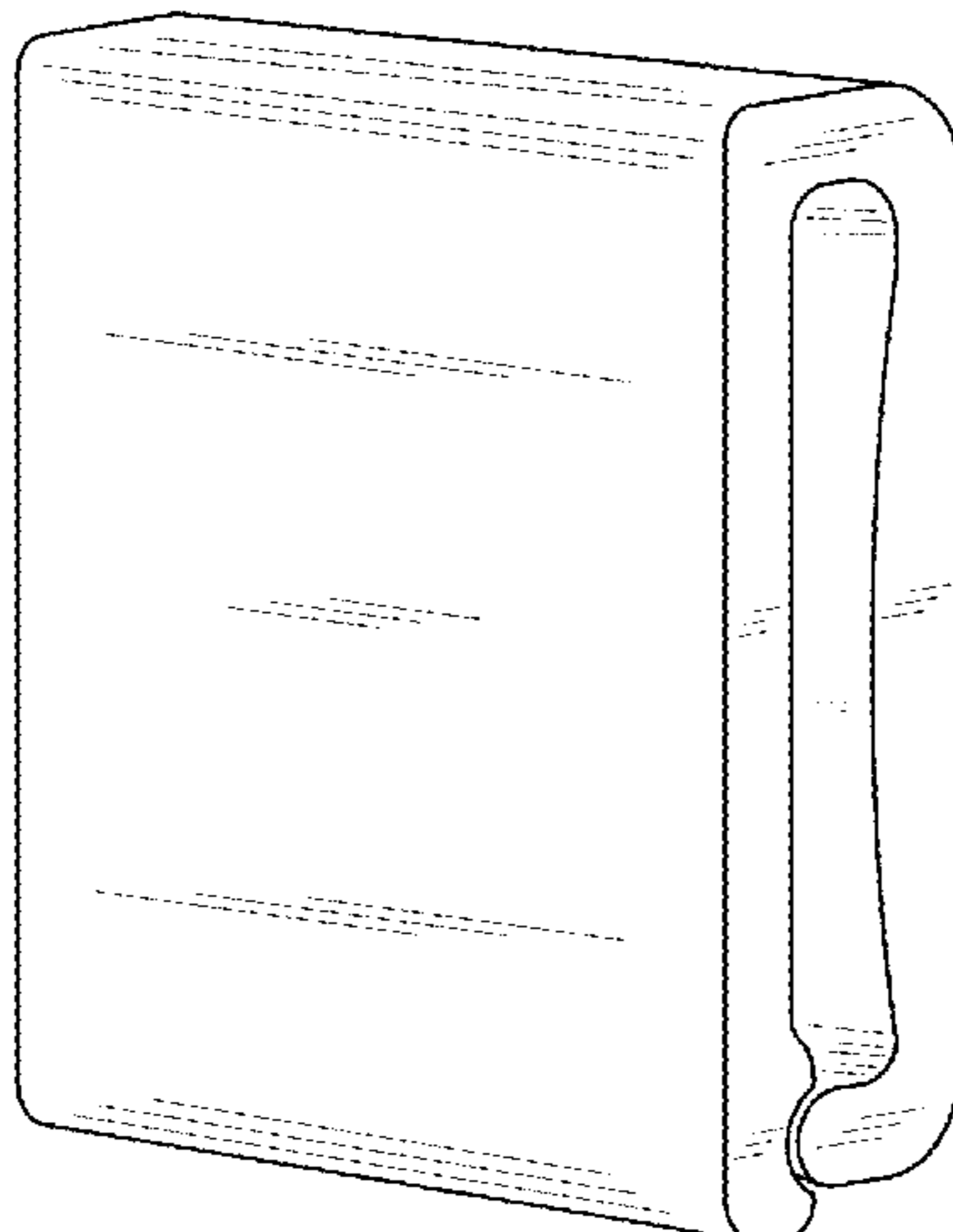


FIG. 6 is a side view thereof; and,

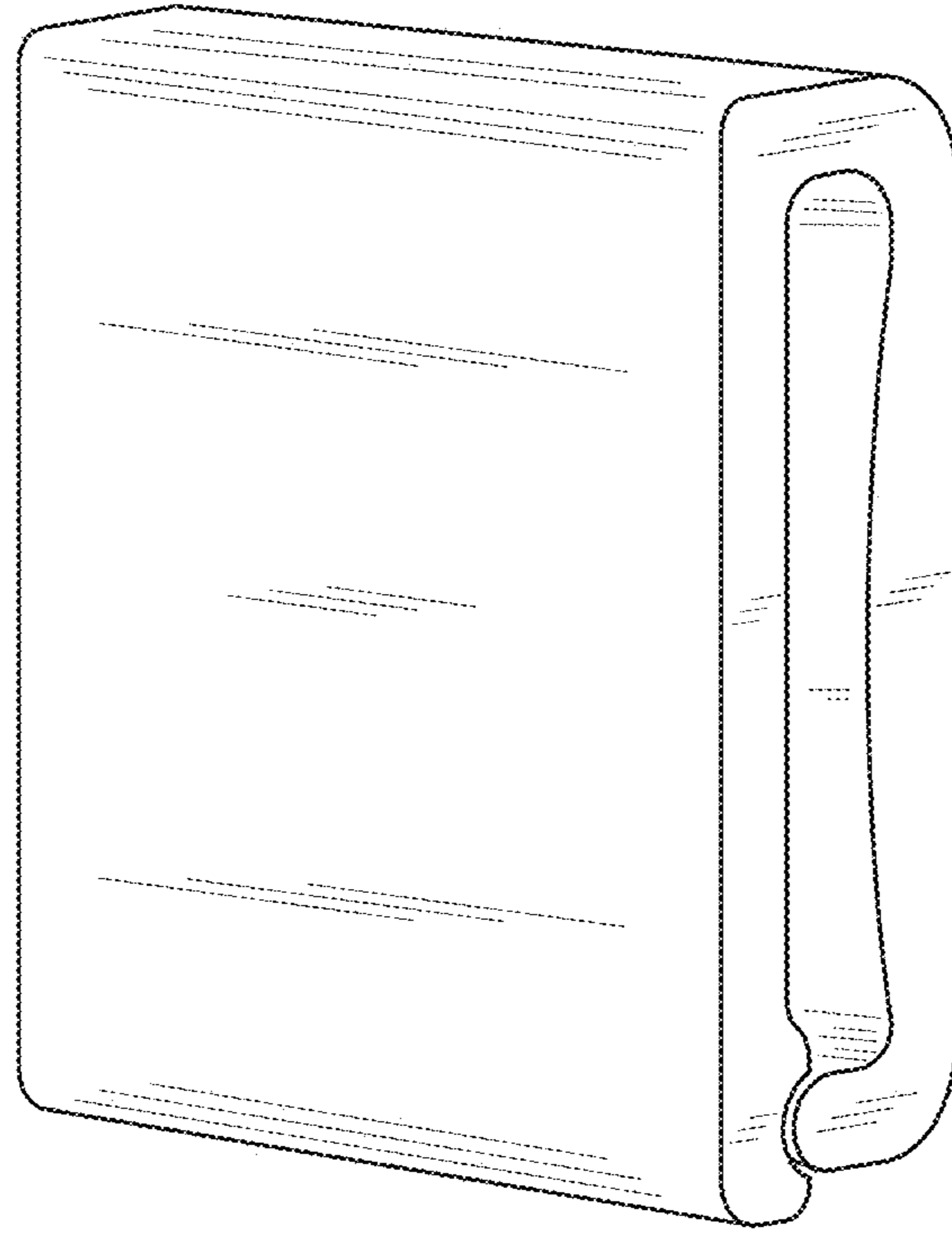

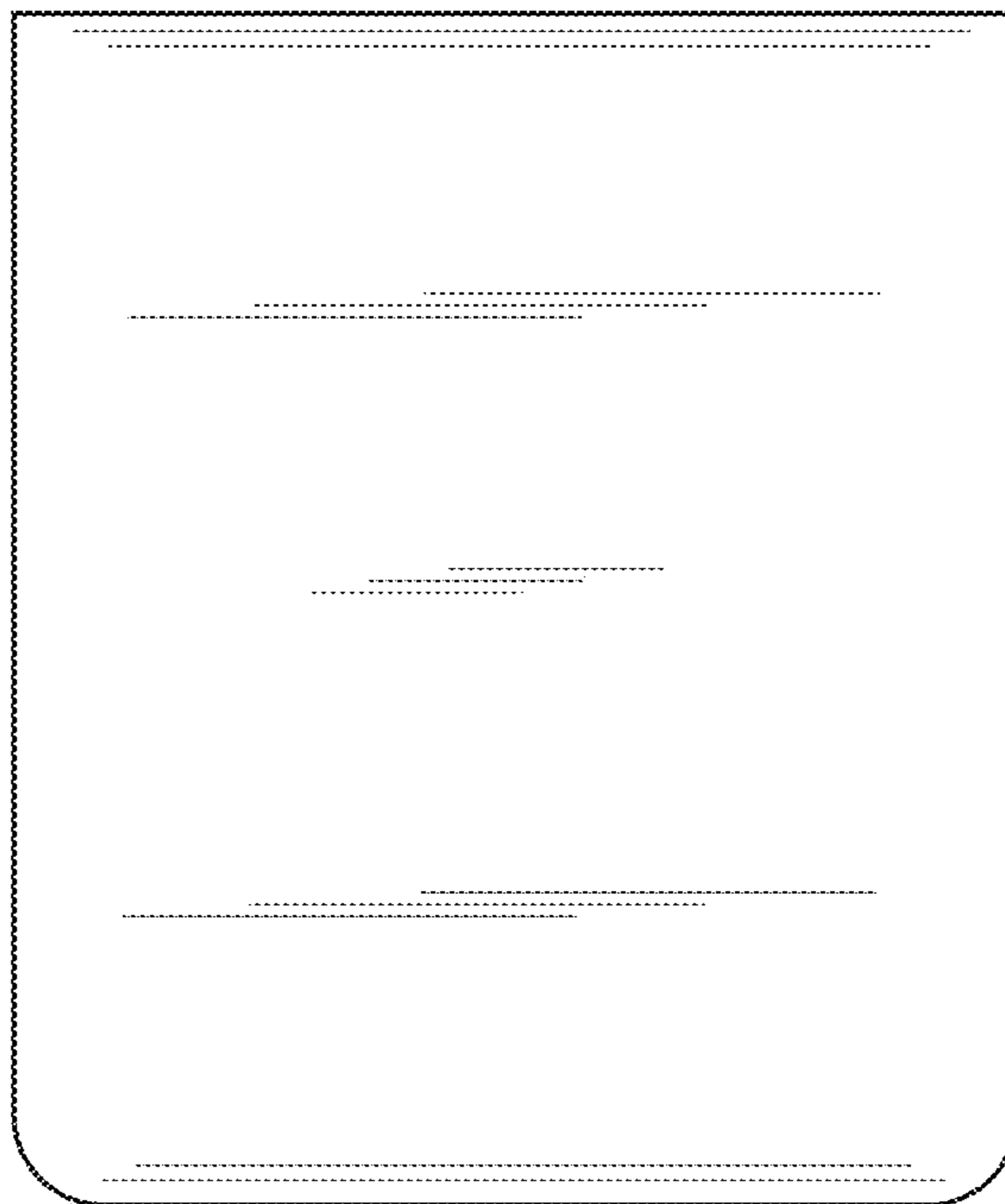

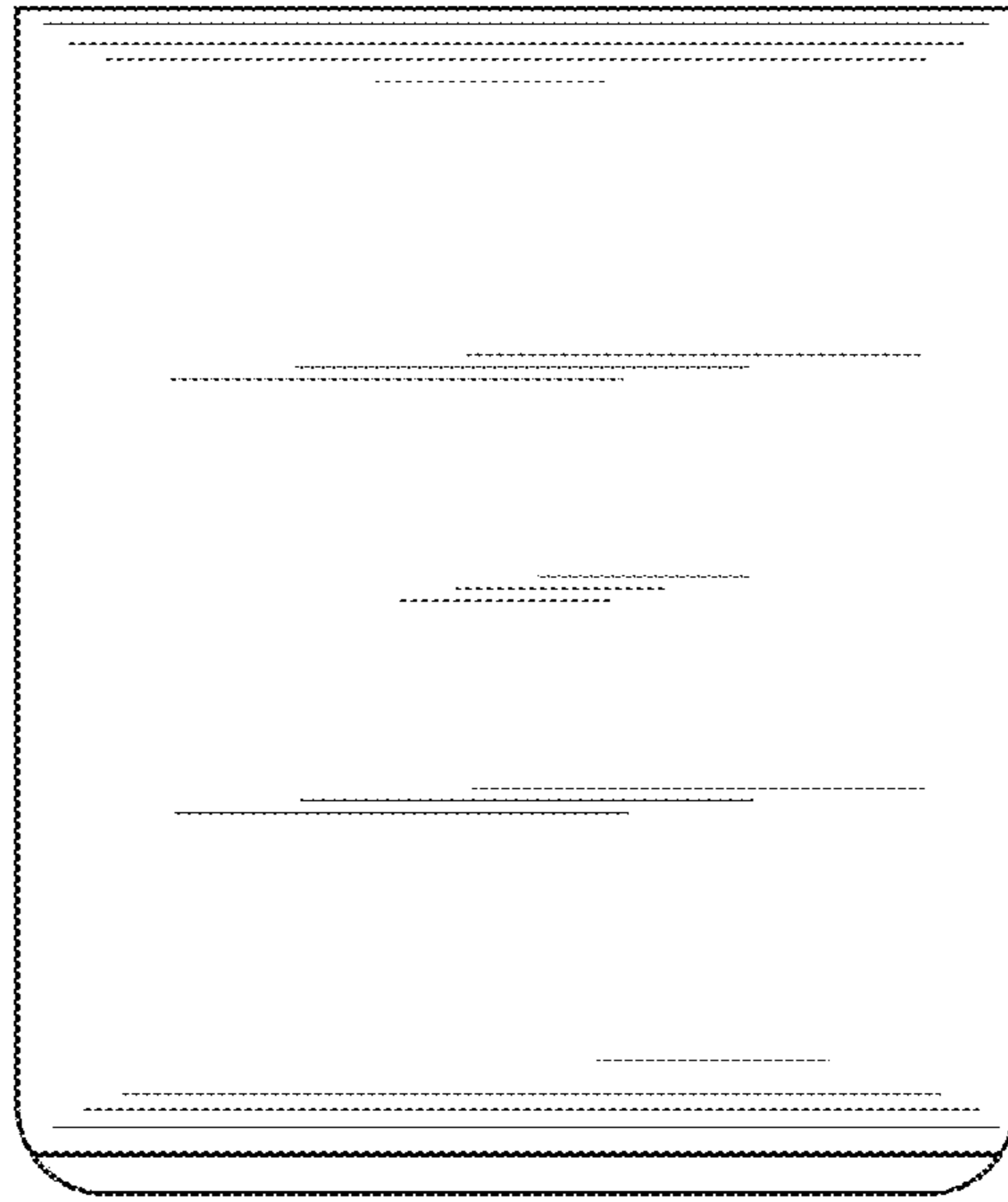

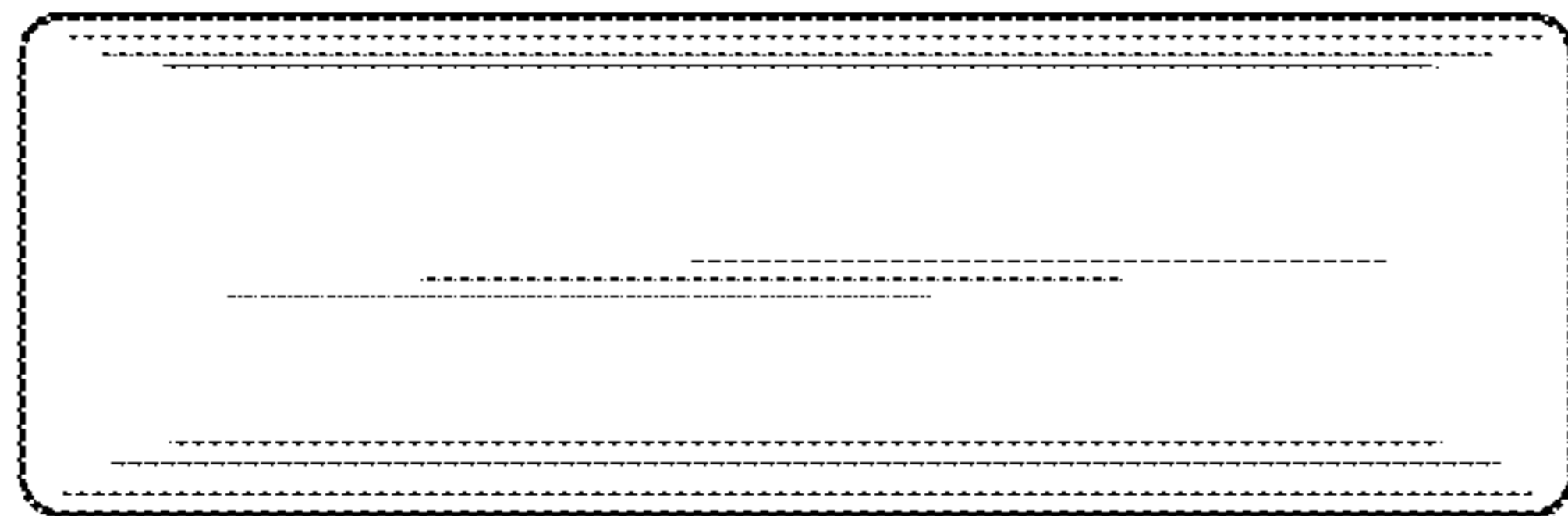

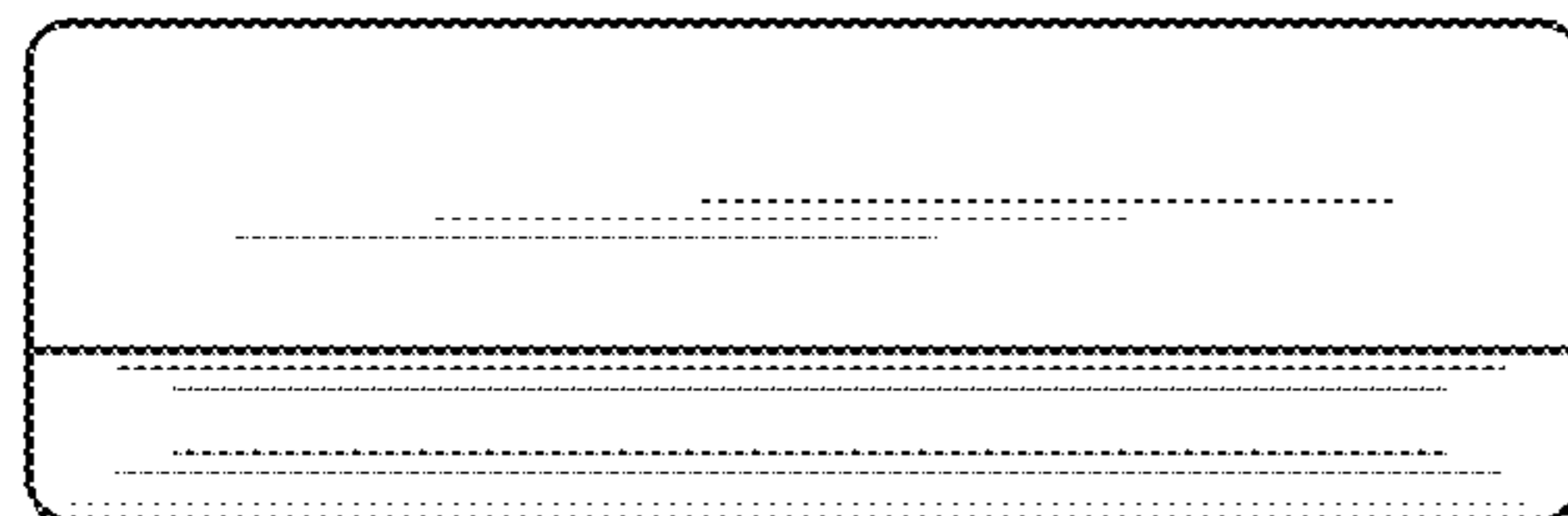

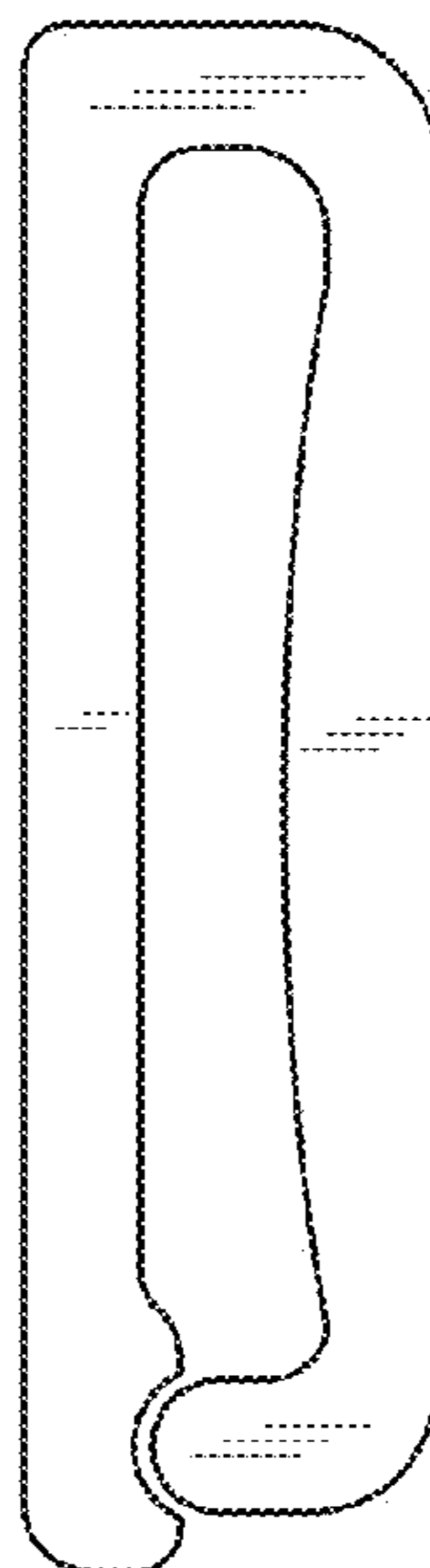

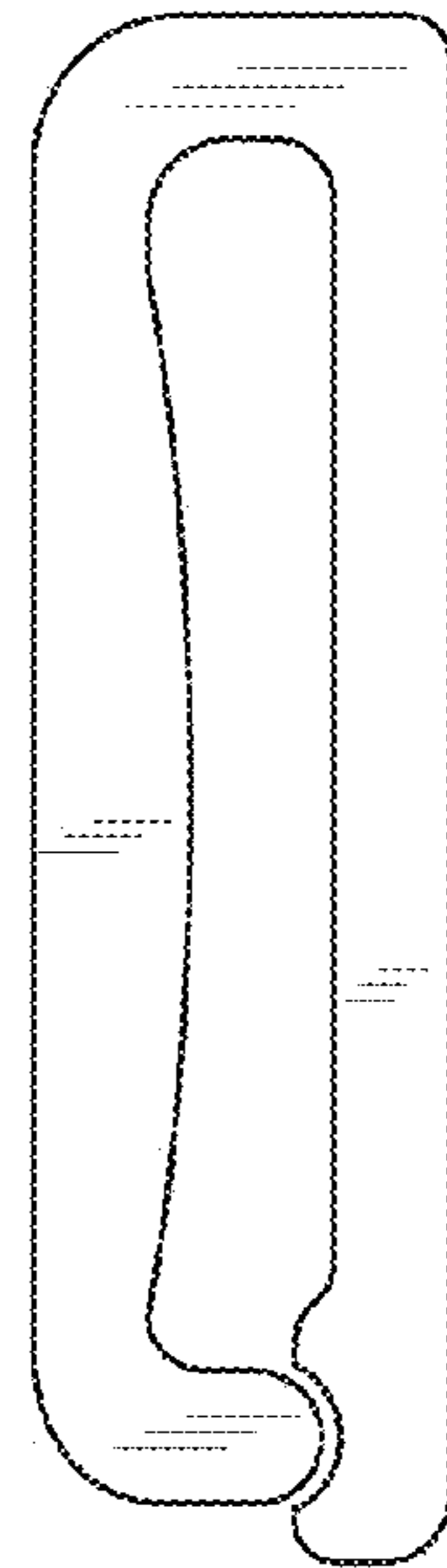
