(57) **CLAIM**

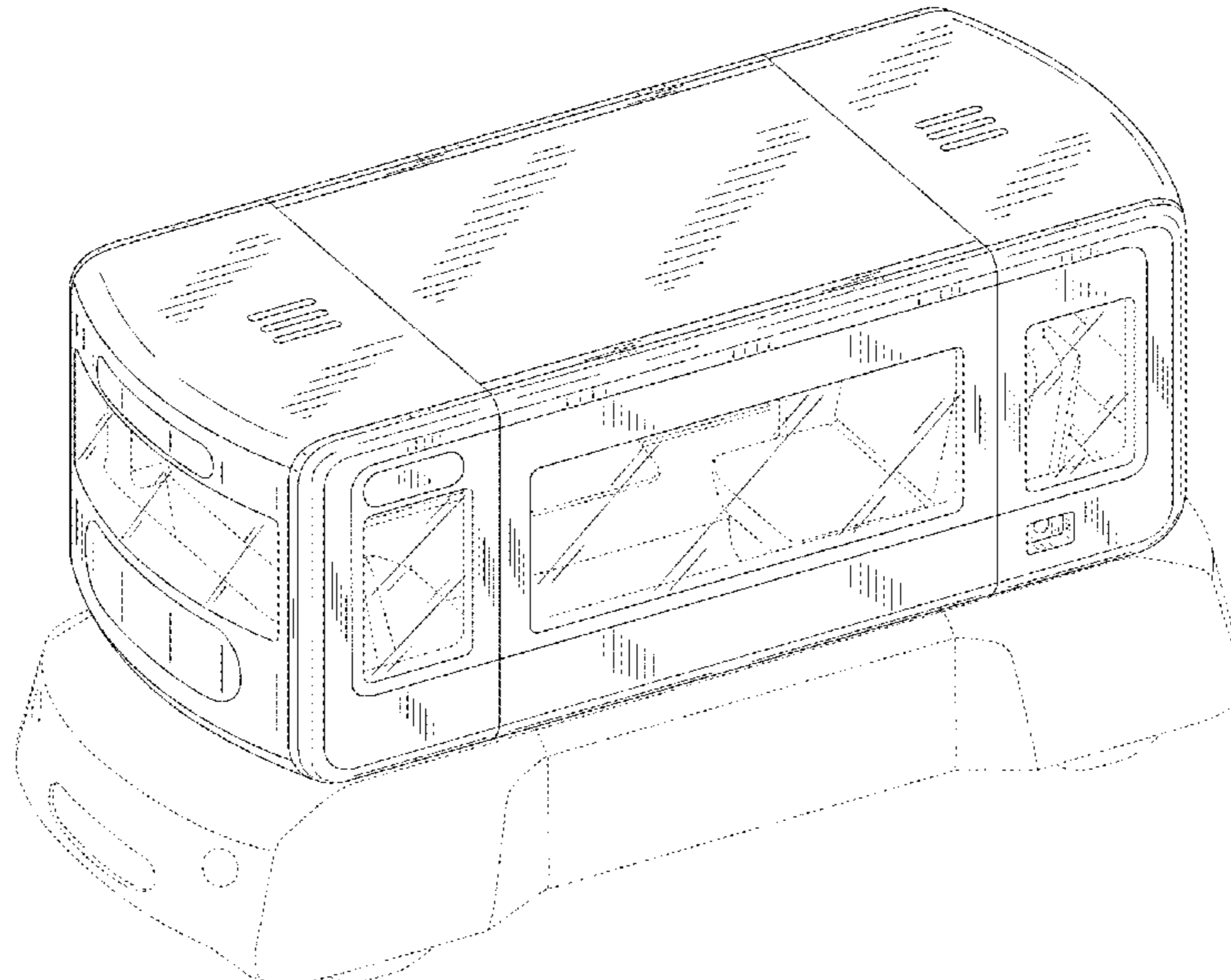
We claim the ornamental design for an electric vehicle, as shown and described.

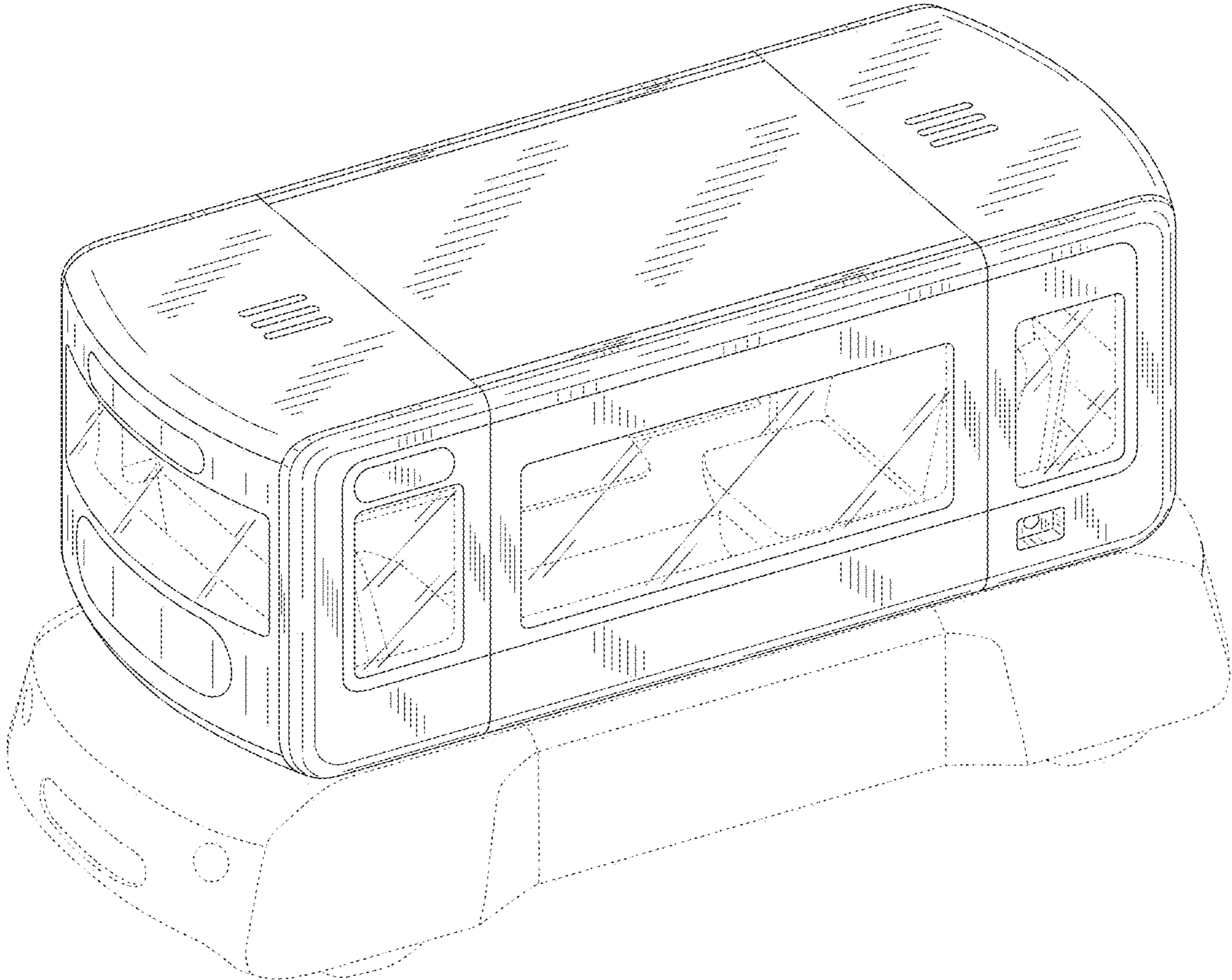

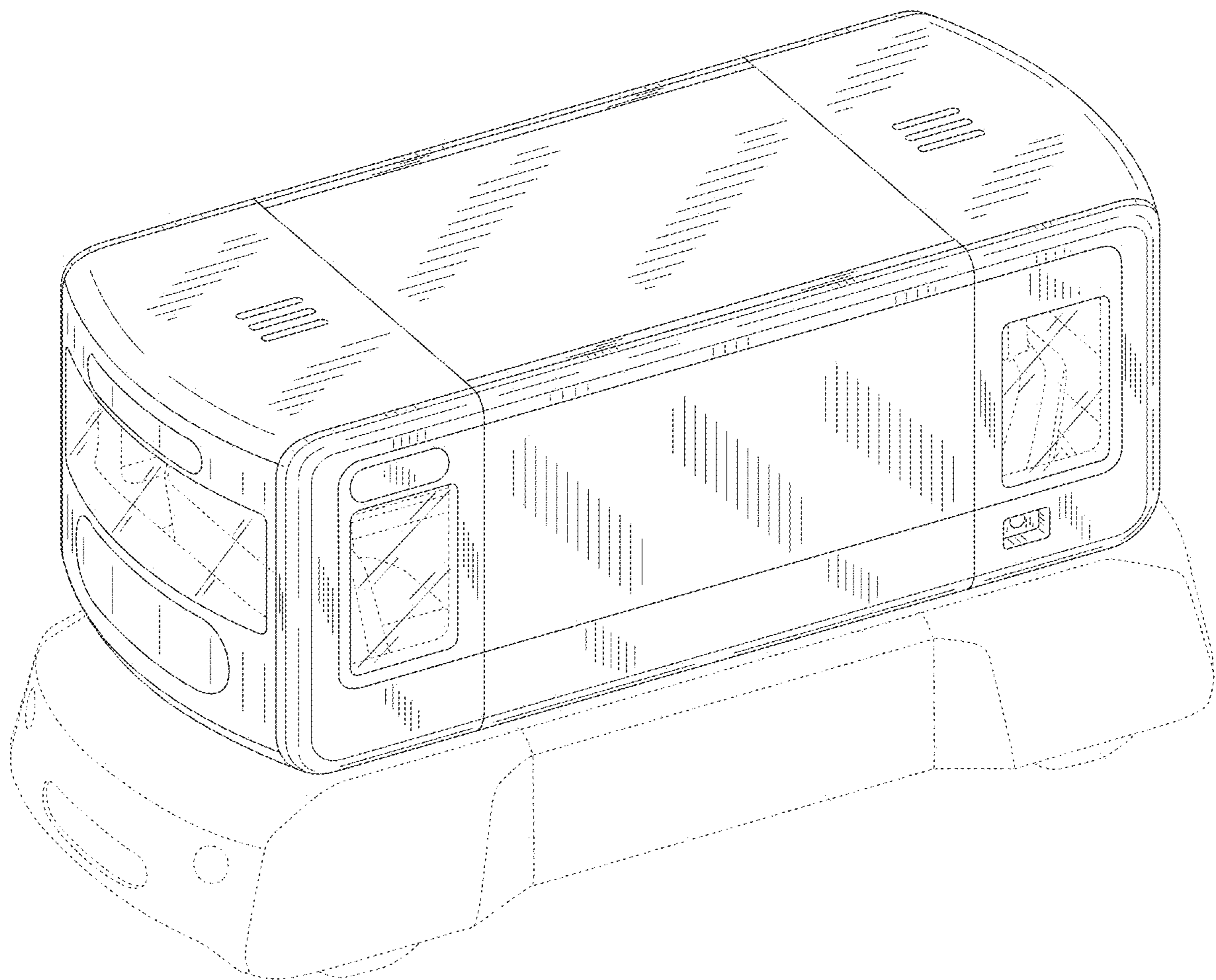

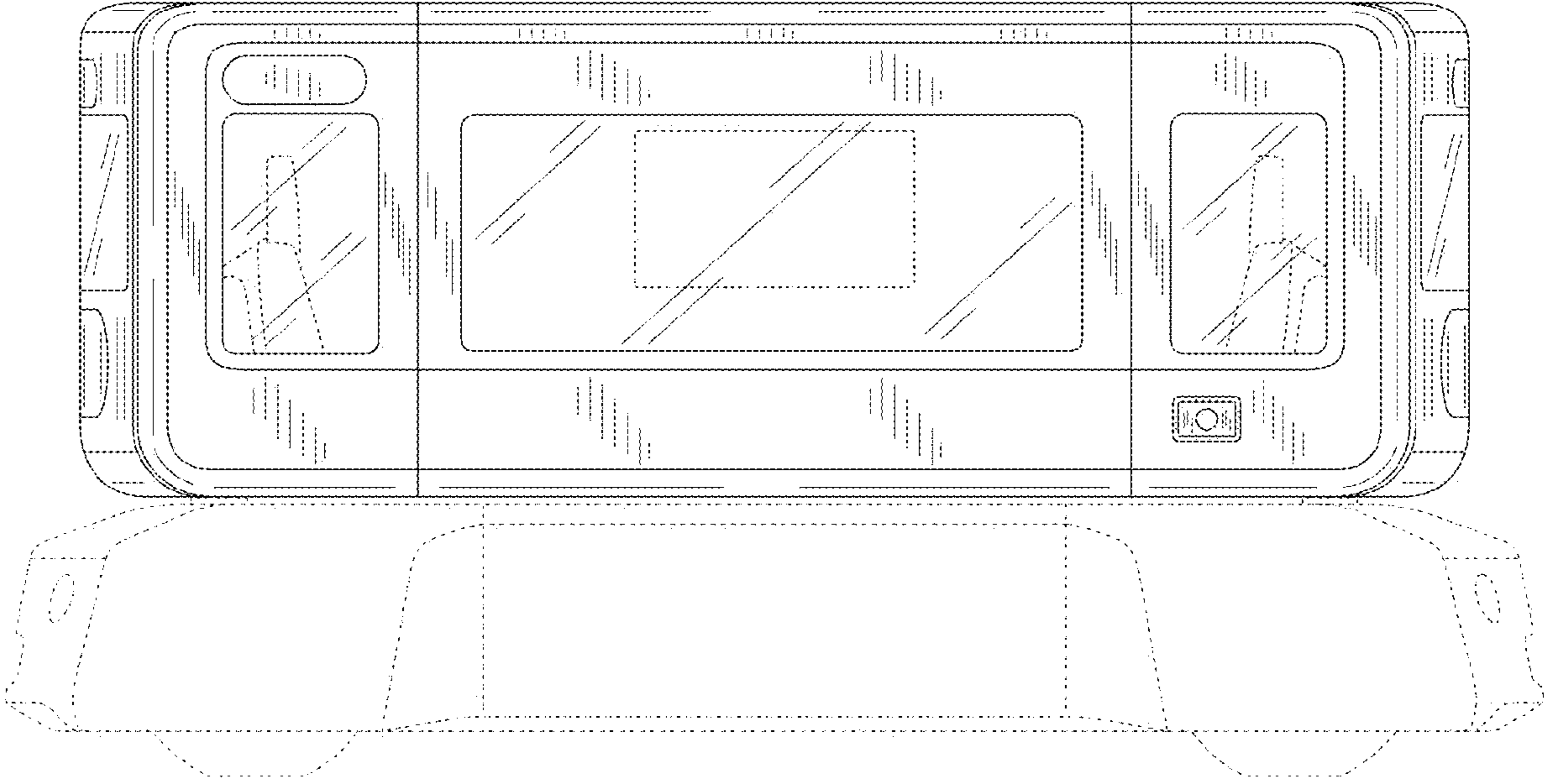

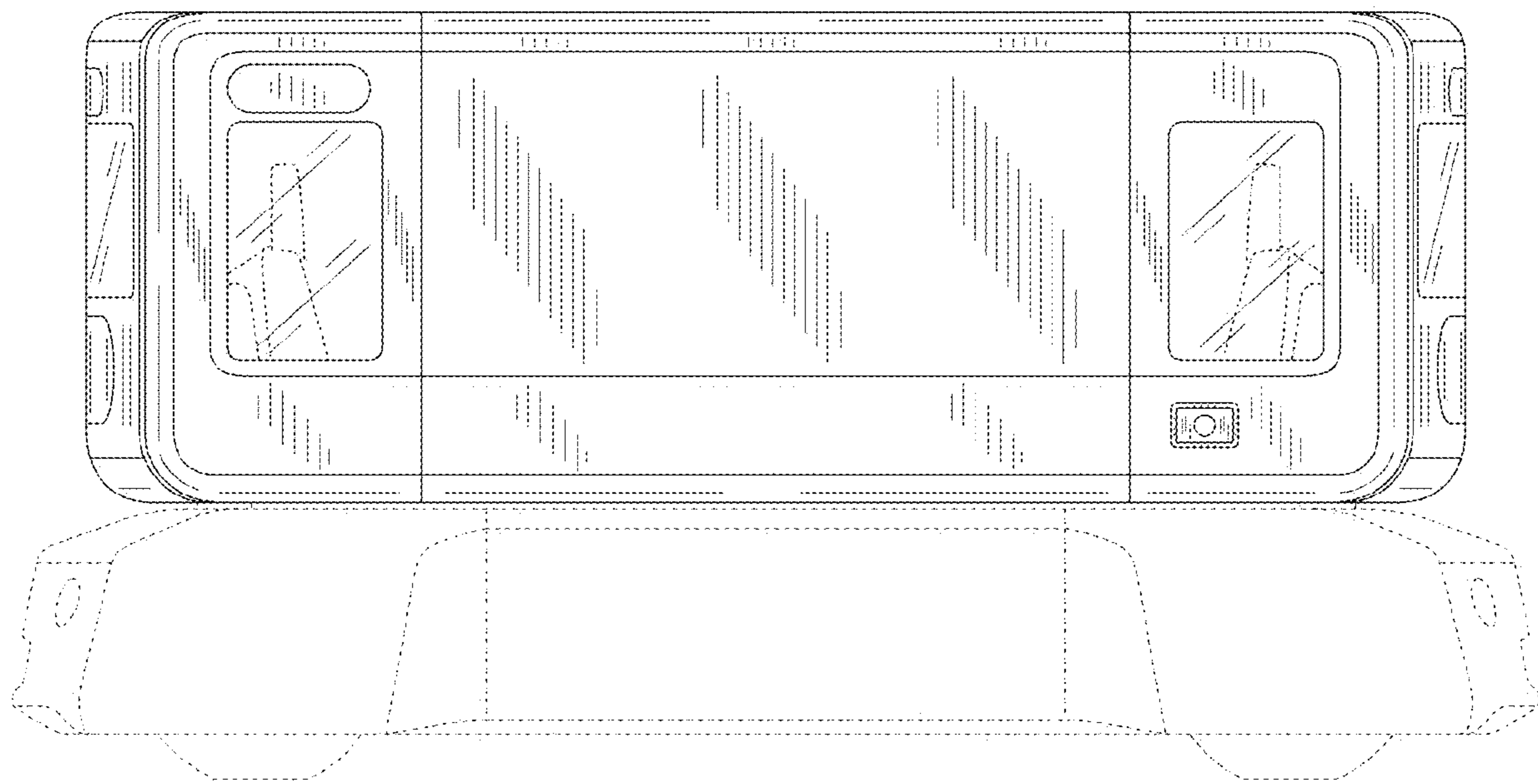

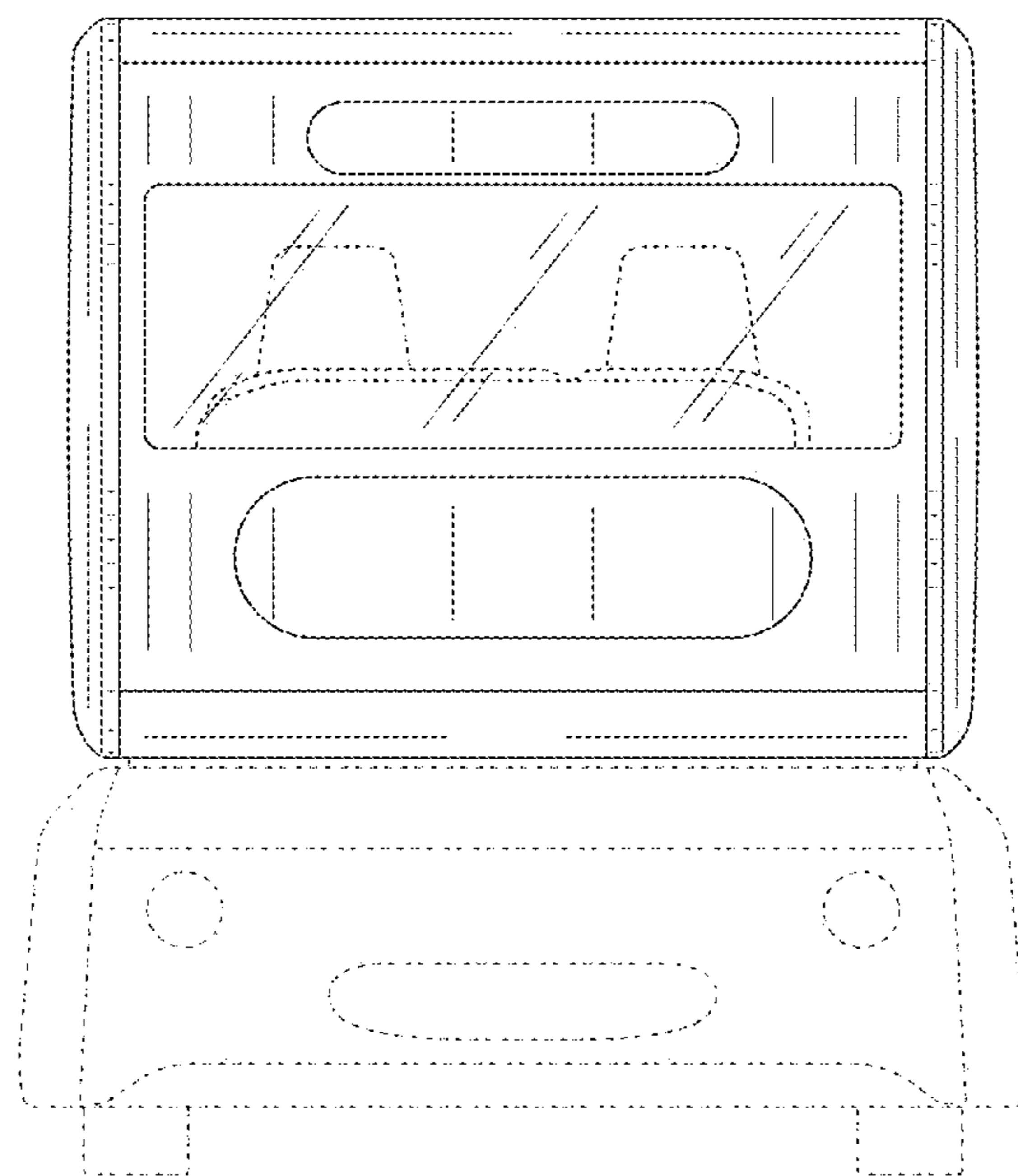

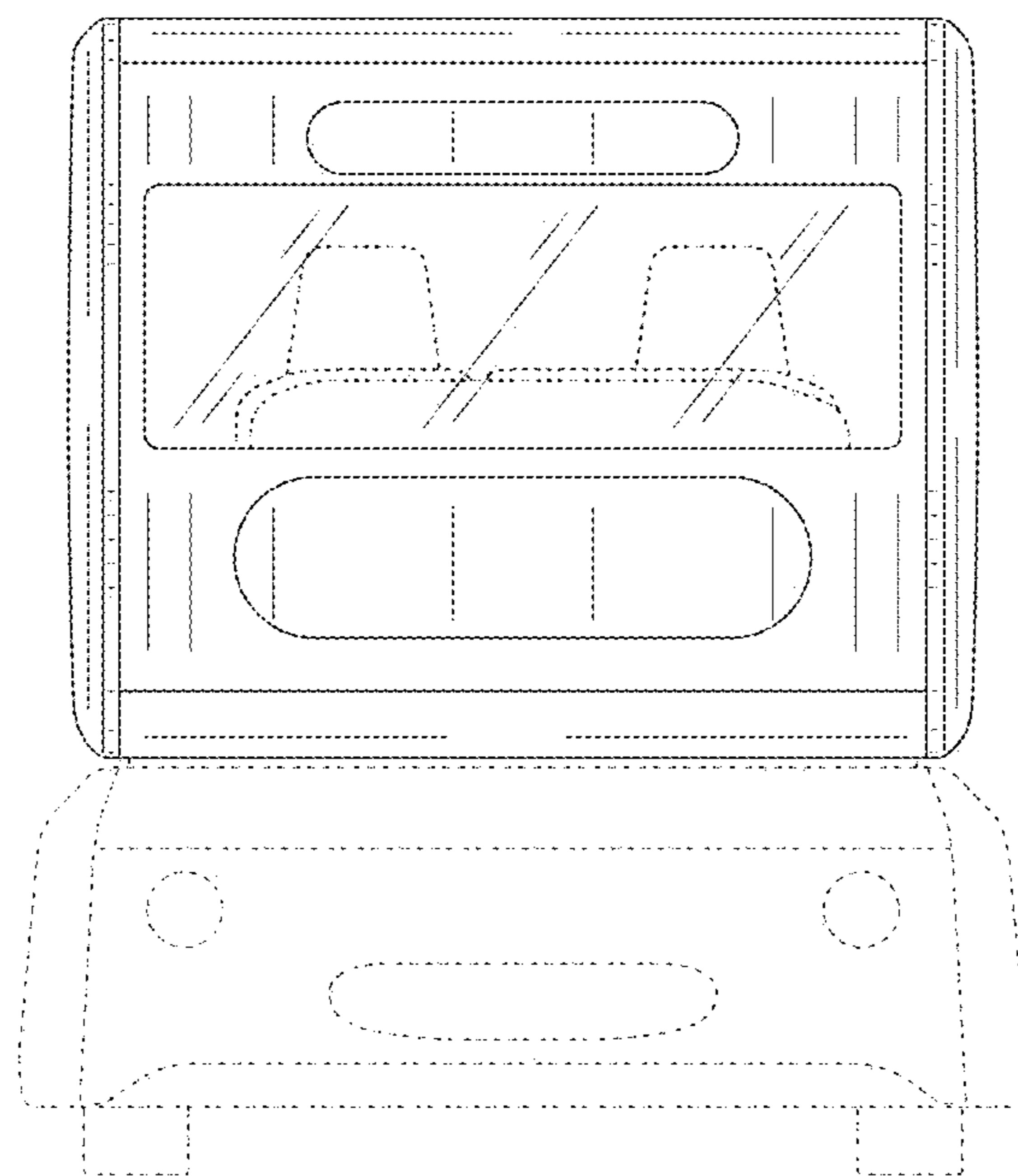

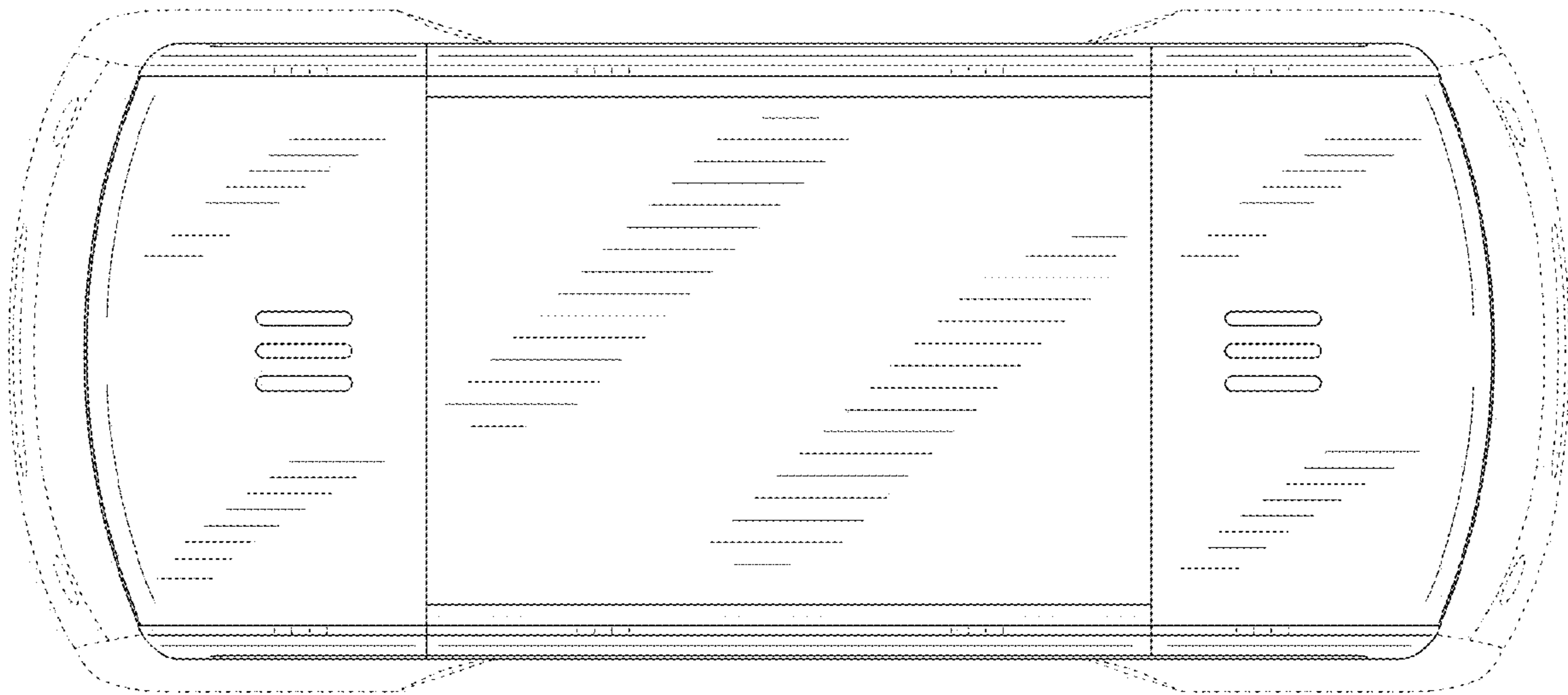

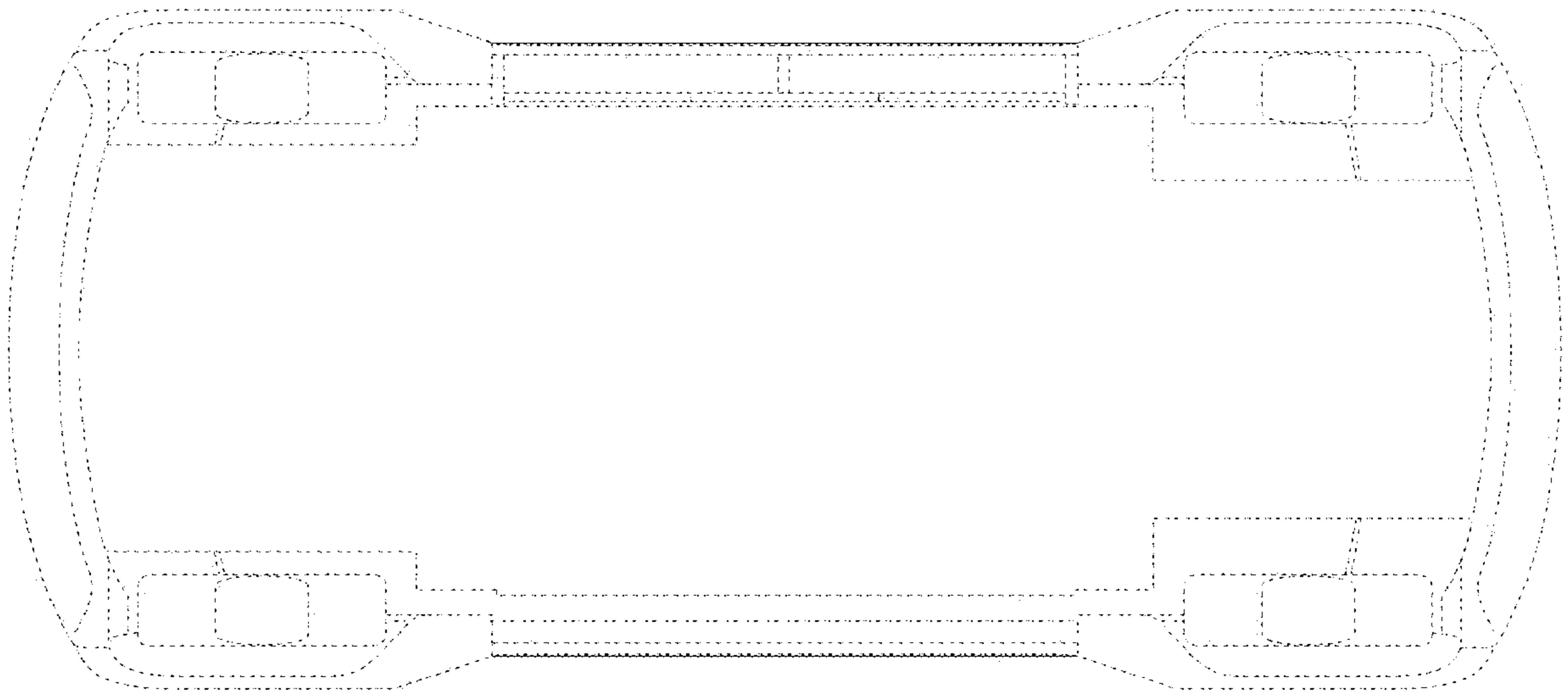

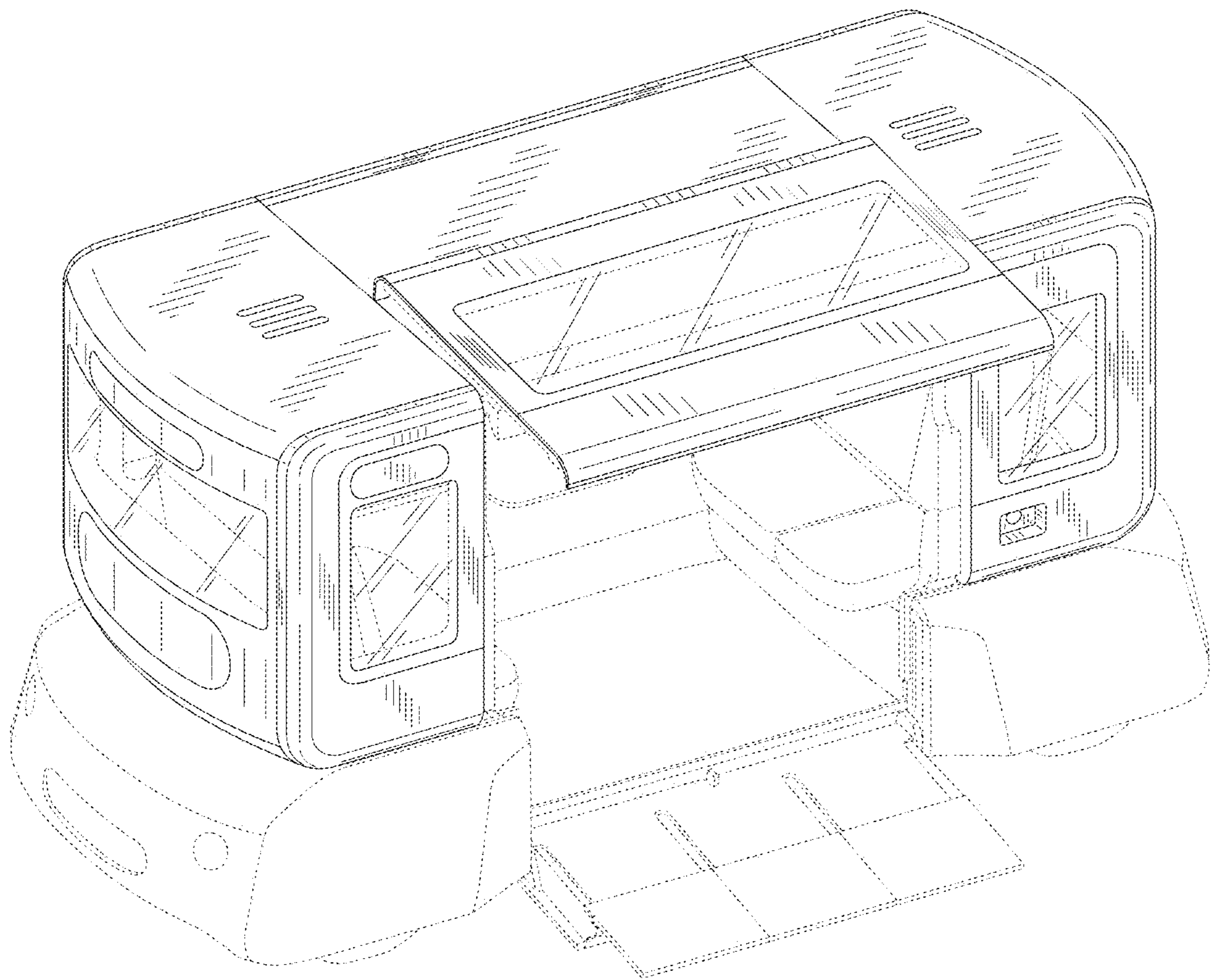
