(57) **CLAIM**

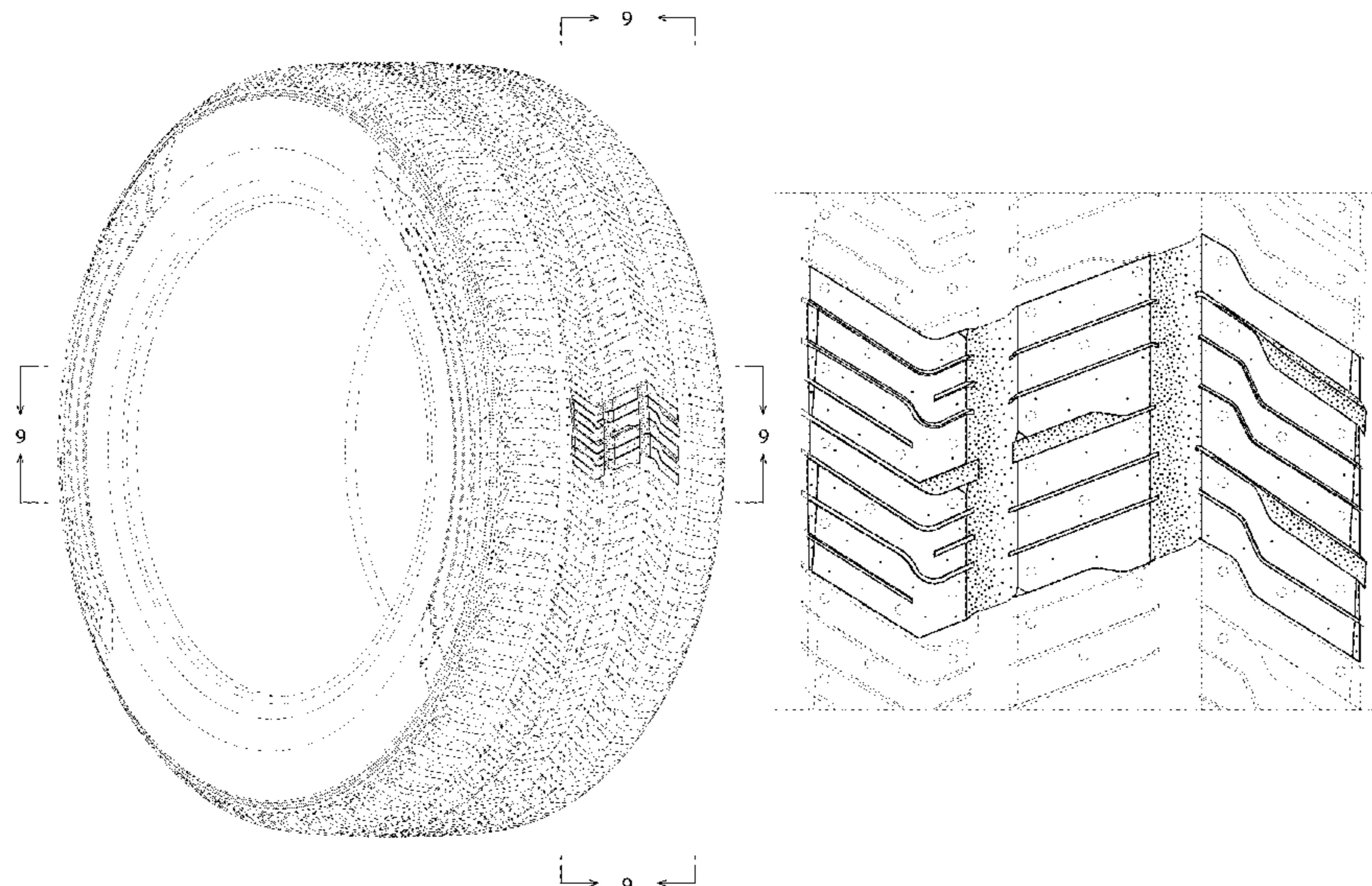
The ornamental design for an automobile tire, as shown and described.

DESCRIPTION

FIG. 1 is a left front perspective view of an automobile tire showing our new design;
 FIG. 2 is a right front perspective view thereof;
 FIG. 3 is a front view thereof;
 FIG. 4 is a rear view thereof;
 FIG. 5 is a top plan view thereof;
 FIG. 6 is a bottom plan views thereof;
 FIG. 7 is a left side view thereof;
 FIG. 8 is a right side view thereof;
 FIG. 9 is an enlarged fragmental left front perspective view taken along lines 9-9 in FIG. 1;
 FIG. 10 is an enlarged fragmental right front perspective view taken along lines 10-10 in FIG. 2; and,
 FIG. 11 is an enlarged fragmental front view taken along lines 11-11 in FIG. 3.

The dashed broken lines in the drawings are for the purpose of illustrating unclaimed portions of the tire and form no part of the claimed design, and the dash-dot-dash broken lines illustrate the boundary of the claimed design.

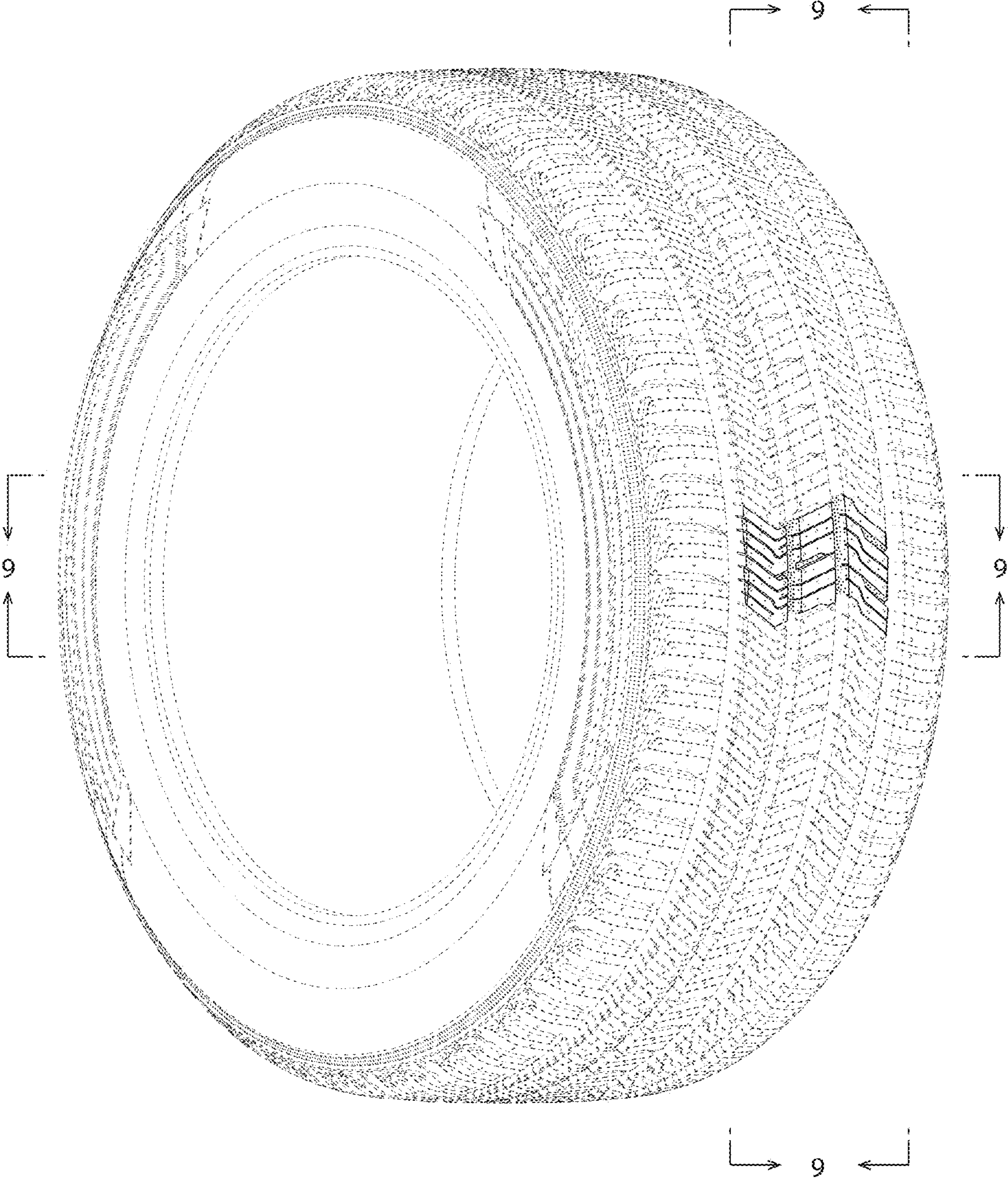

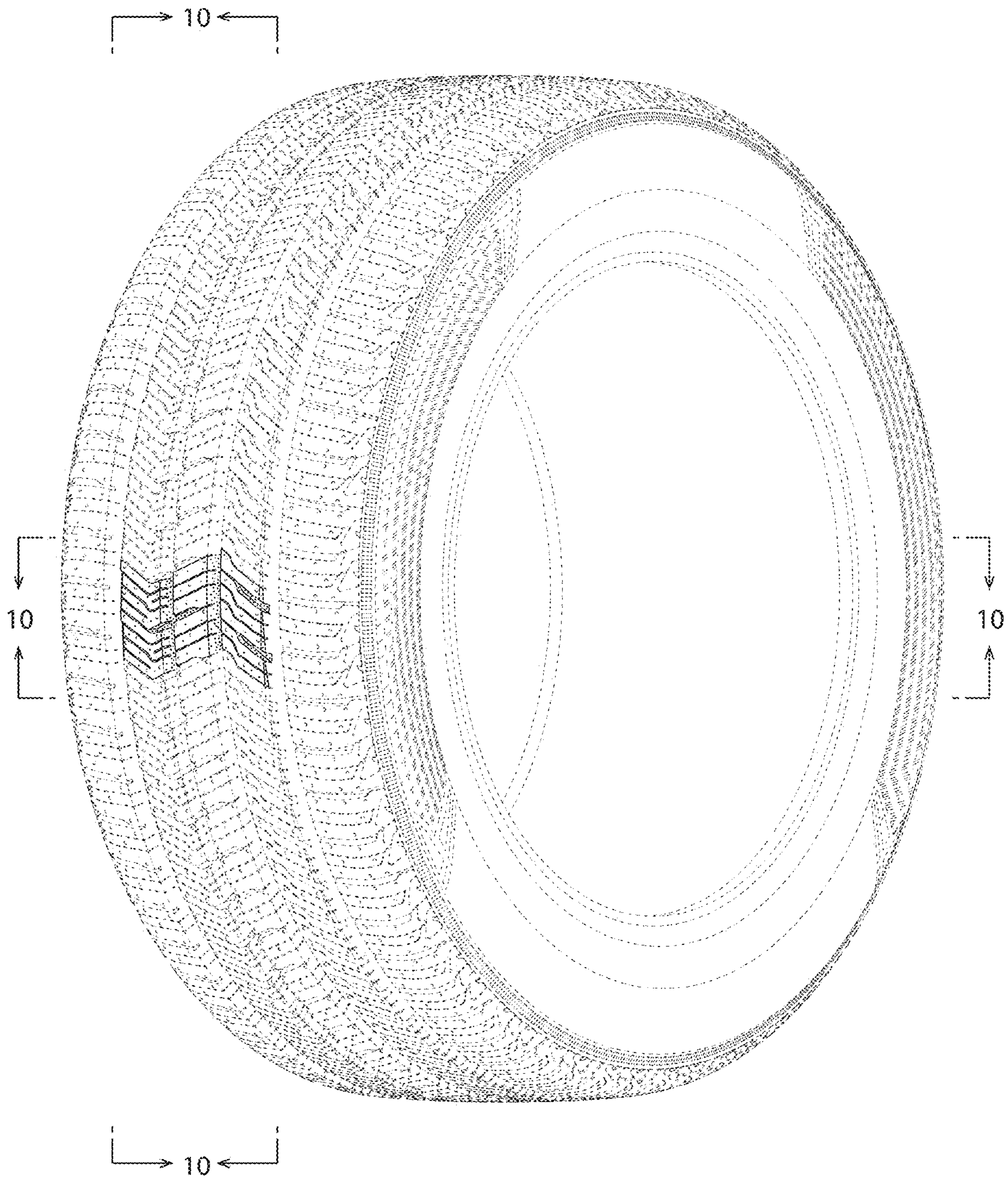

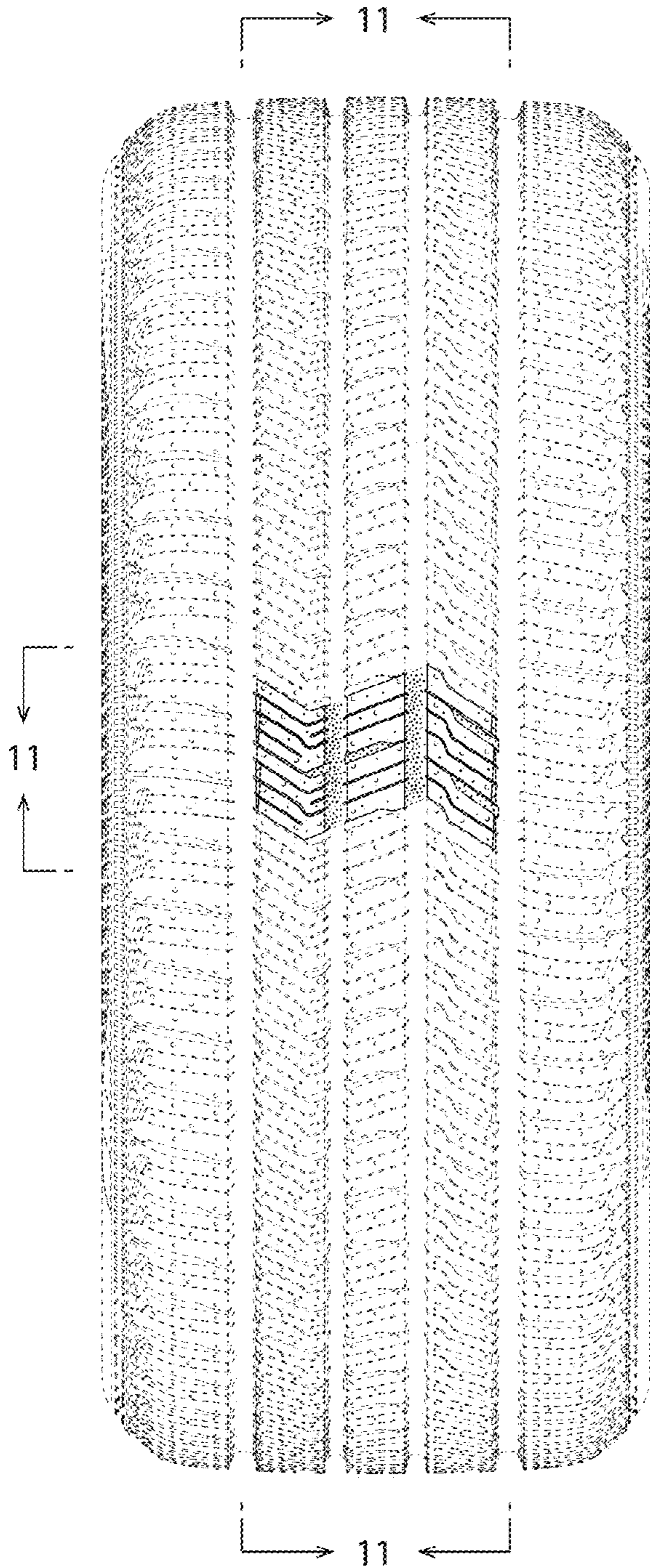

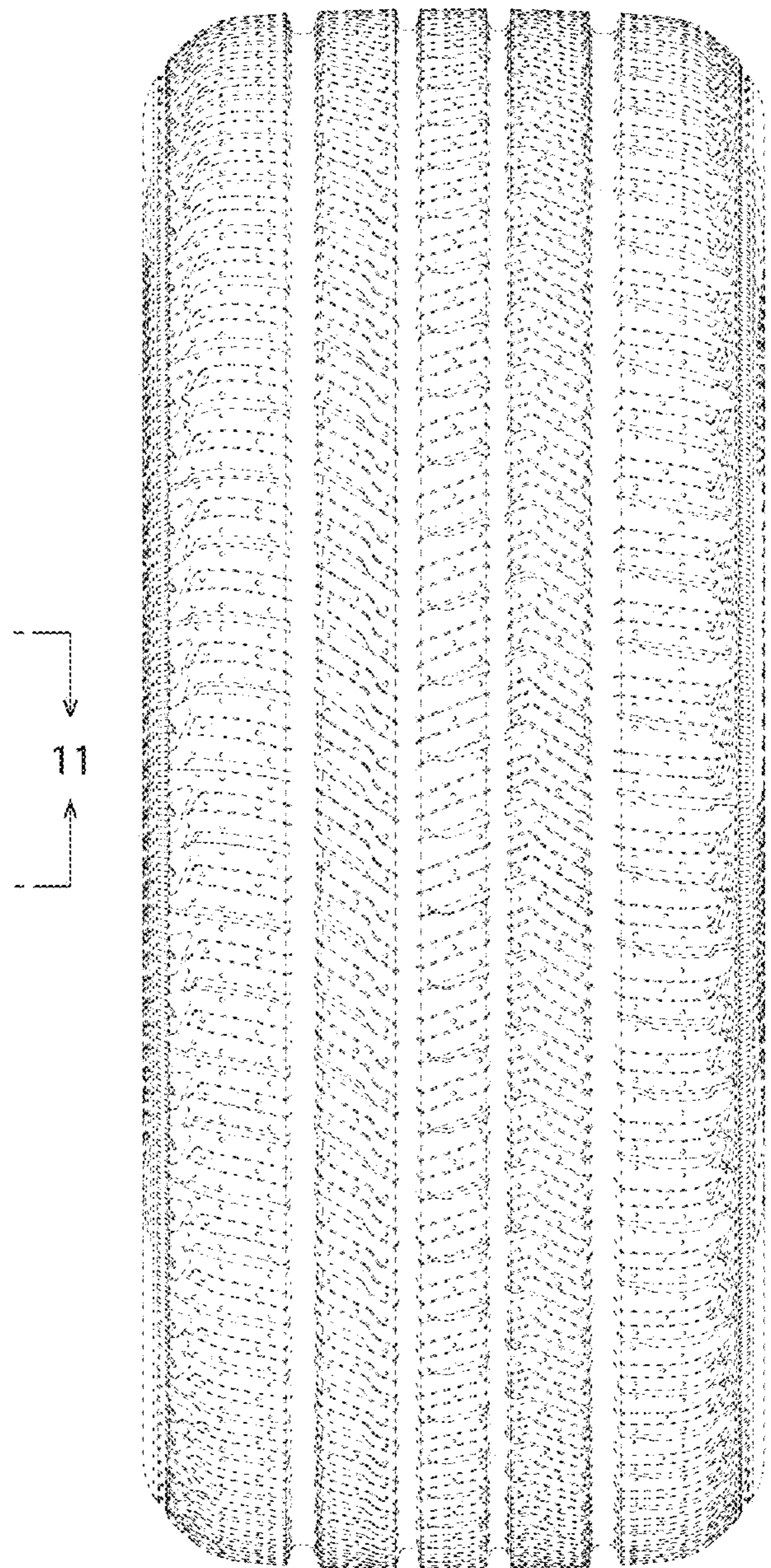

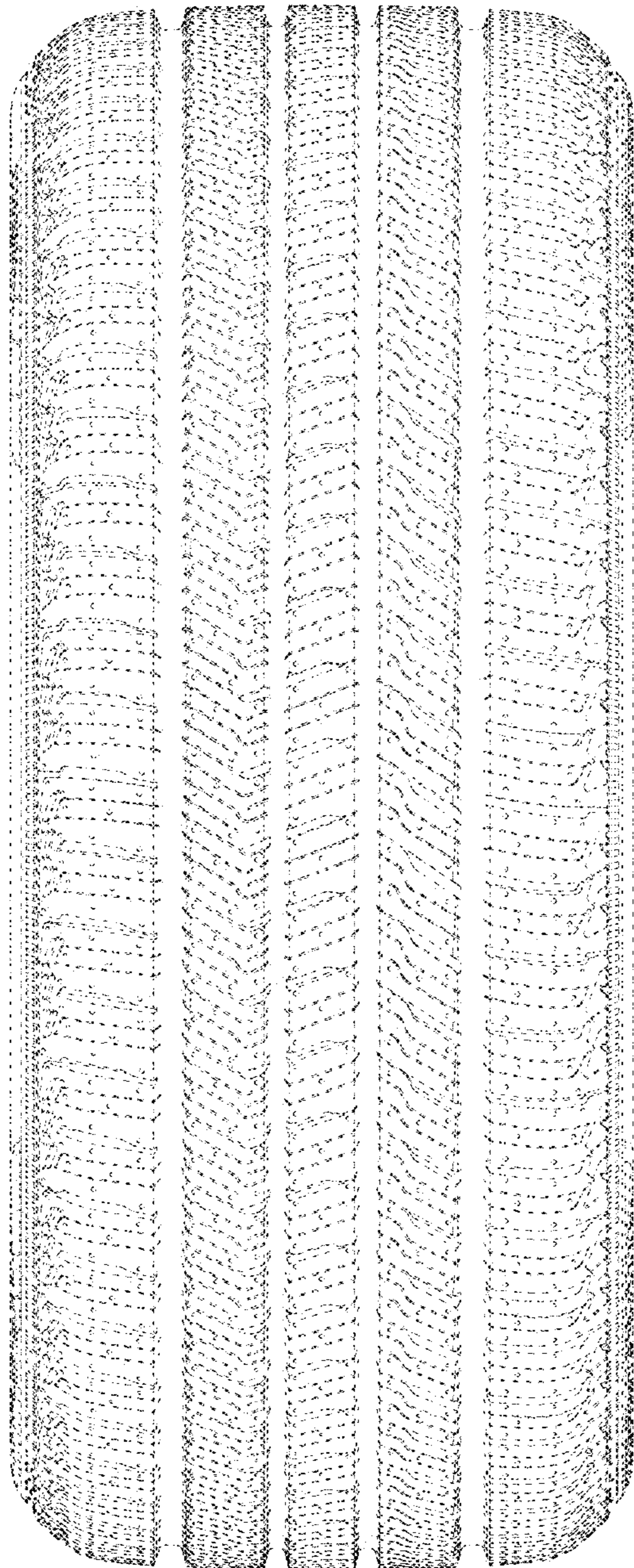

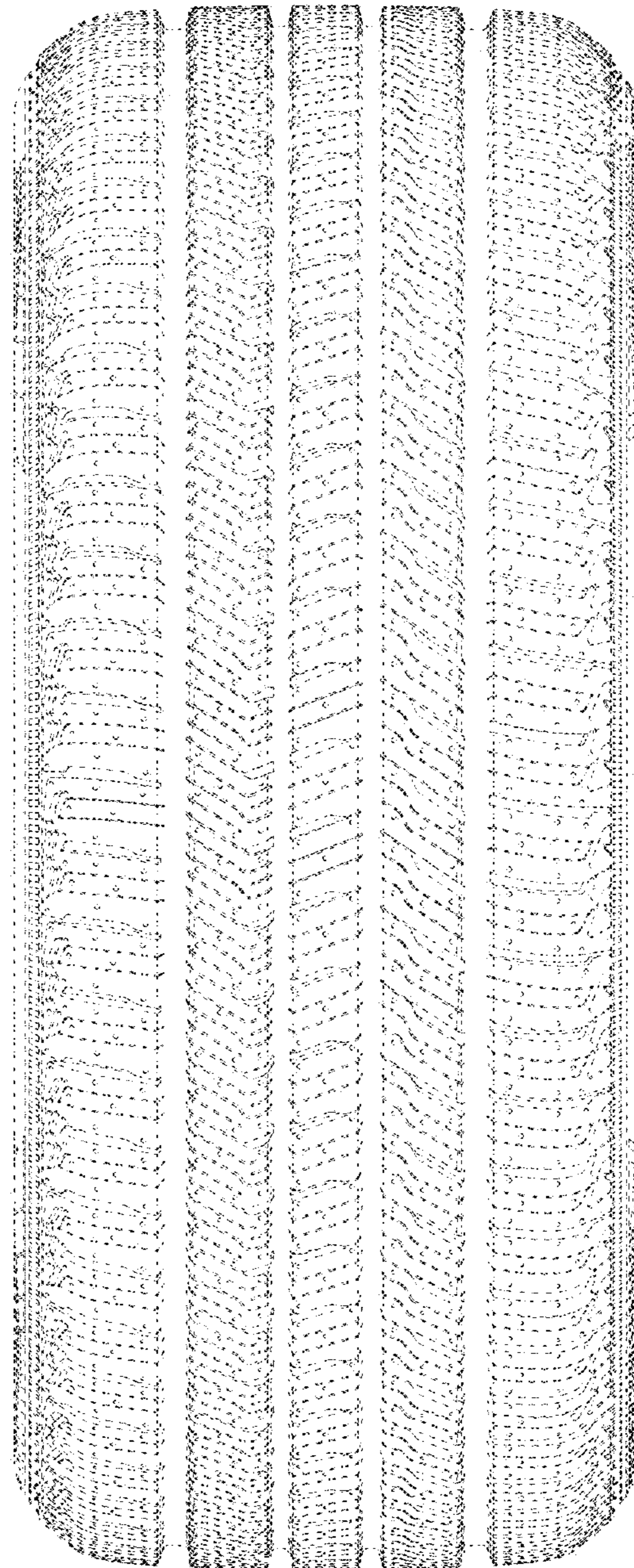

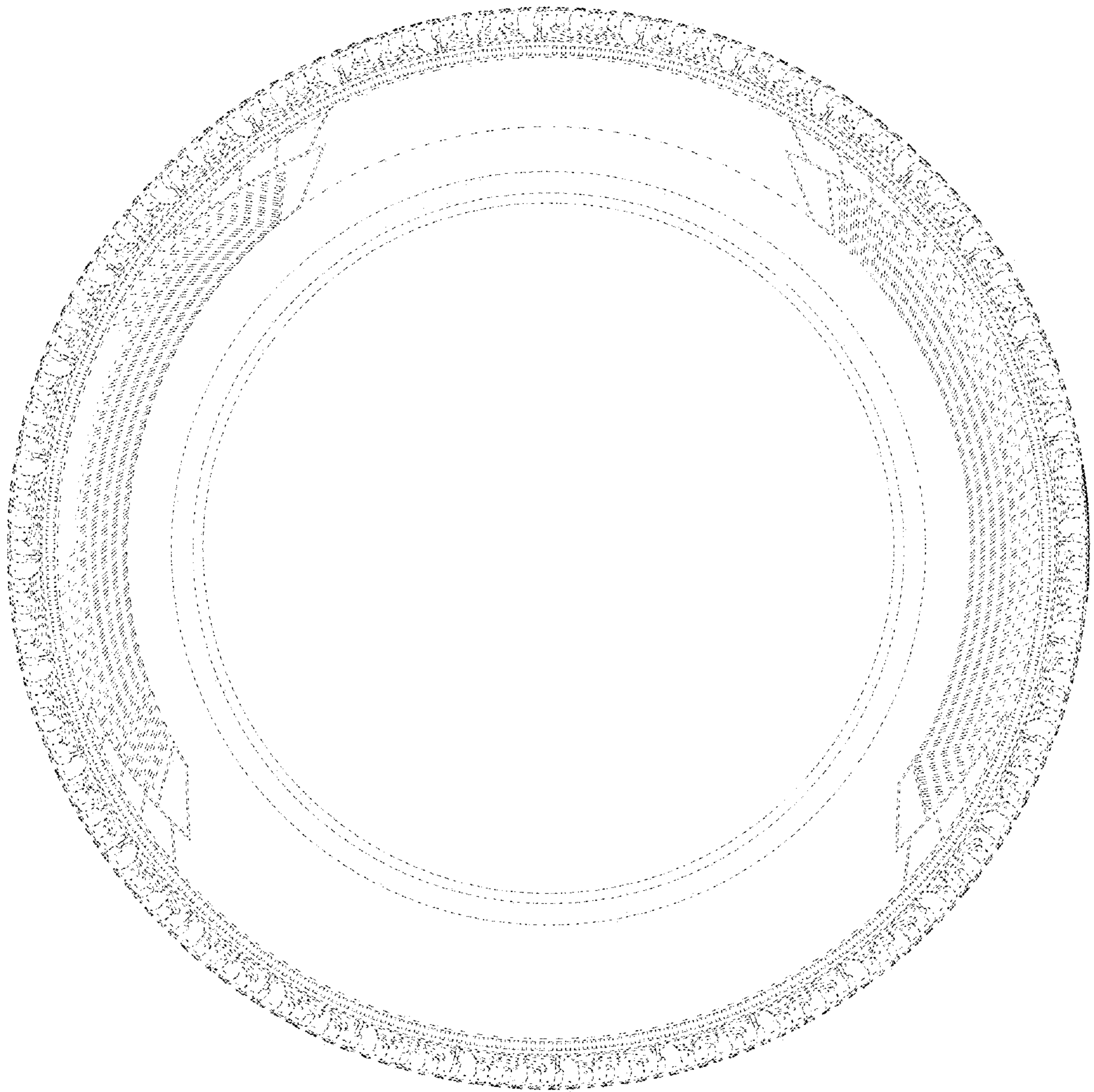

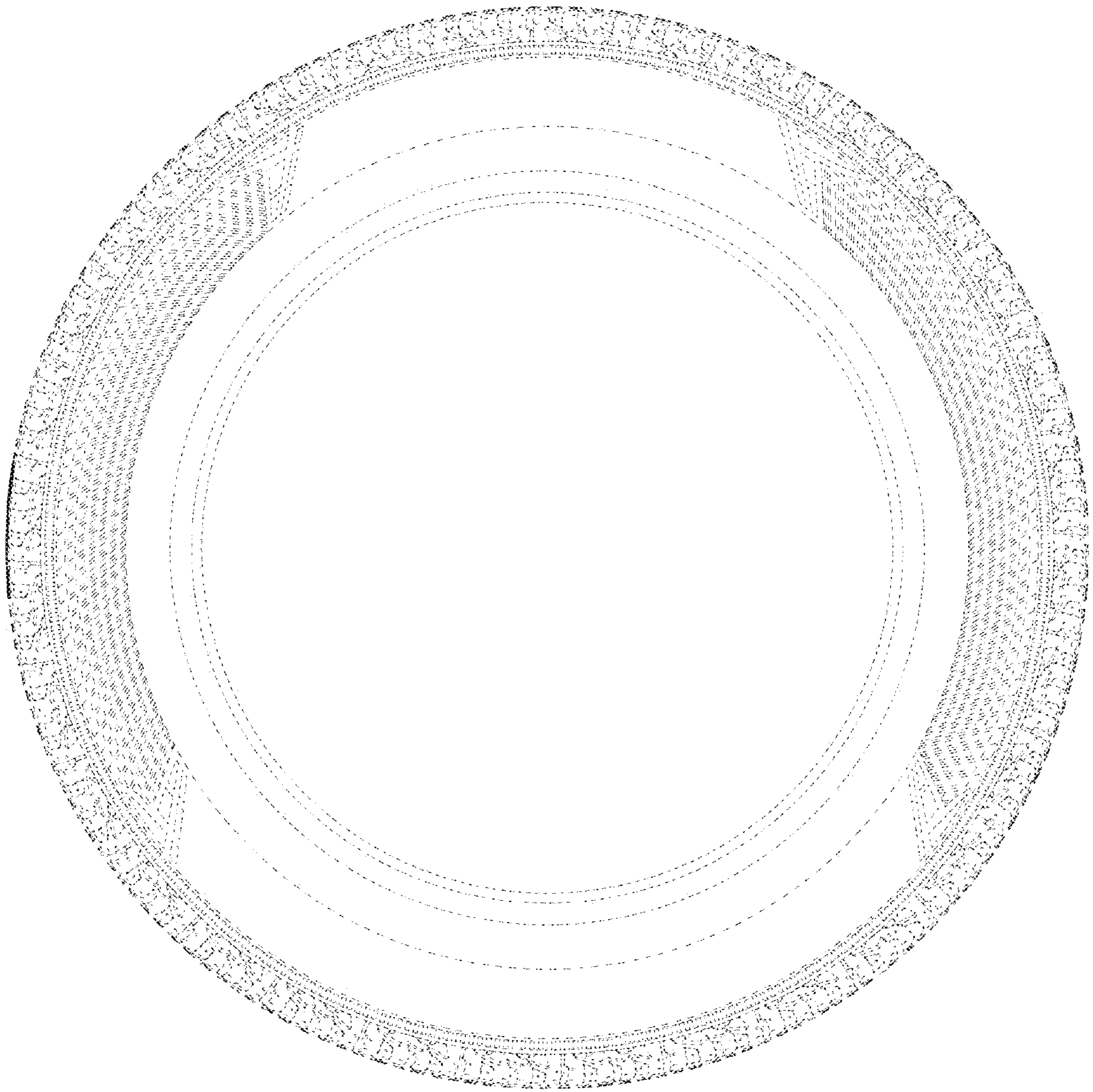

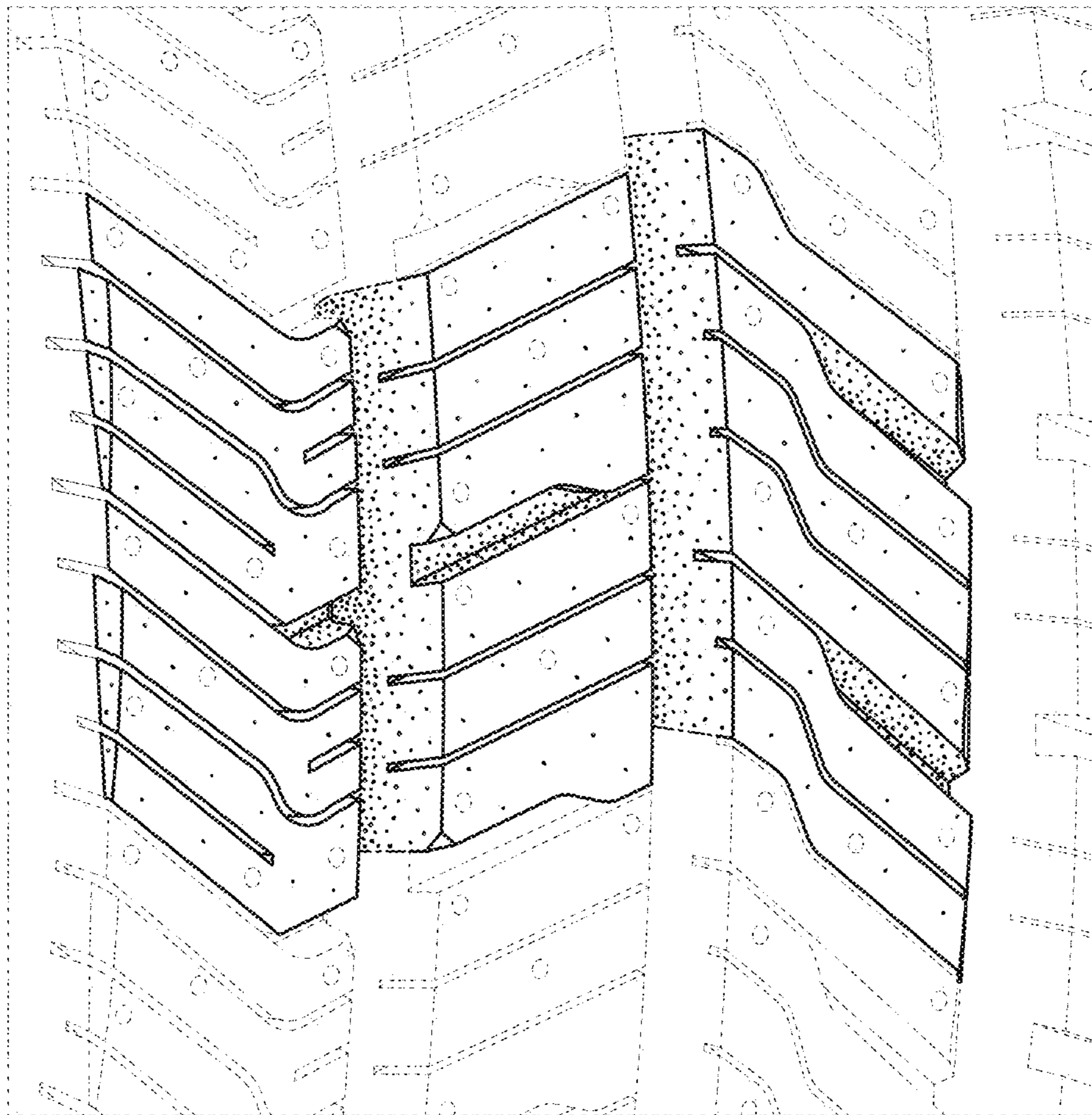

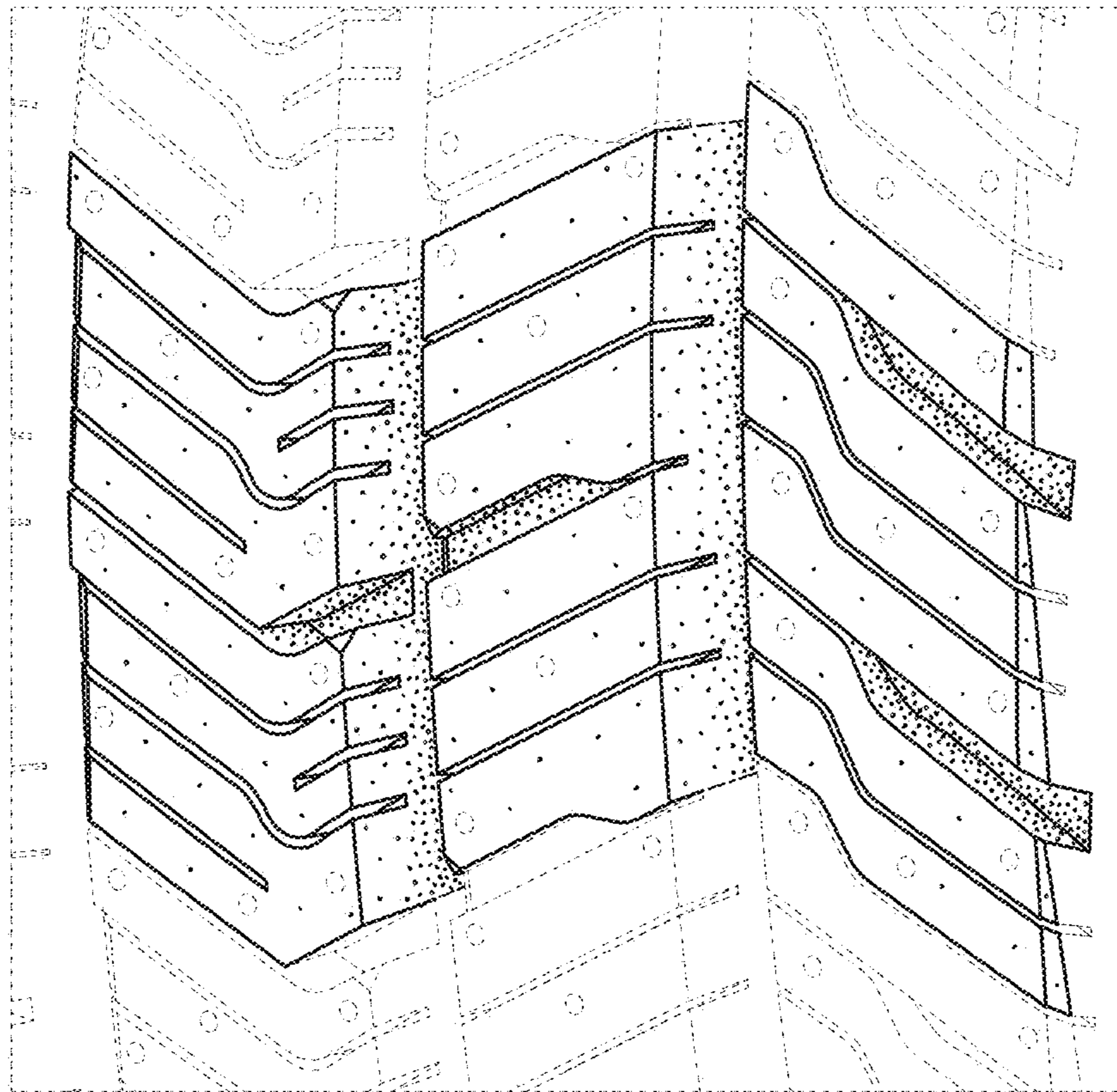
