(57) **CLAIM**

The ornamental design for a millimeter-wave radio equipment enclosure, as shown and described herein.

DESCRIPTION

FIG. 1 is a left side, front, and top perspective top view of a millimeter-wave radio equipment enclosure, showing the new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a top plan view thereof;

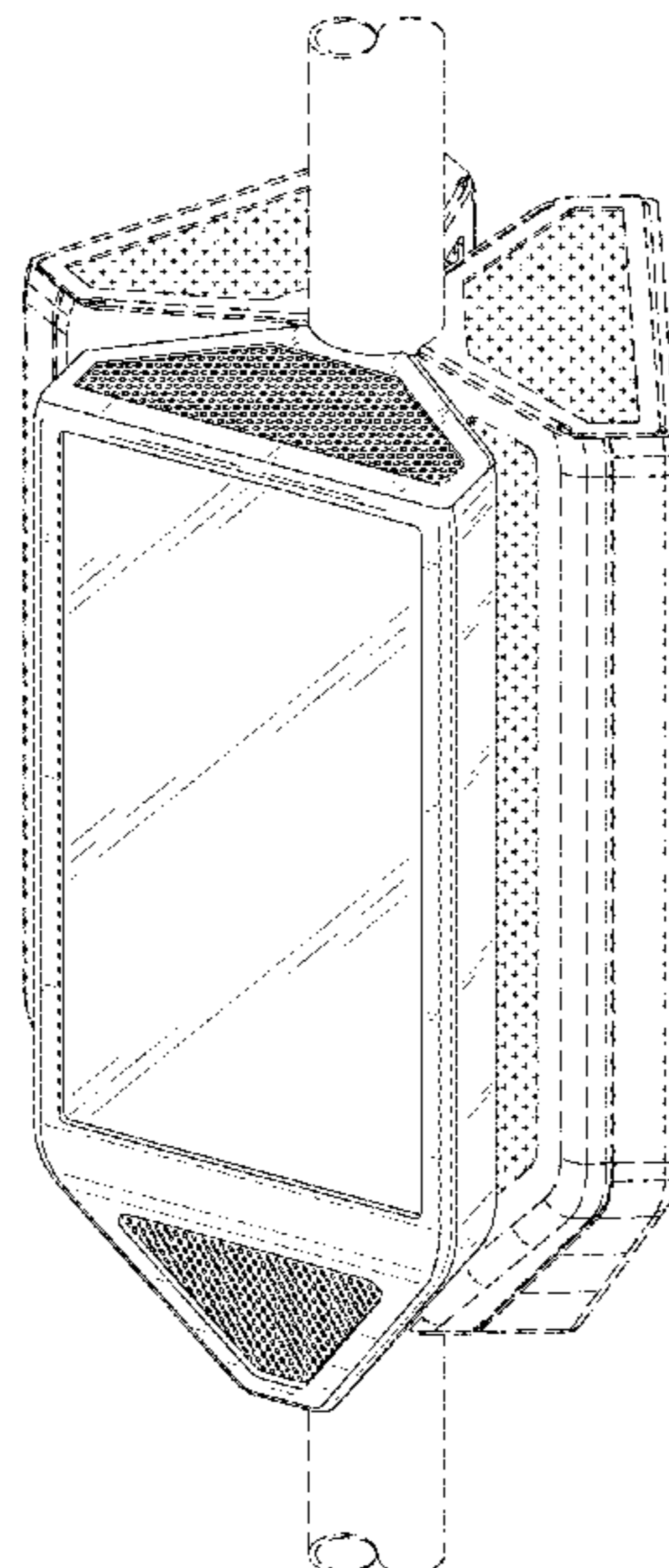
FIG. 4 is a left side elevational view thereof;

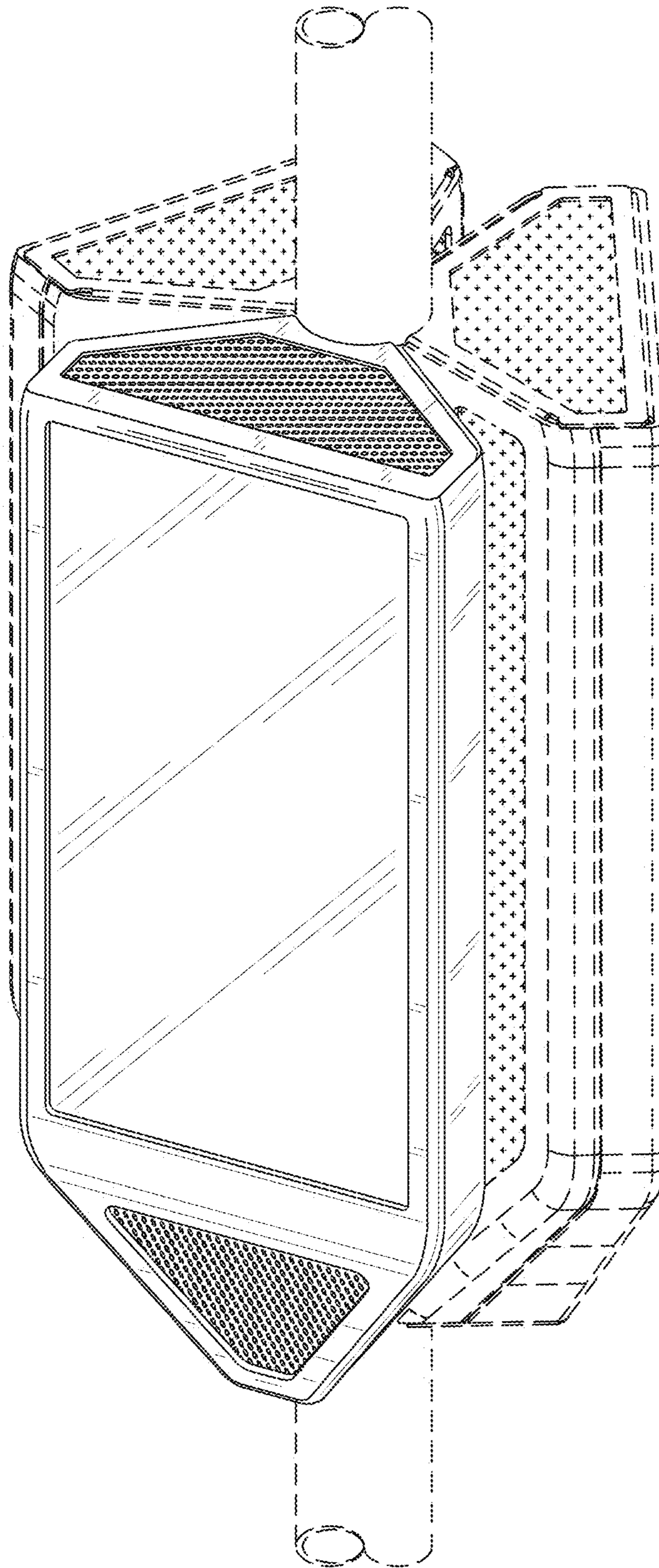

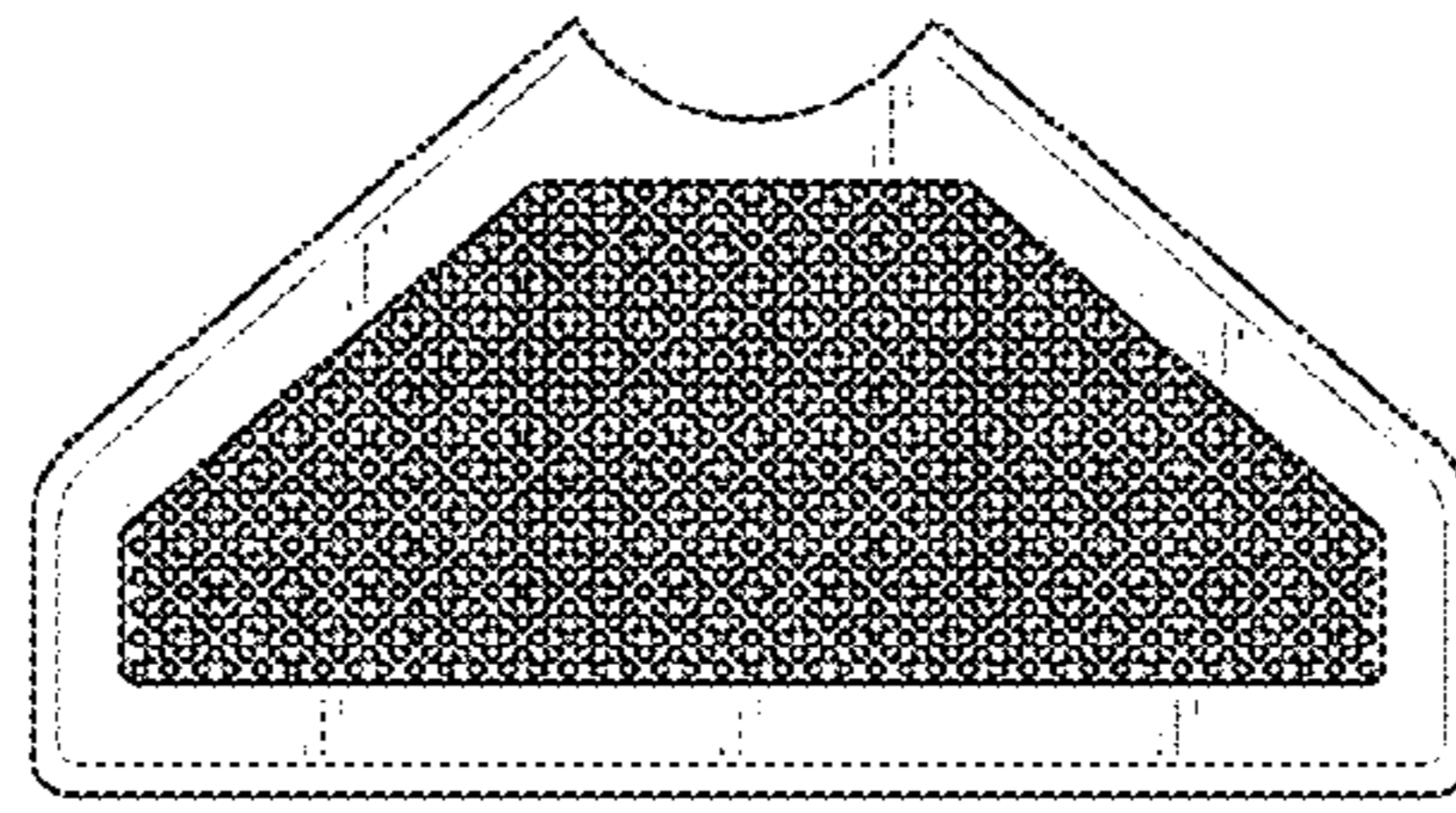

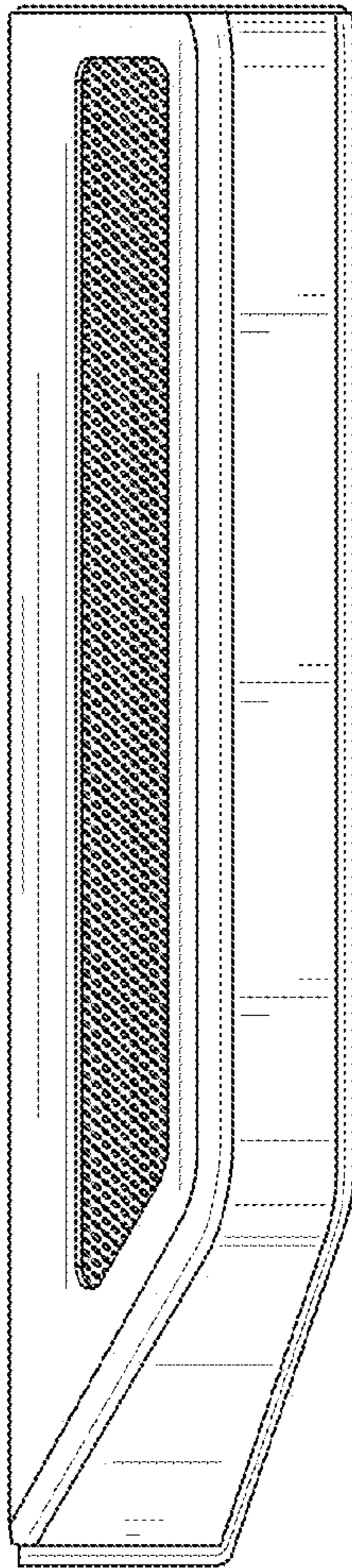

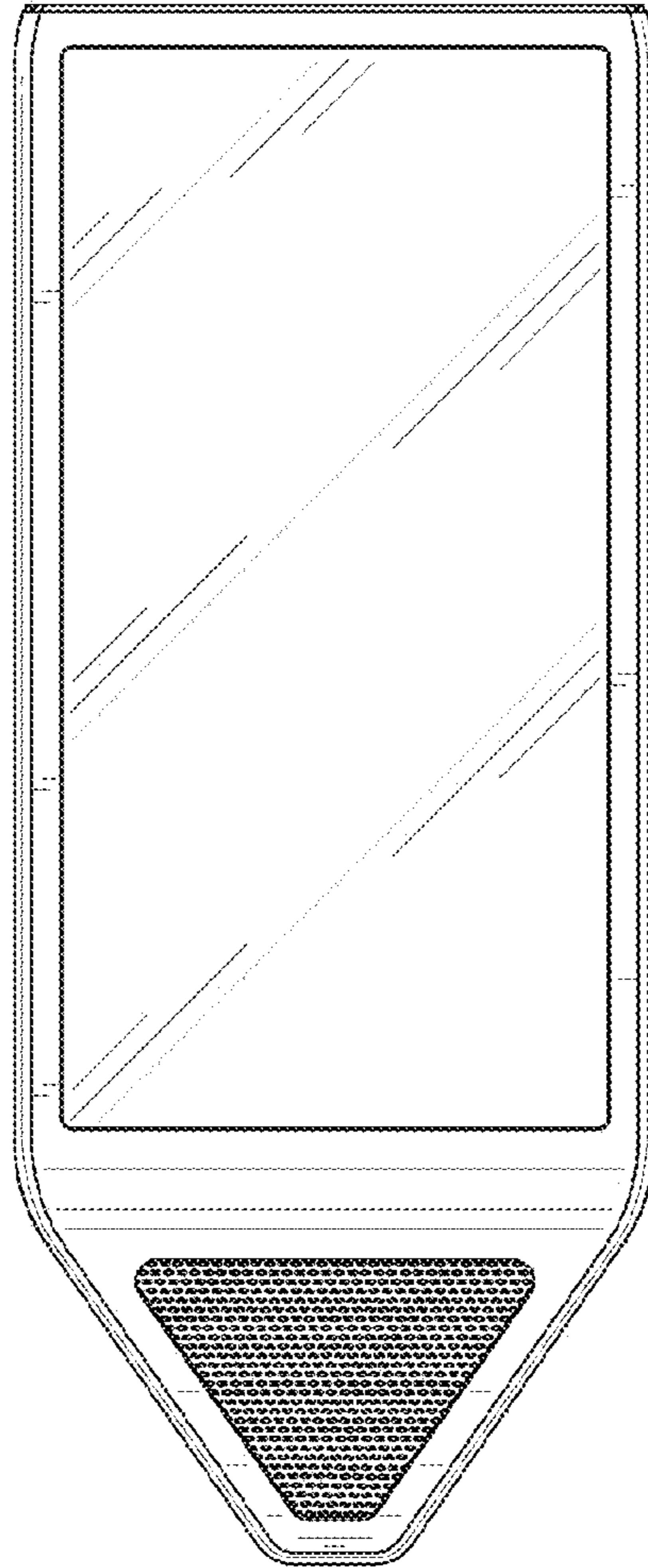

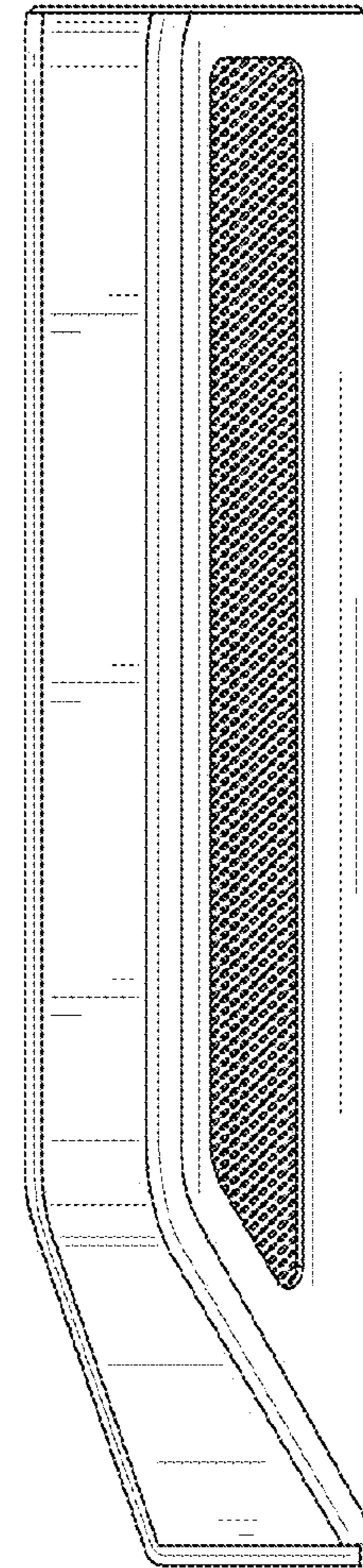

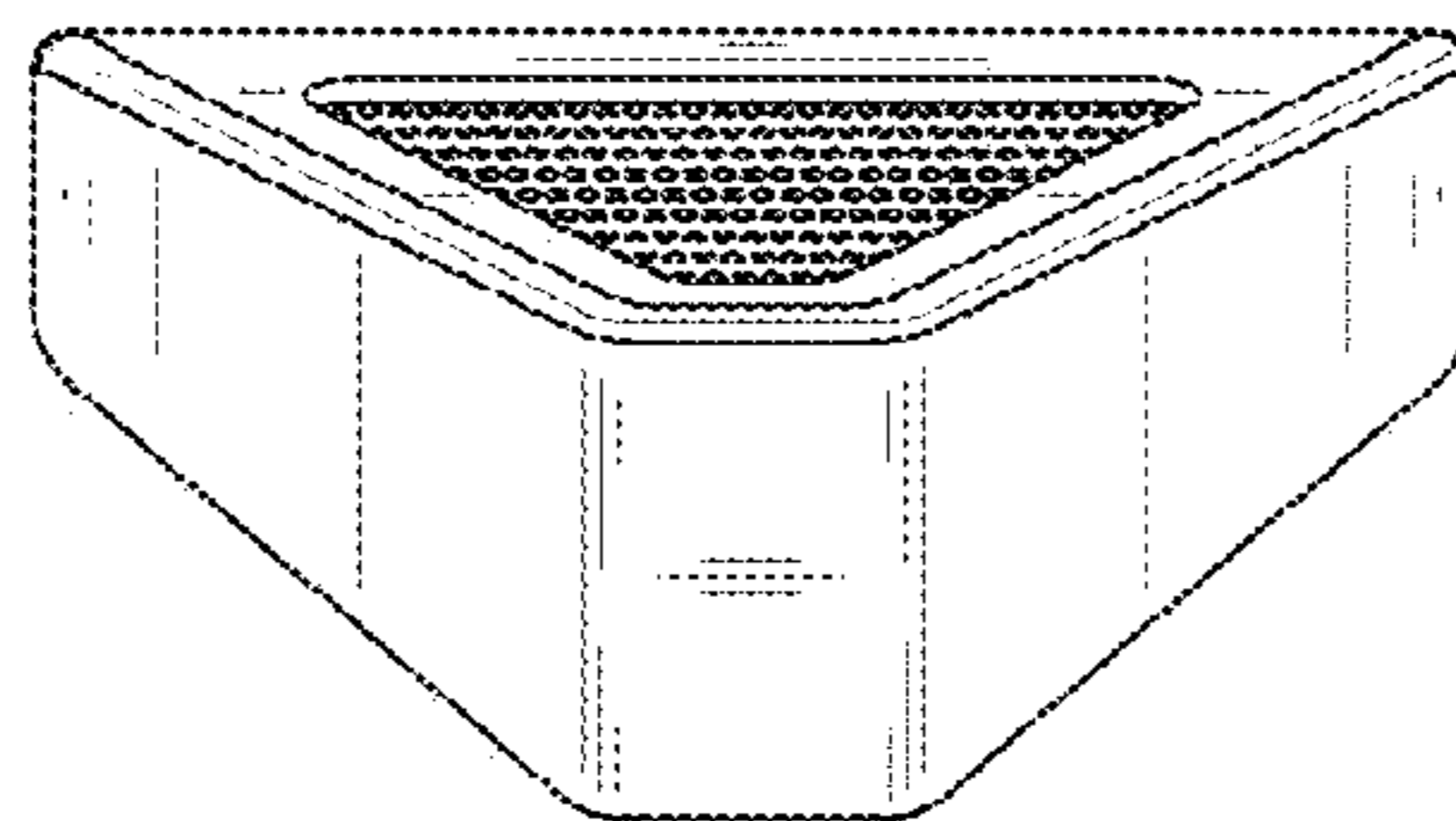
