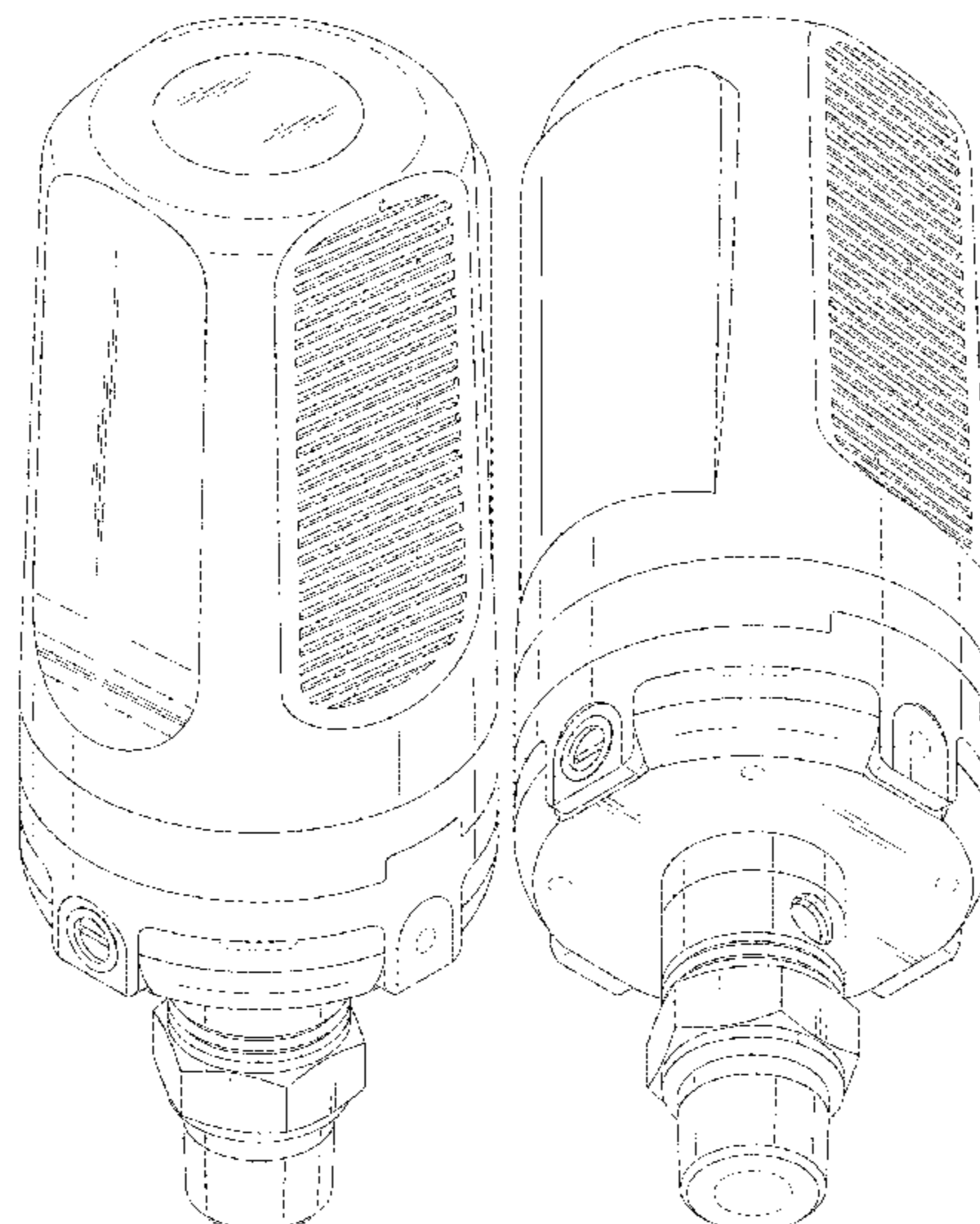
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of front, top and right side view of a wireless communication device showing our new design;

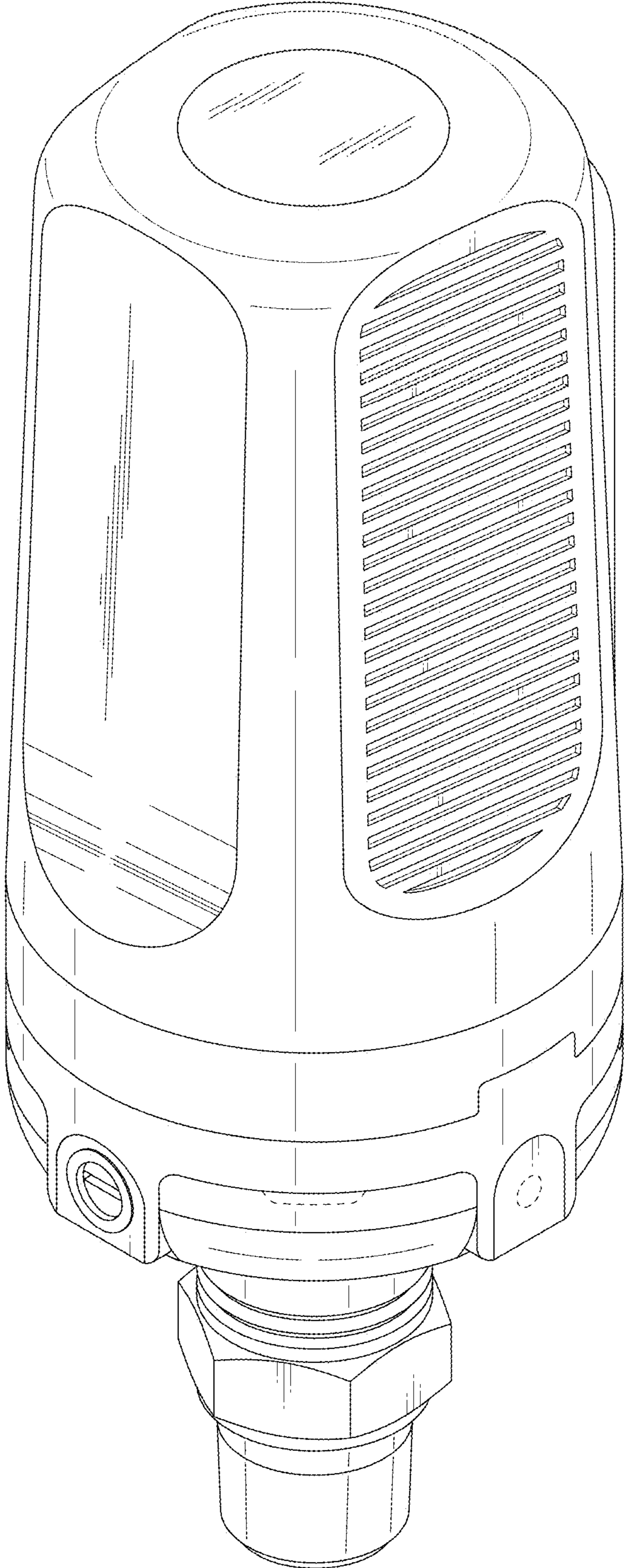
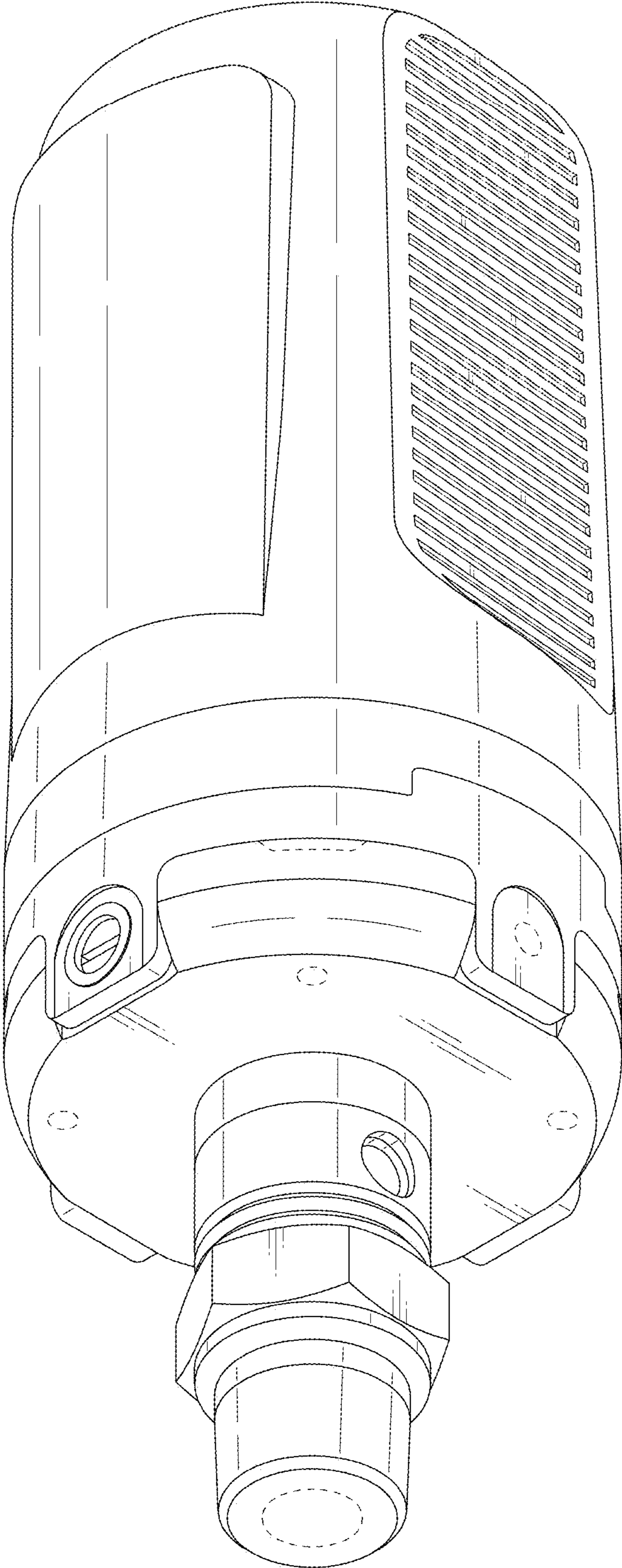

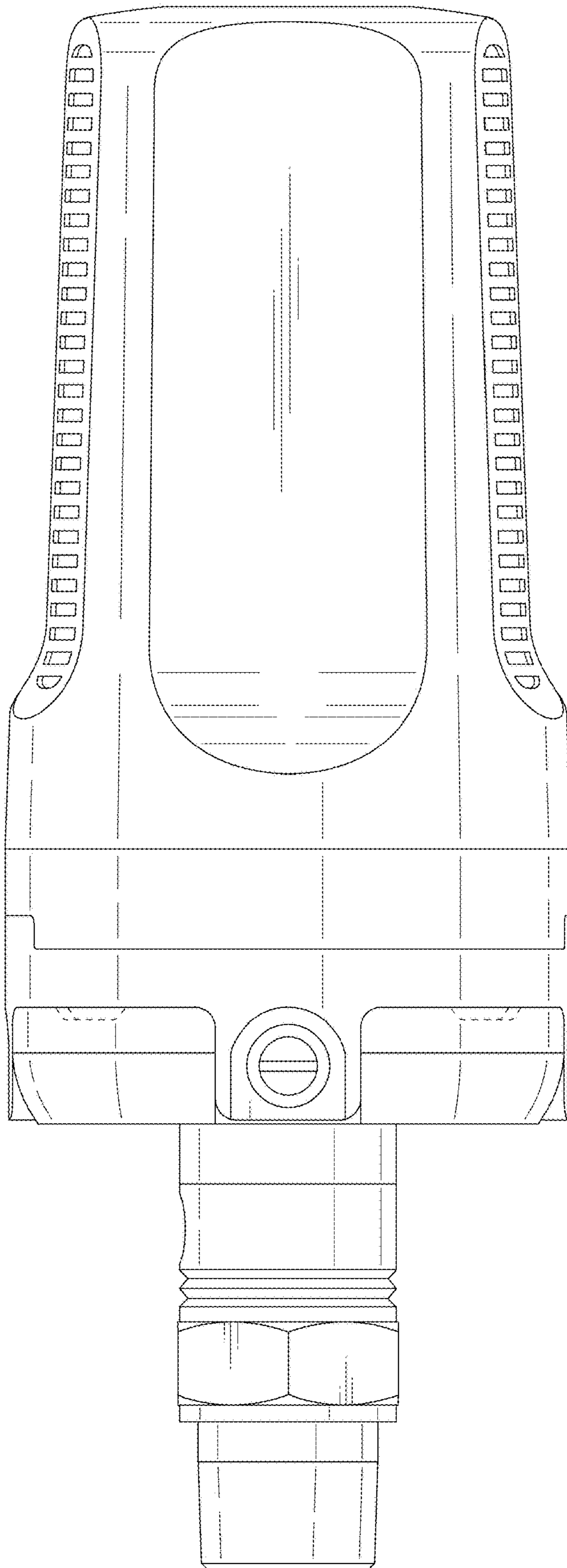

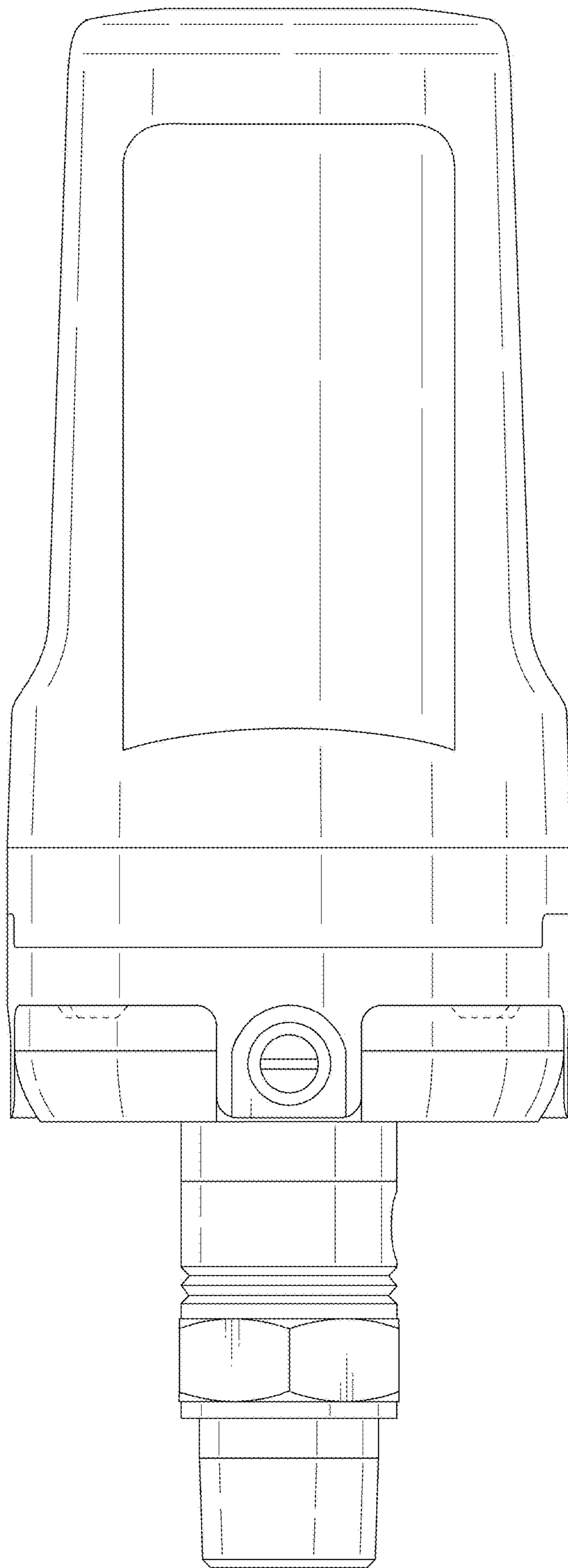

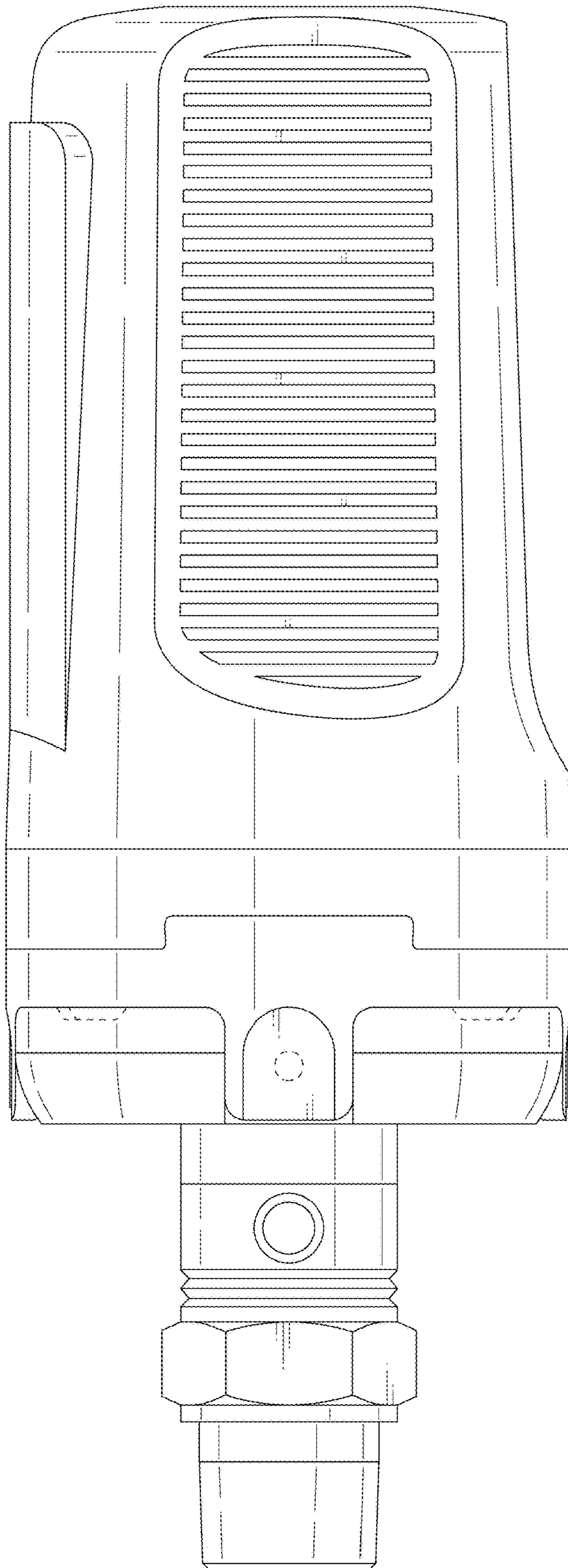

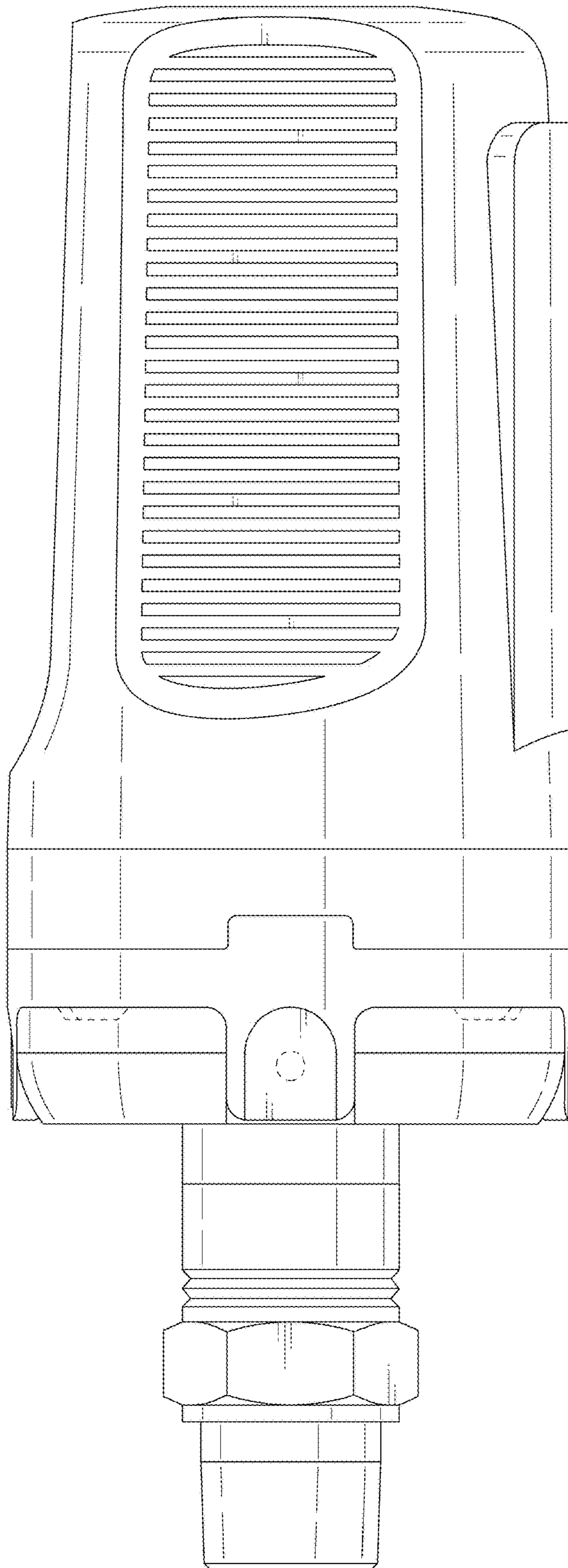

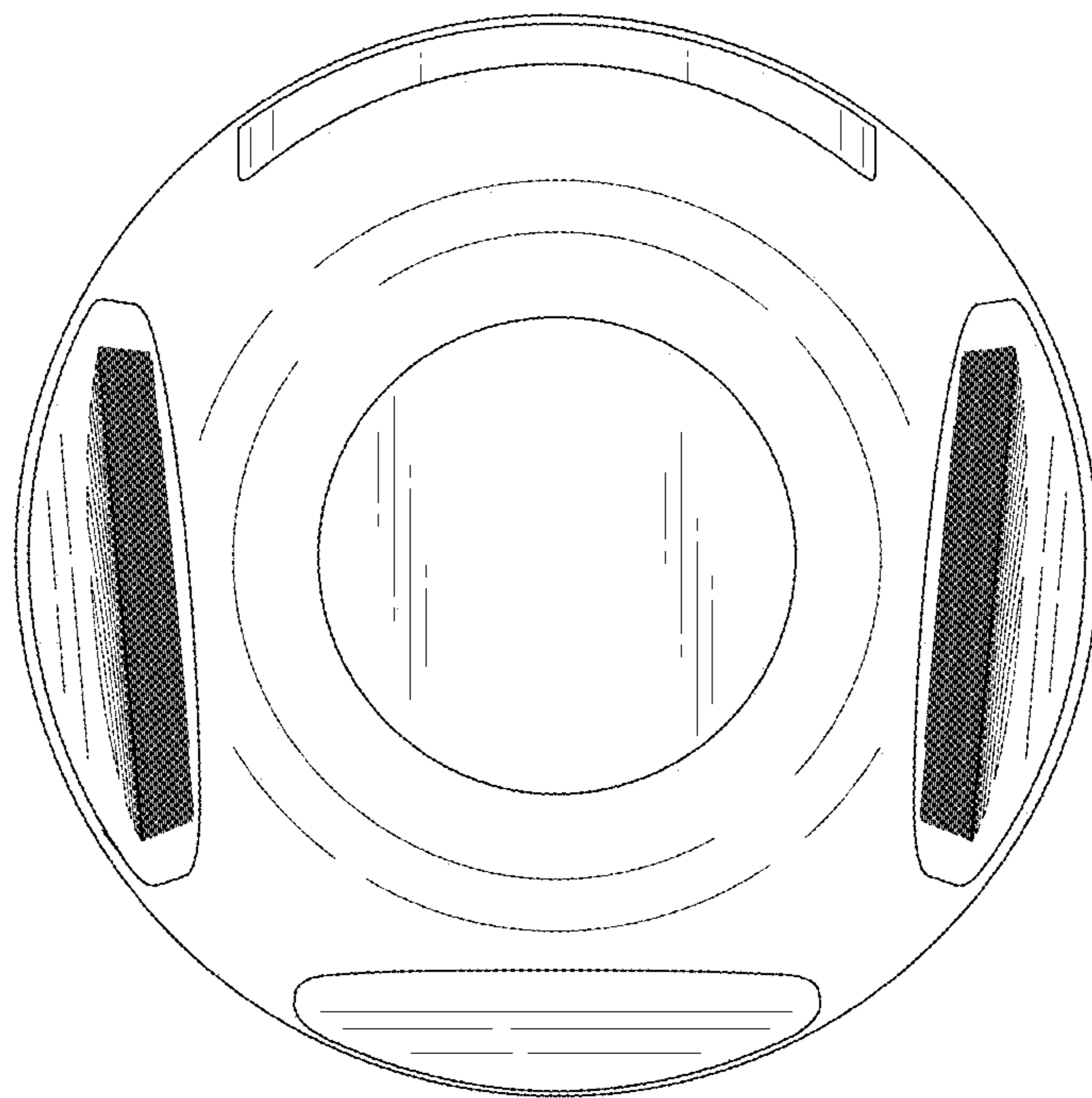
