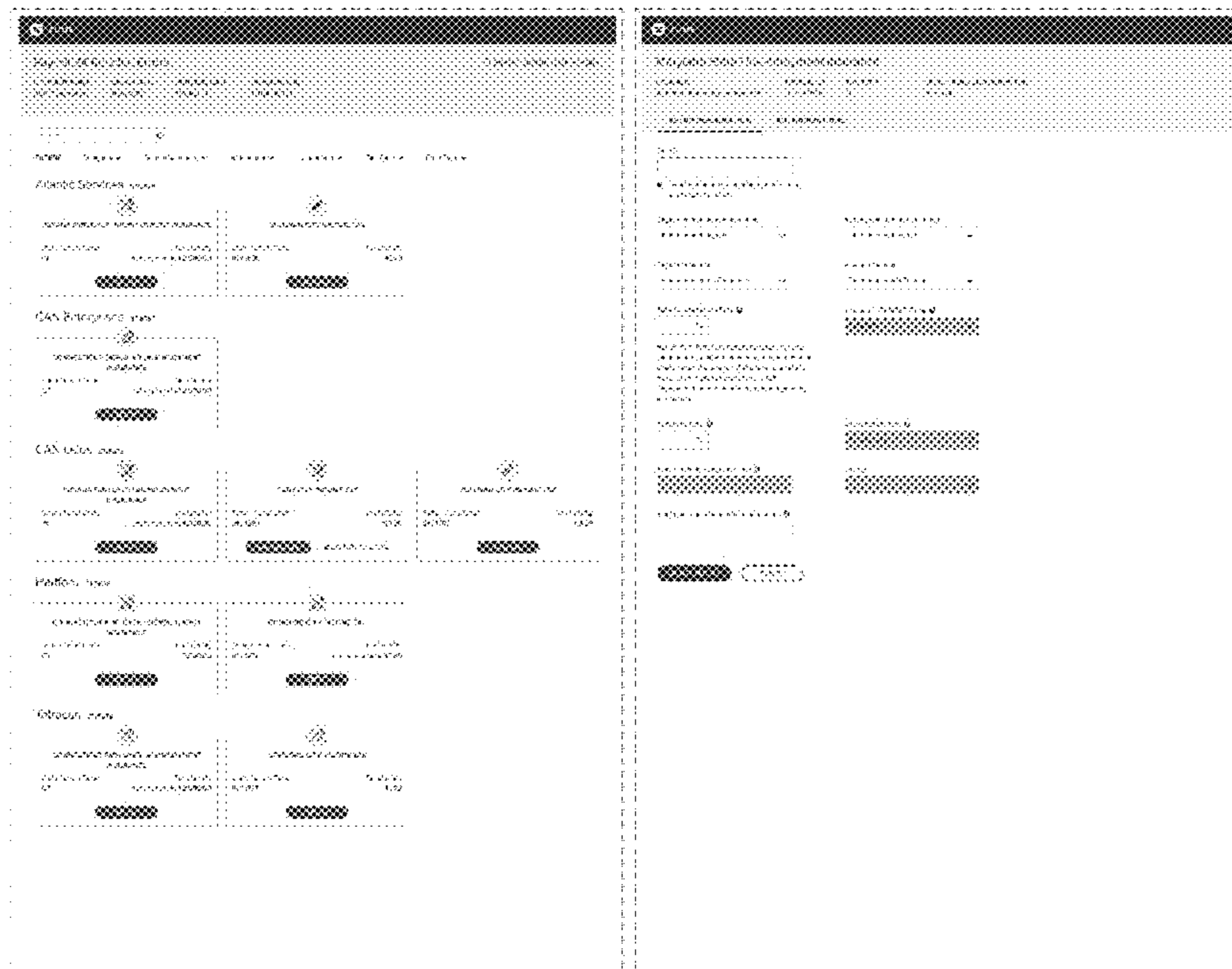
FIG. 1 is a view of a display screen with an animated graphical user interface;
