(57) **CLAIM**

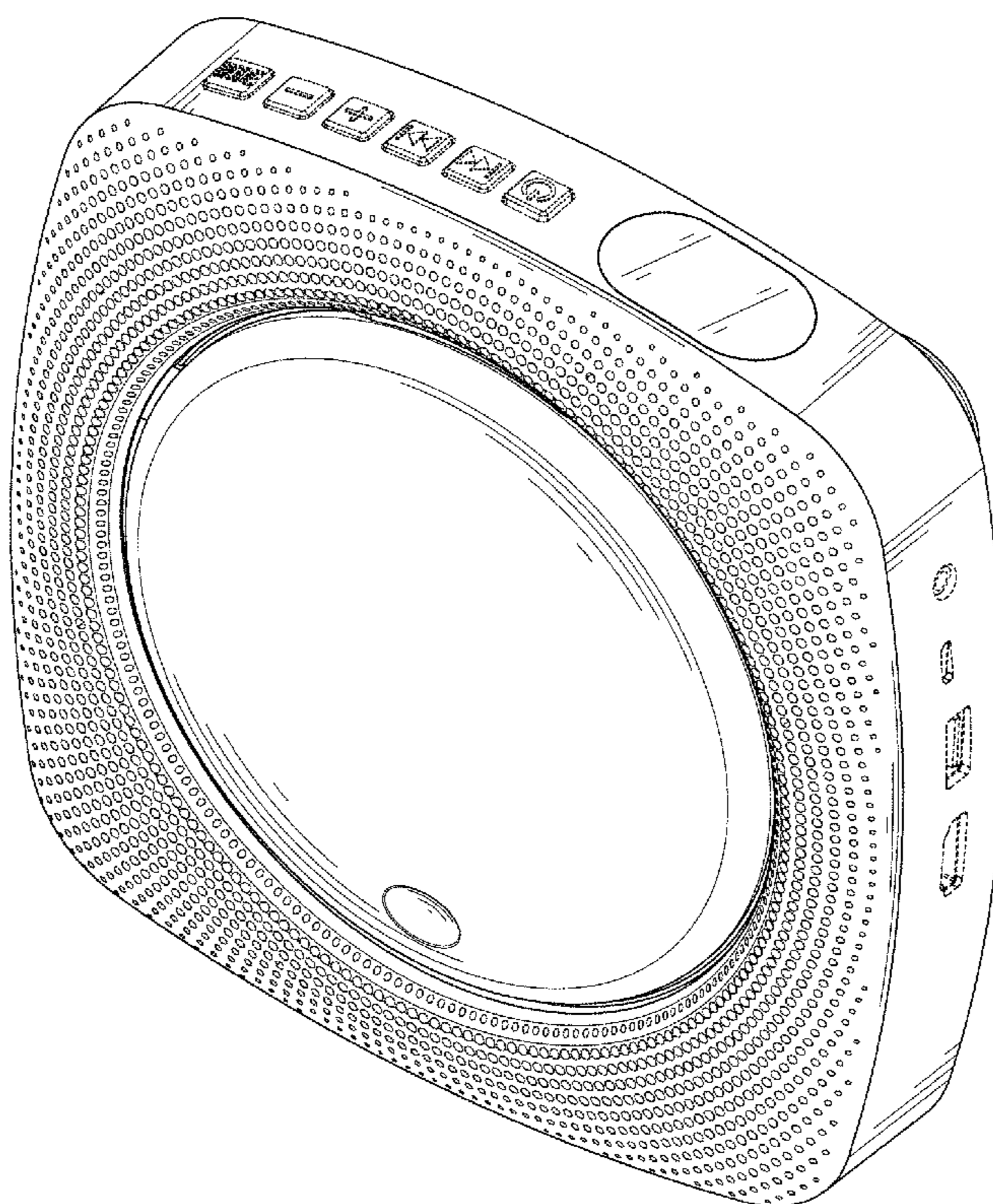
The ornamental design for a CD player, as shown and described.

DESCRIPTION

FIG. 1 is a front, right side, top perspective view of the CD player showing my new design;

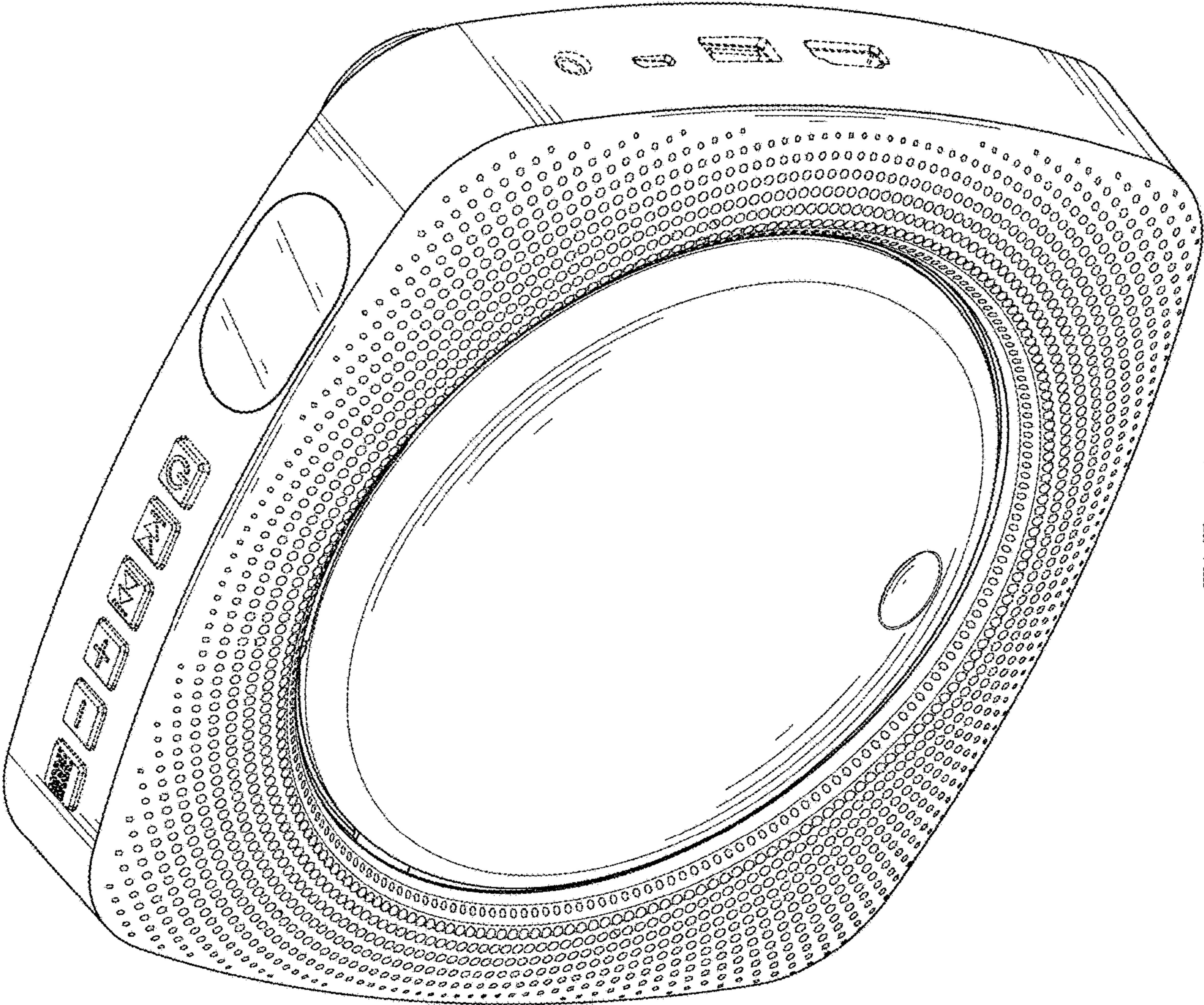

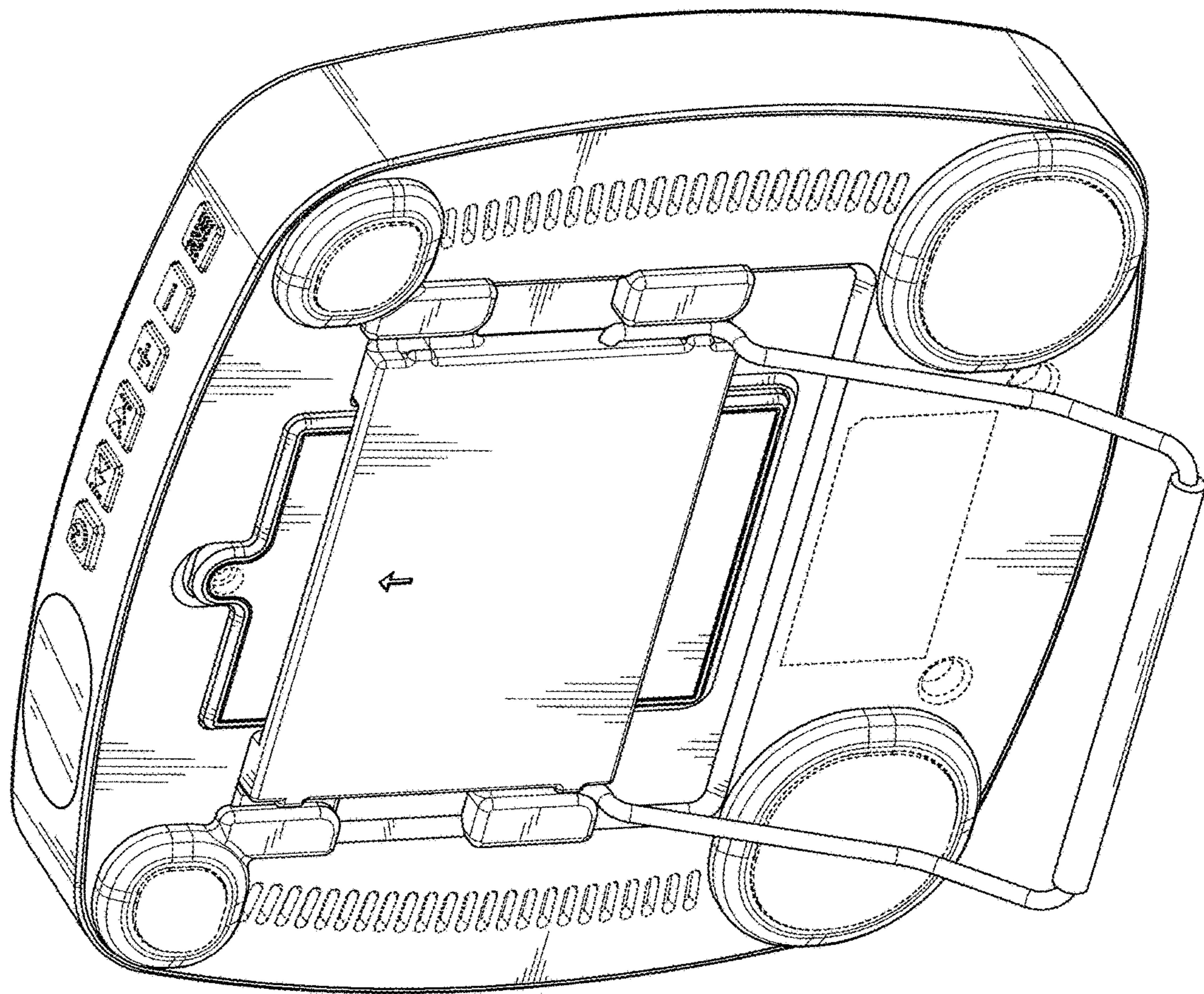

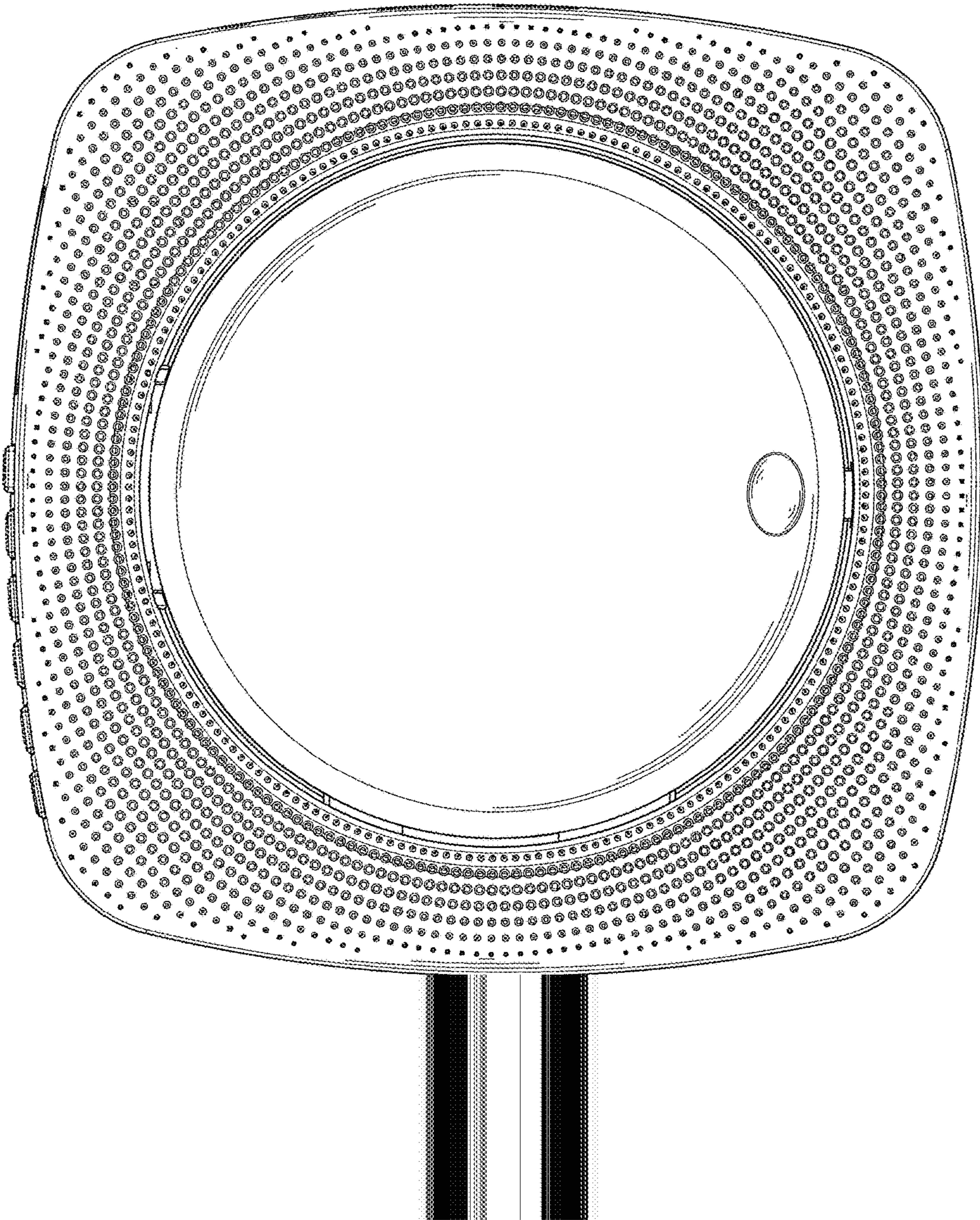

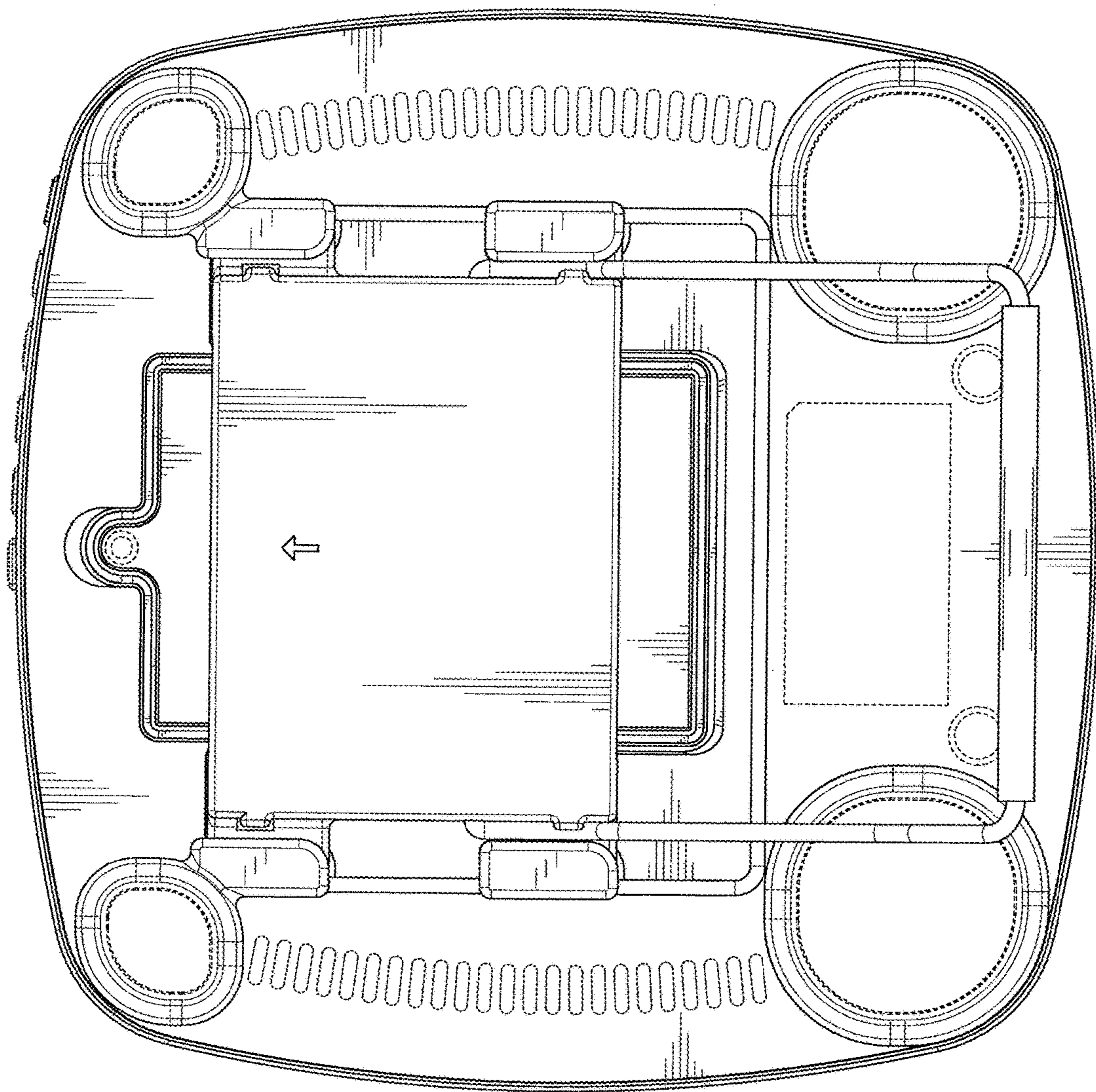

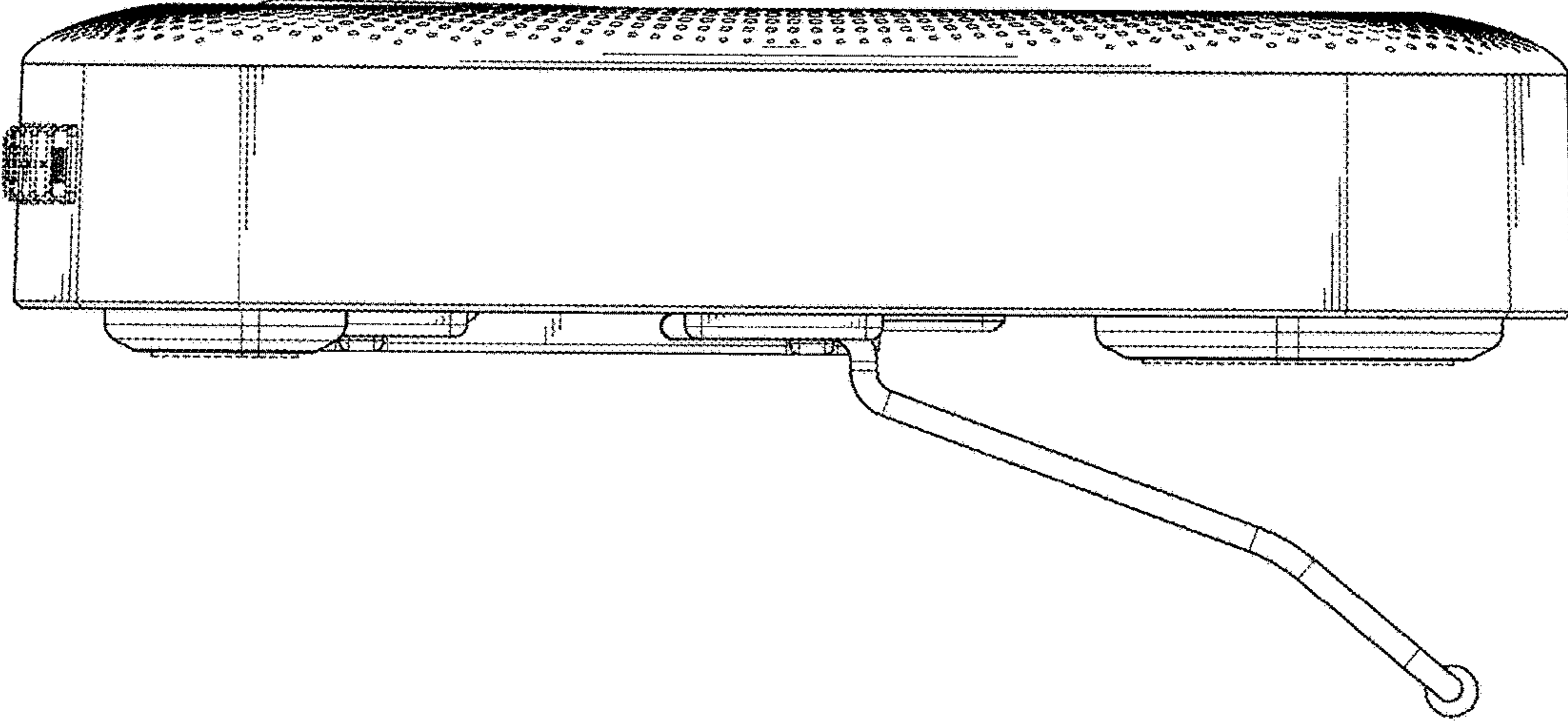

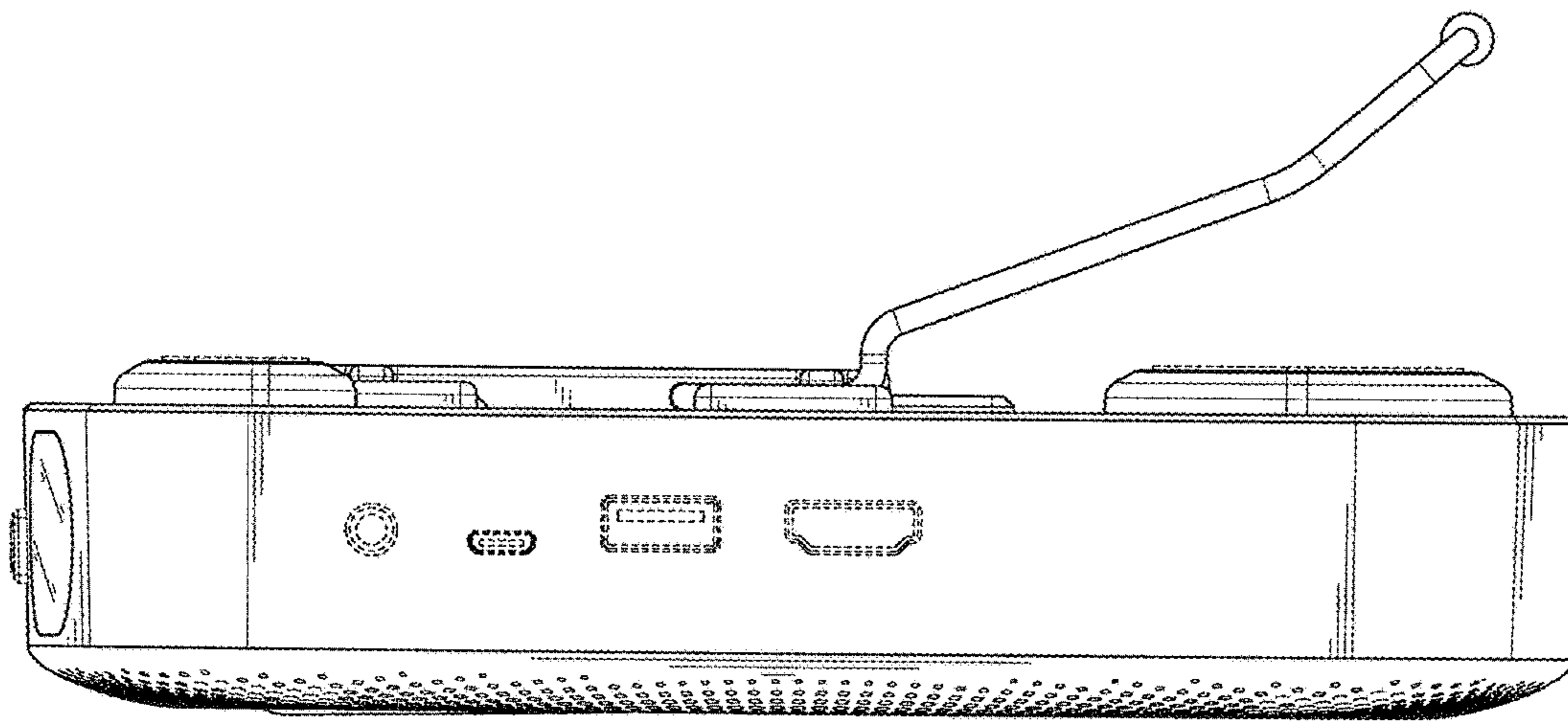

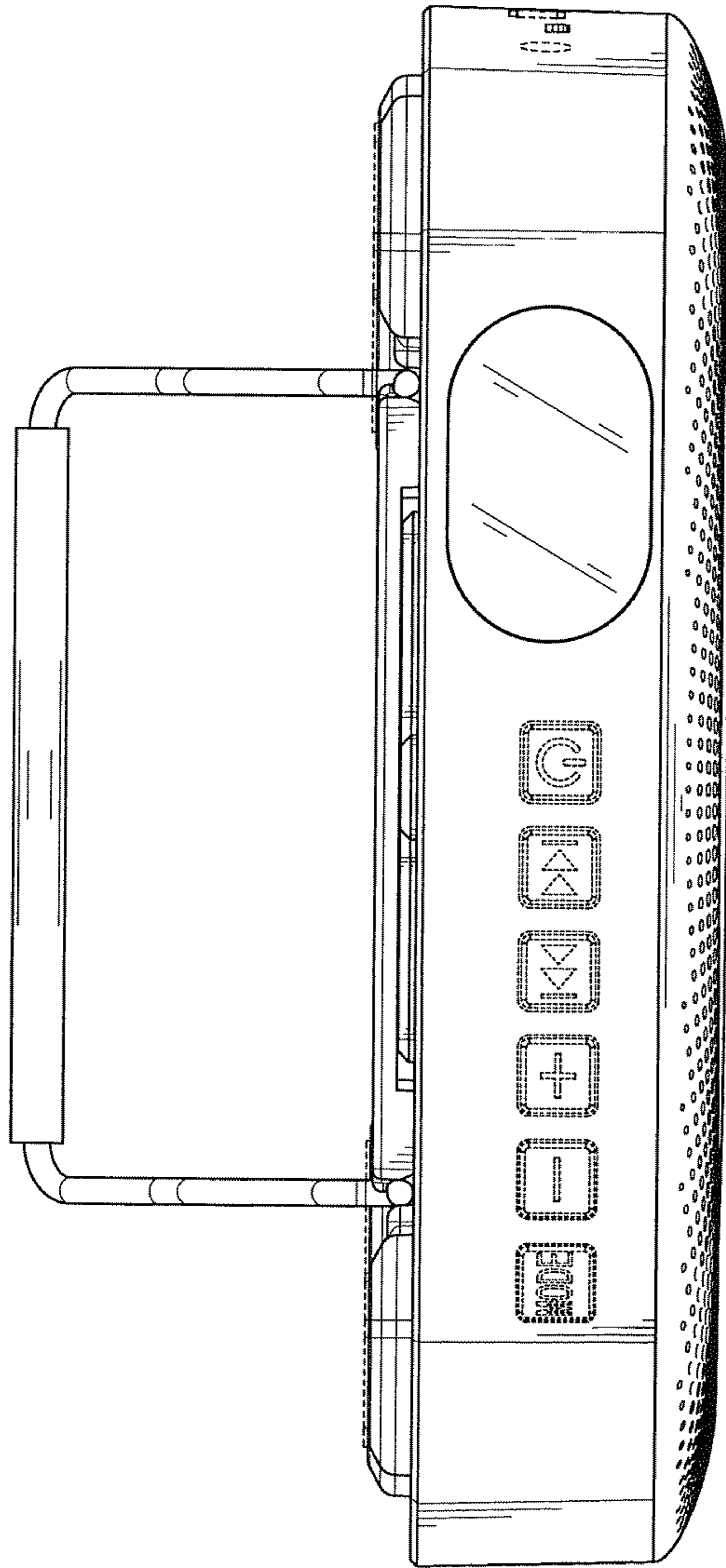

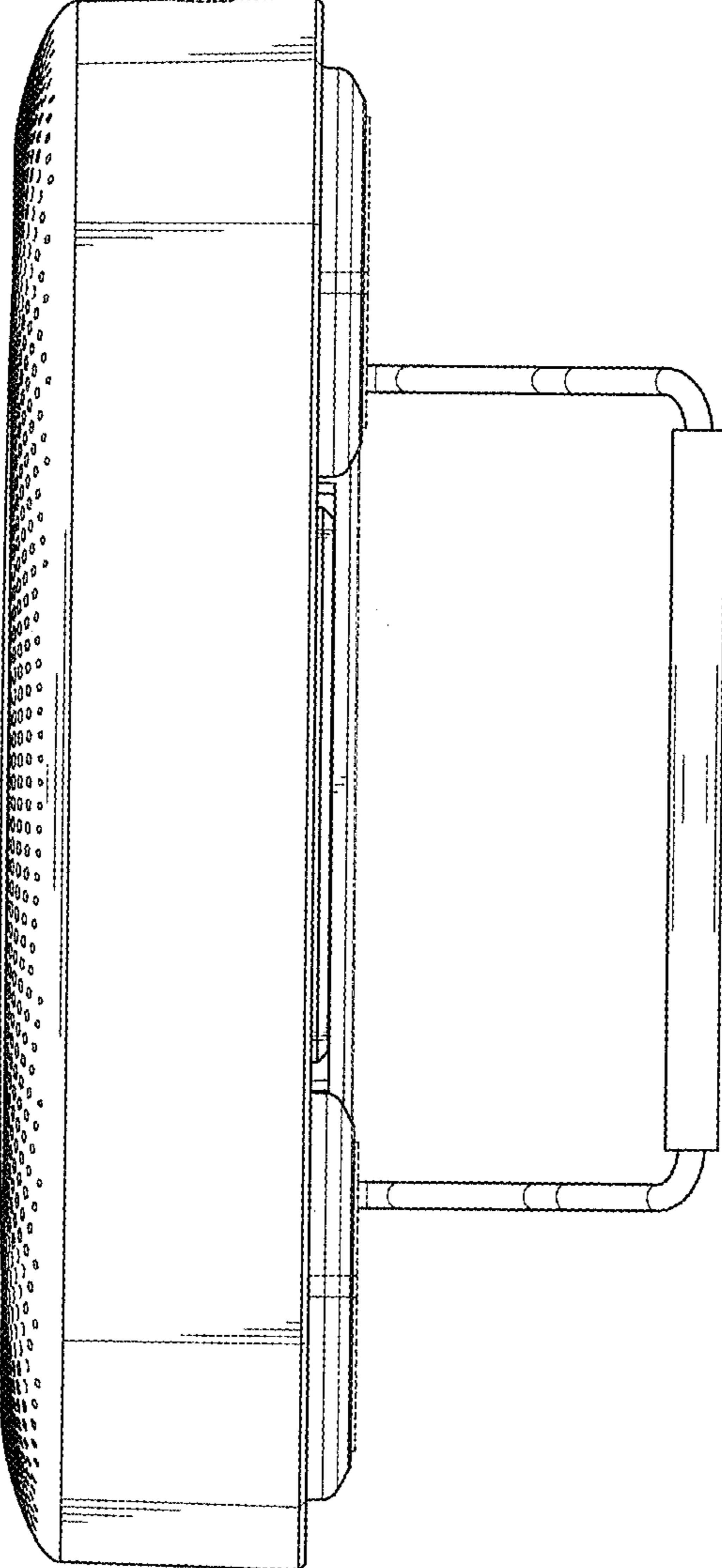
