FIG. 2 is a front elevational view thereof.

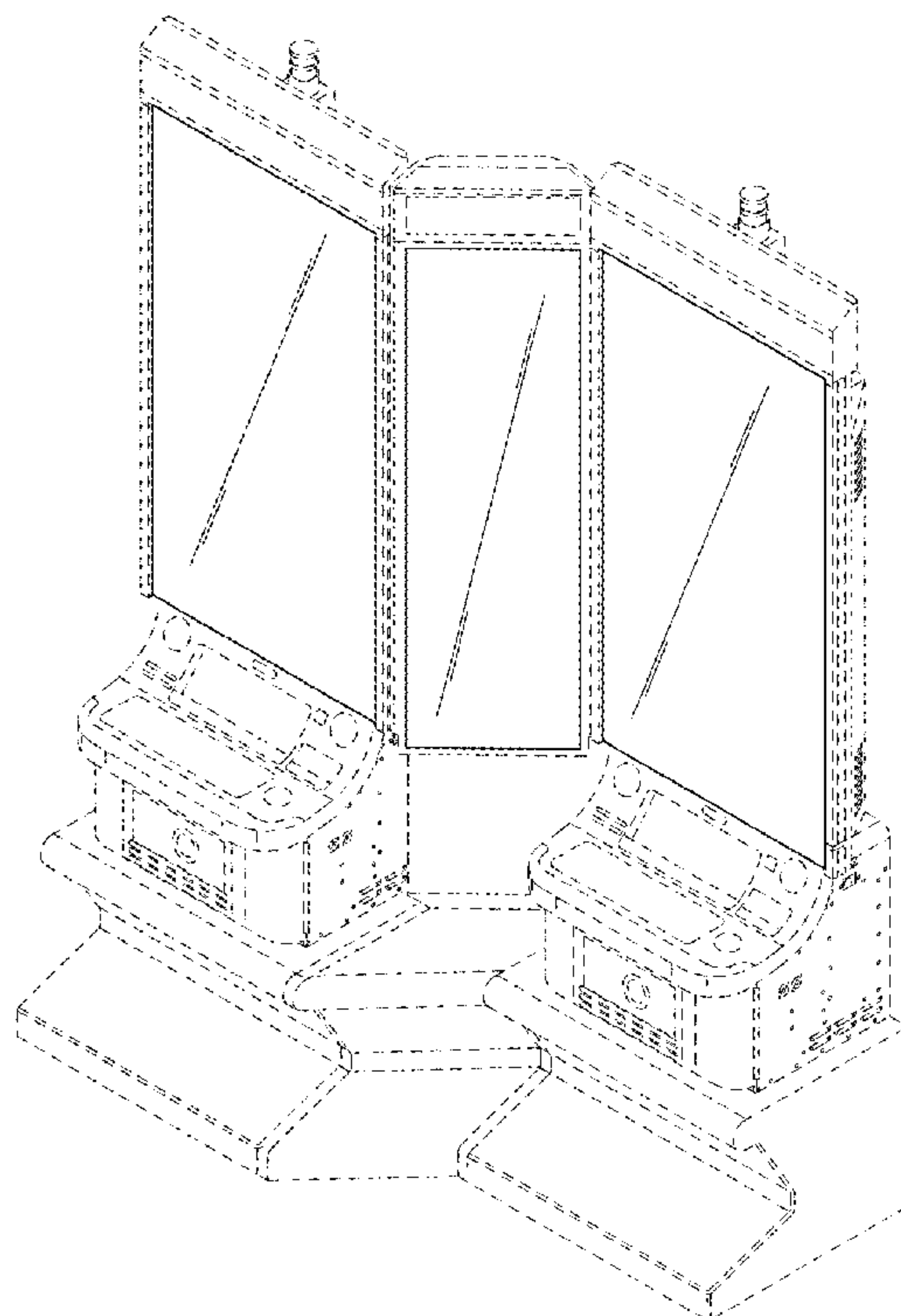
FIG. 3 is a left side elevational view thereof.

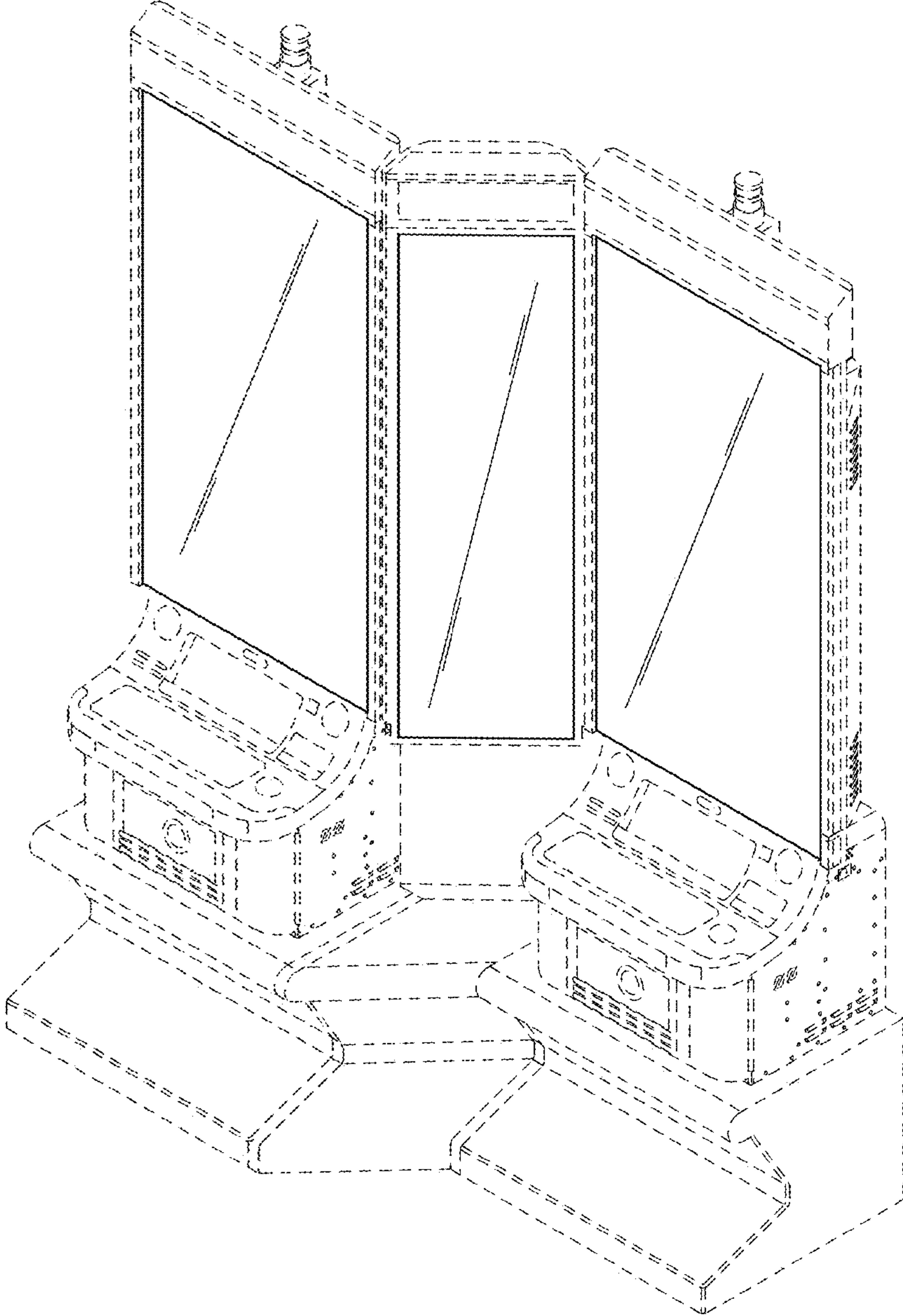

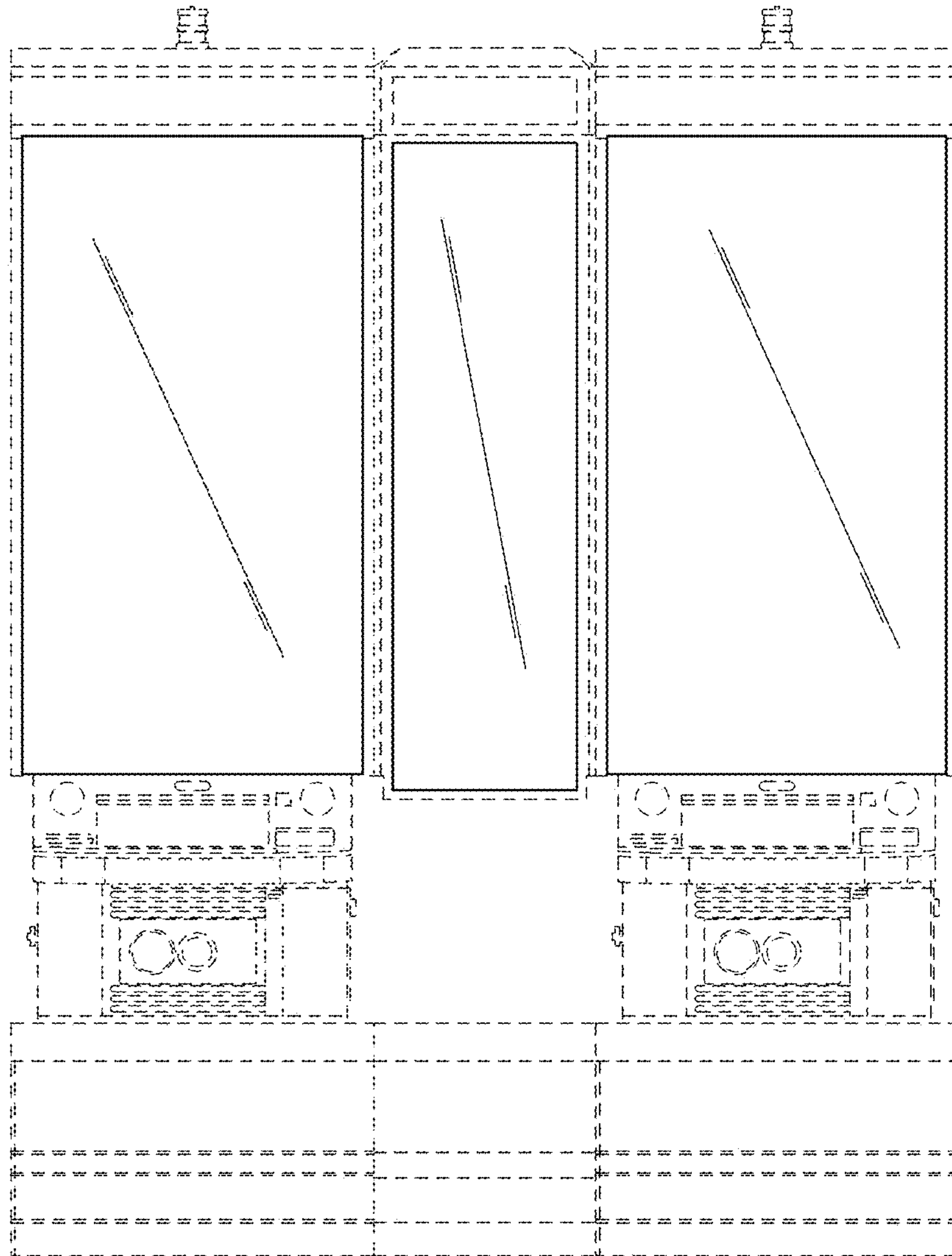

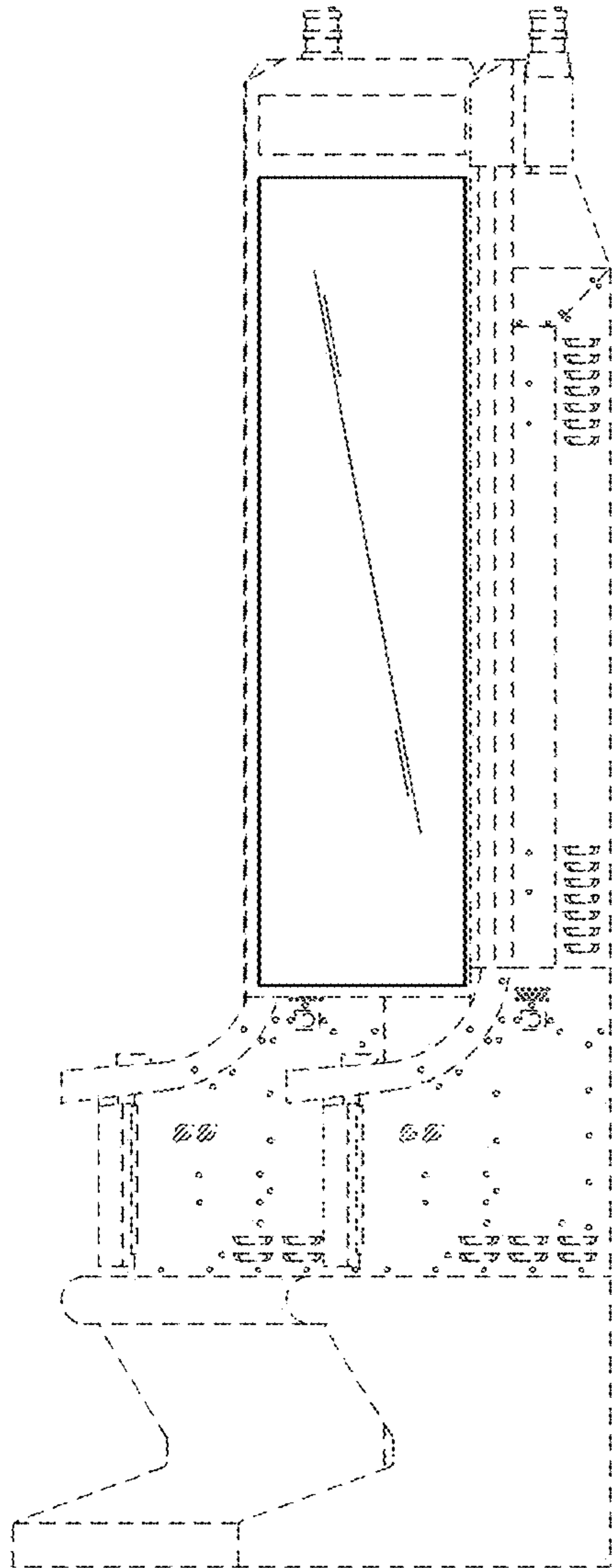

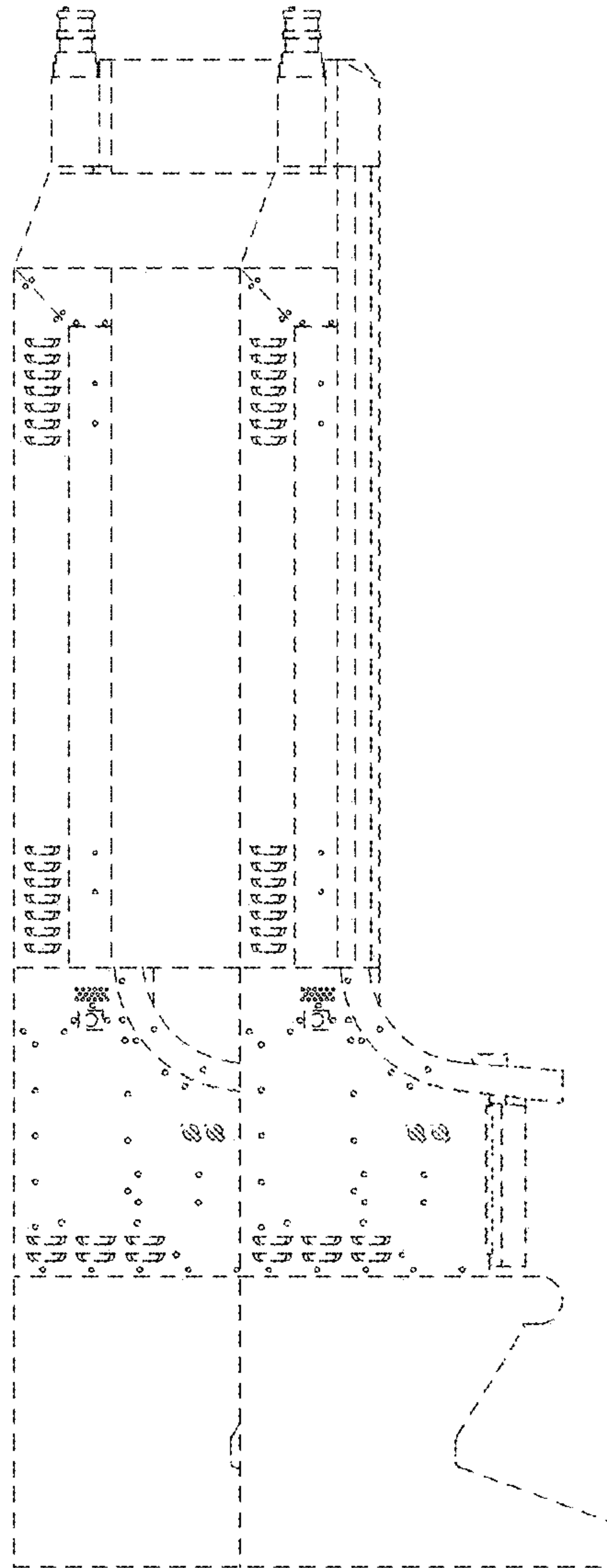

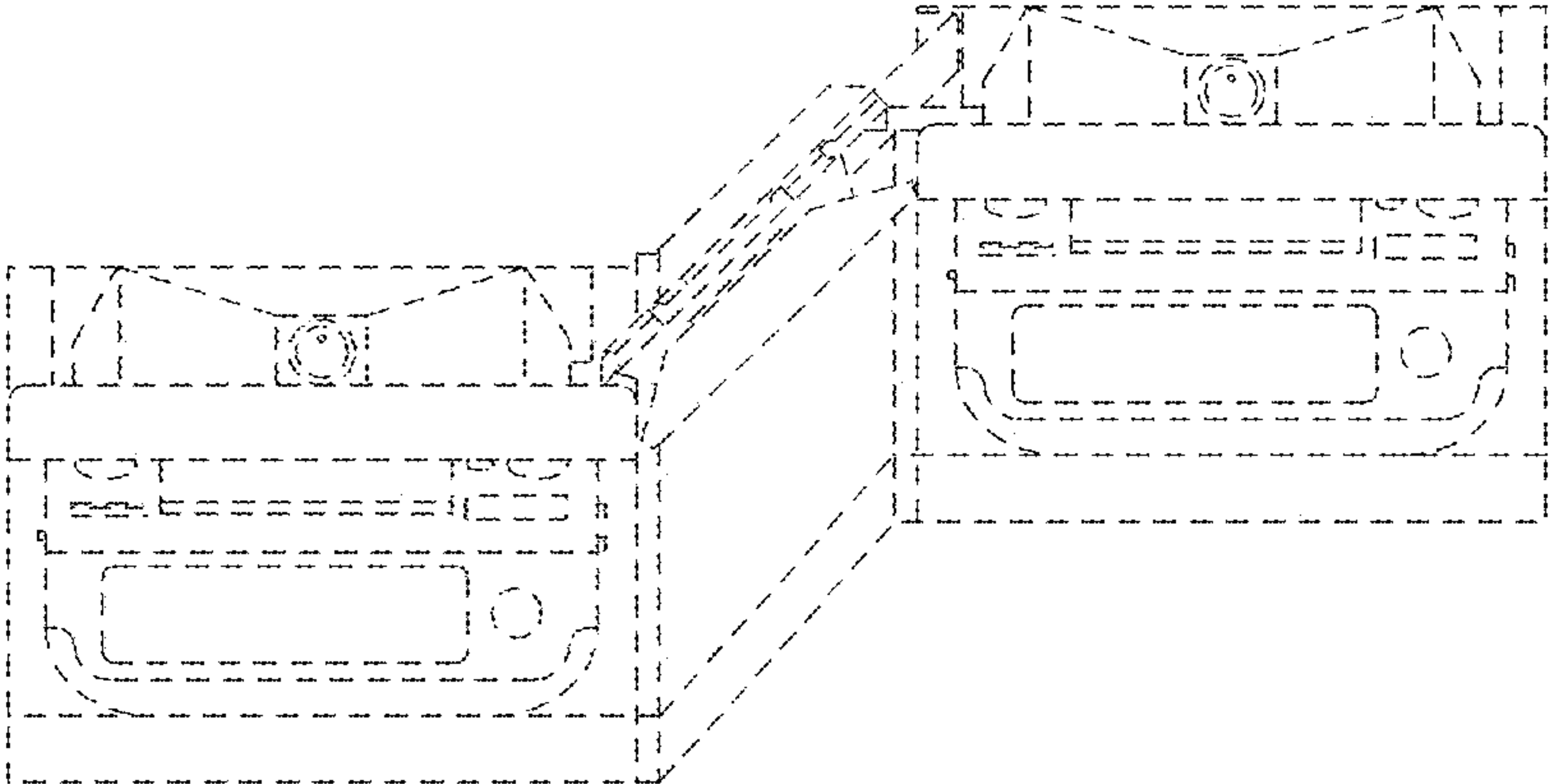
