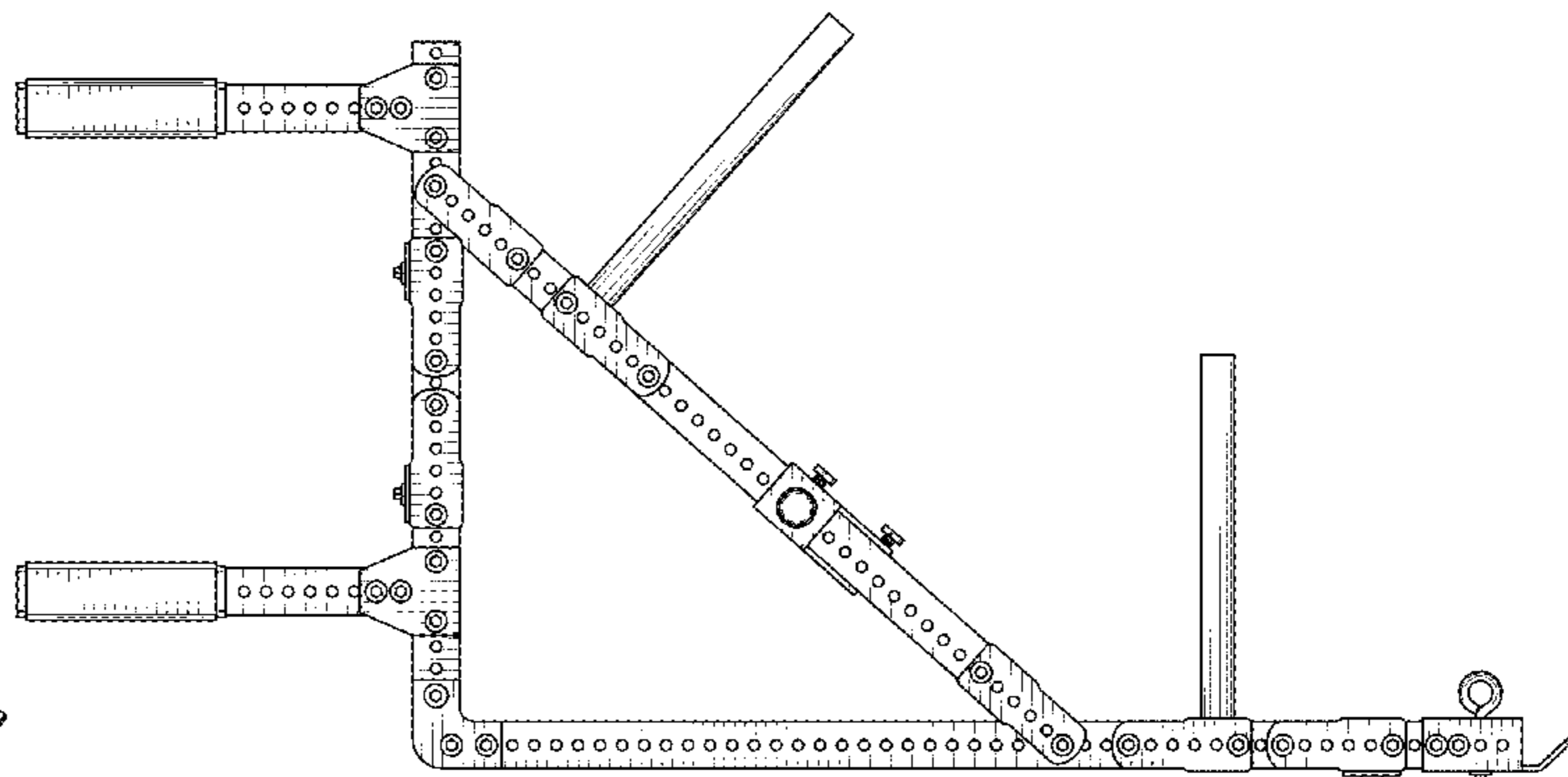
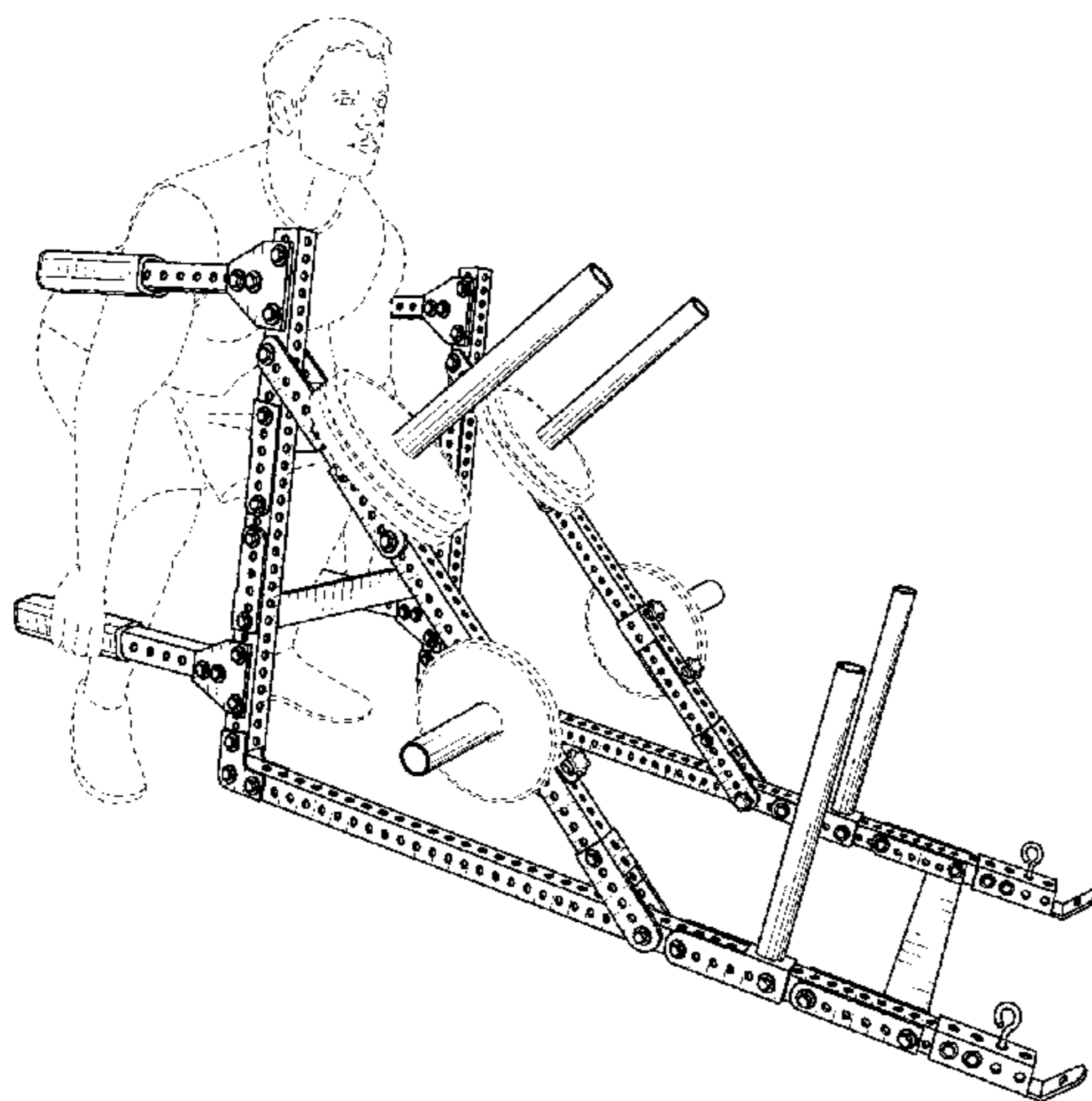
I claim the ornamental design for a strength training power sled, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a strength training power sled, showing a first embodiment of my new design; FIG. 2 is a left-side elevational view of FIG. 1, the right-side elevational view being a mirror image thereof; FIG. 3 is a rear elevational view of FIG. 1; FIG. 4 is a front elevational view of FIG. 1; FIG. 5 is a top plan view of FIG. 1; FIG. 6 is a bottom plan view of FIG. 1; FIG. 7 is a perspective view of a second embodiment thereof; FIG. 8 is a left-side elevational view of FIG. 8, the right-side elevational view being a mirror image thereof; FIG. 9 is a rear elevational view of FIG. 8; FIG. 10 is a front elevational view of FIG. 8; FIG. 11 is a top plan view of FIG. 8; and, FIG. 12 is a bottom plan view of FIG. 8.

The broken lines in FIGS. 2, 3, 5, 8, 9, and 11 showing the strength training power sled illustrate the portions of the strength training power sled that form no part of the claimed design.

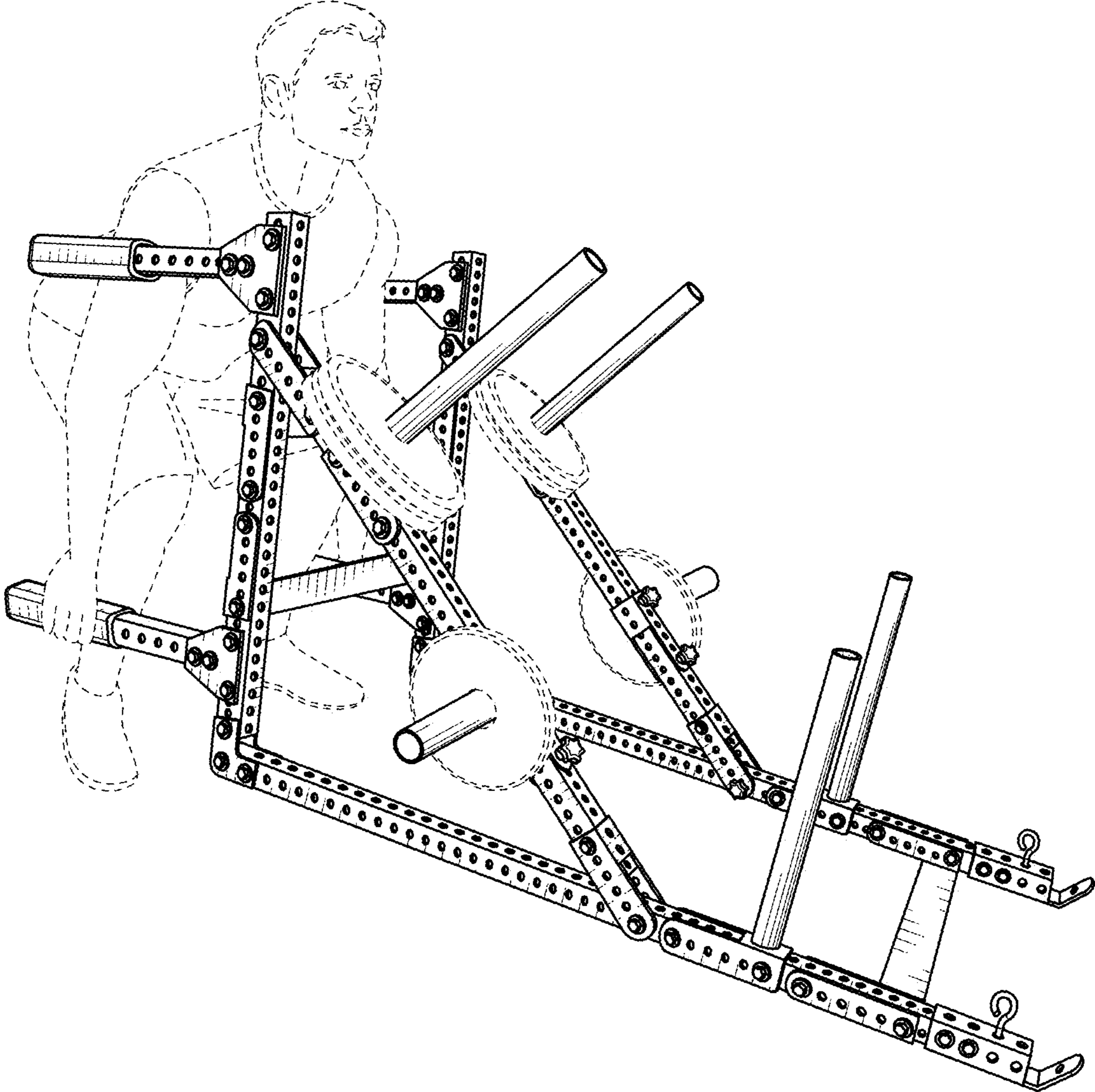

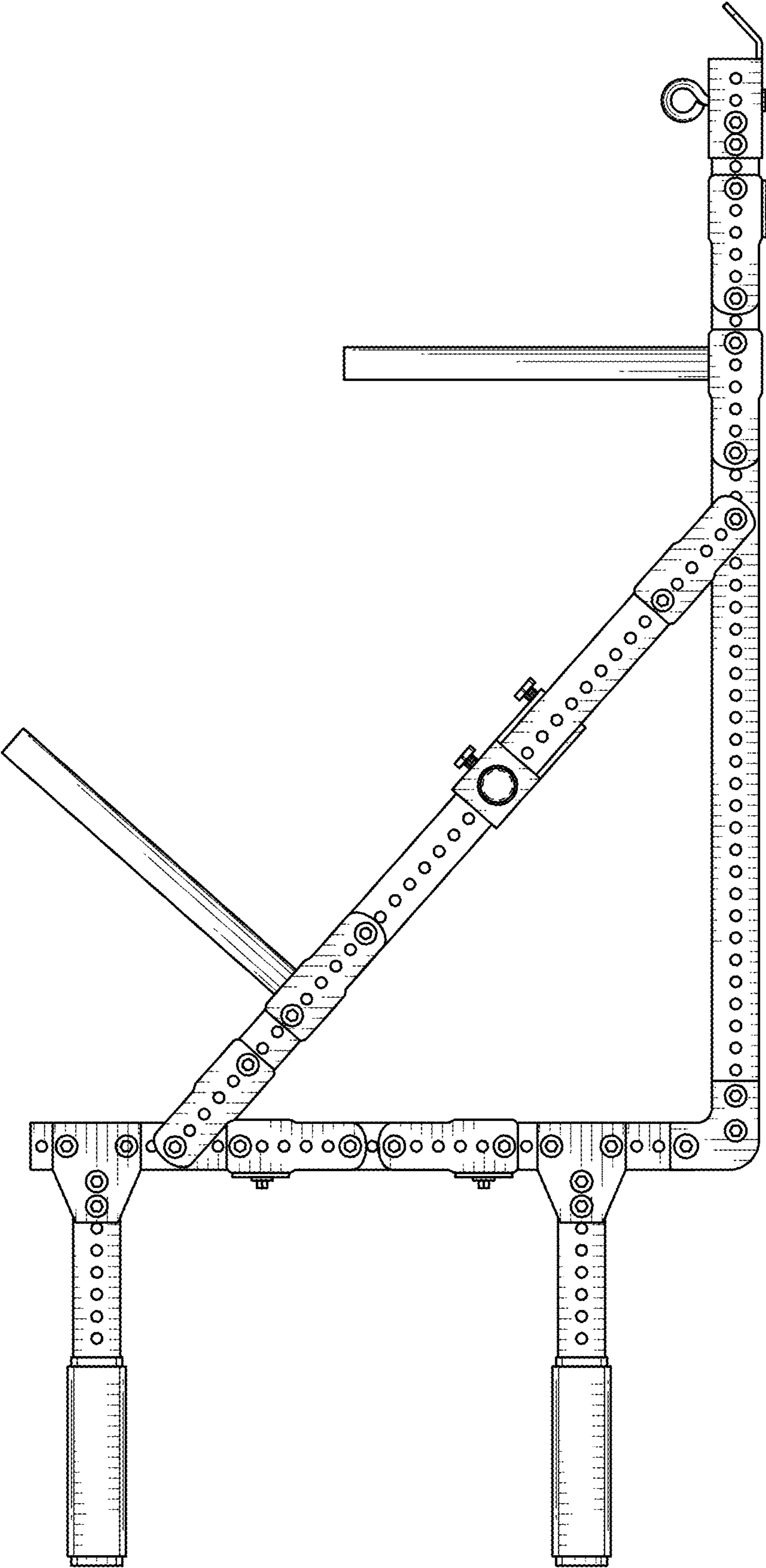

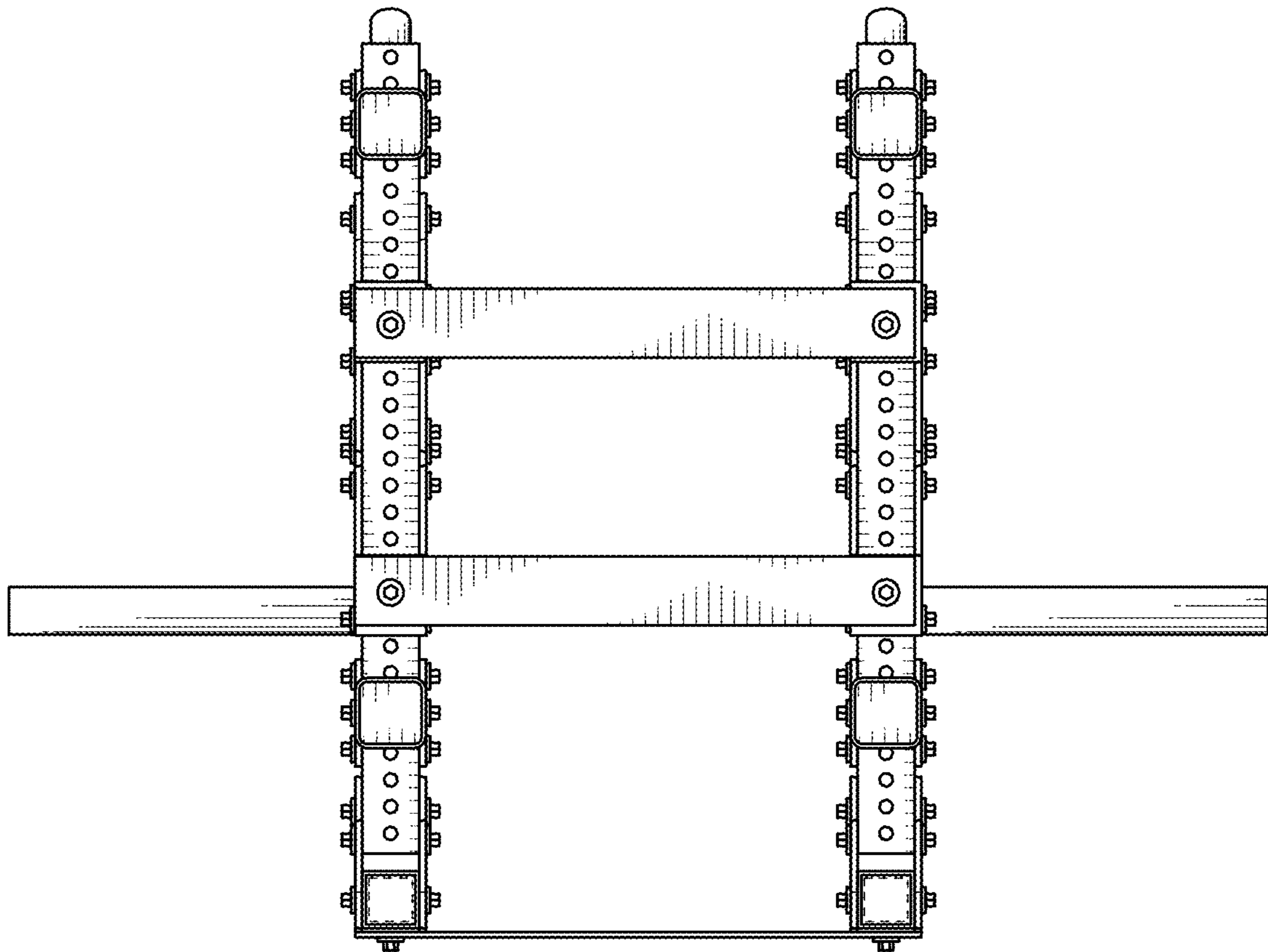

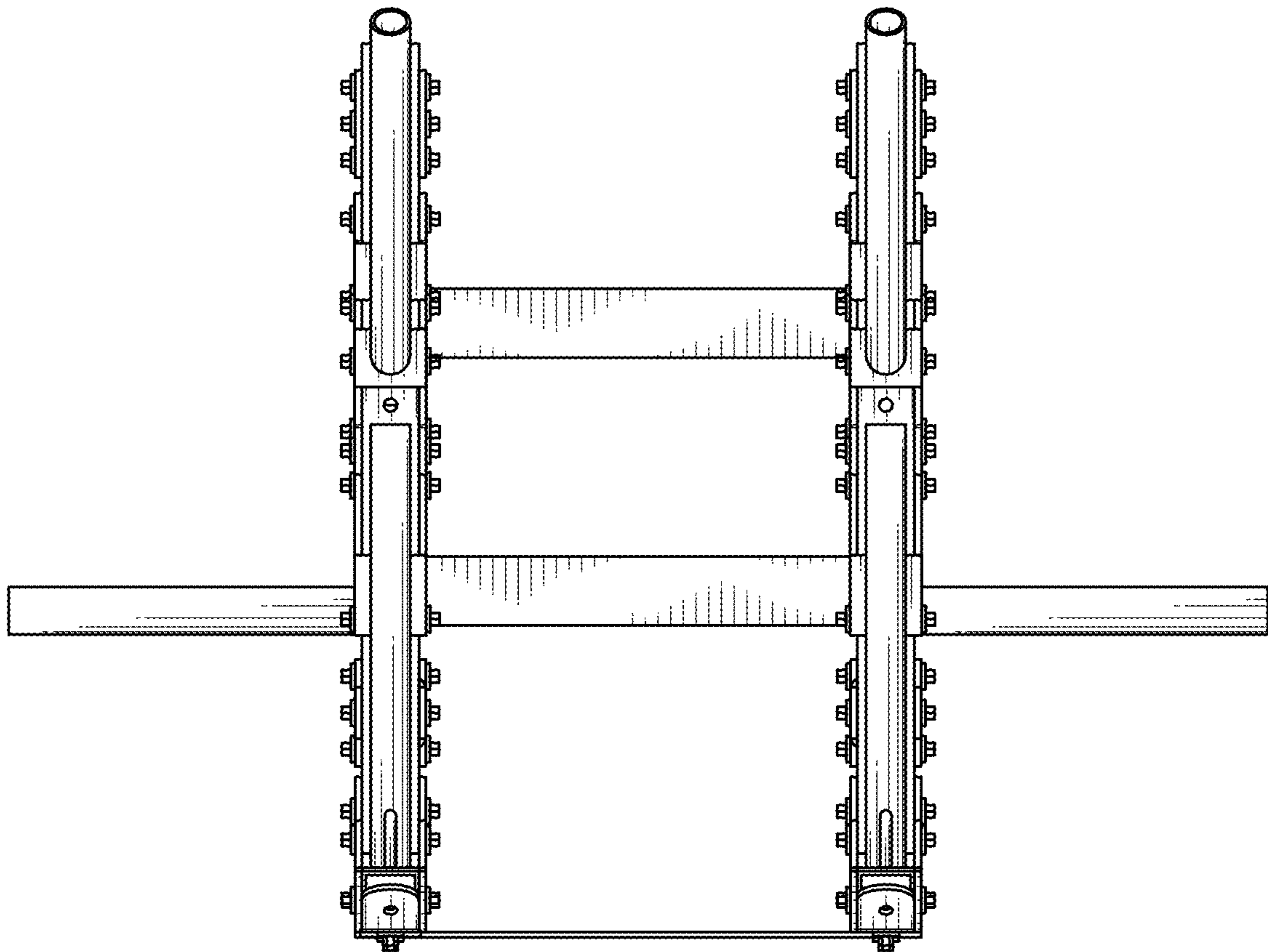

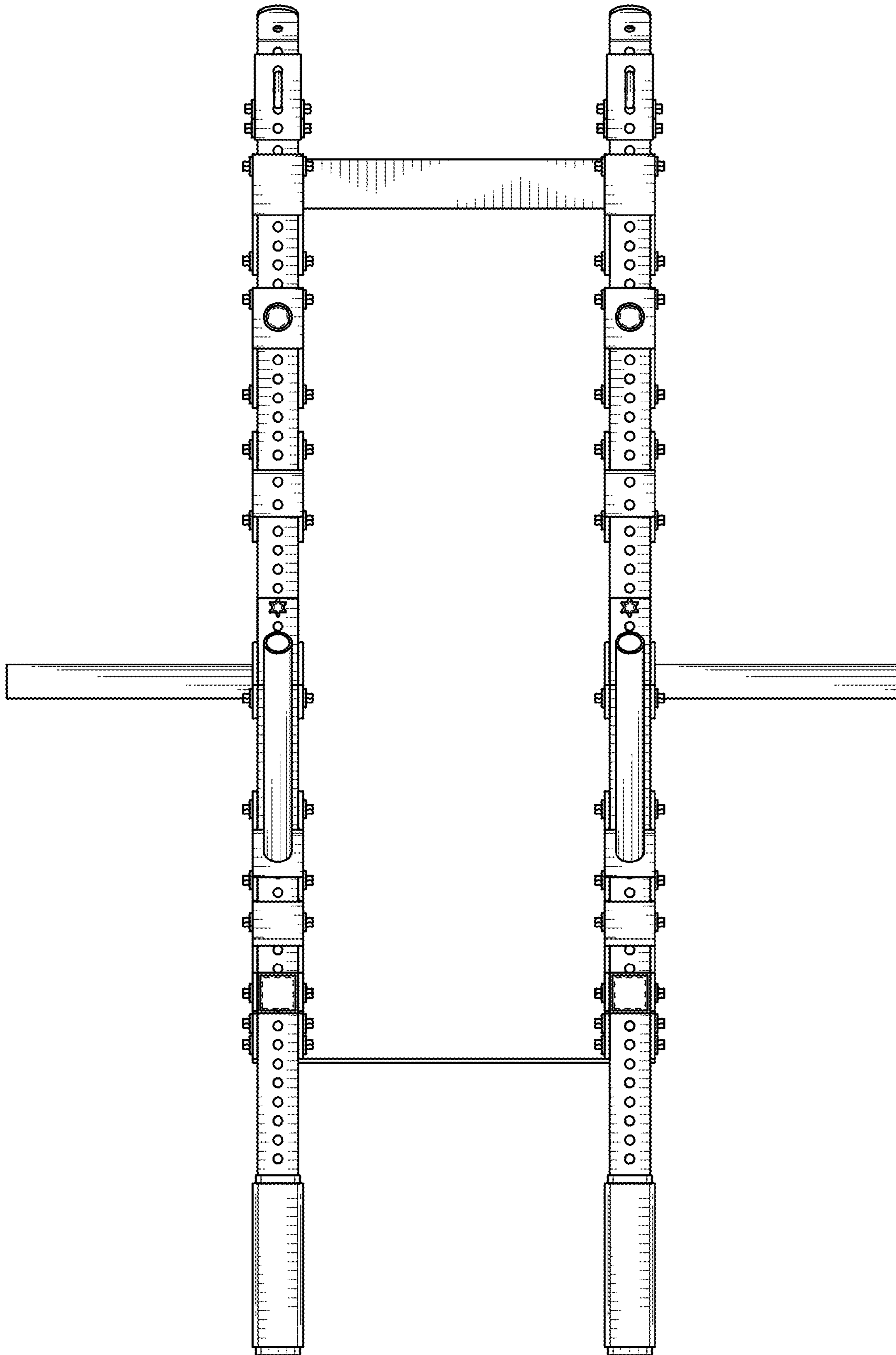

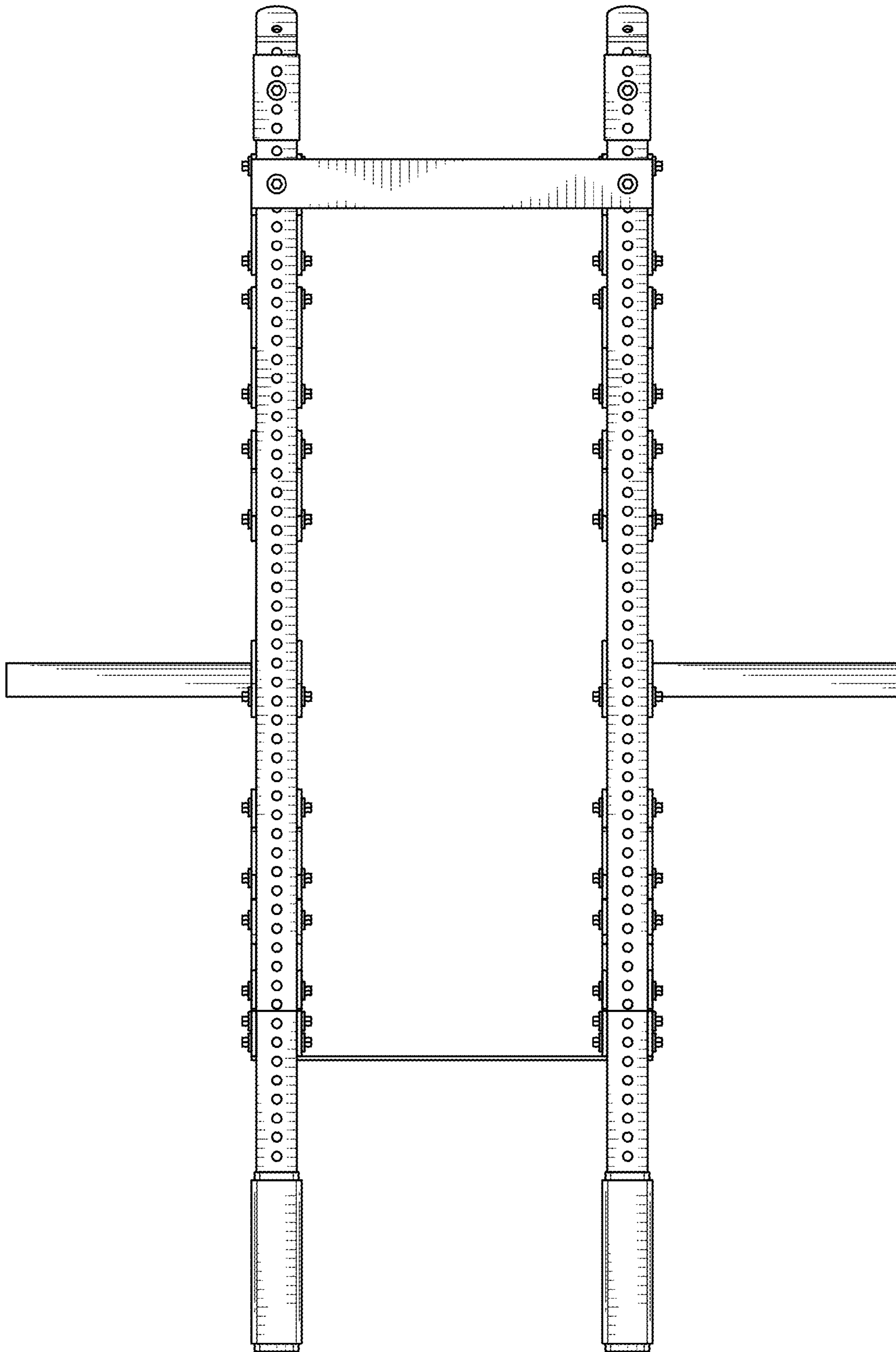

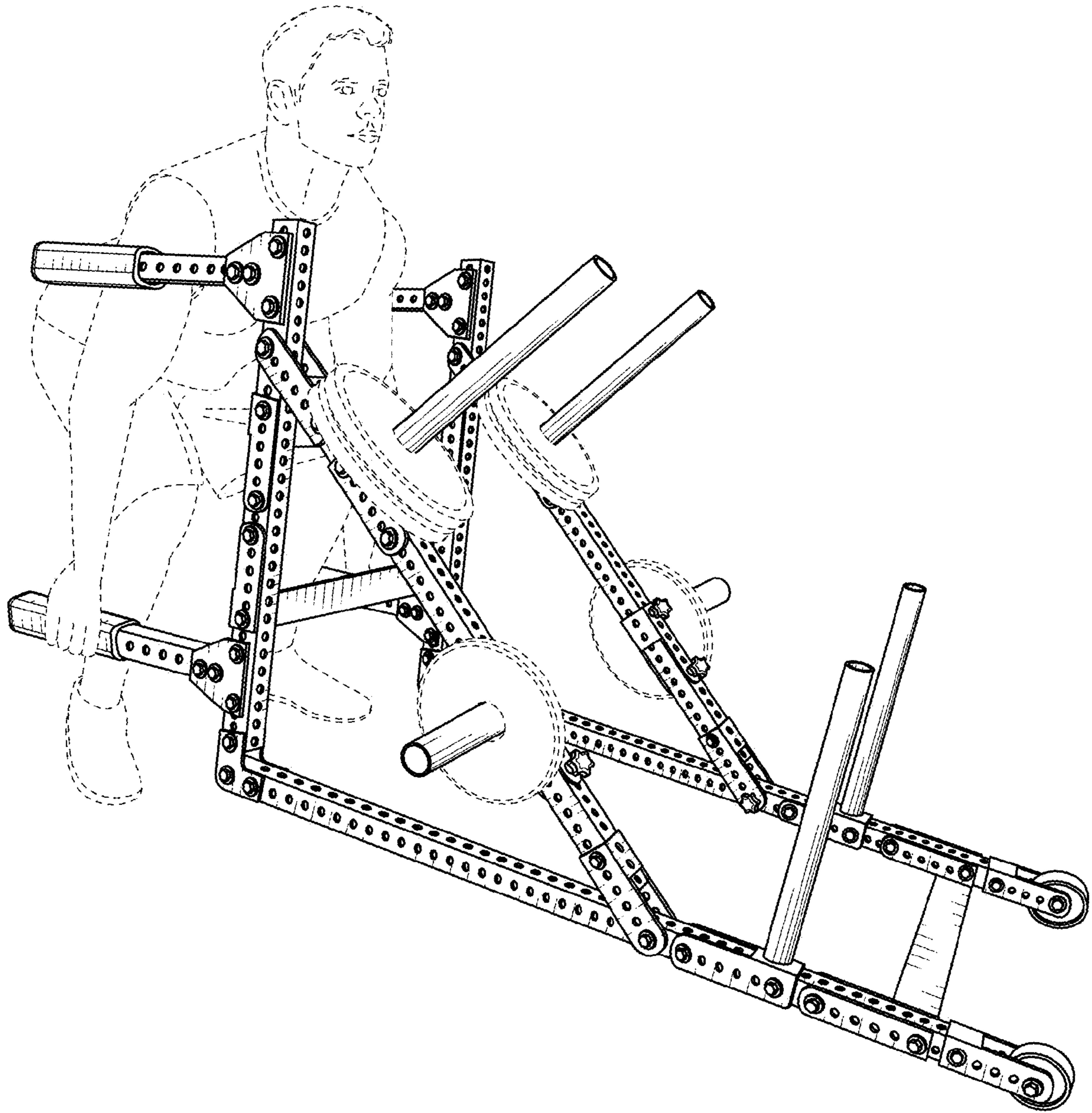

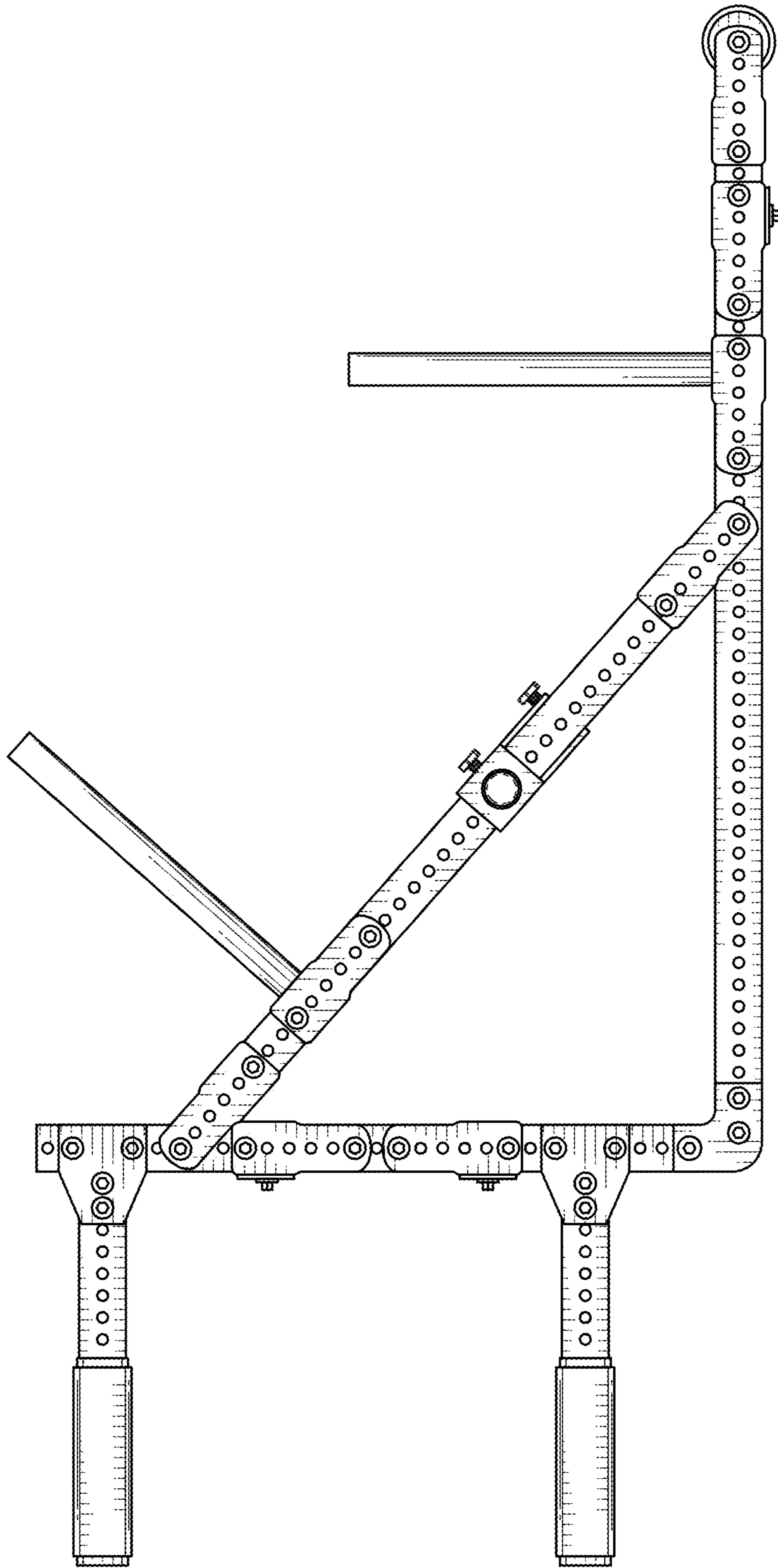

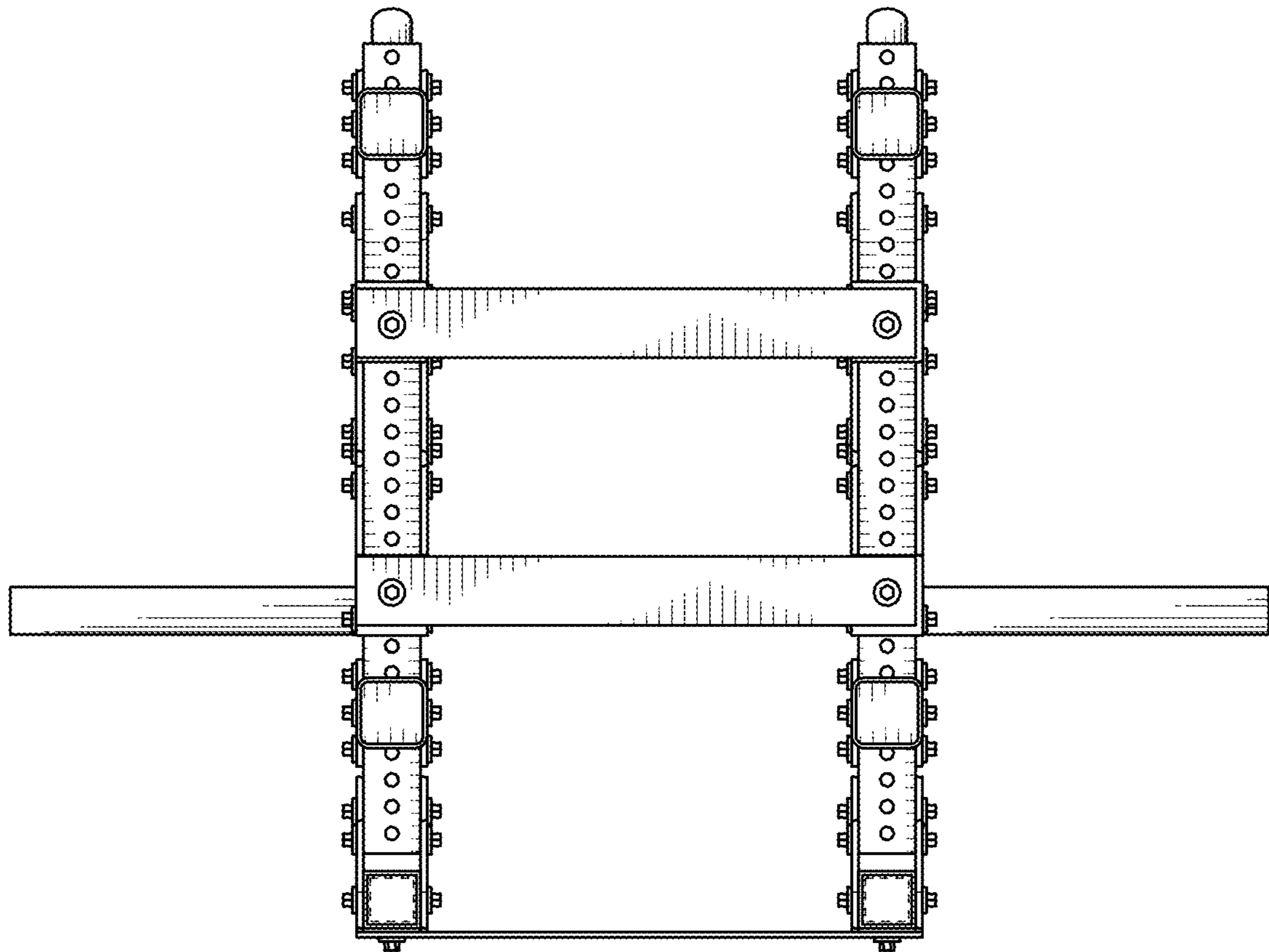

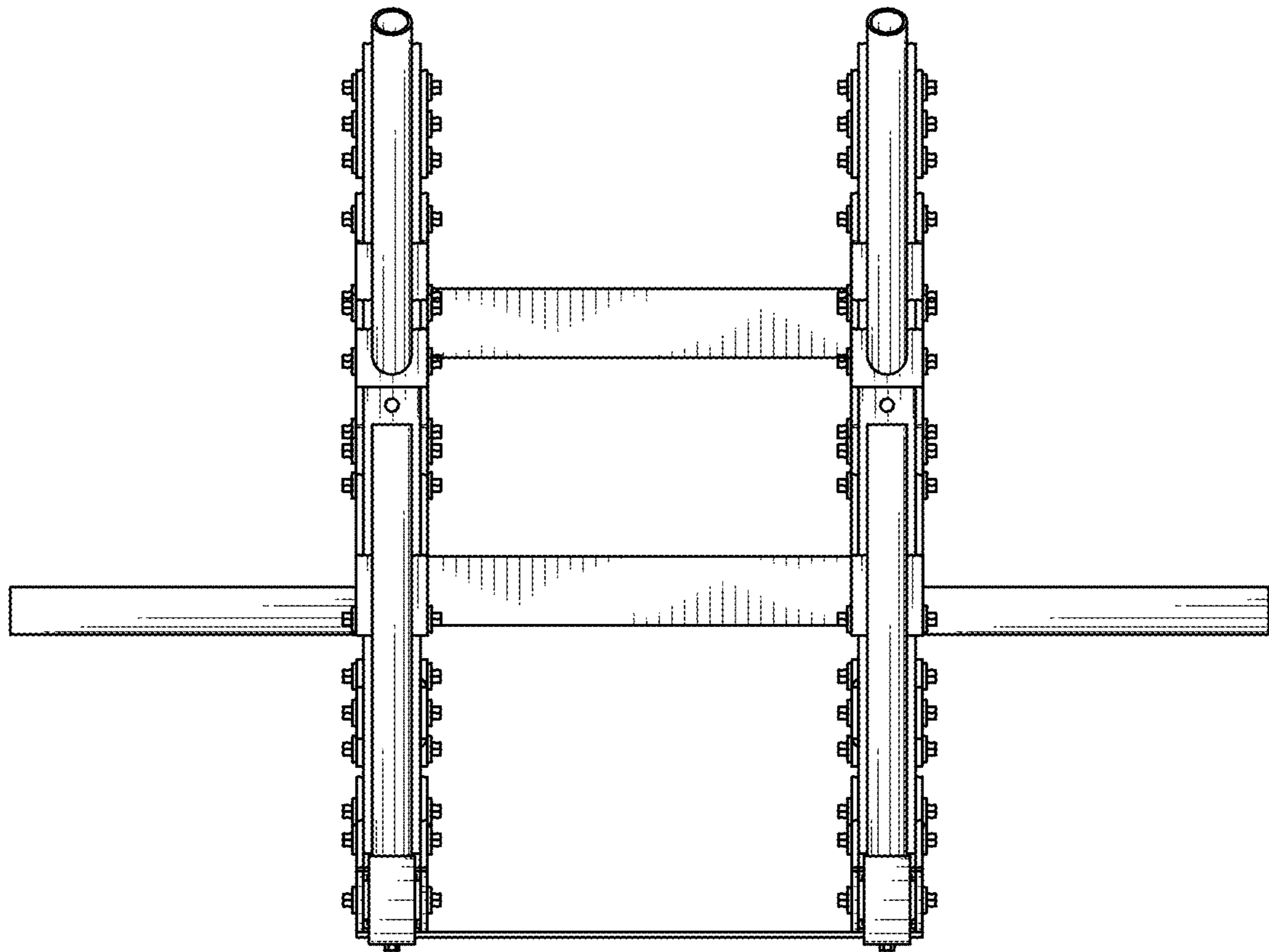

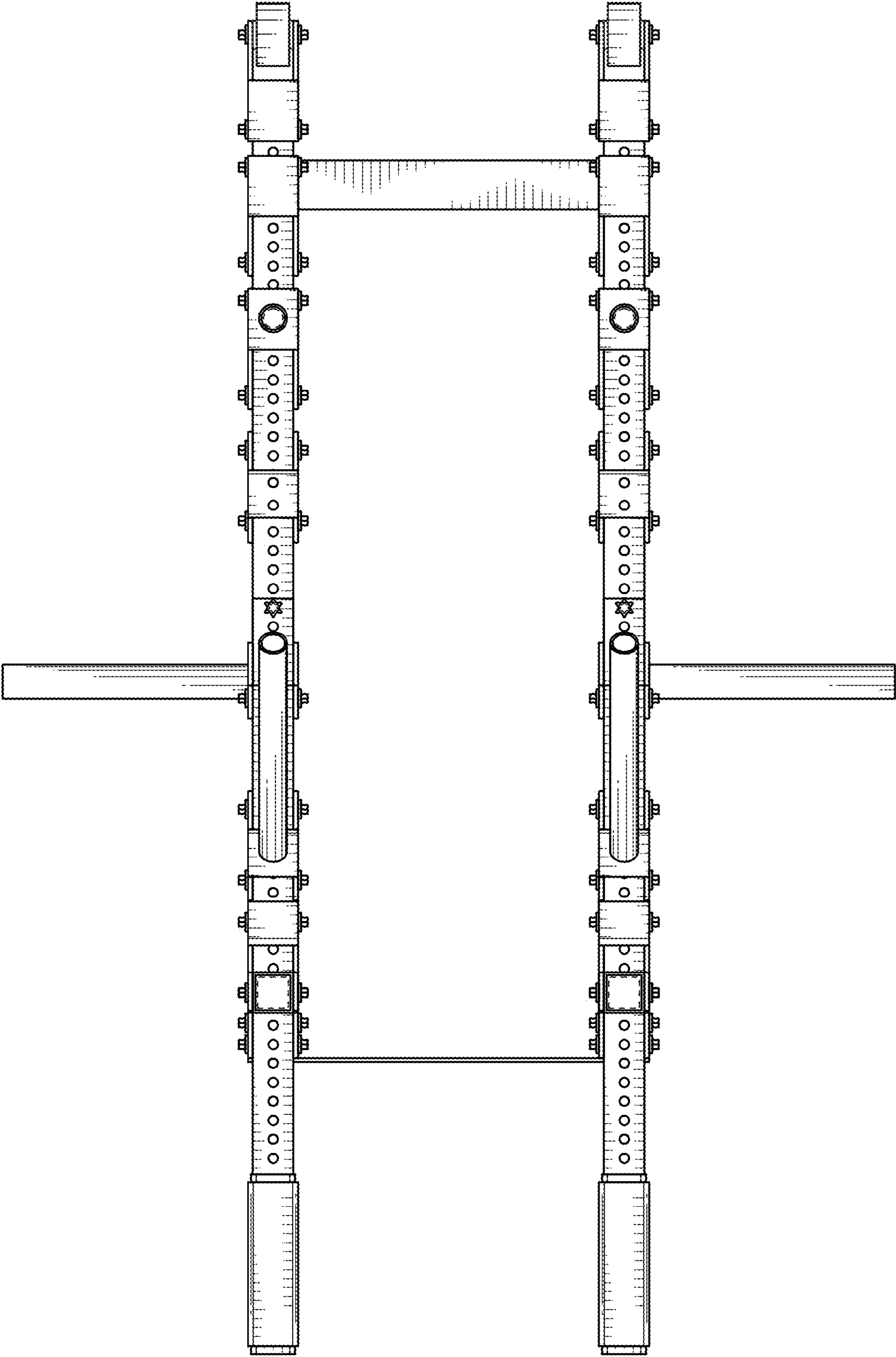

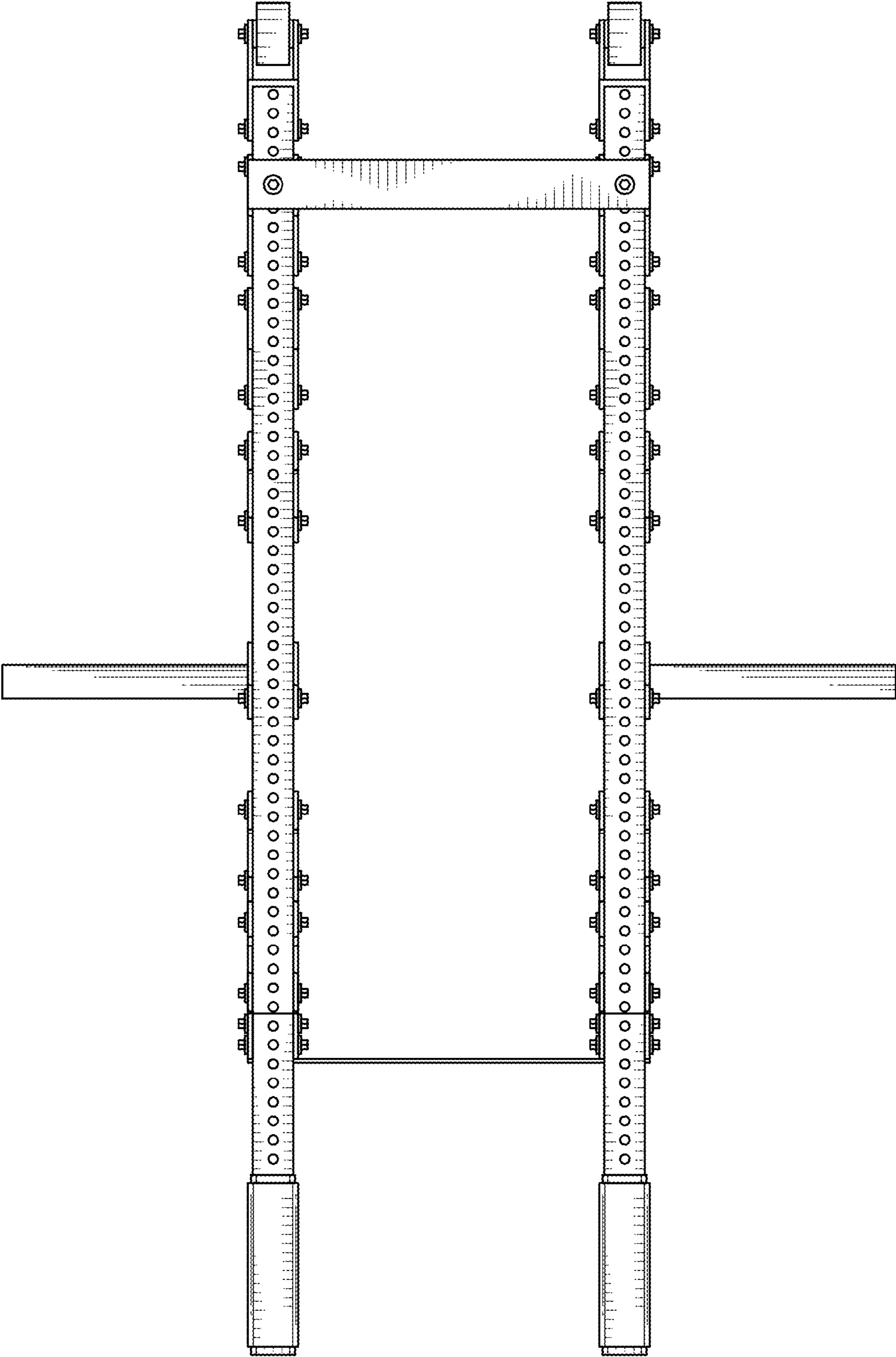
