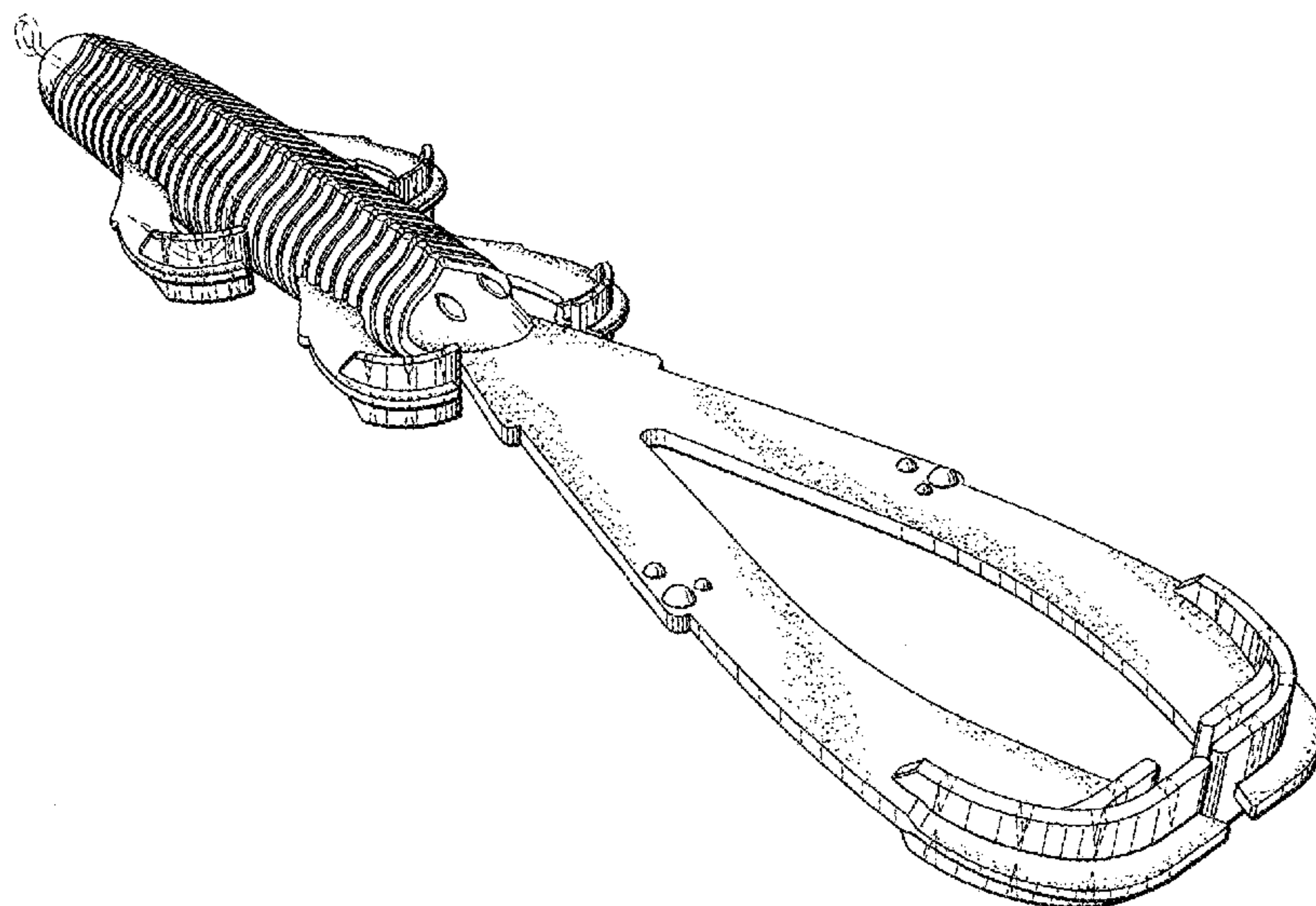
(57) **CLAIM**

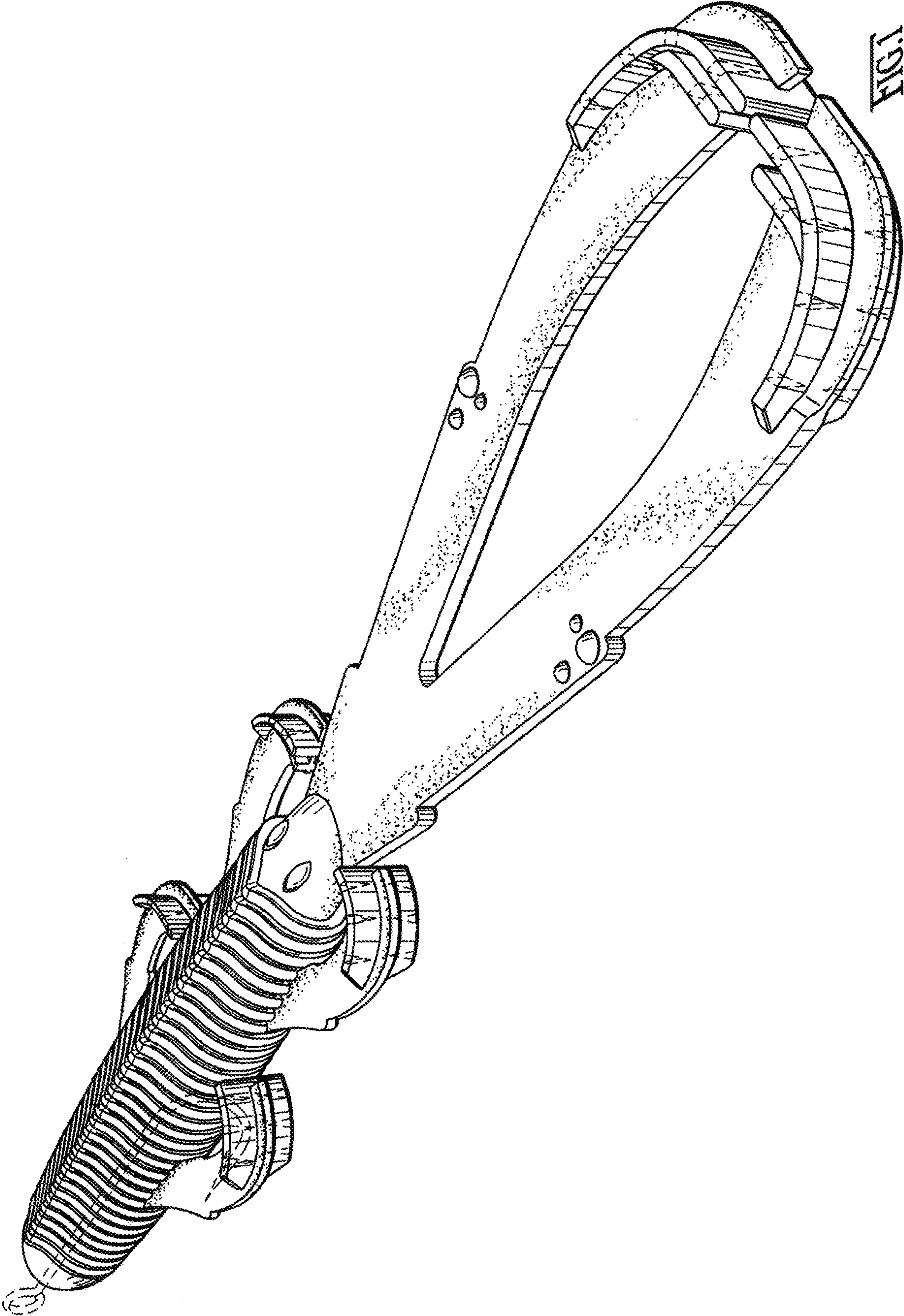
The ornamental design for a longpincer artificial crayfish plastic bait, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a longpincer artificial crayfish plastic bait showing my new design; FIG. 2 is a top plan view thereof; FIG. 3 is a right side elevational view thereof, the opposite side being a mirror image; FIG. 4 is a rear elevational view thereof; FIG. 5 is a front elevational view thereof; and, FIG. 6 is a bottom plan view thereof. The broken lines in the drawing represent environmental subject matter that forms no part of the claimed design.

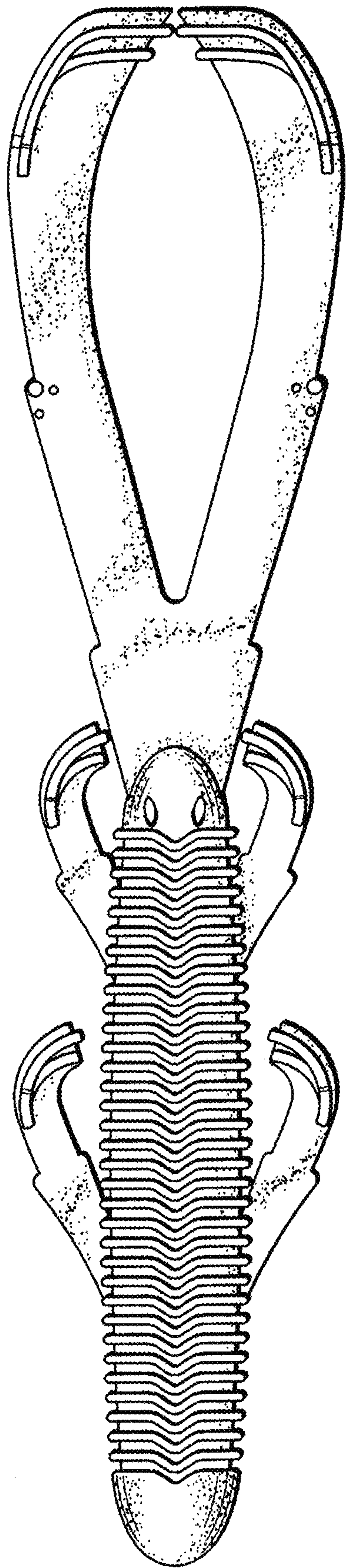
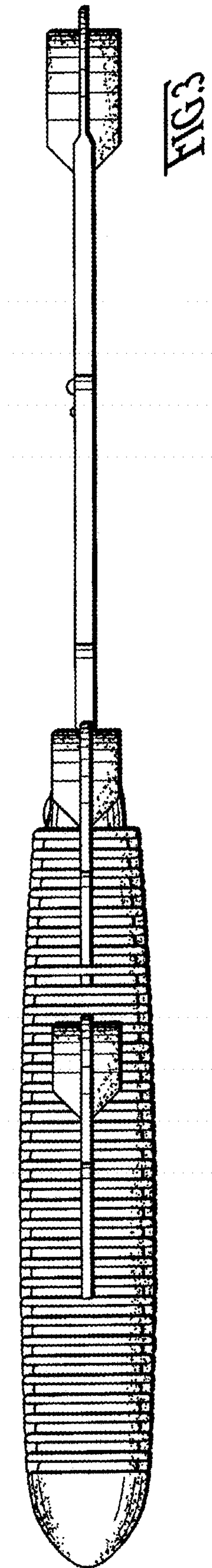

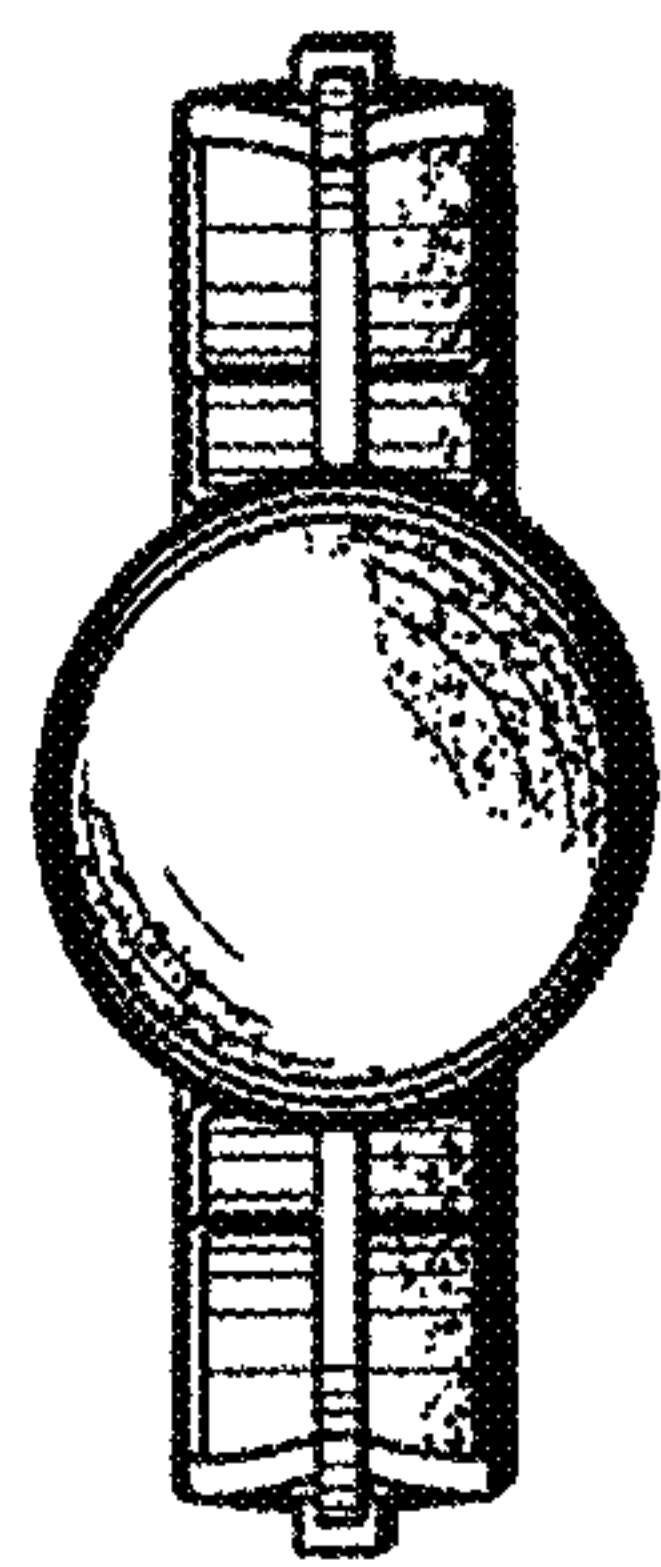

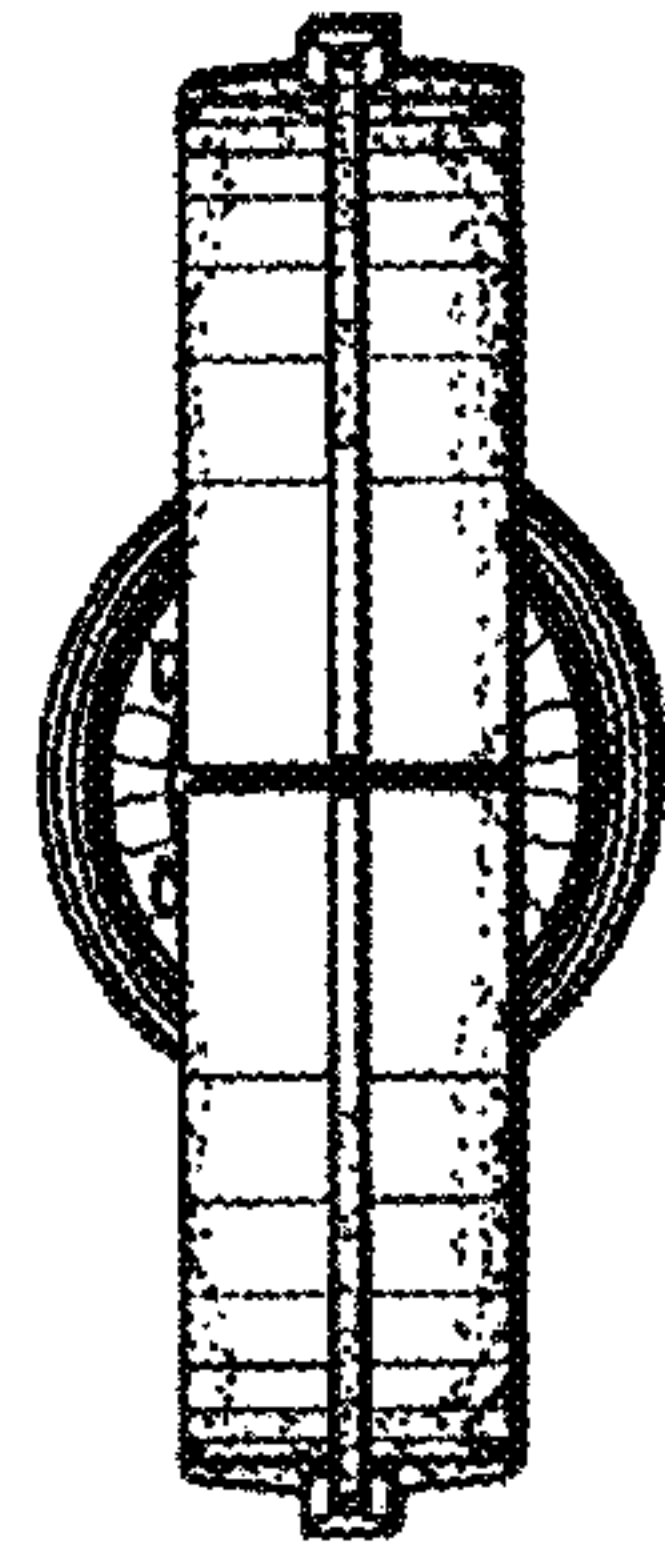

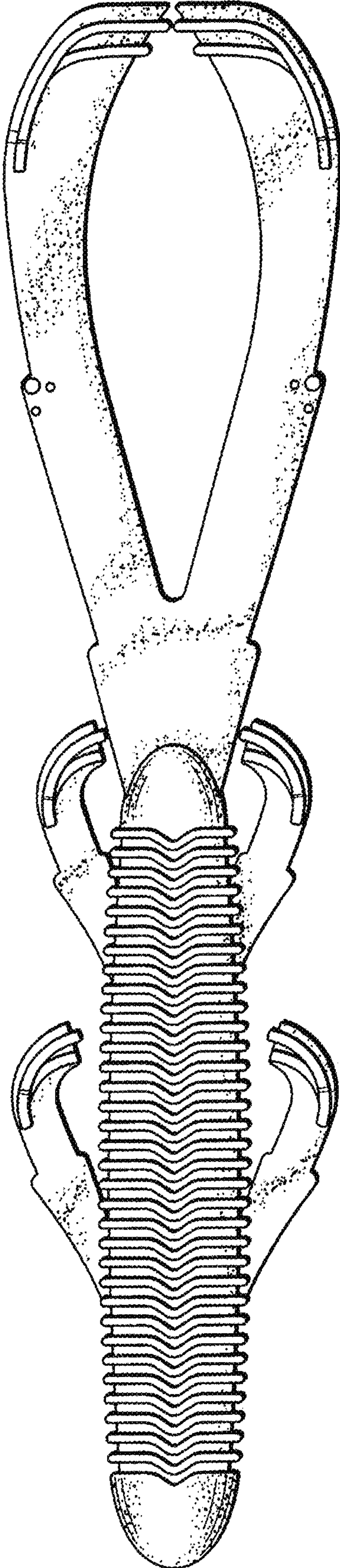
