(57) **CLAIM**

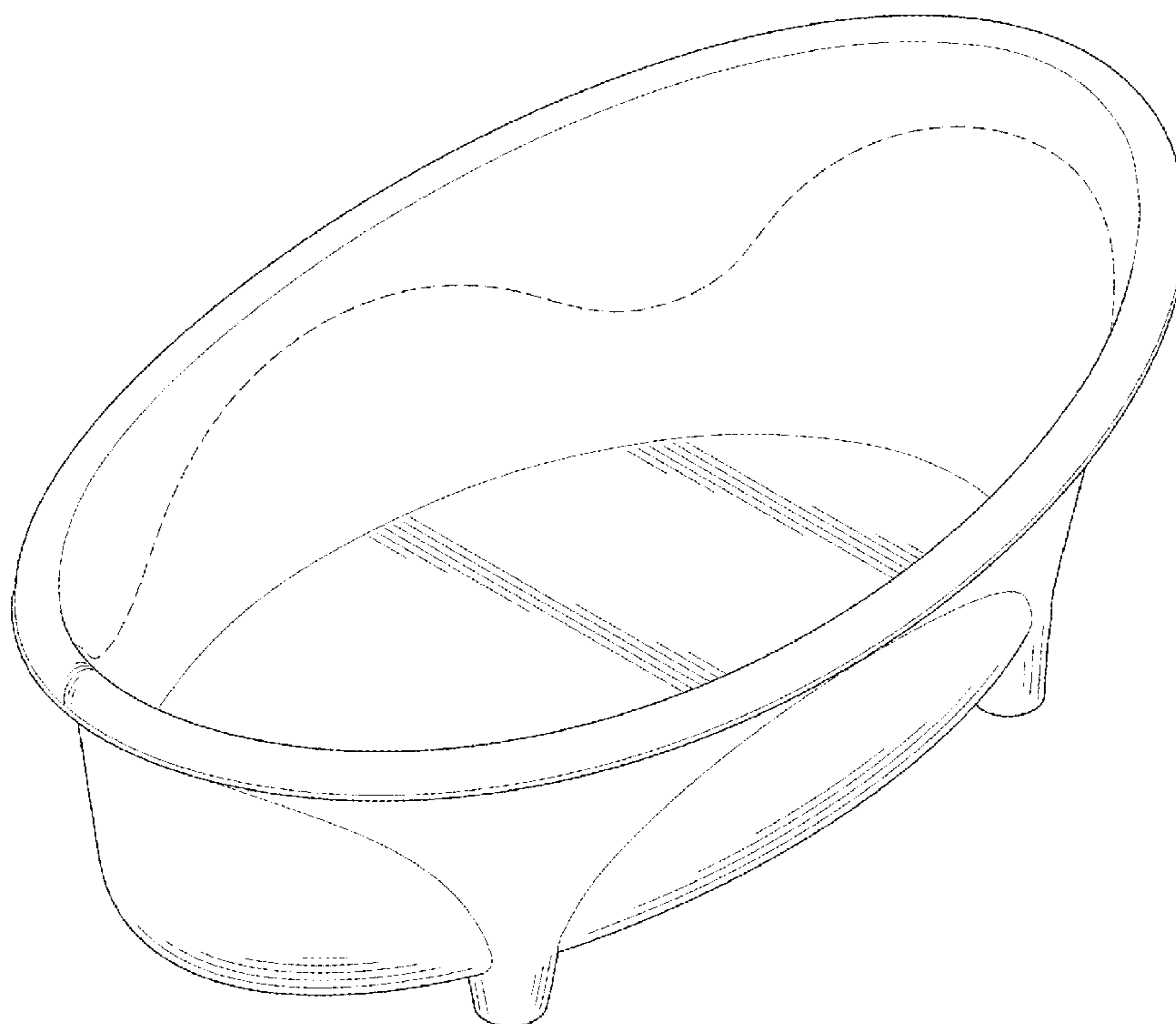
The ornamental design for a bathtub, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bathtub showing my new design;

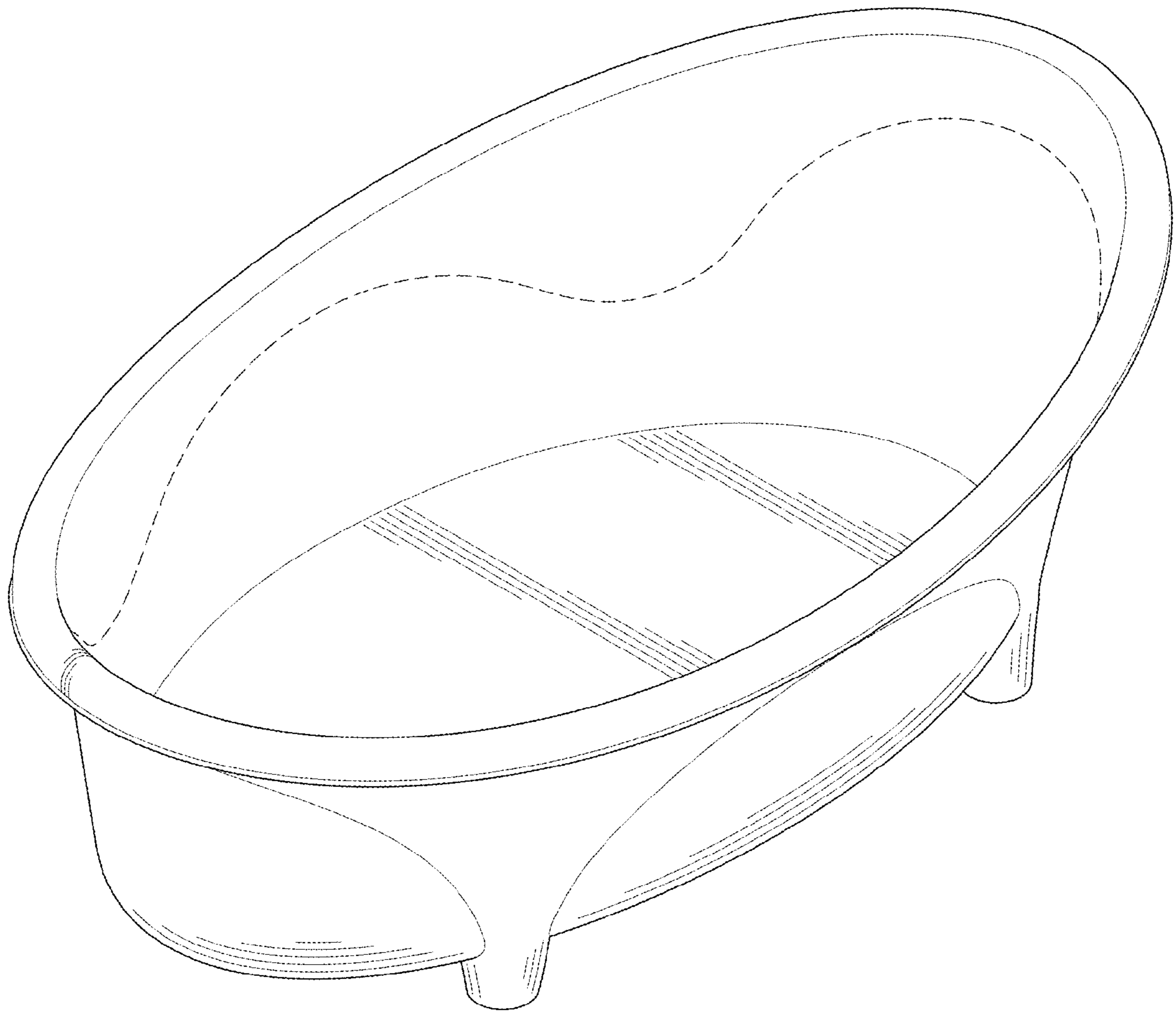

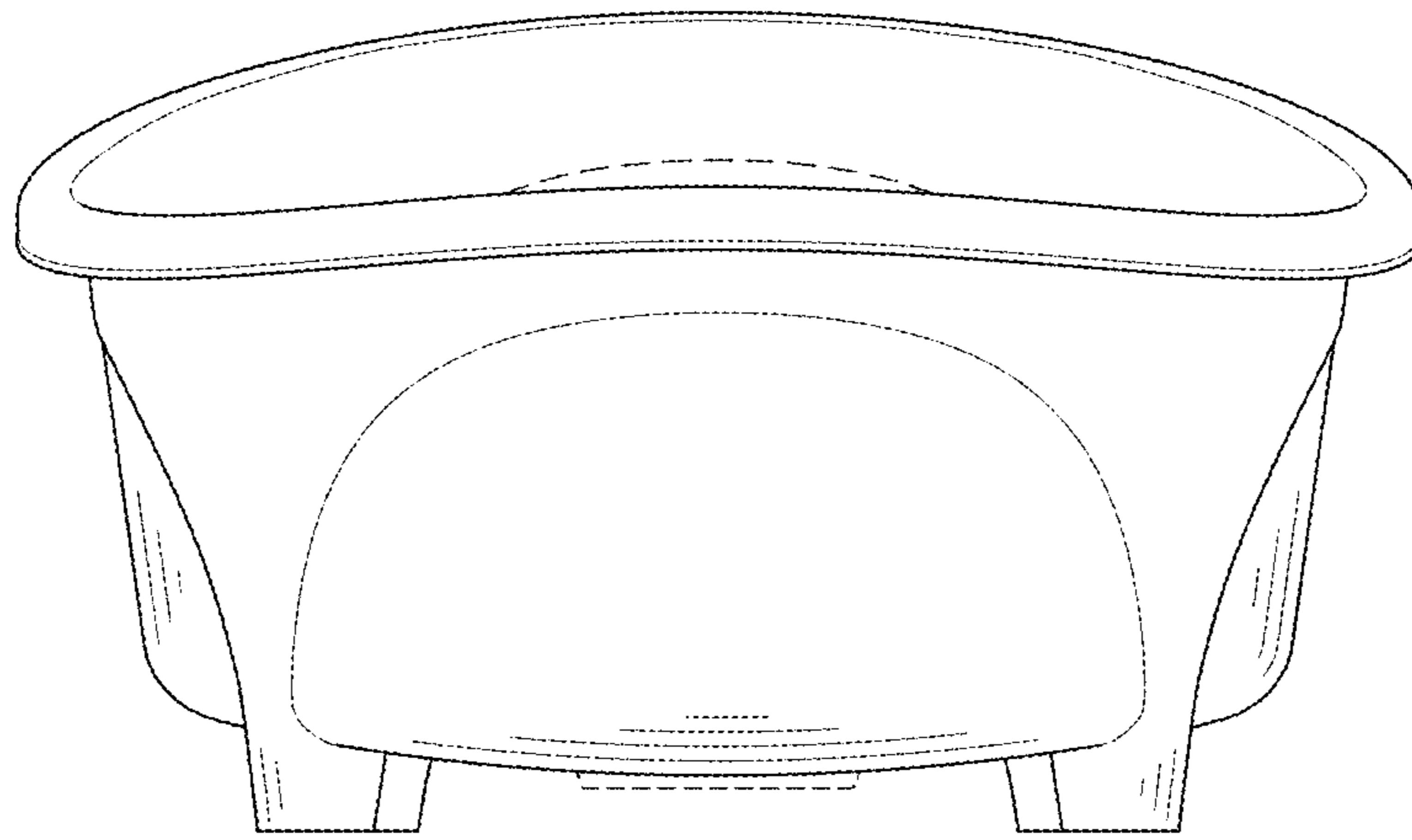

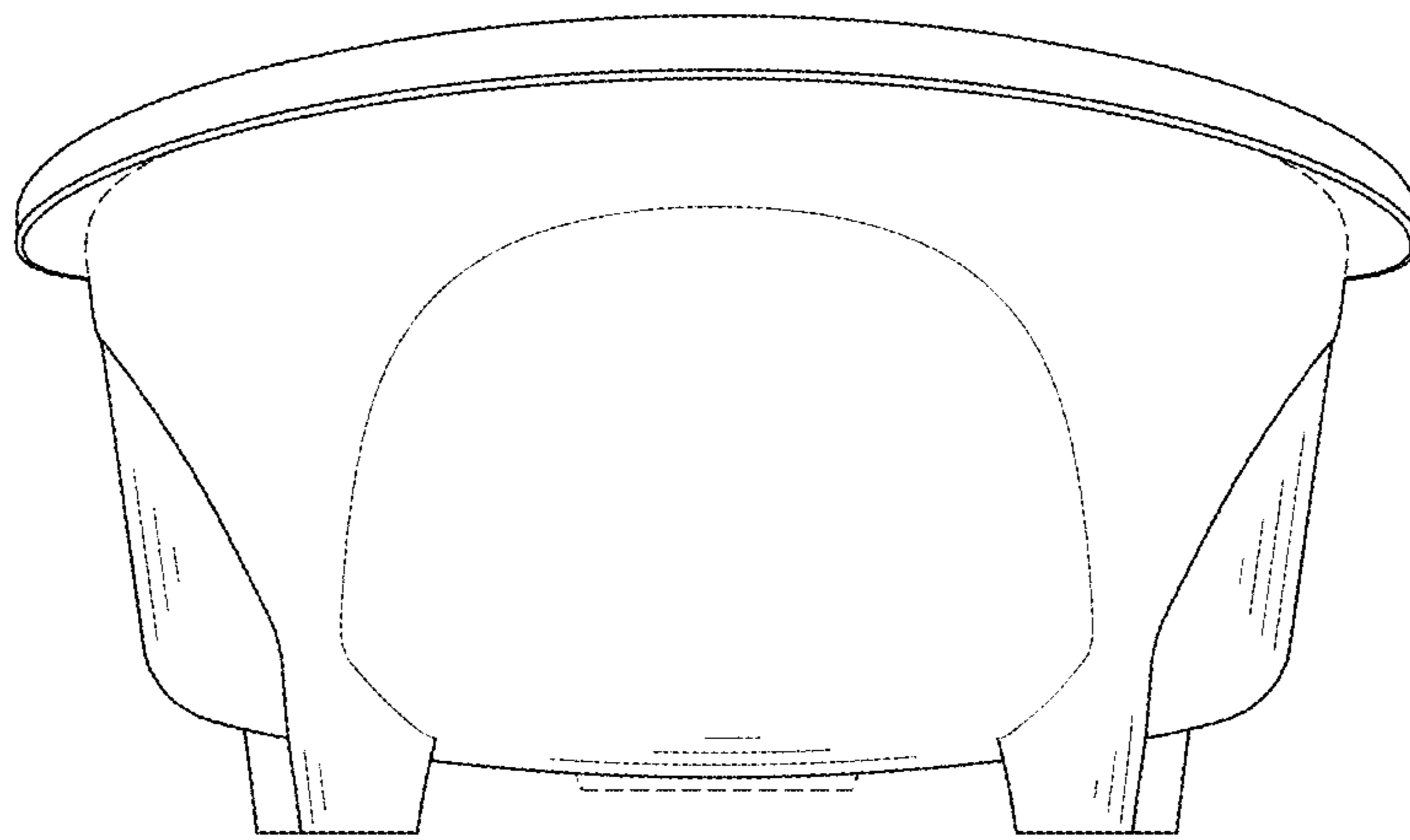

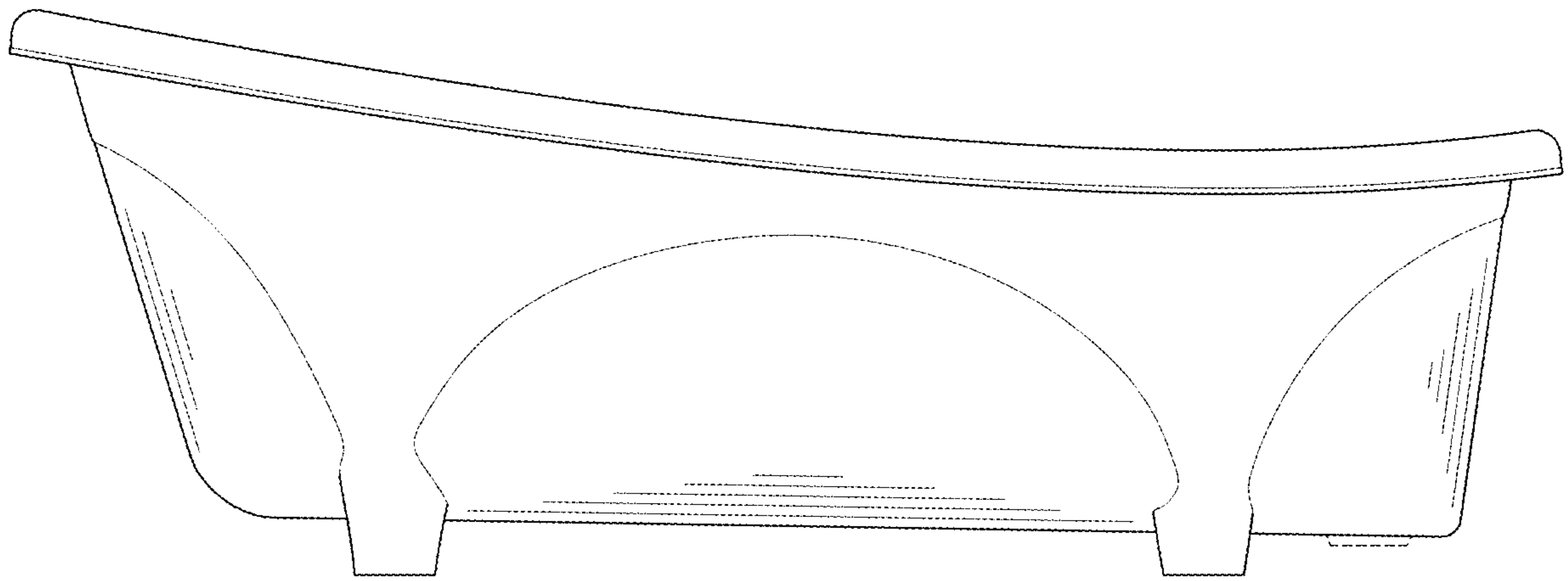

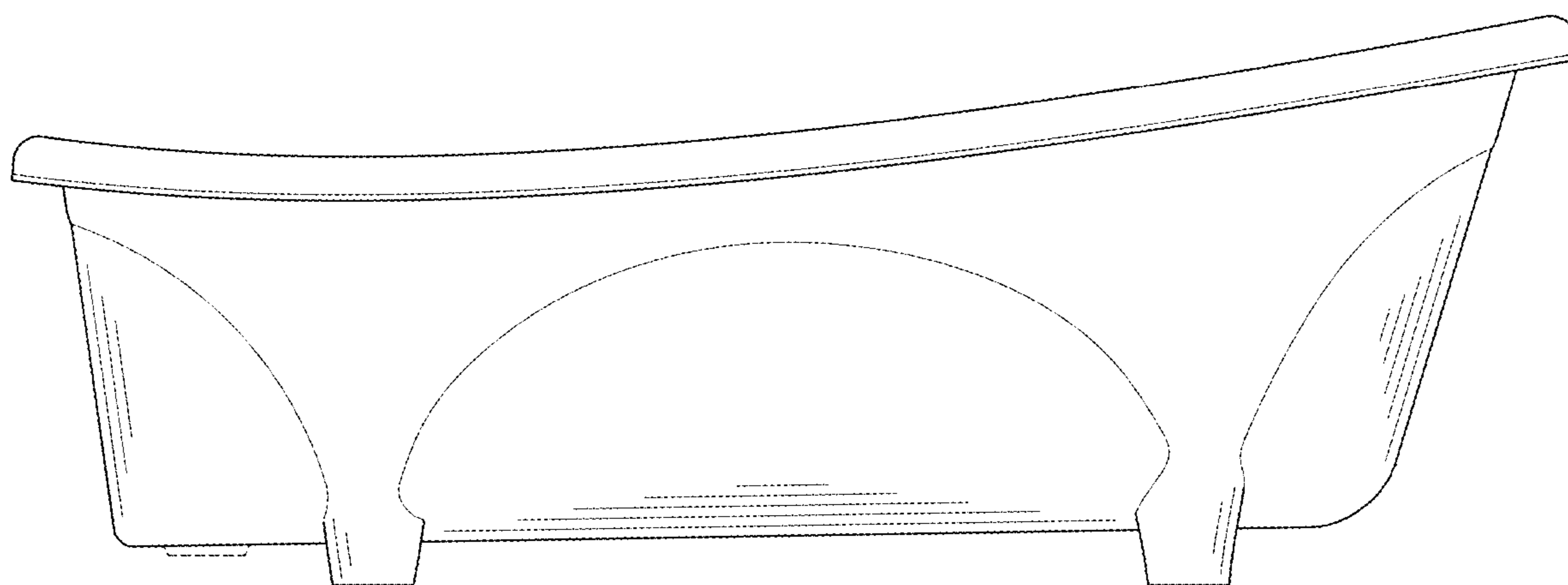

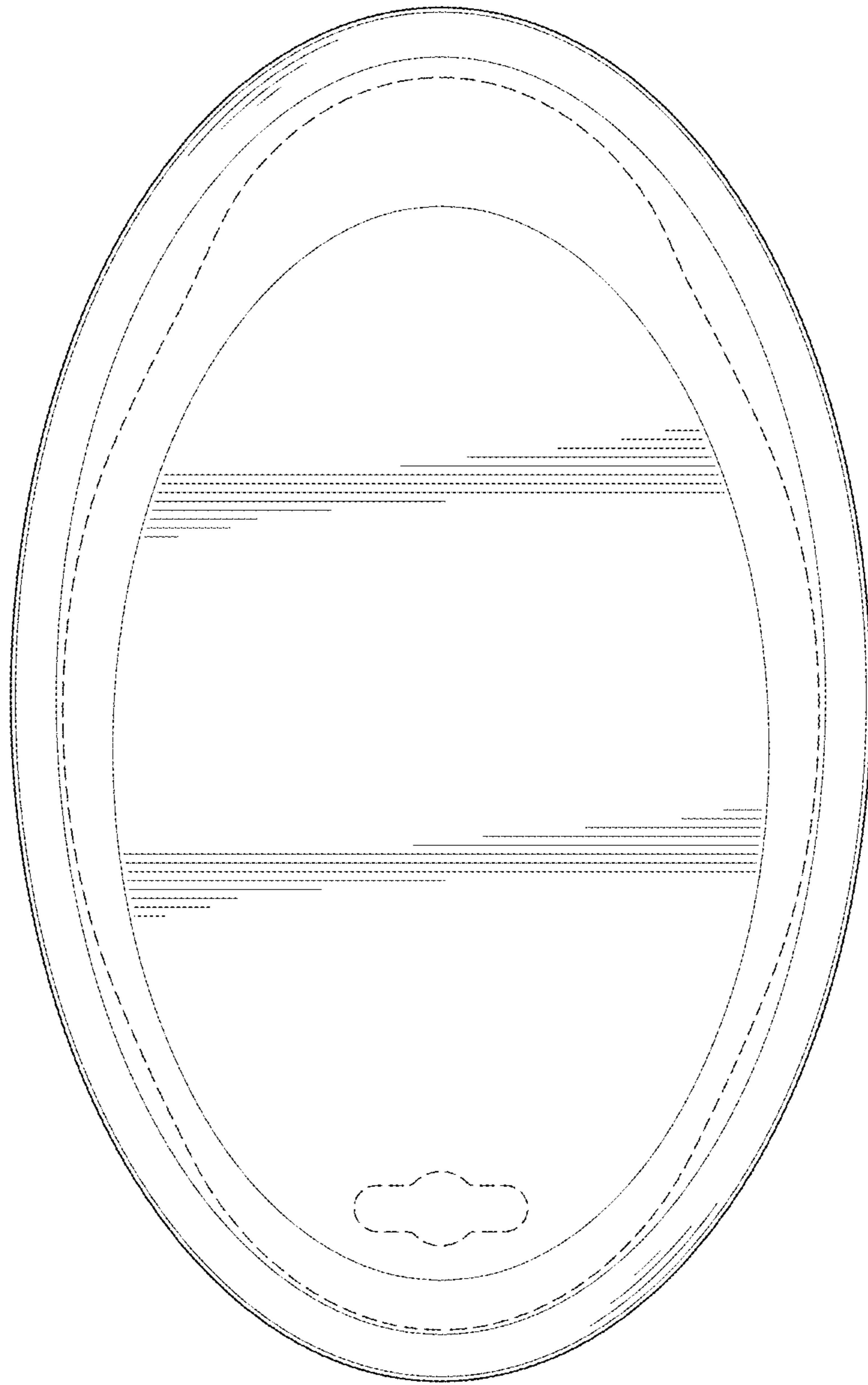

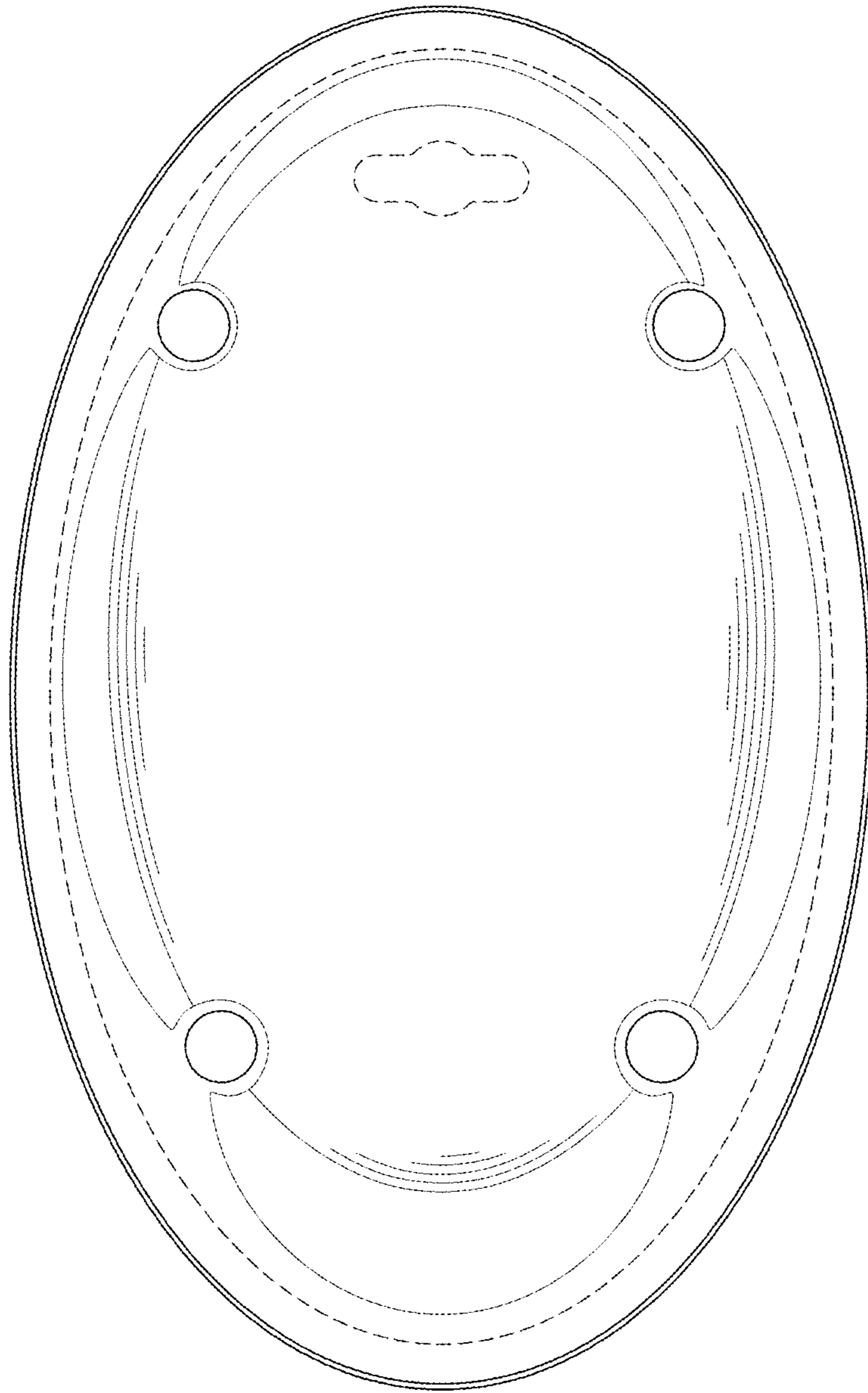
